We claim the ornamental design for a portable printer, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a portable printer showing our new design;

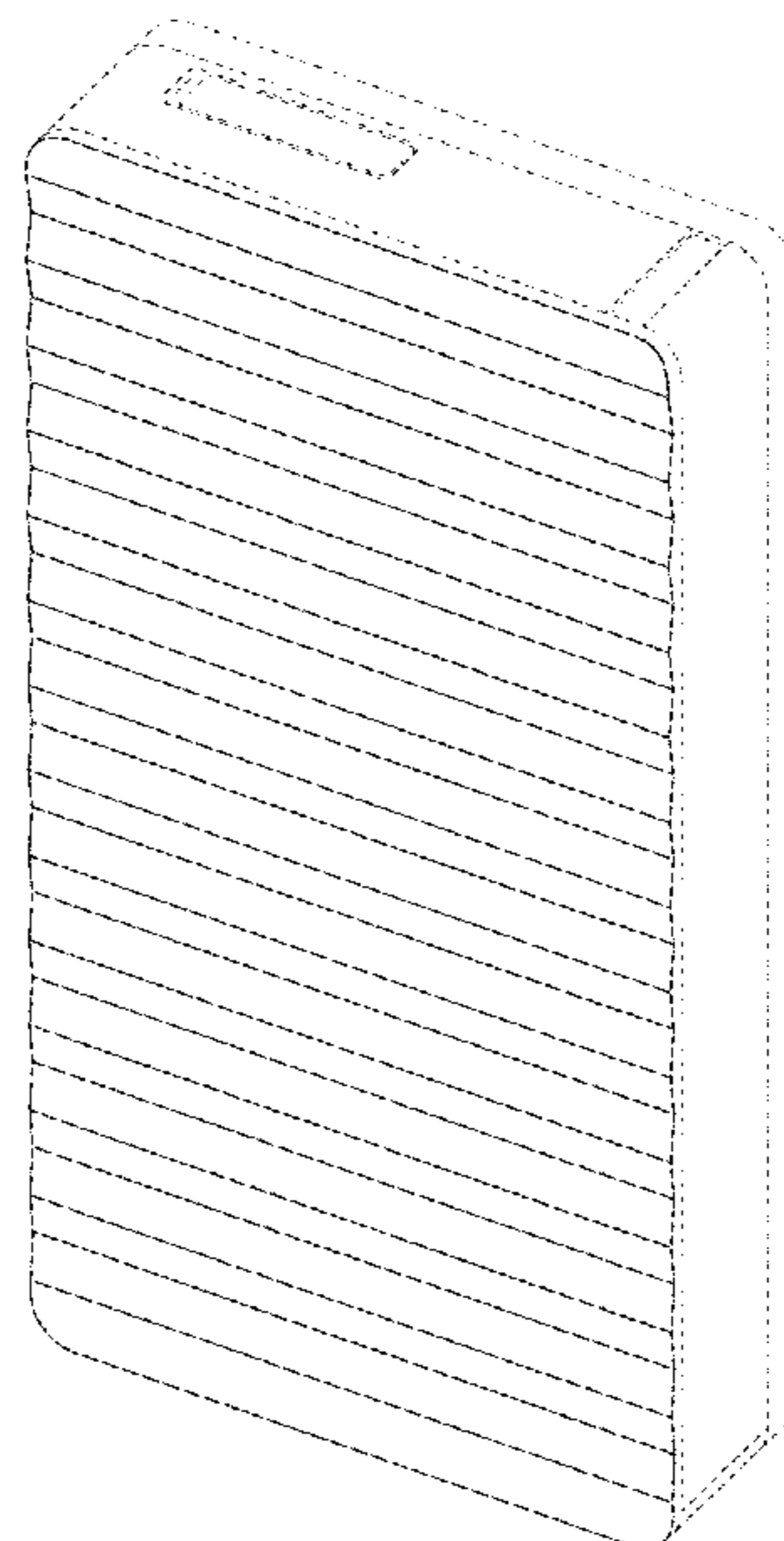

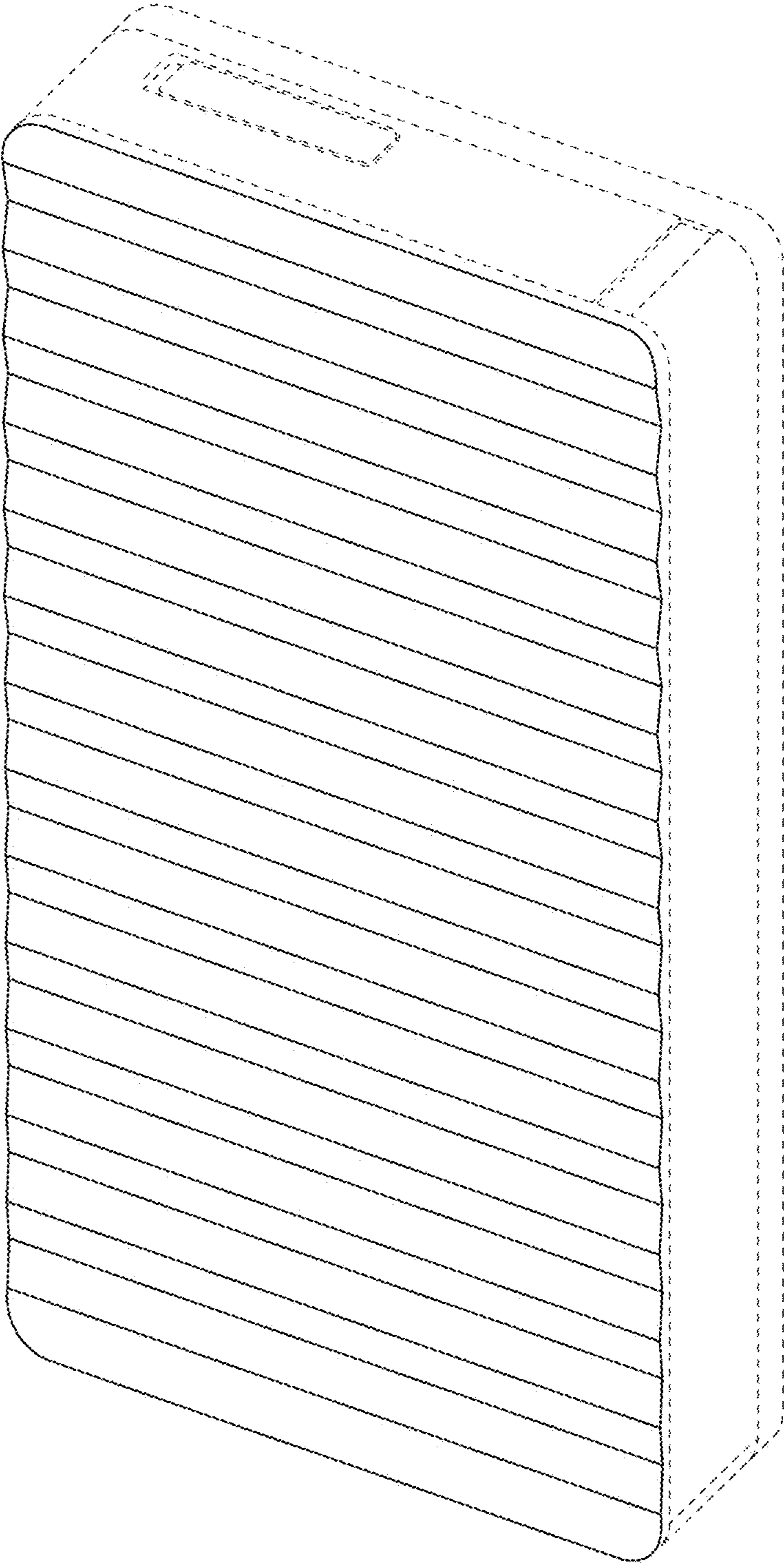

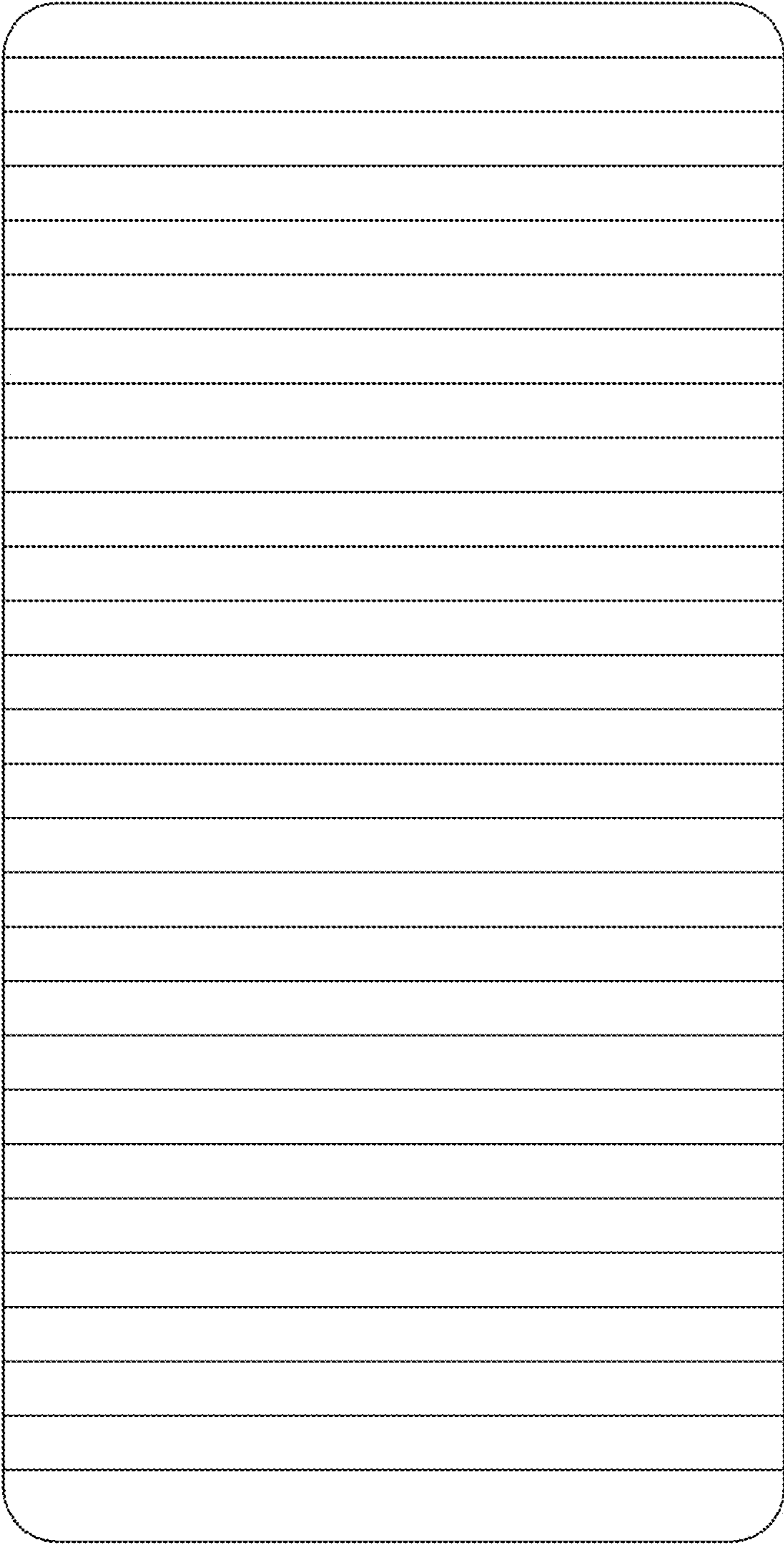

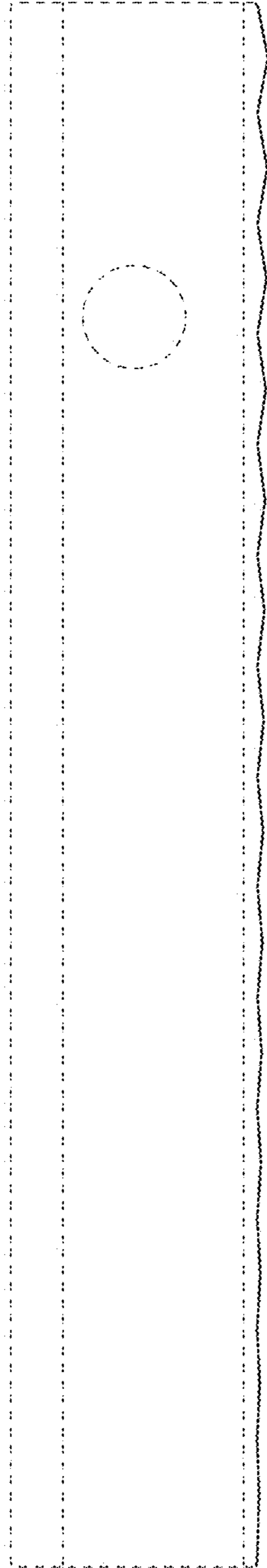

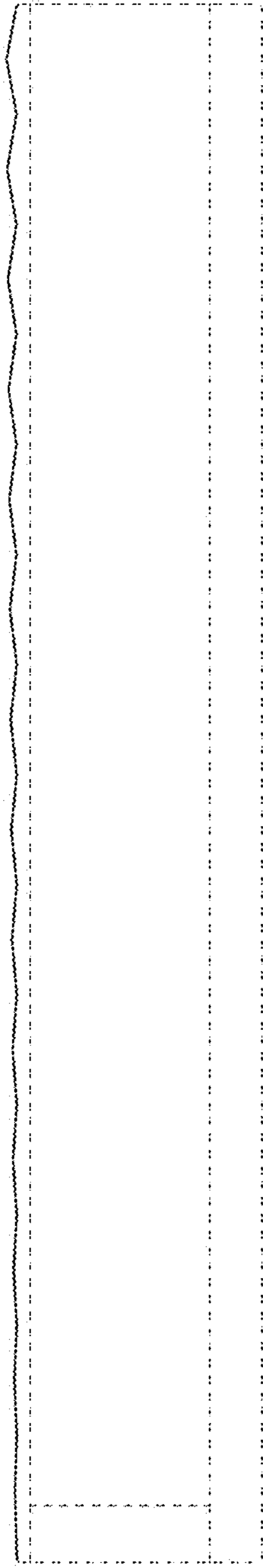

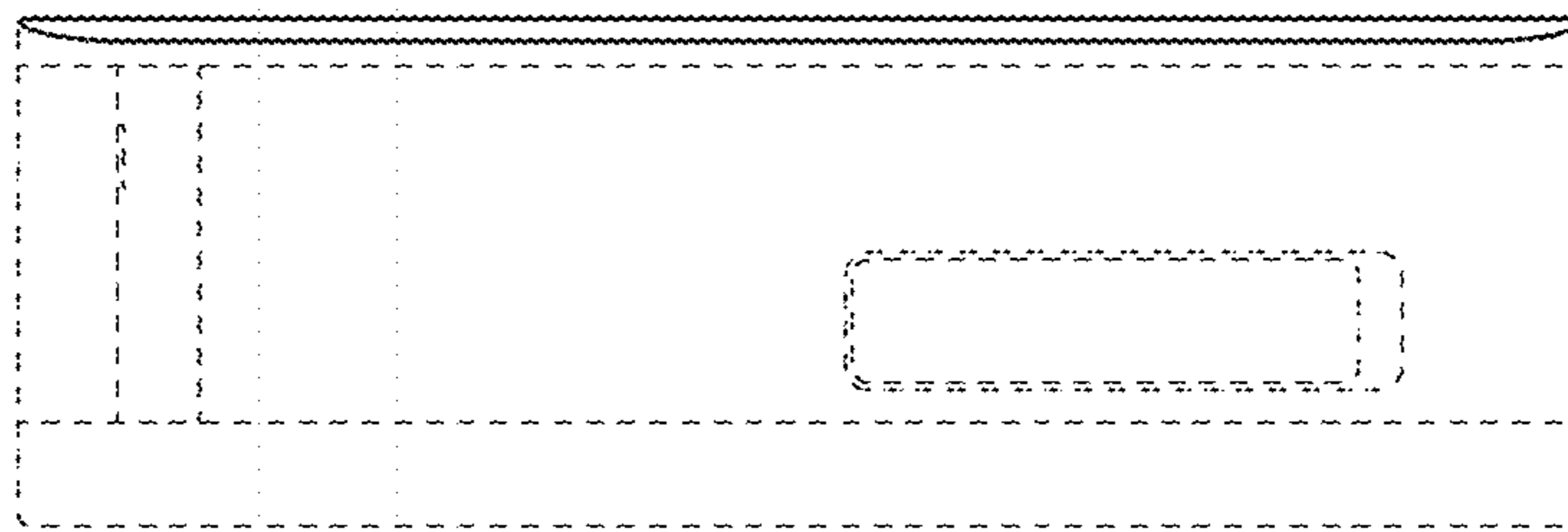
