FIG. 1 is a perspective view of the abdominal exercise wheel;

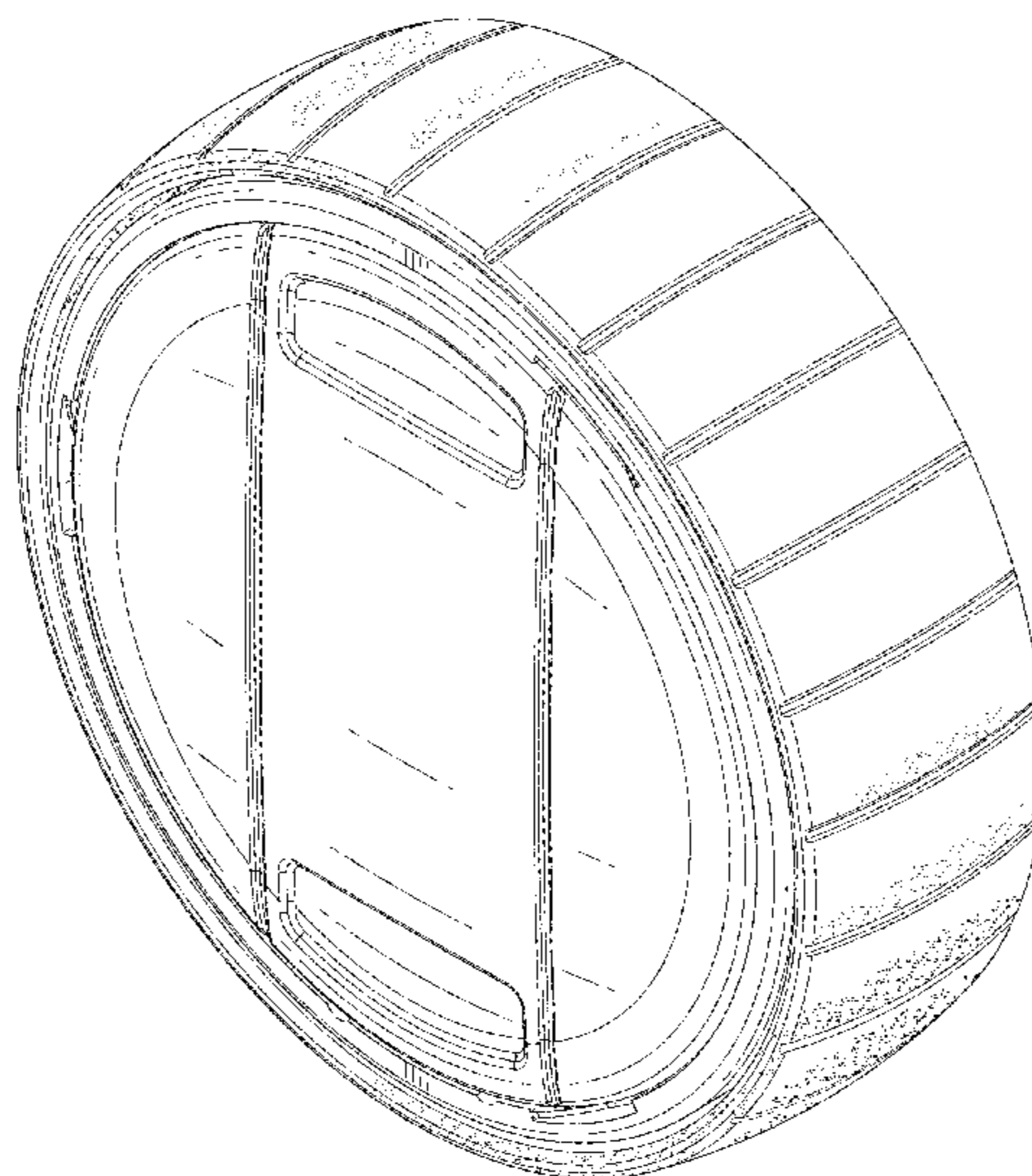
FIG. 2 is a front view of the abdominal exercise wheel, the back view being a mirror image;

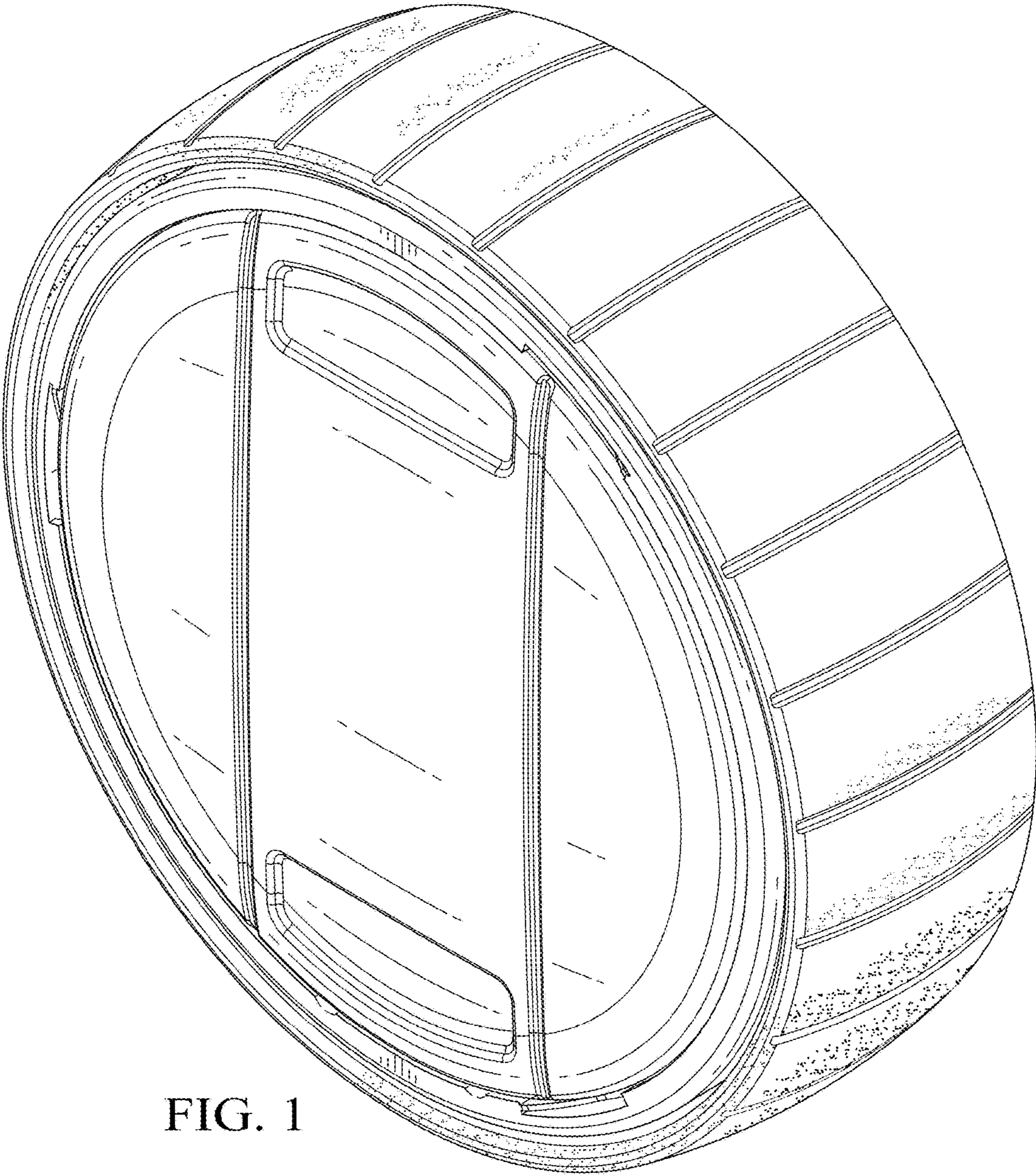

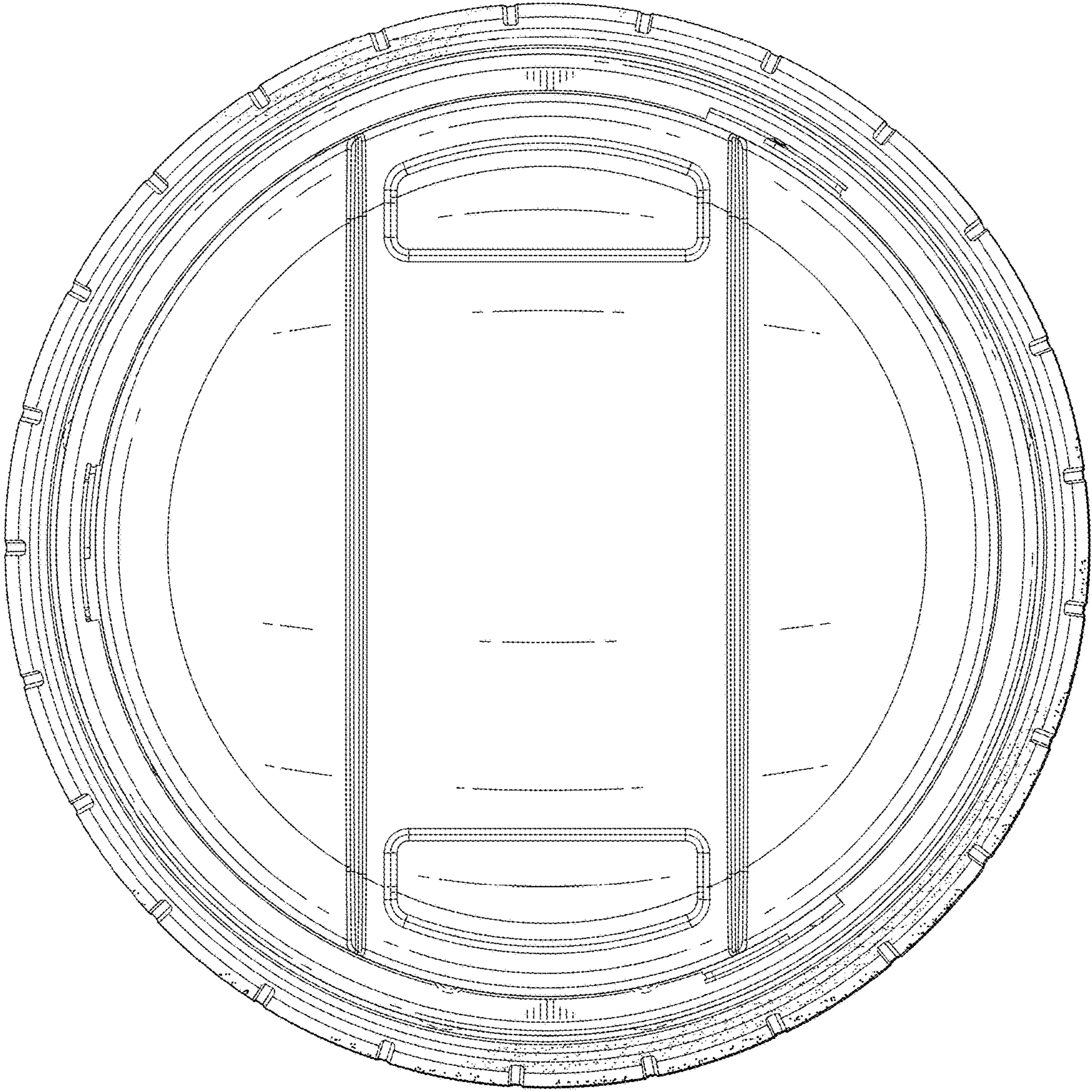

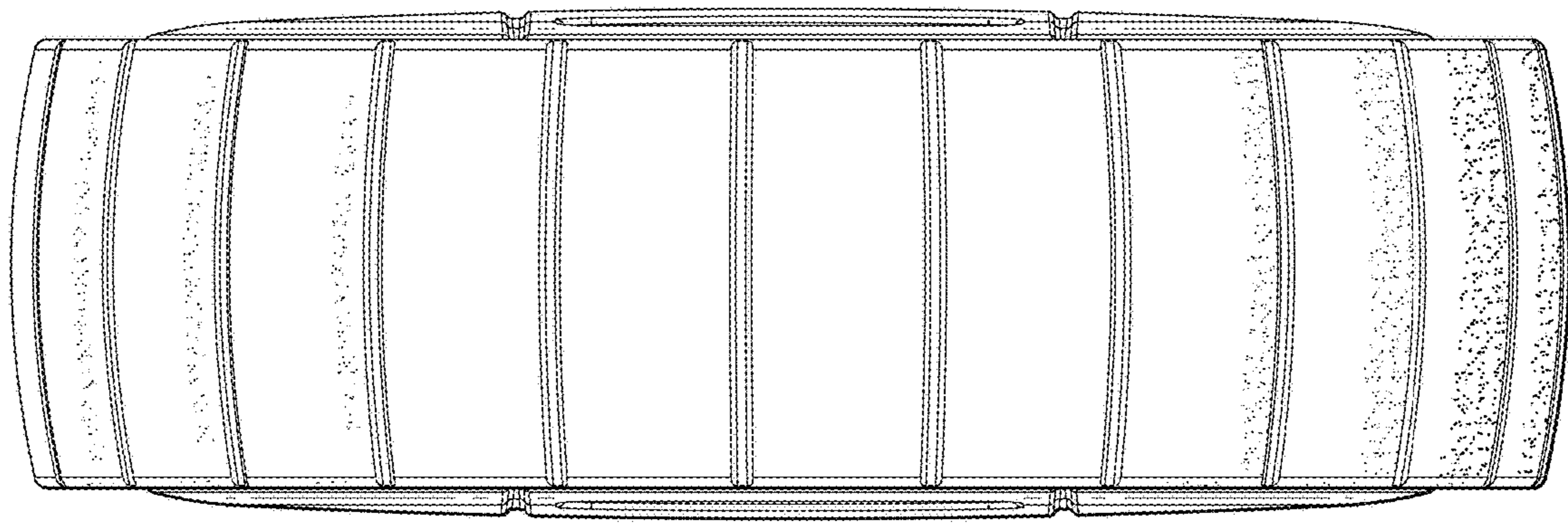

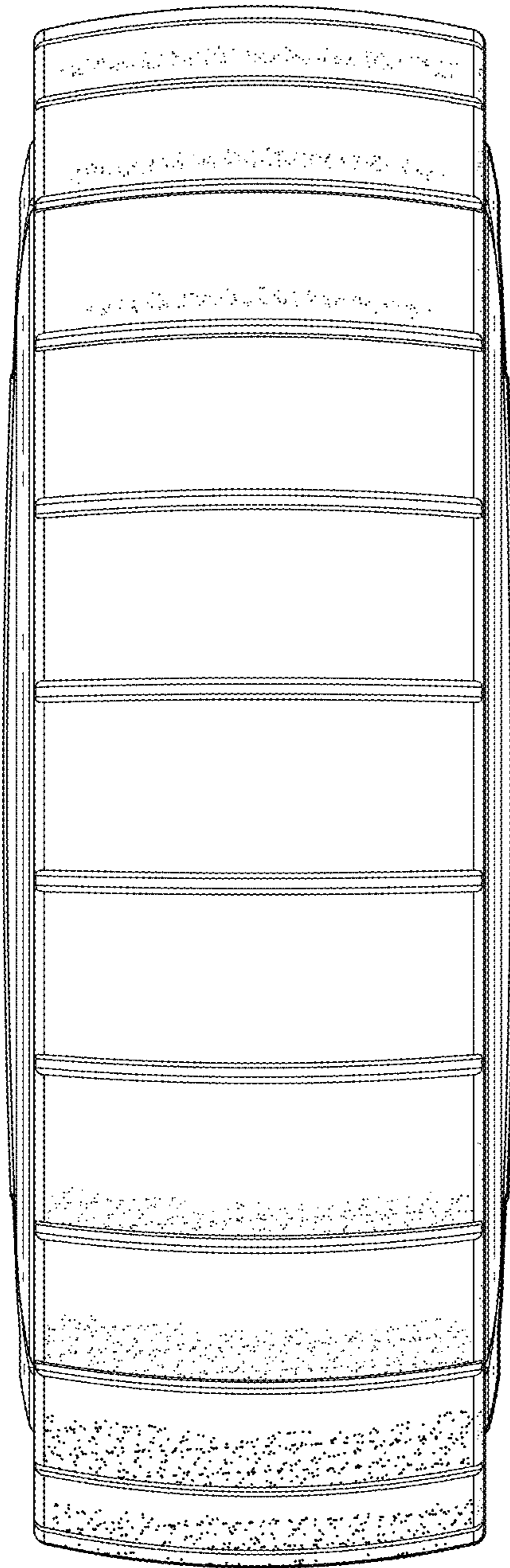

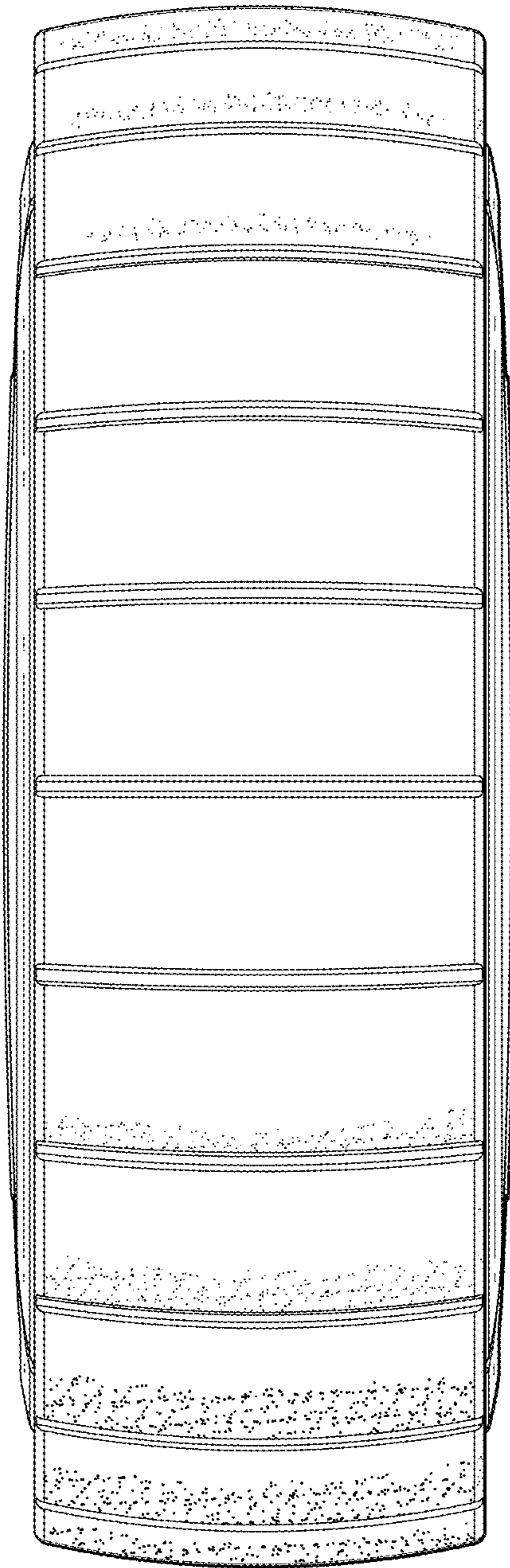
