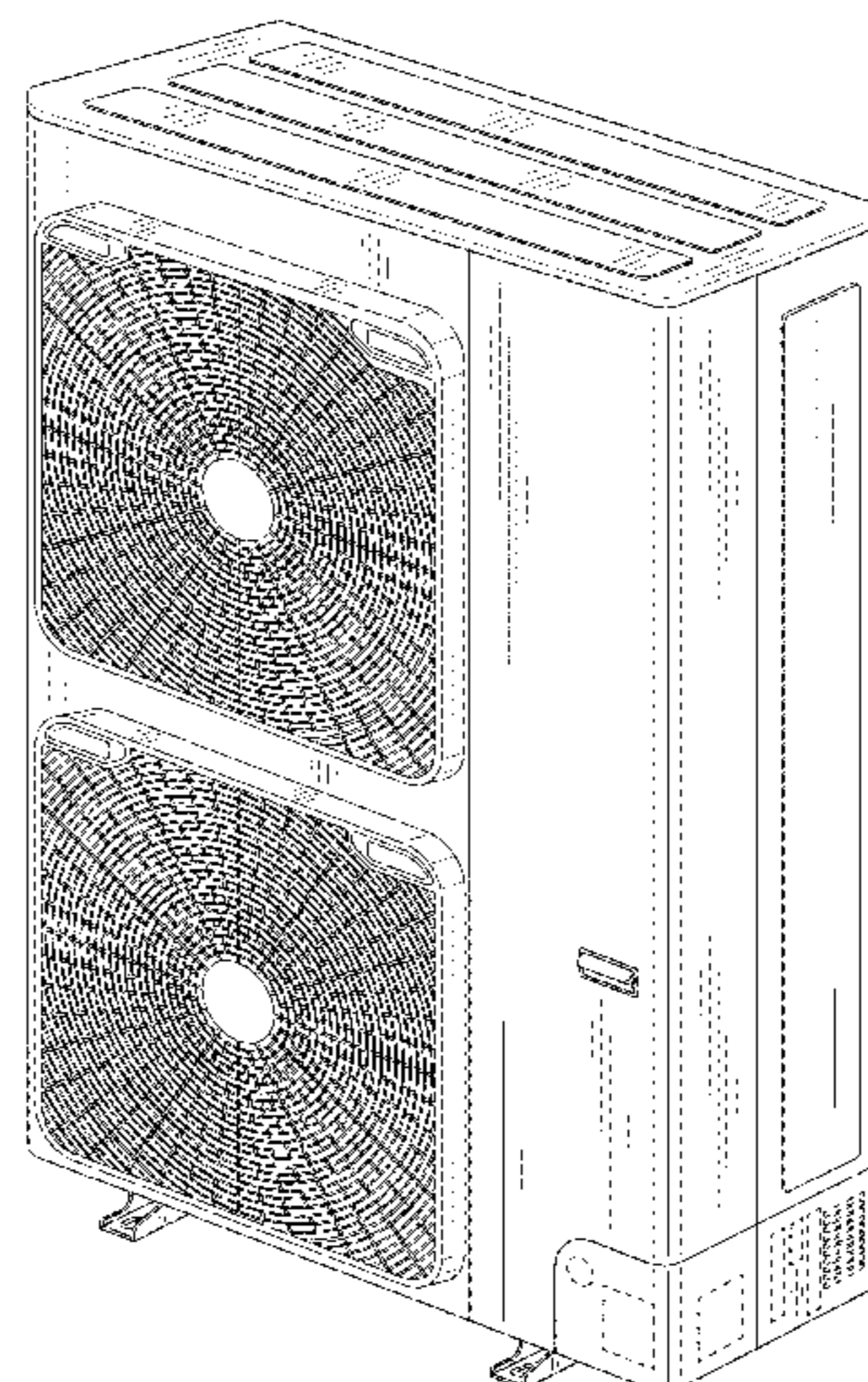
(57) **CLAIM**

The ornamental design for a heat exchanger for an air conditioner, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right side, and top perspective view of a heat exchanger for an air conditioner showing our new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a left side view thereof;  
FIG. 6 is a rear view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken lines depict unclaimed portions of the heat exchanger for an air conditioner.

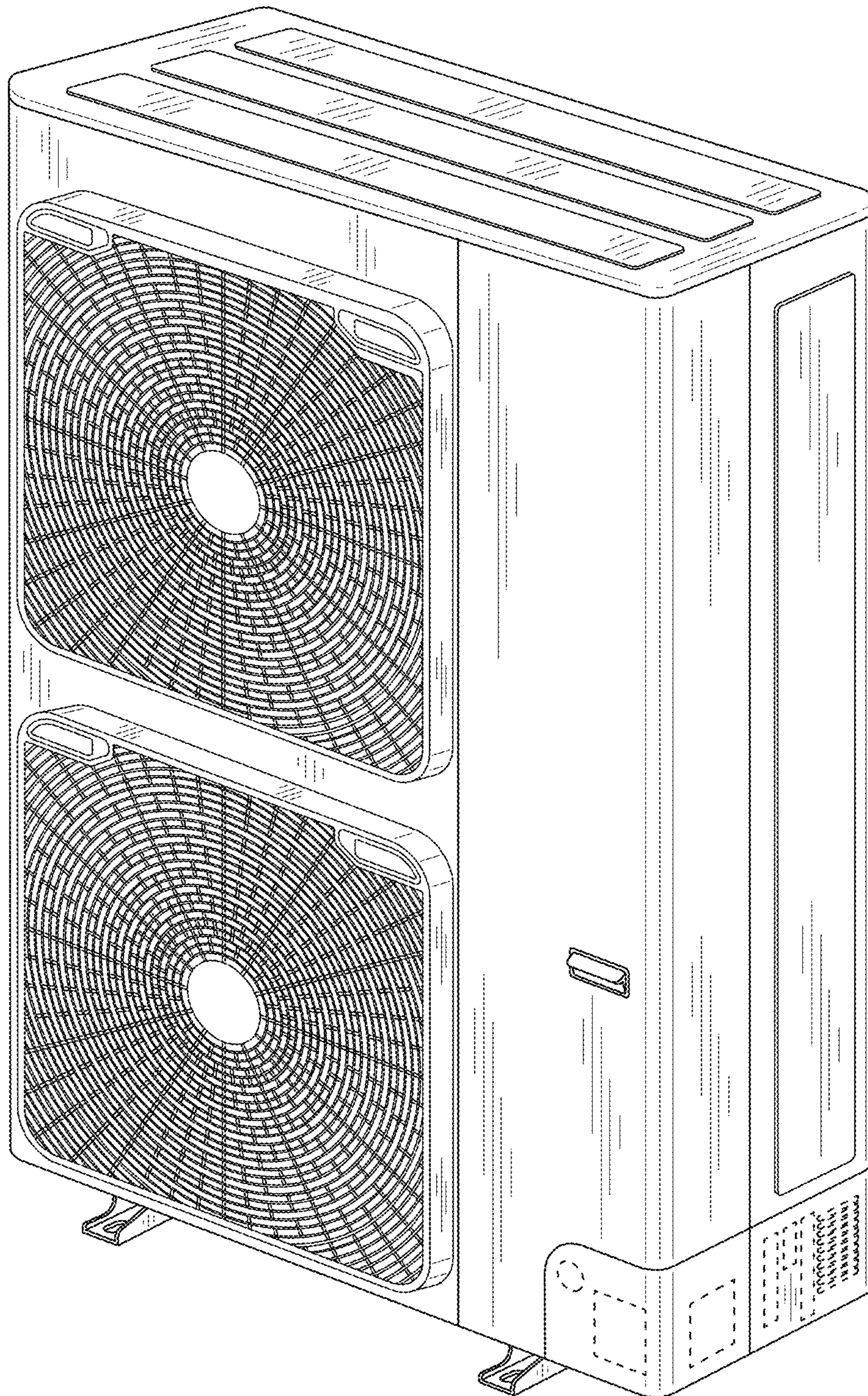

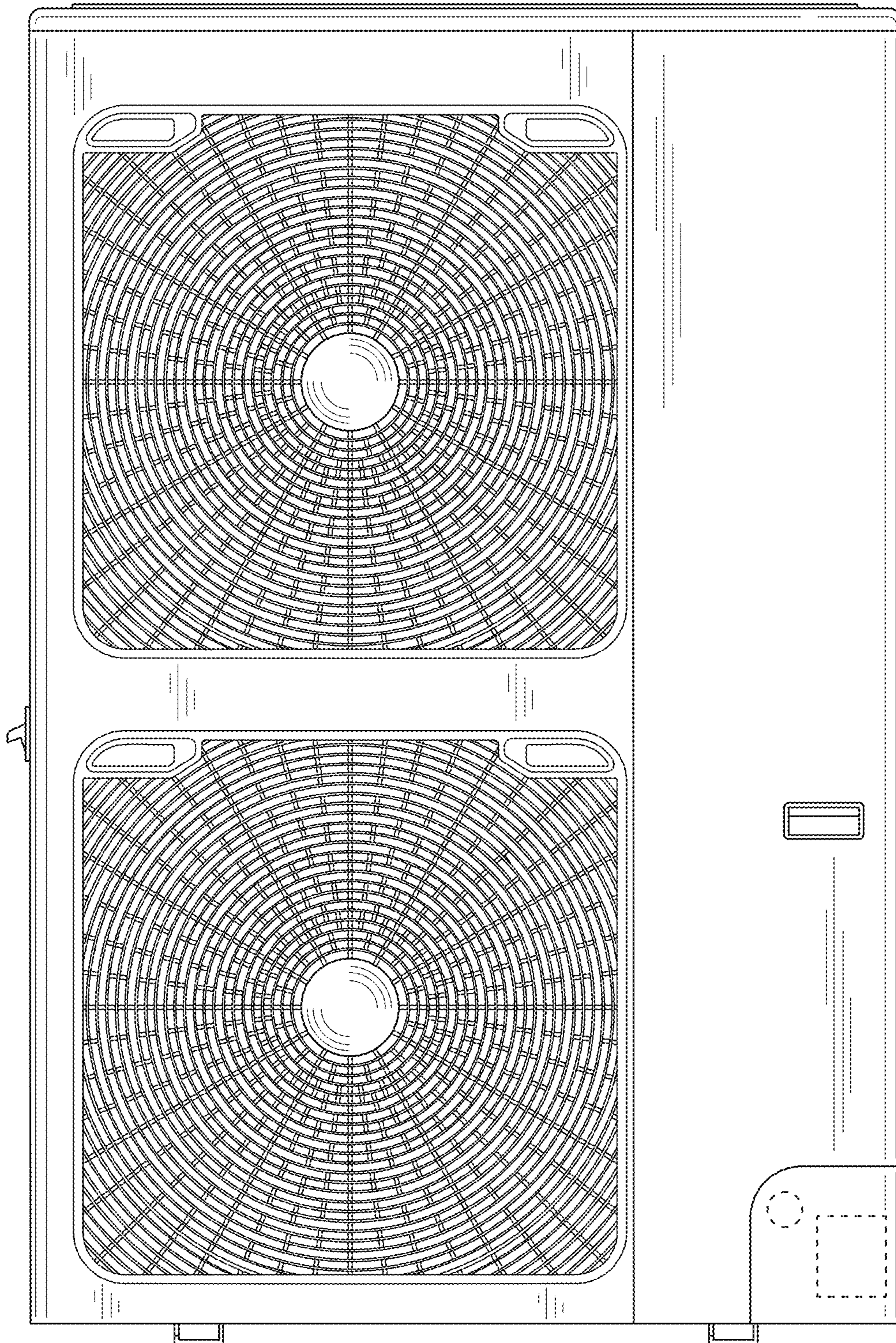

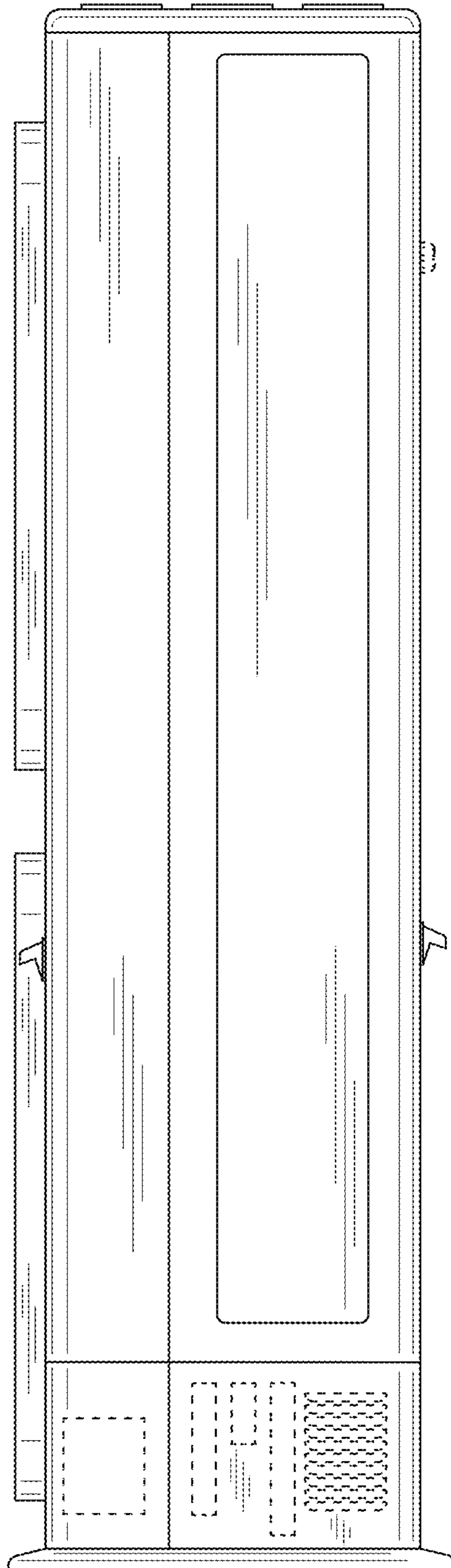

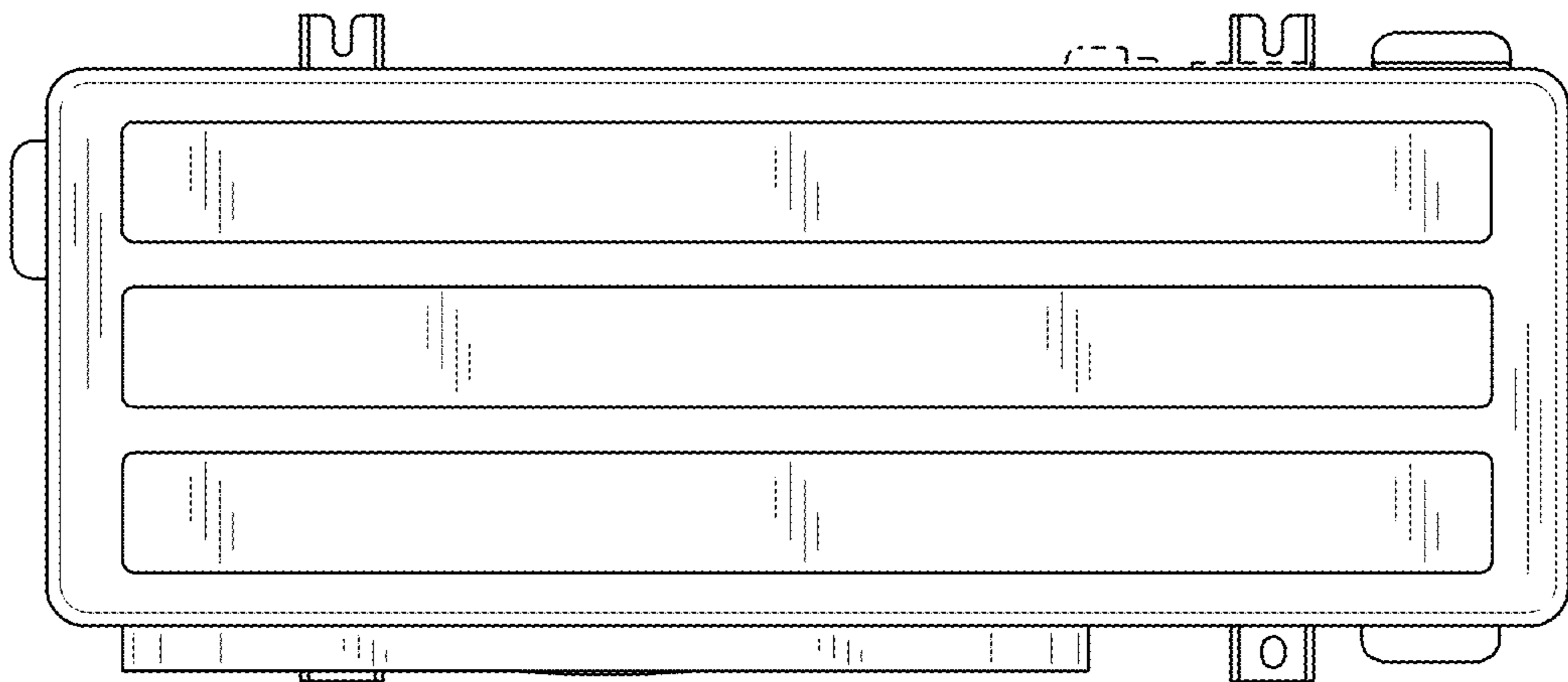

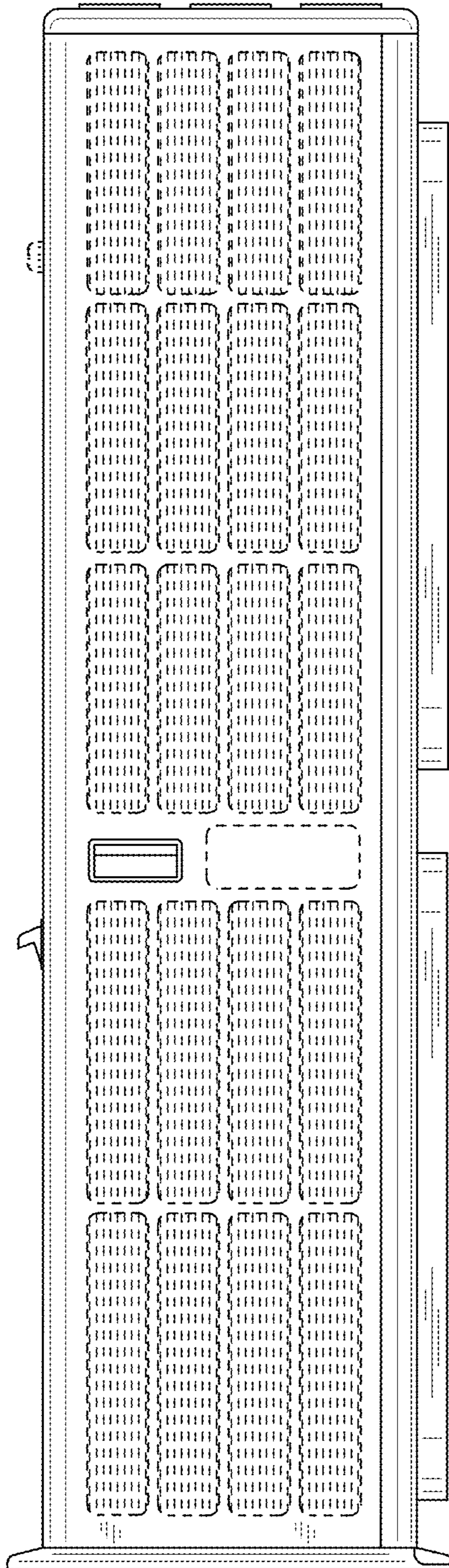

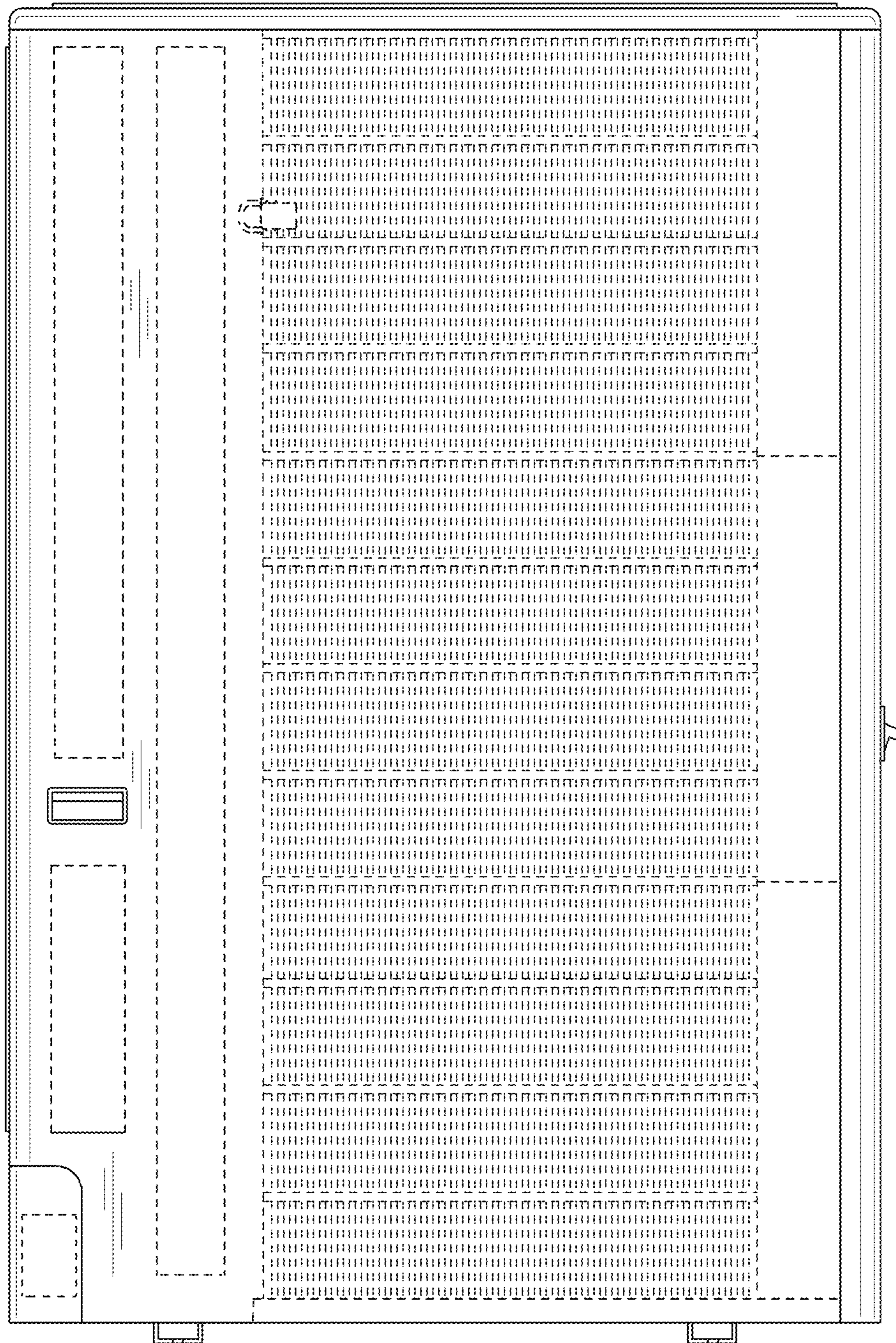
