DESCRIPTION

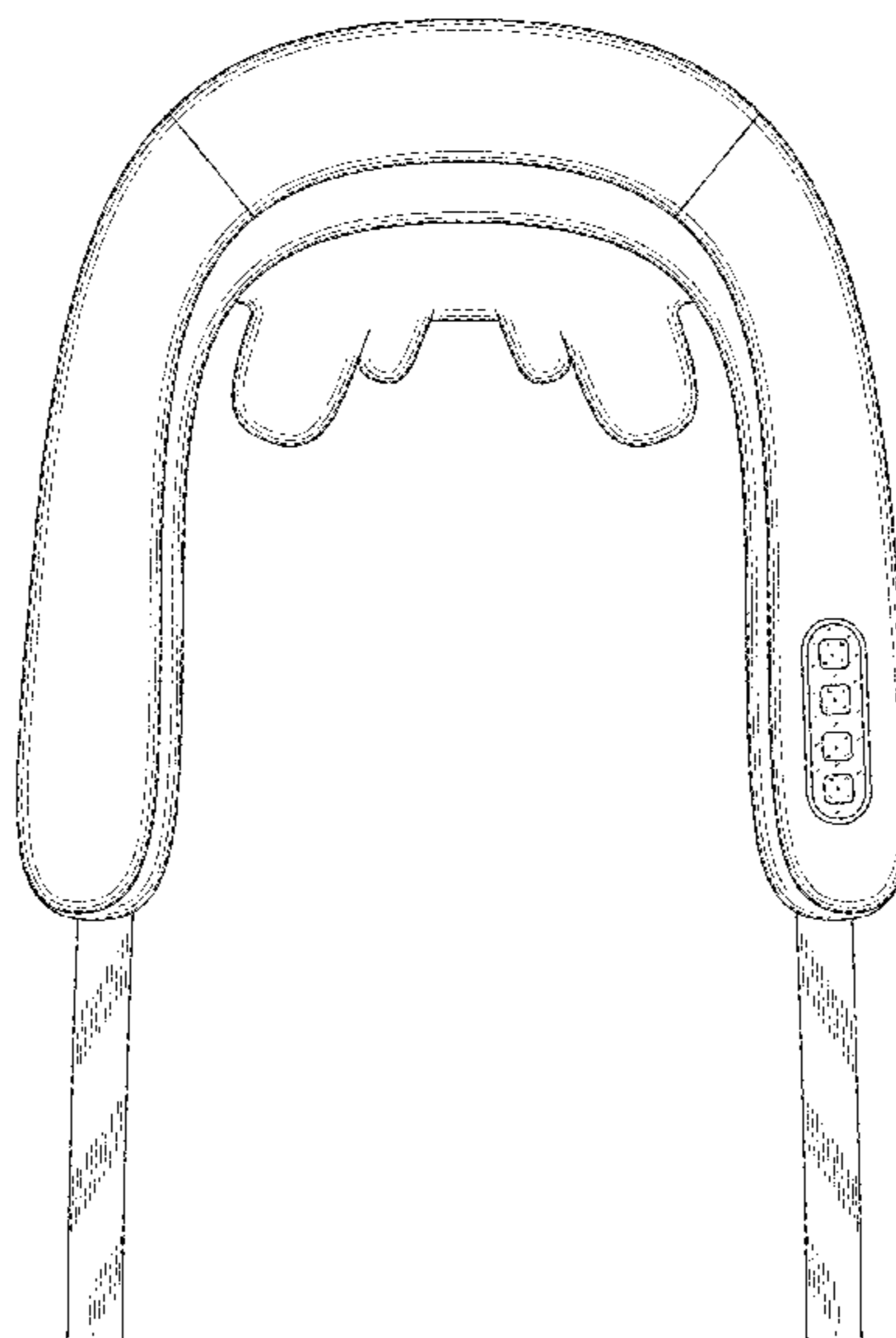
FIG. 1 is a front side view of a massage device showing my new design;

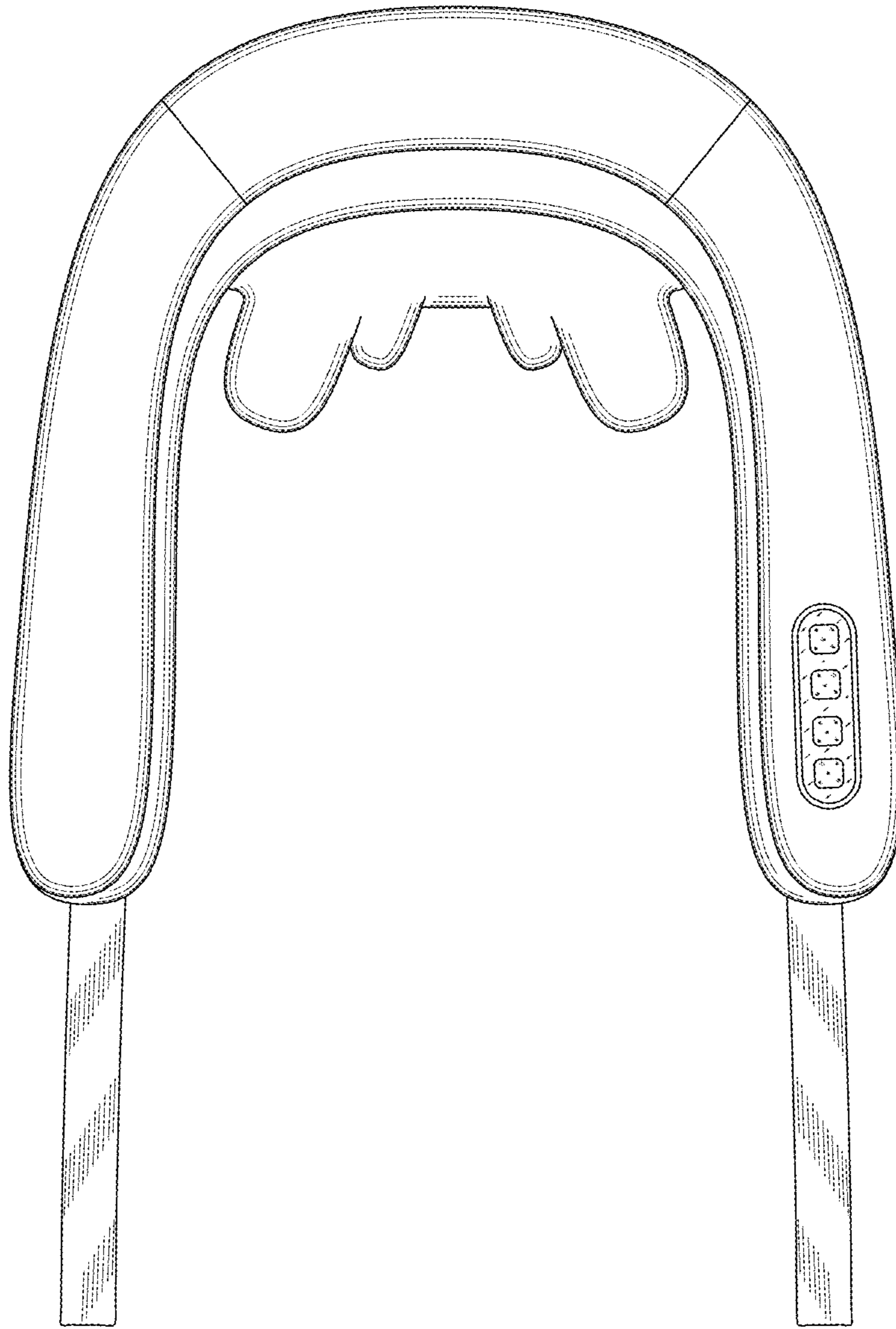

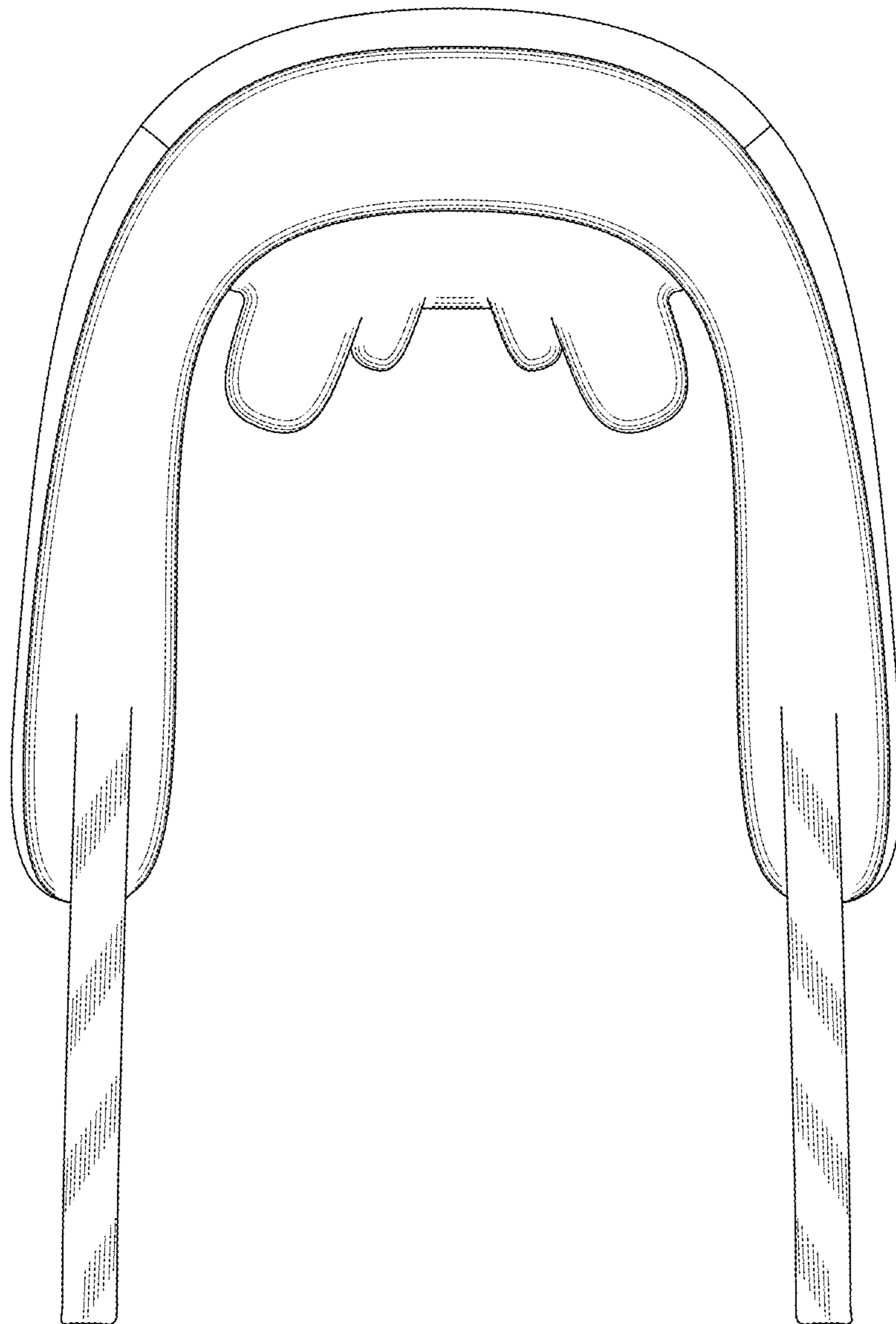

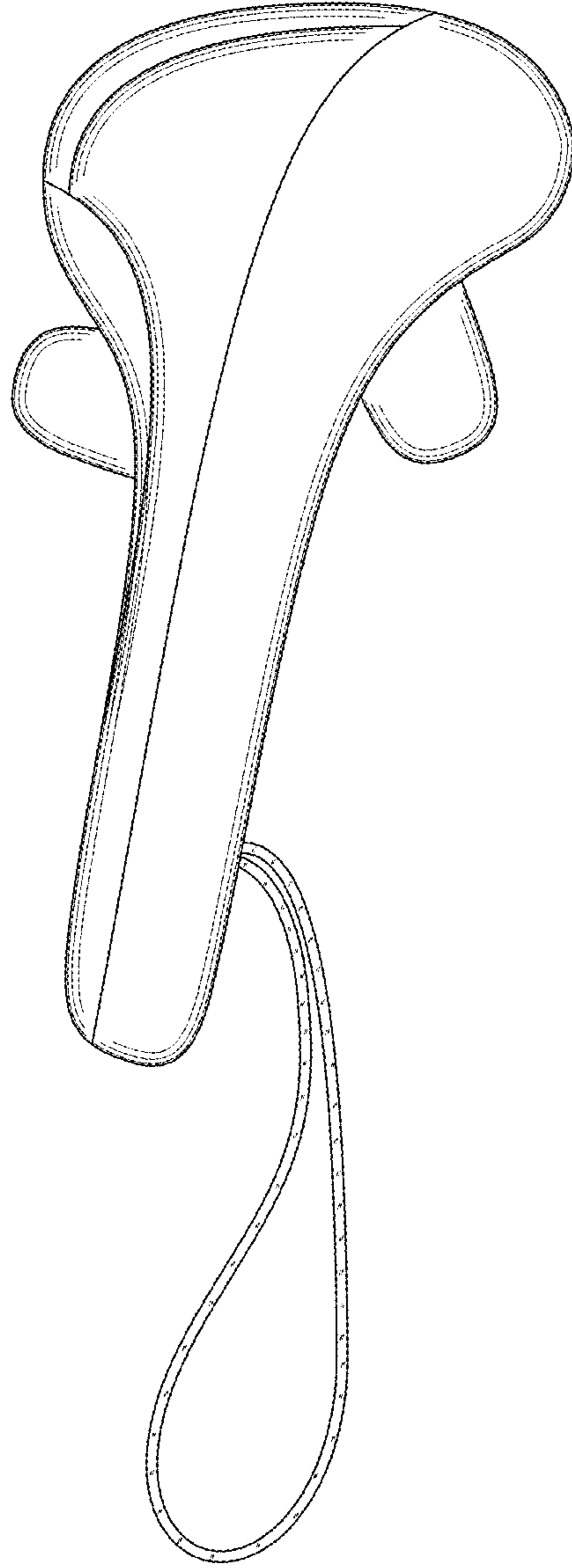

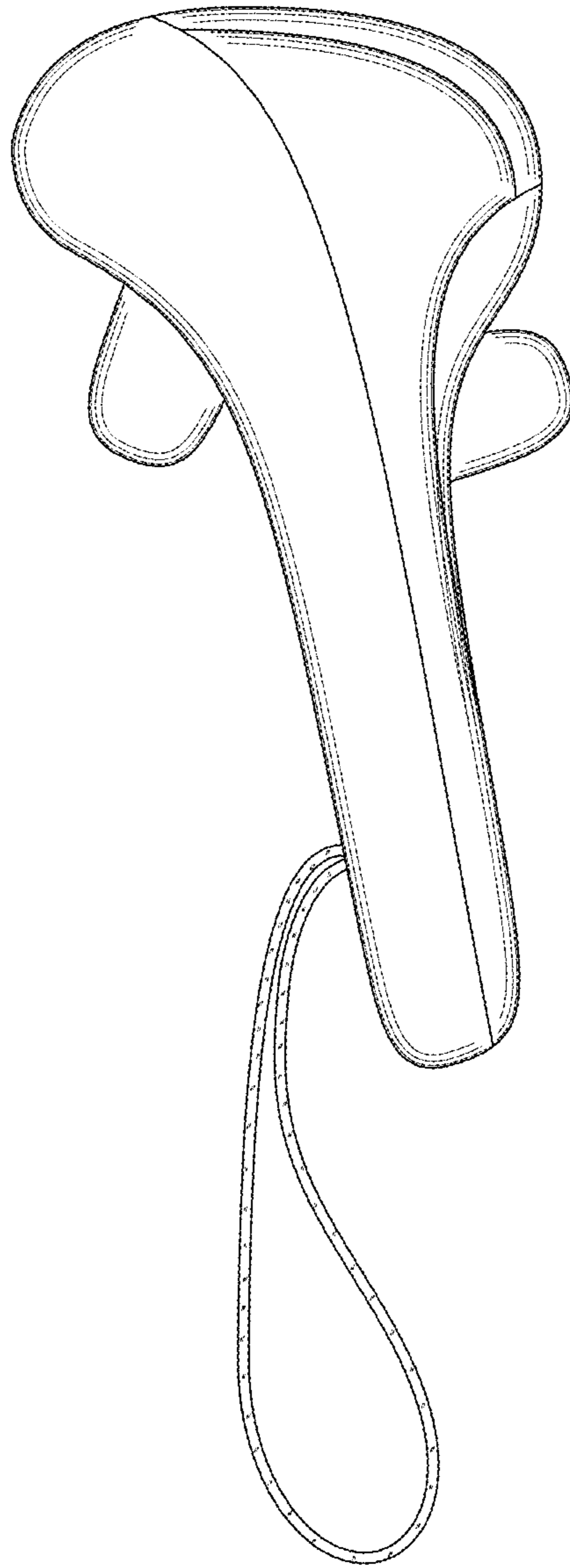

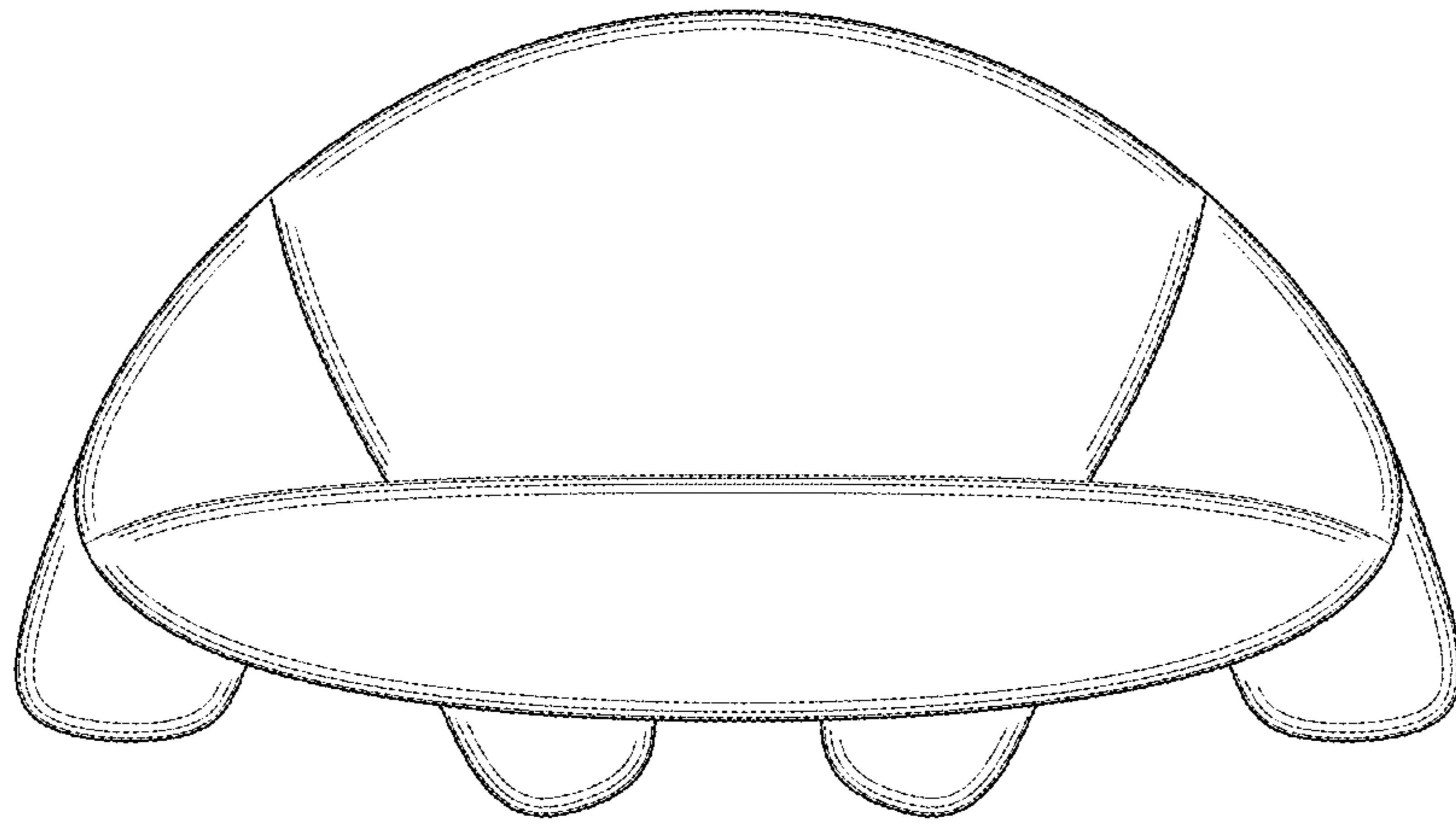

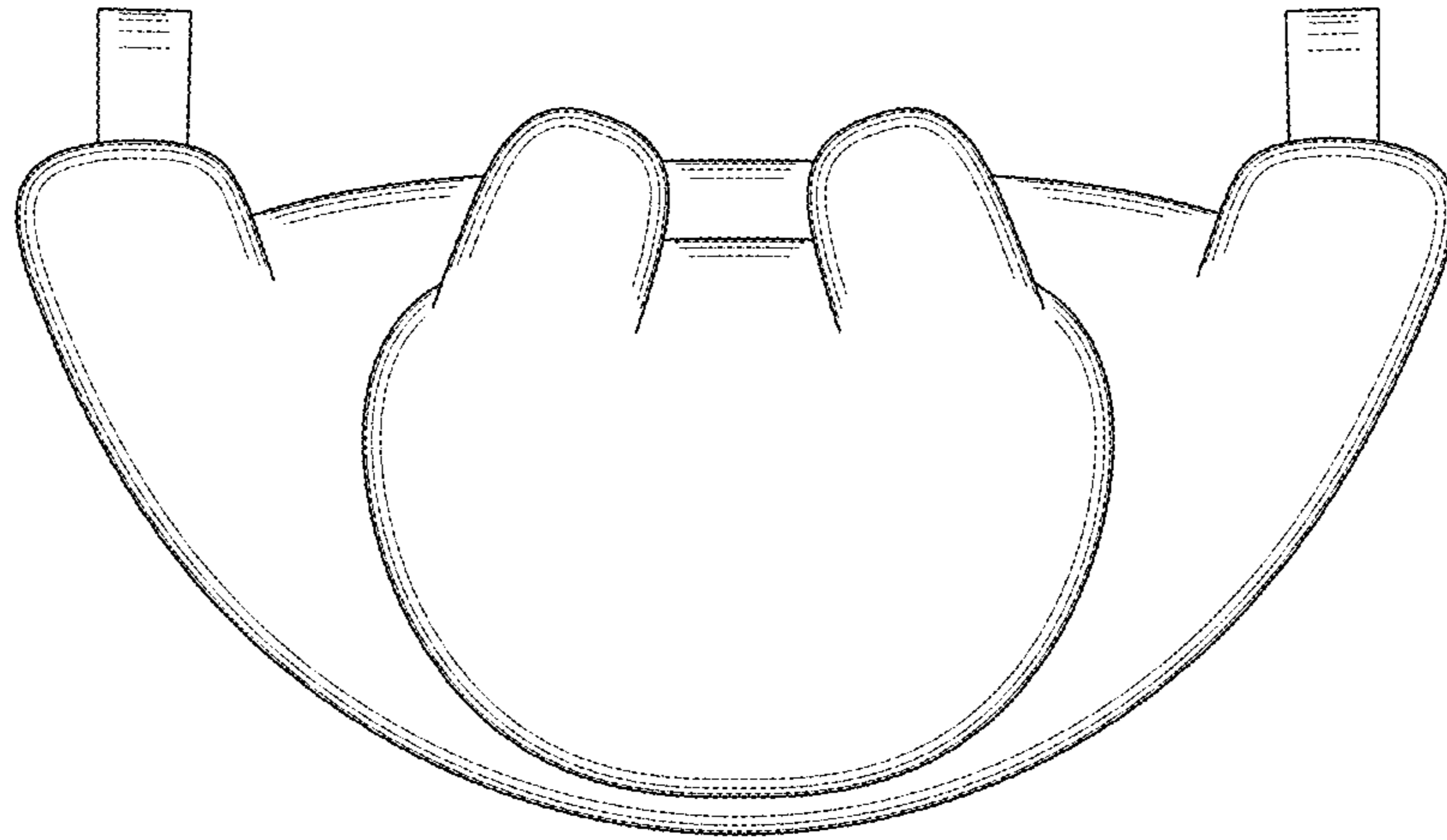
