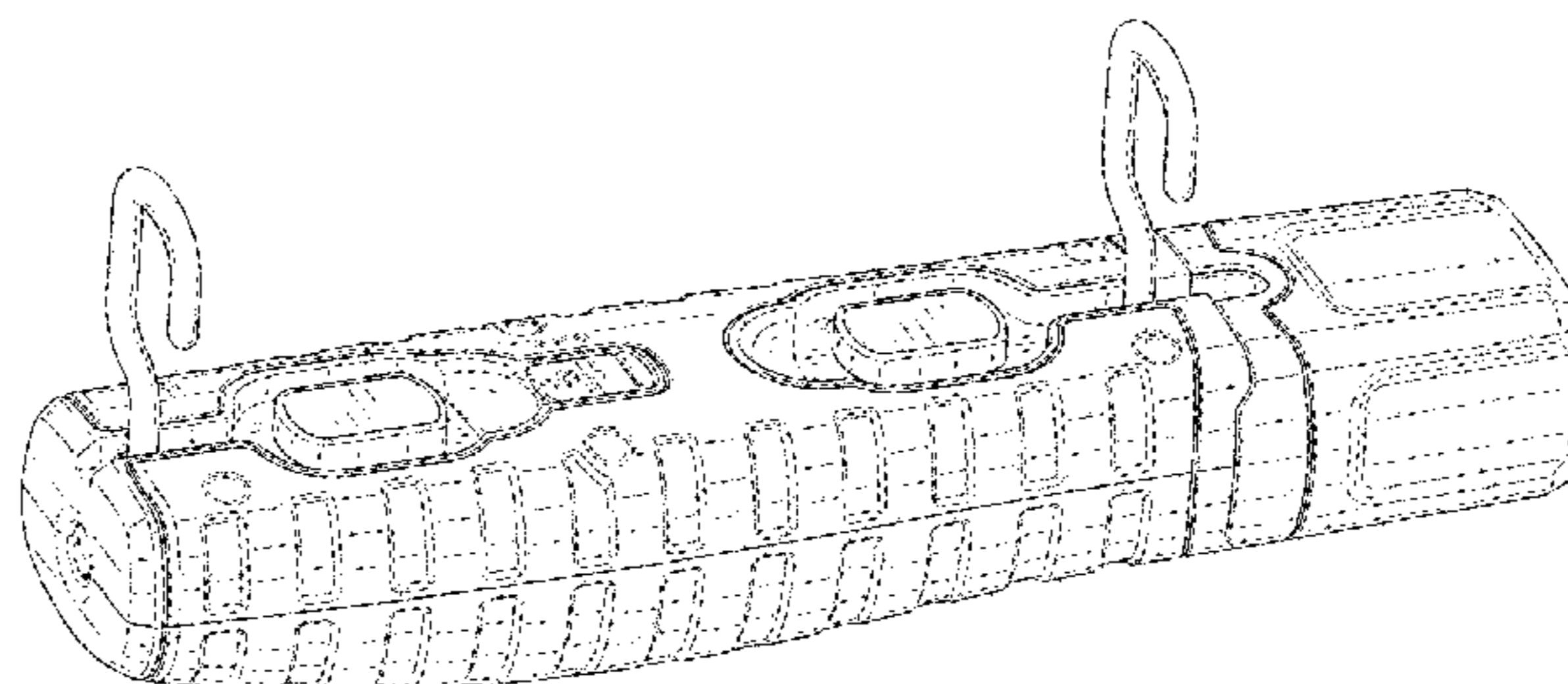
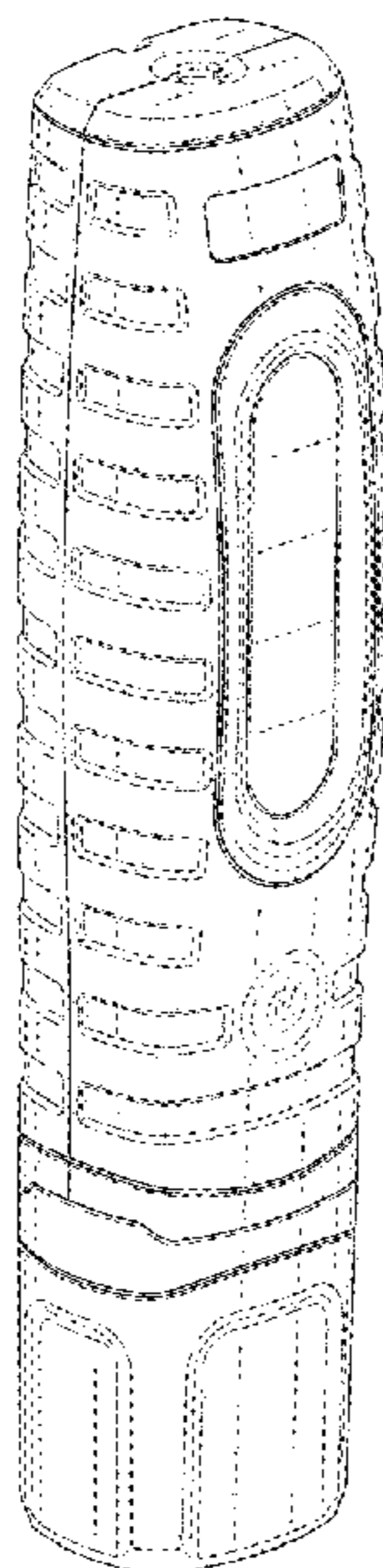
The ornamental design for a working lamp, as shown and described.

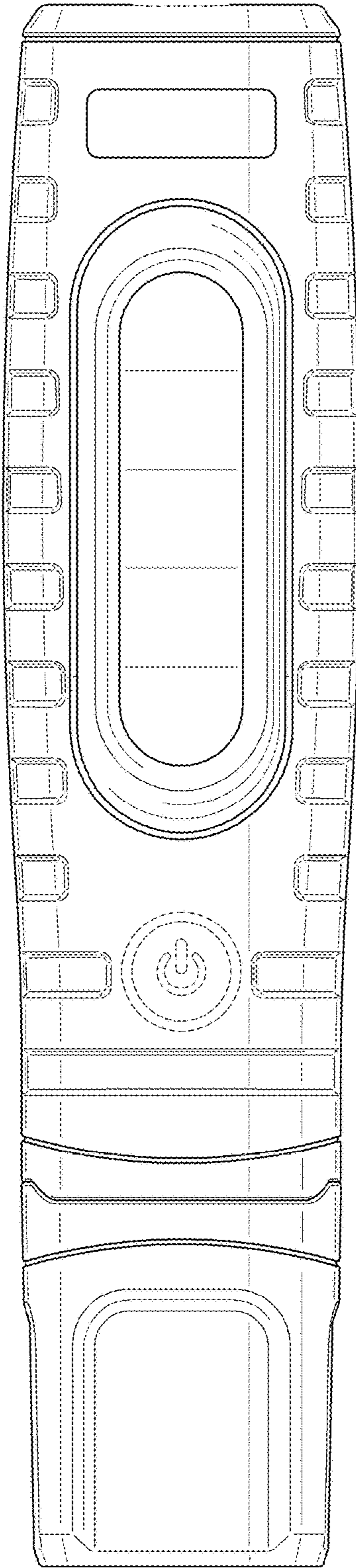

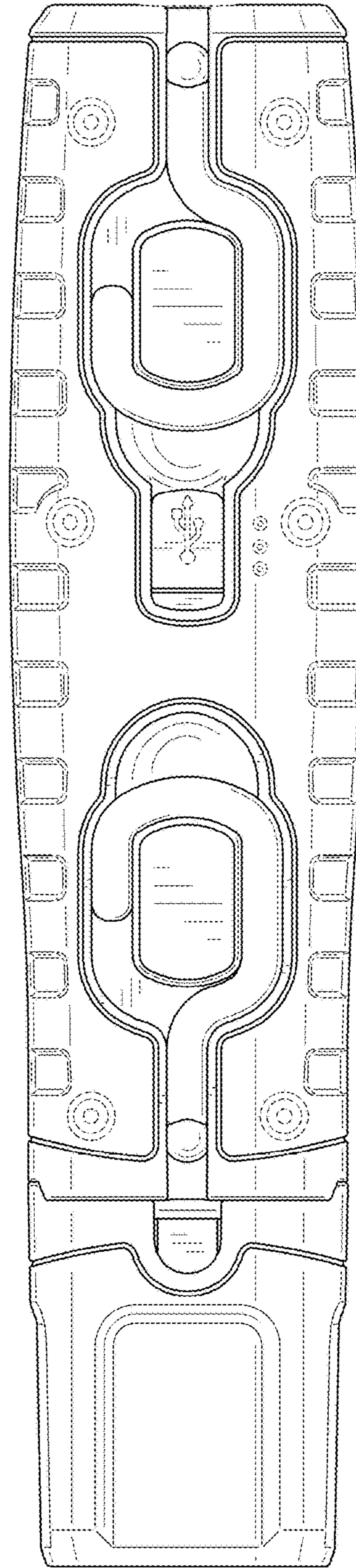

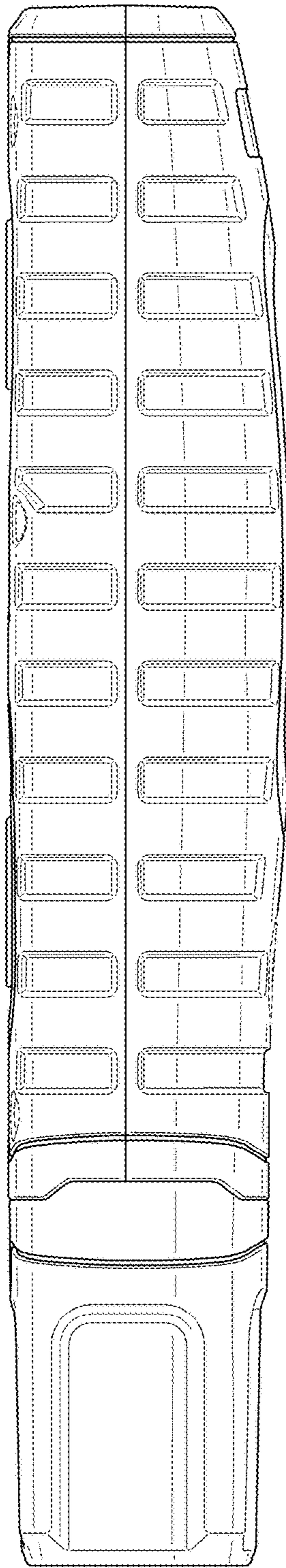

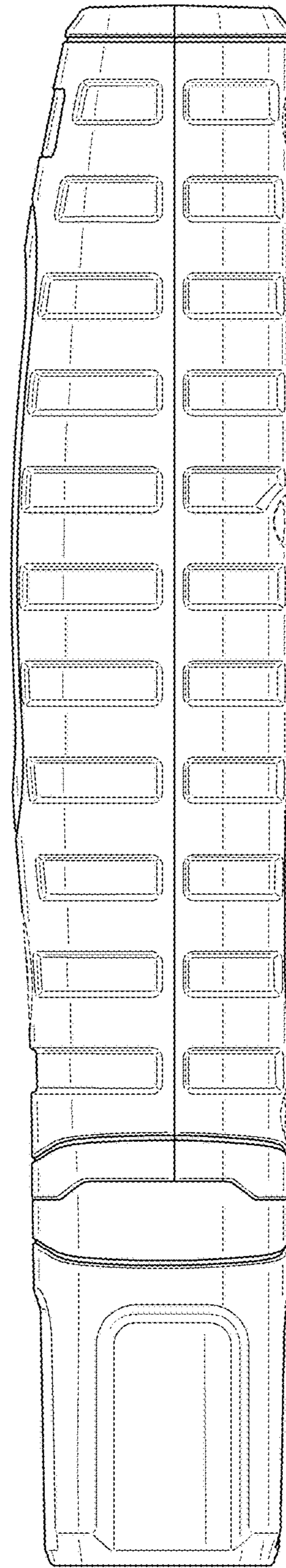

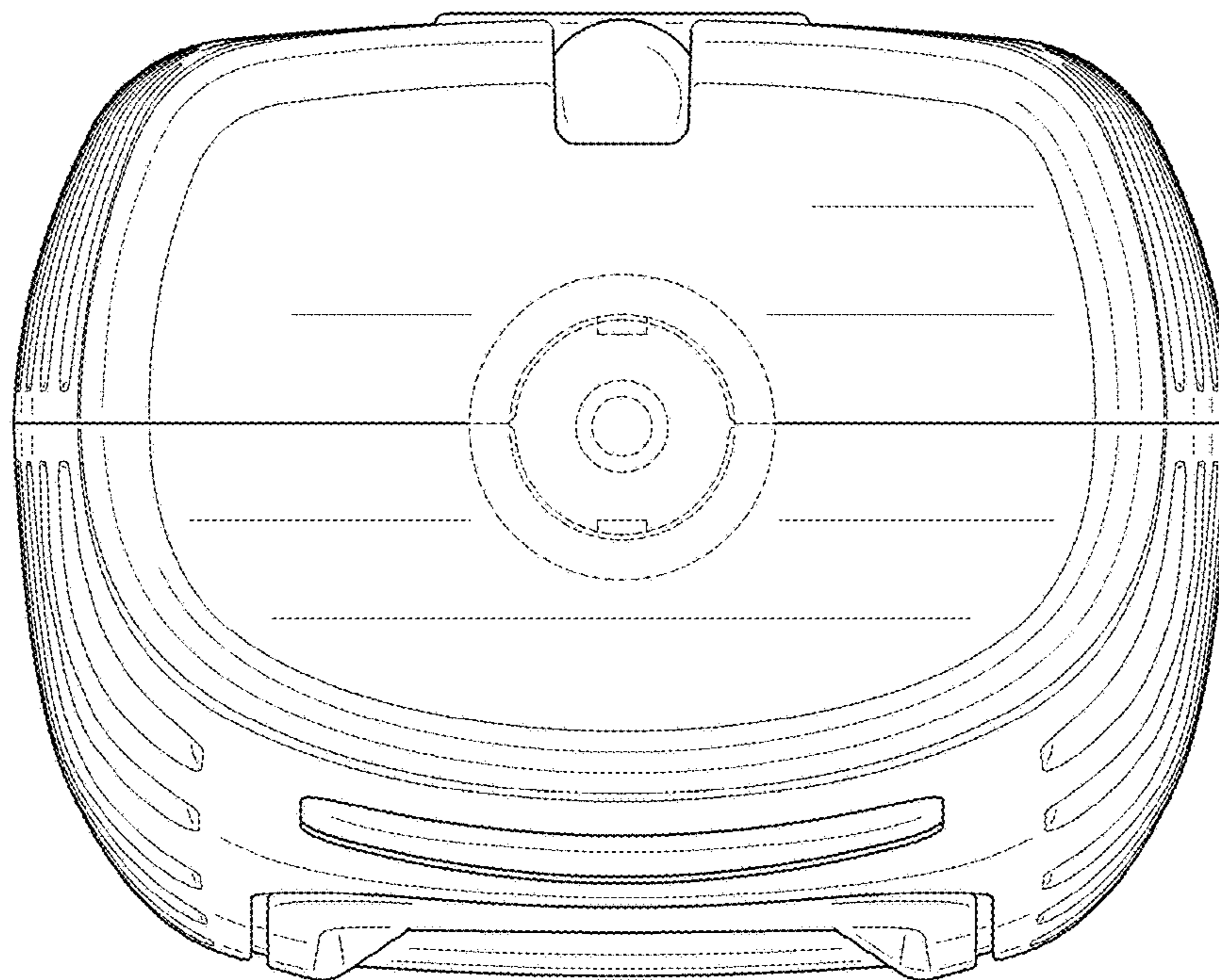

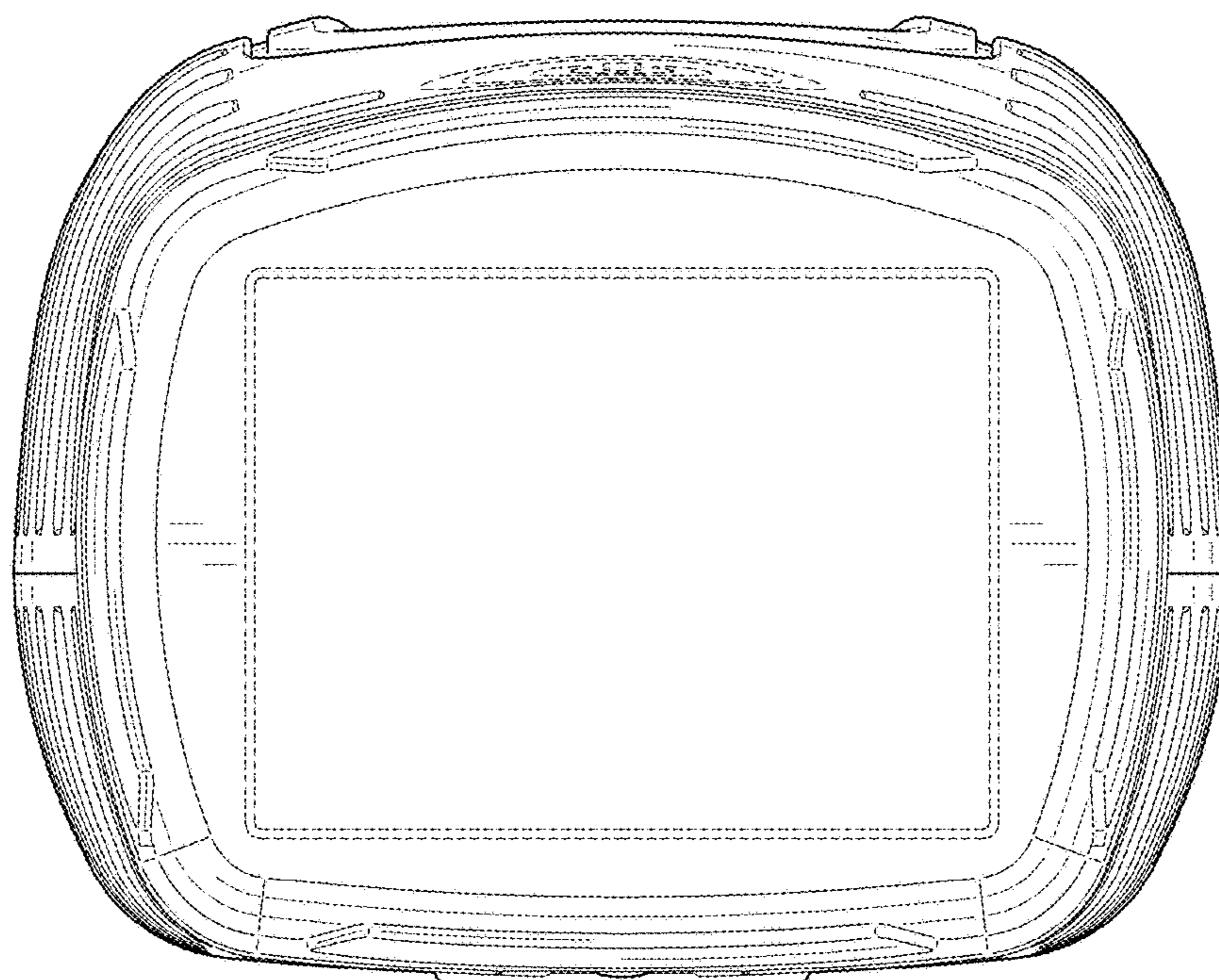

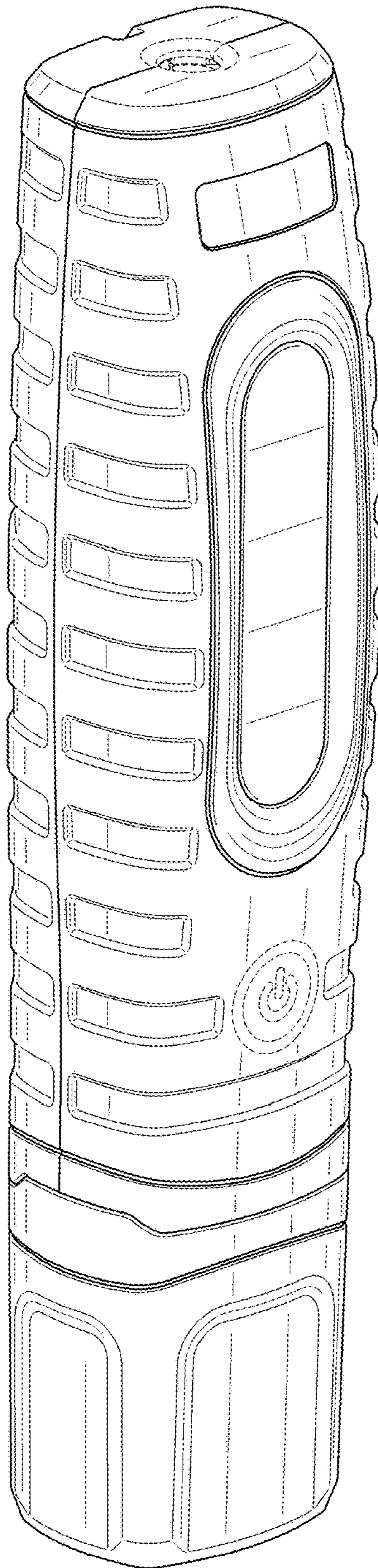

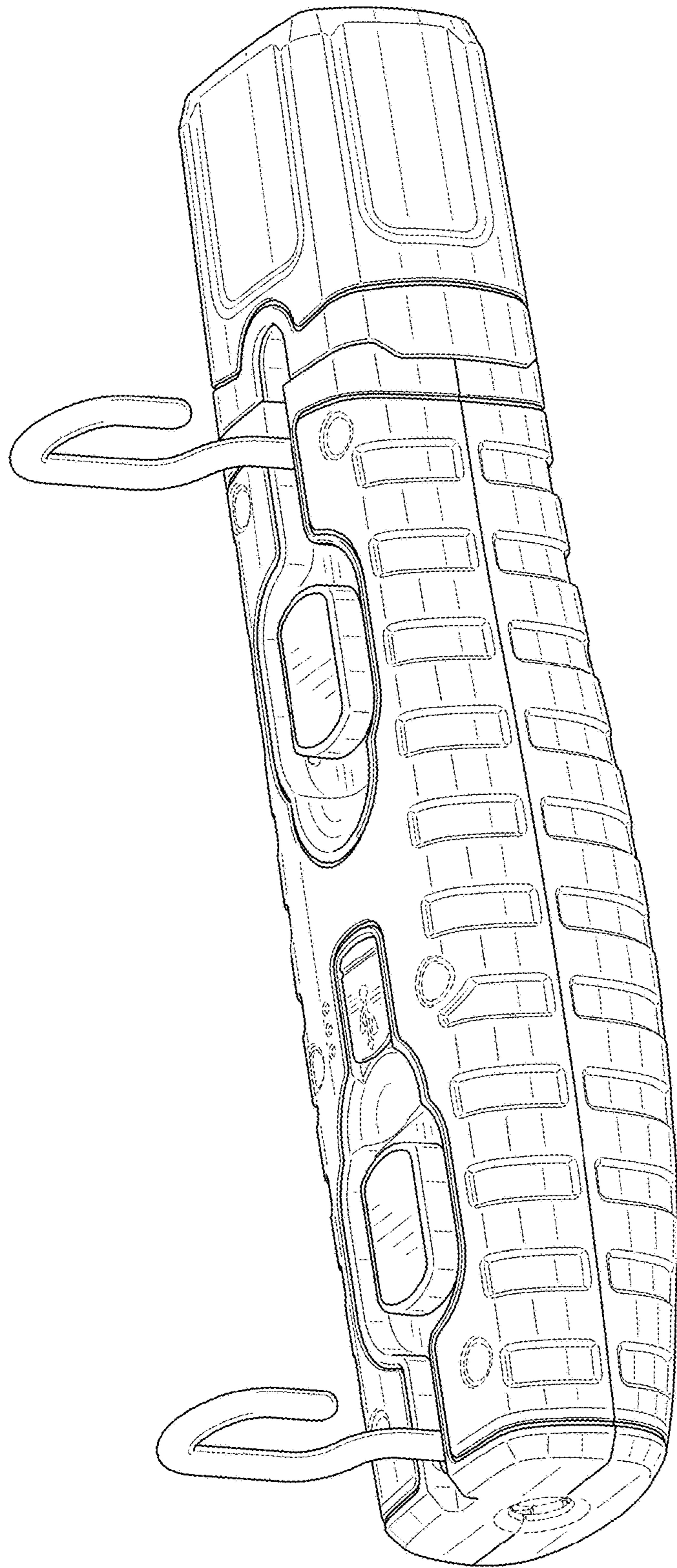
