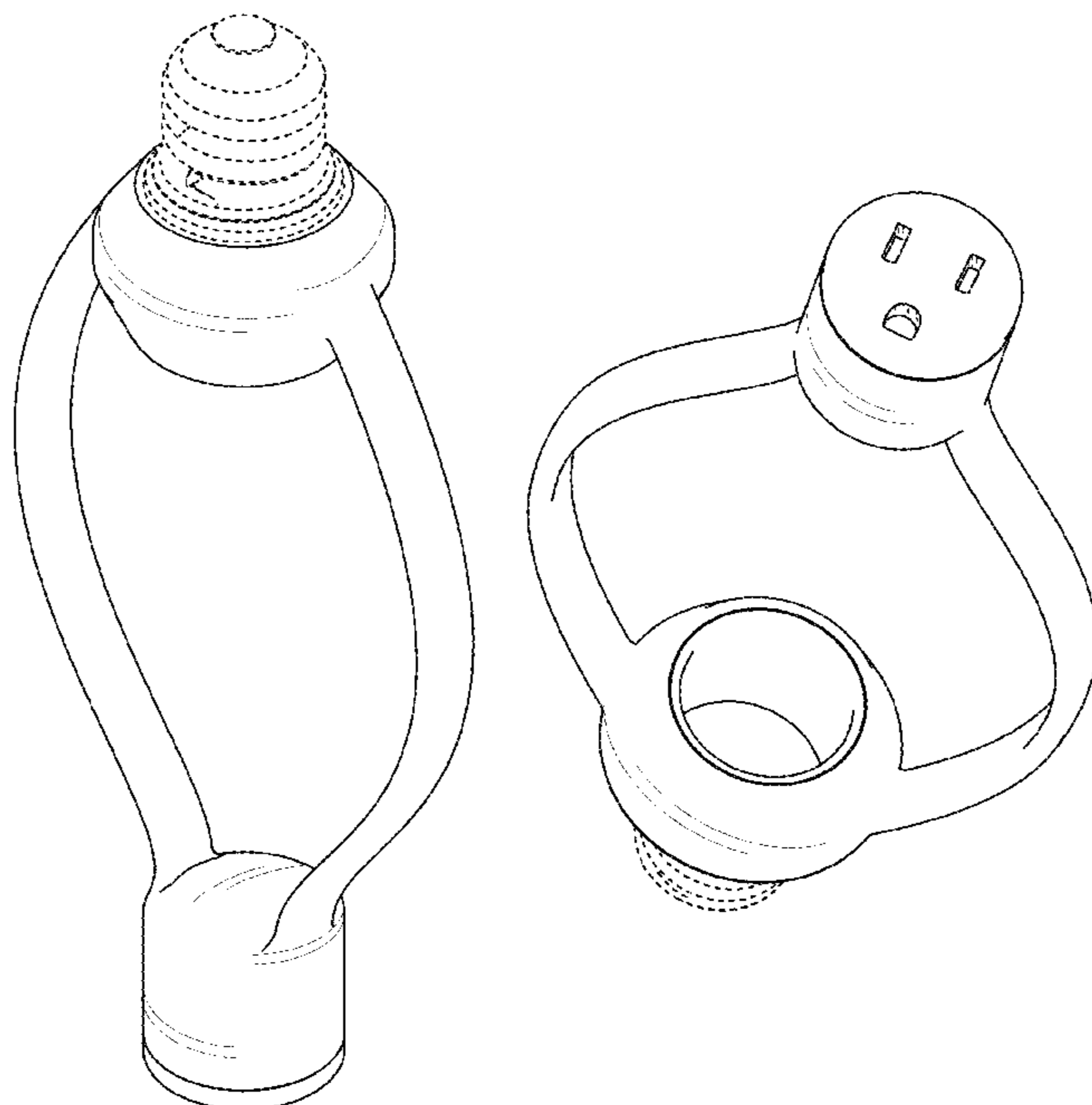
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front-top perspective view of a lighting fixture, showing my new design;

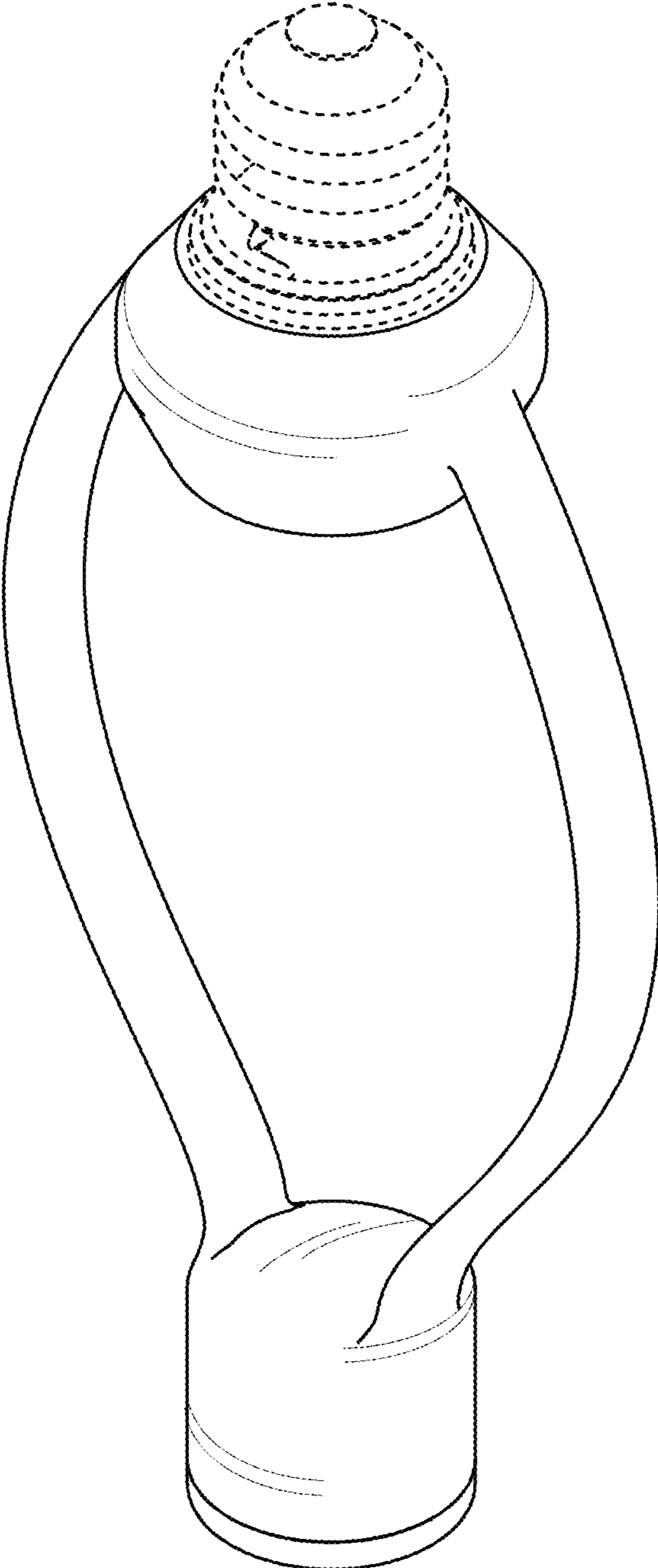

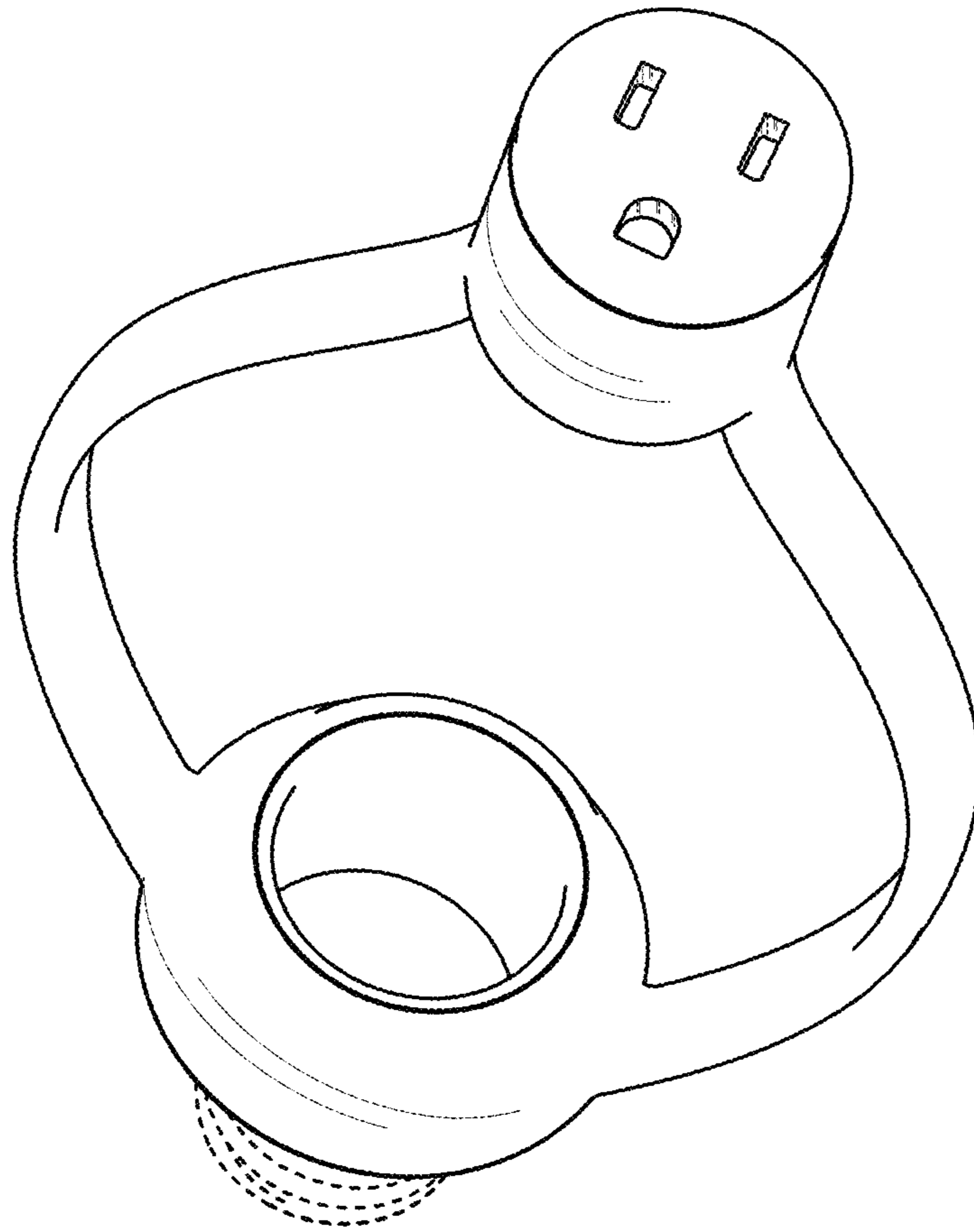

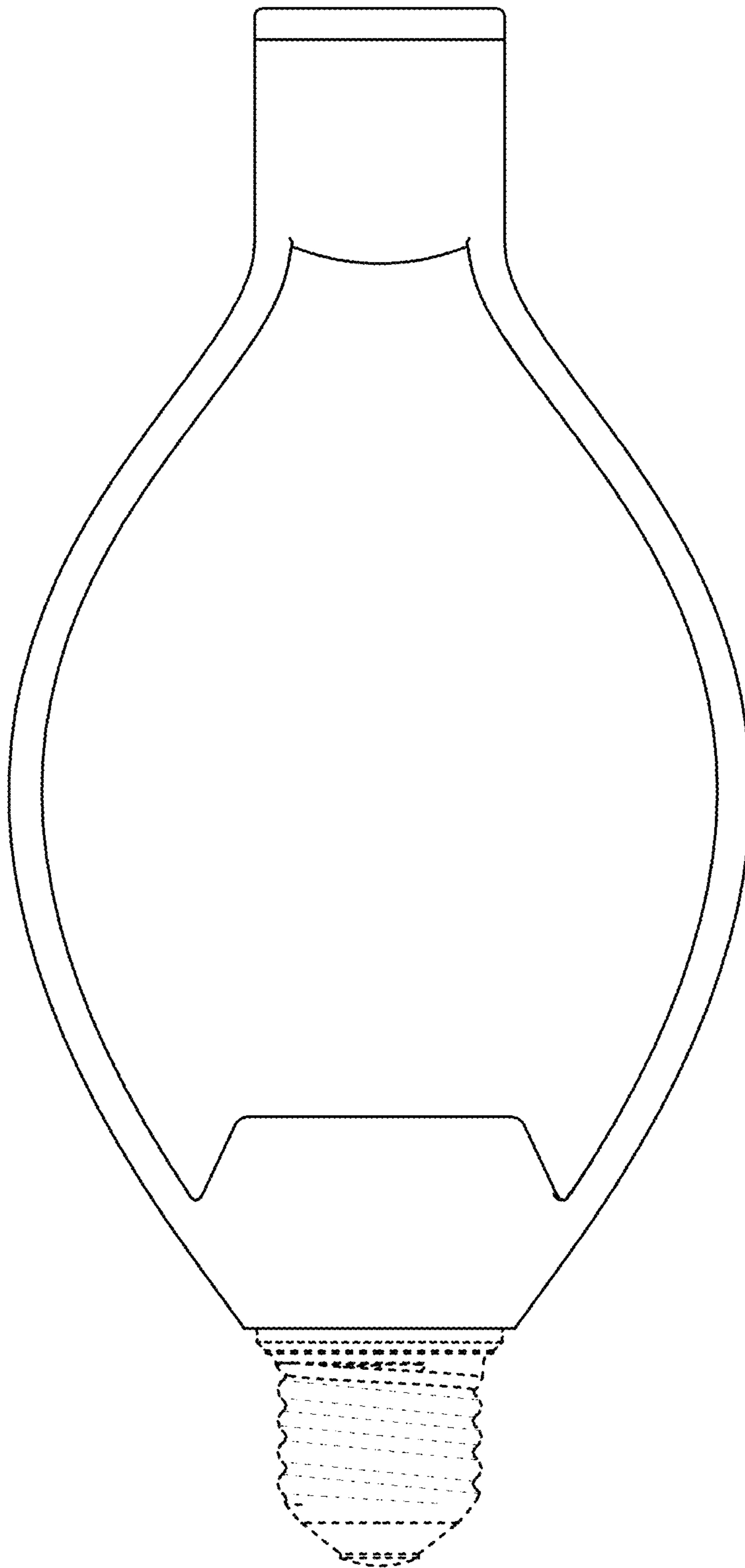

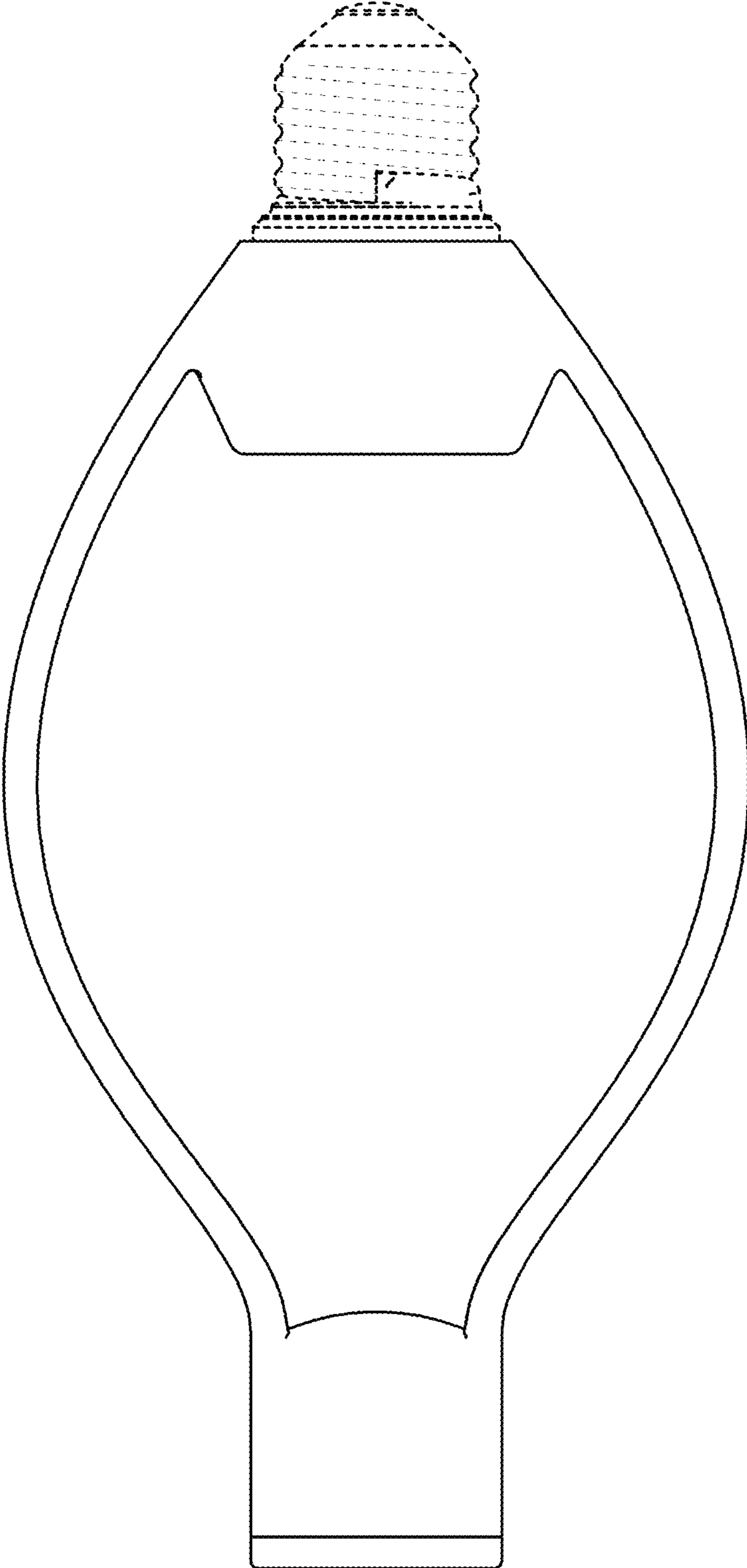

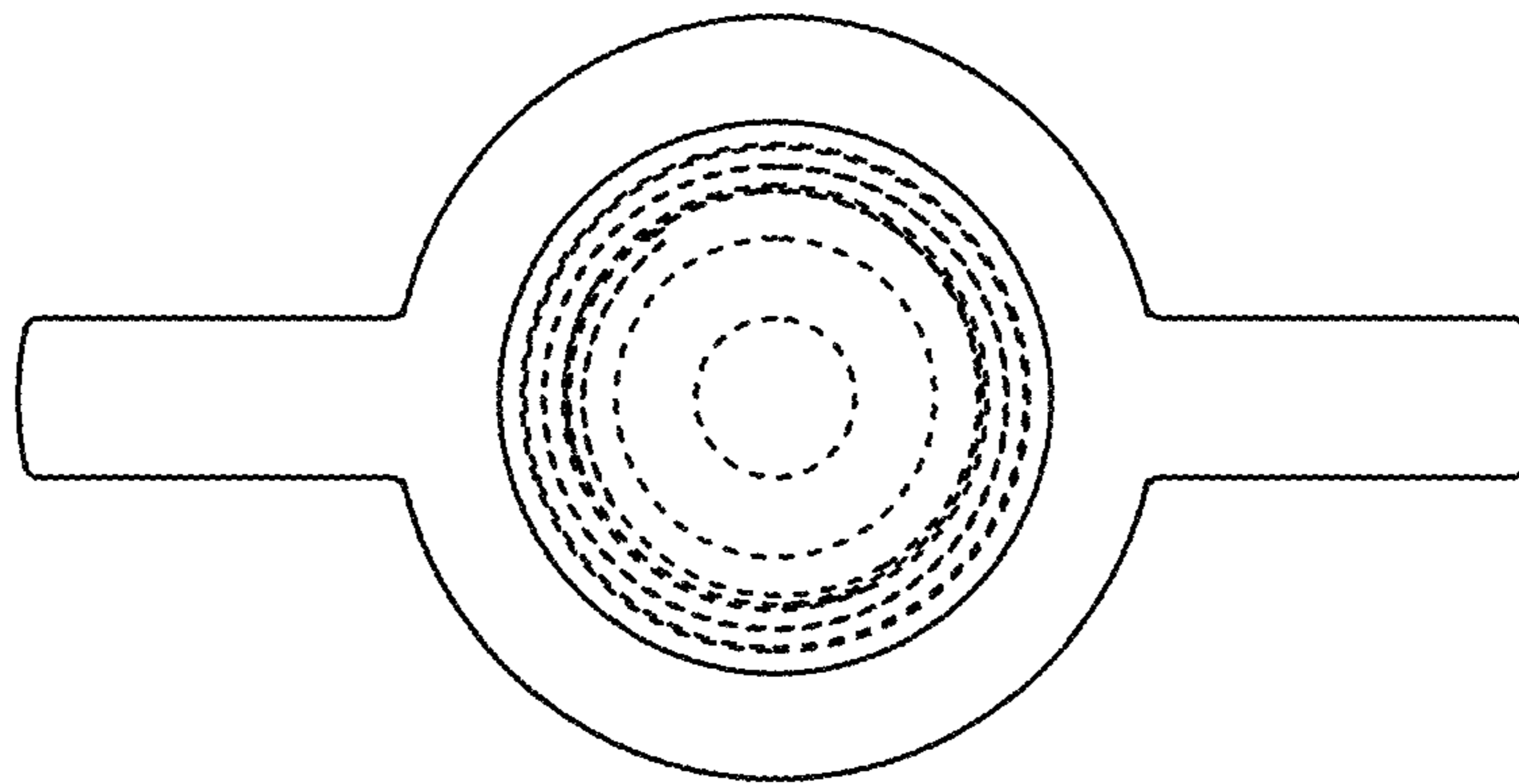

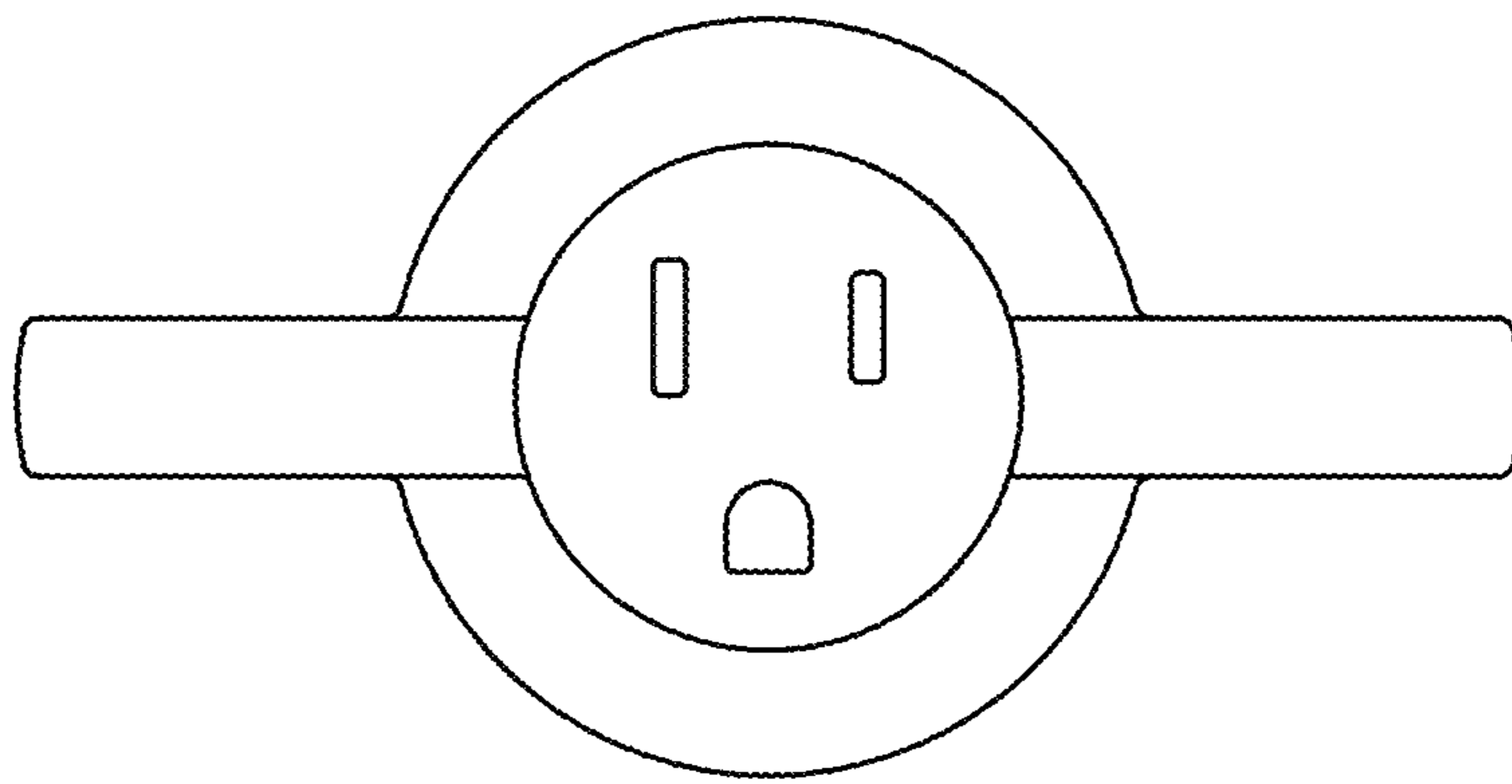

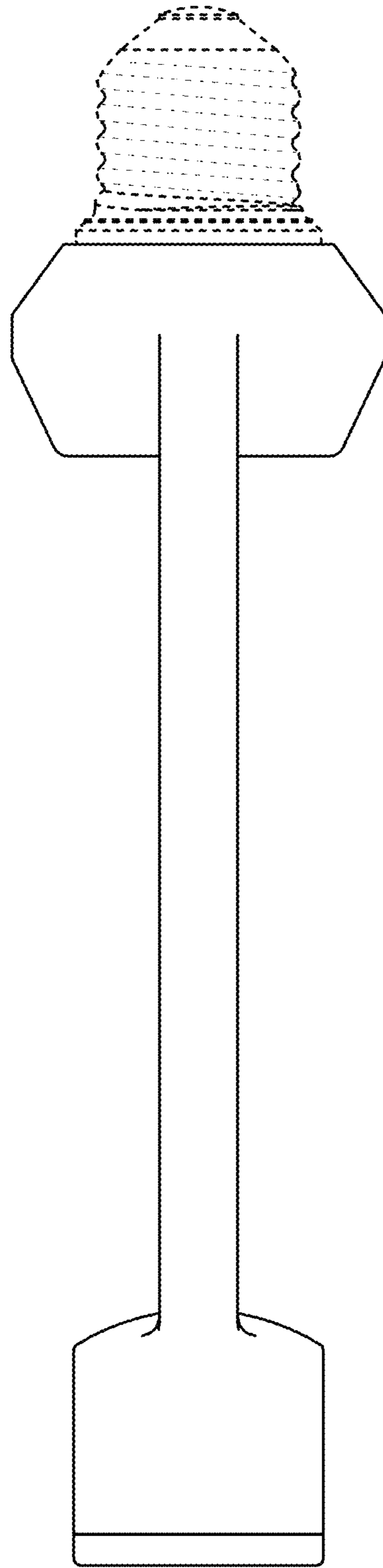

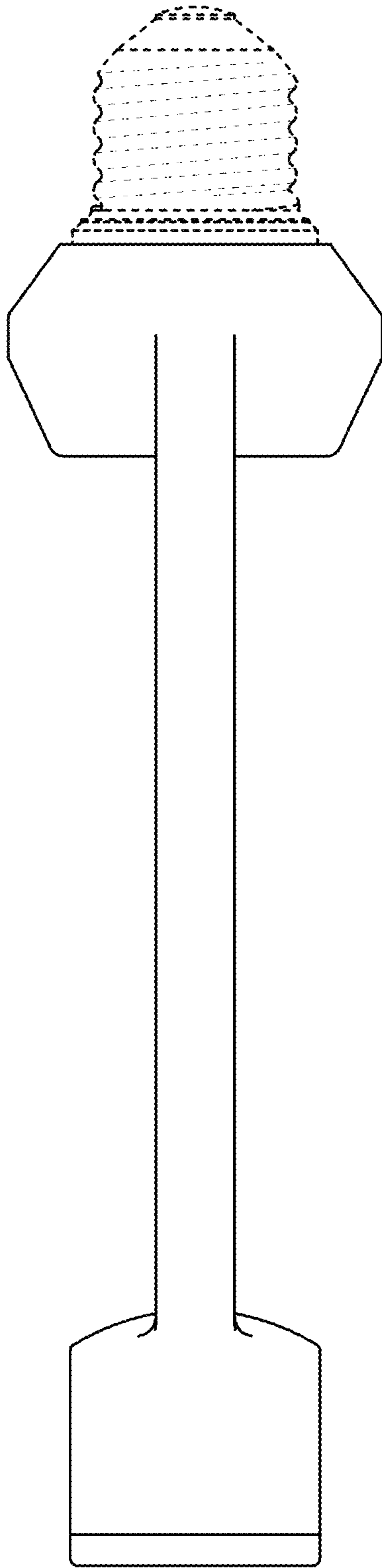
