(57) **CLAIM**

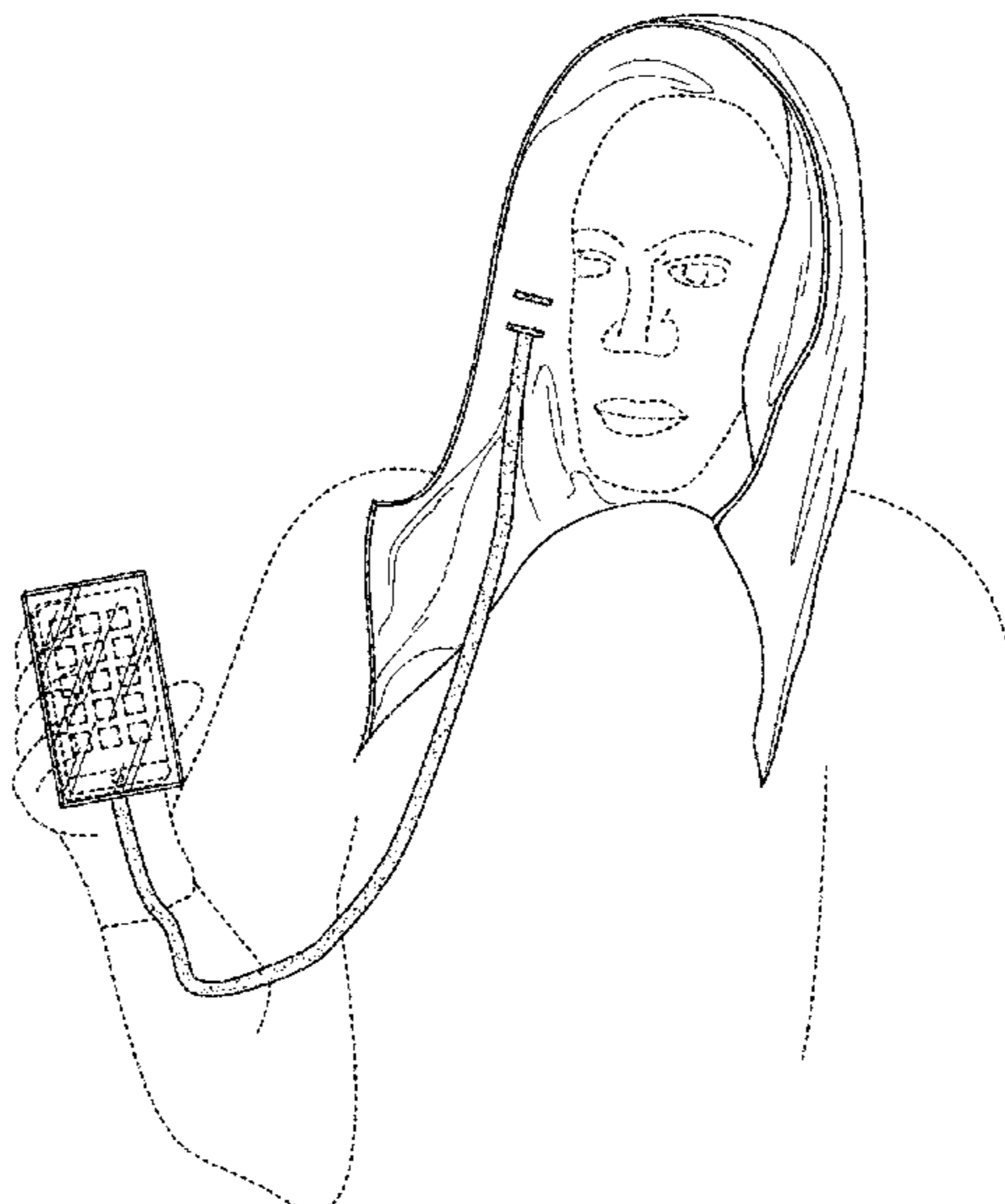
The ornamental design for a hood with movable pocket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hood with movable pocket, shown as it may appear when worn with pocket detached in a position of use;
 FIG. 2 is a perspective view thereof, with the pocket shown in an alternative position of use;
 FIG. 3 is a front elevation view thereof;
 FIG. 4 is a rear elevation view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a side elevation view thereof;
 FIG. 8 is an opposite side elevation view thereof;
 FIG. 9 is a section-cut view of the interior of the hood as taken from lines 9 in FIG. 3, with the pocket shown attached; and,
 FIG. 10 is a section-cut view of the interior of the hood as taken from lines 10 in FIG. 3, with the pocket shown detached.

The partial human figure and the electronic device outlined by broken lines represents environmental structure that forms no part of the claimed design.

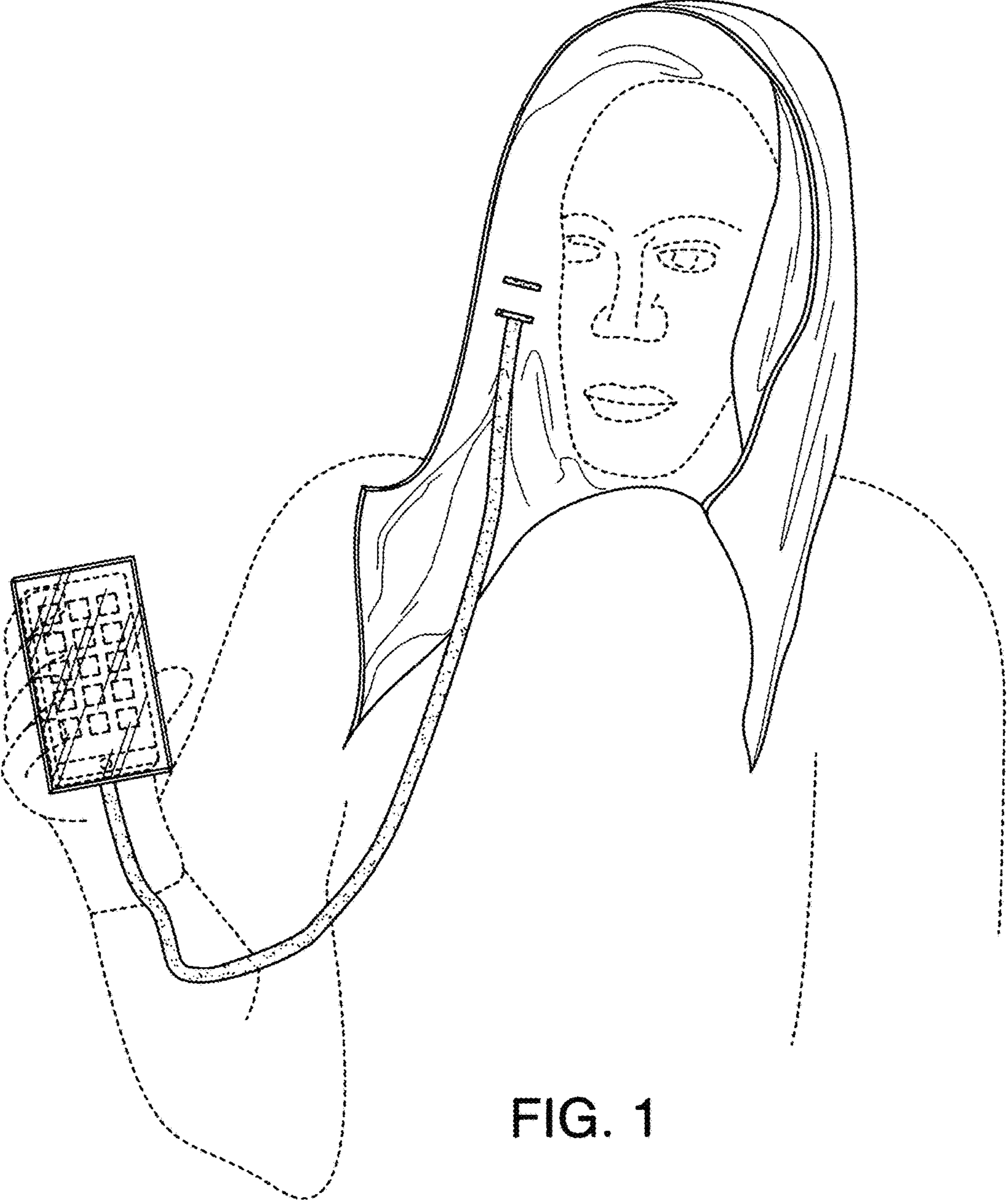

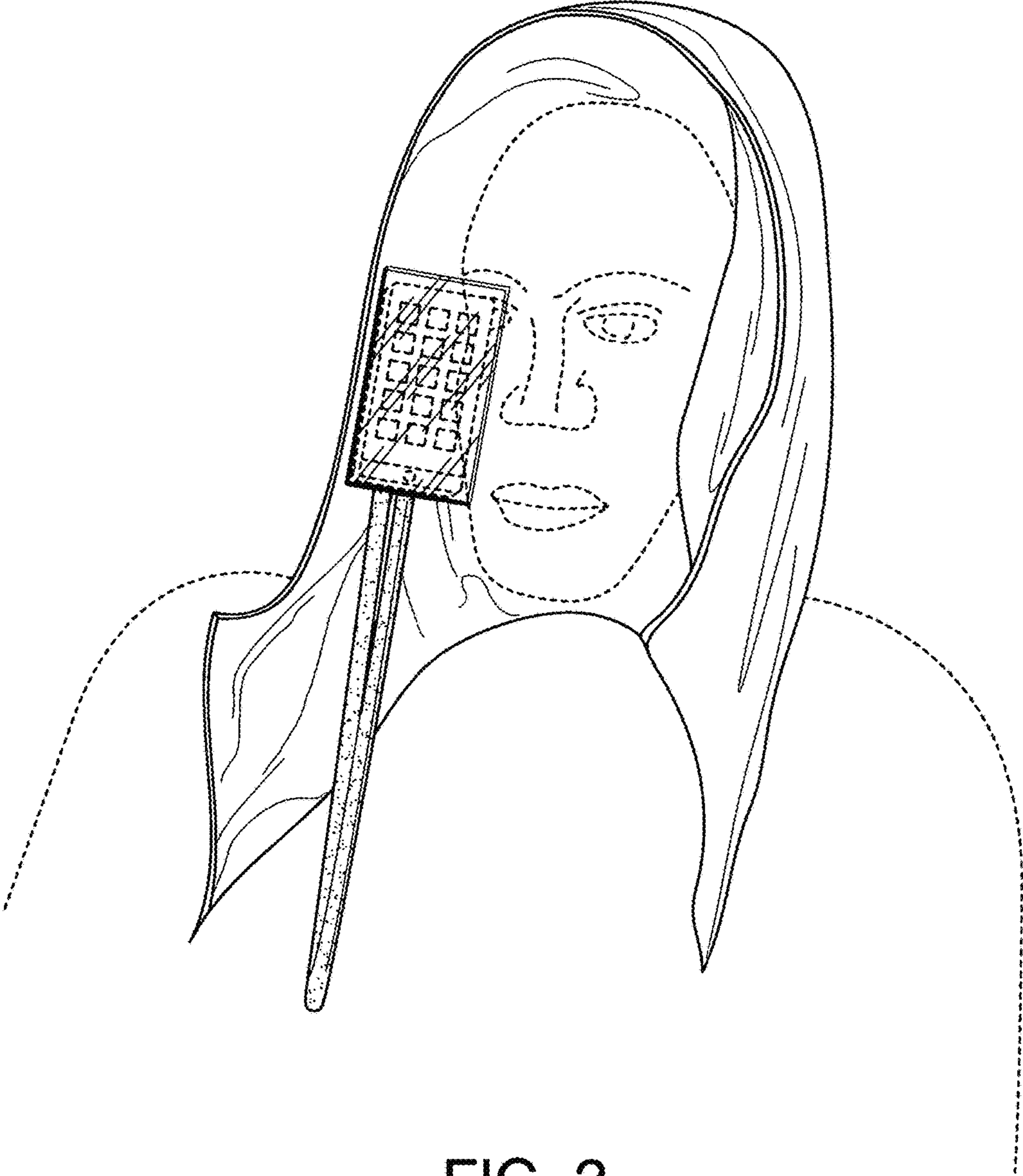

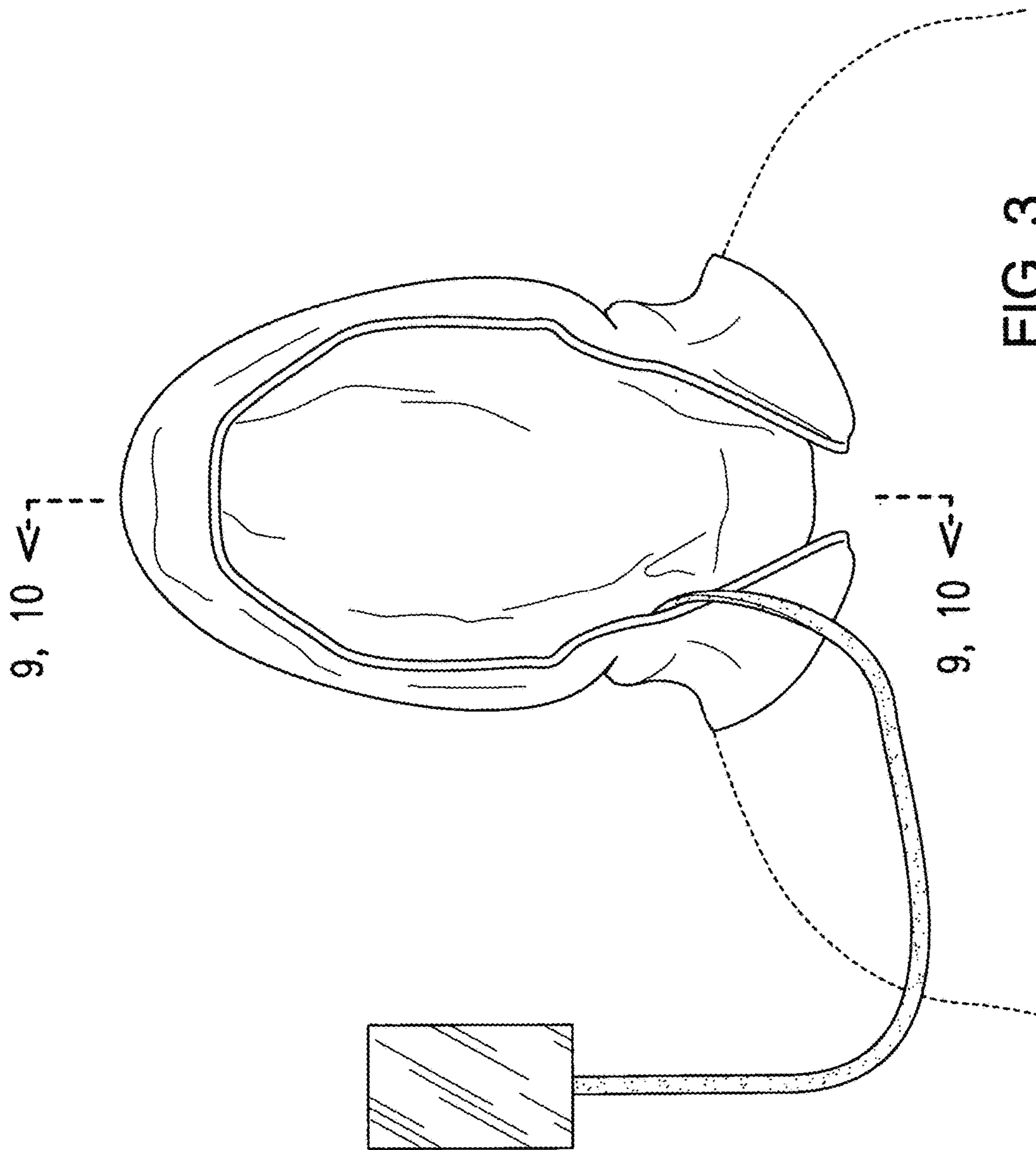

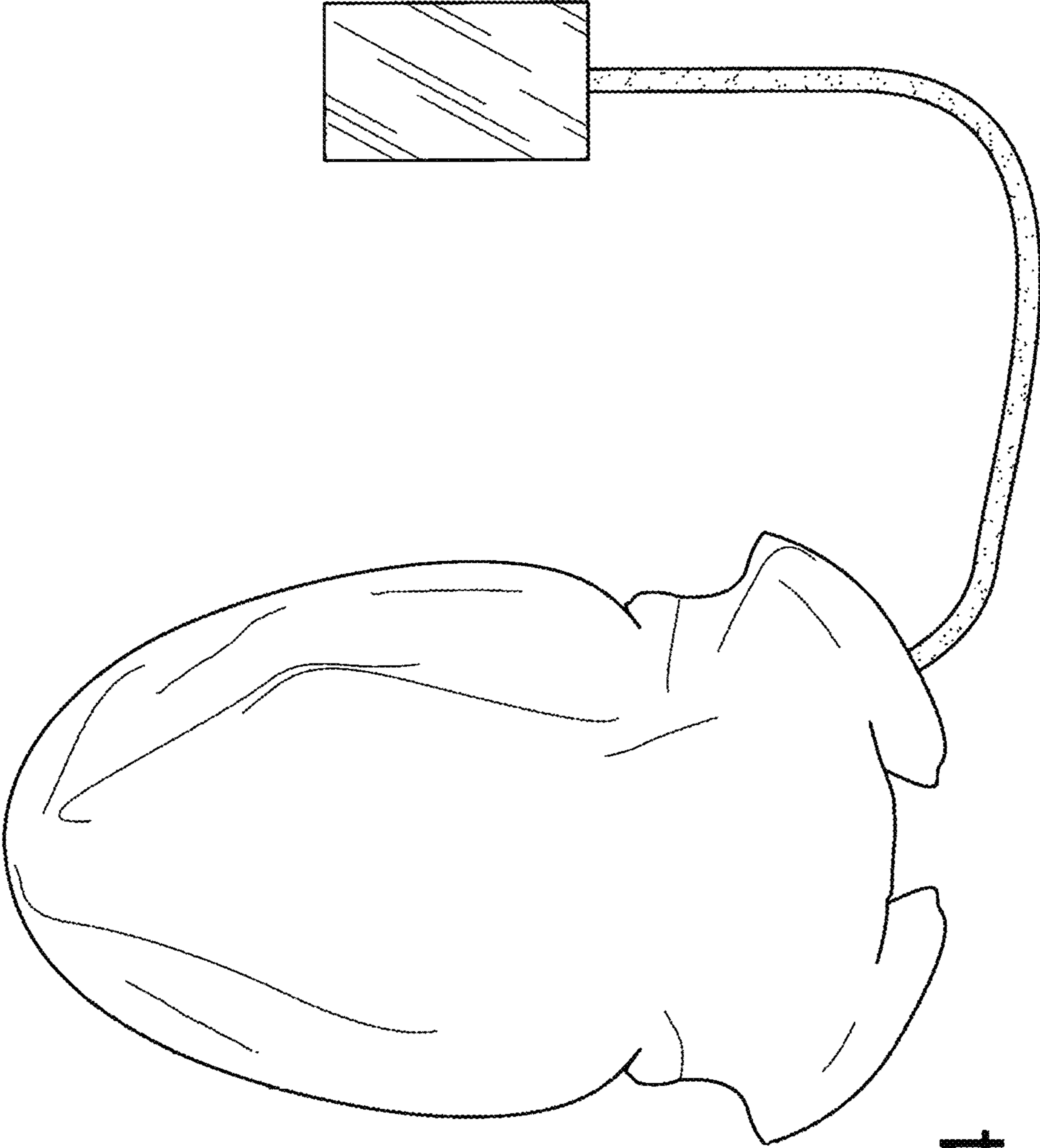

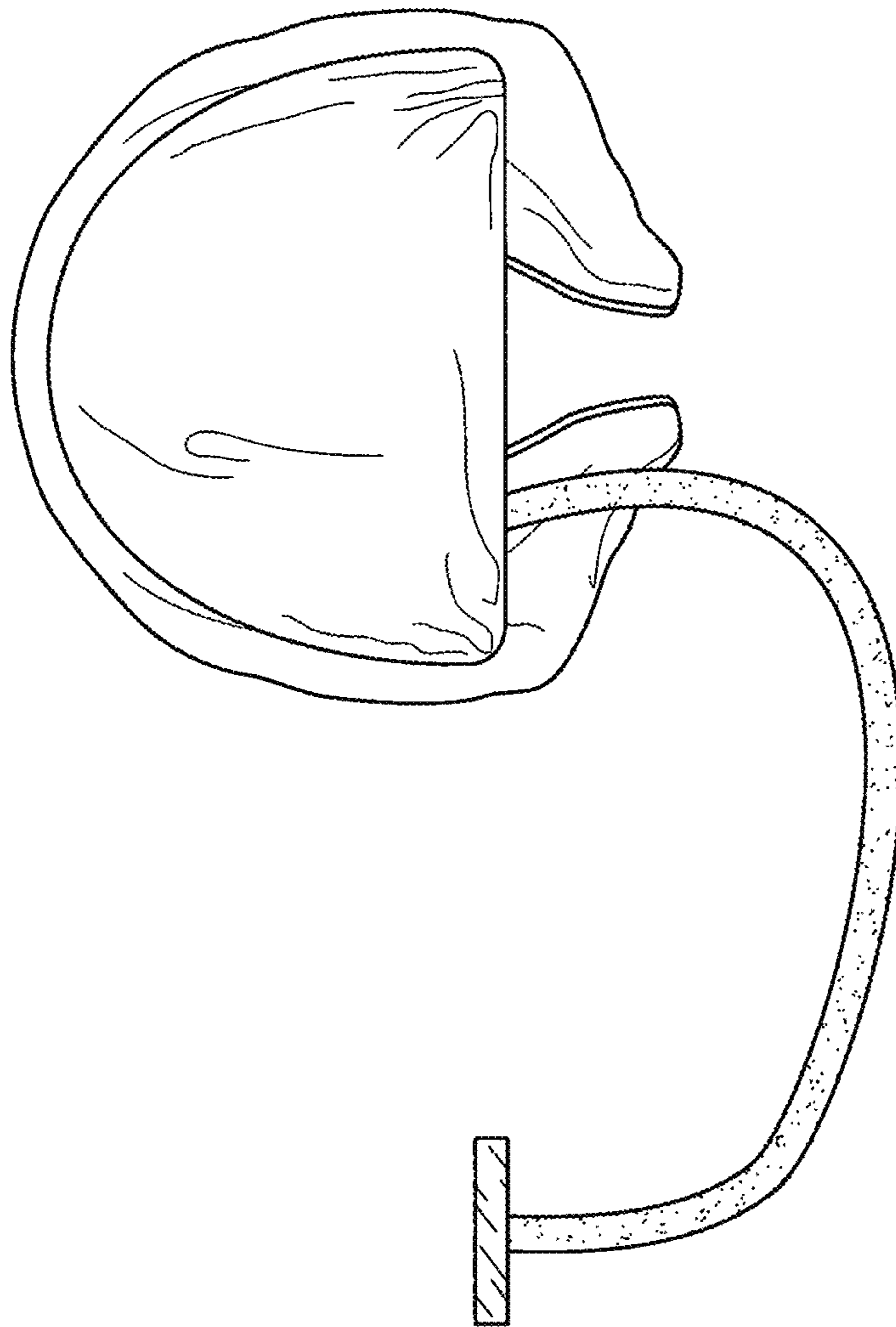

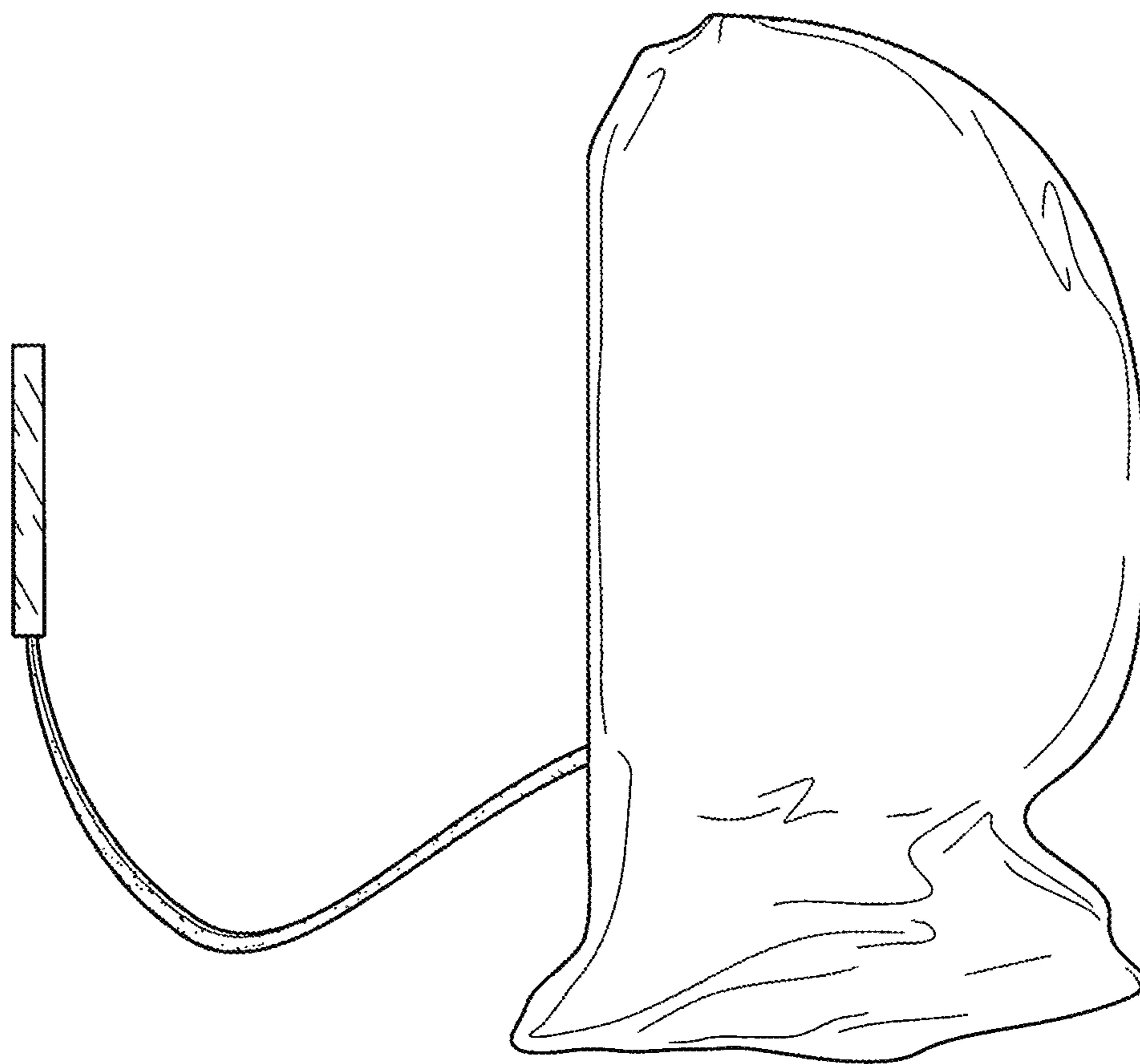

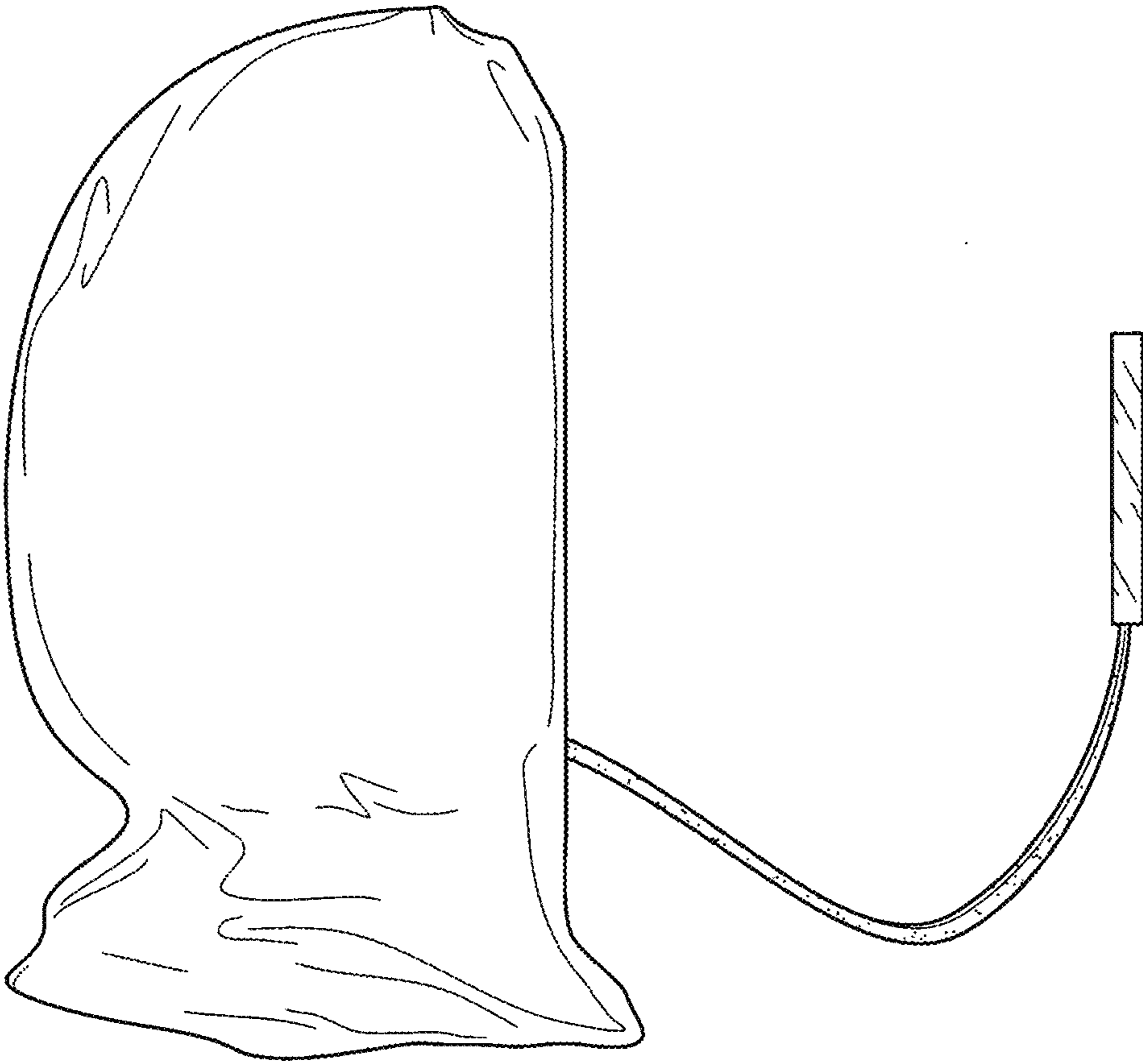

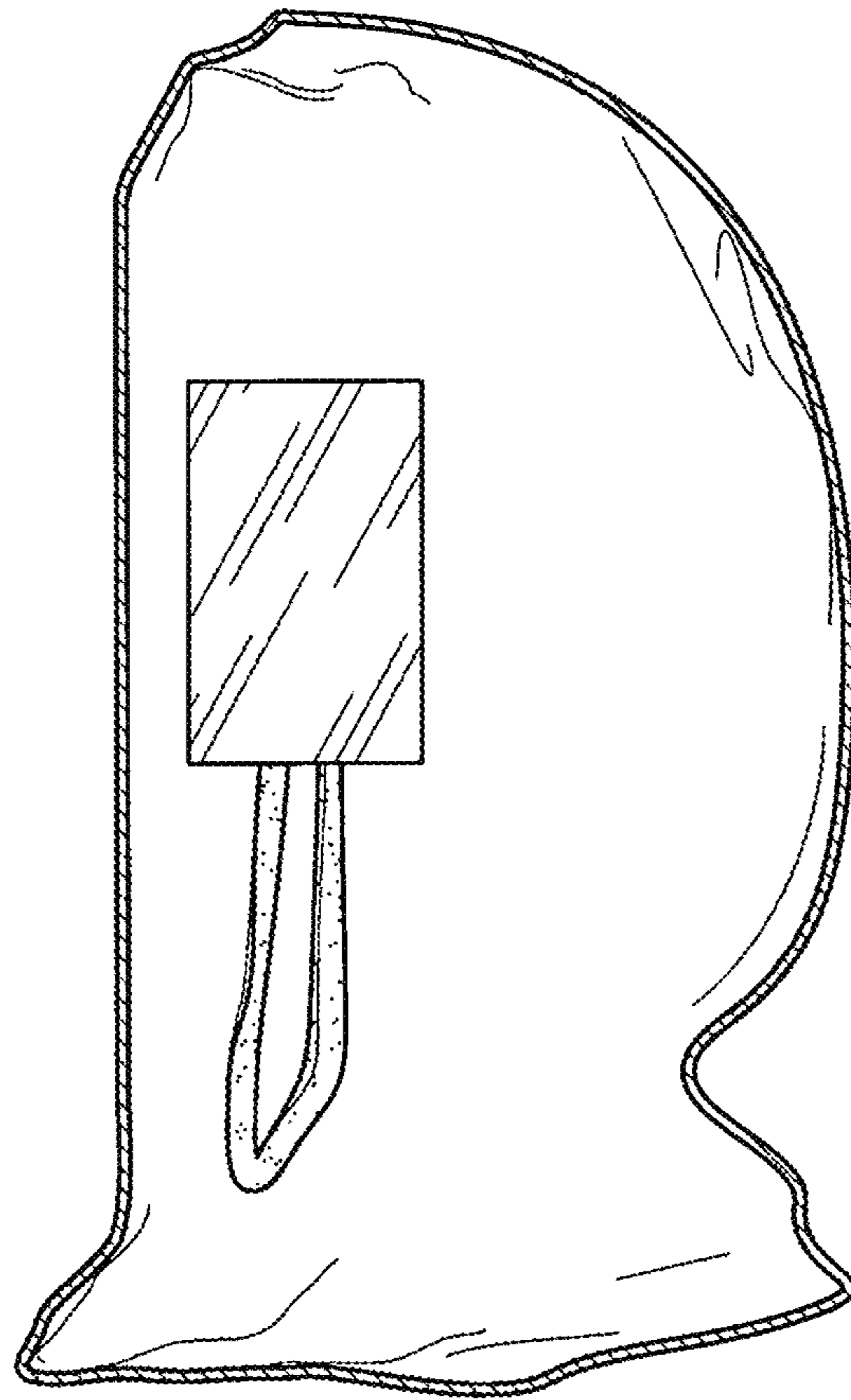

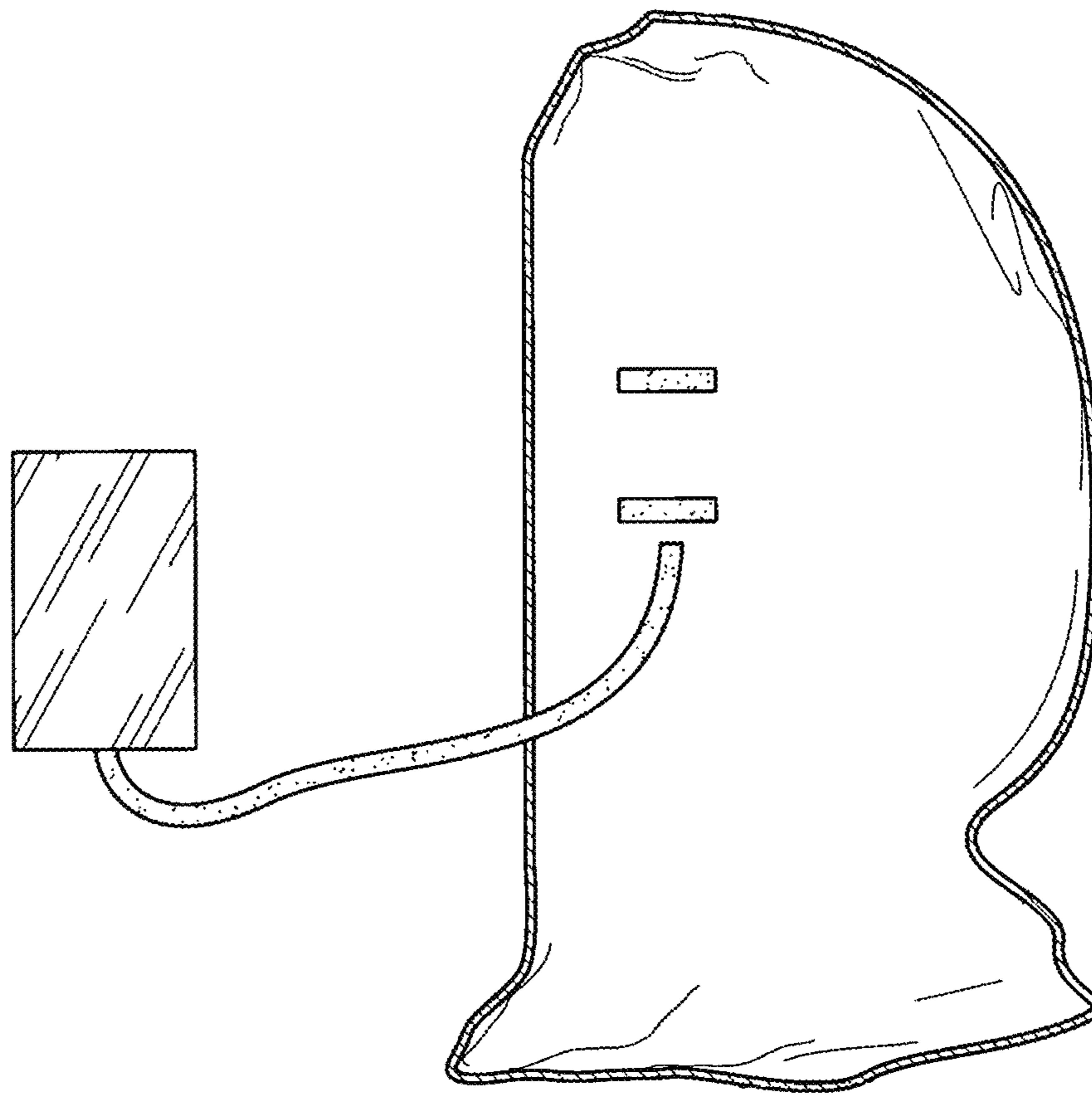
