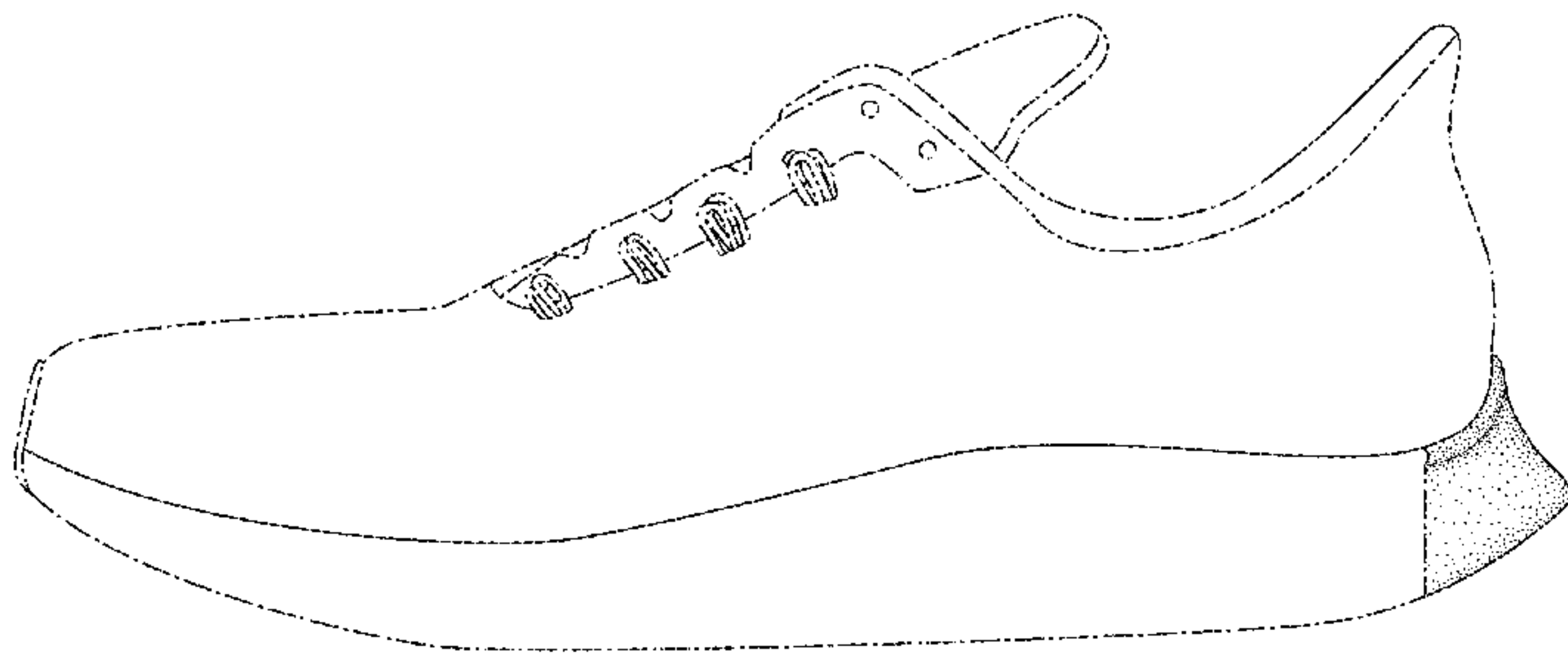
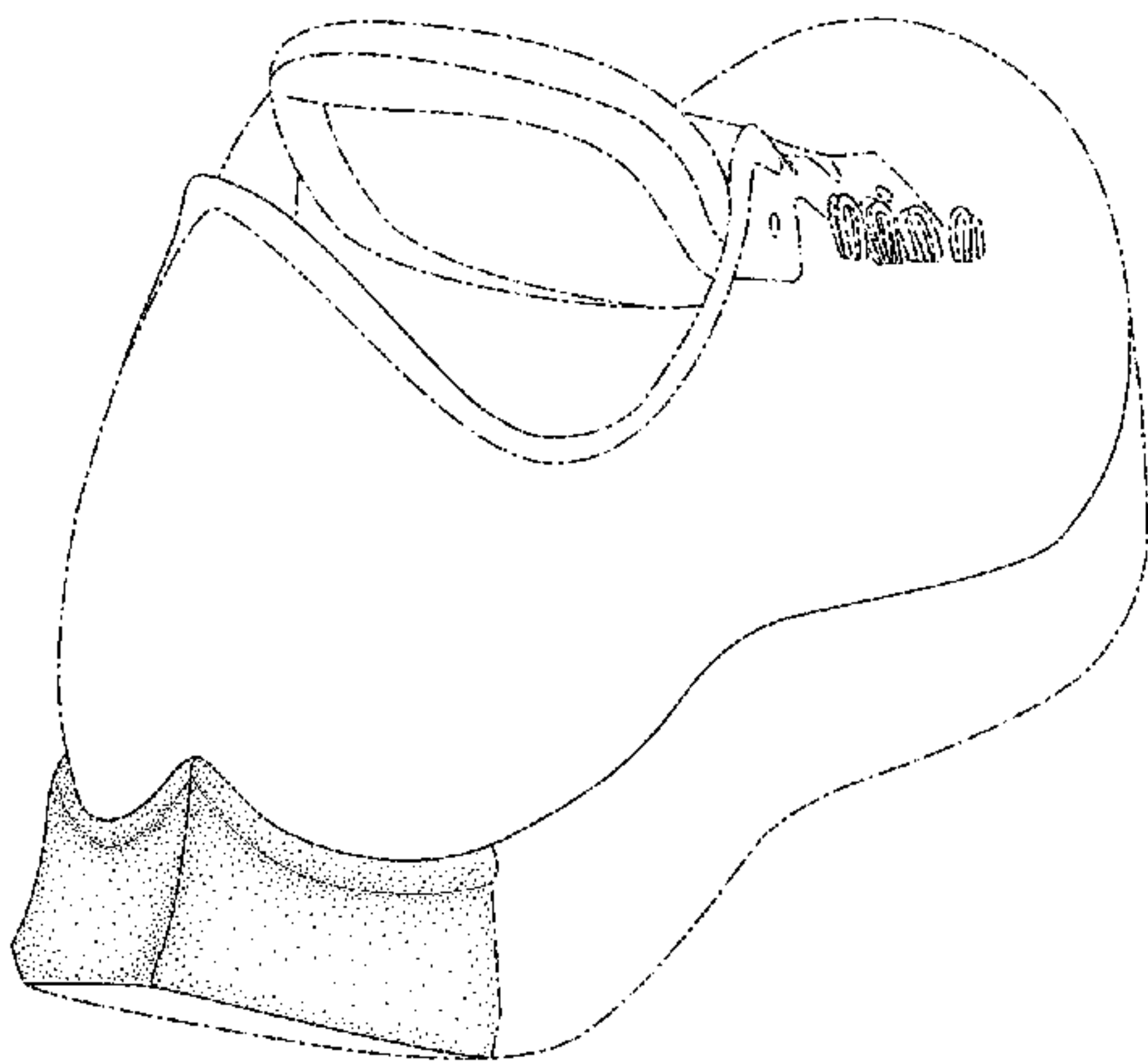
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a first rear perspective view thereof;
FIG. 4 is a second rear perspective view thereof; and,
FIG. 5 is an opposite side view thereof.

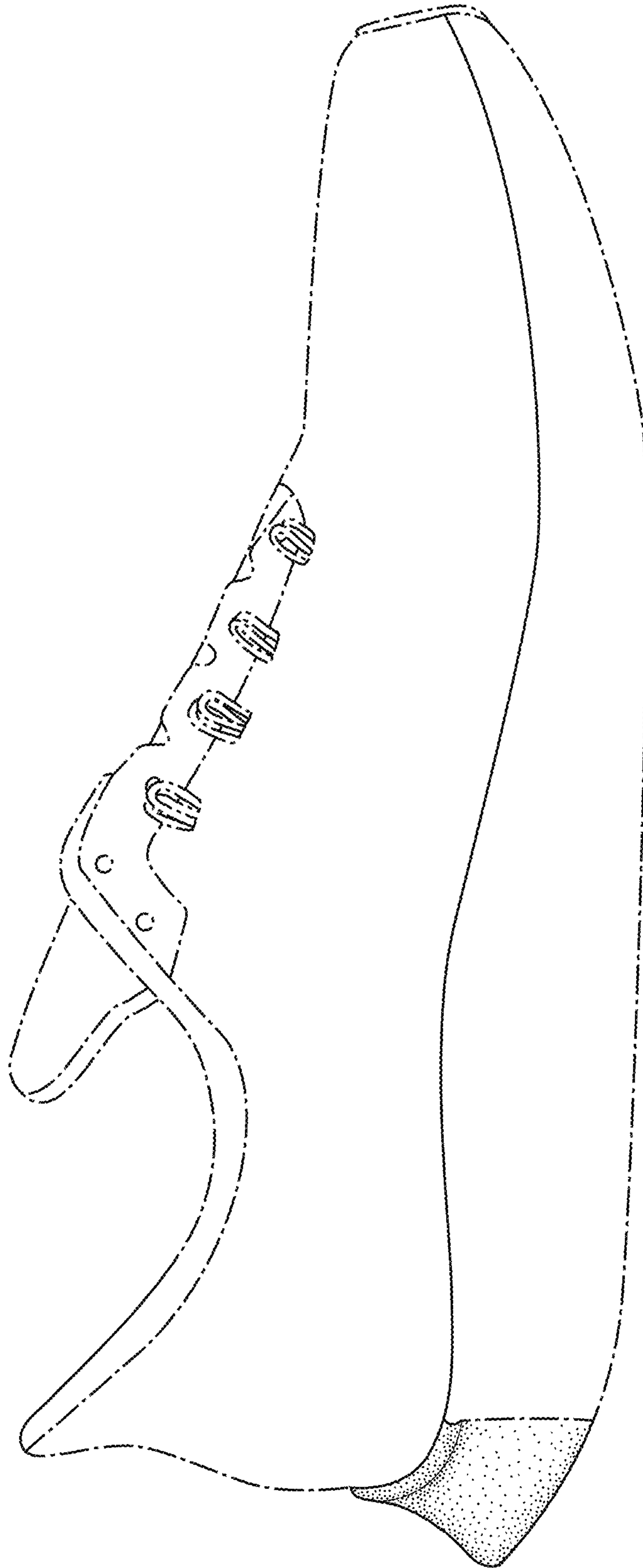

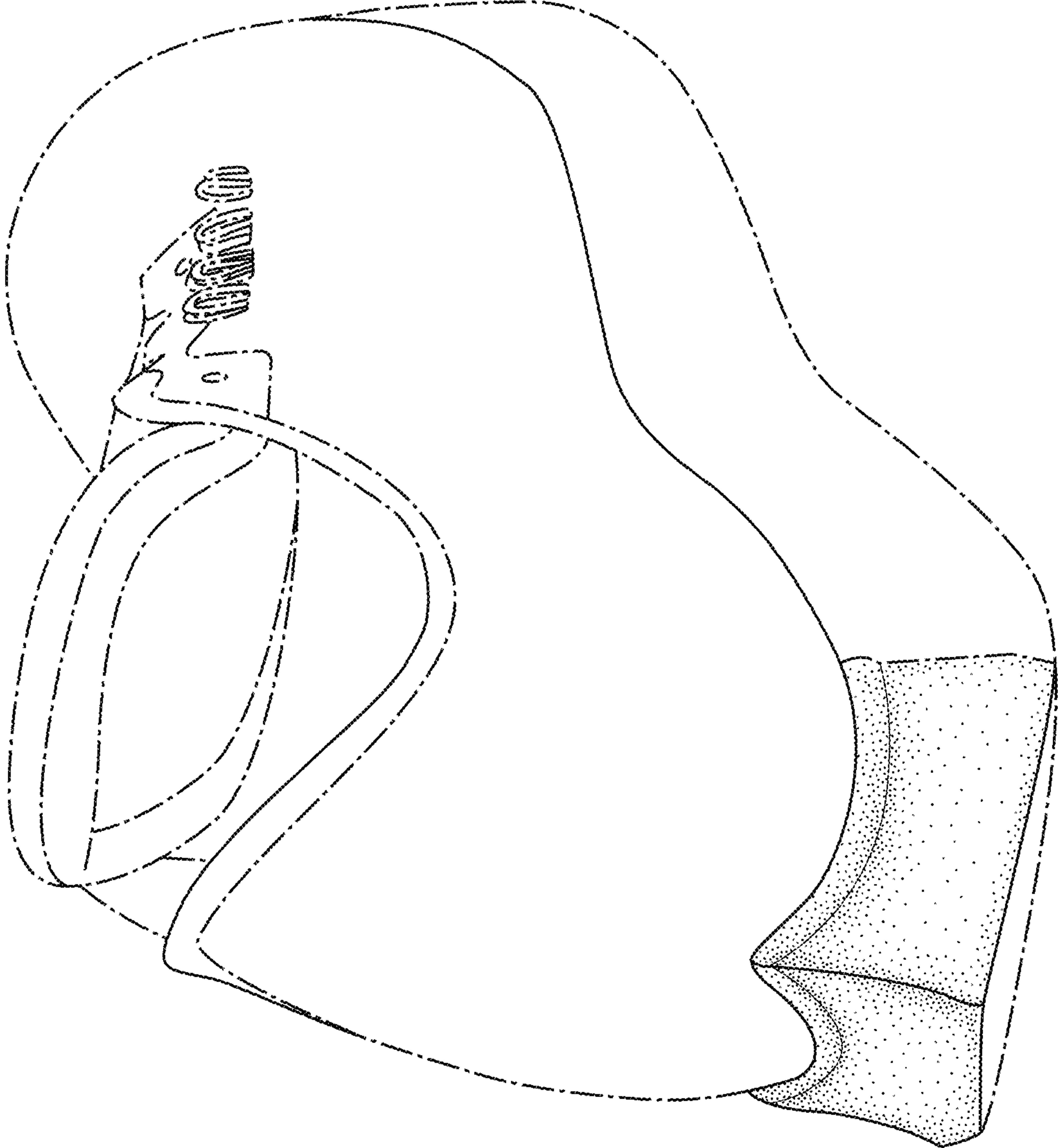

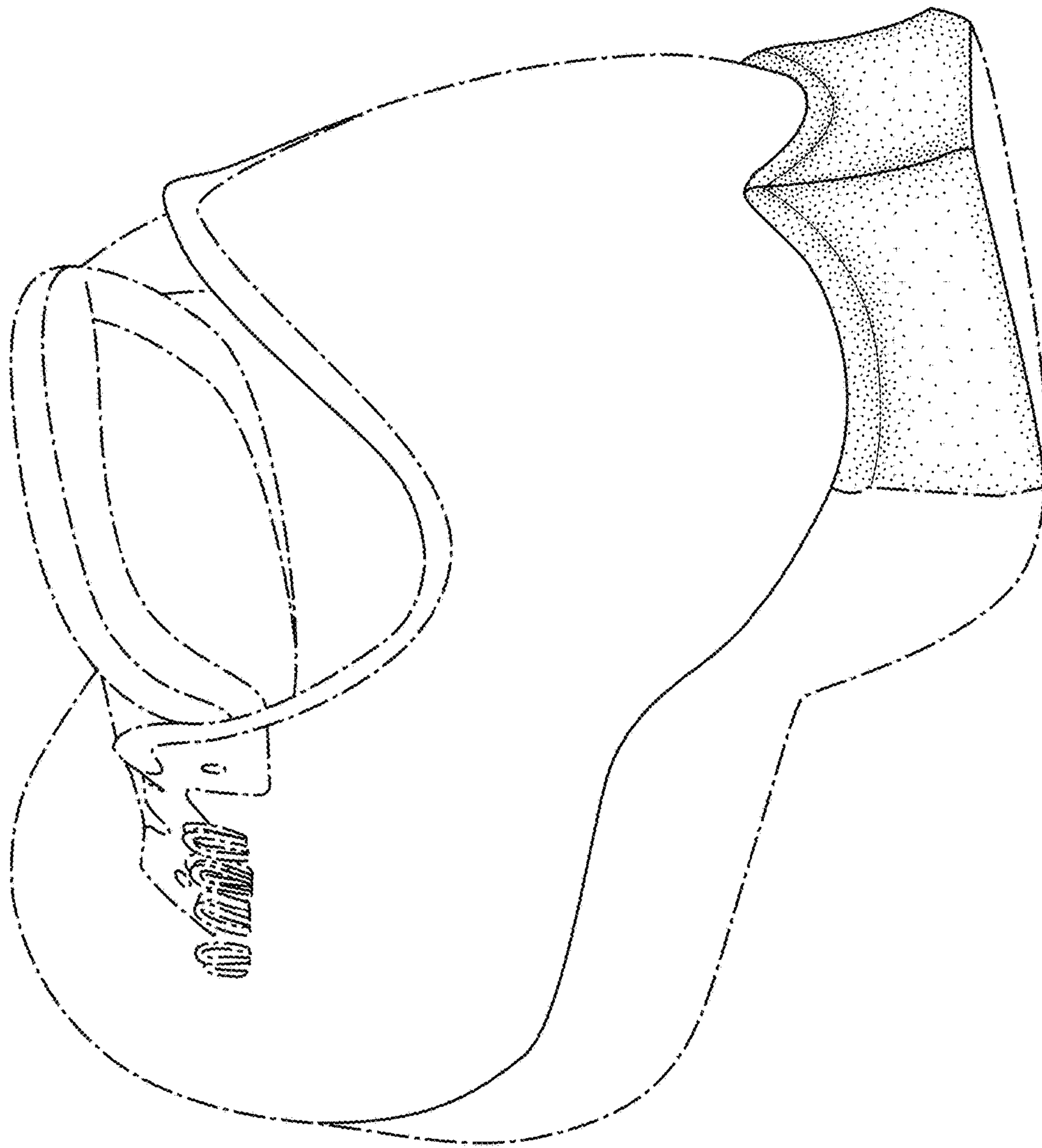

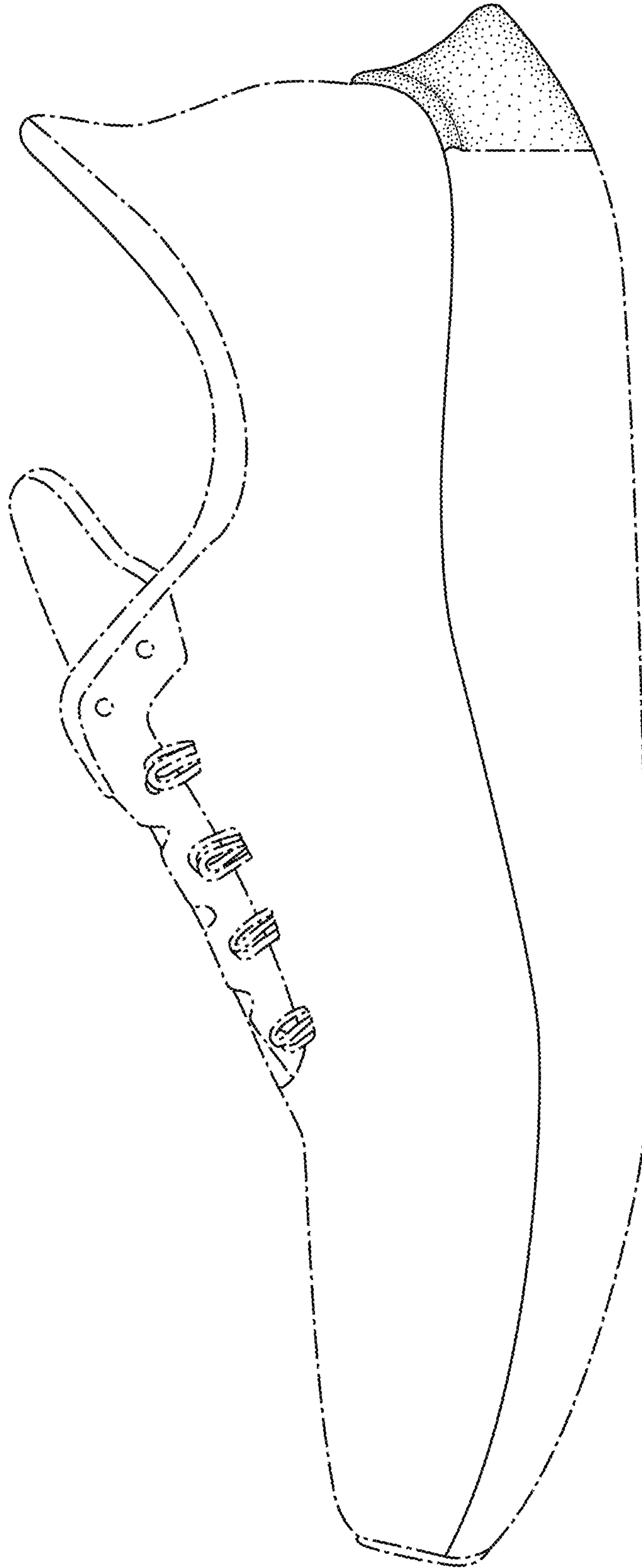
