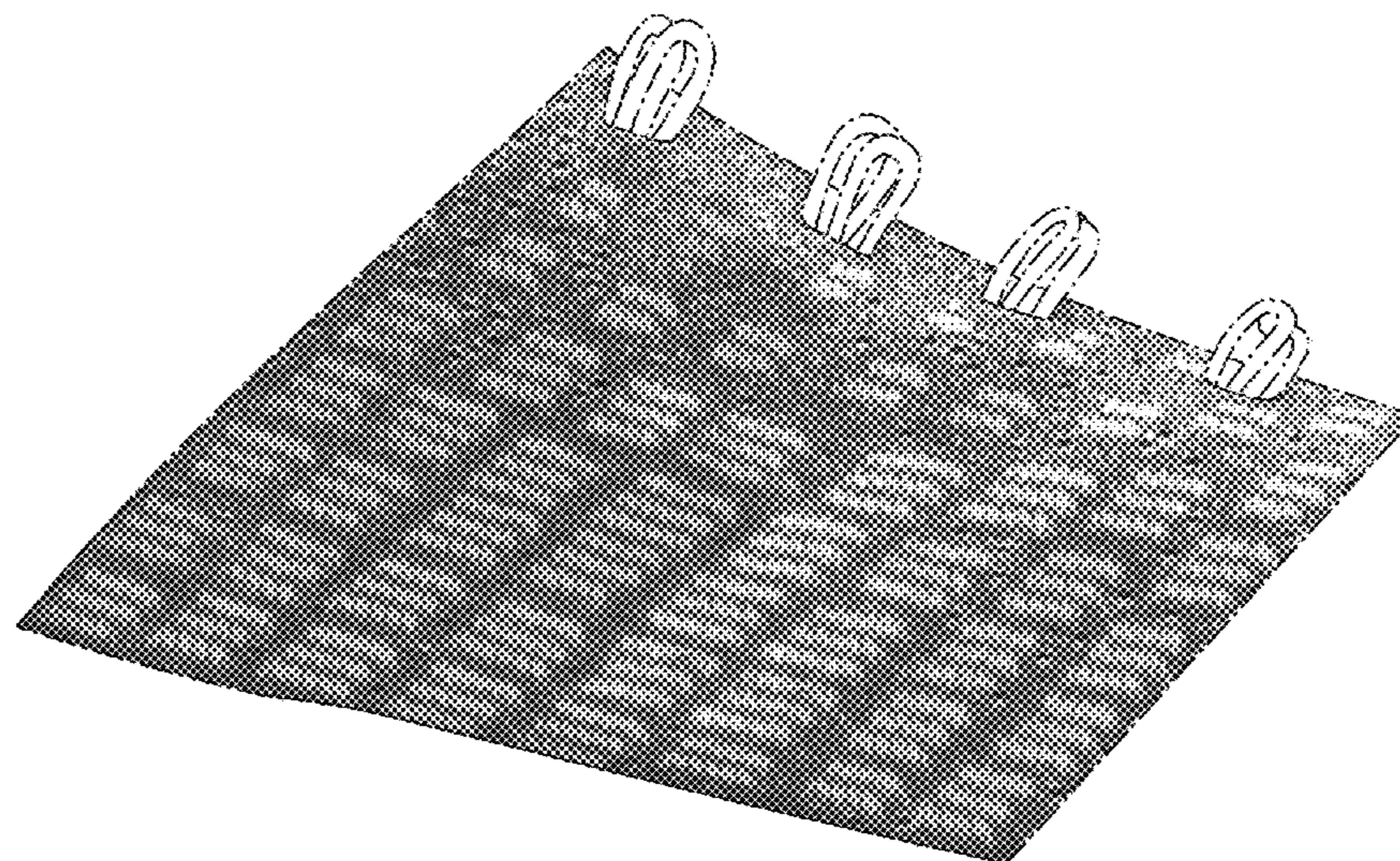
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing my new design;
FIG. 2 is a side view thereof; and,
FIG. 3 is an enlarged view of FIG. 2 with environmental portions removed for clarity.
The broken lines immediately adjacent to the photographic area define the bounds of the claimed design and form no part thereof. The unshaded regions within and adjacent to the photographic area, and that are demarcated by broken lines, form no part of the claimed design. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

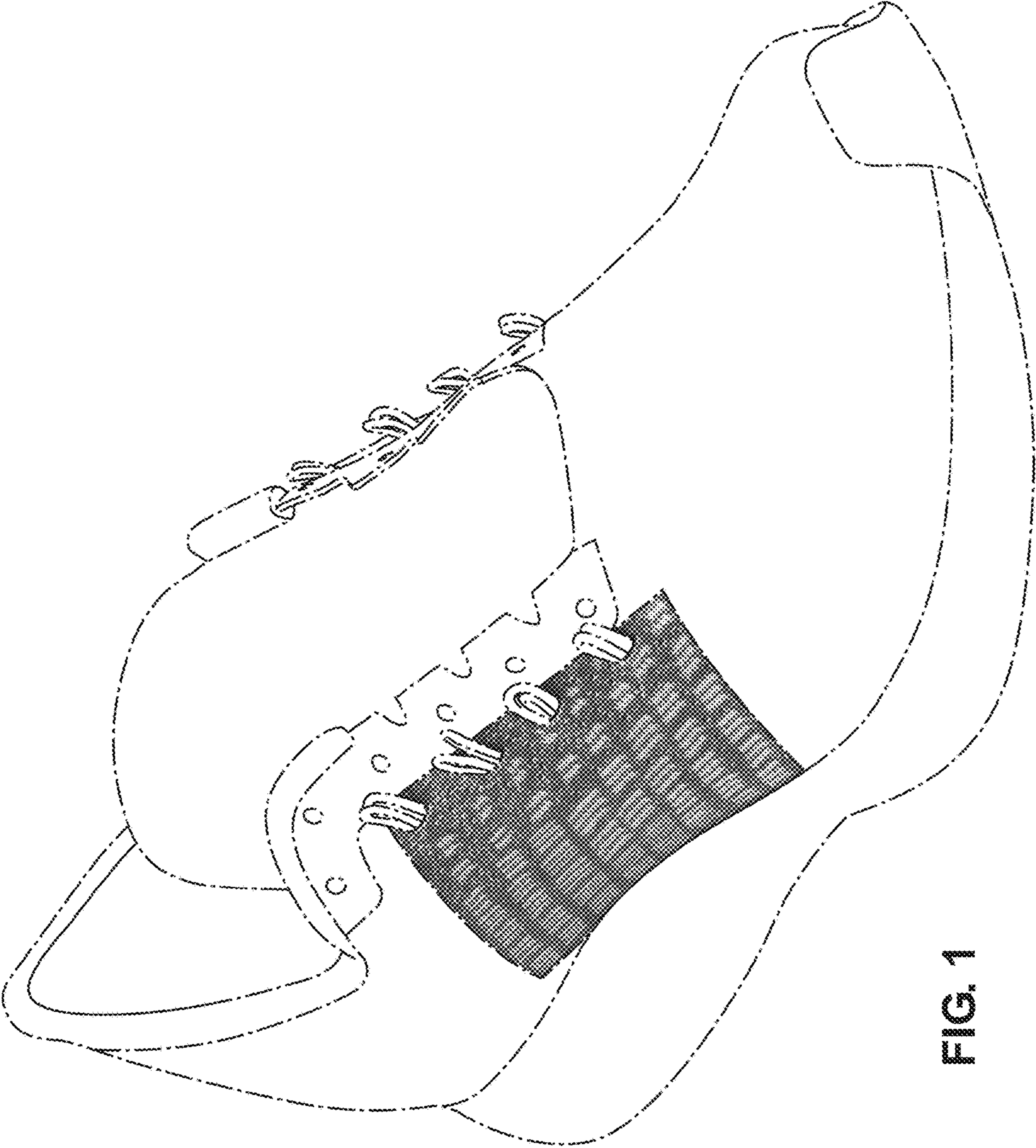

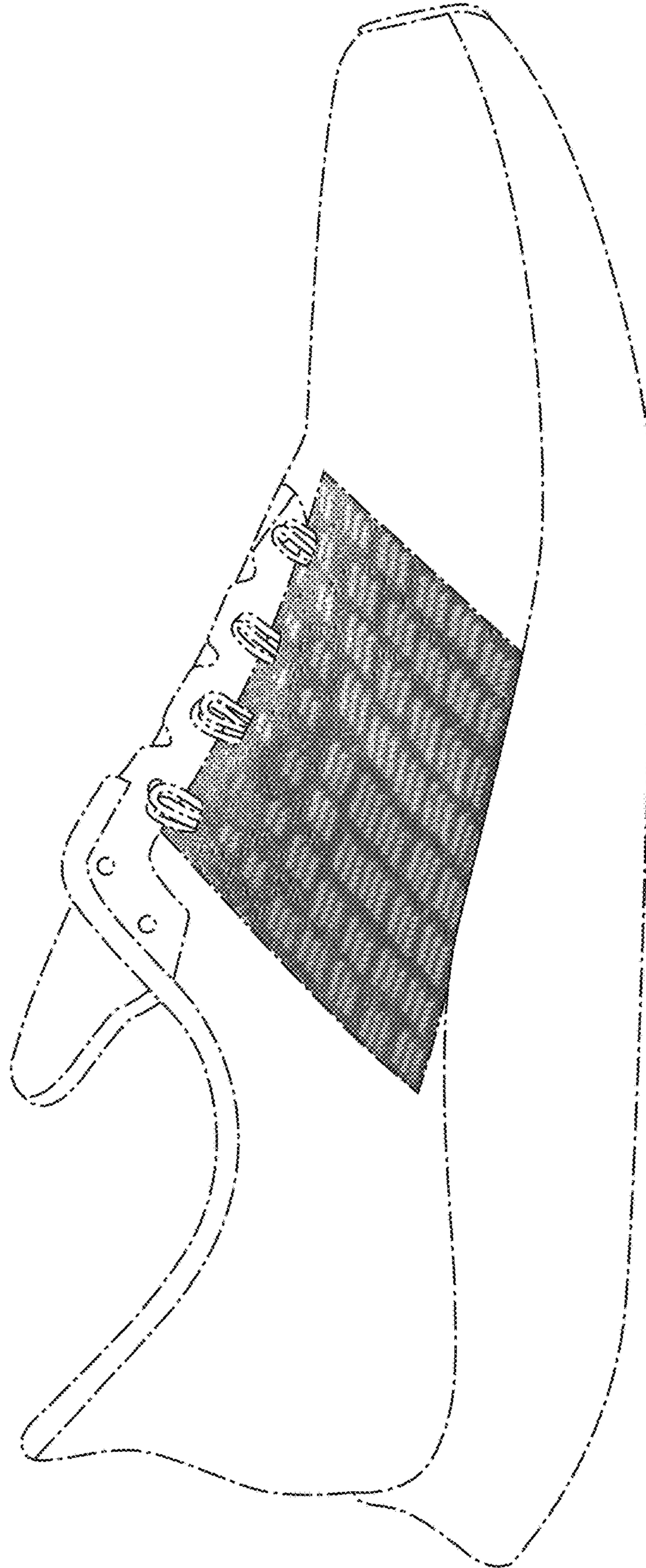

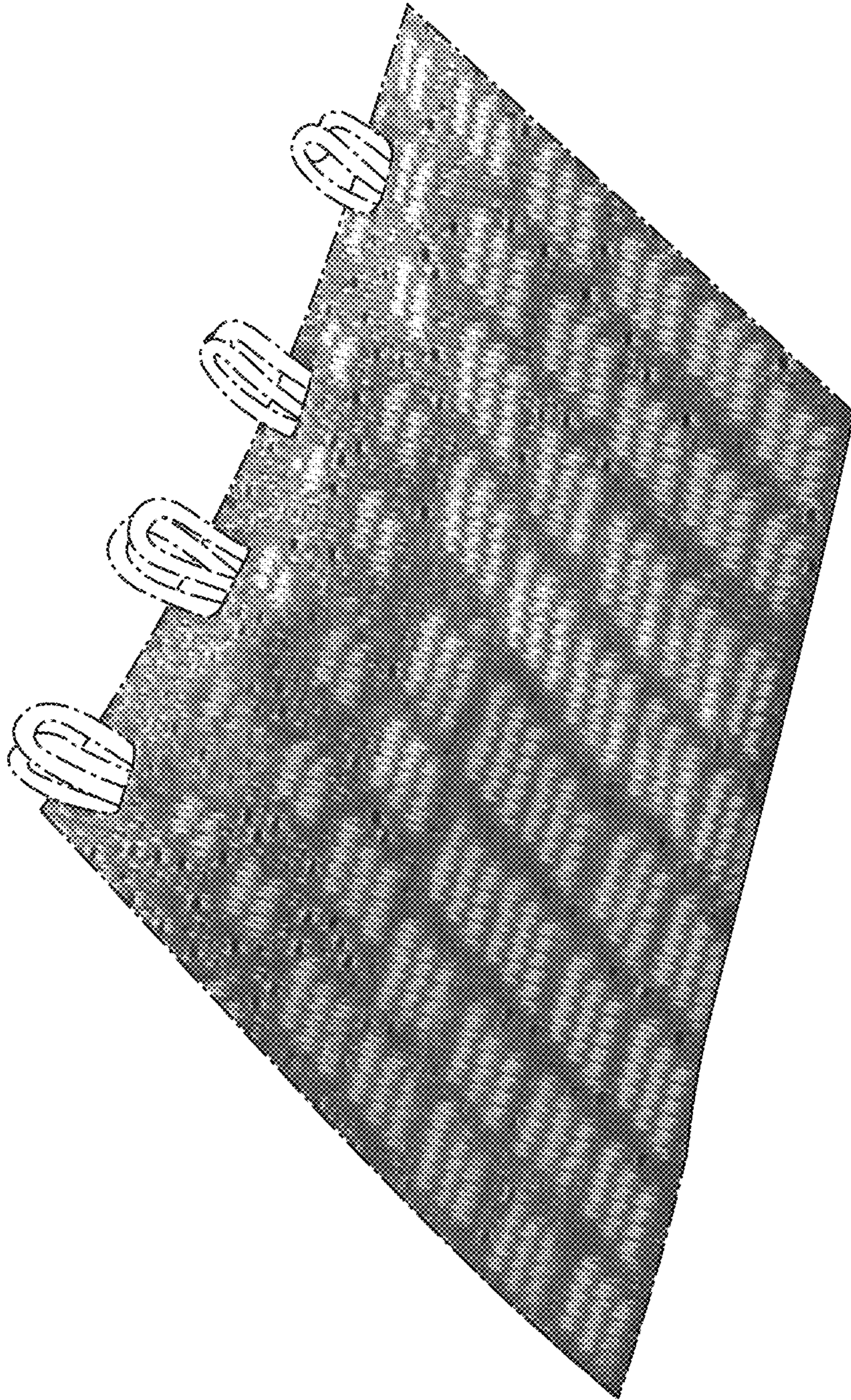
