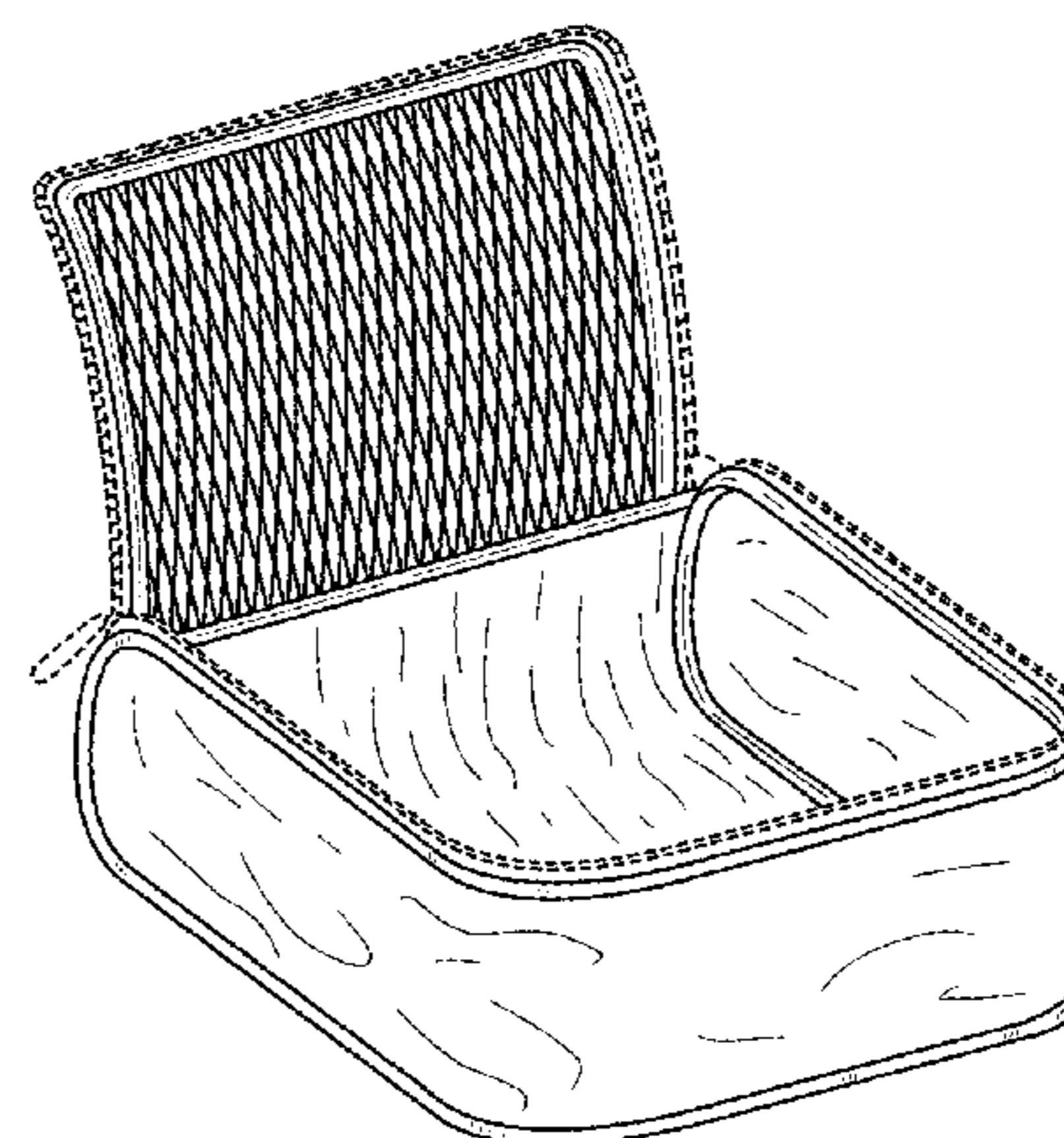
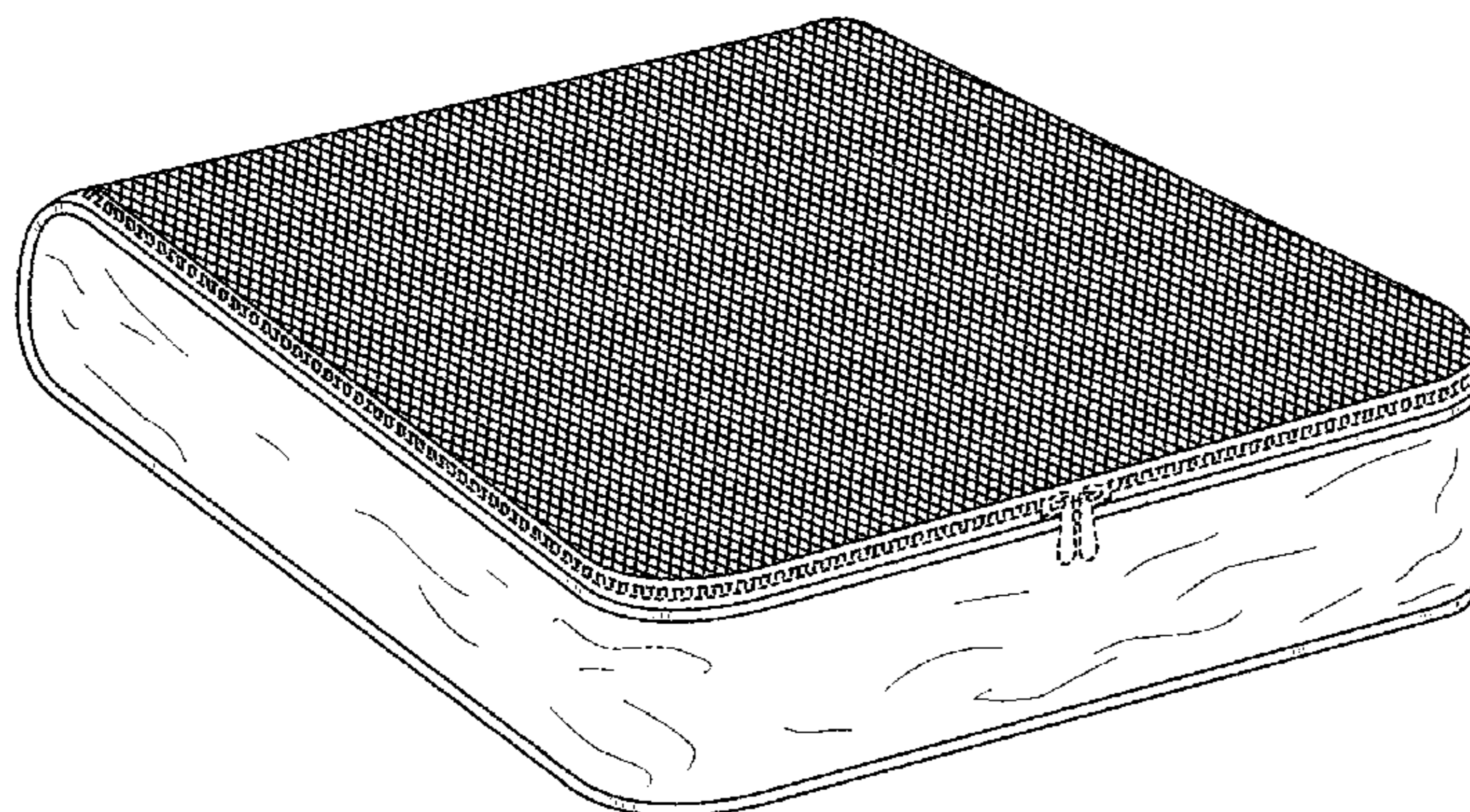
(57) **CLAIM**

The ornamental design for a packing cube, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the packing cube, showing our new design, in a double-rectangular configuration. FIG. 2 is a front view thereof. FIG. 3 is a back view thereof. FIG. 4 is a right side view thereof. FIG. 5 is a left side view thereof. FIG. 6 is a top view thereof. FIG. 7 is a bottom view thereof. FIG. 8 is a perspective view thereof, shown in an open state of use. FIG. 9 is a perspective view of the packing cube, showing our new design, in a rectangular configuration. FIG. 10 is a front view thereof. FIG. 11 is a back view thereof. FIG. 12 is a right side view thereof. FIG. 13 is a left side view thereof. FIG. 14 is a top view thereof. FIG. 15 is a bottom view thereof. FIG. 16 is a perspective view thereof, shown in an open state of use. FIG. 17 is a perspective view of the packing cube, showing our new design, in a square configuration. FIG. 18 is a front view thereof. FIG. 19 is a back view thereof. FIG. 20 is a right side view thereof. FIG. 21 is a left side view thereof. FIG. 22 is a top view thereof. FIG. 23 is a bottom view thereof; and, FIG. 24 is a perspective view thereof, shown in an open state of use. To the extent the packing cubes in FIGS. 1-24 include broken lines, the broken lines depict portions of the packing cube that form no part of the claimed design.

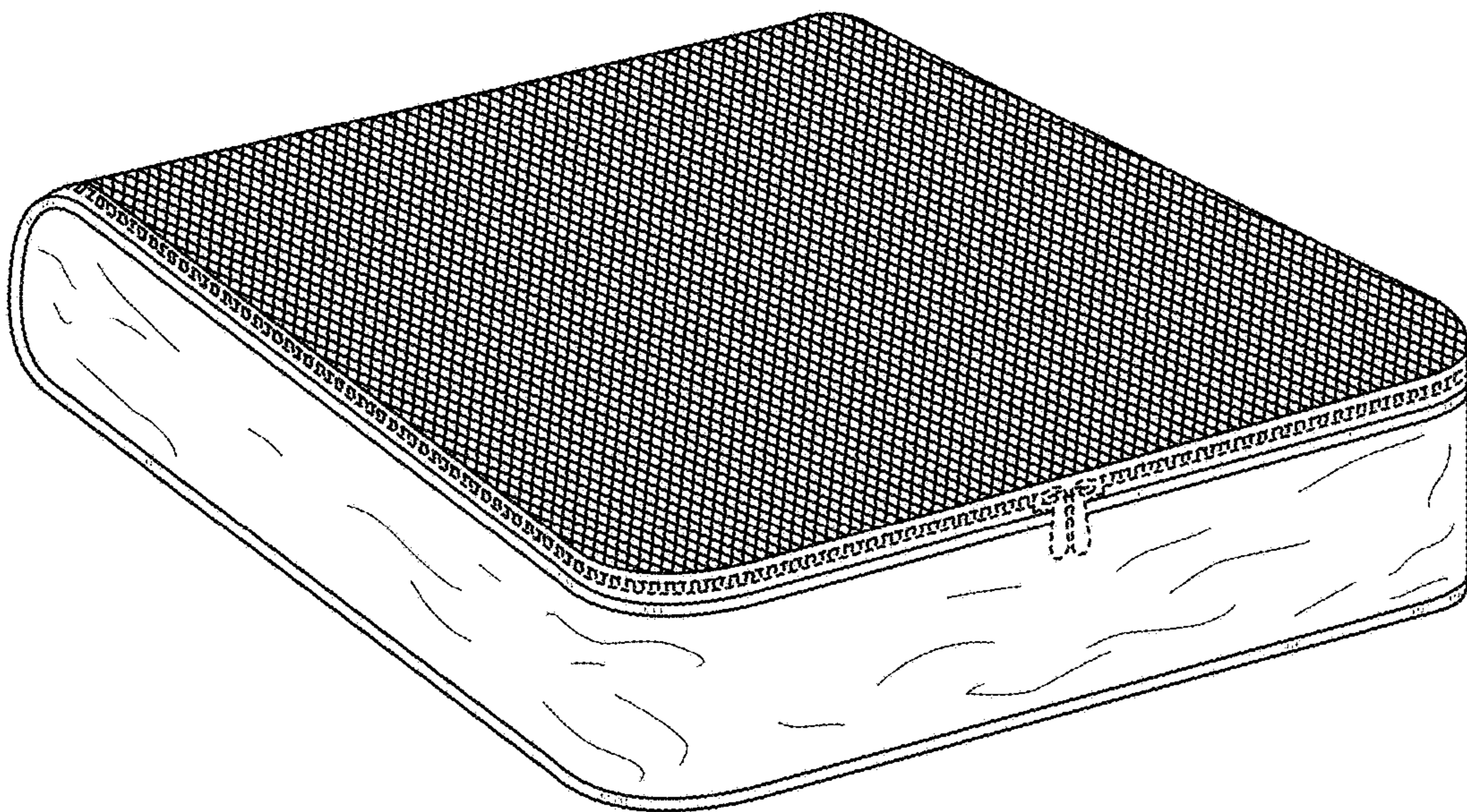

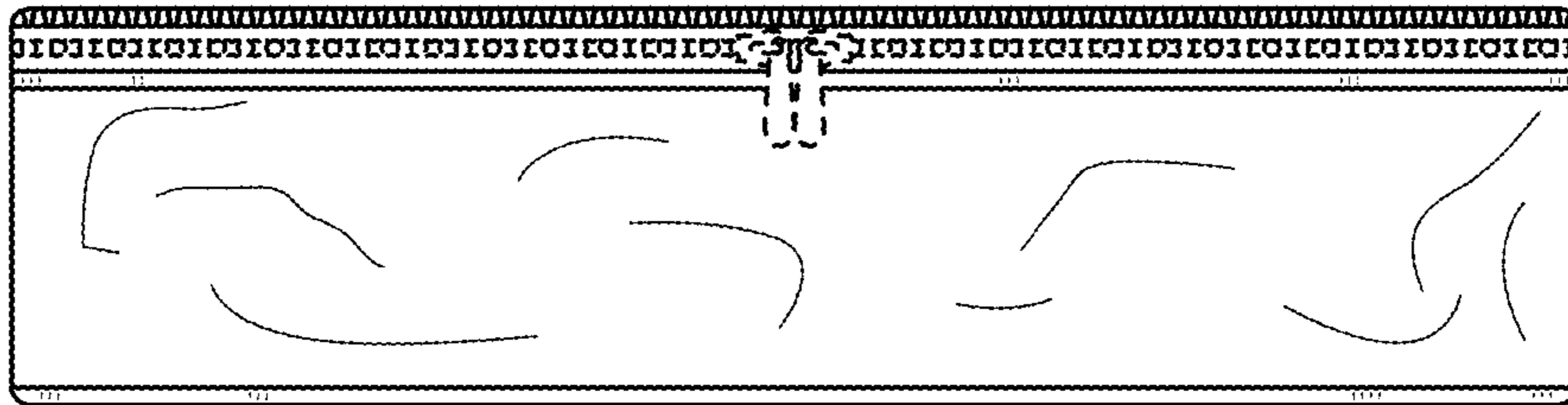

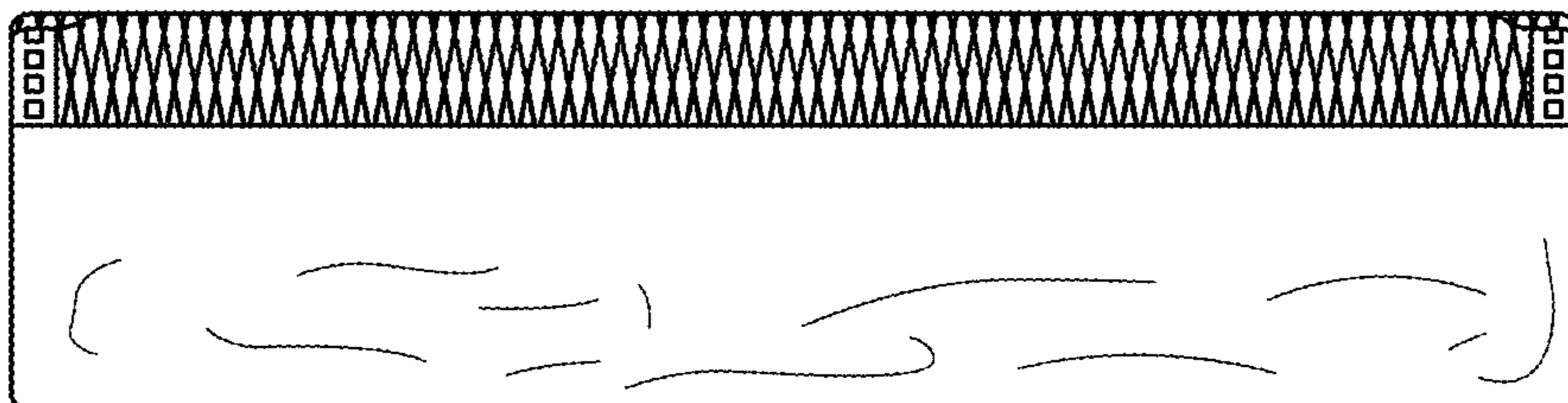

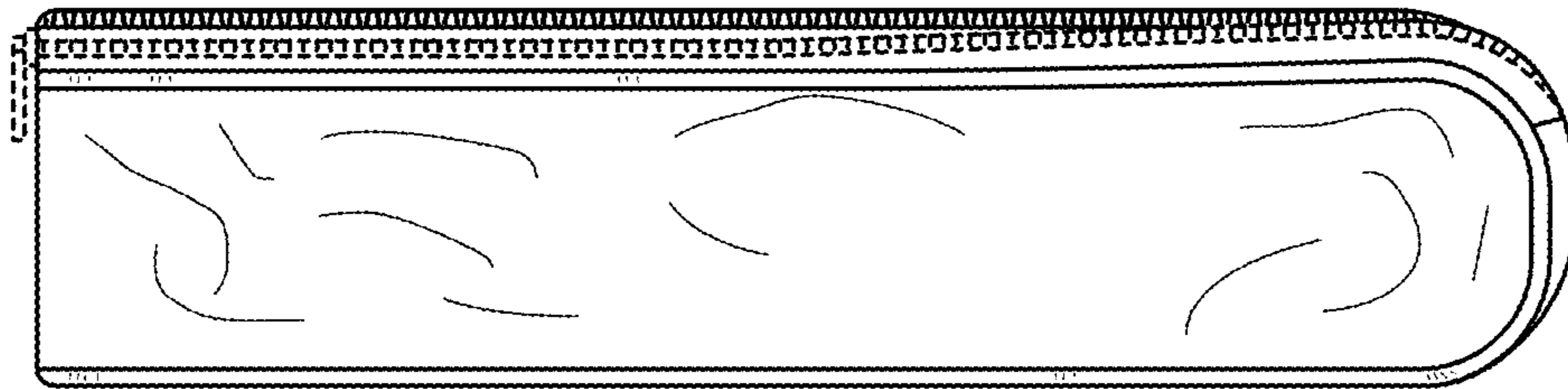

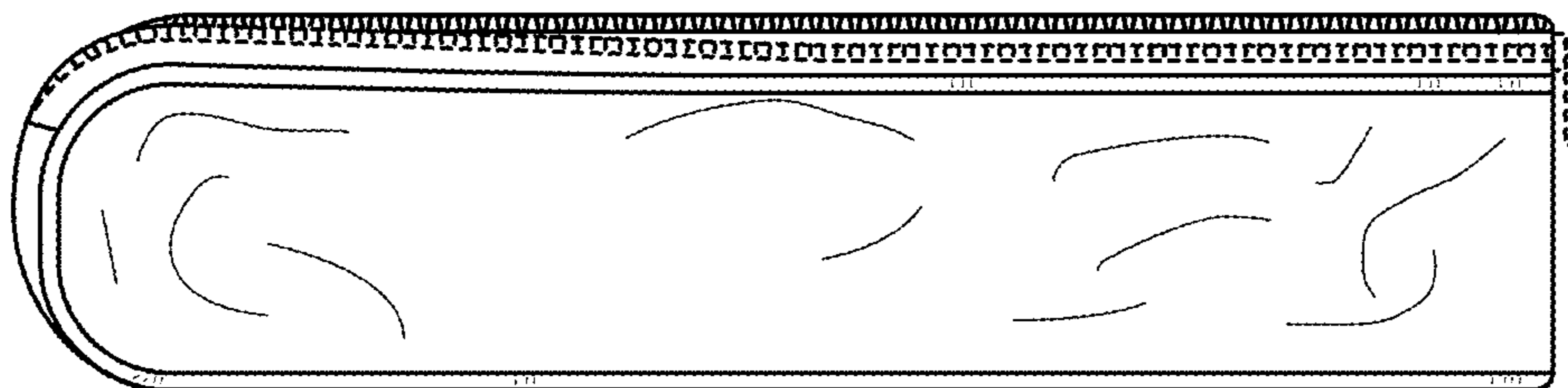

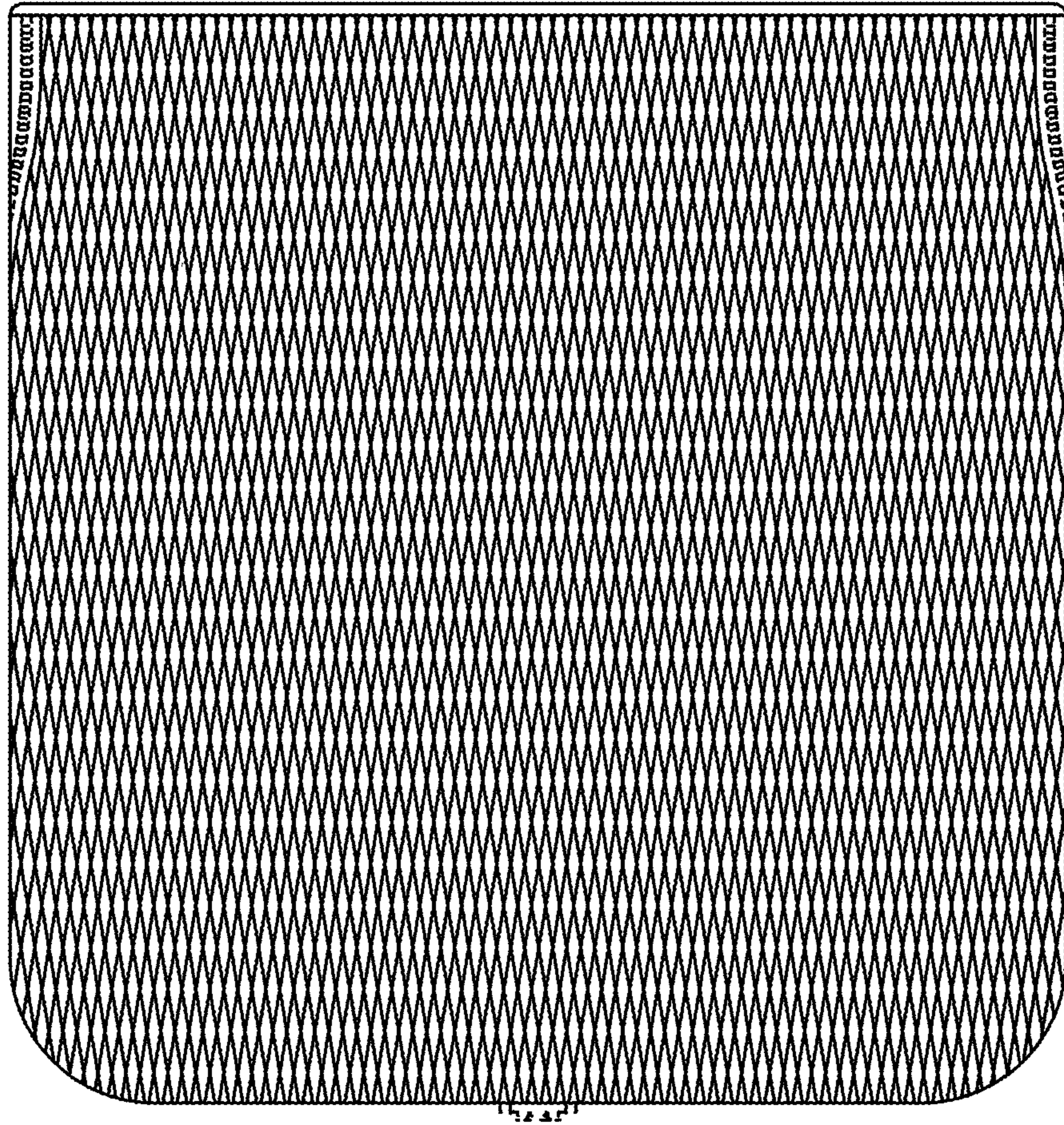

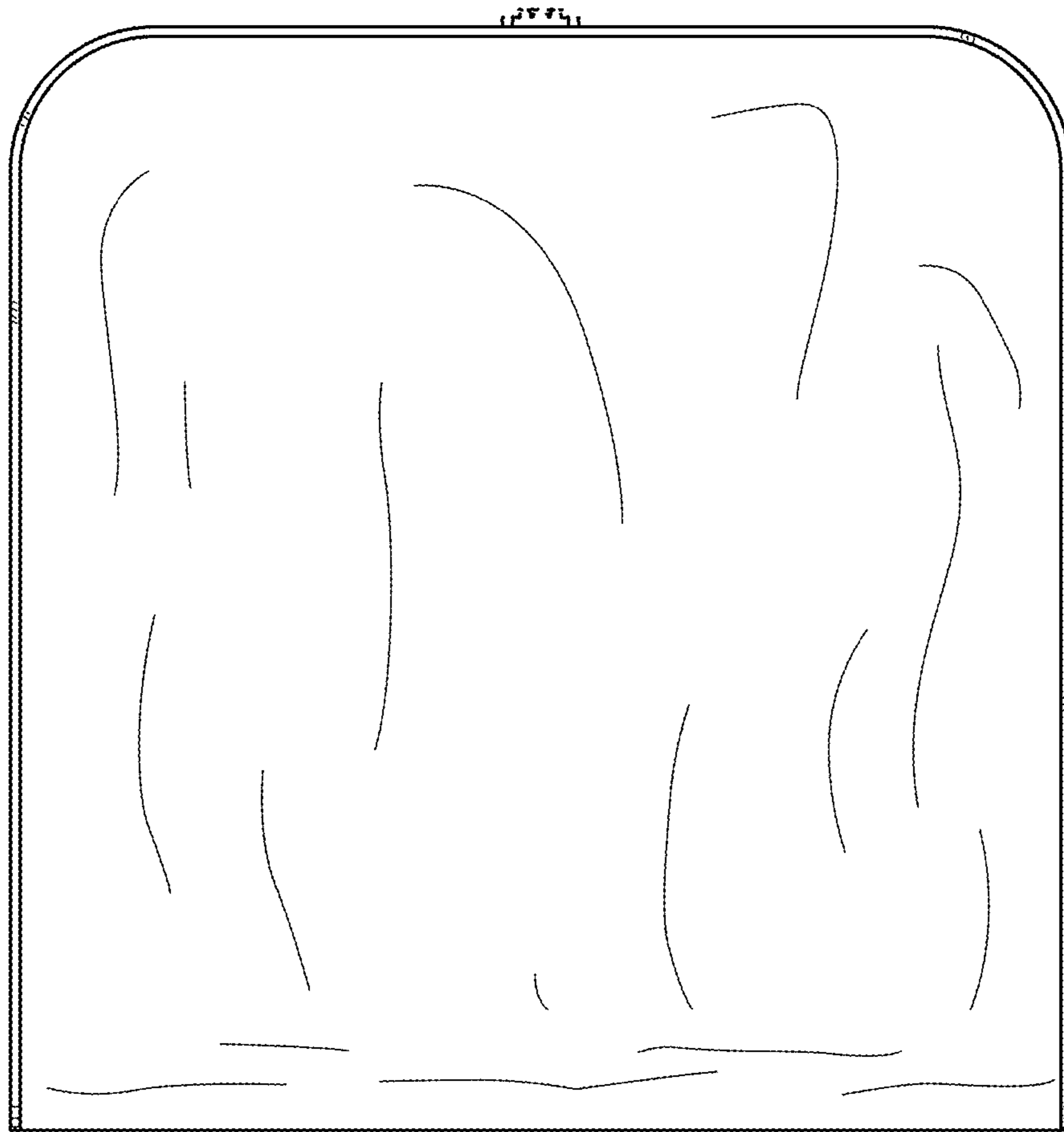

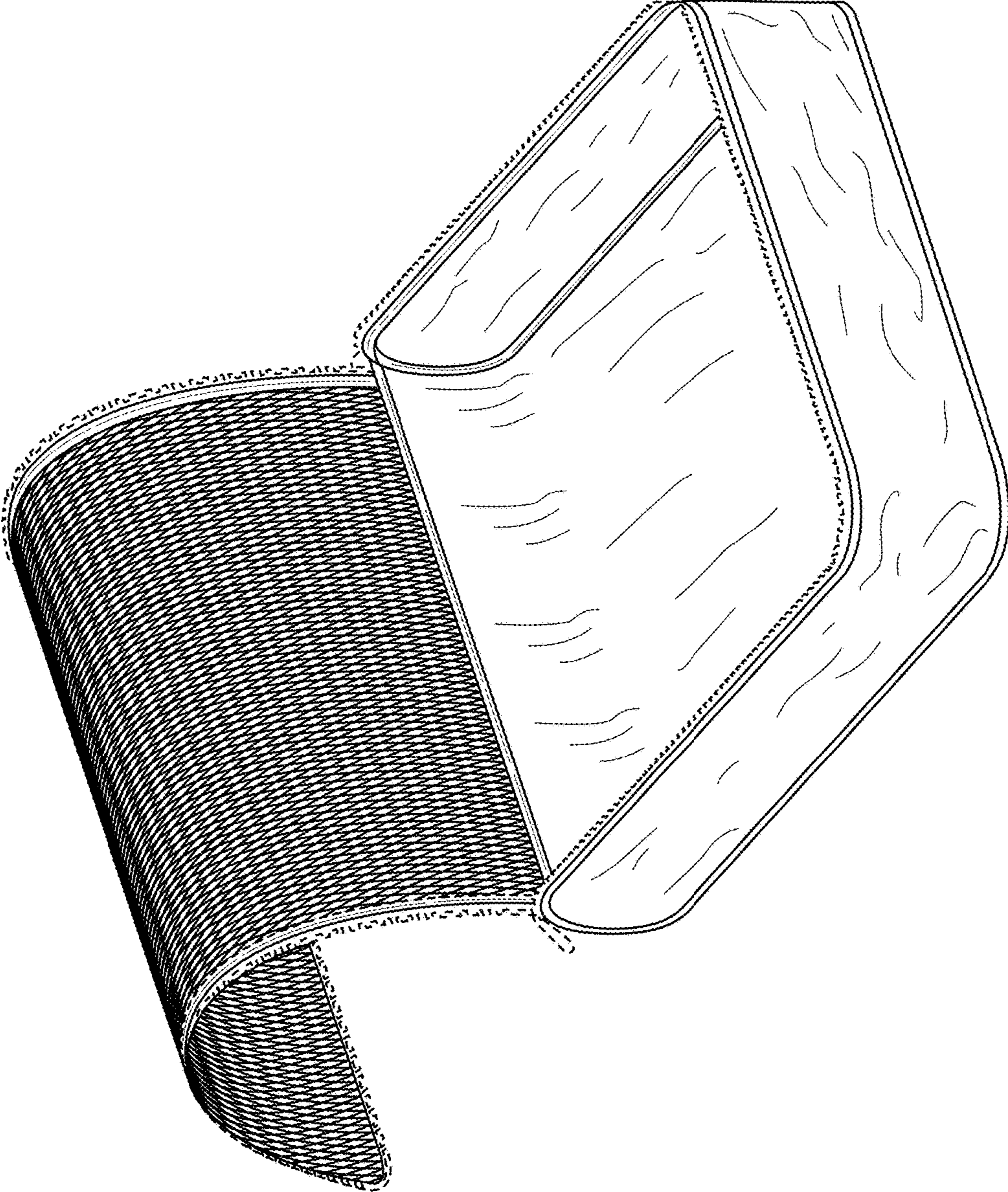

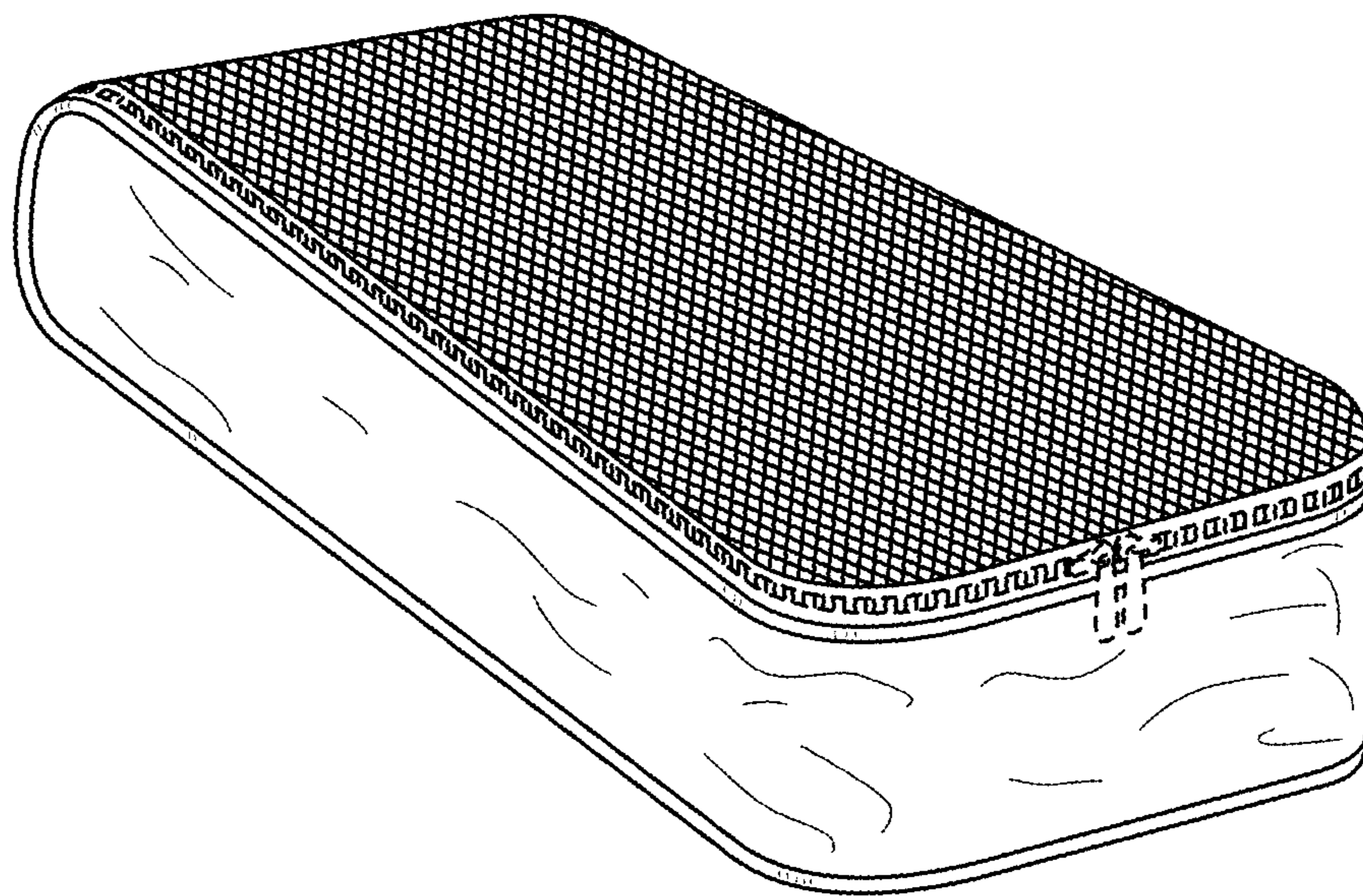

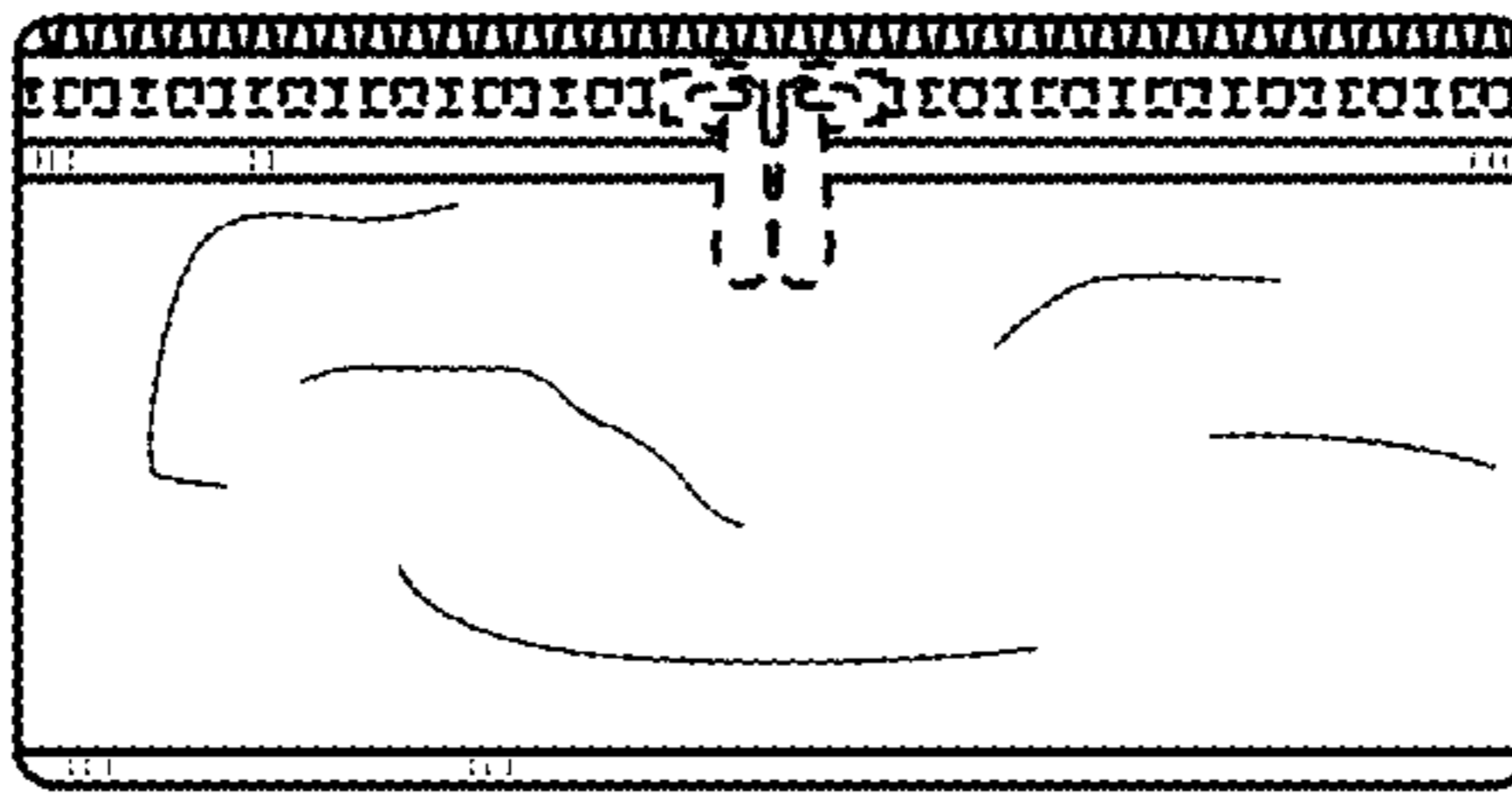

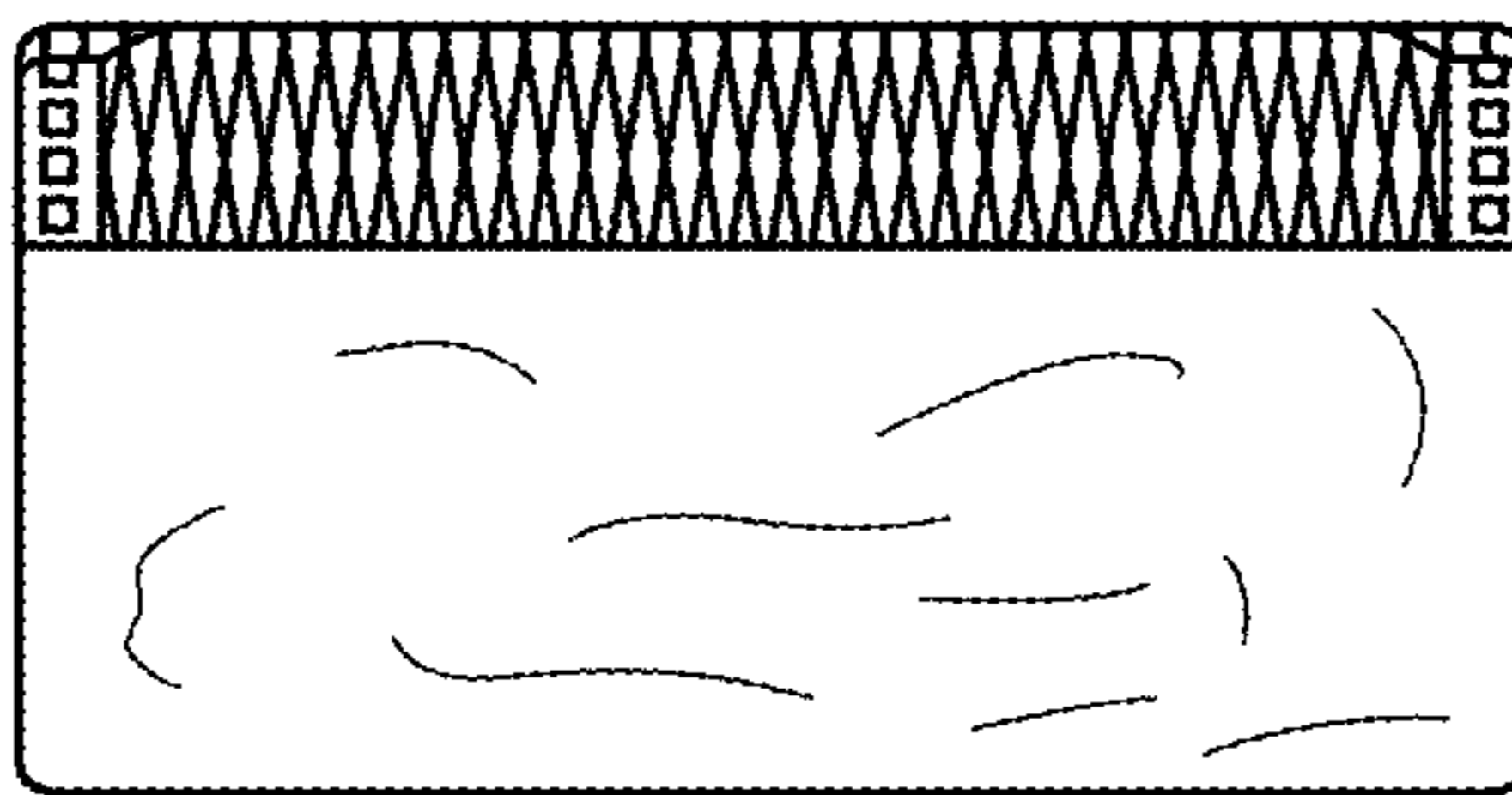

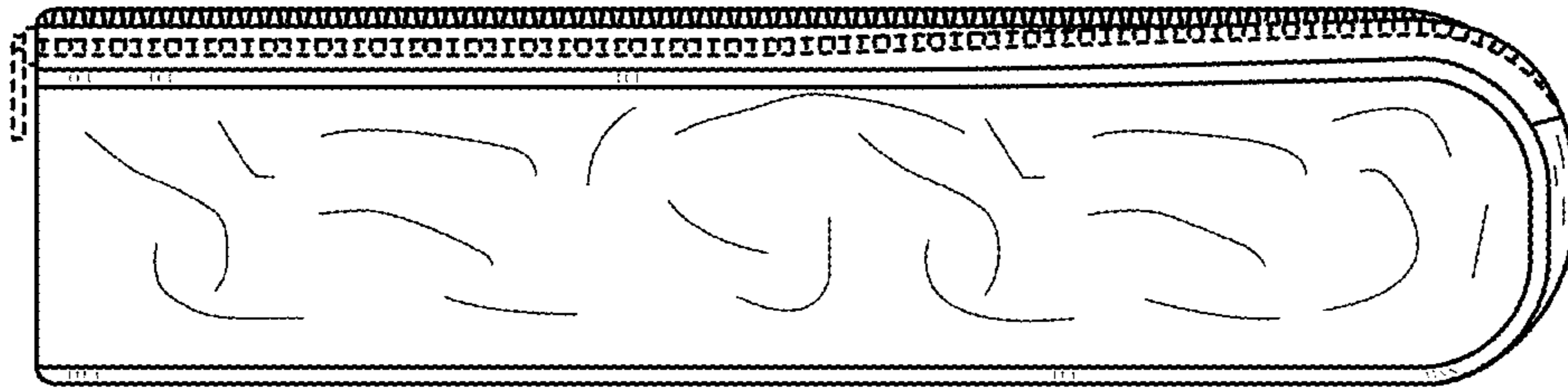

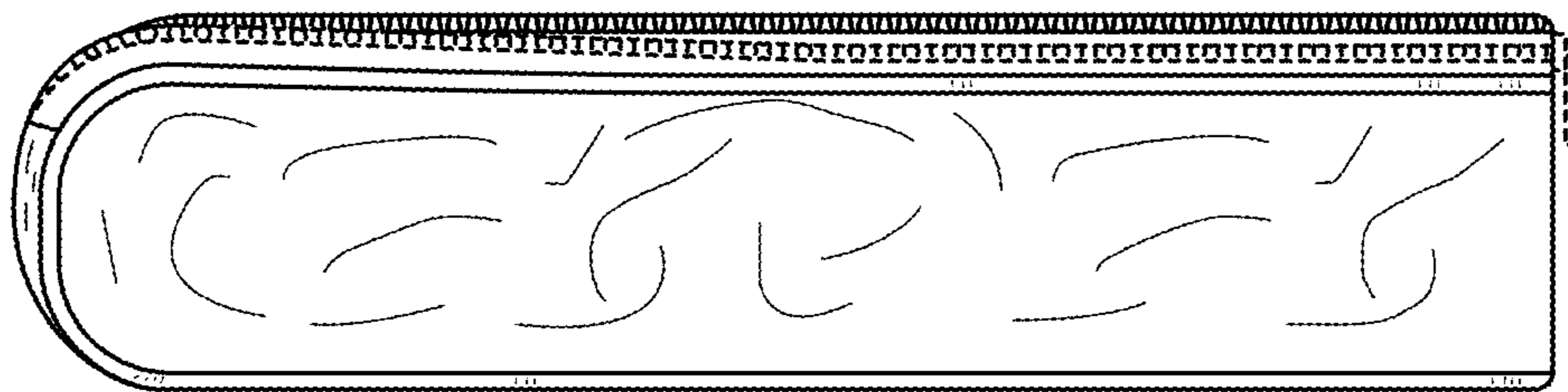

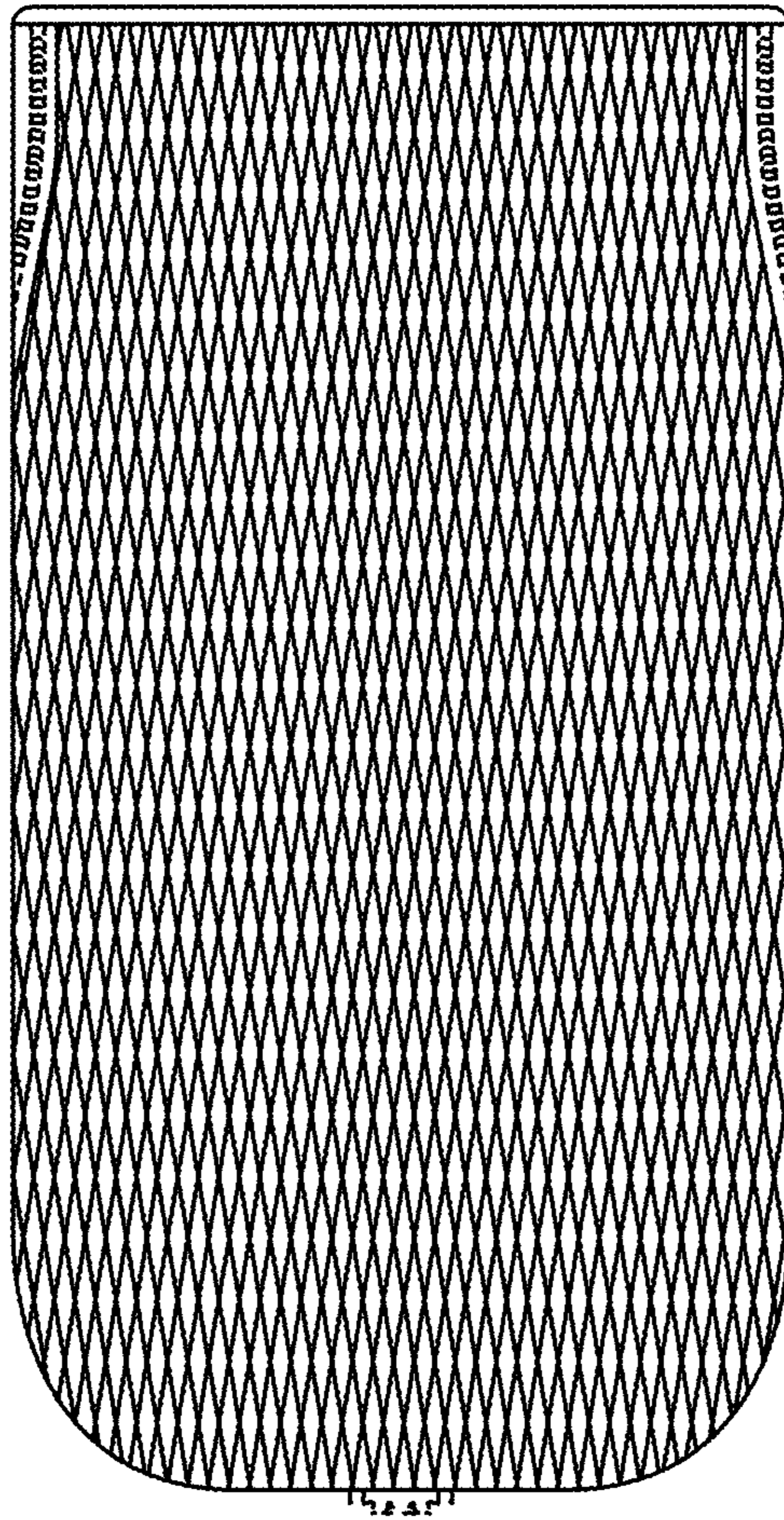

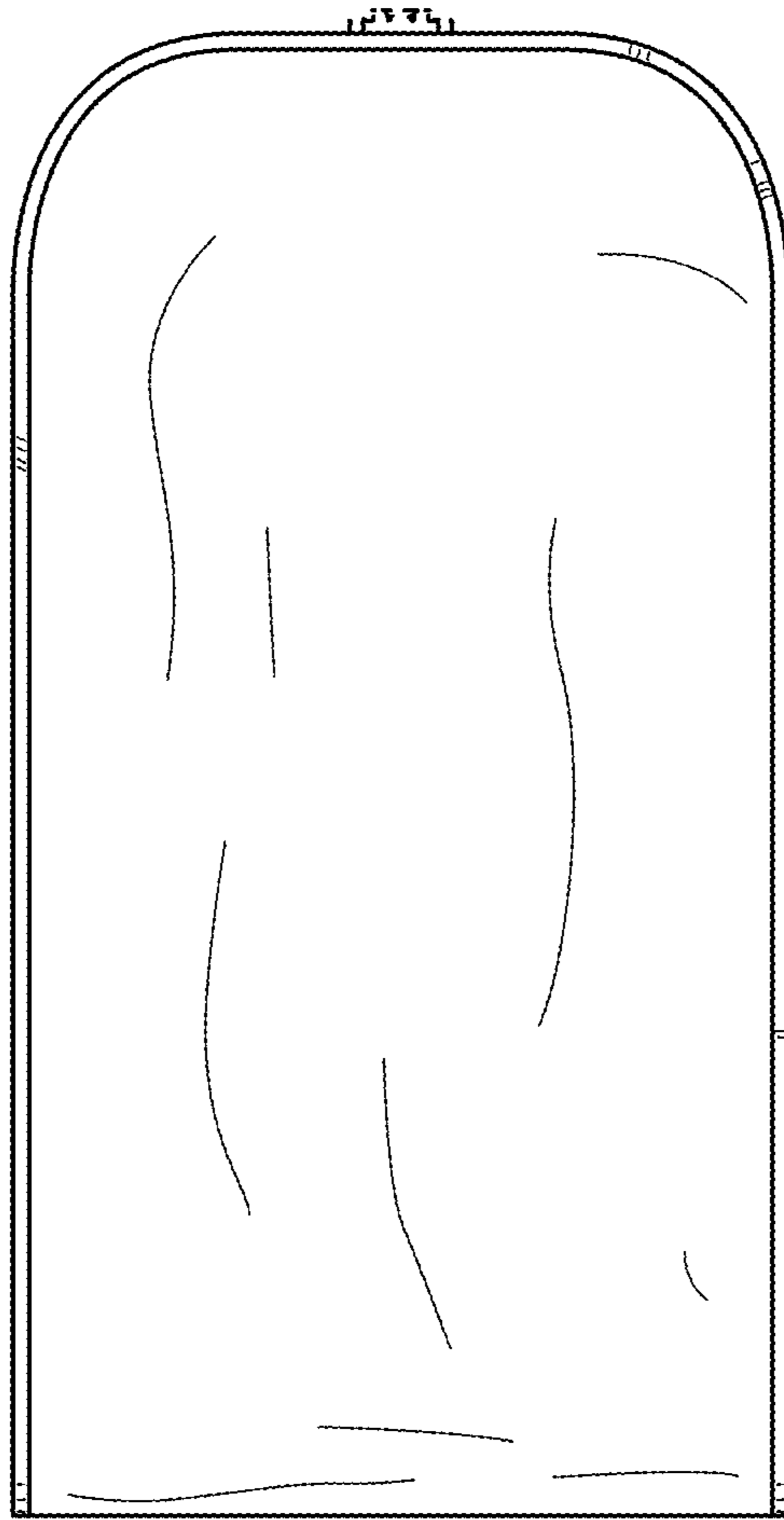

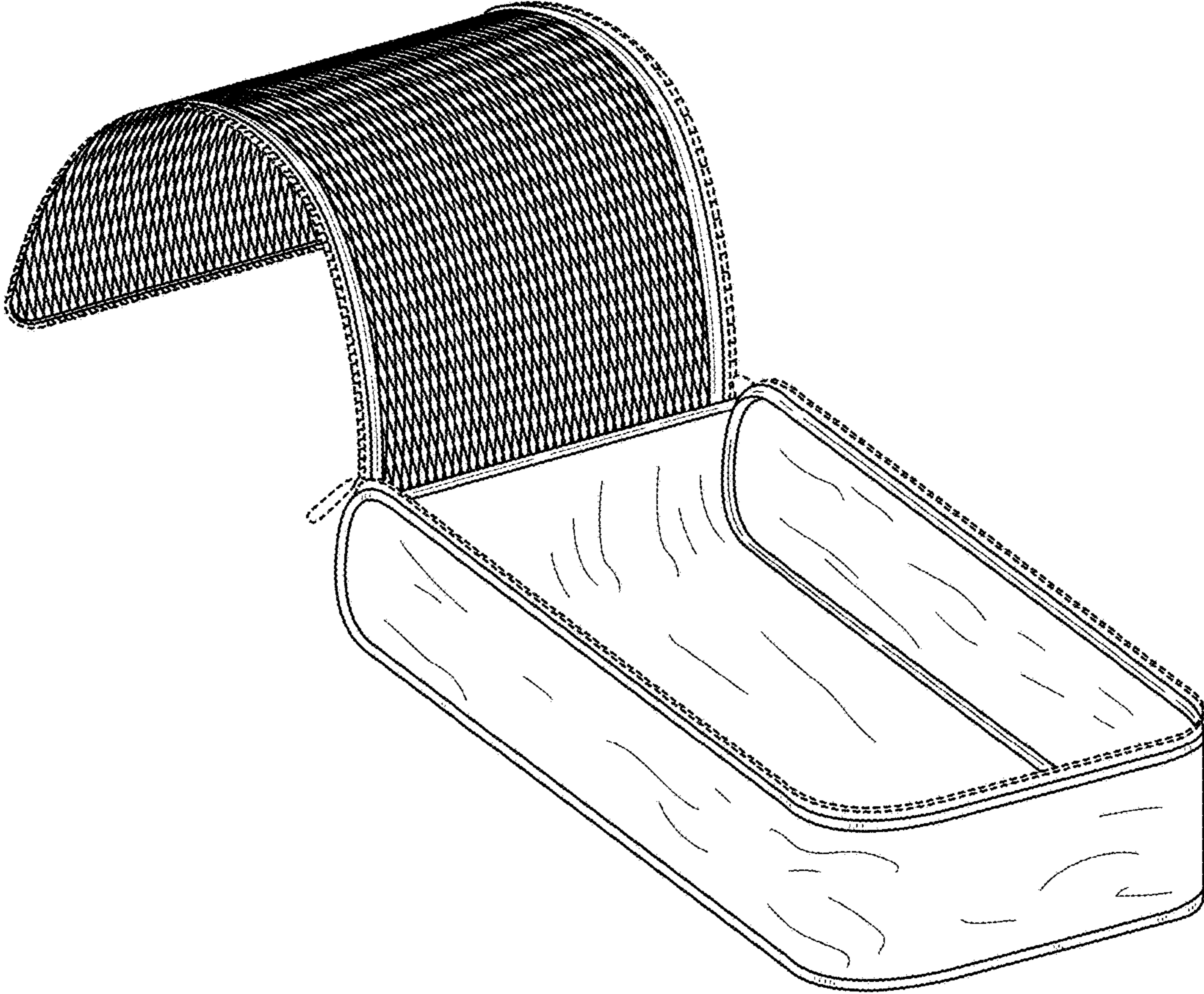

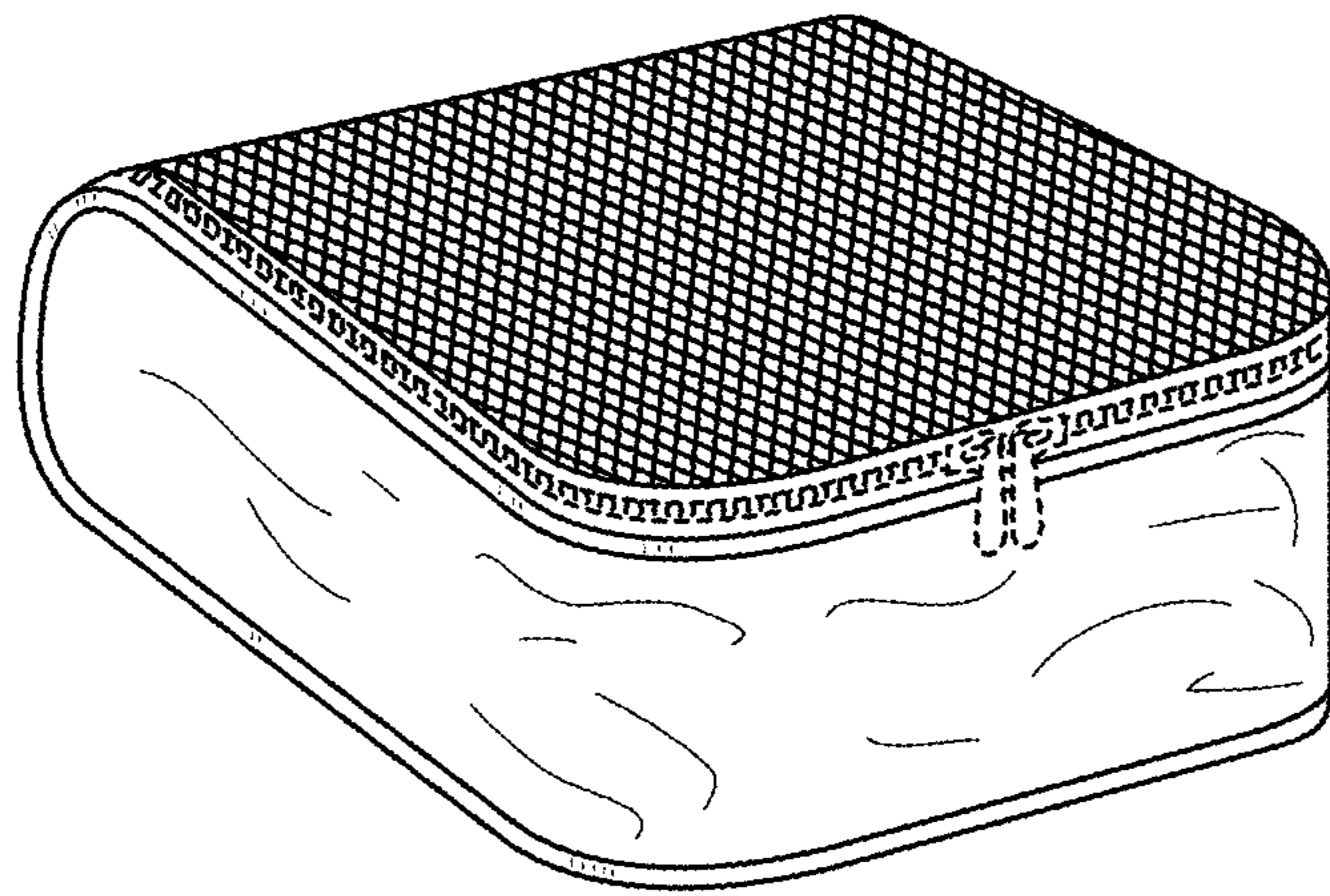

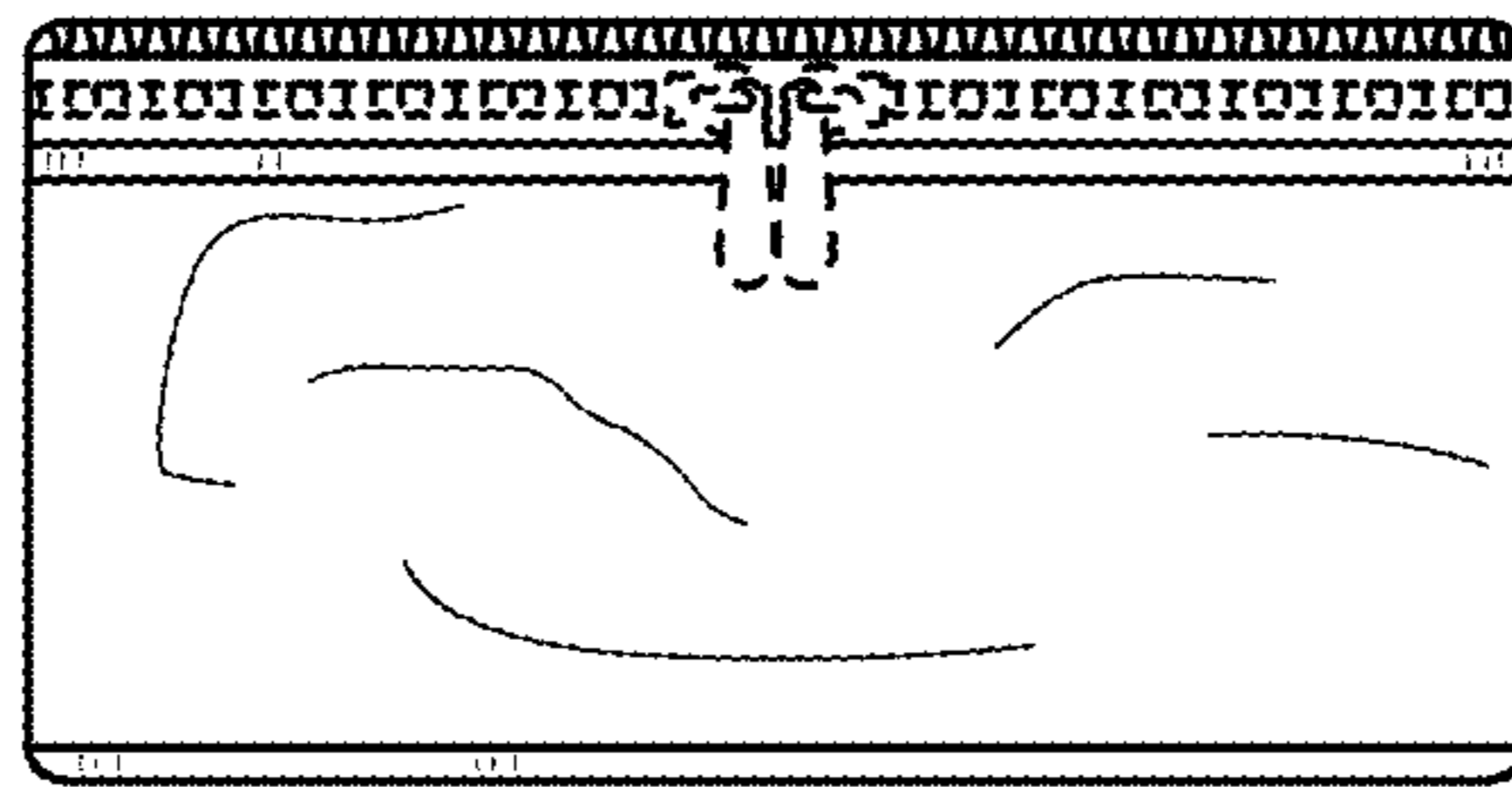

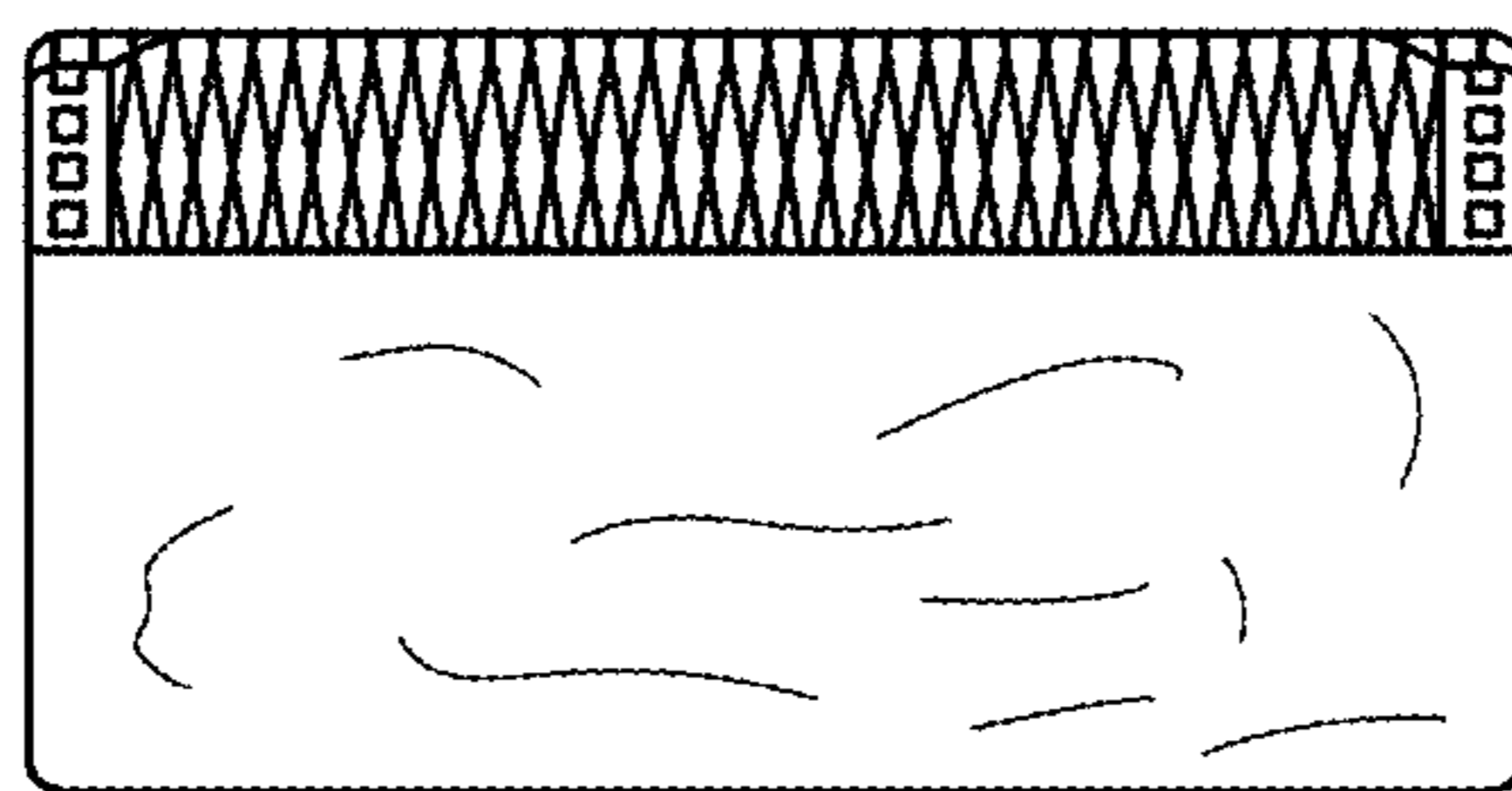

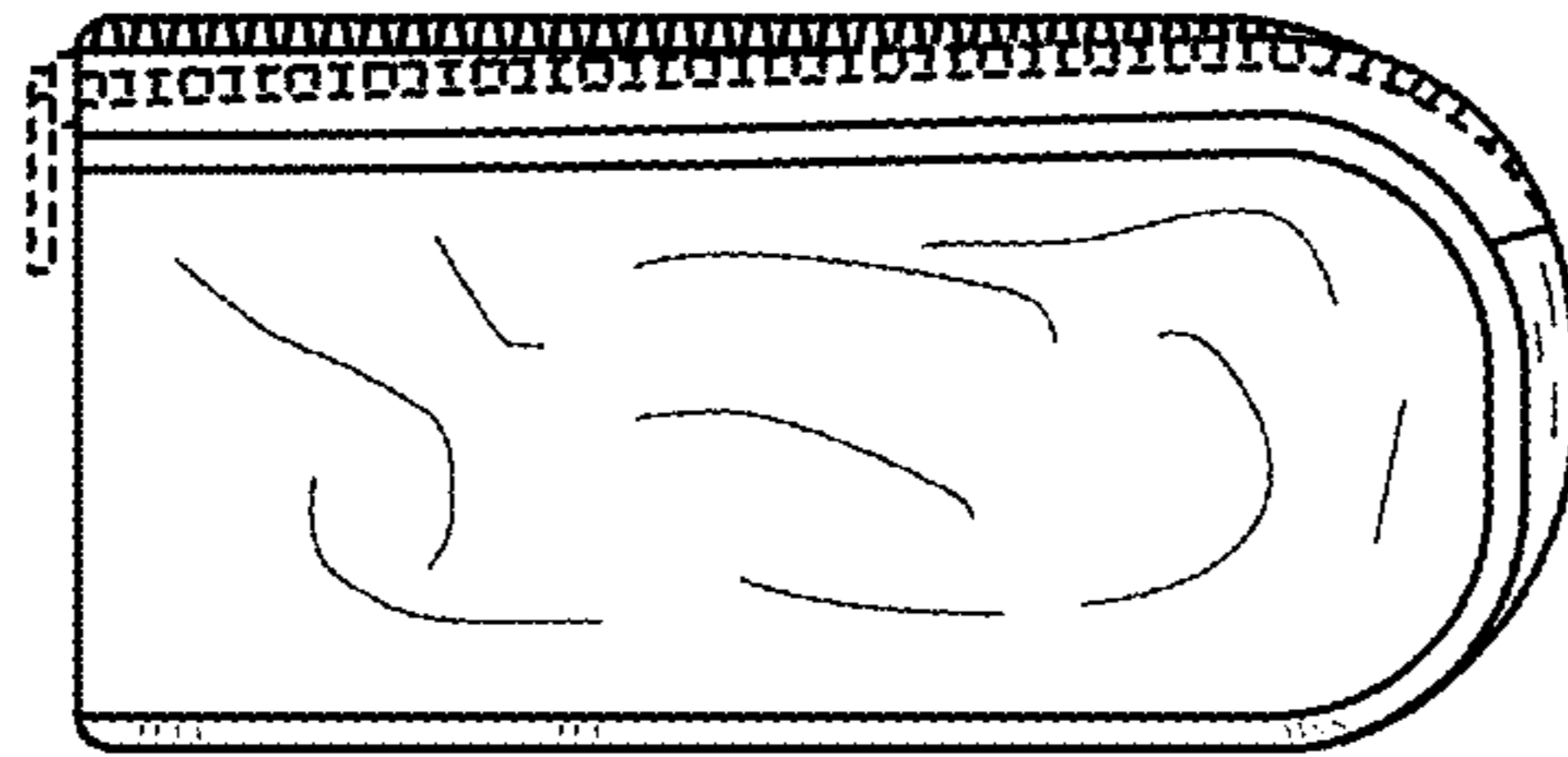

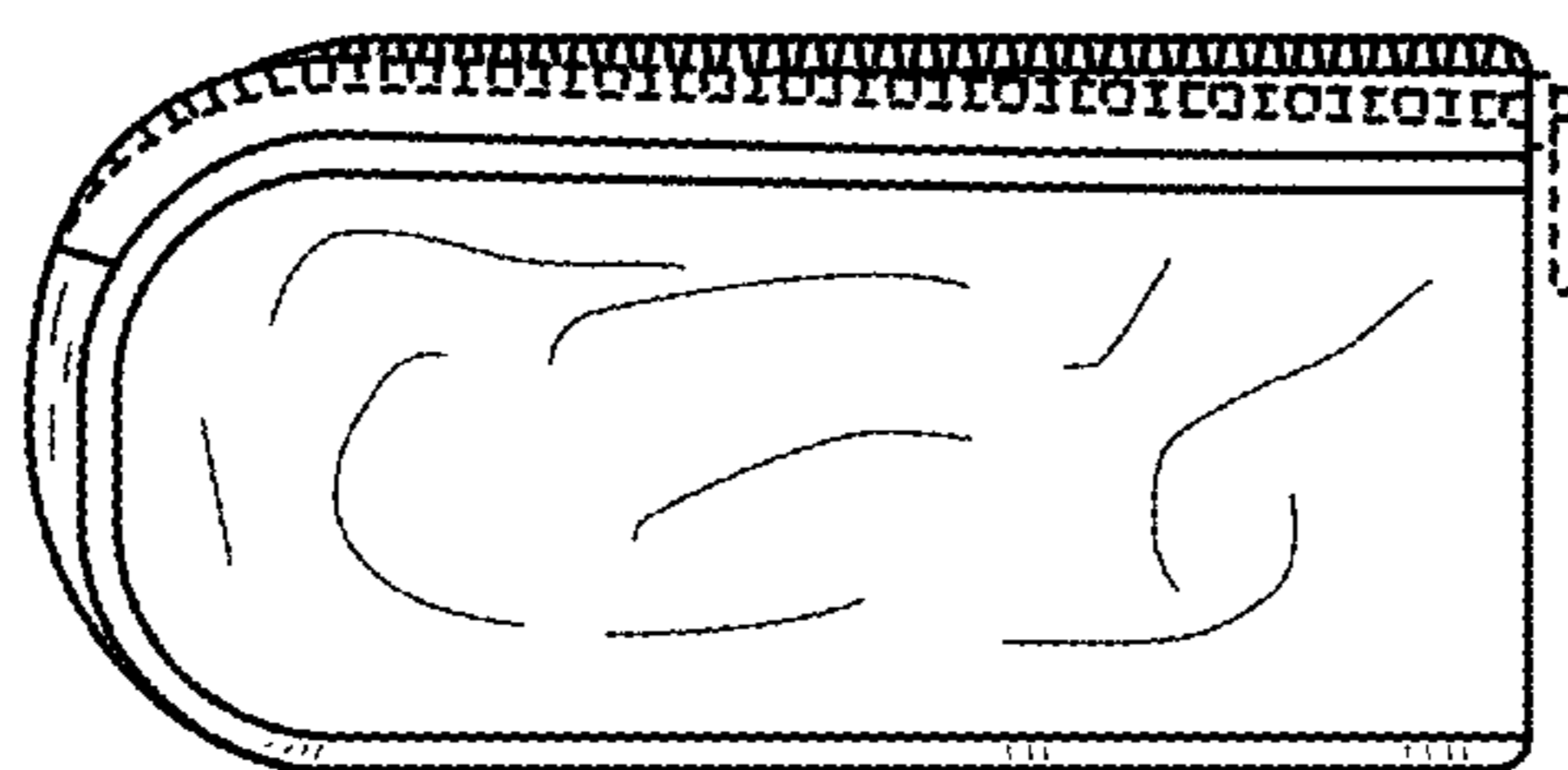

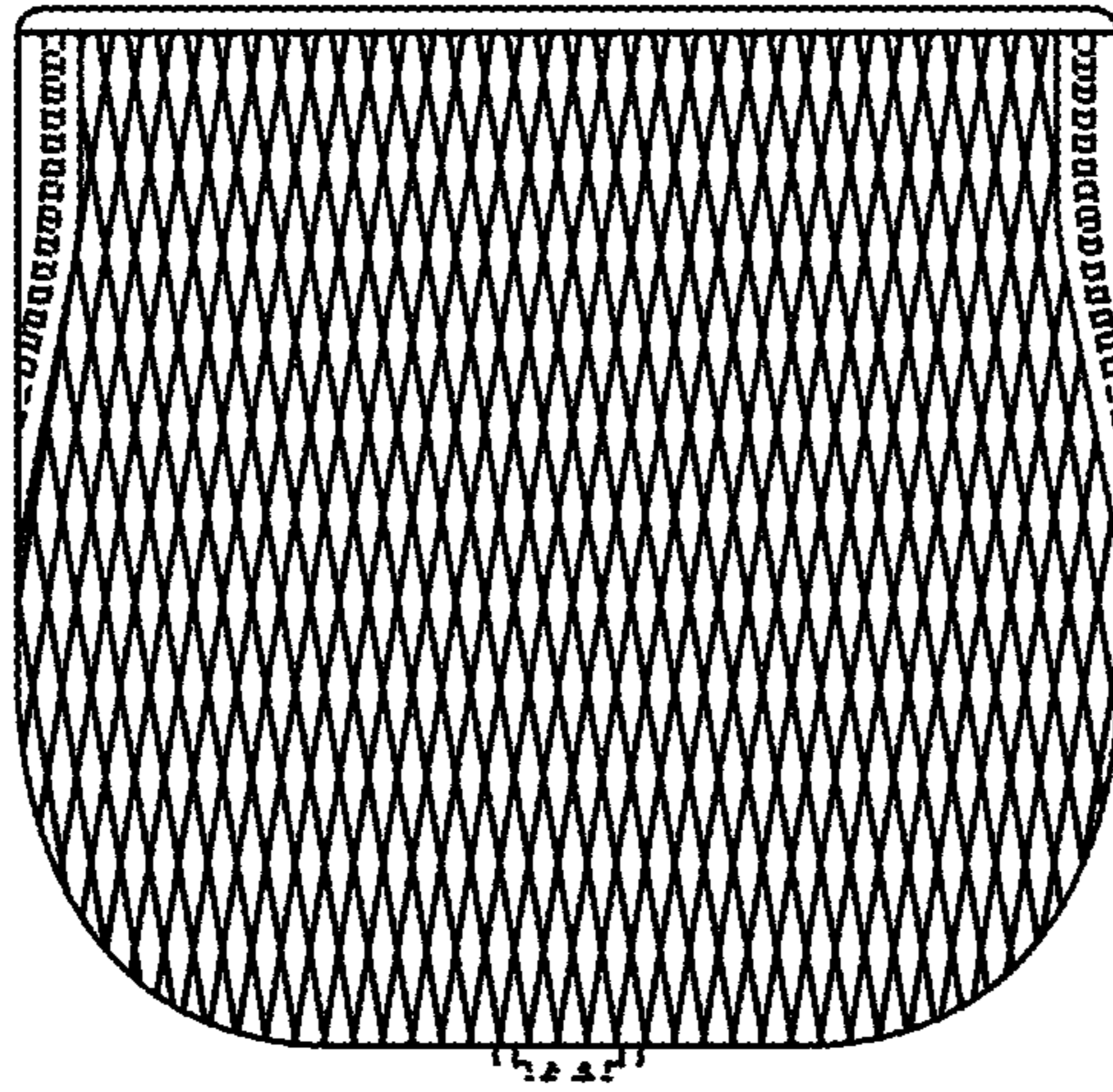

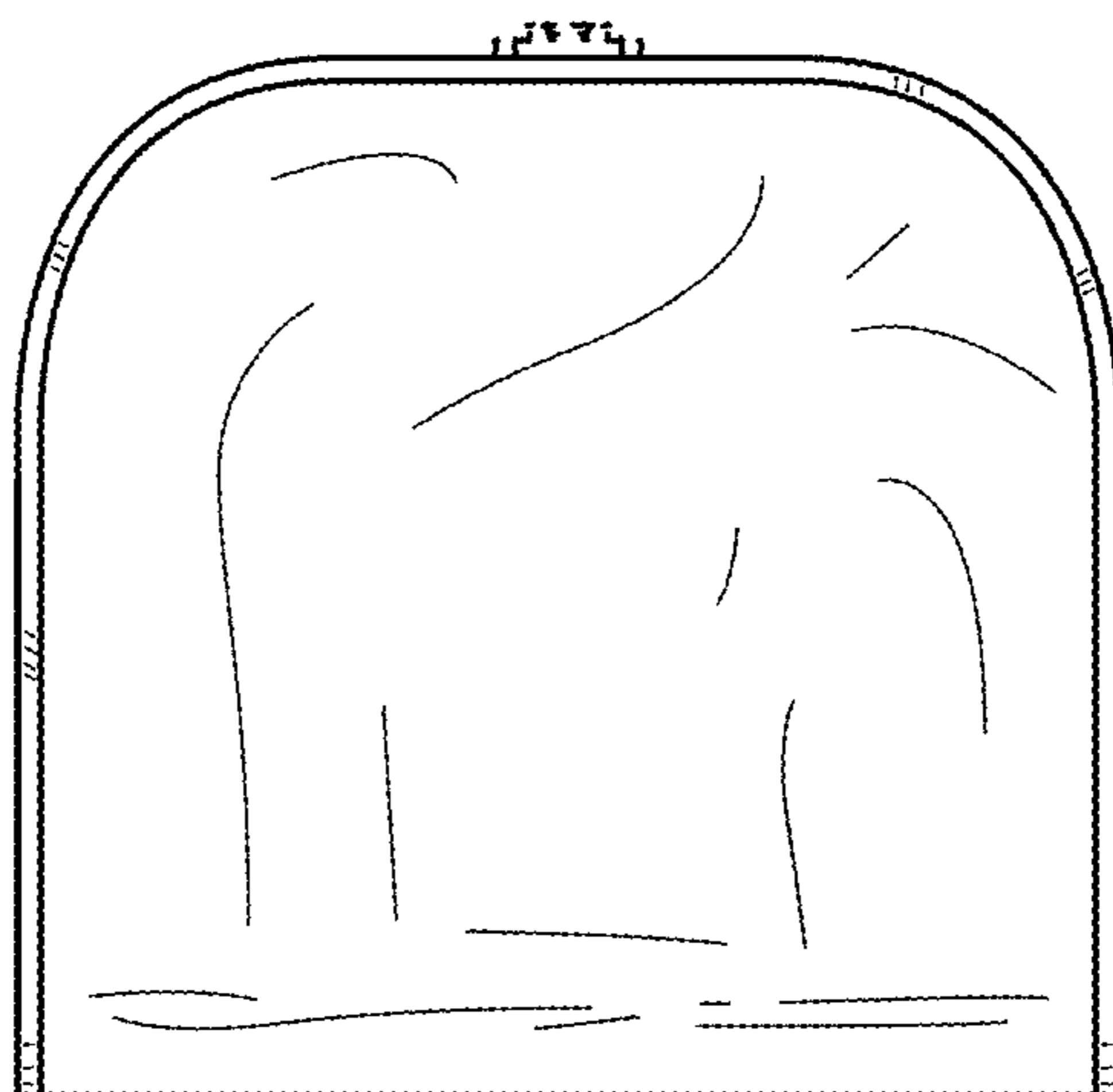

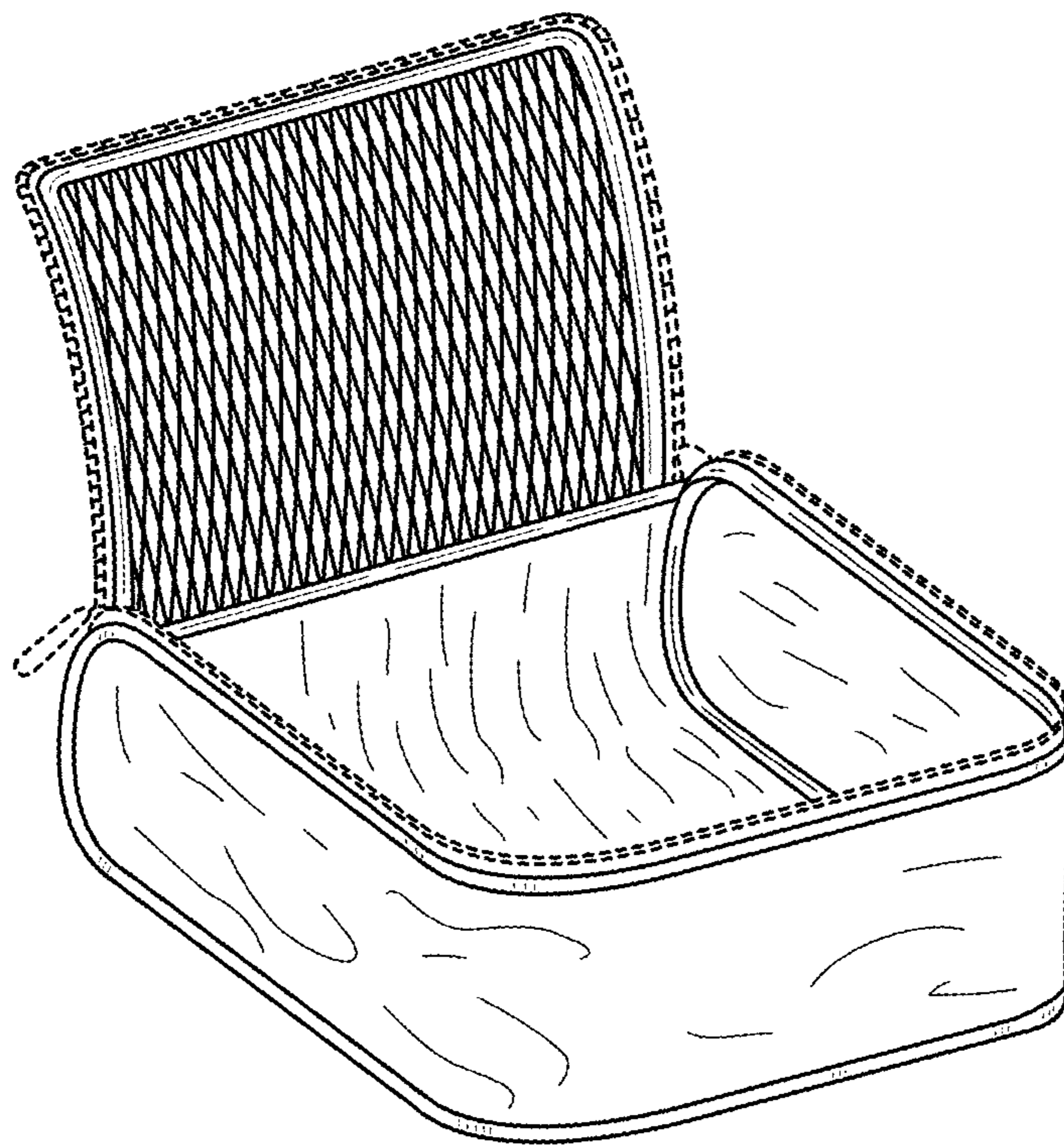
