(57) **CLAIM**

The ornamental design for a foldable chair with changeable seats, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the foldable chair with changeable seats showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is an exploded view thereof; FIG. 9 is a perspective view of the foldable chair with changeable seats with a second seat showing my new design; FIG. 10 is a front elevational view thereof; FIG. 11 is a rear elevational view thereof; FIG. 12 is a left side elevational view thereof; FIG. 13 is a right side elevational thereof; FIG. 14 is a top plan view thereof; FIG. 15 is a bottom plan view thereof; FIG. 16 is an exploded view thereof; and, FIG. 17 is a perspective view of the chair structure when it is folded.

The dashed lines shown on the seat and backrest of the chair are understood to represent stitching.

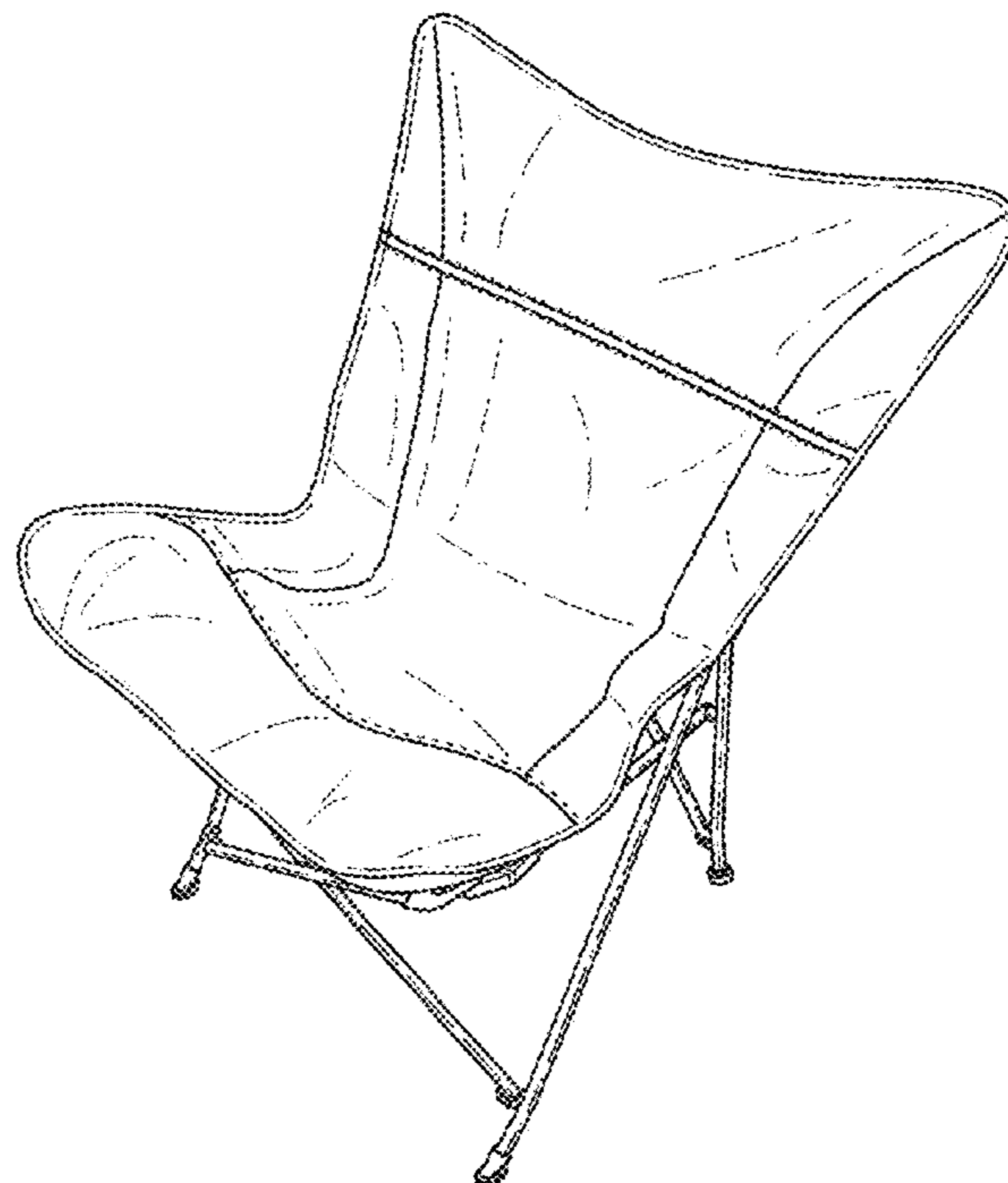

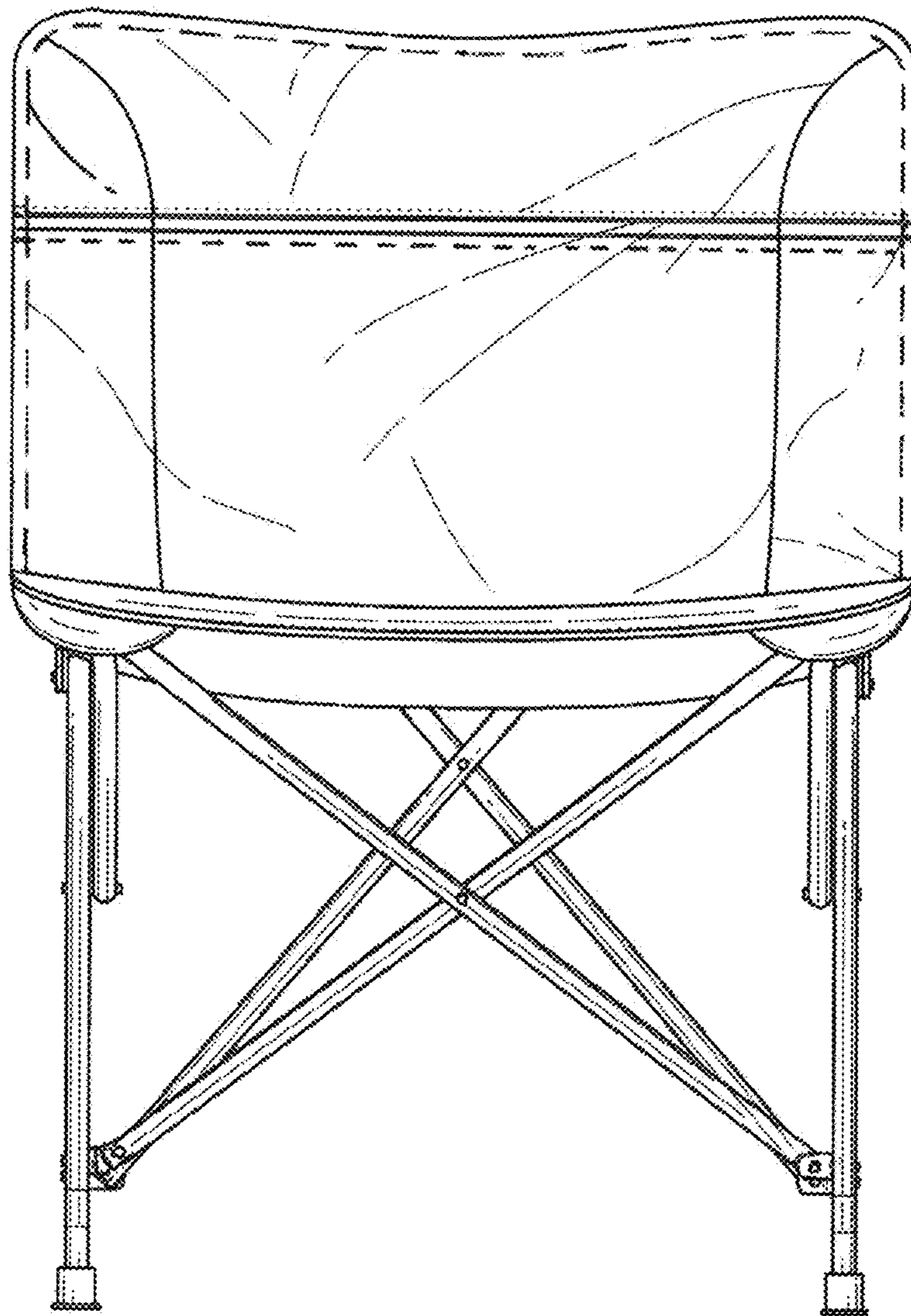

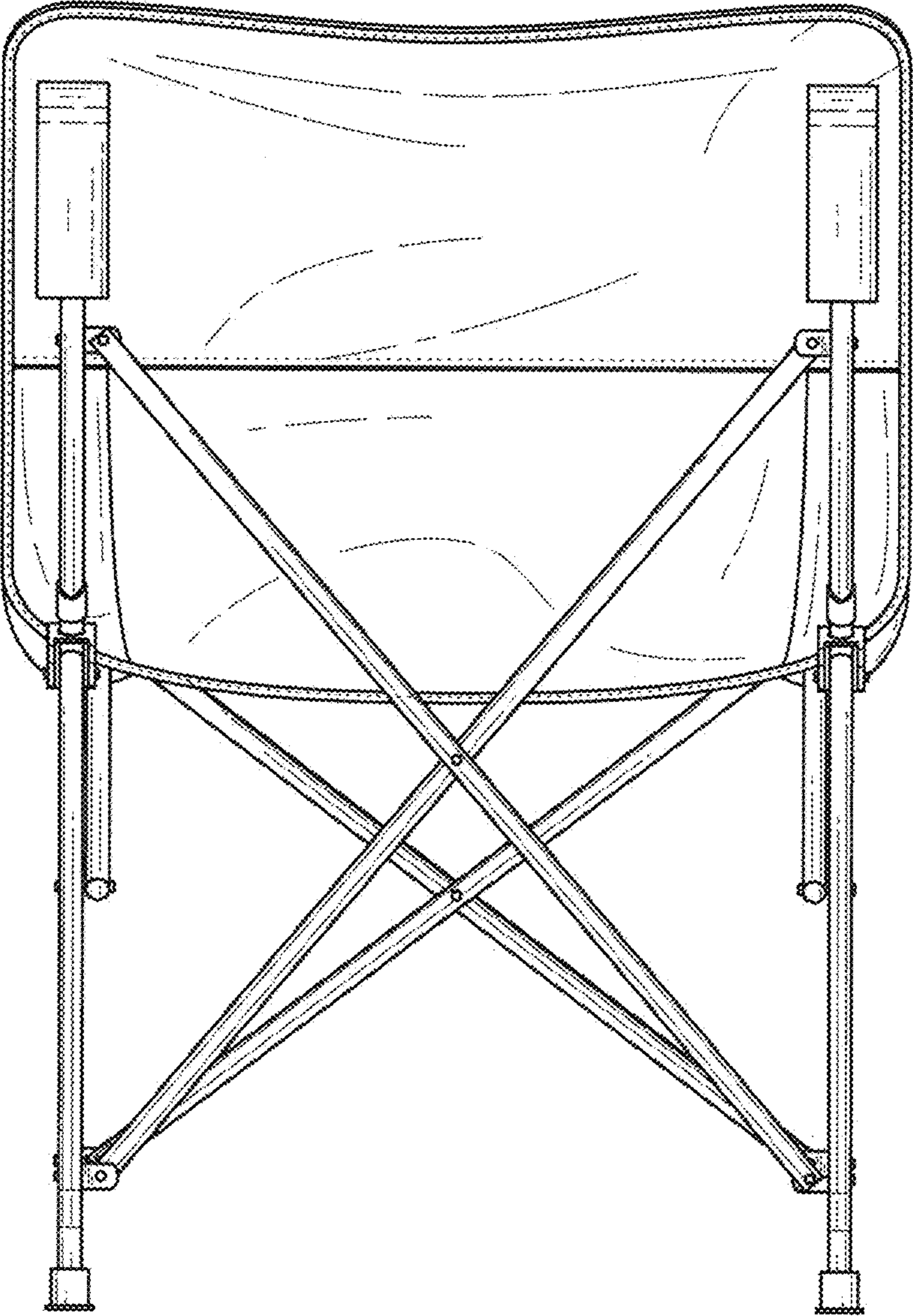

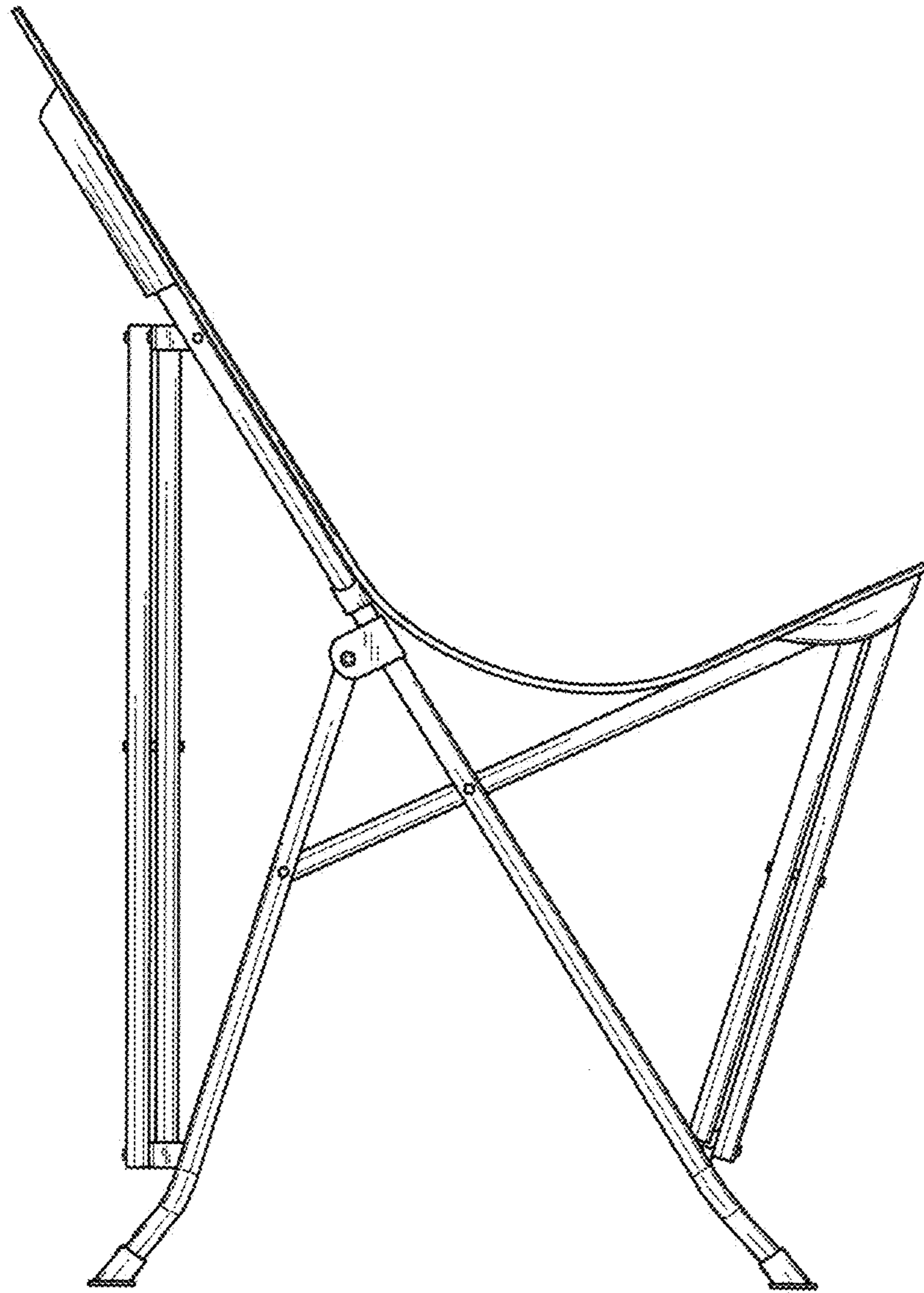

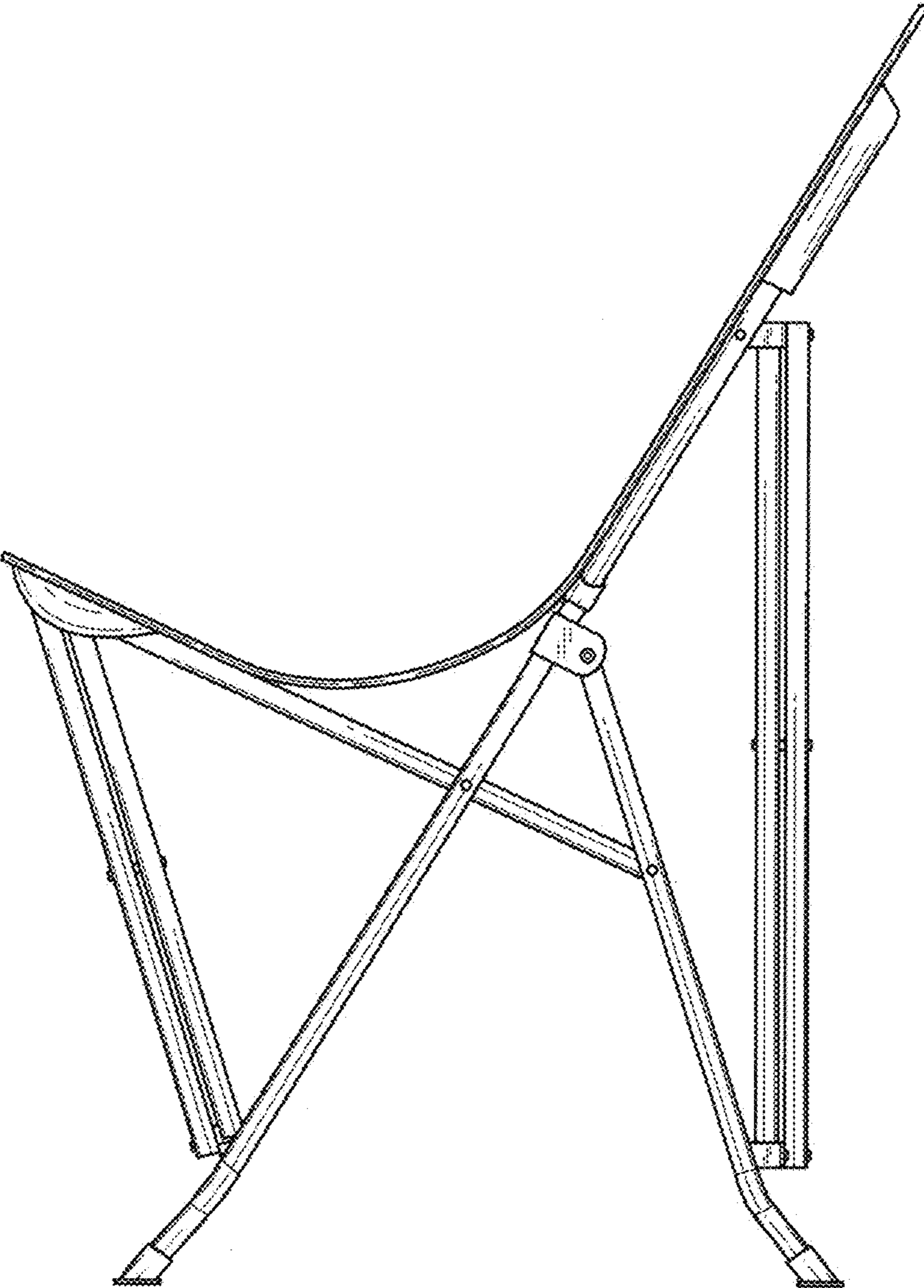

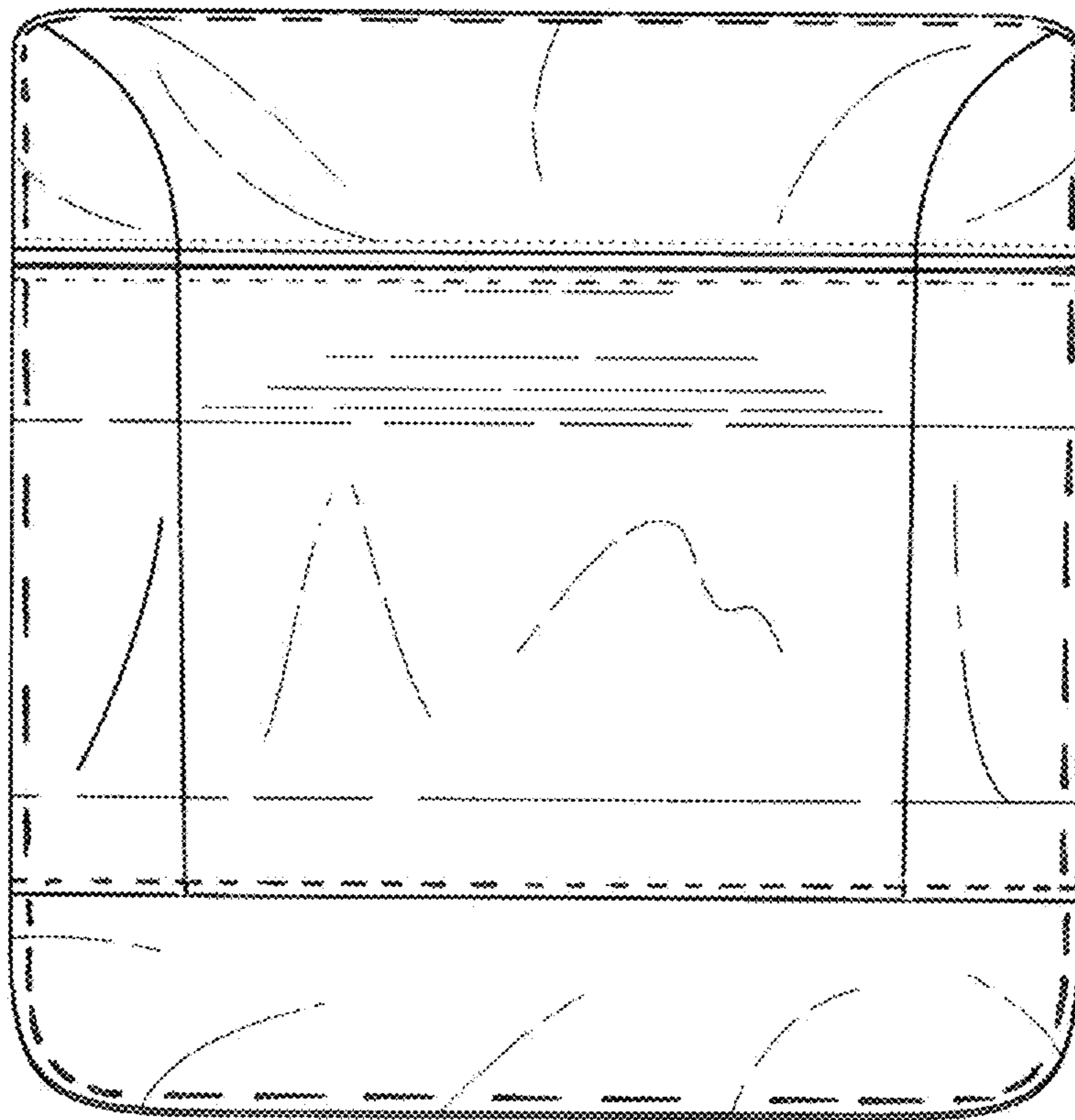

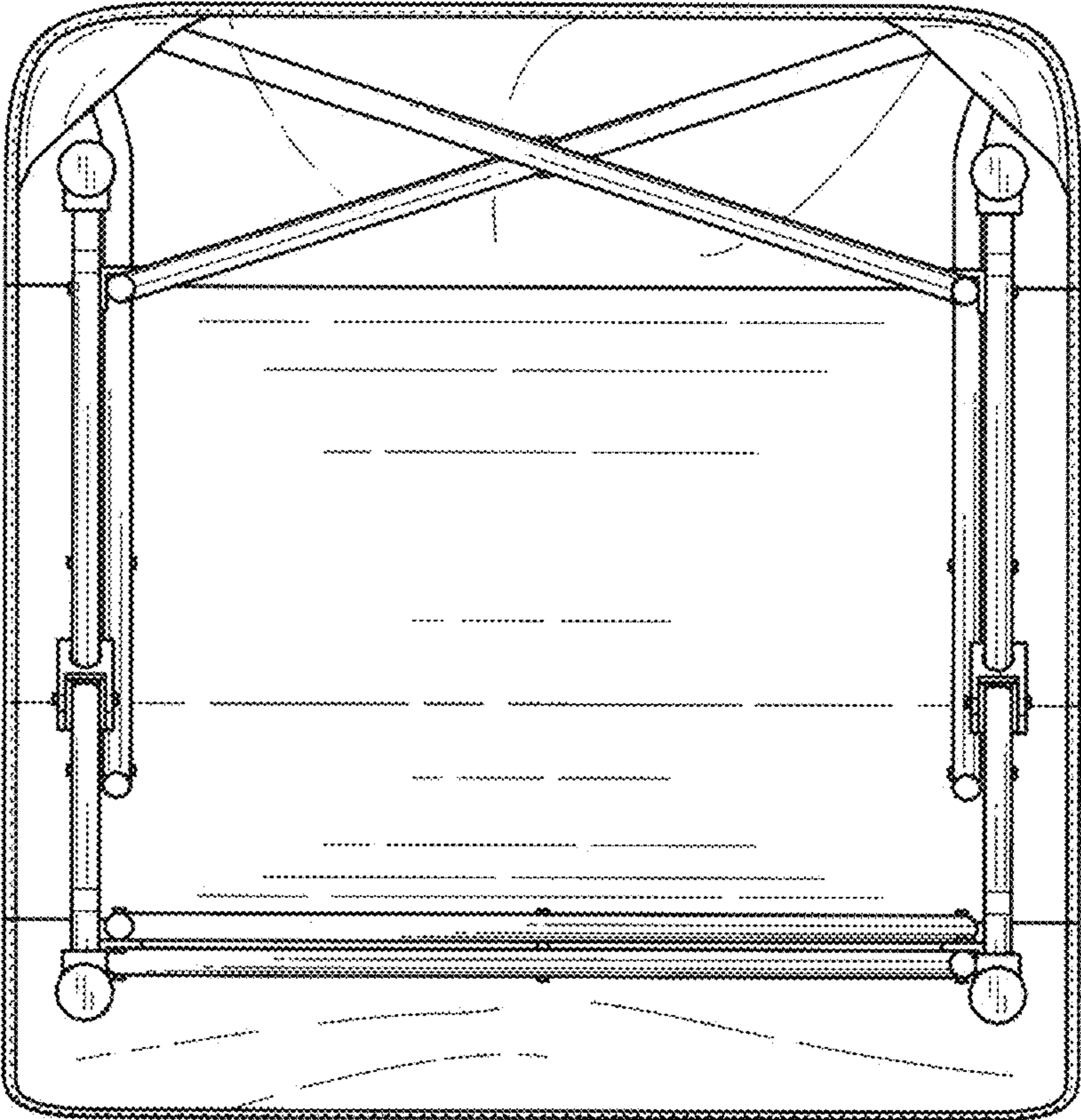

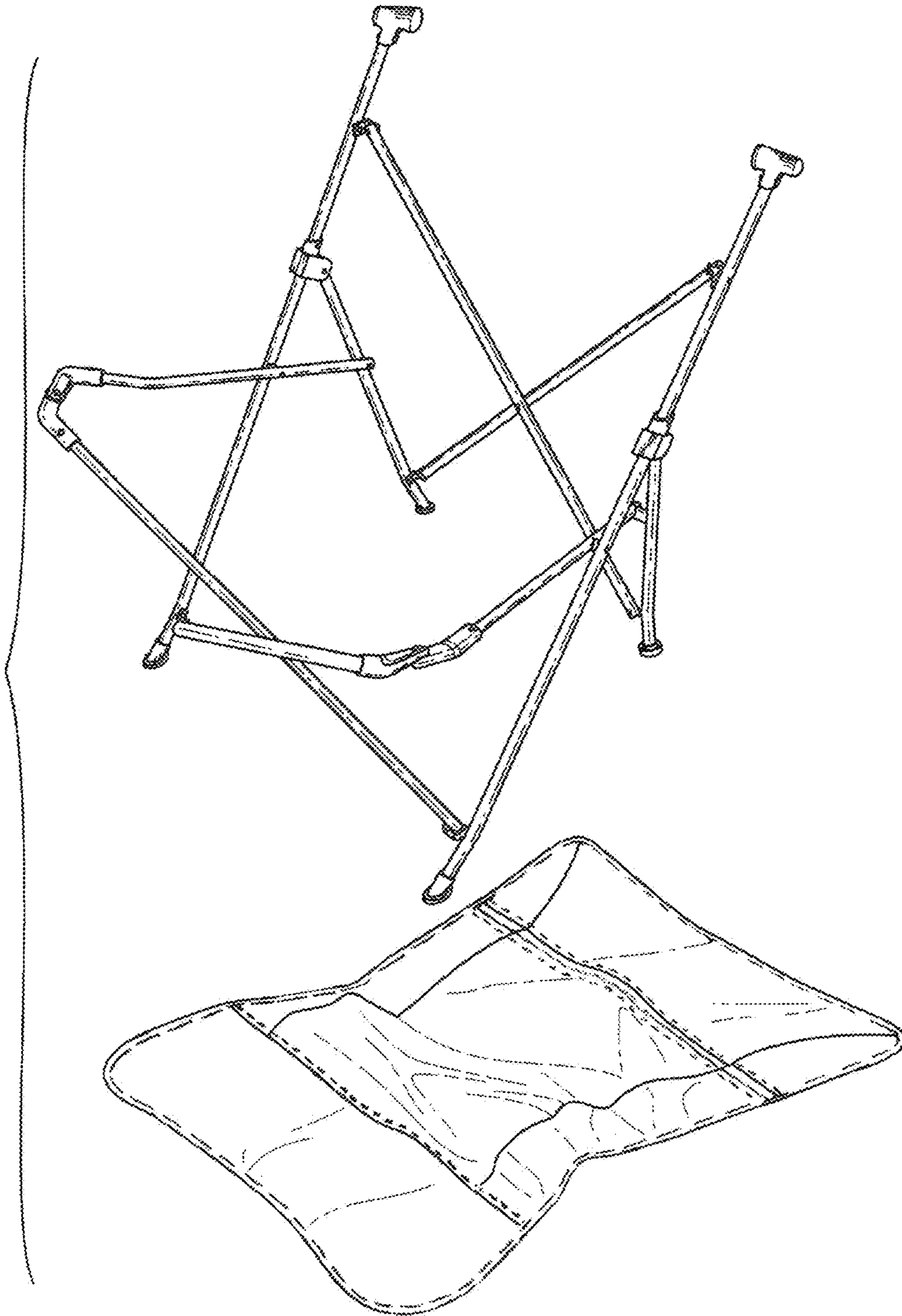

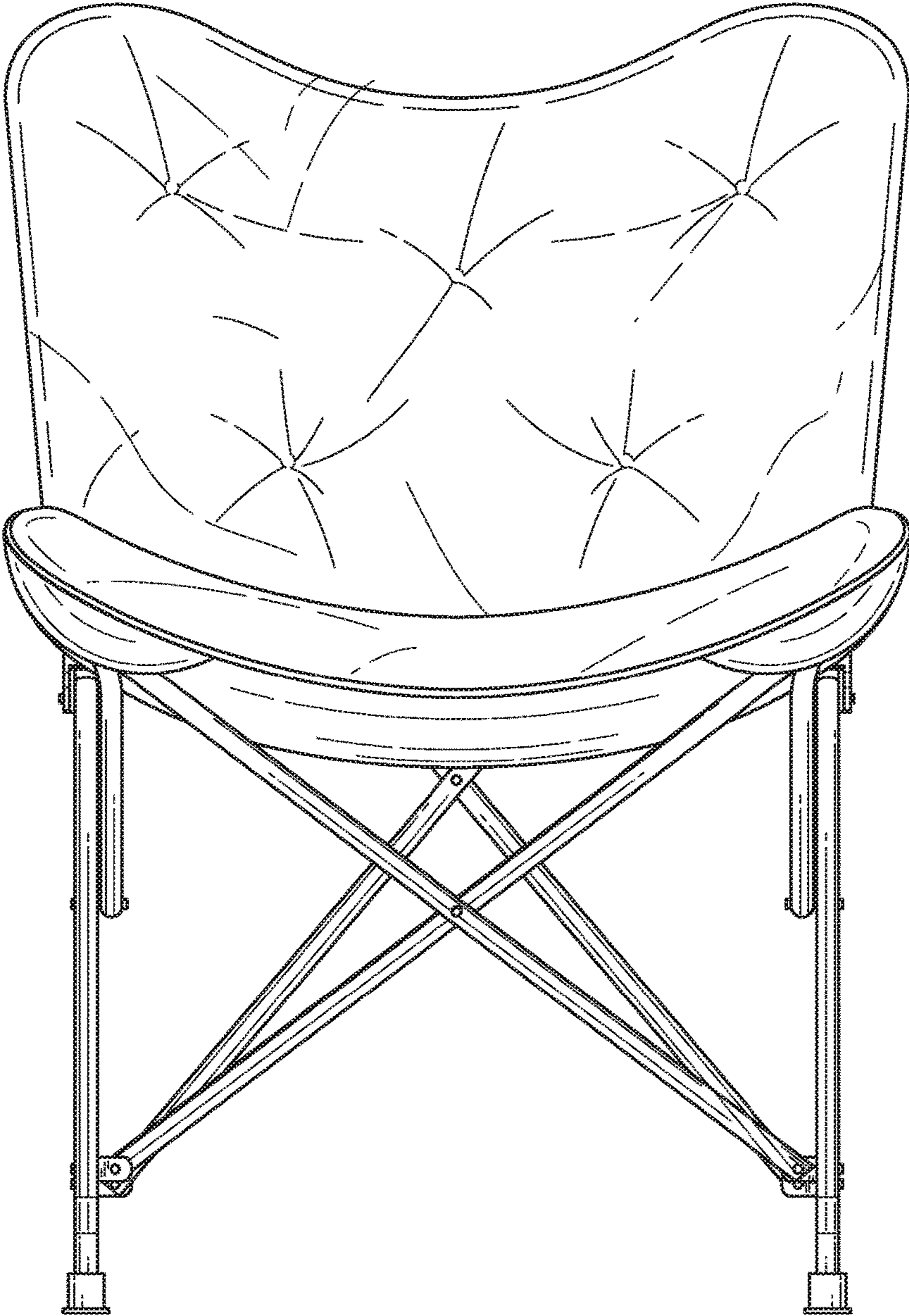

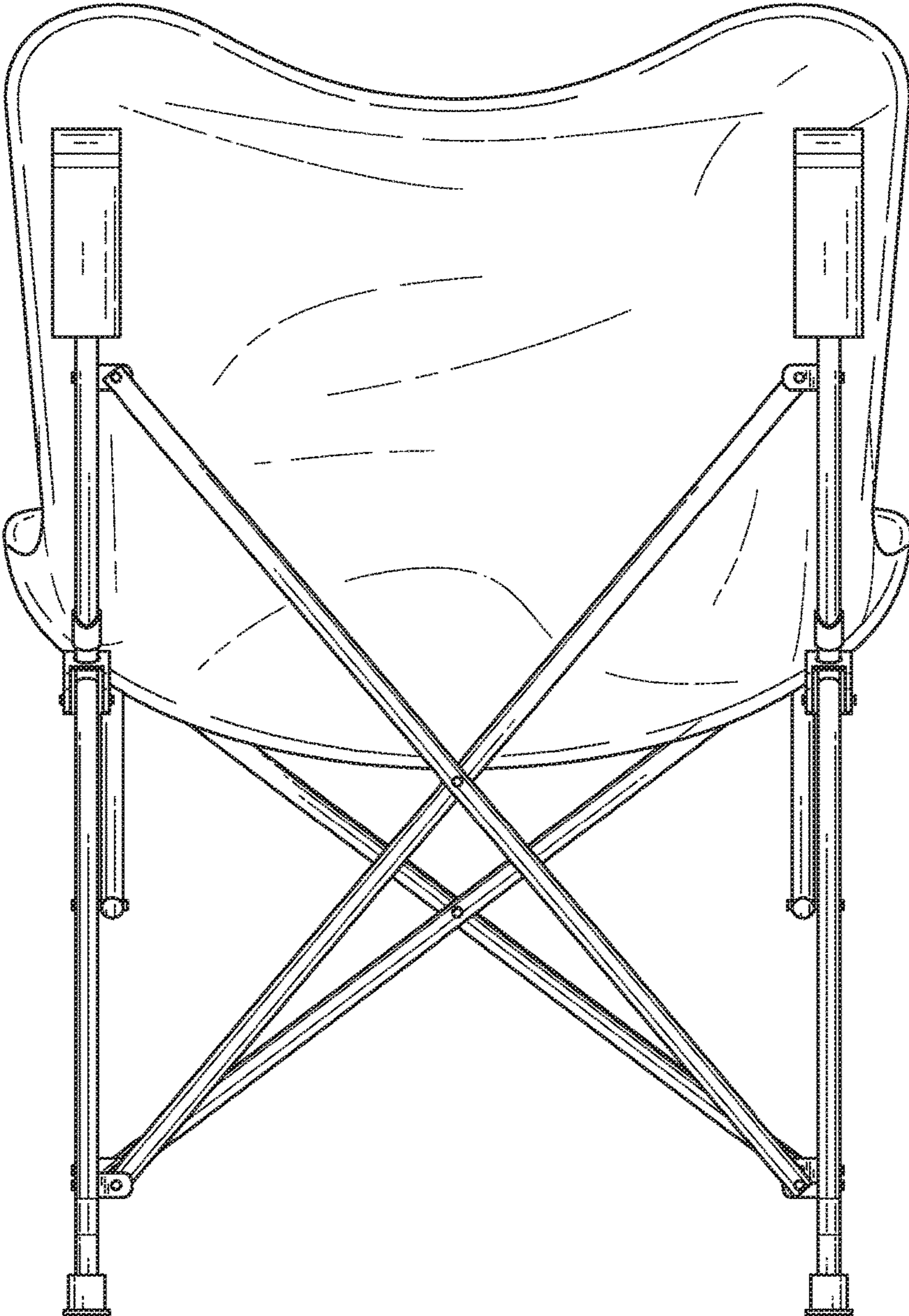

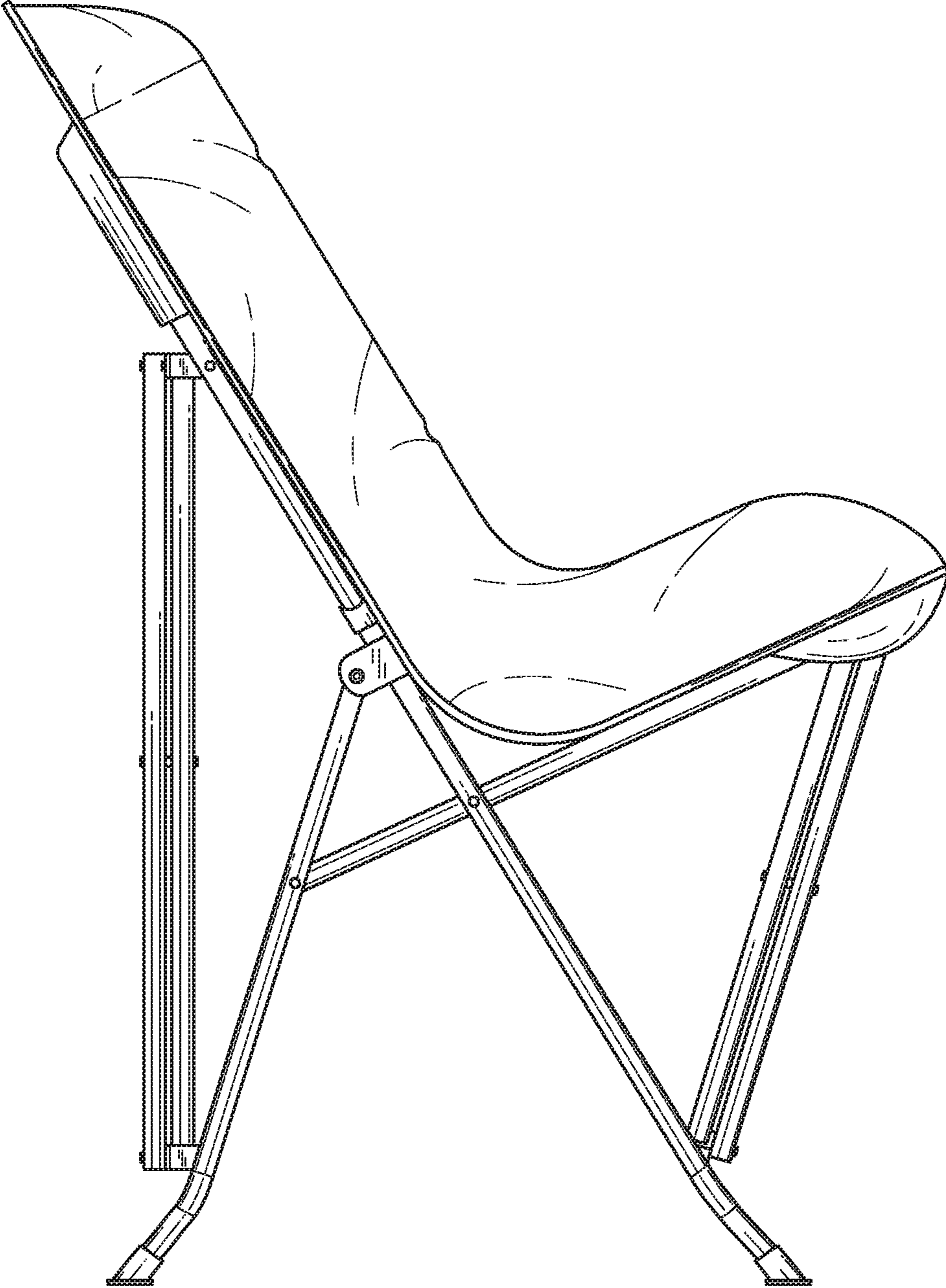

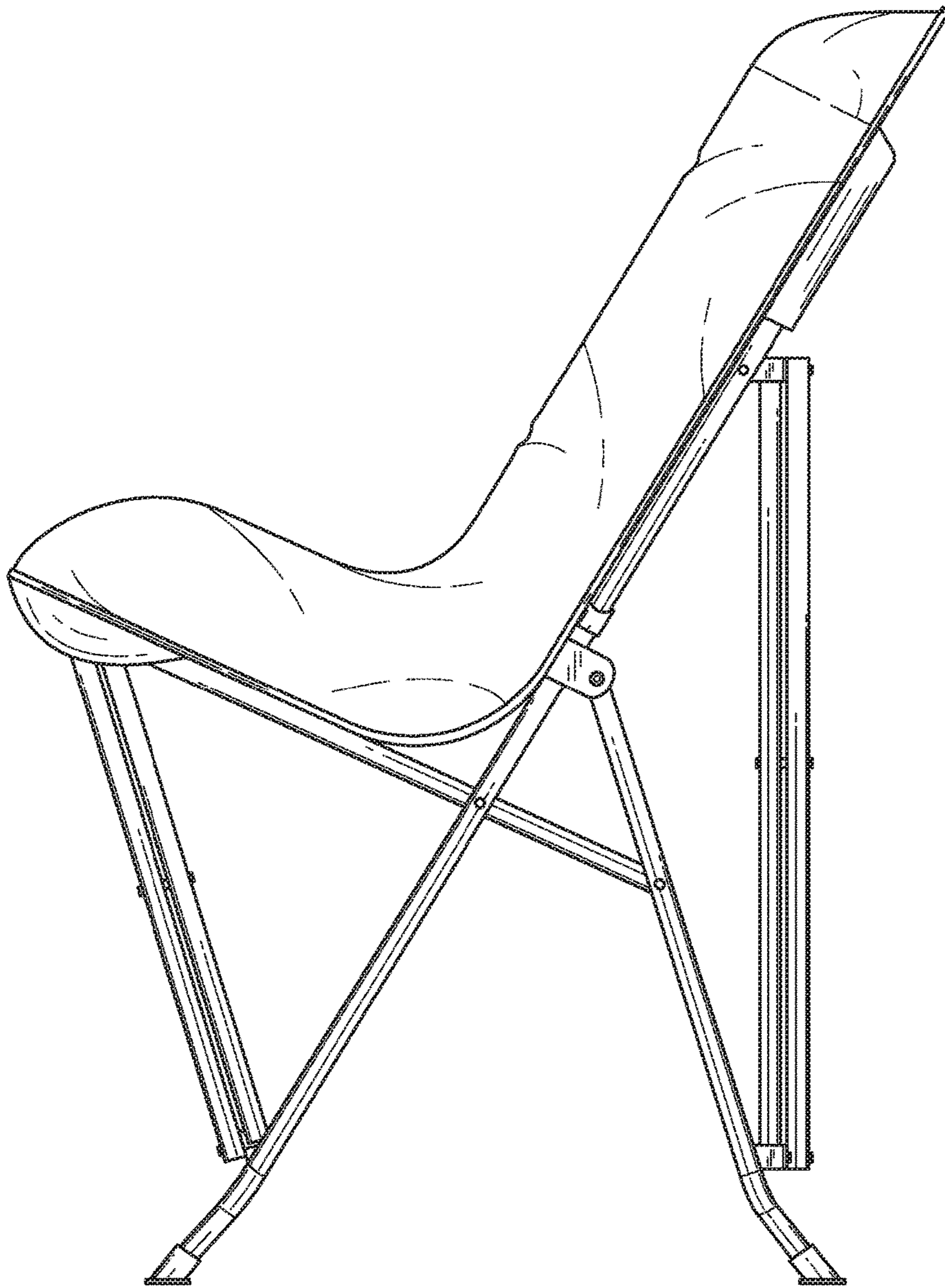

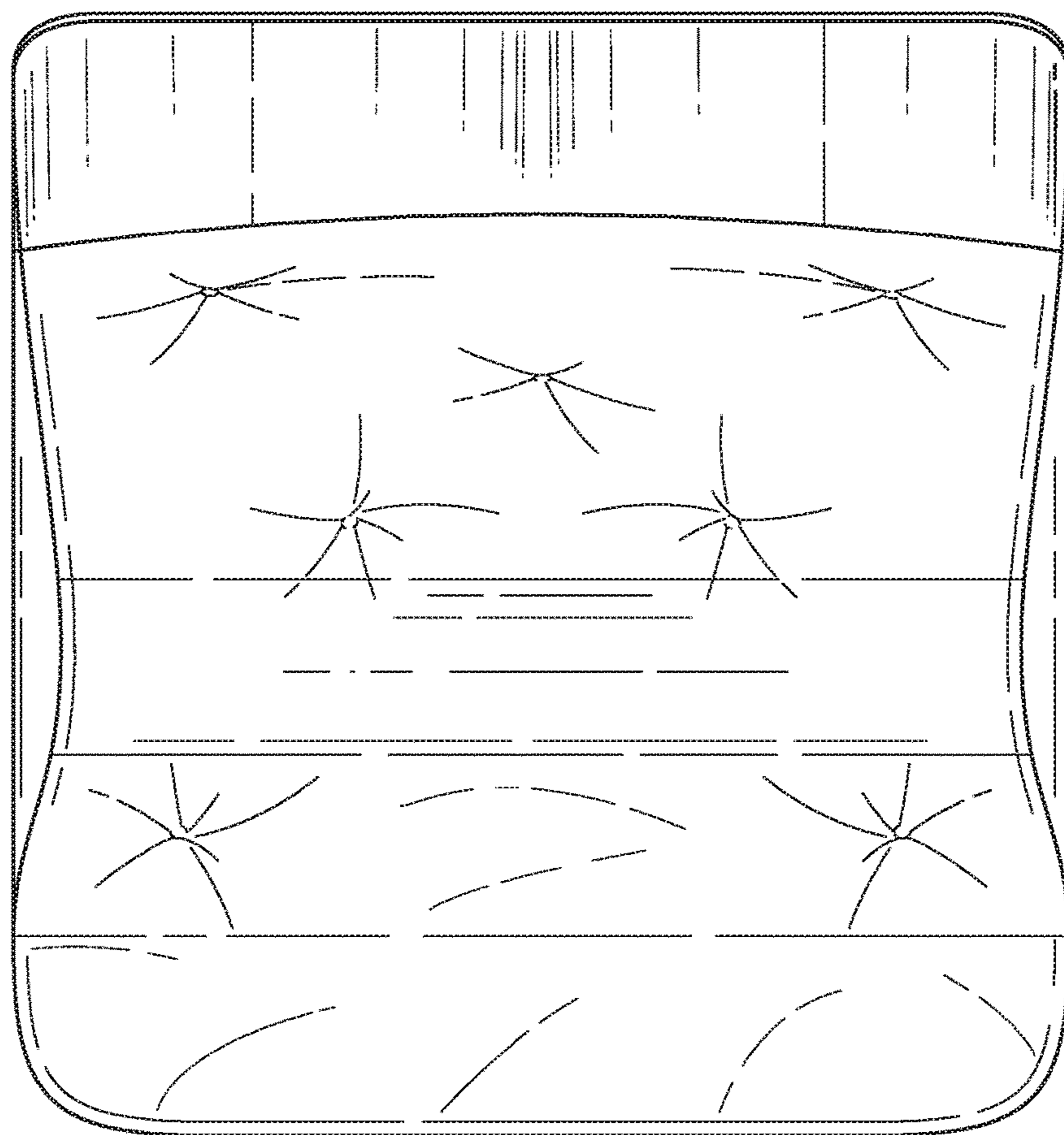

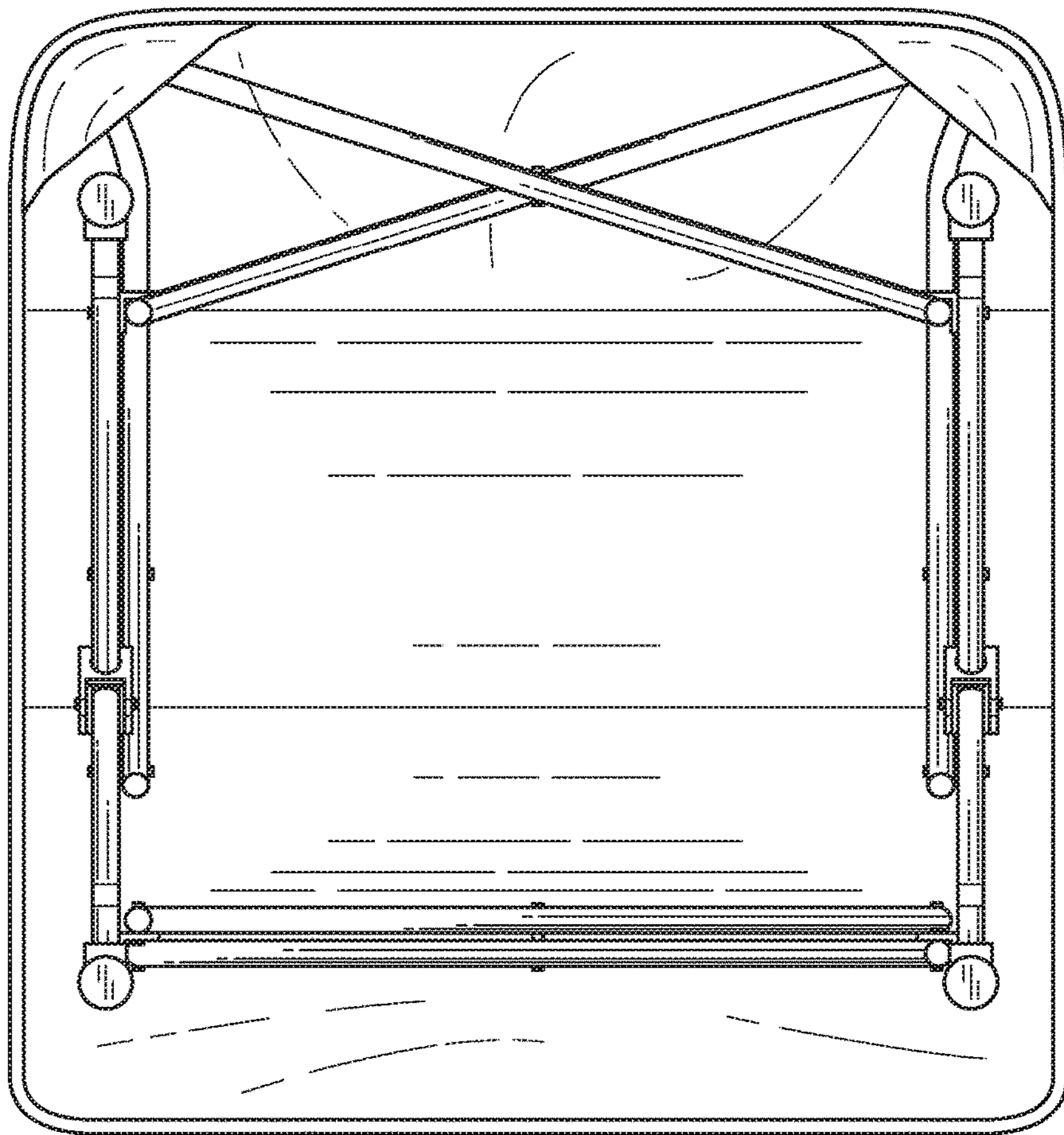

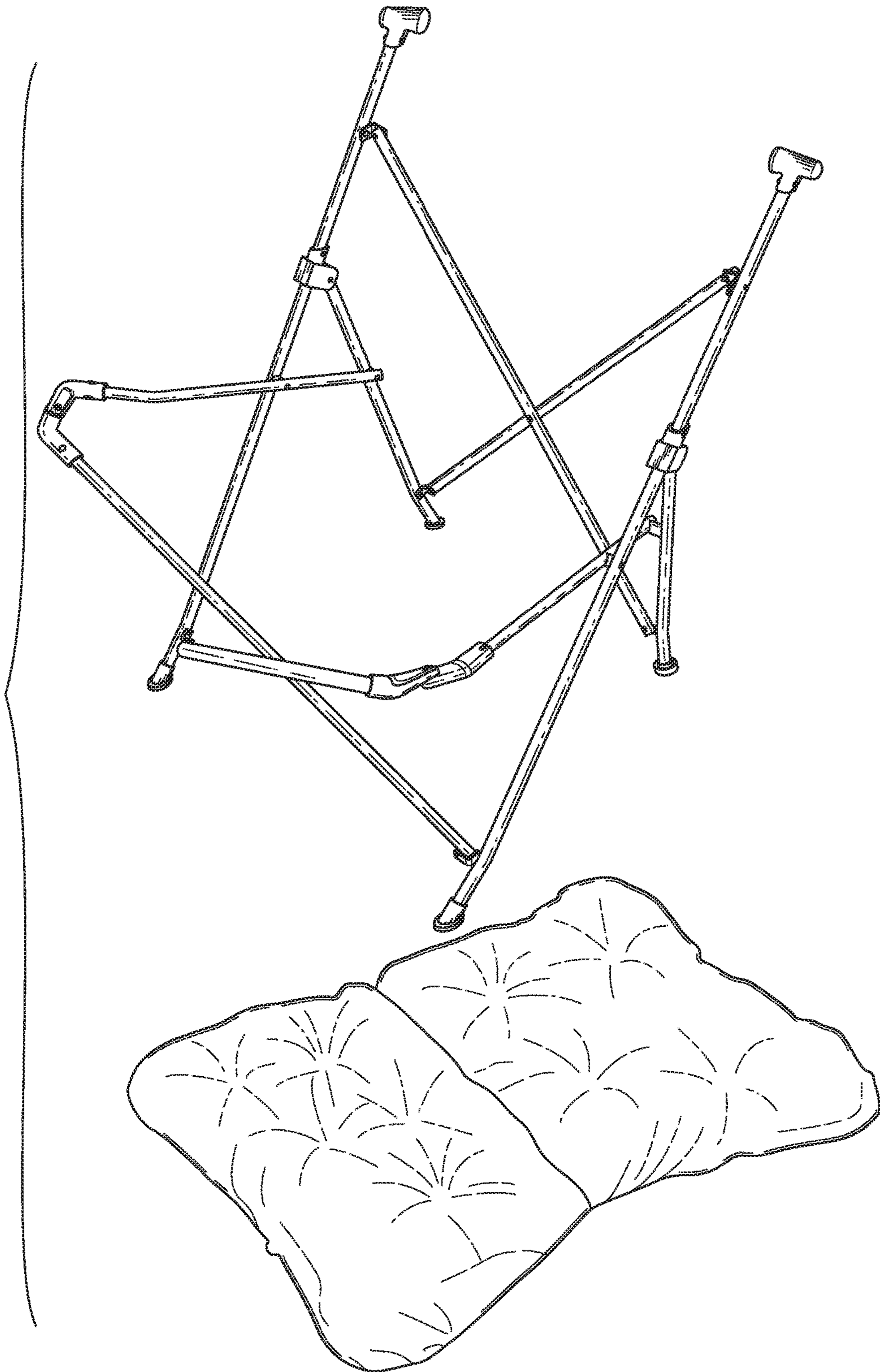

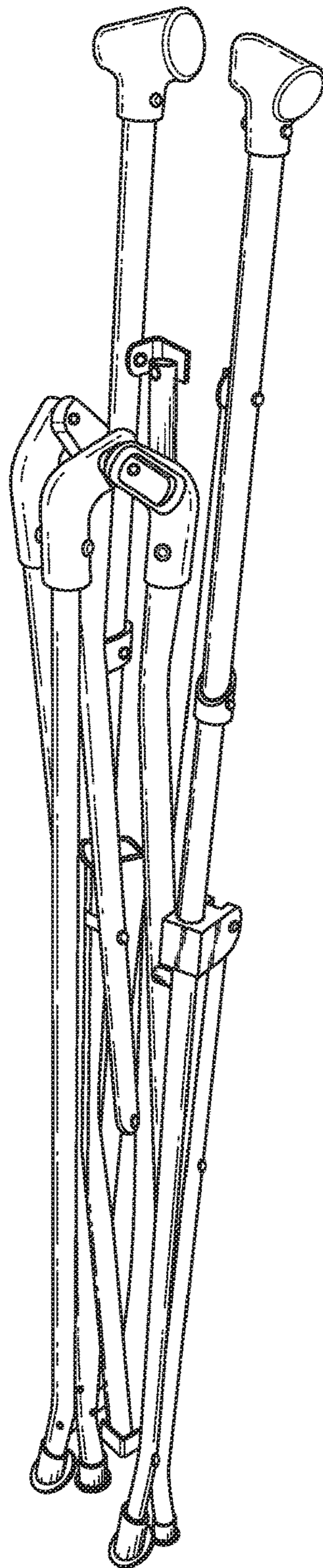
