The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a chair.
FIG. 2 is a rear perspective view thereof.
FIG. 3 is a front elevation view thereof.
FIG. 4 is a rear elevation view thereof.
FIG. 5 is a right side elevation view thereof. A left side elevation view is a mirror image of the right side elevation view.
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The backrest sheet of the chair is made of mesh.

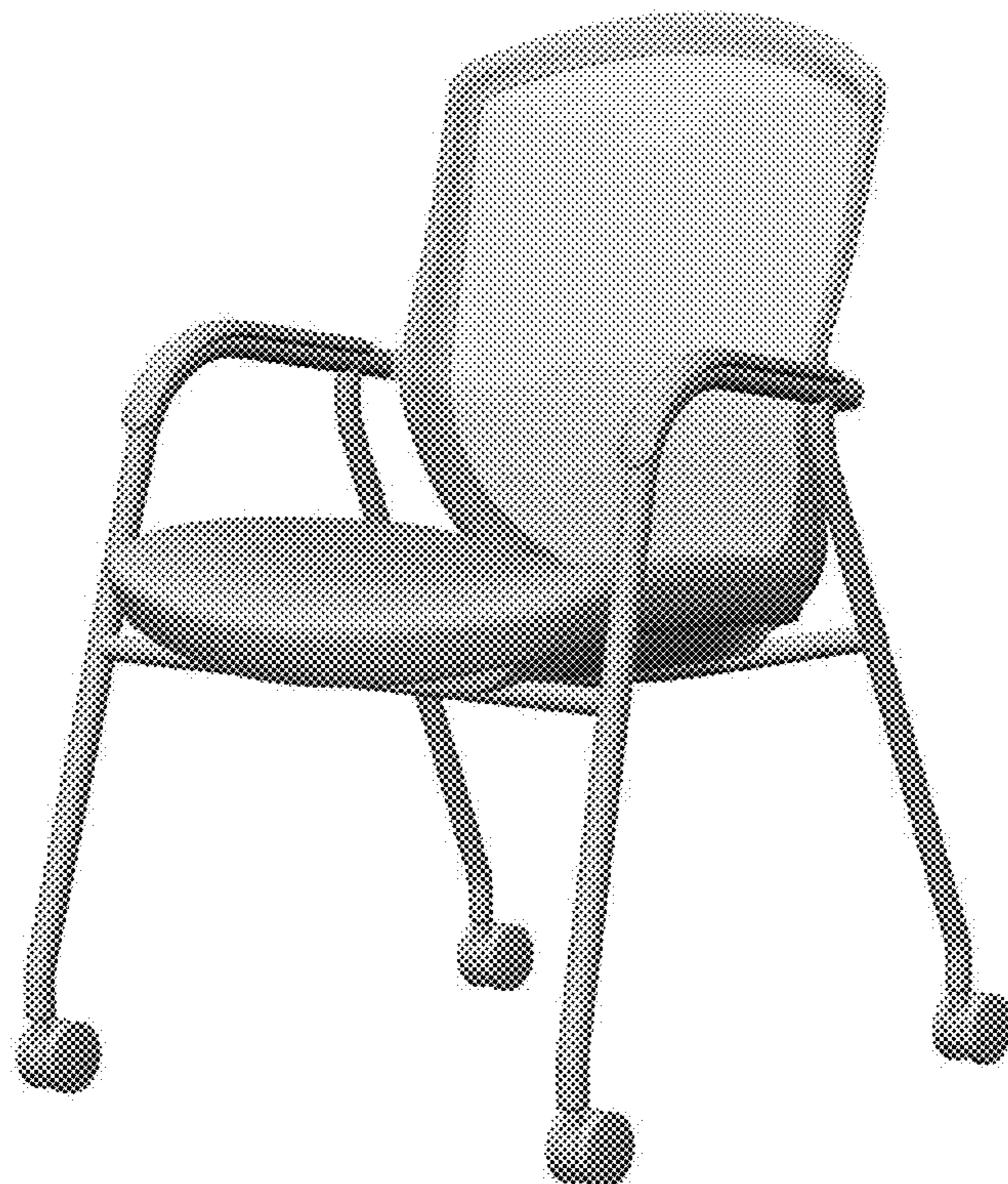
