FIG. 8 is a bottom view of the weapons storage component of FIG. 1.

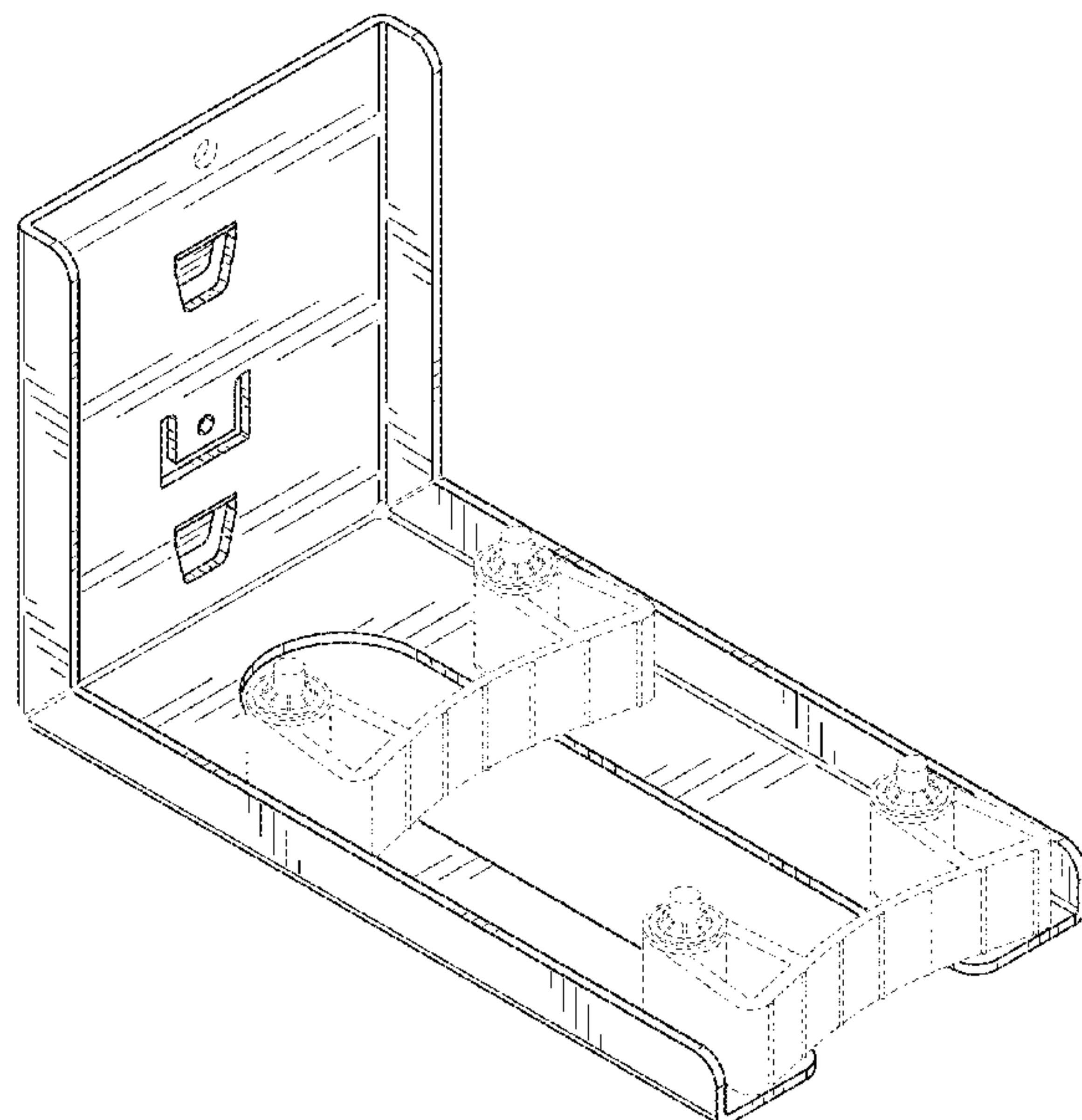
The broken lines in the drawings are portions of the weapons storage component that form no part of the claimed design.

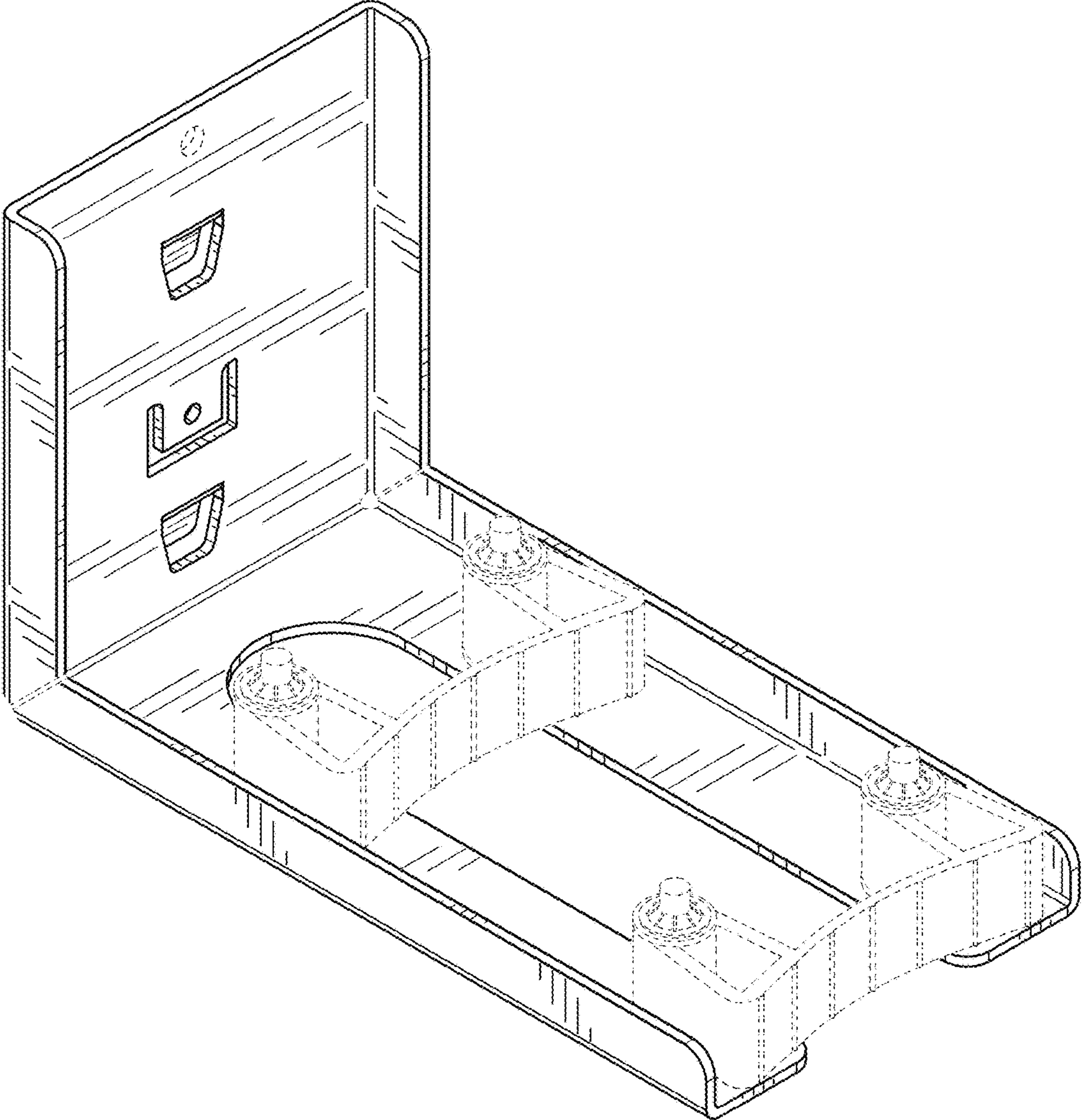

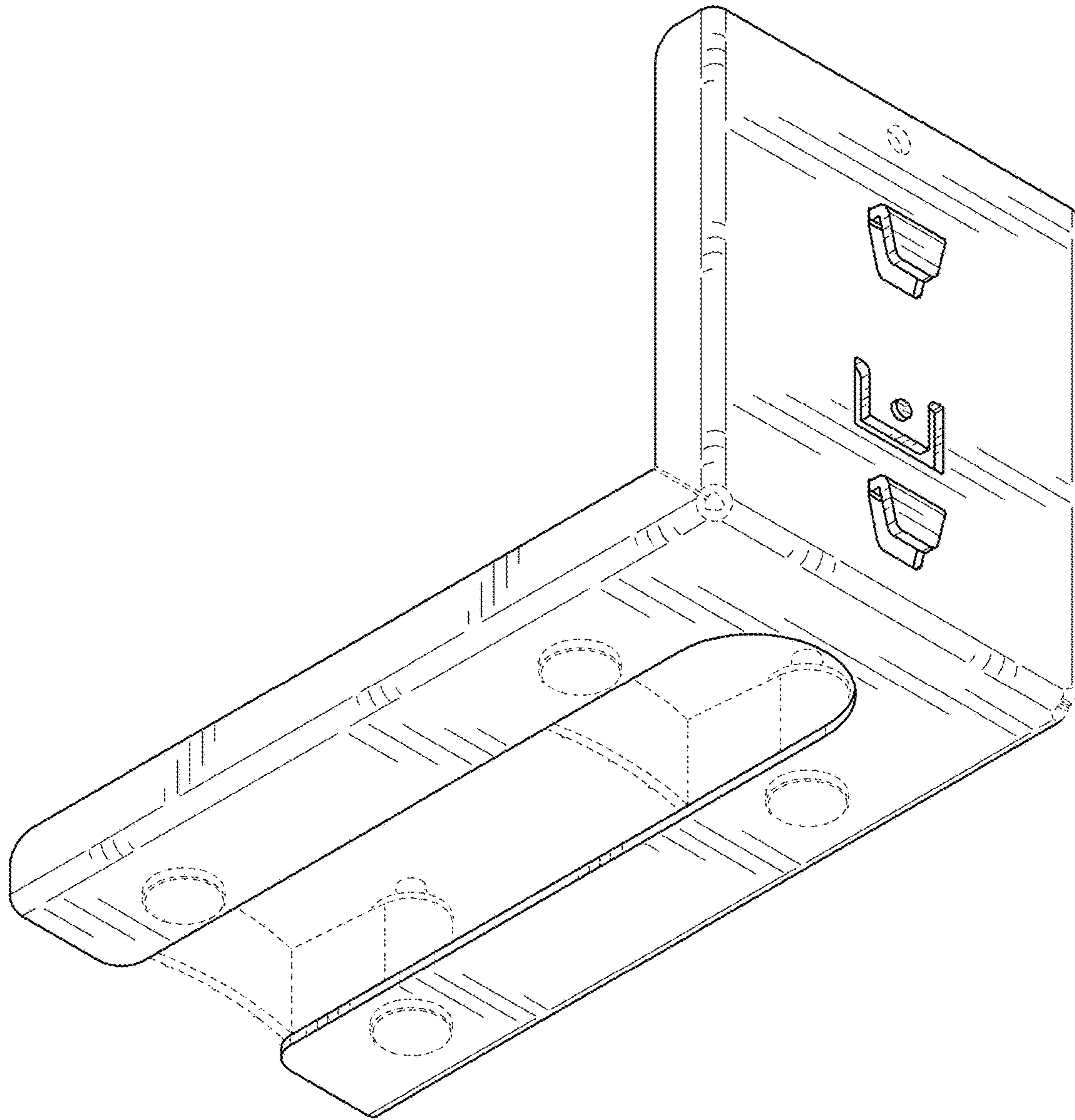

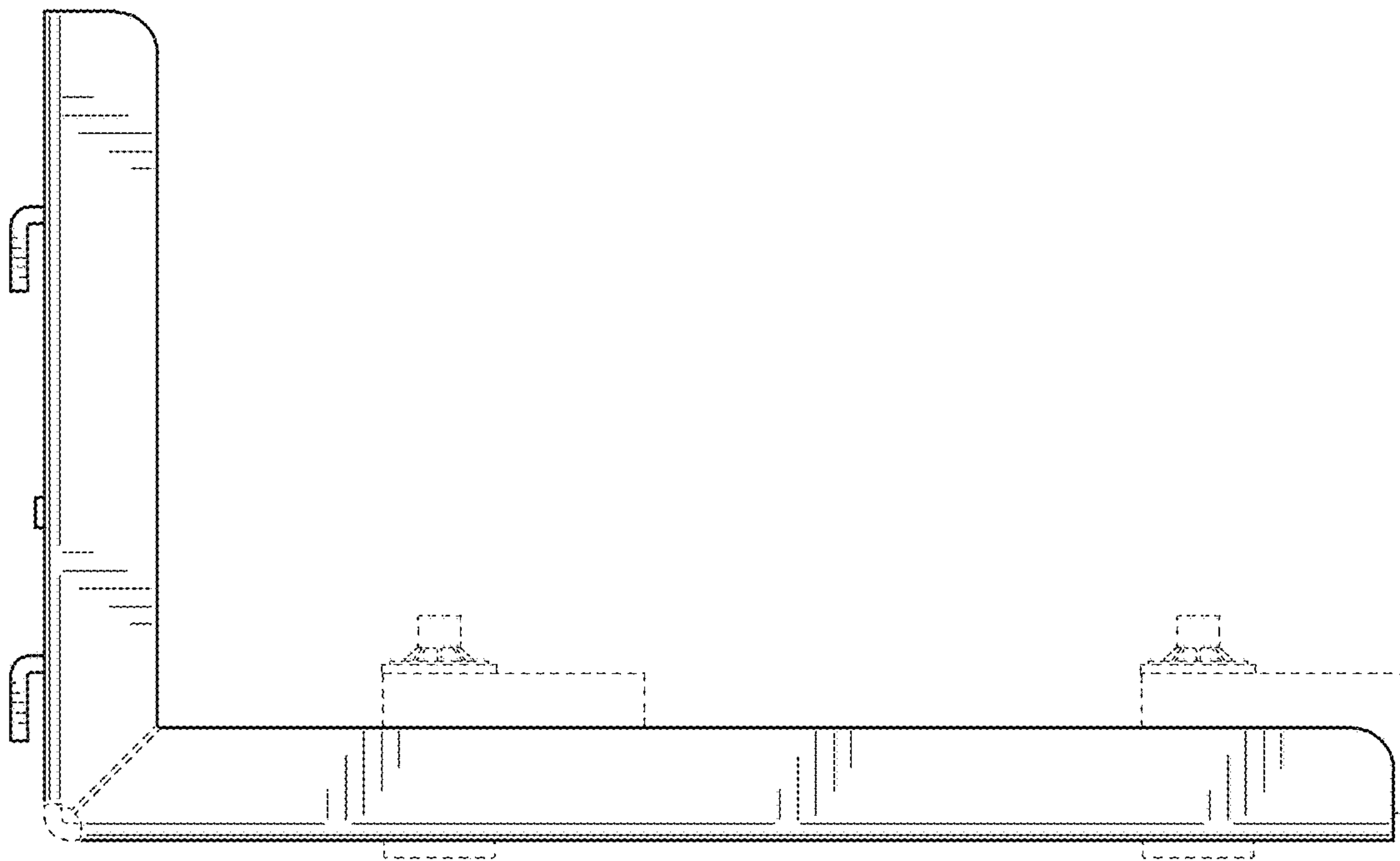

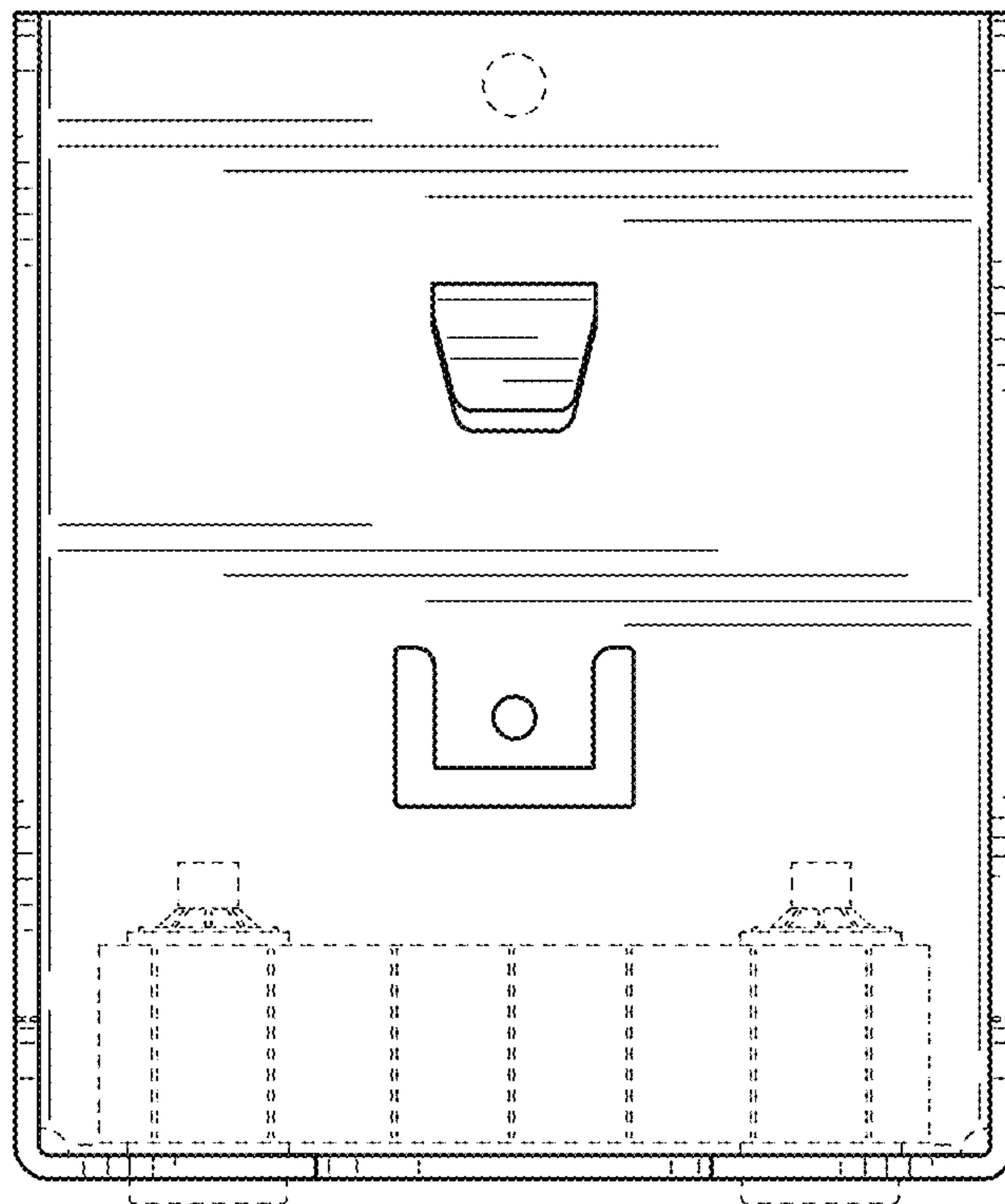

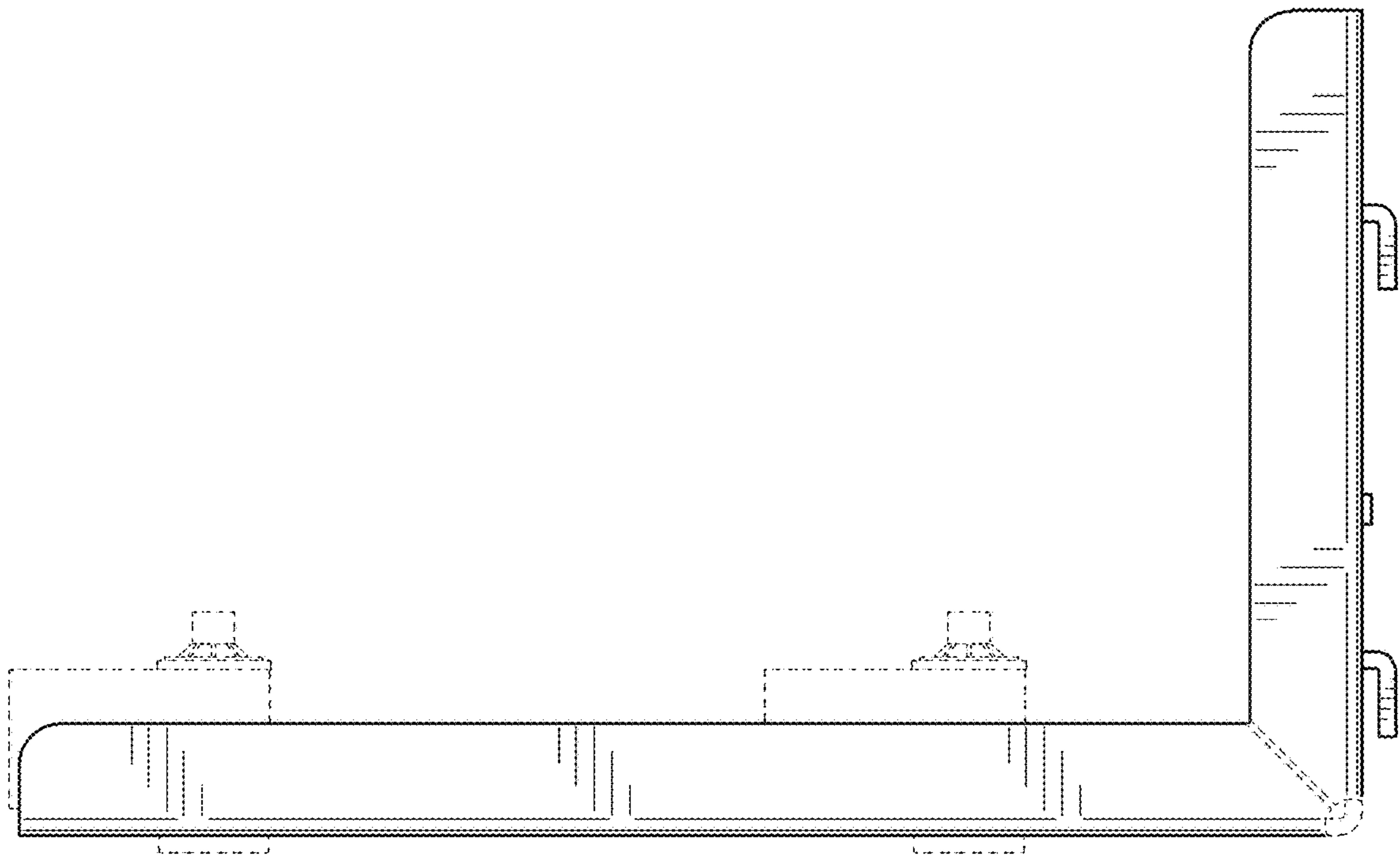

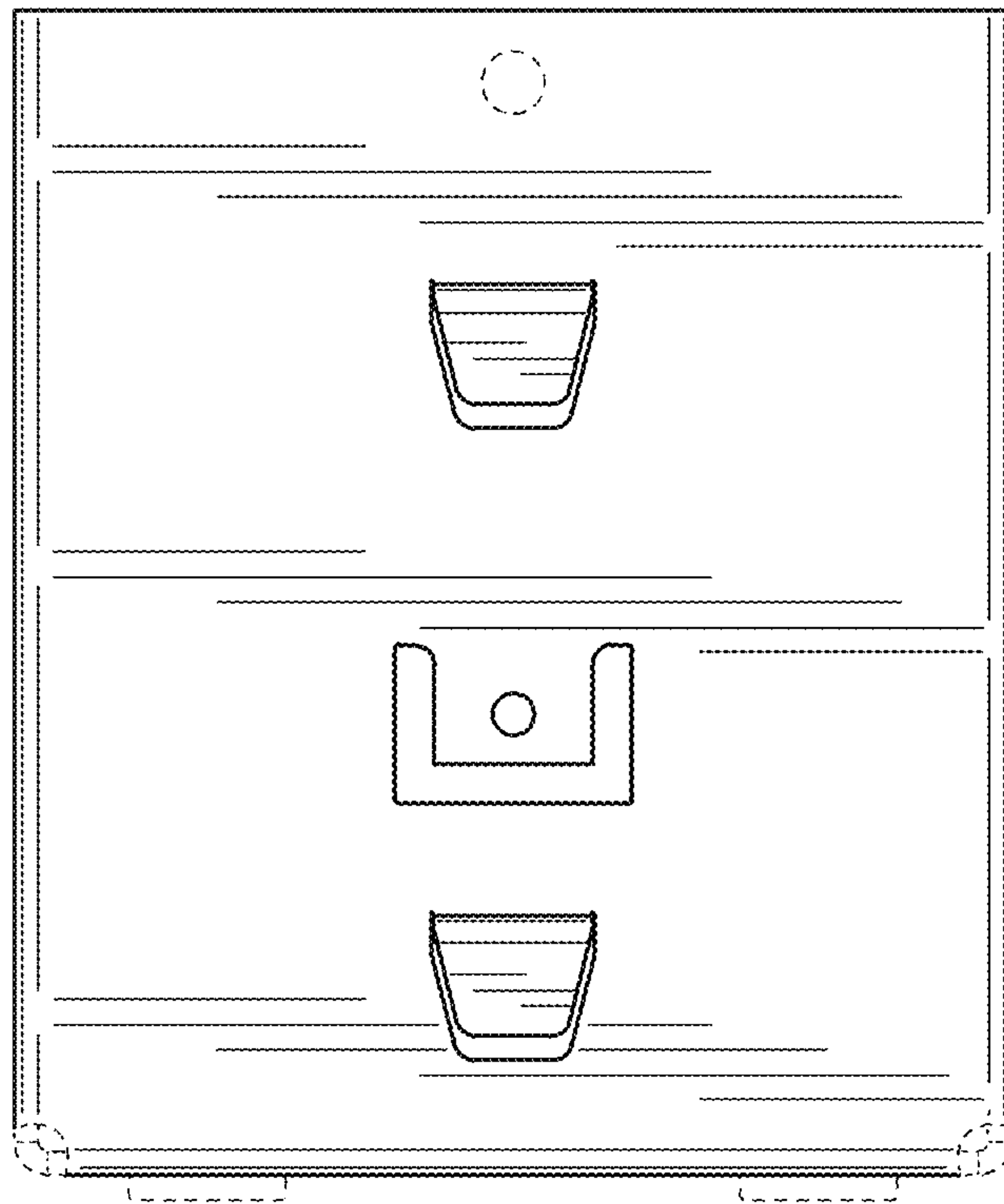

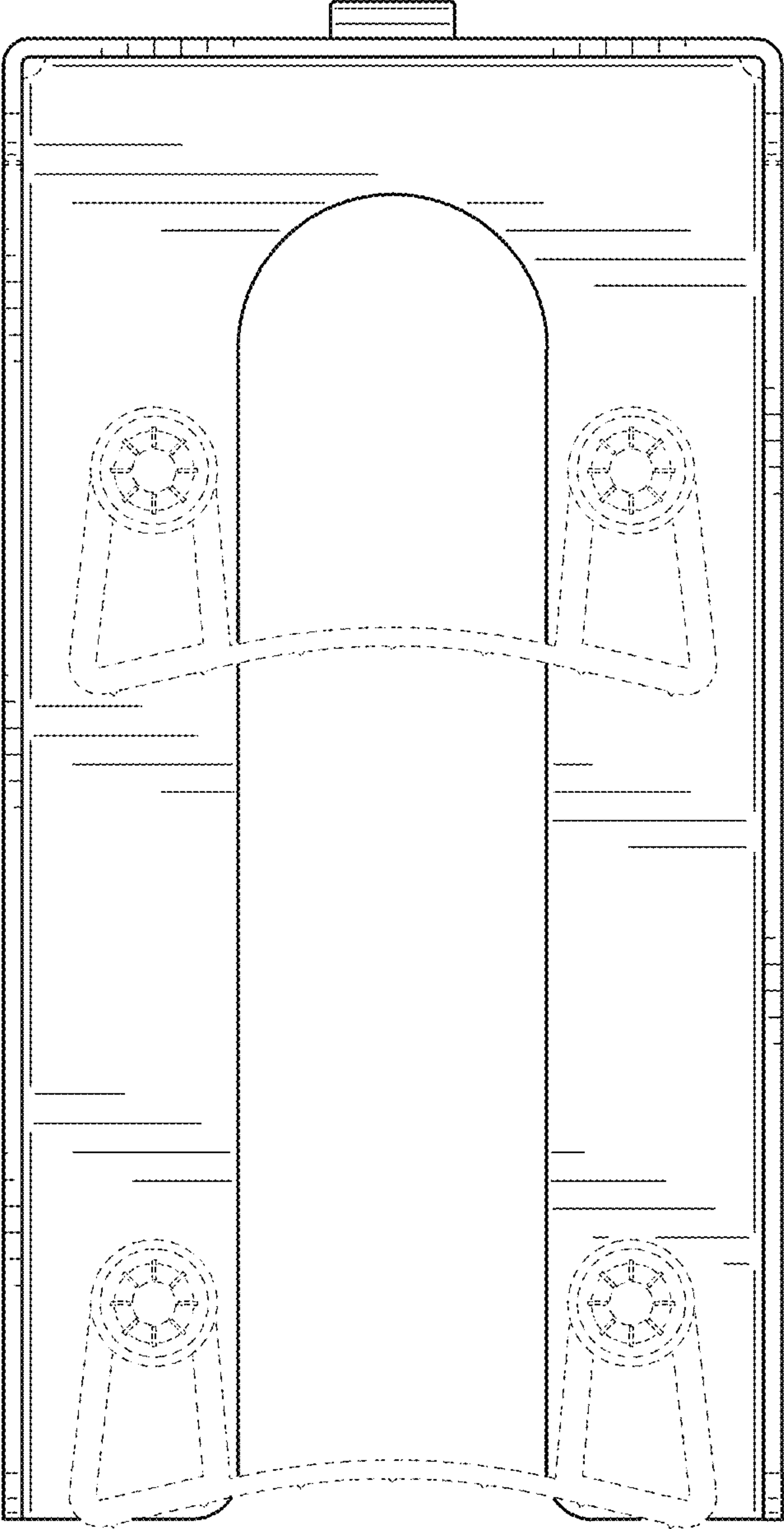

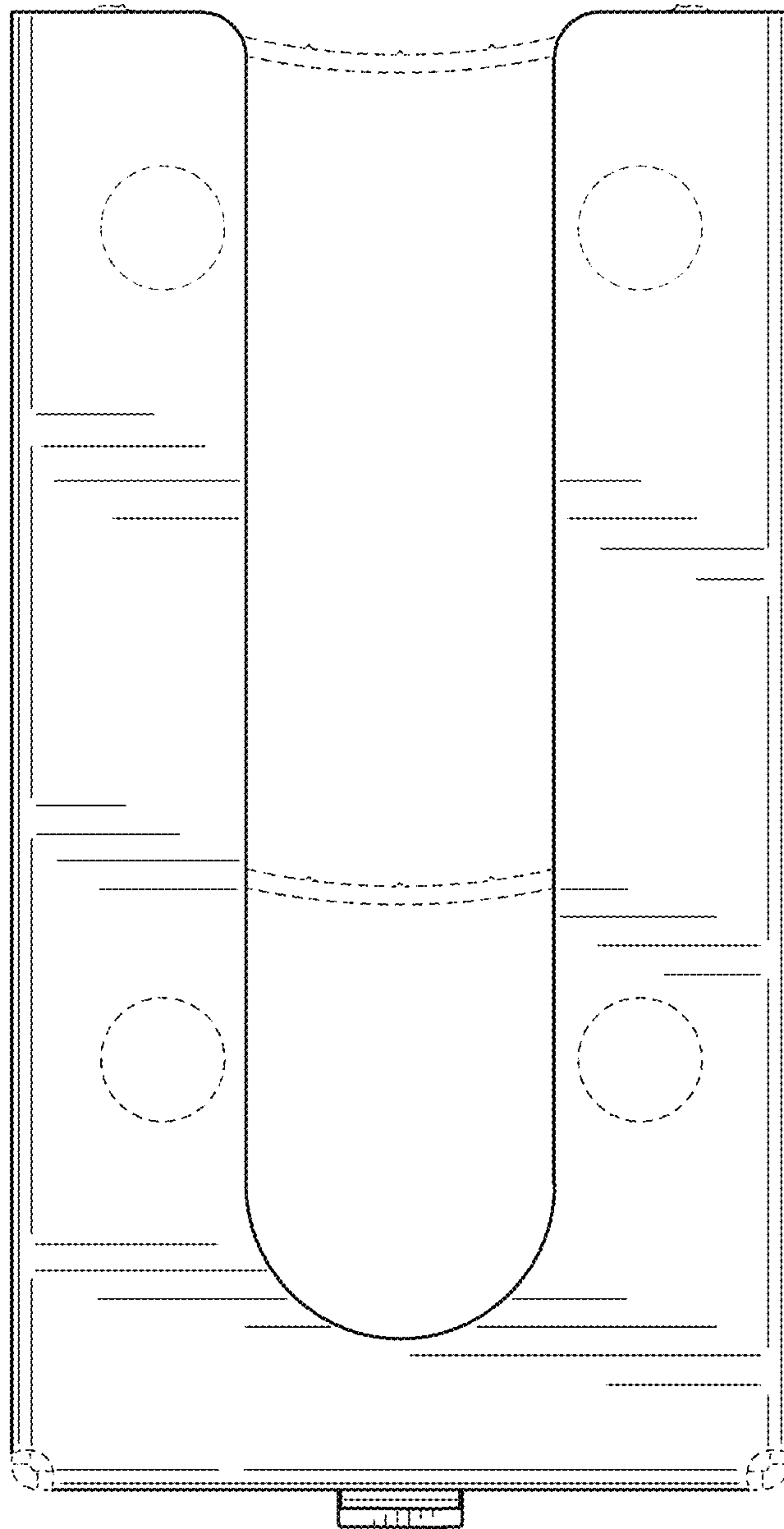
