An ornamental design for a bottle with cap, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a first embodiment of a bottle with cap;

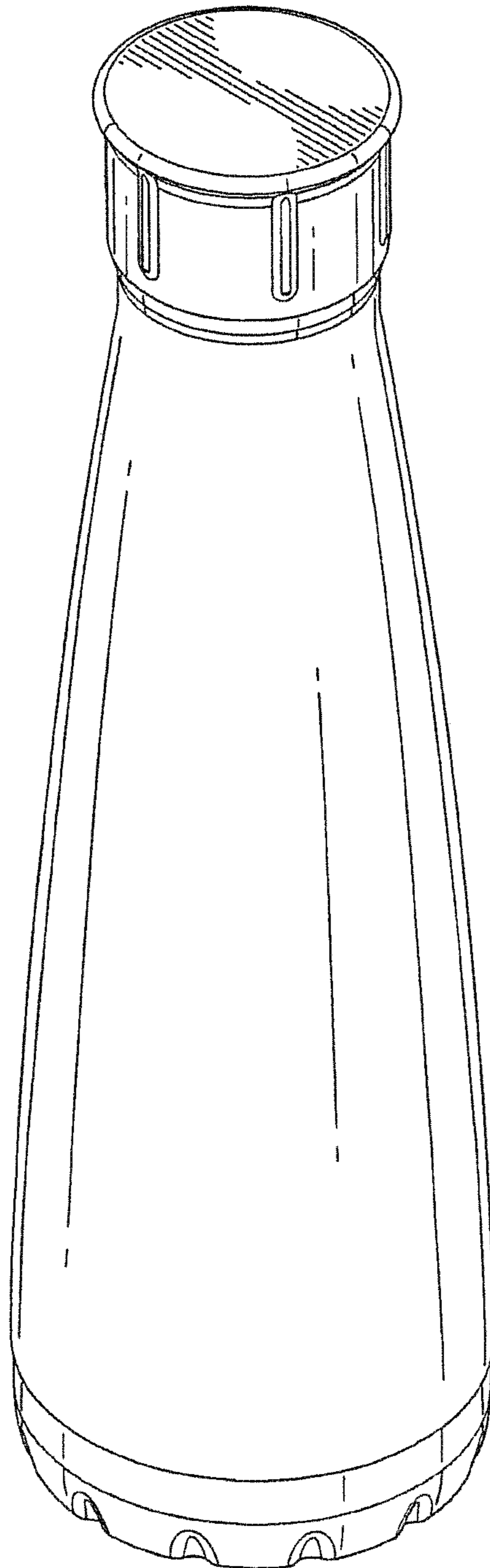

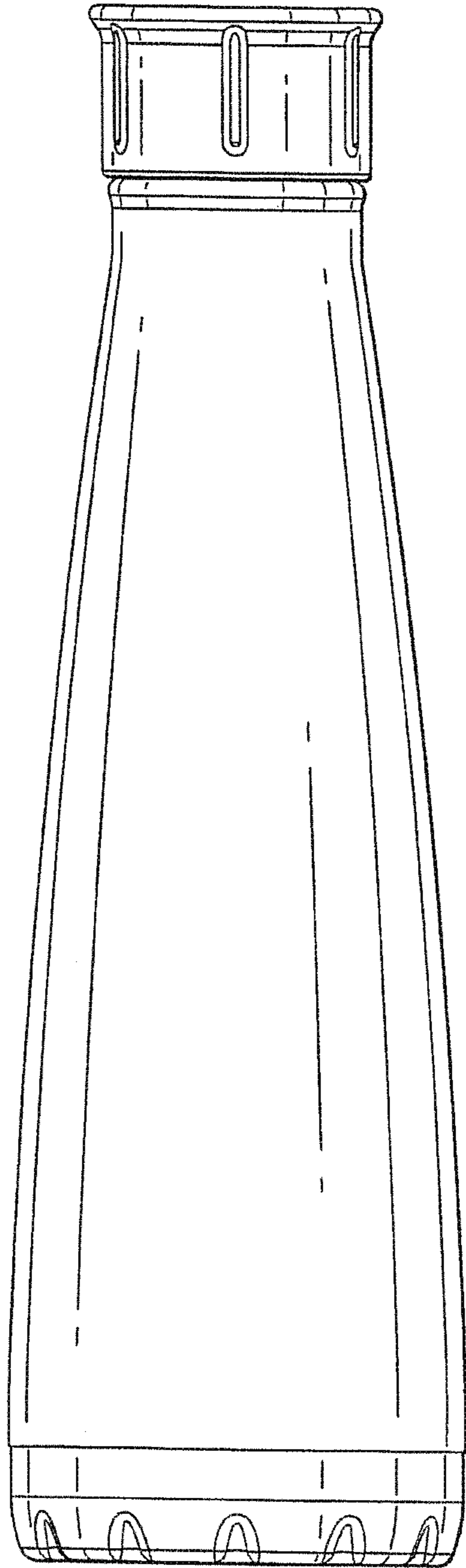

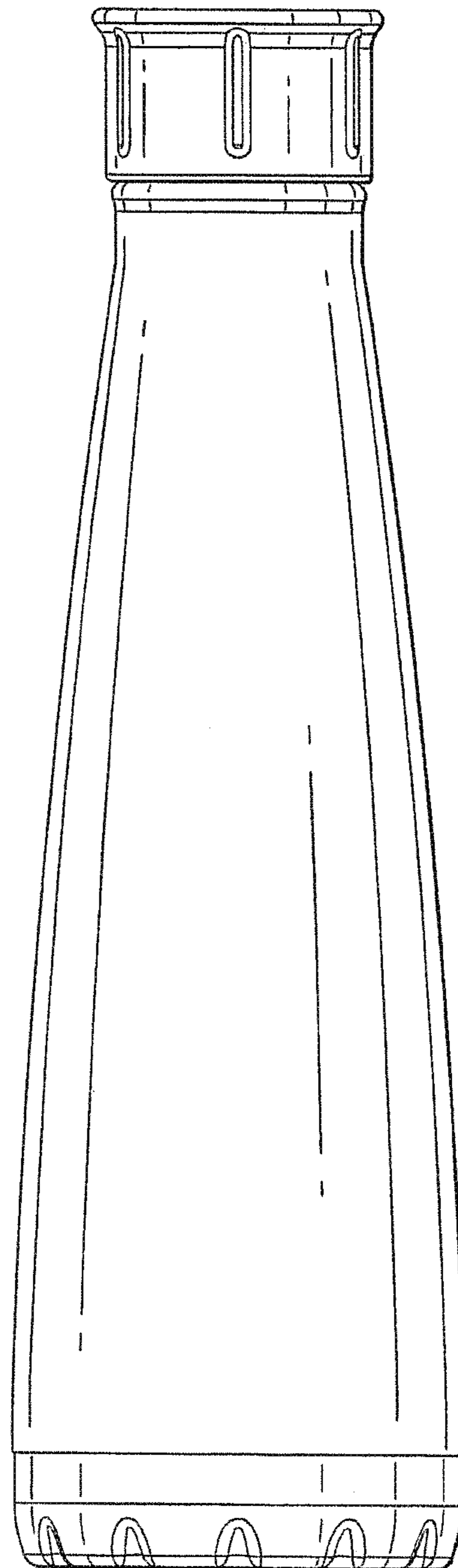

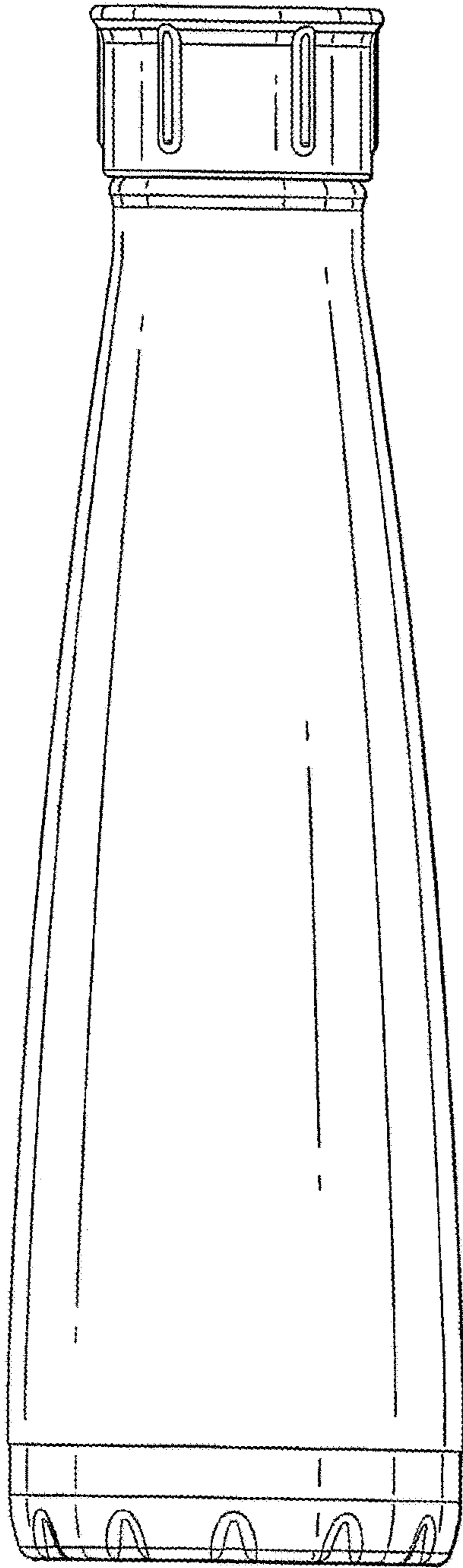

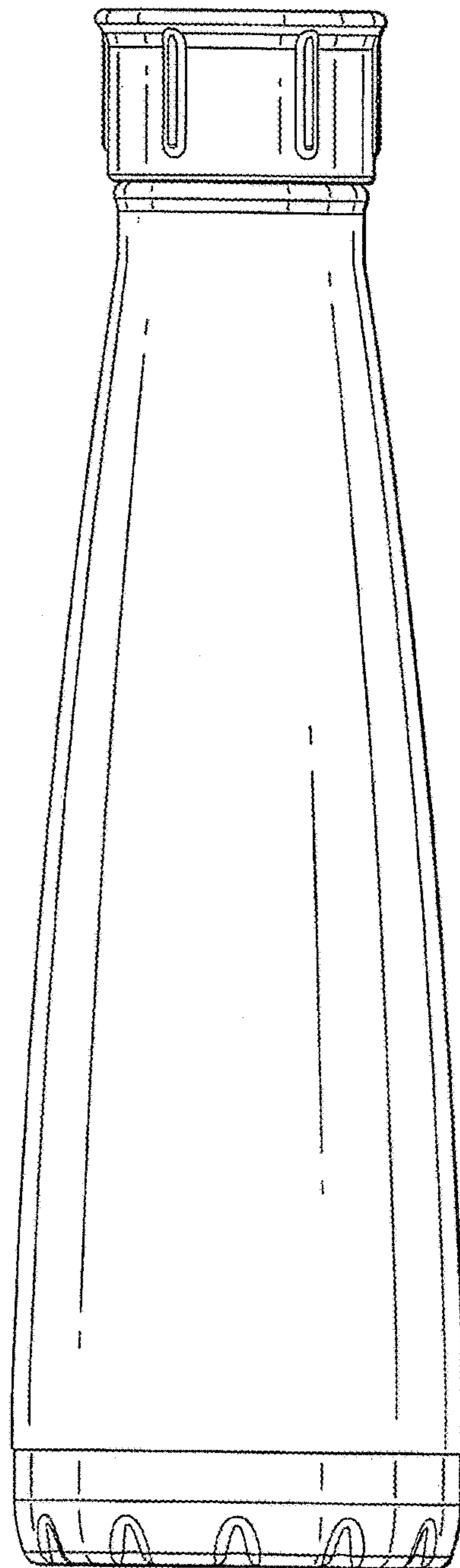

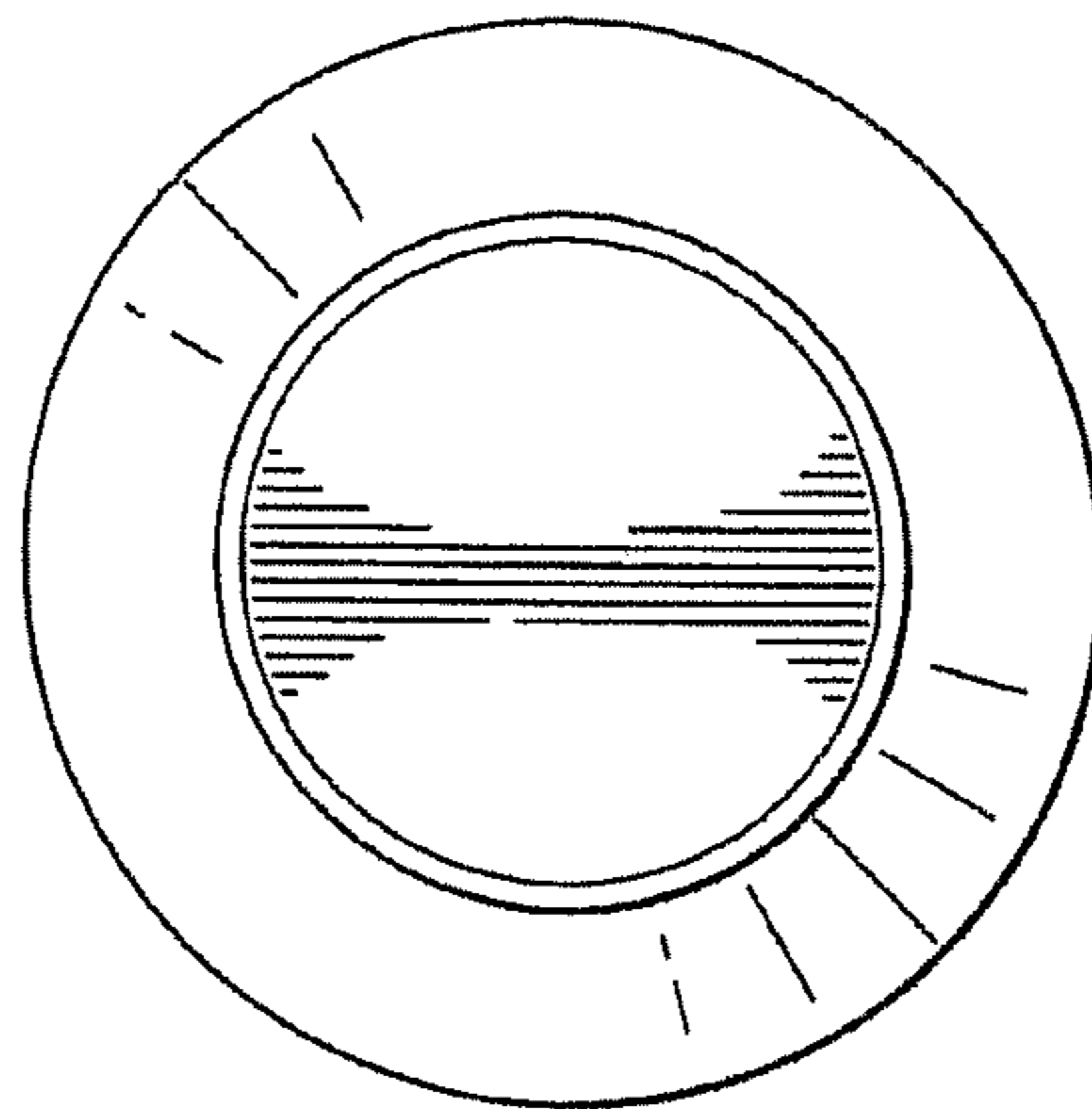

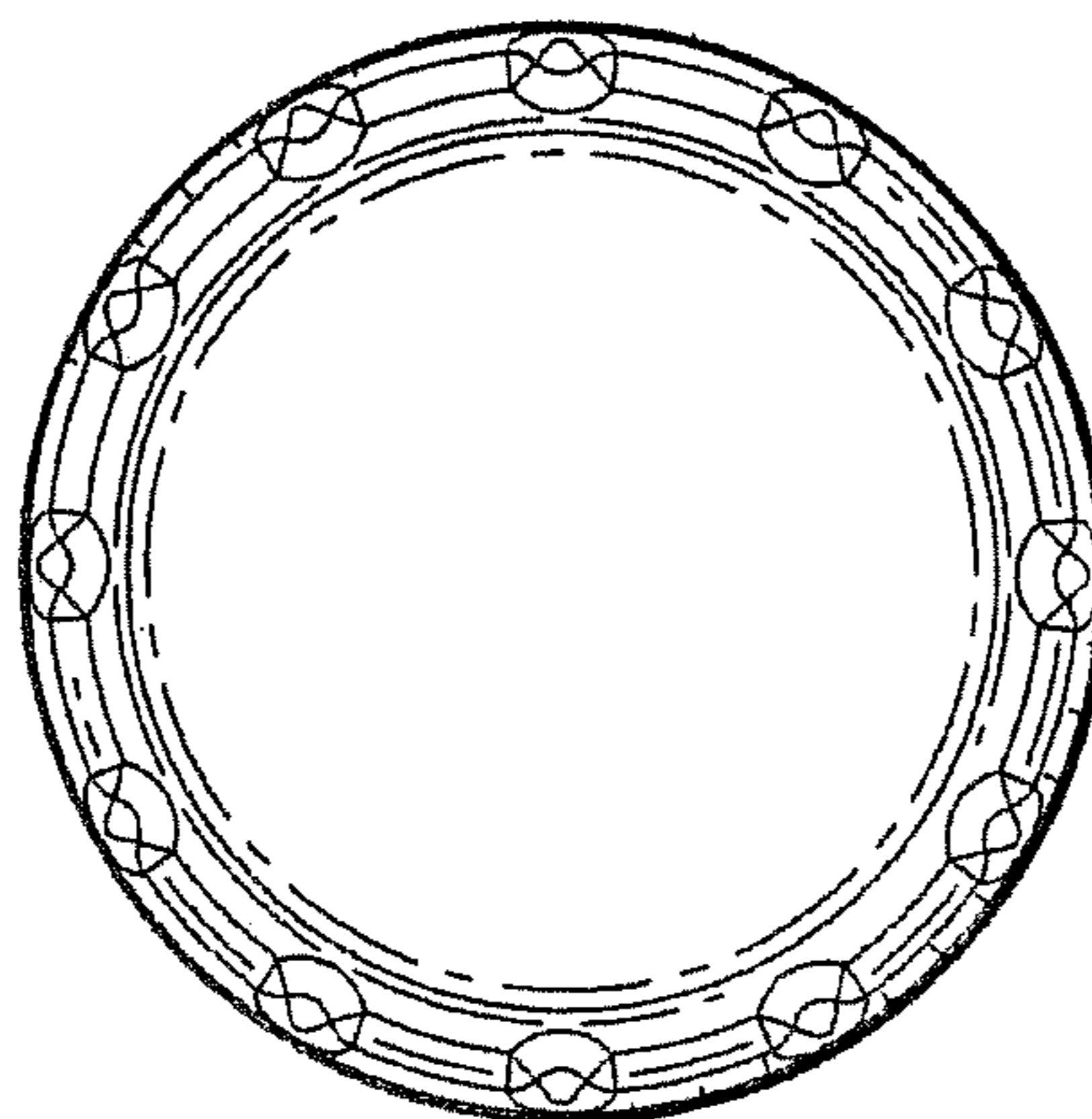

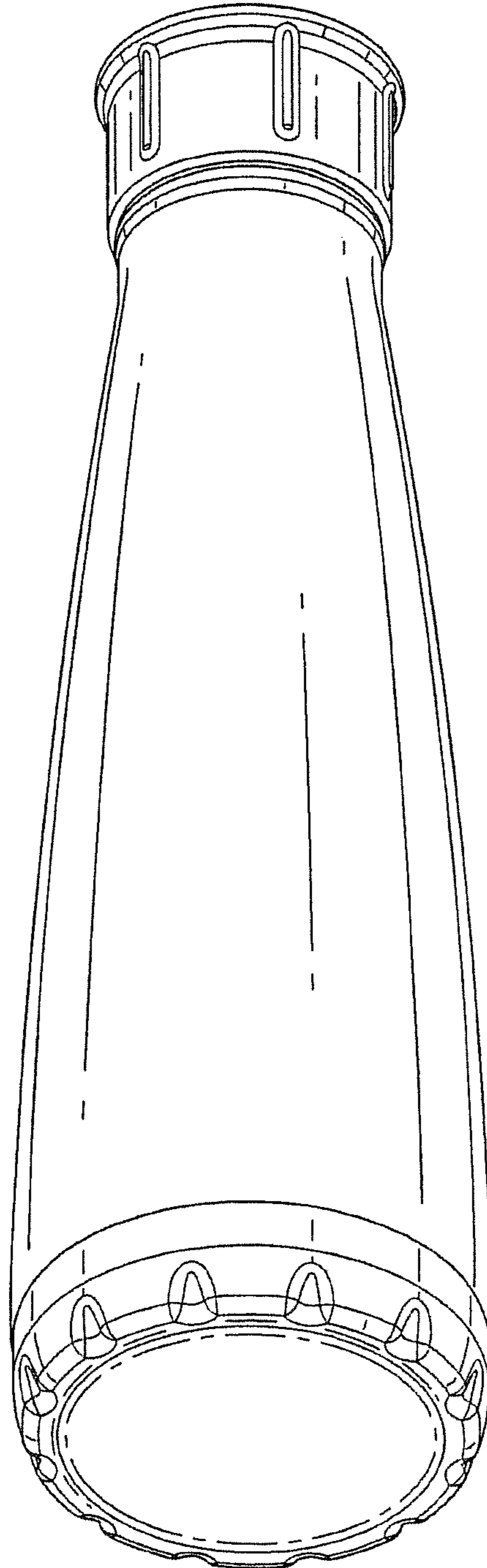

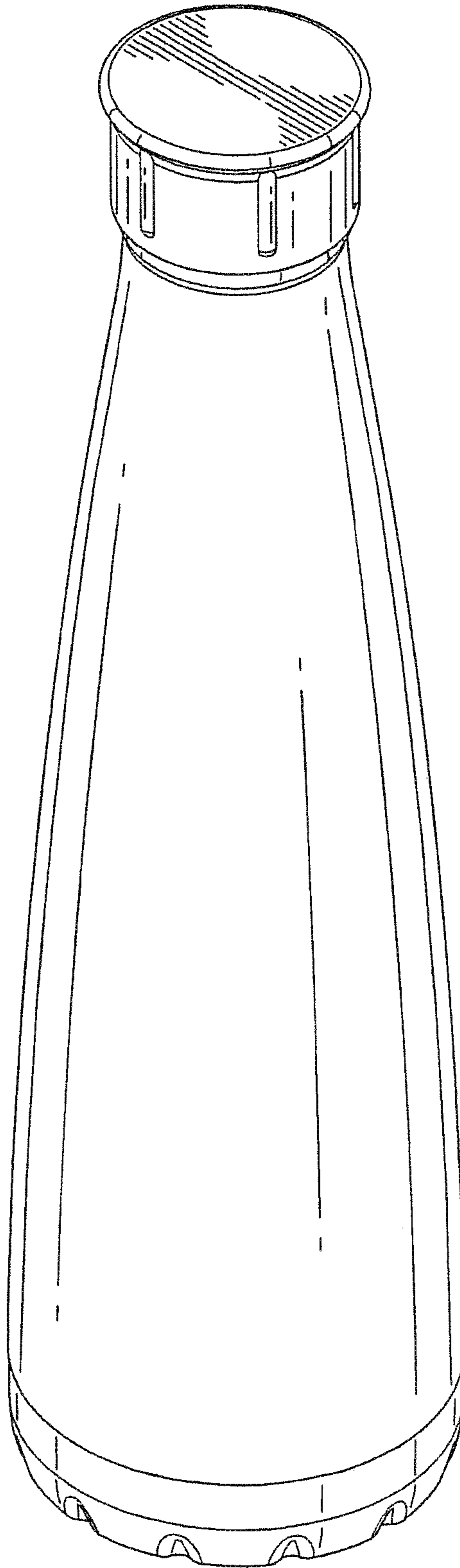

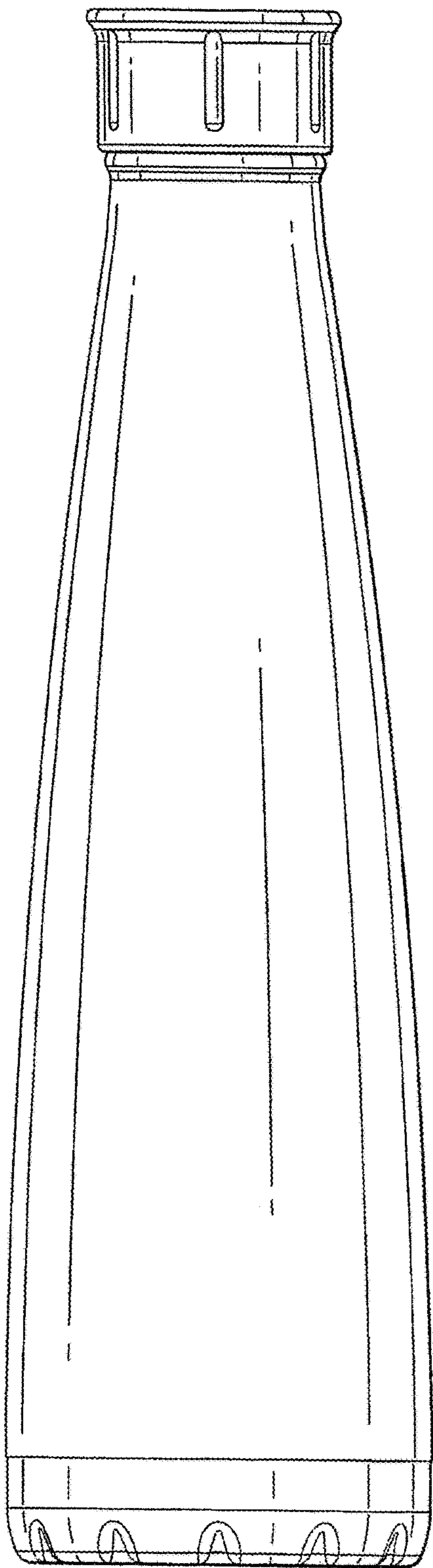

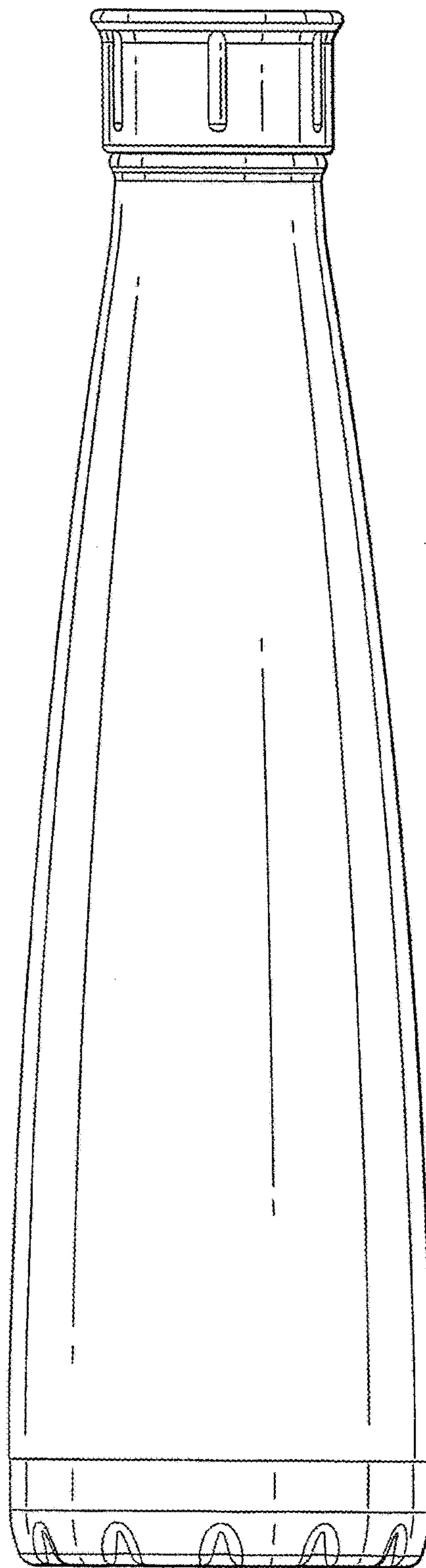

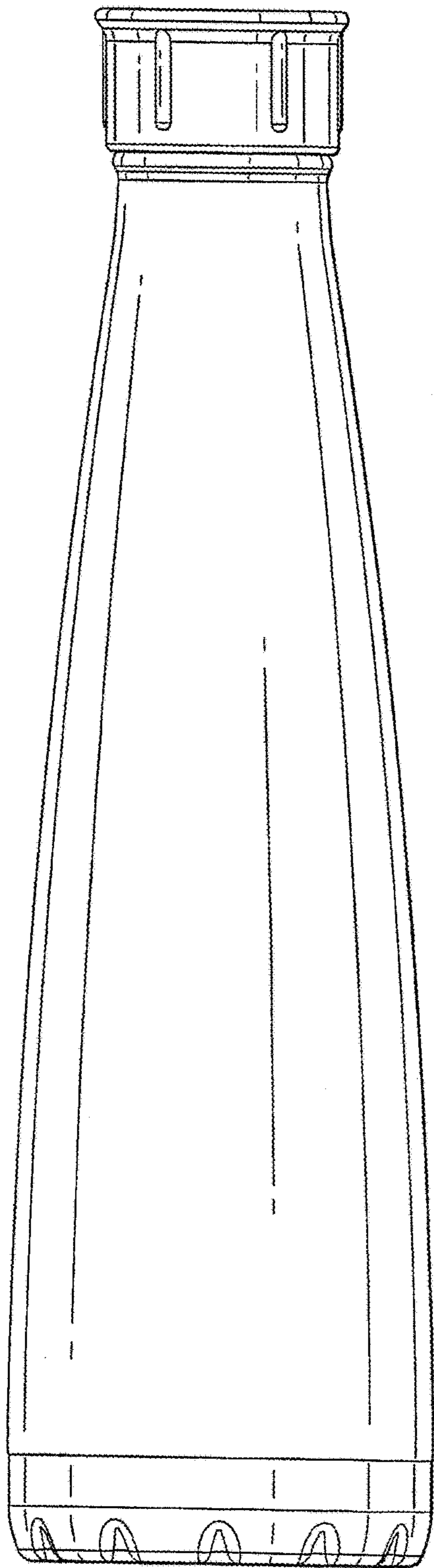

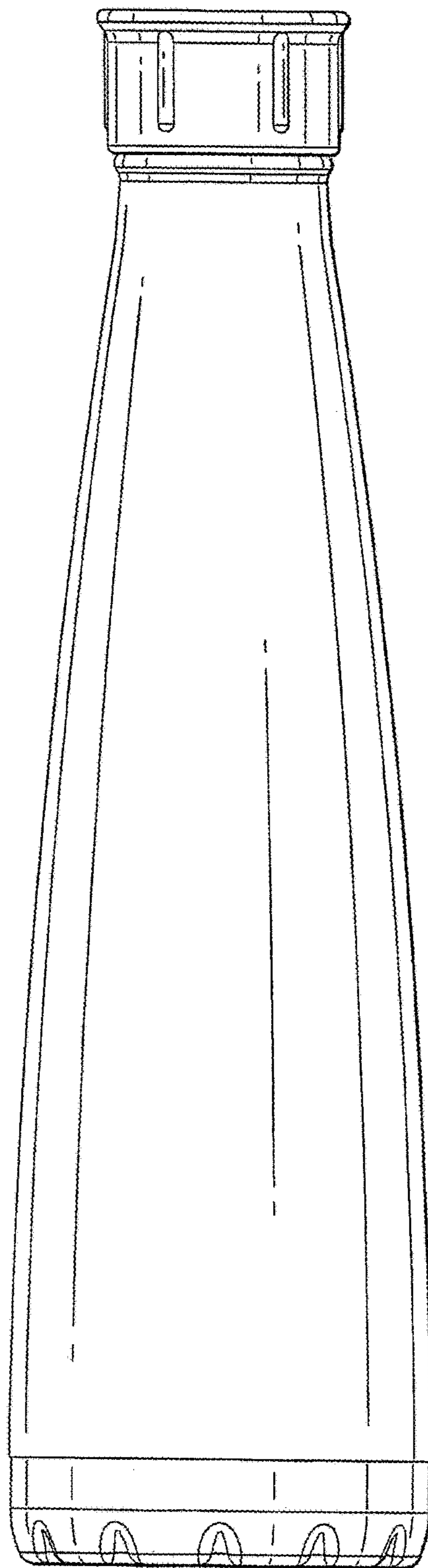

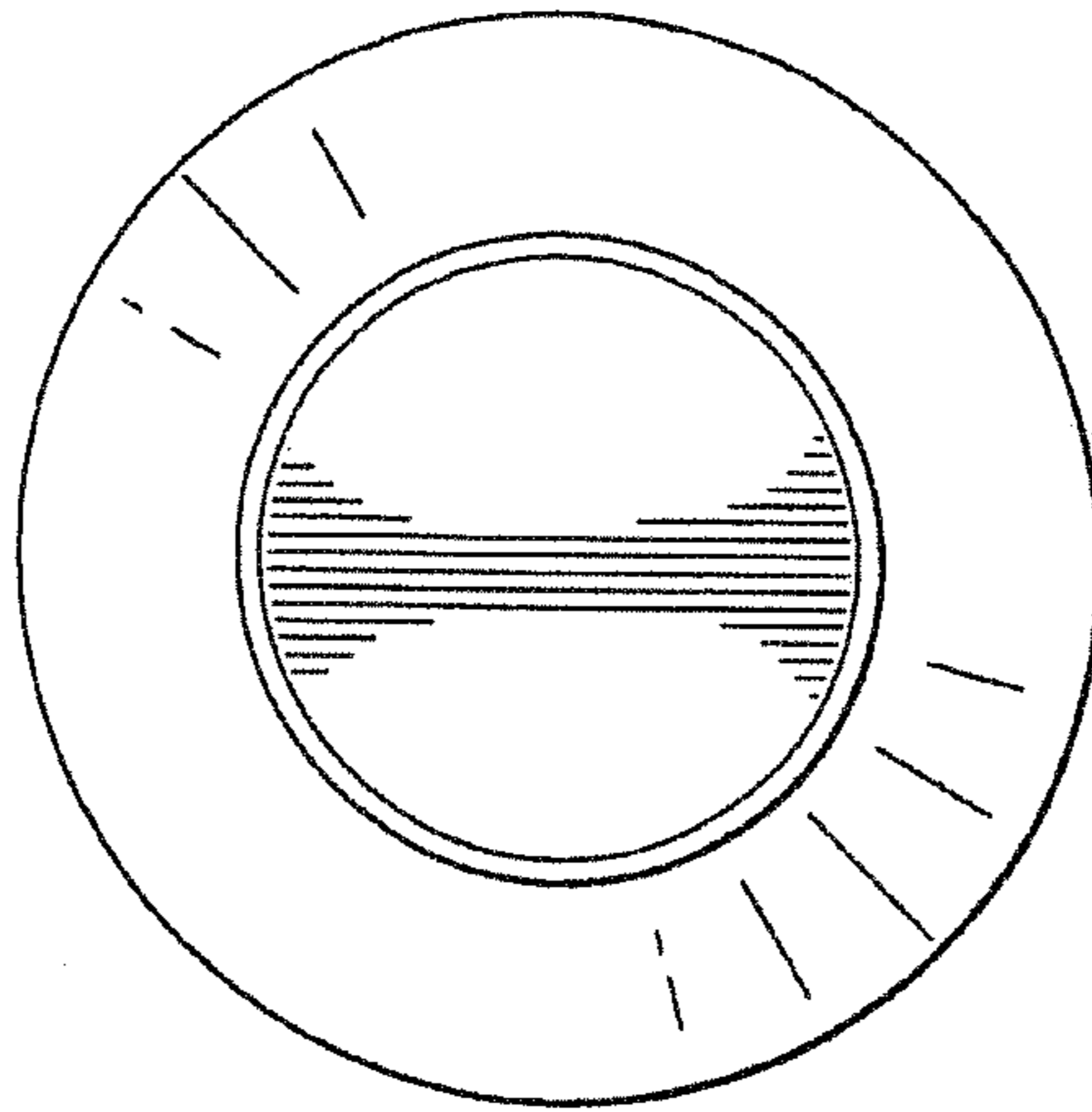

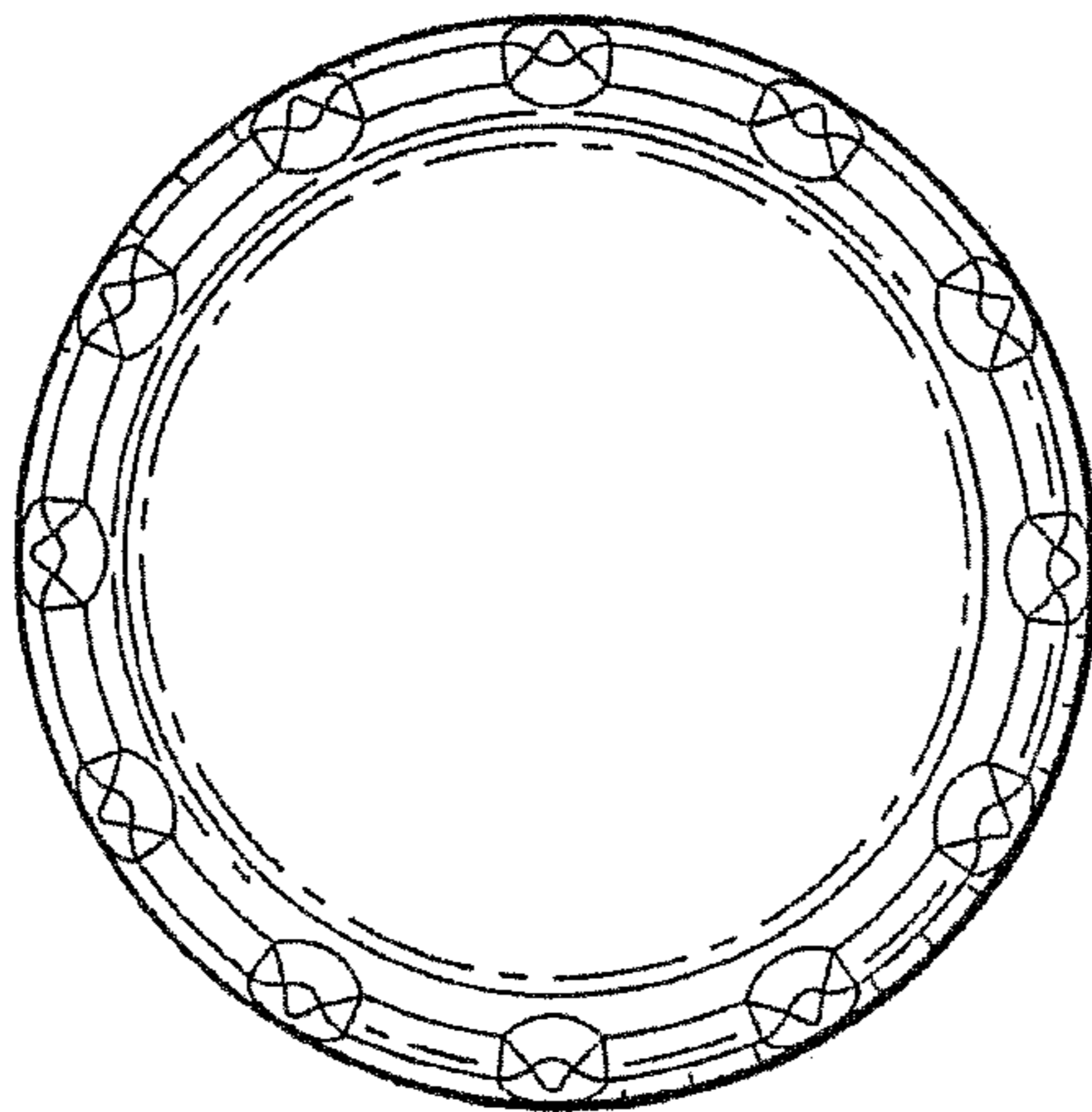

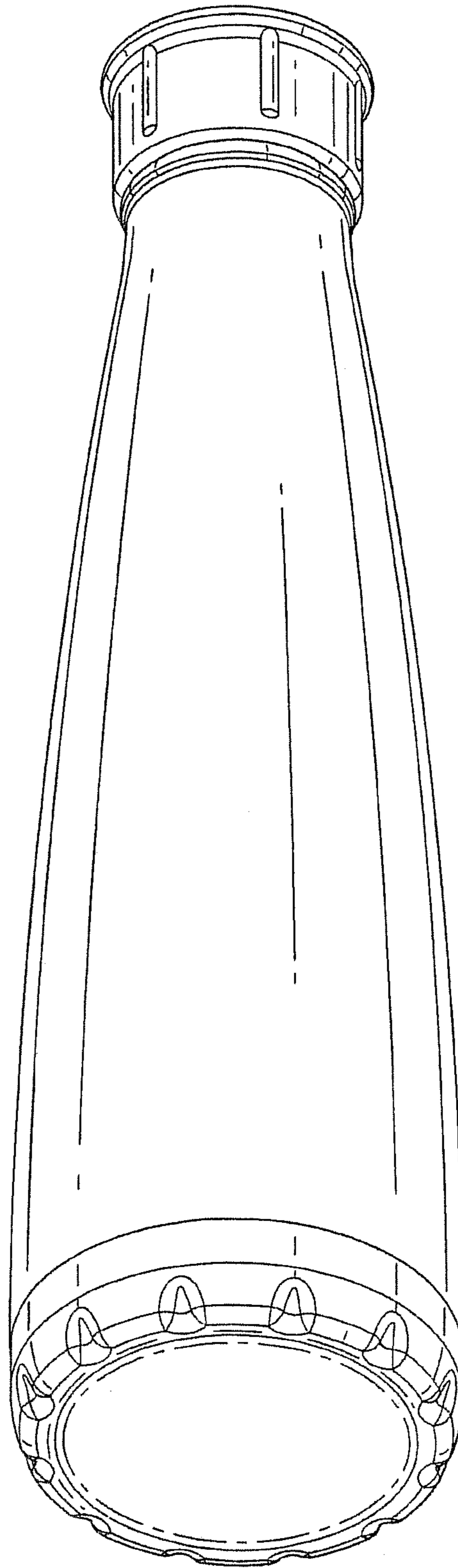
