(57) **CLAIM**

What is claimed is the ornamental design for a furry beverage sleeve, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a furry beverage sleeve. FIG. 2 is a rear perspective view of the furry beverage sleeve of FIG. 1.

FIG. 3 is a front elevation view of the furry beverage sleeve of FIG. 1.

FIG. 4 is a left side view of the furry beverage sleeve of FIG. 1.

FIG. 5 is a right side view of the furry beverage sleeve of FIG. 1.

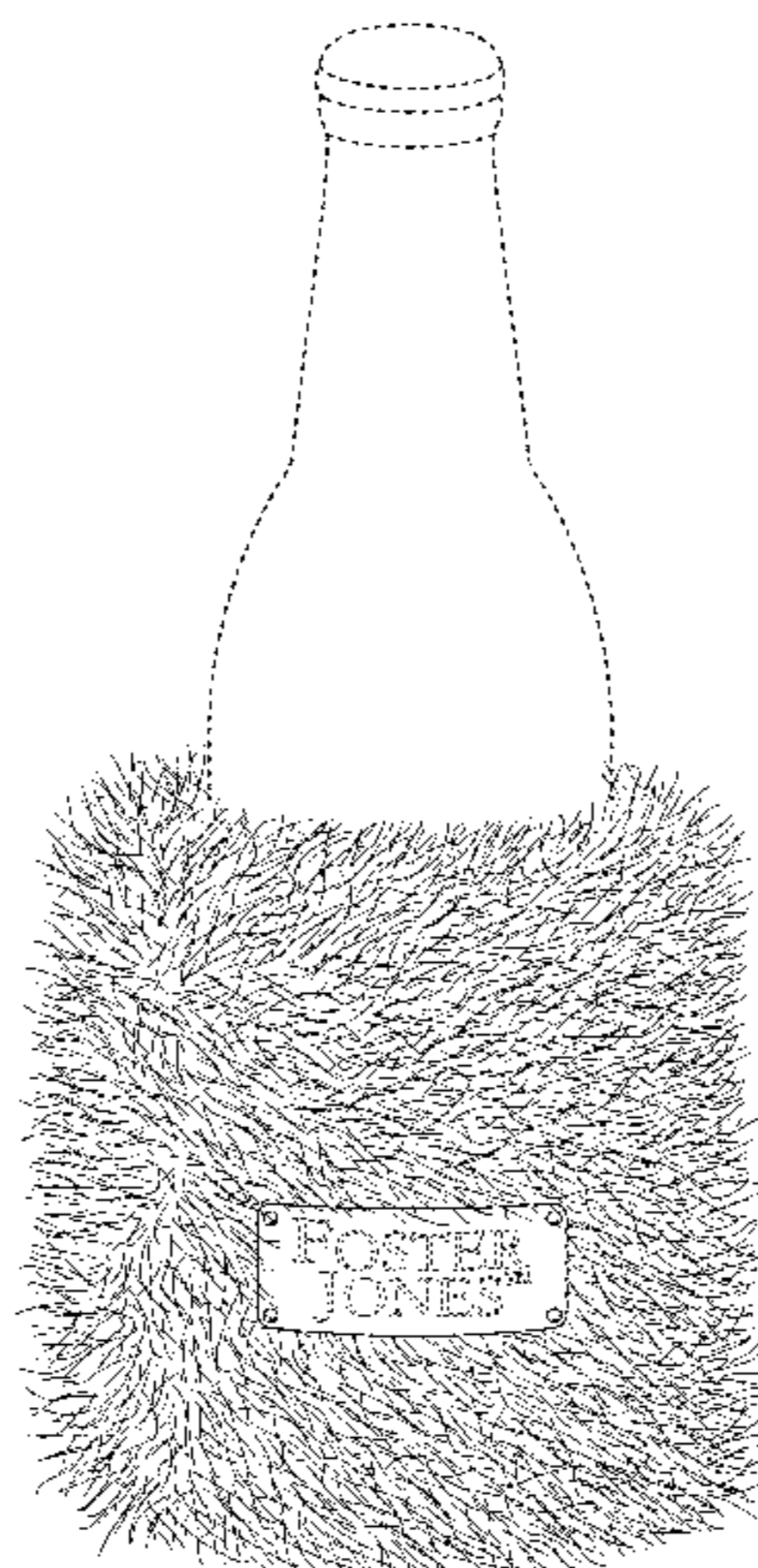
FIG. 6 is a rear elevation view of the furry beverage sleeve of FIG. 1.

FIG. 7 is a top view of the furry beverage sleeve of FIG. 1; and,

FIG. 8 is a bottom view of the furry beverage sleeve of FIG. 1, with the bottom surface of the sleeve being flush with the bottom of the holder, as shown in FIG. 3.

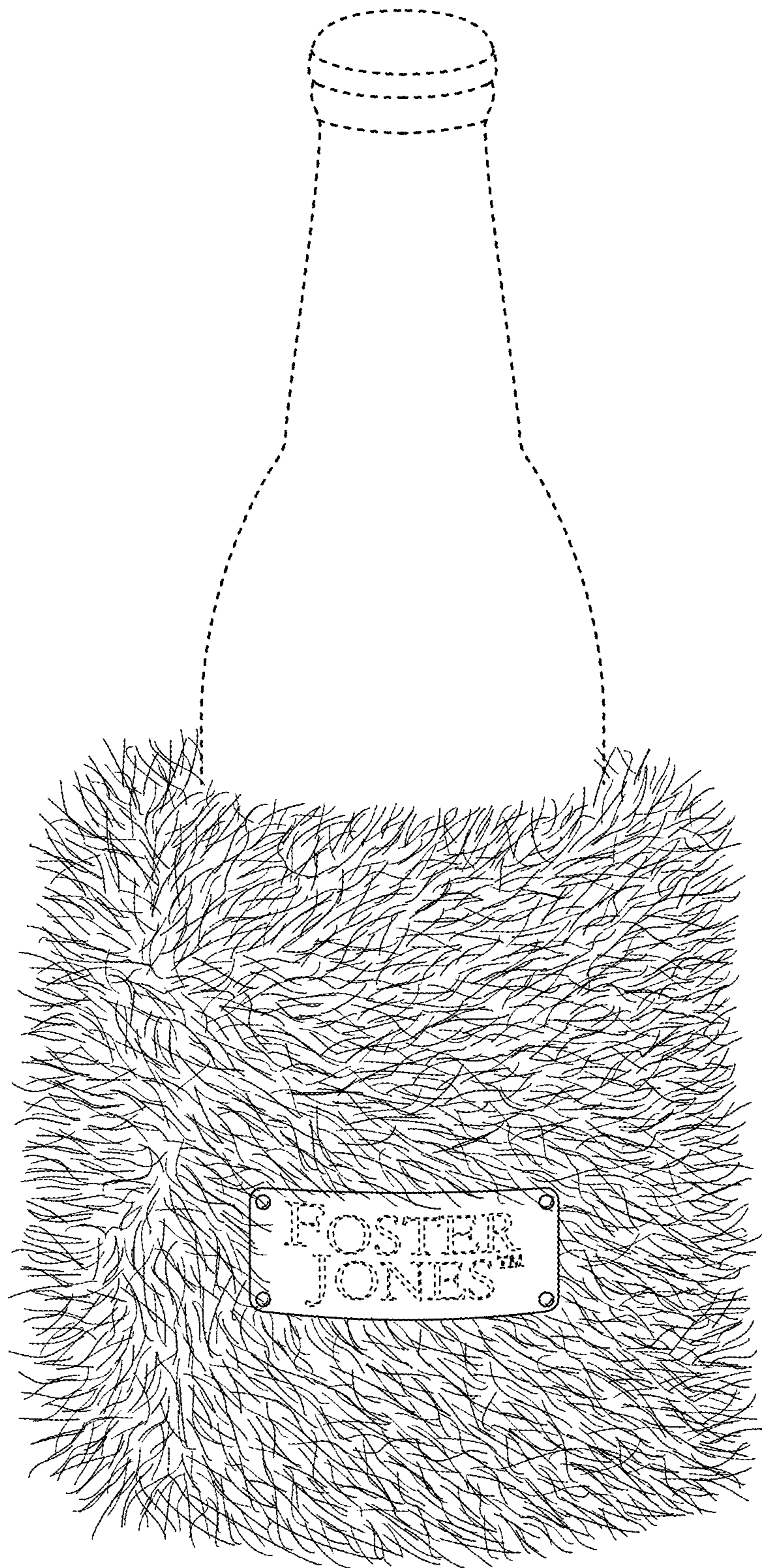

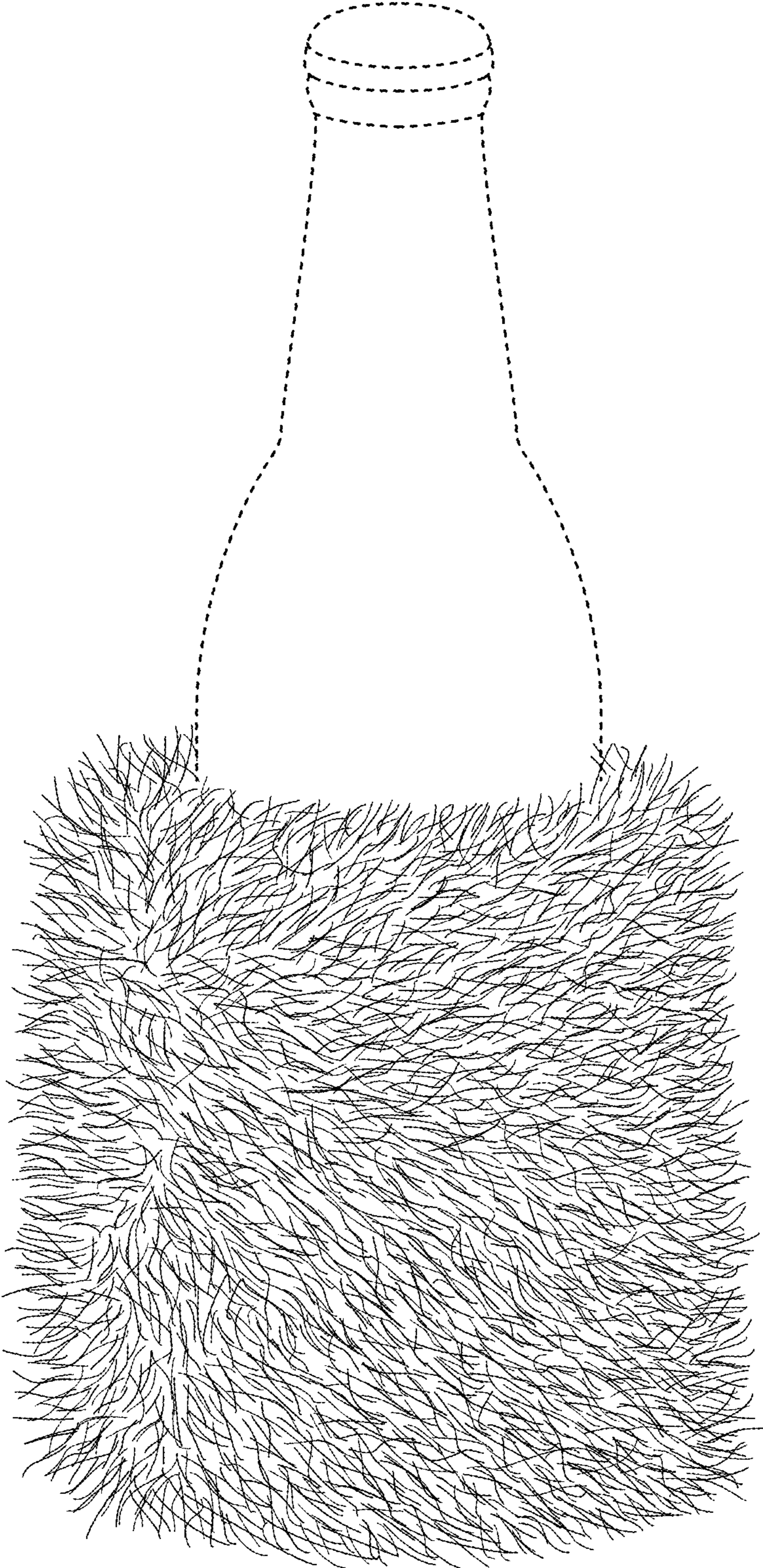

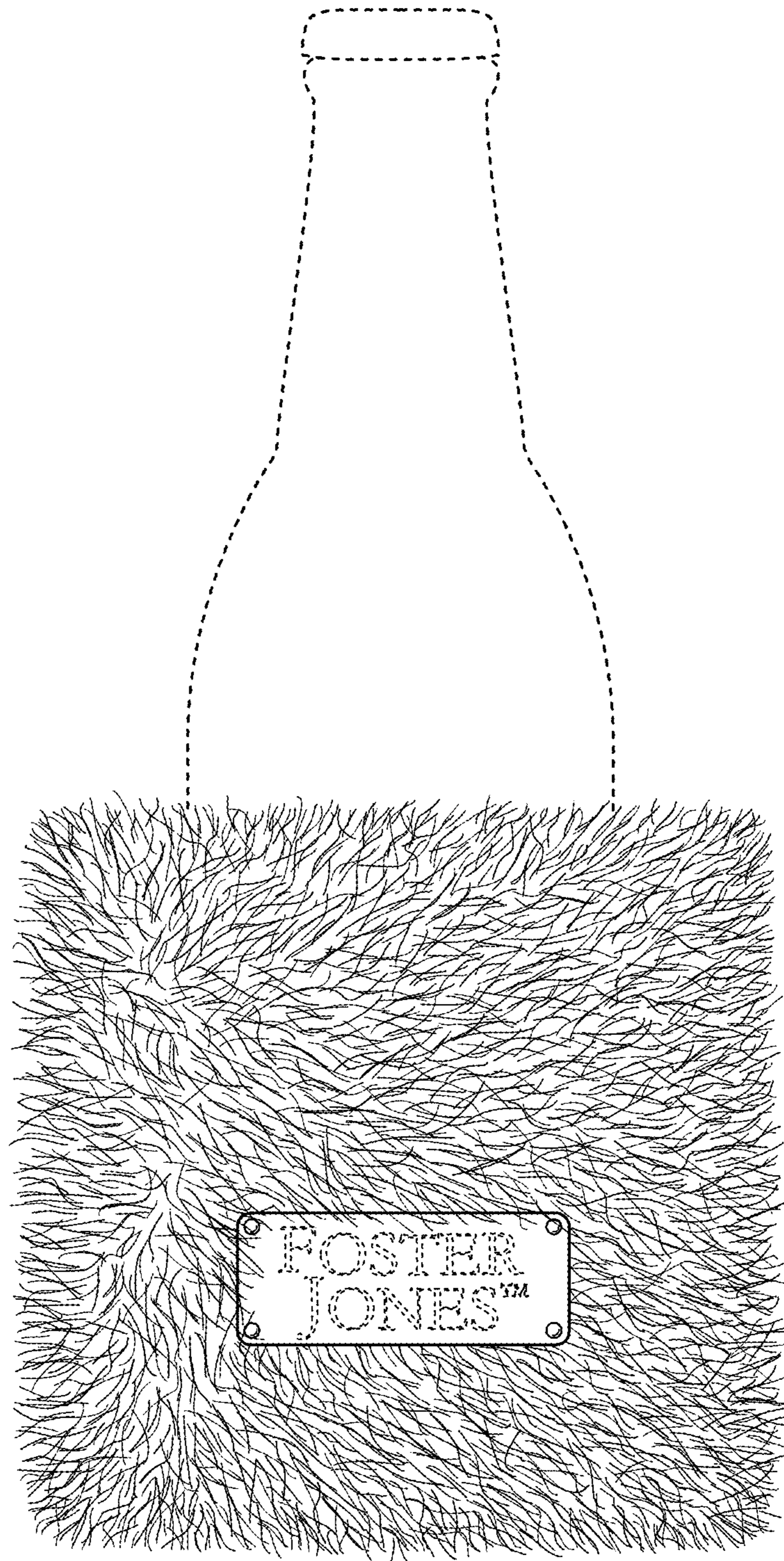

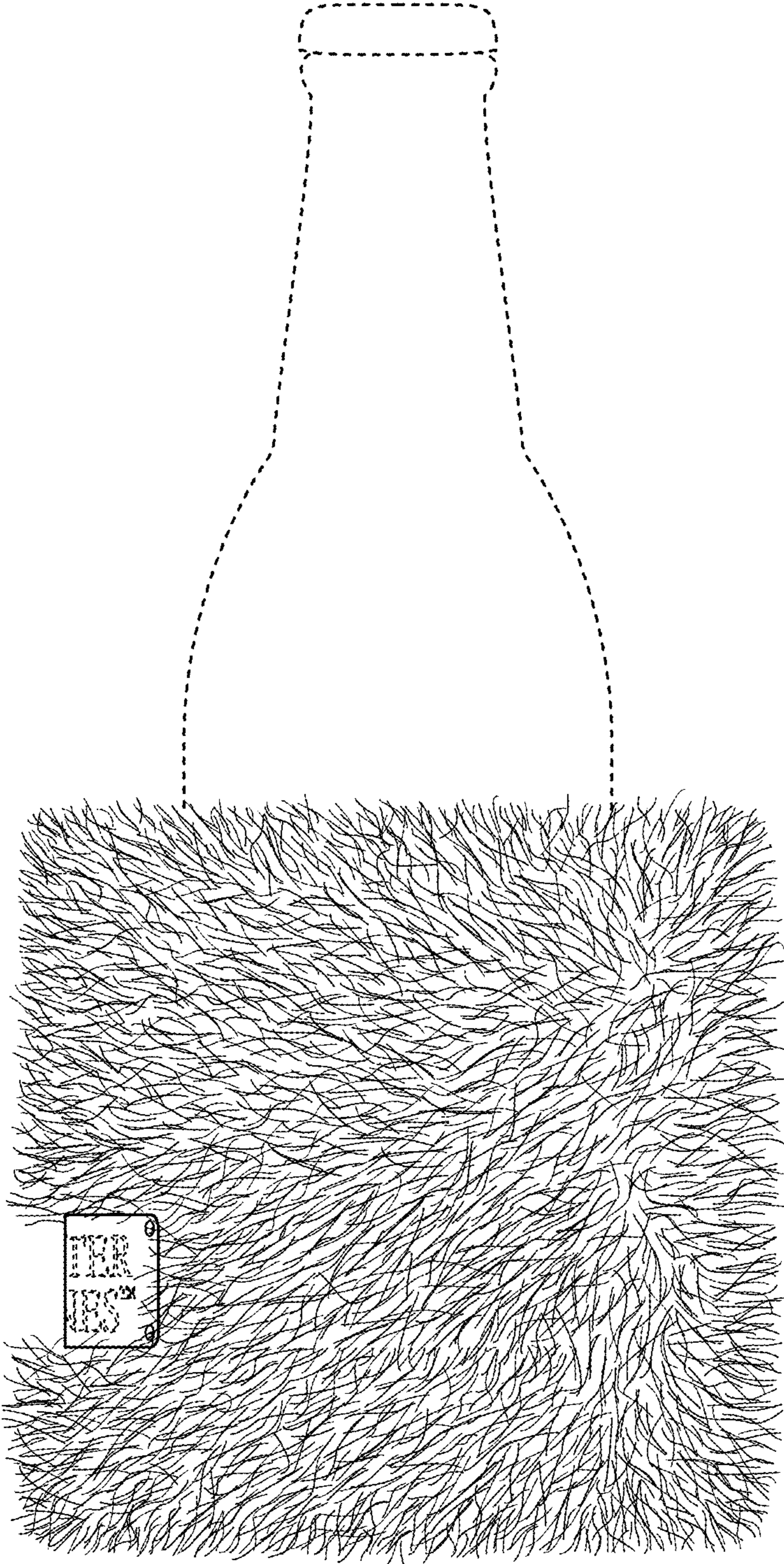

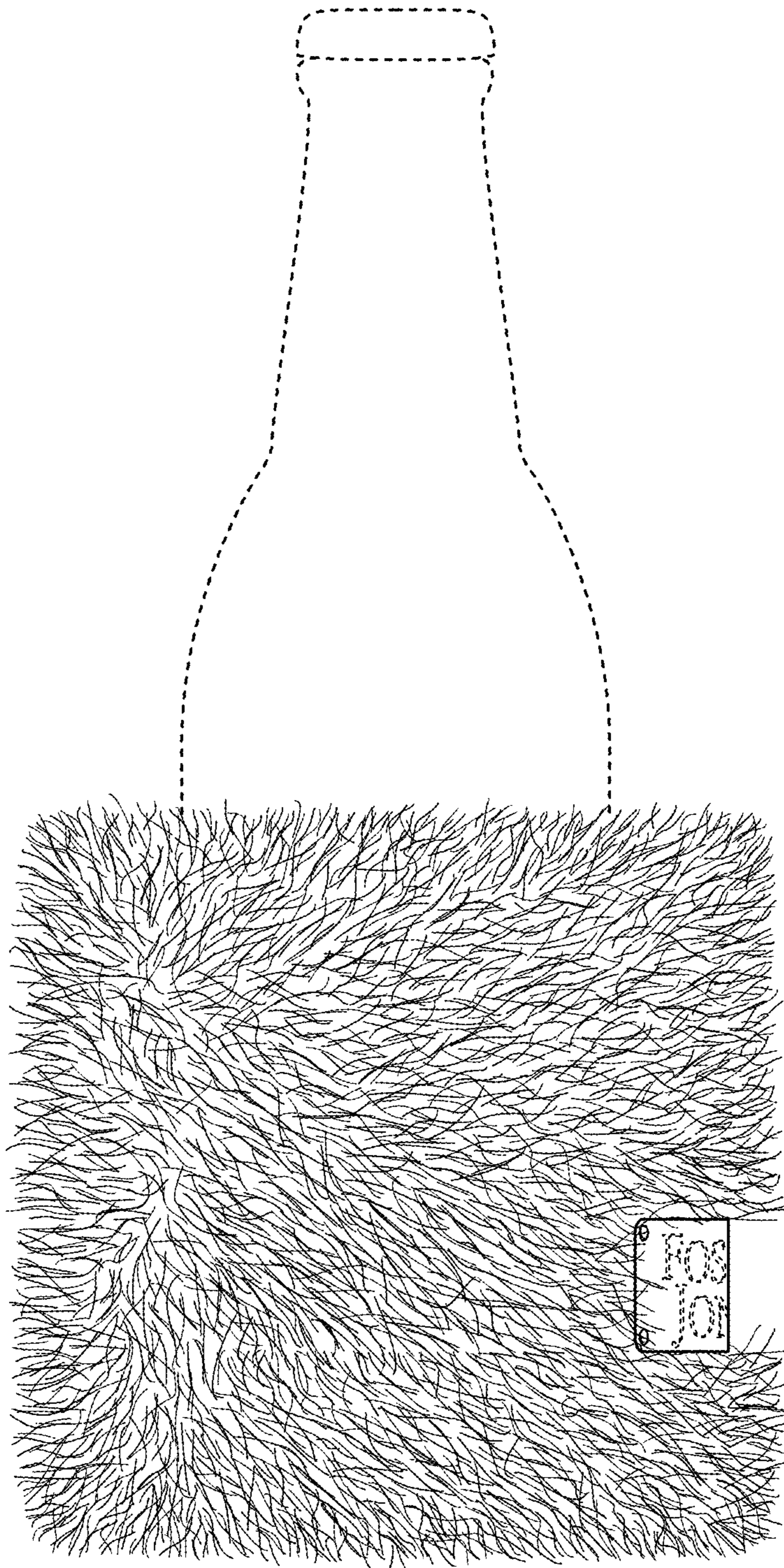

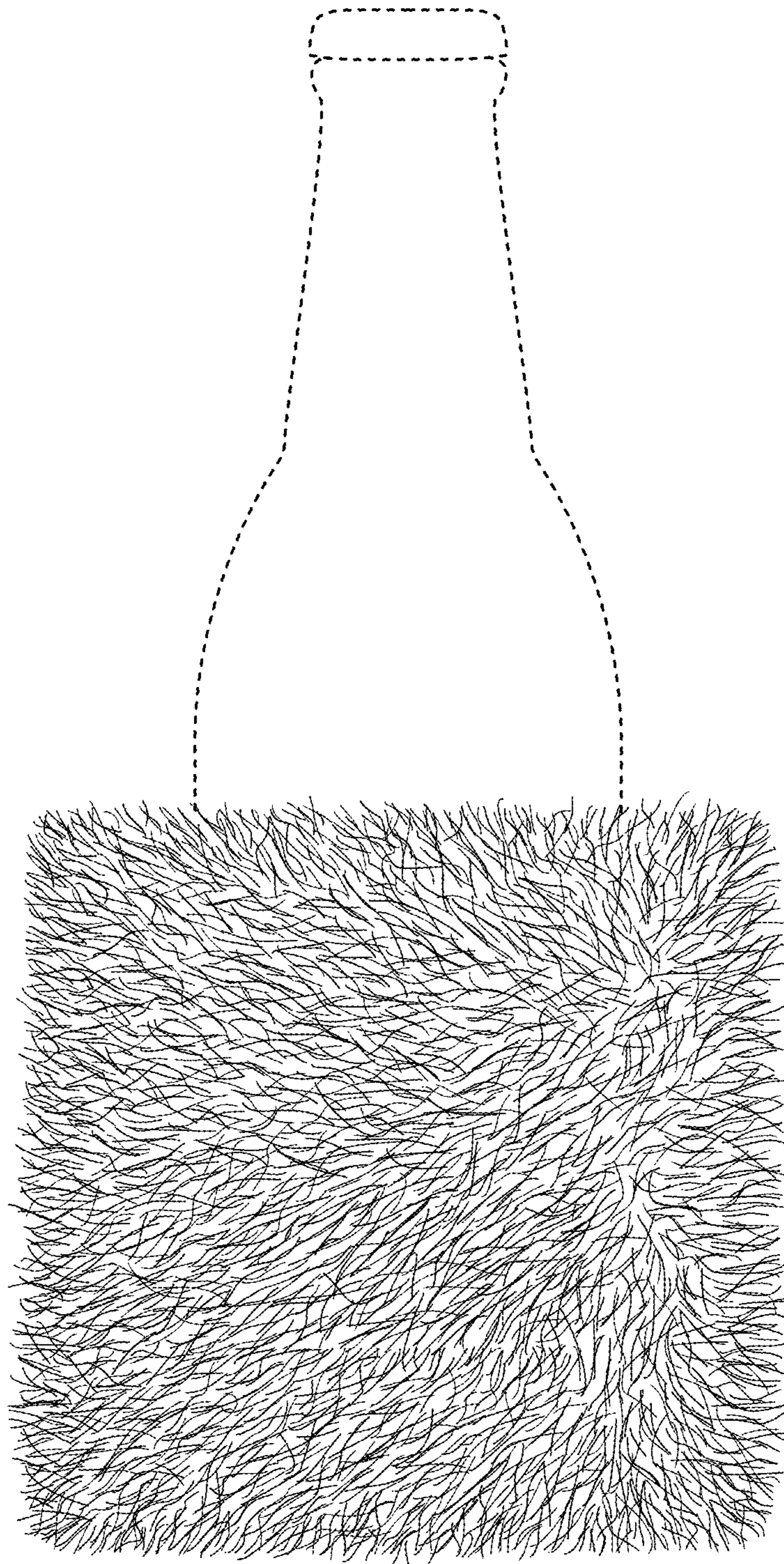

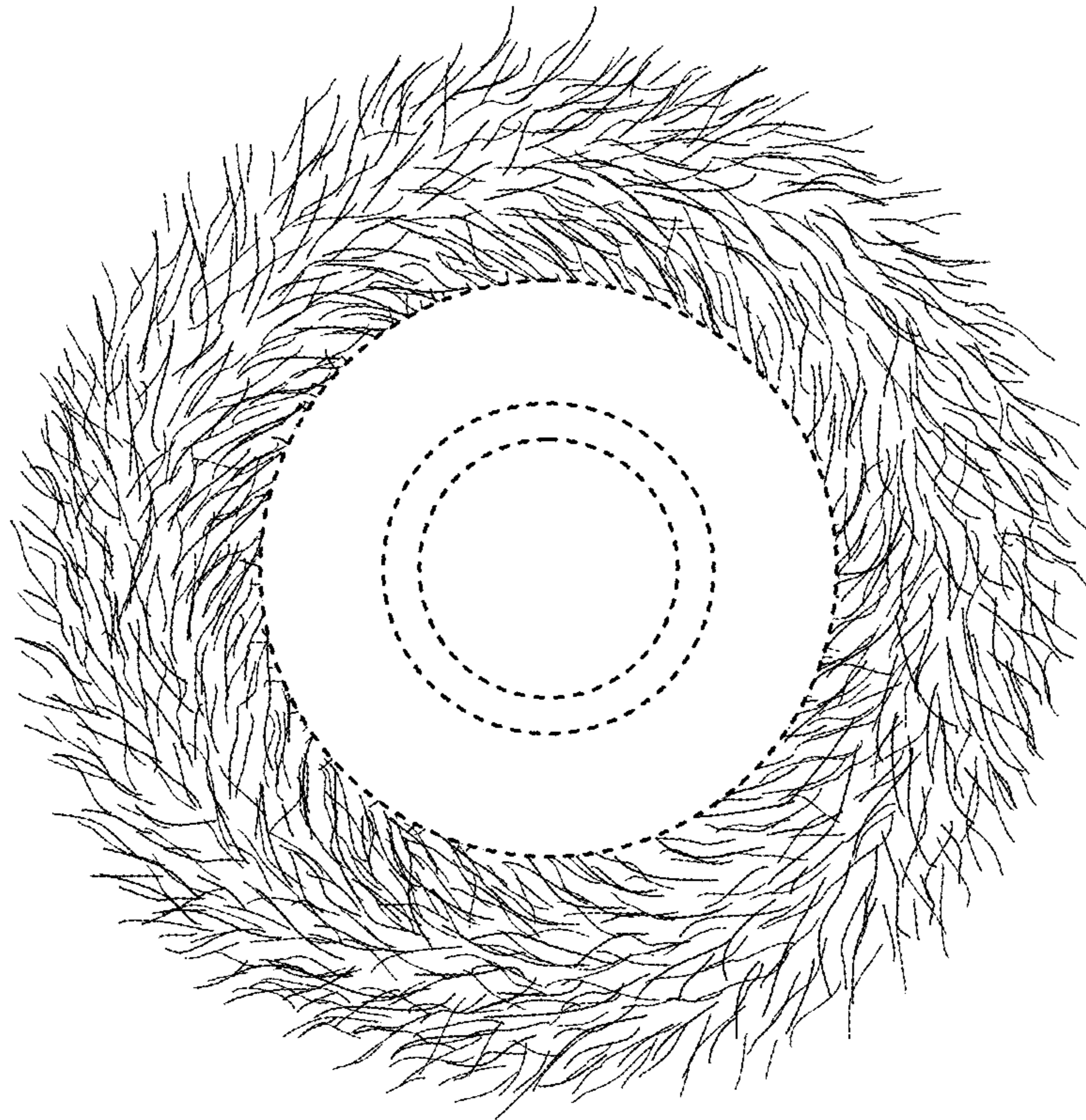

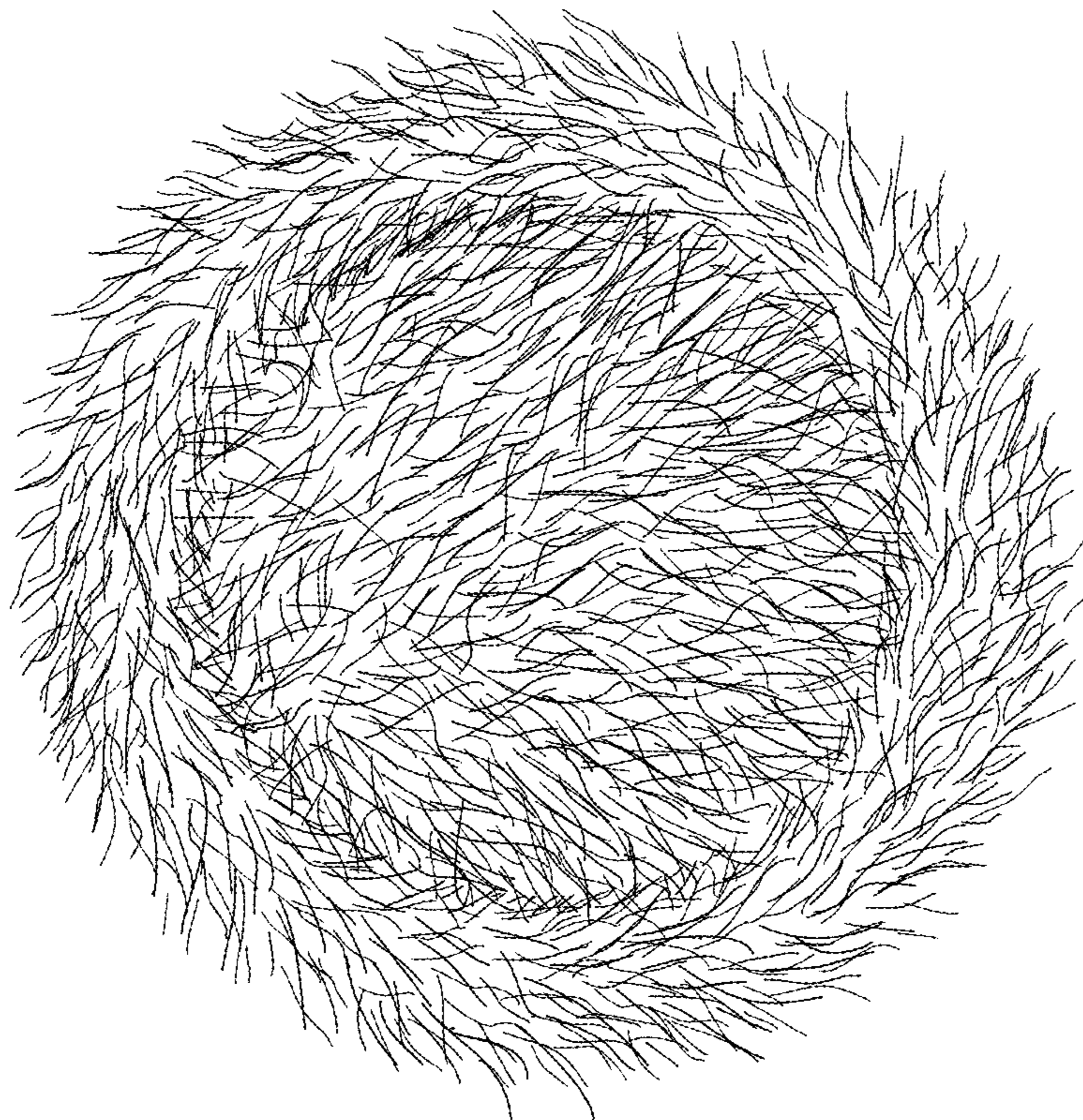
