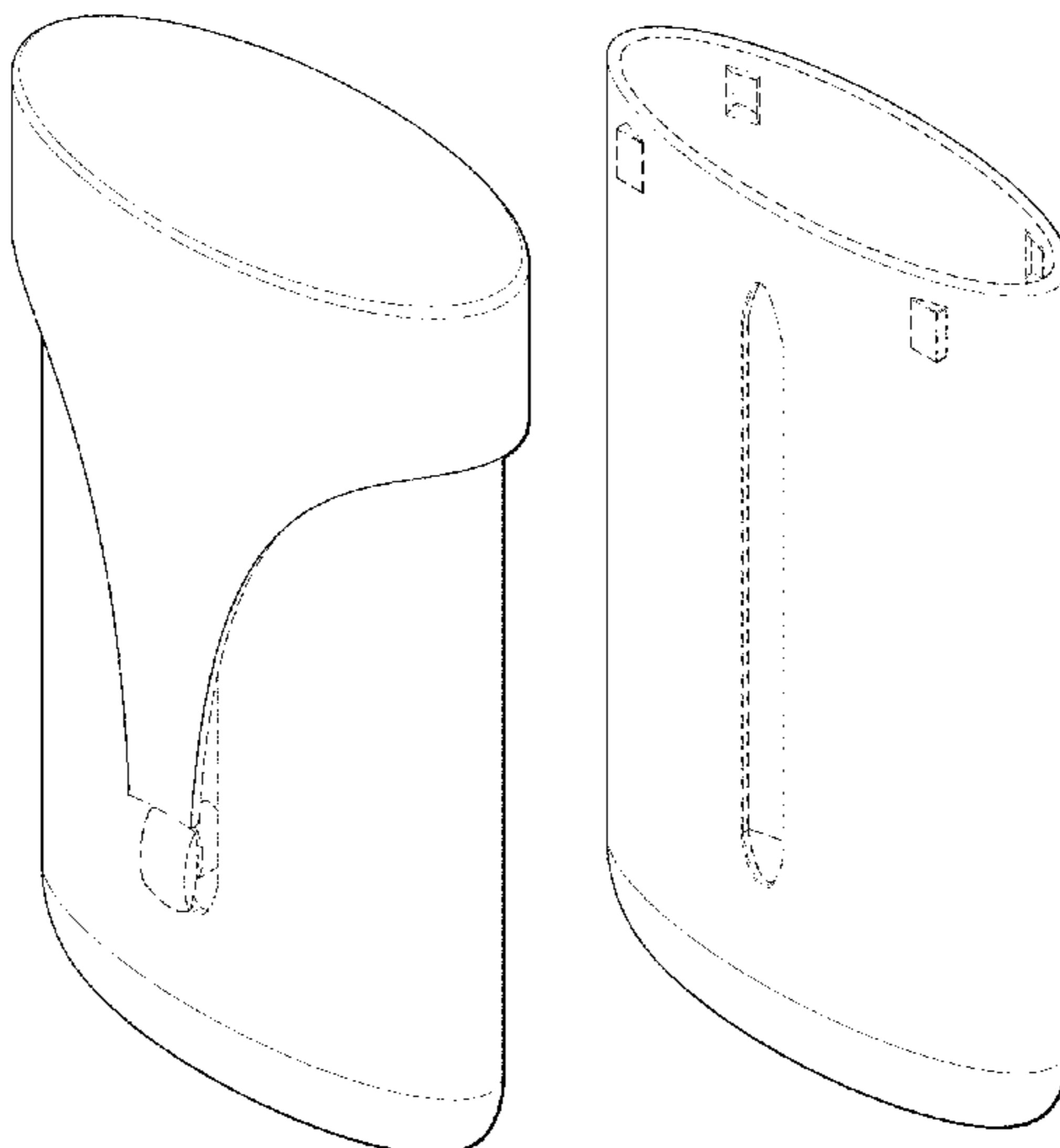
(57) **CLAIM**

The ornamental design for a deodorant dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a top, front perspective view of embodiment one, of a deodorant dispenser, showing my new design; FIG. 2 is a bottom, rear perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a right side elevation view thereof, with the left side elevation view being a mirror image thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a top view thereof; FIG. 7 is a bottom view thereof; FIG. 8 is a top, front perspective of embodiment two, of a deodorant dispenser, shown without the cap for ease of illustration, showing my new design; FIG. 9 is a bottom, rear perspective view thereof; FIG. 10 is a front elevation view thereof; FIG. 11 is a right side elevation view thereof, with the left side elevation view being a mirror image thereof; FIG. 12 is a rear elevation view thereof; FIG. 13 is a top view thereof; FIG. 14 is a bottom view thereof; FIG. 15 is a top, front perspective view of embodiment three, of a deodorant dispenser, shown without the body for ease of illustration, showing my new design; FIG. 16 is a bottom, rear perspective view thereof; FIG. 17 is a front elevation view thereof; FIG. 18 is a right side elevation view thereof, with the left side elevation view being a mirror image thereof; FIG. 19 is a rear elevation view thereof; FIG. 20 is a top view thereof; and, FIG. 21 is a bottom view thereof. The broken dashed lines in the various Figures illustrate the portions of the design that form no part of the claimed design. The broken dashed-dotted lines shown in the various Figures illustrate the boundaries of the claimed surfaces of the claimed design.

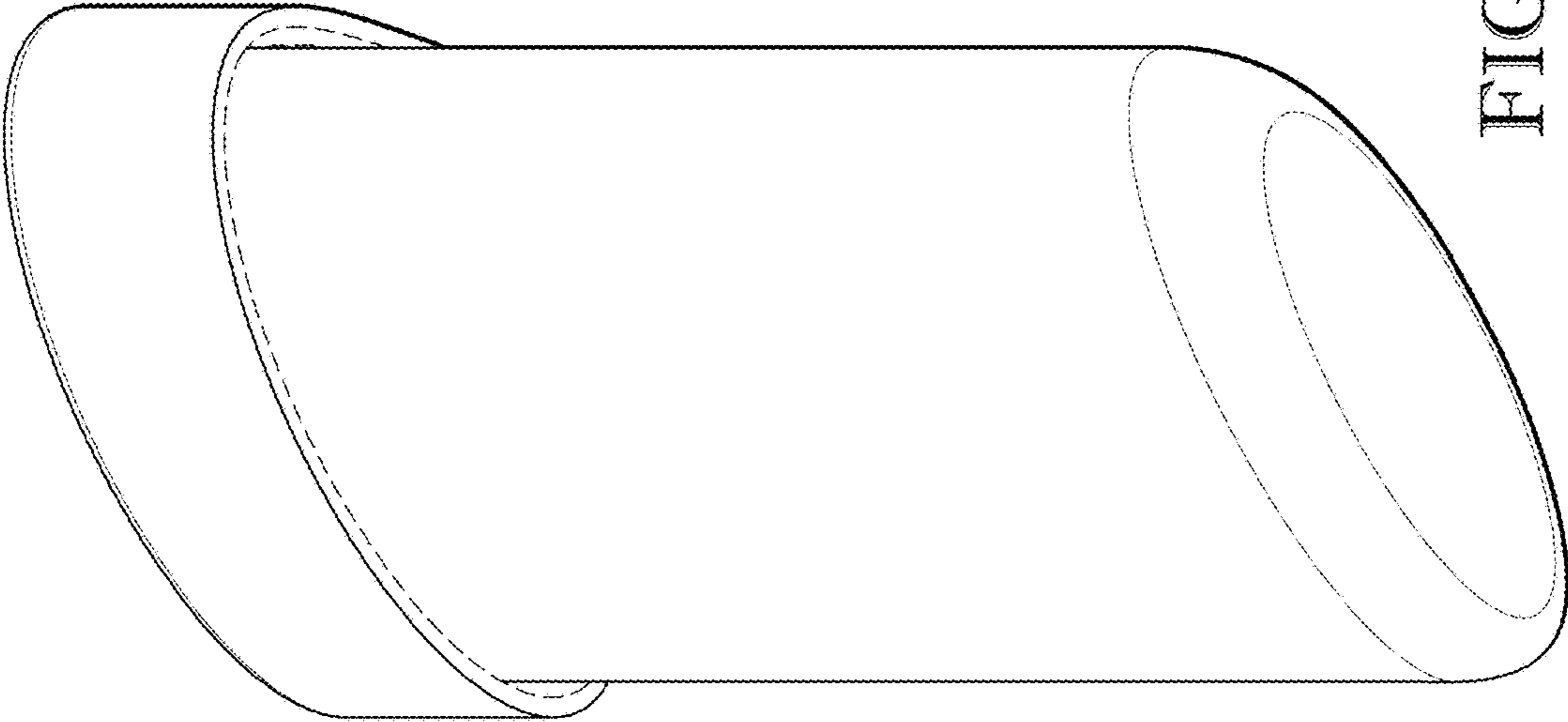

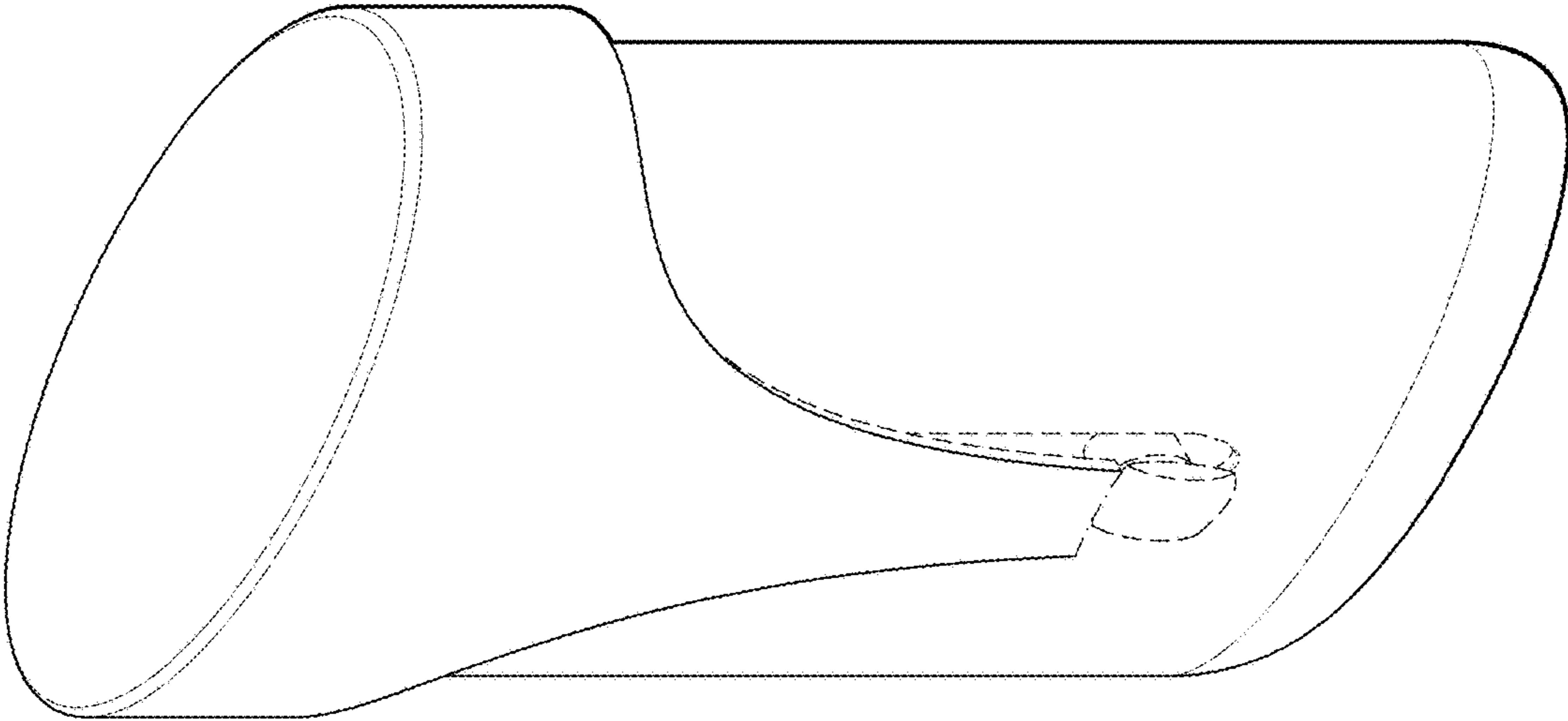

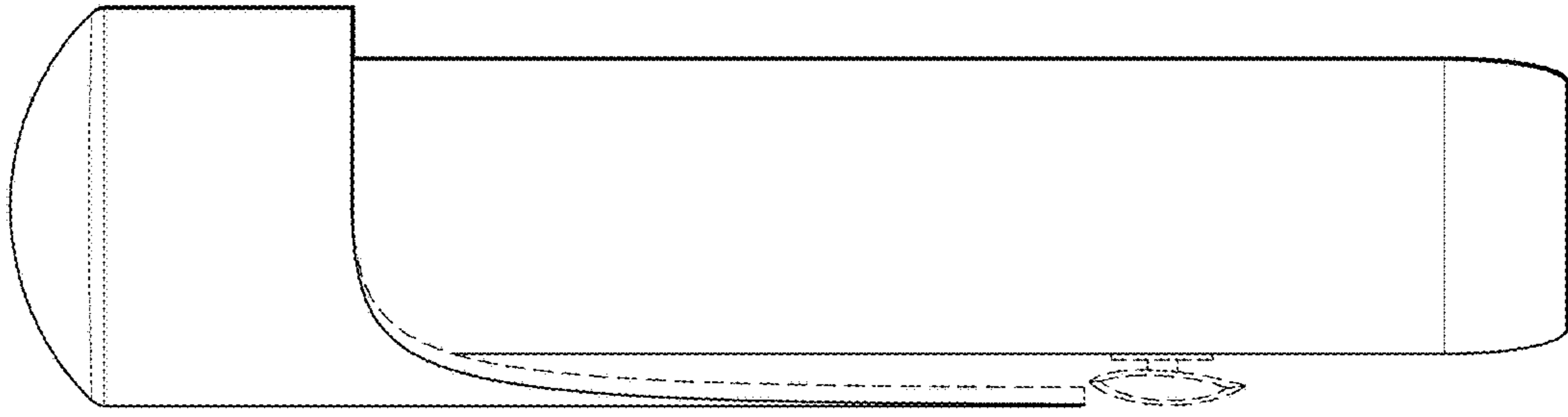

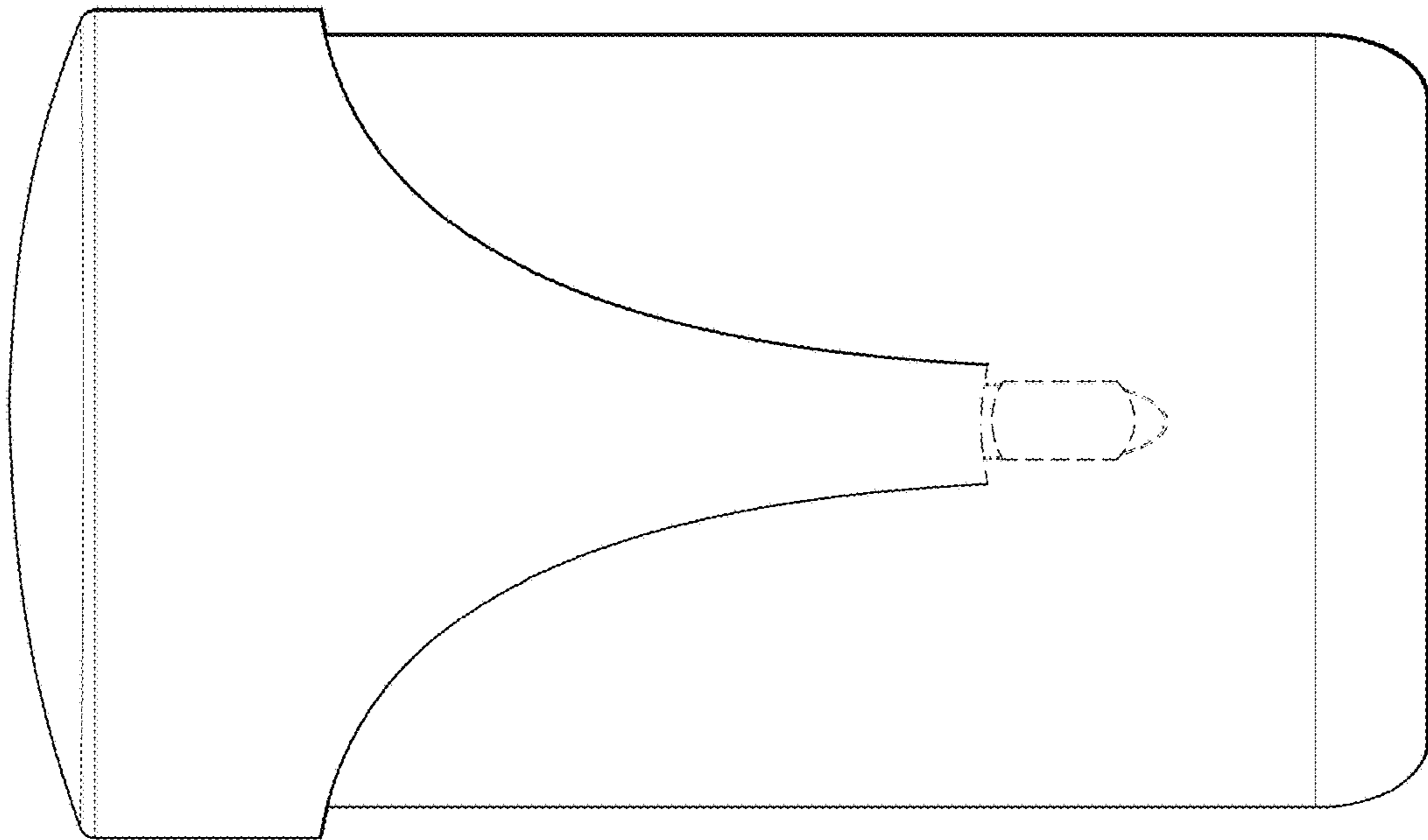

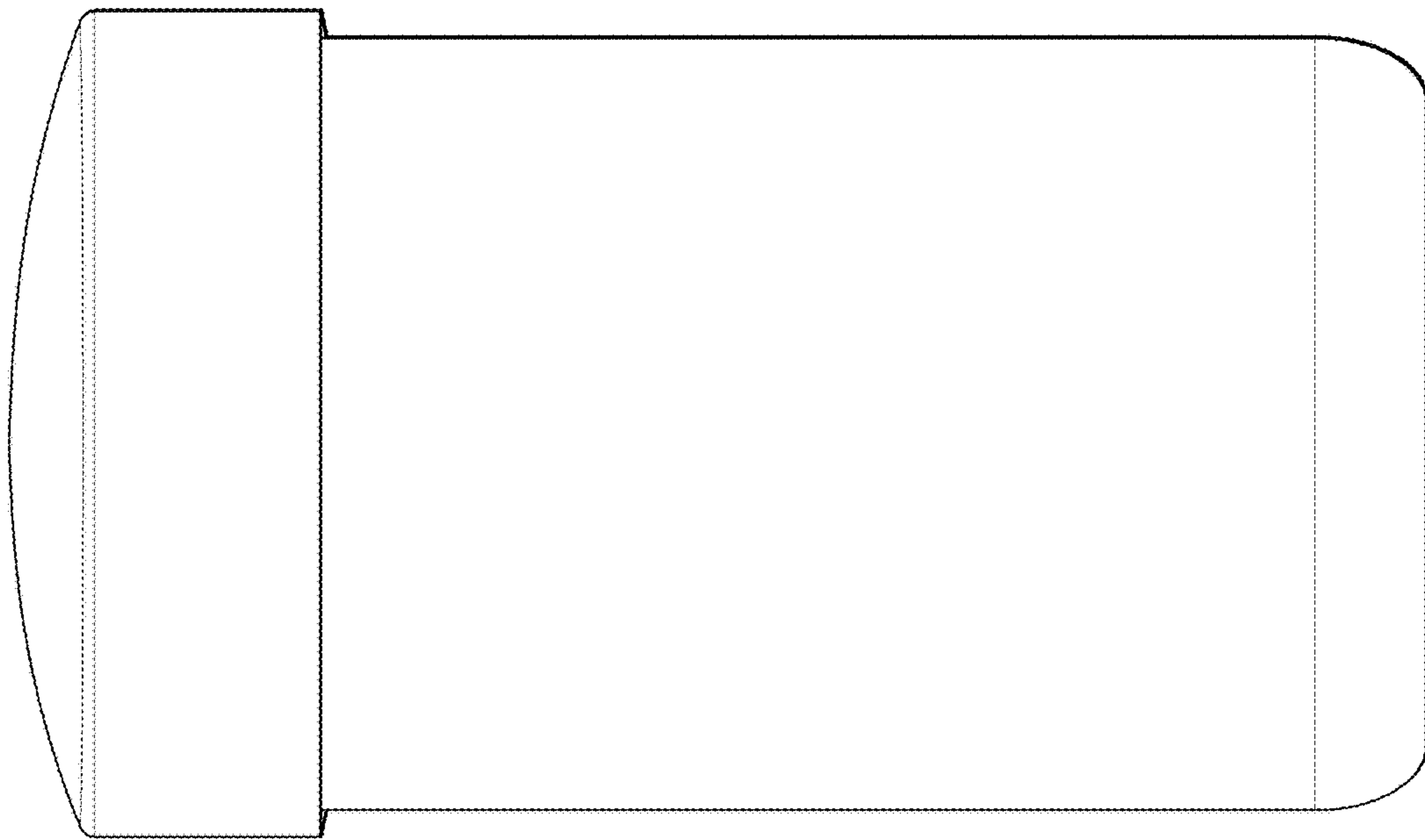

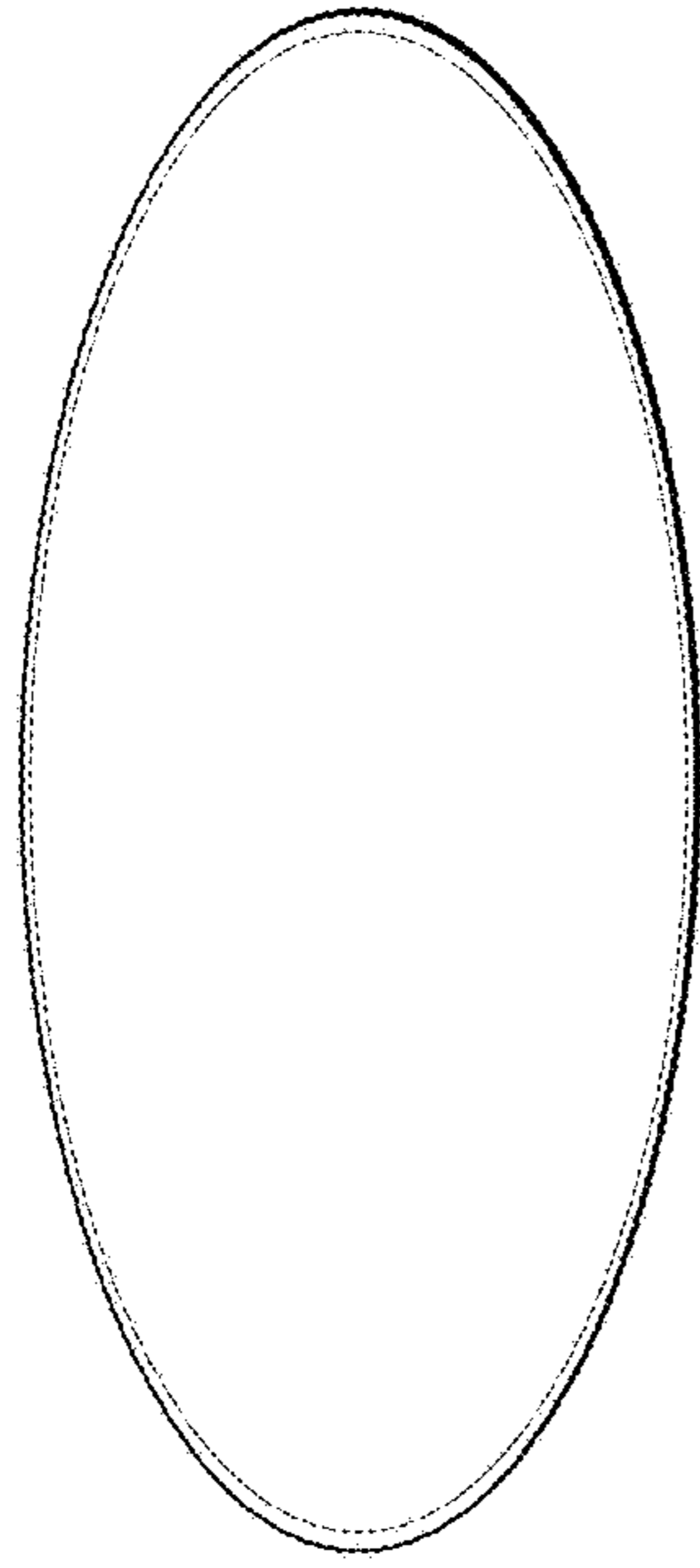

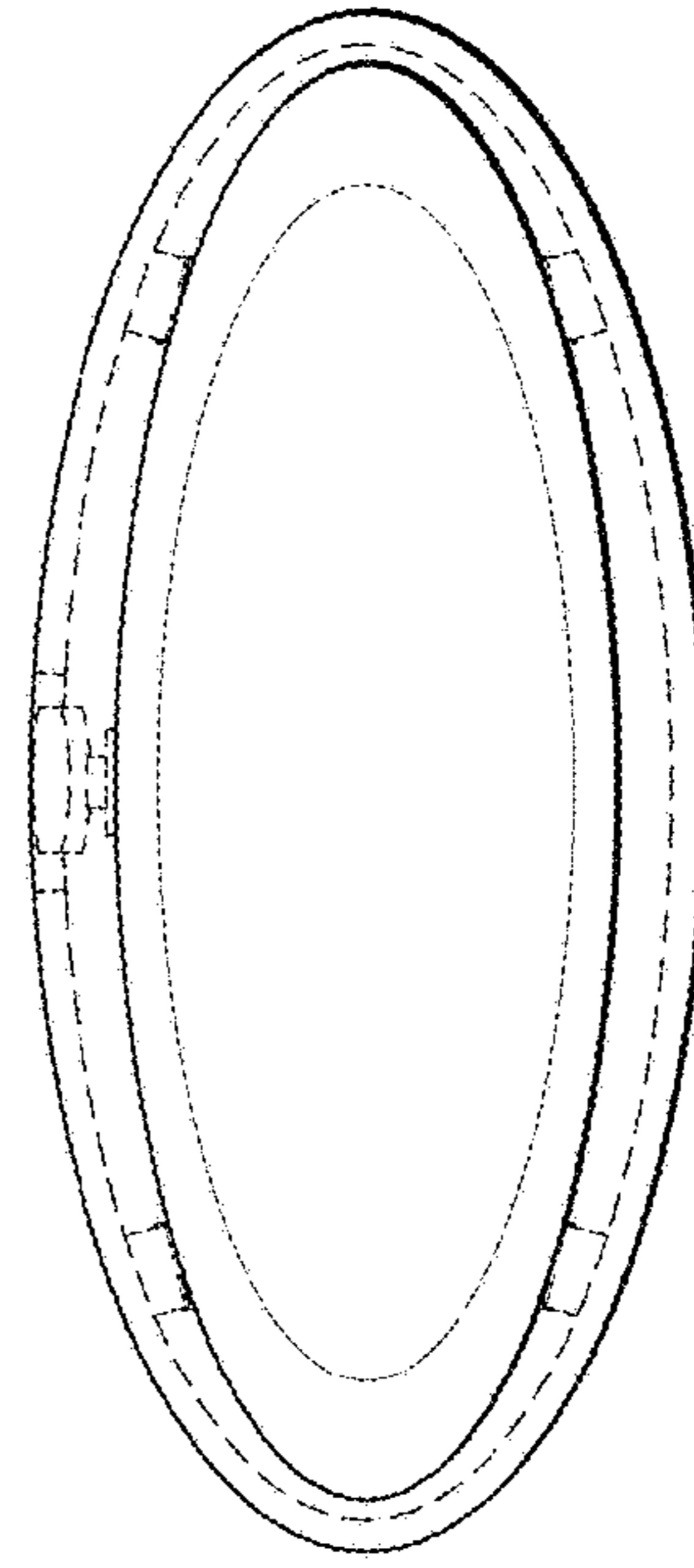

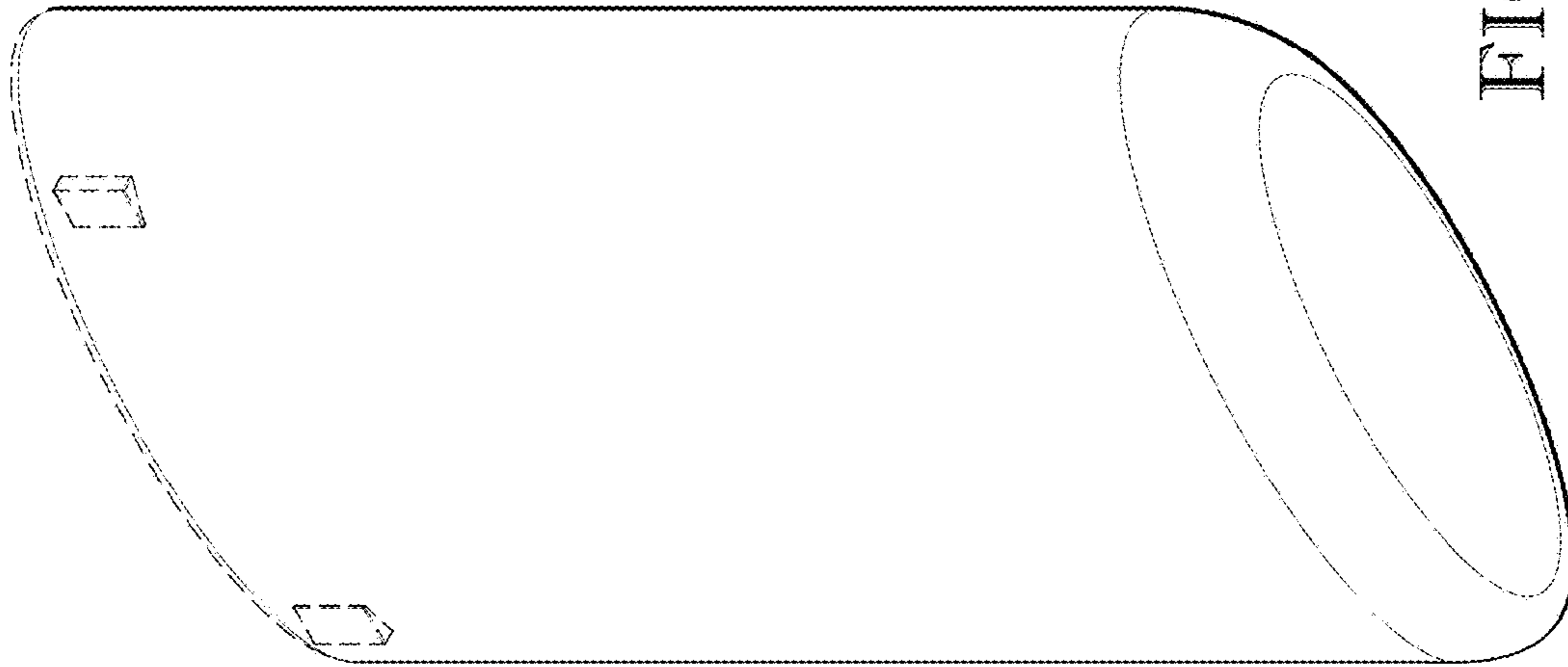

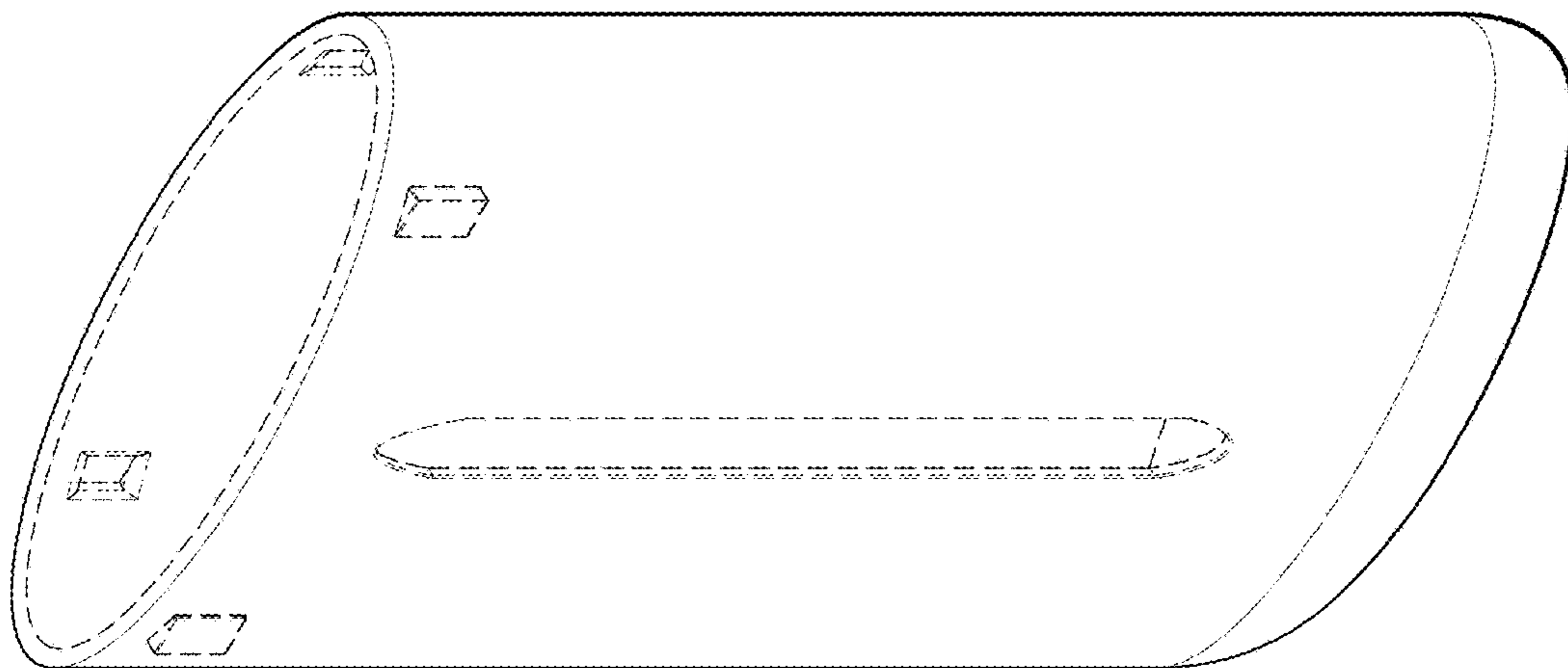

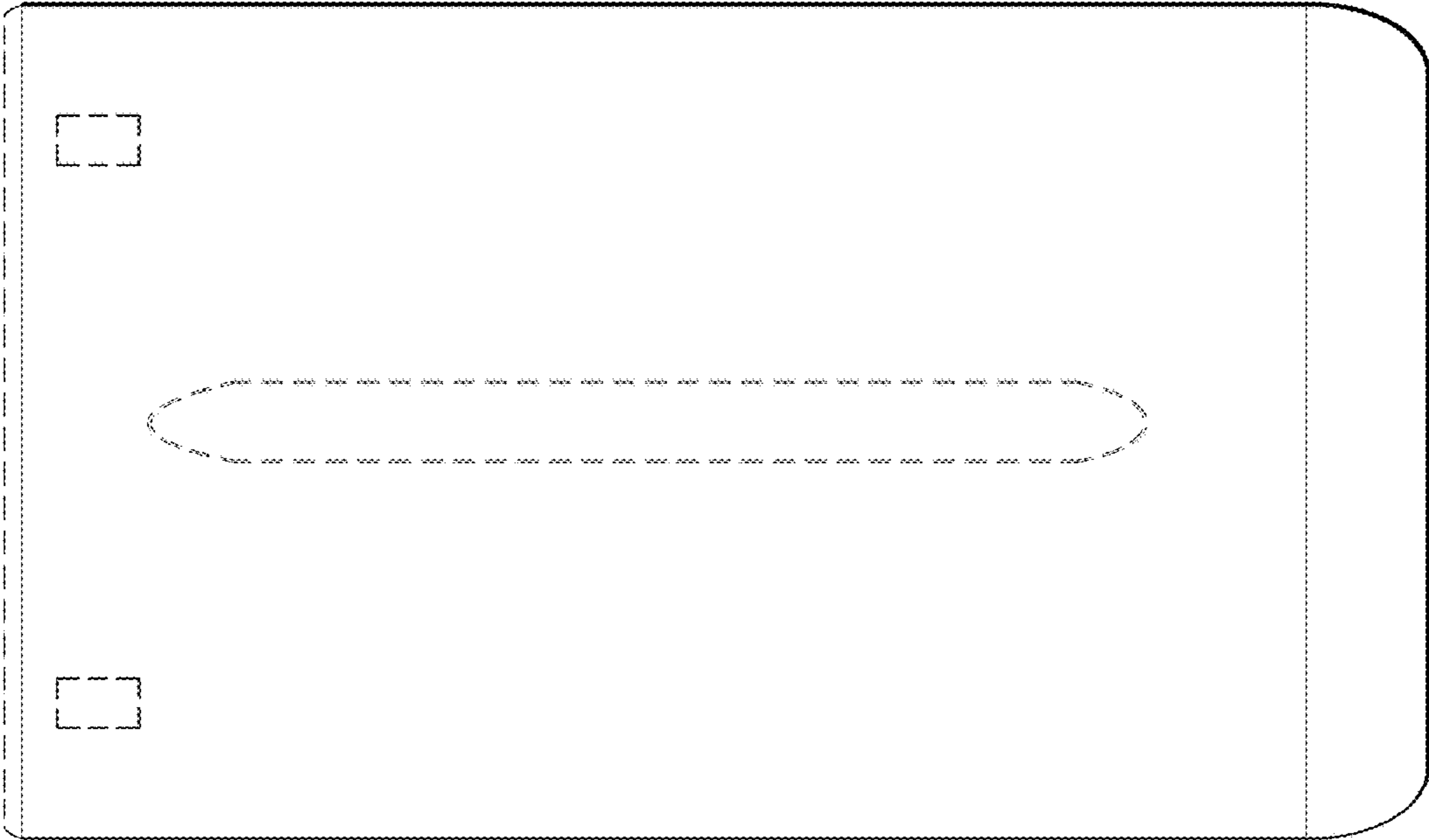

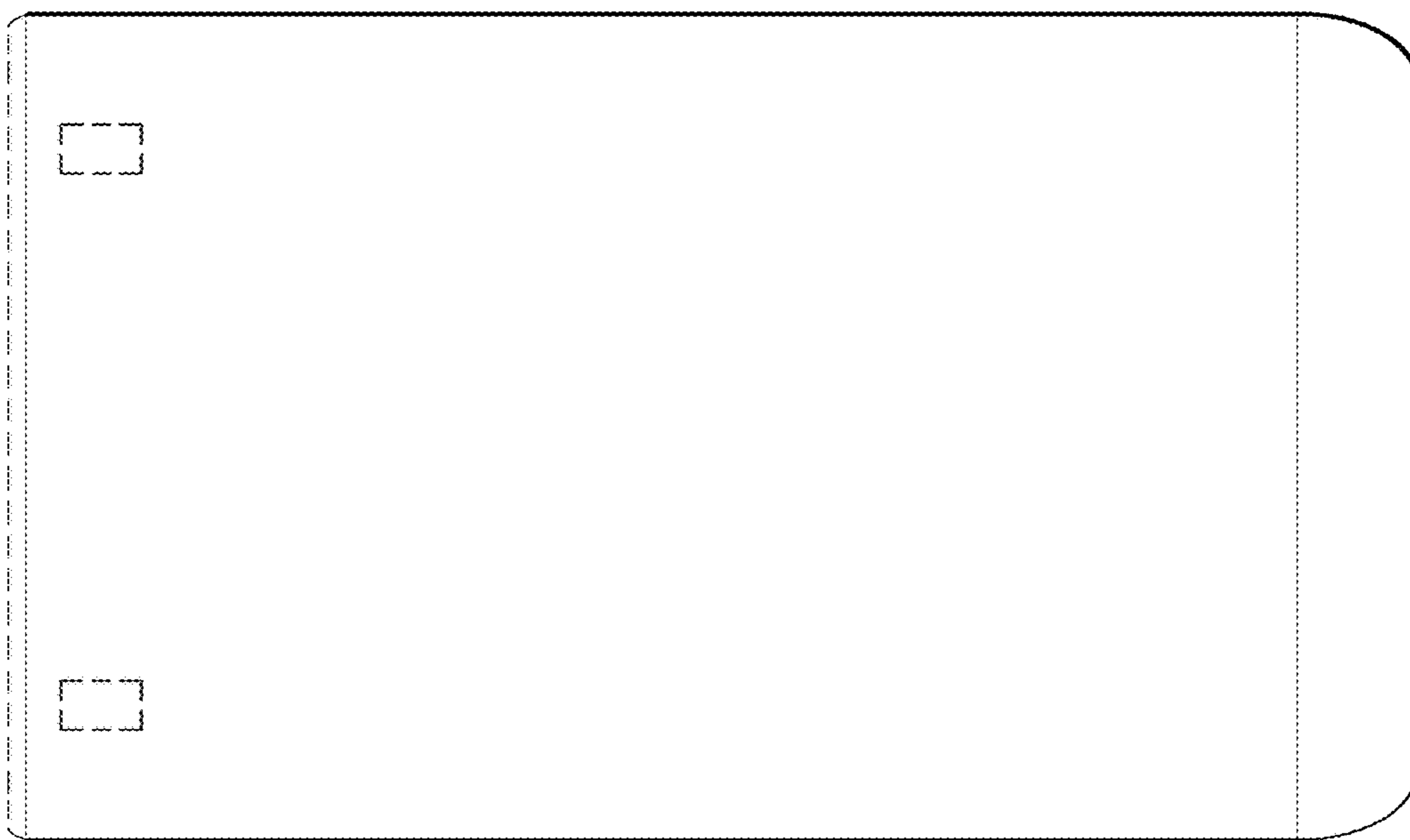

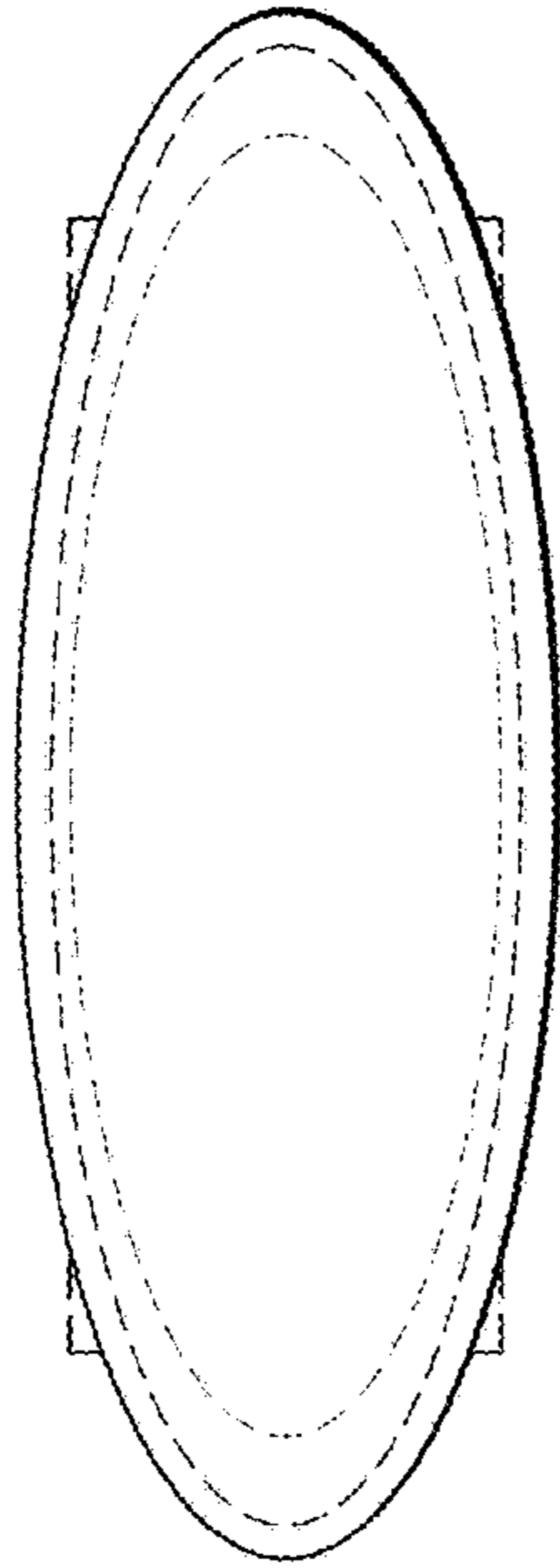

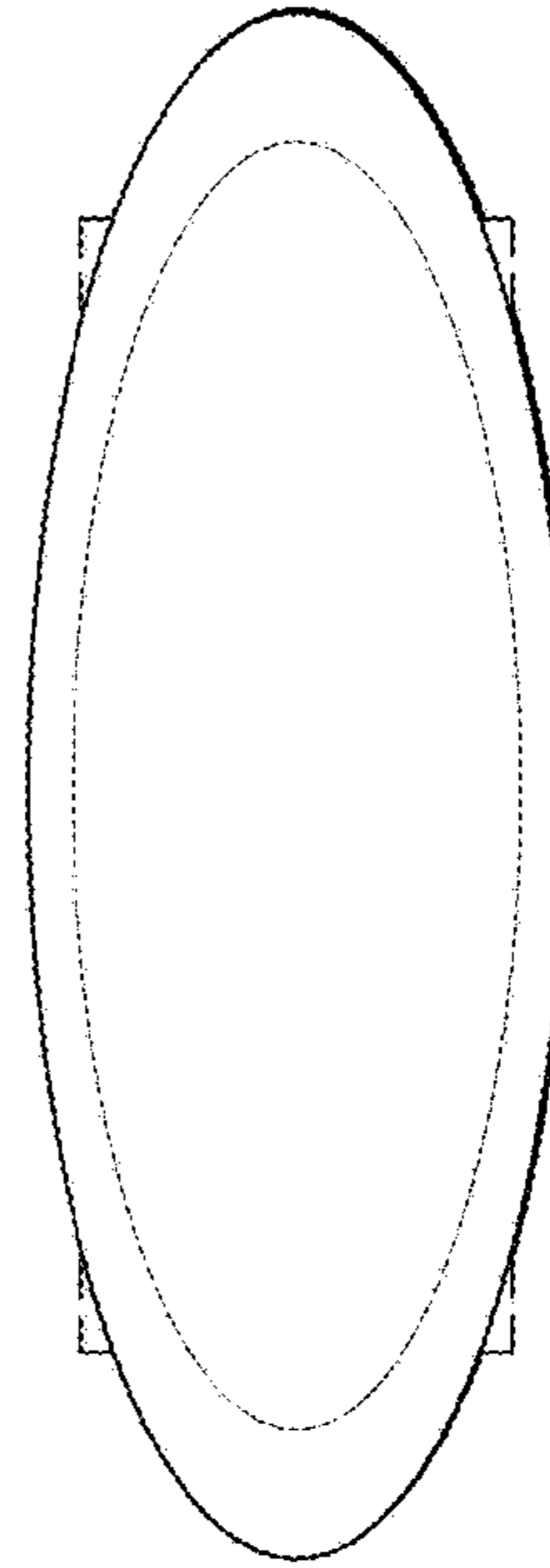

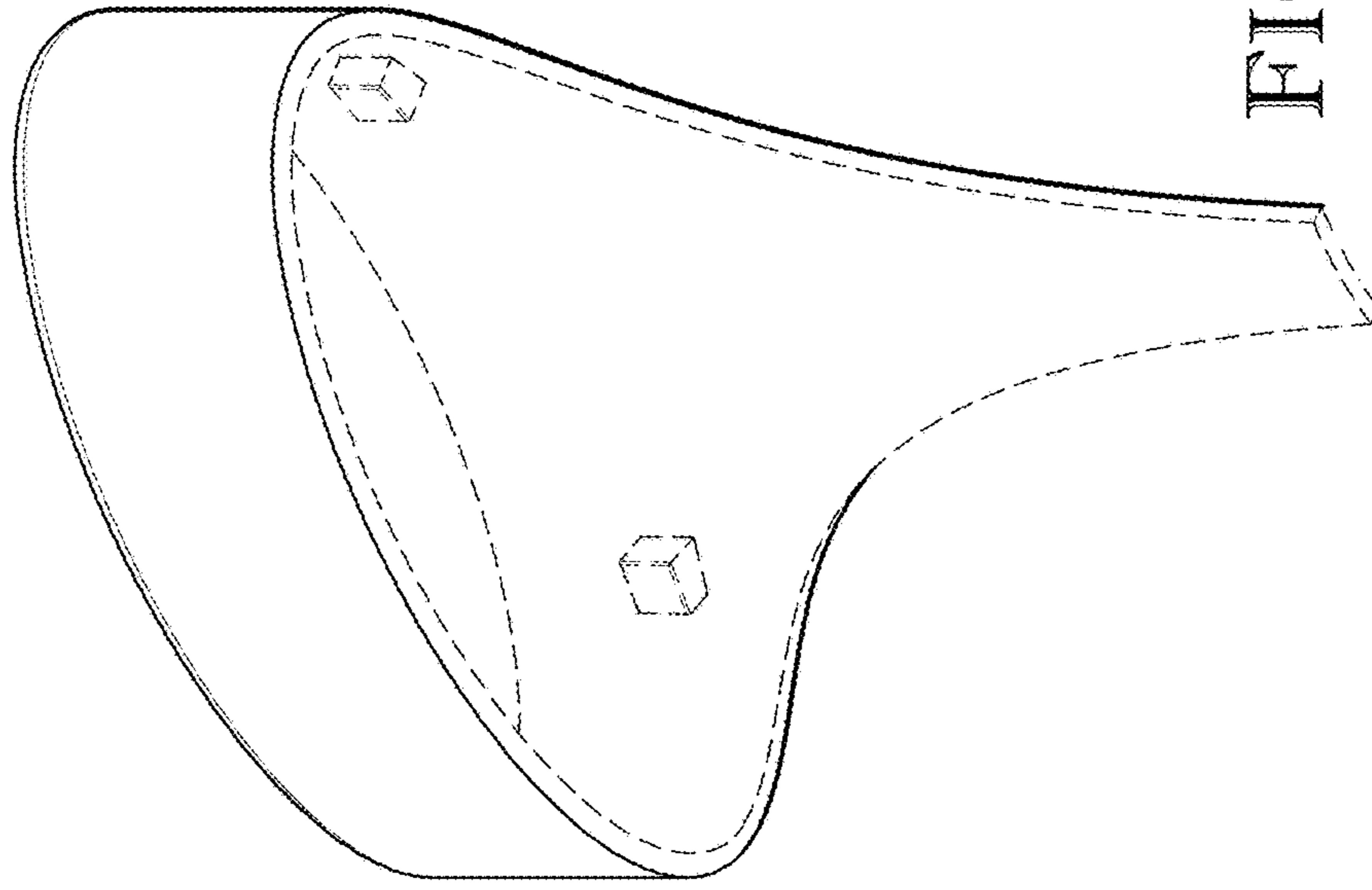

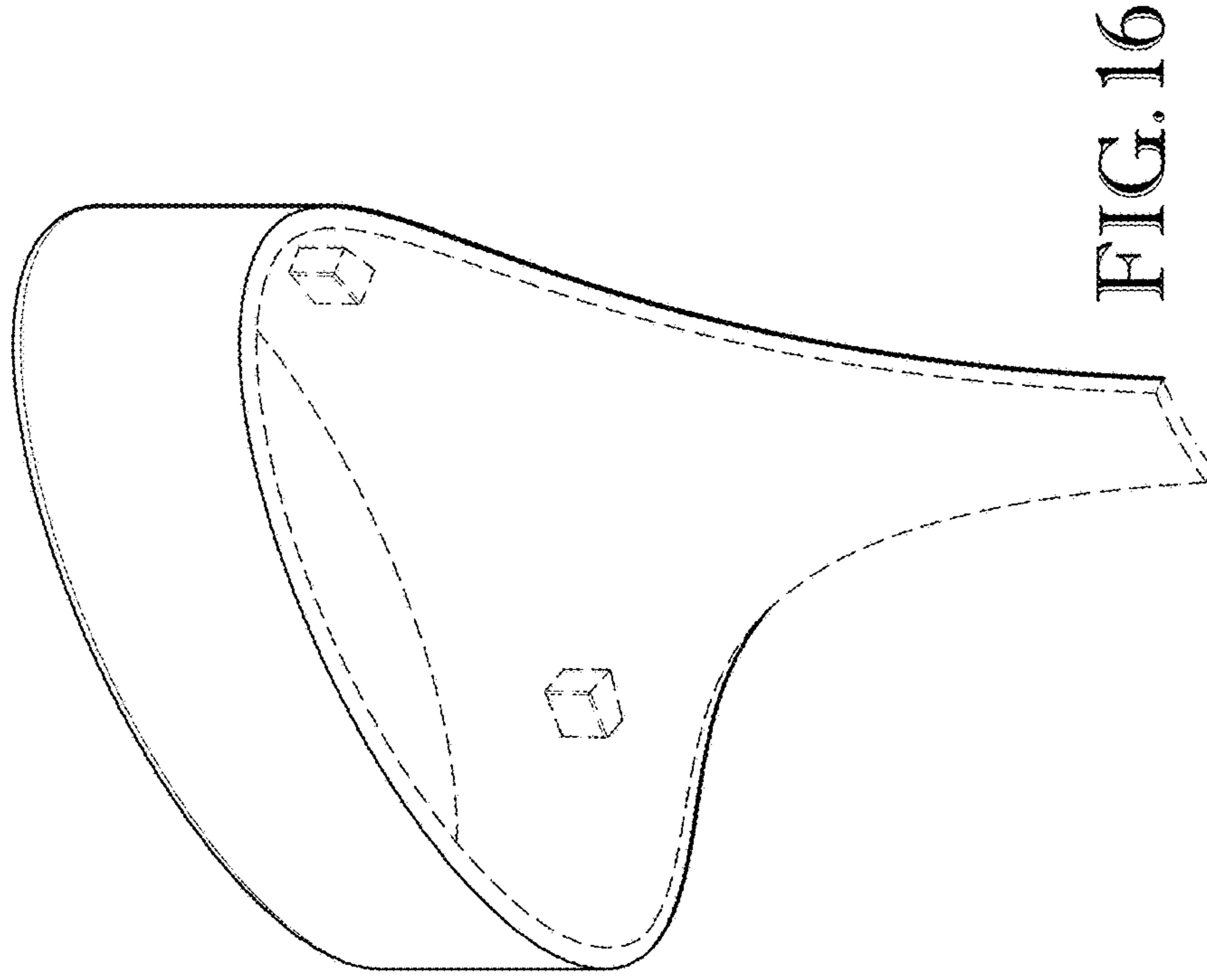

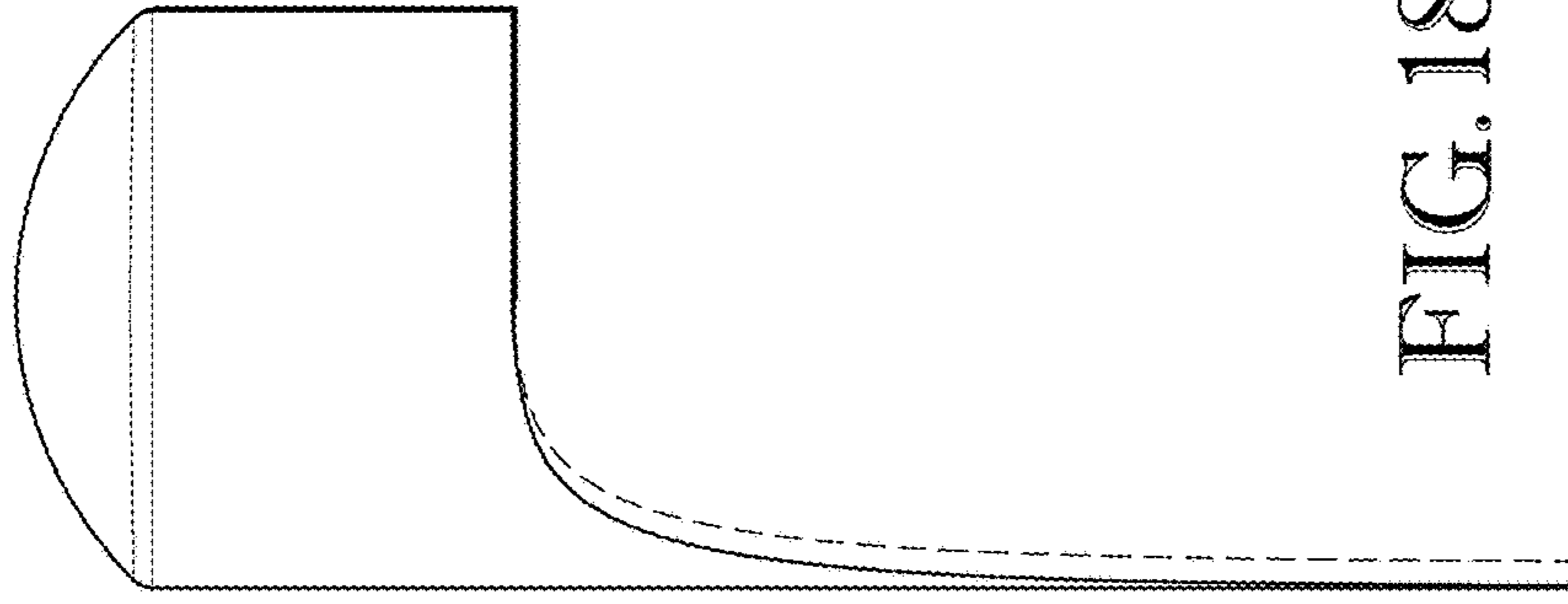

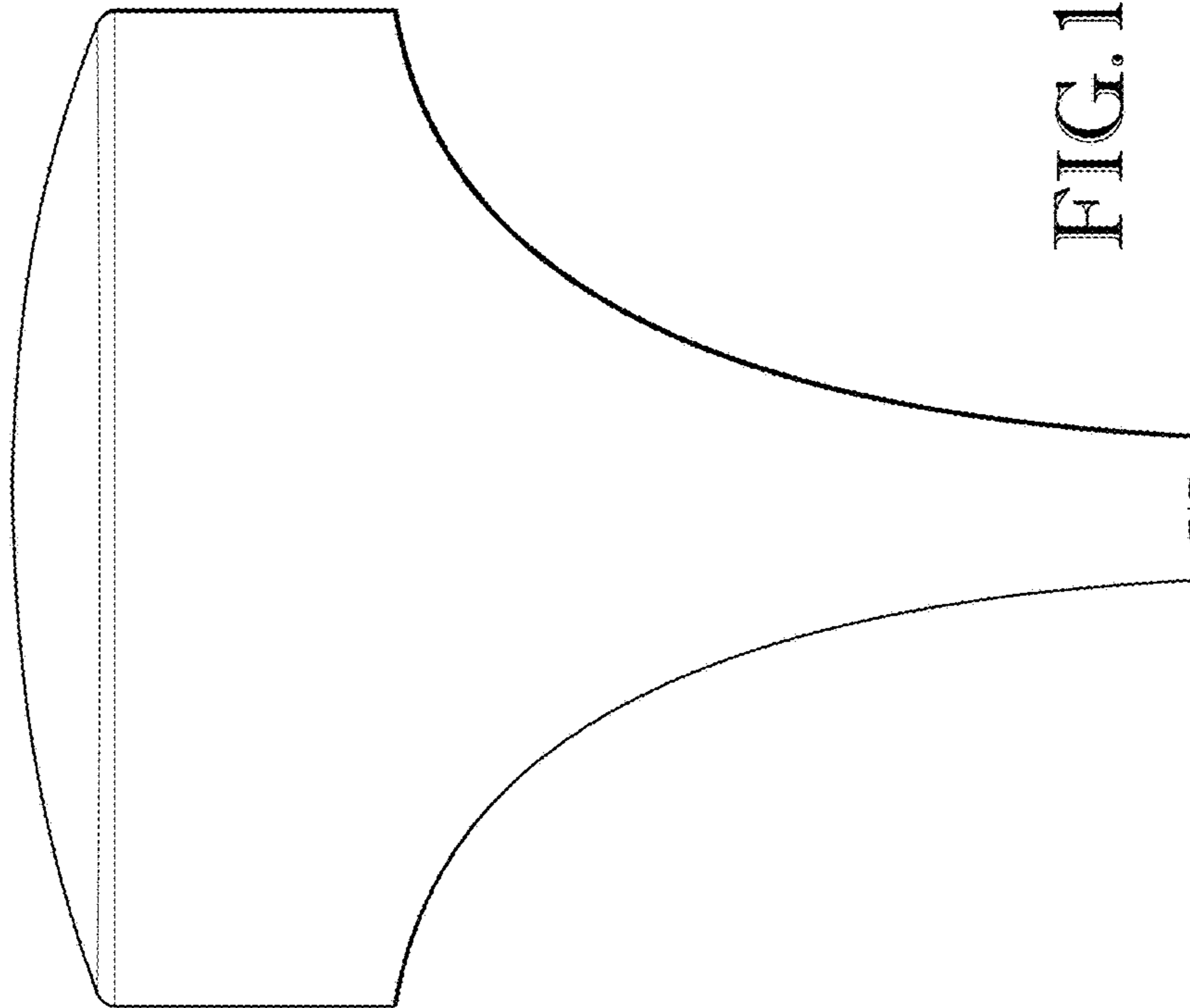

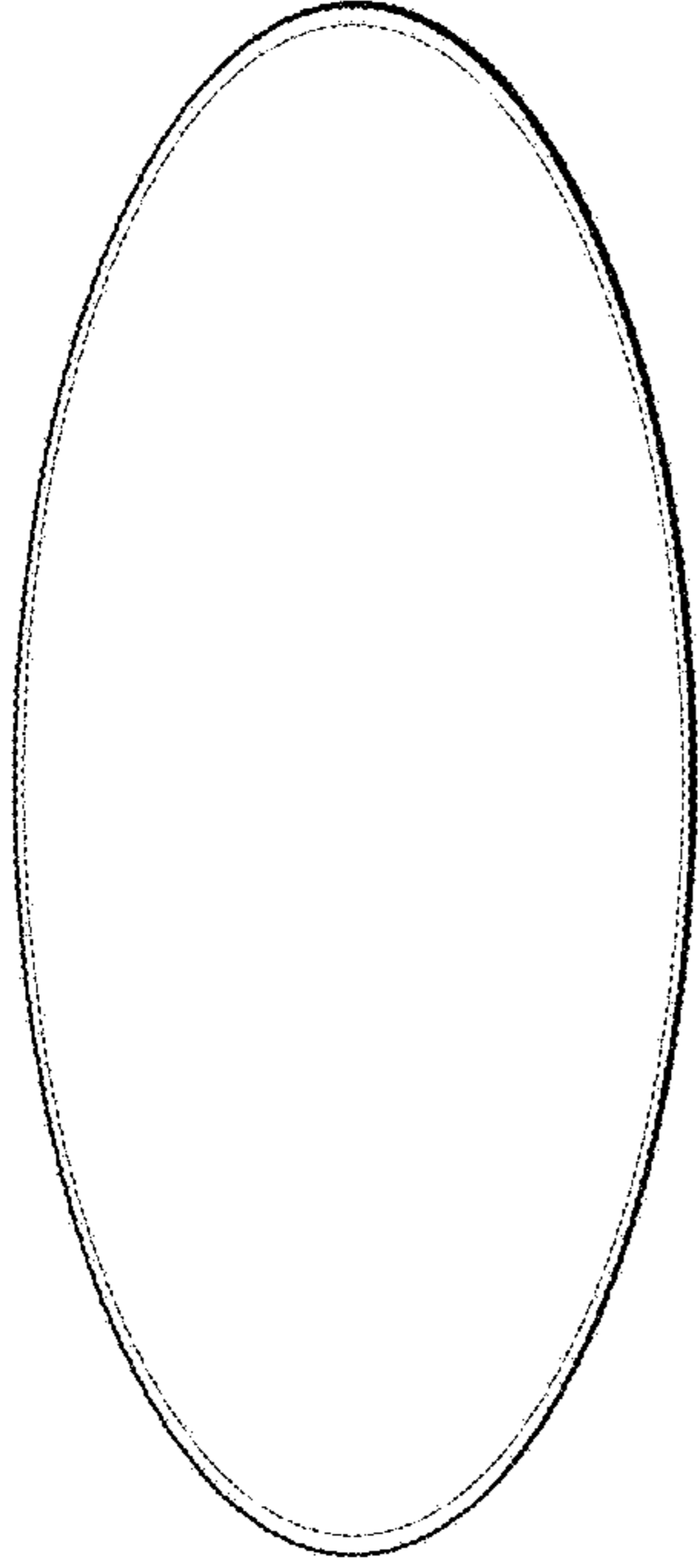

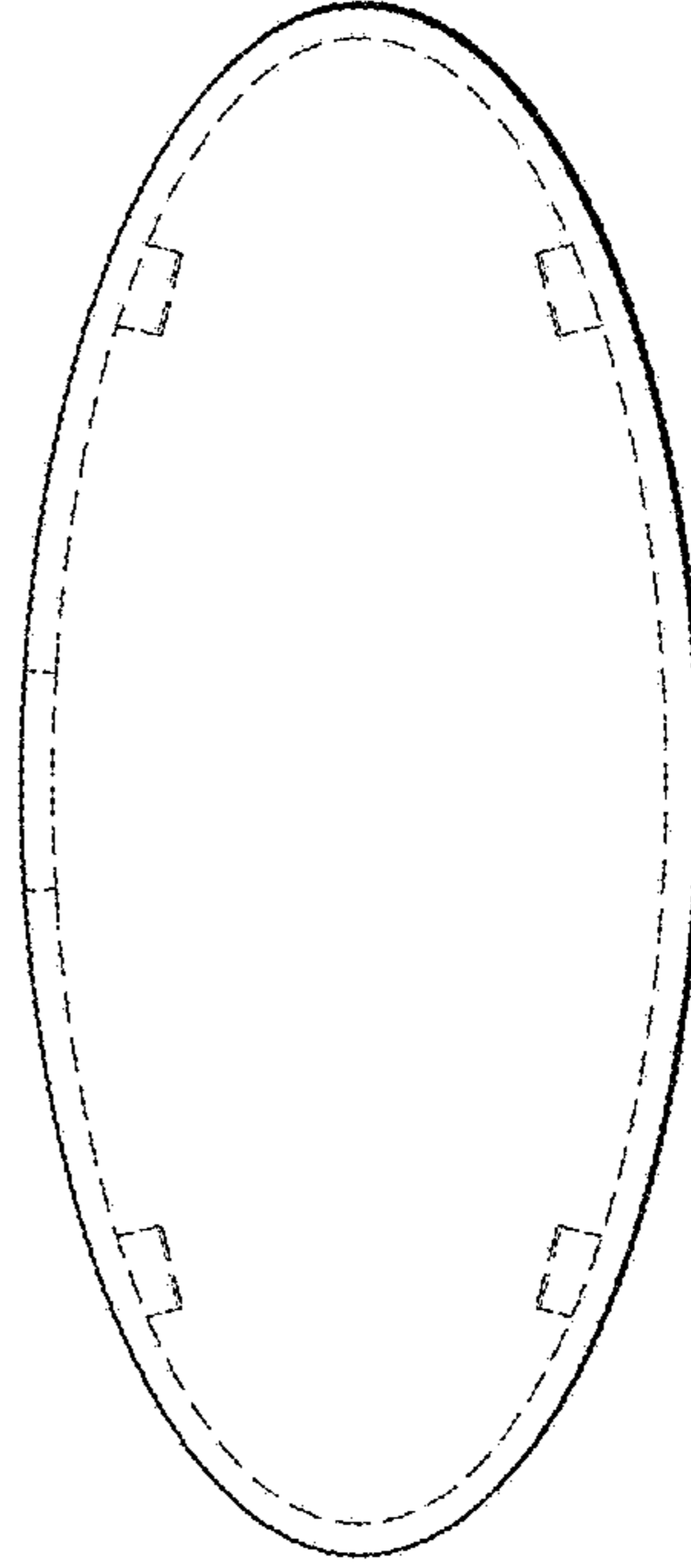

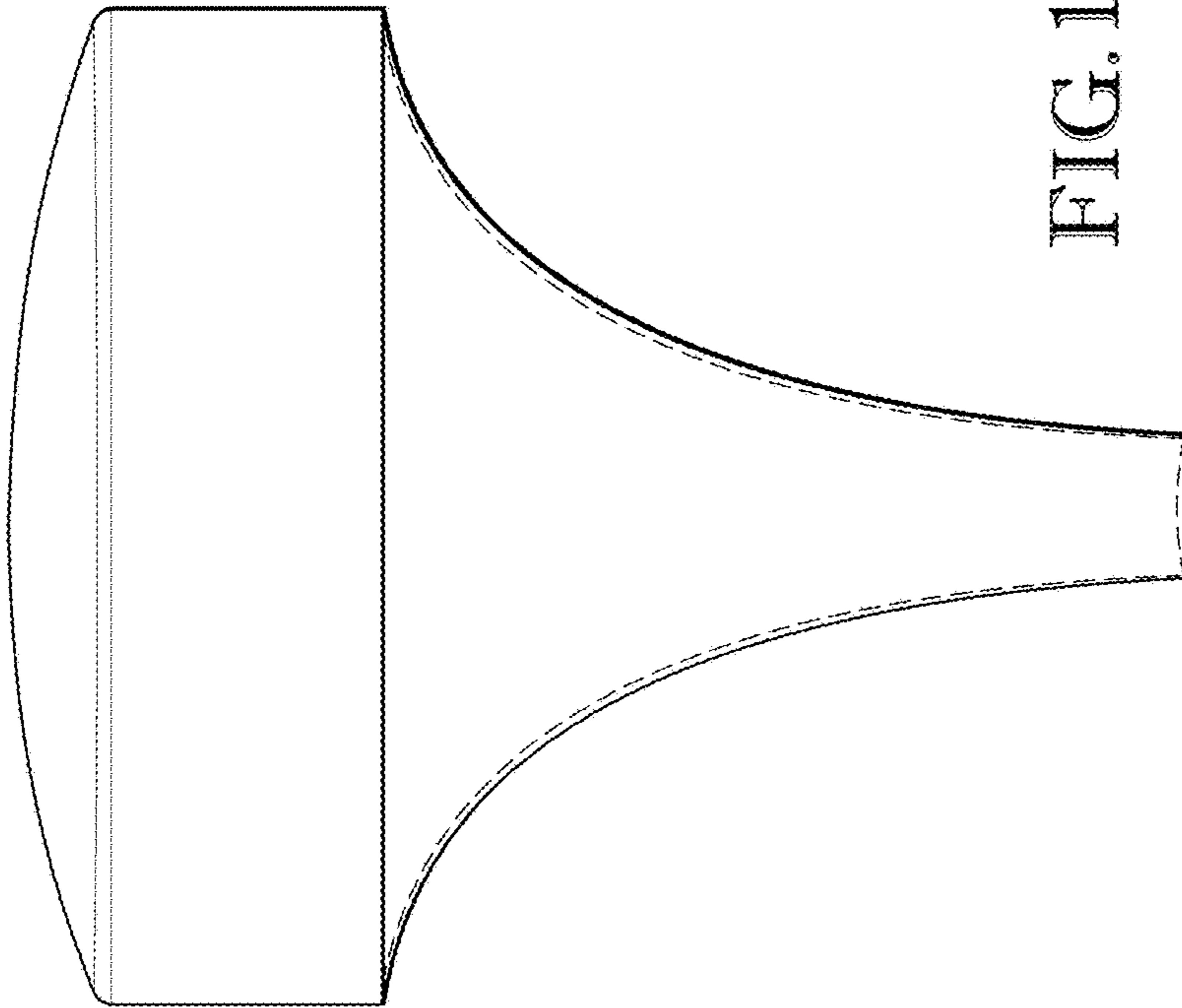
