DESCRIPTION

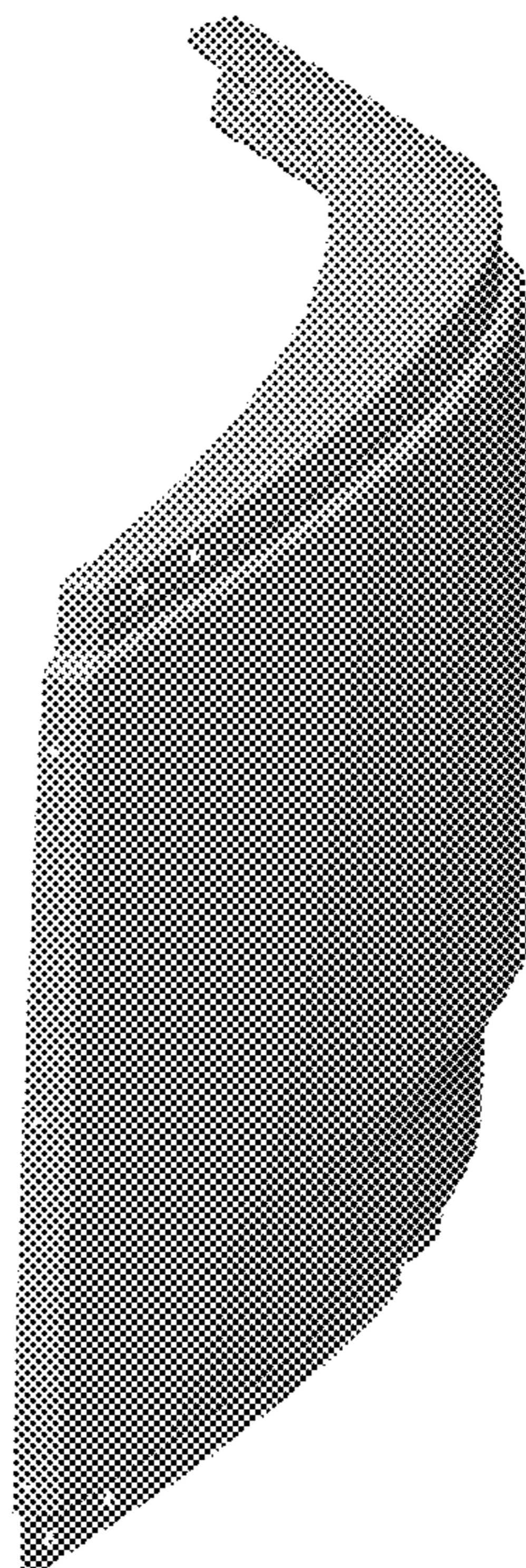
FIG. 1 is a perspective view of a body part for vehicle showing our new design.

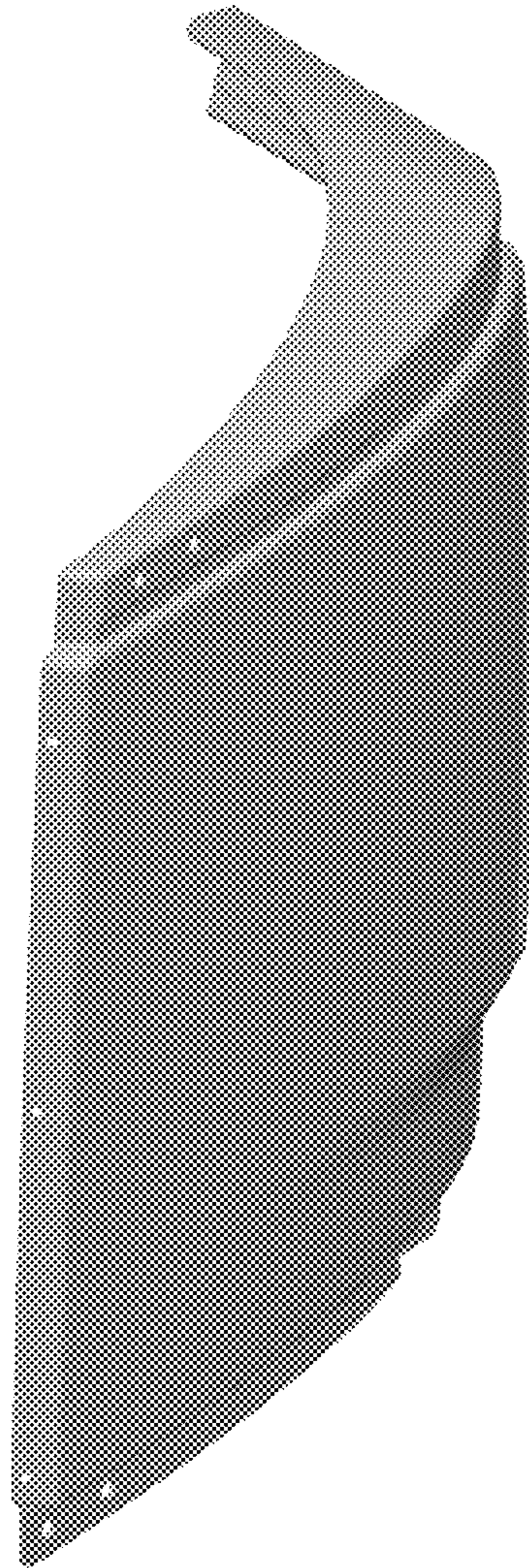

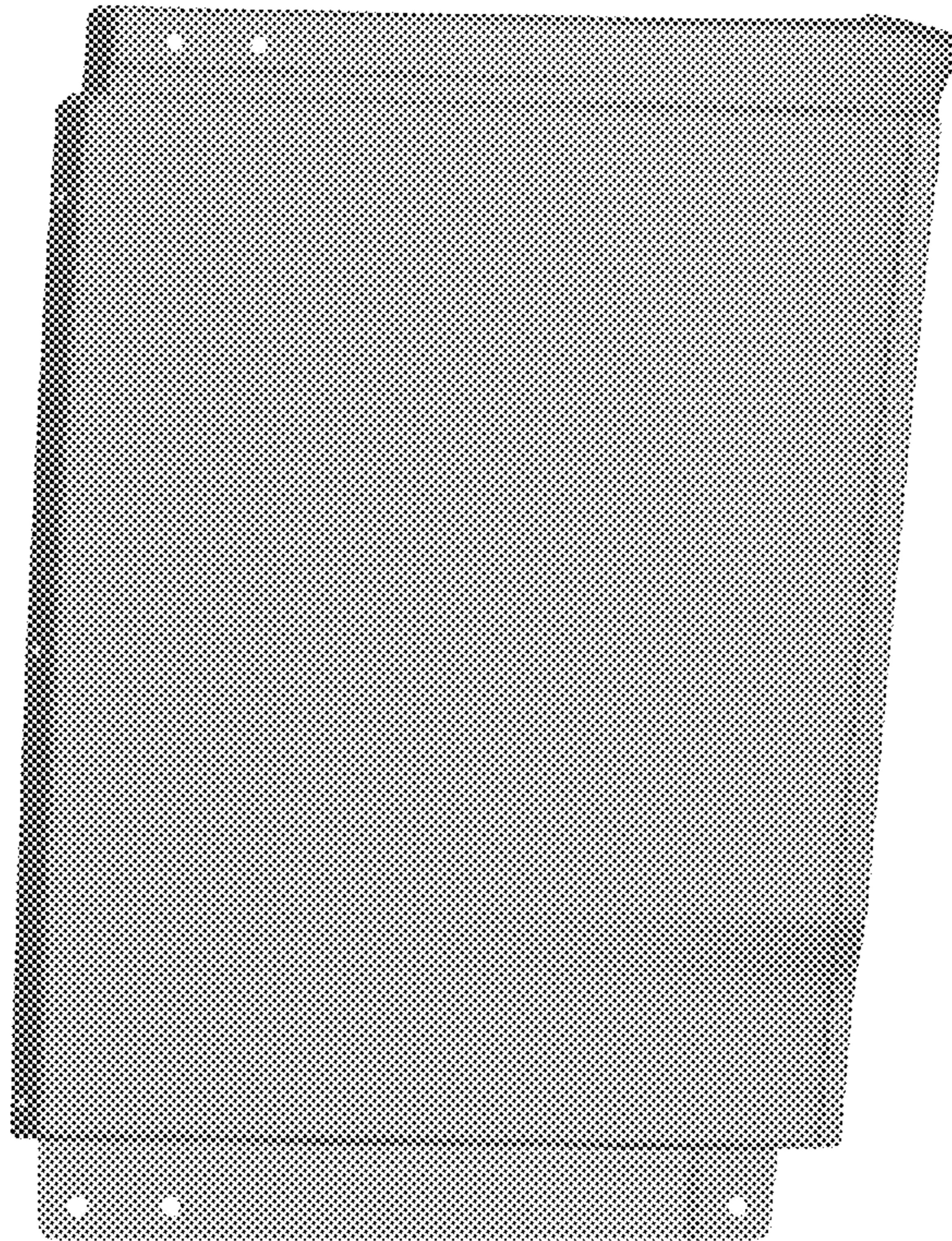

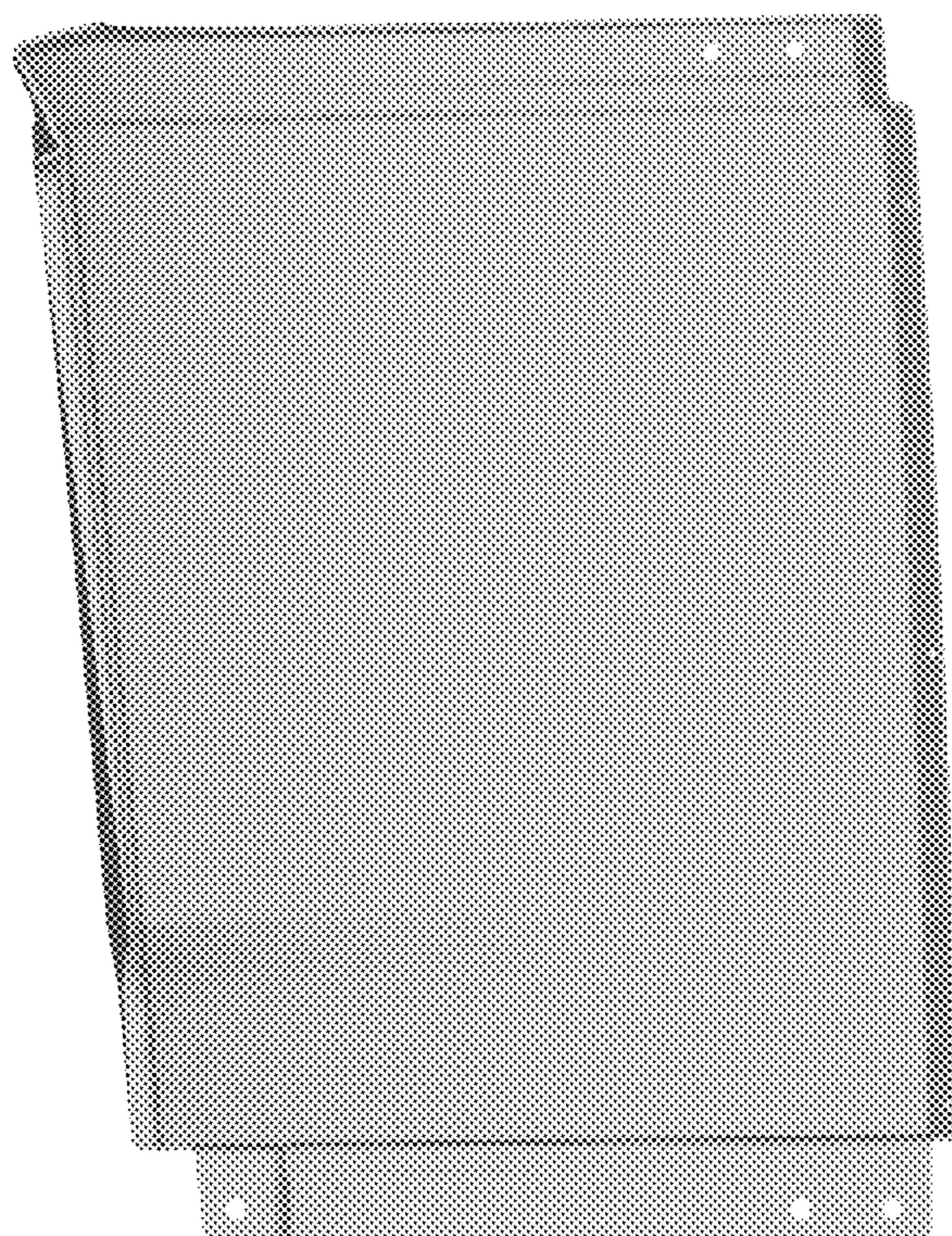

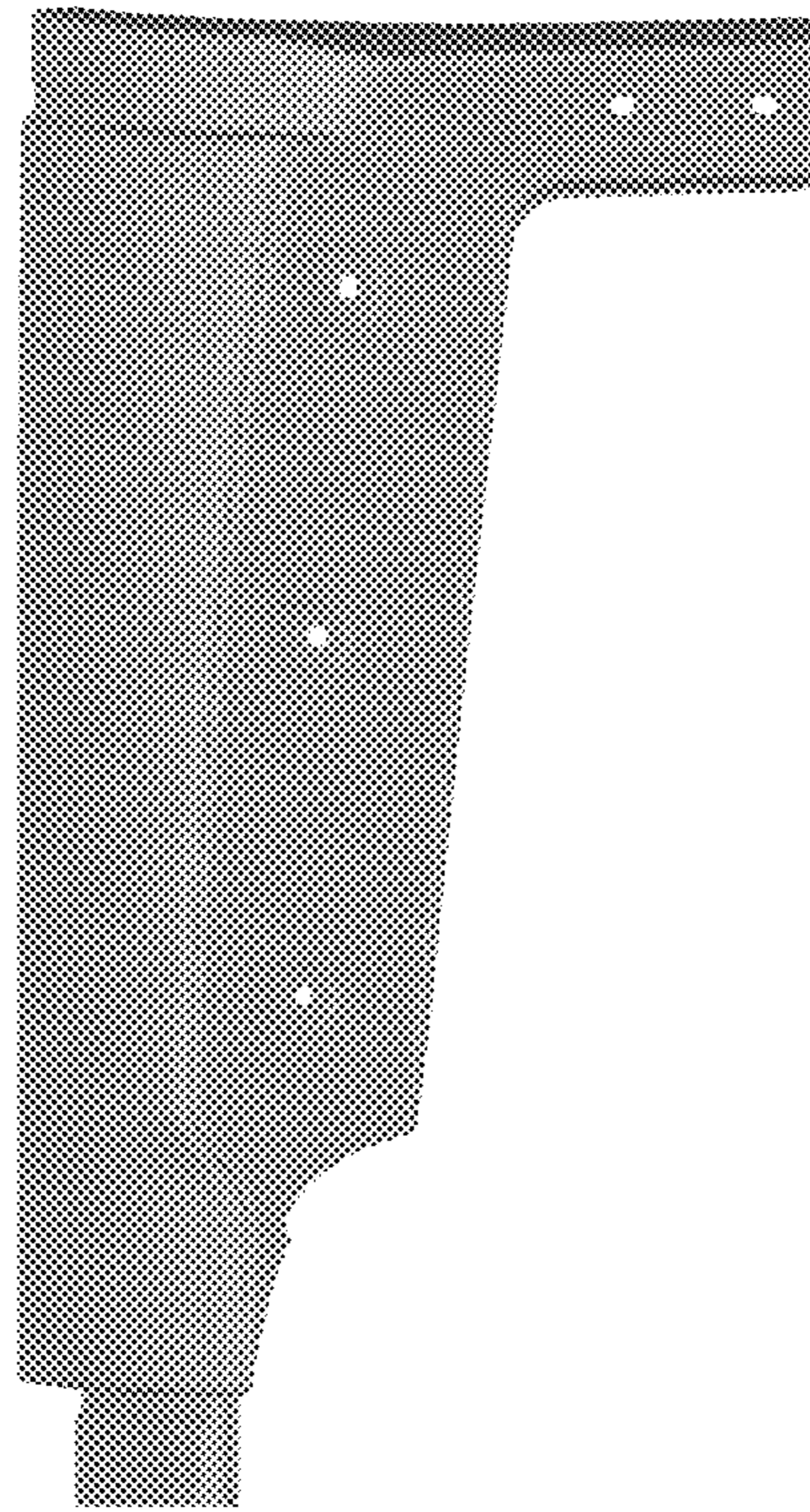

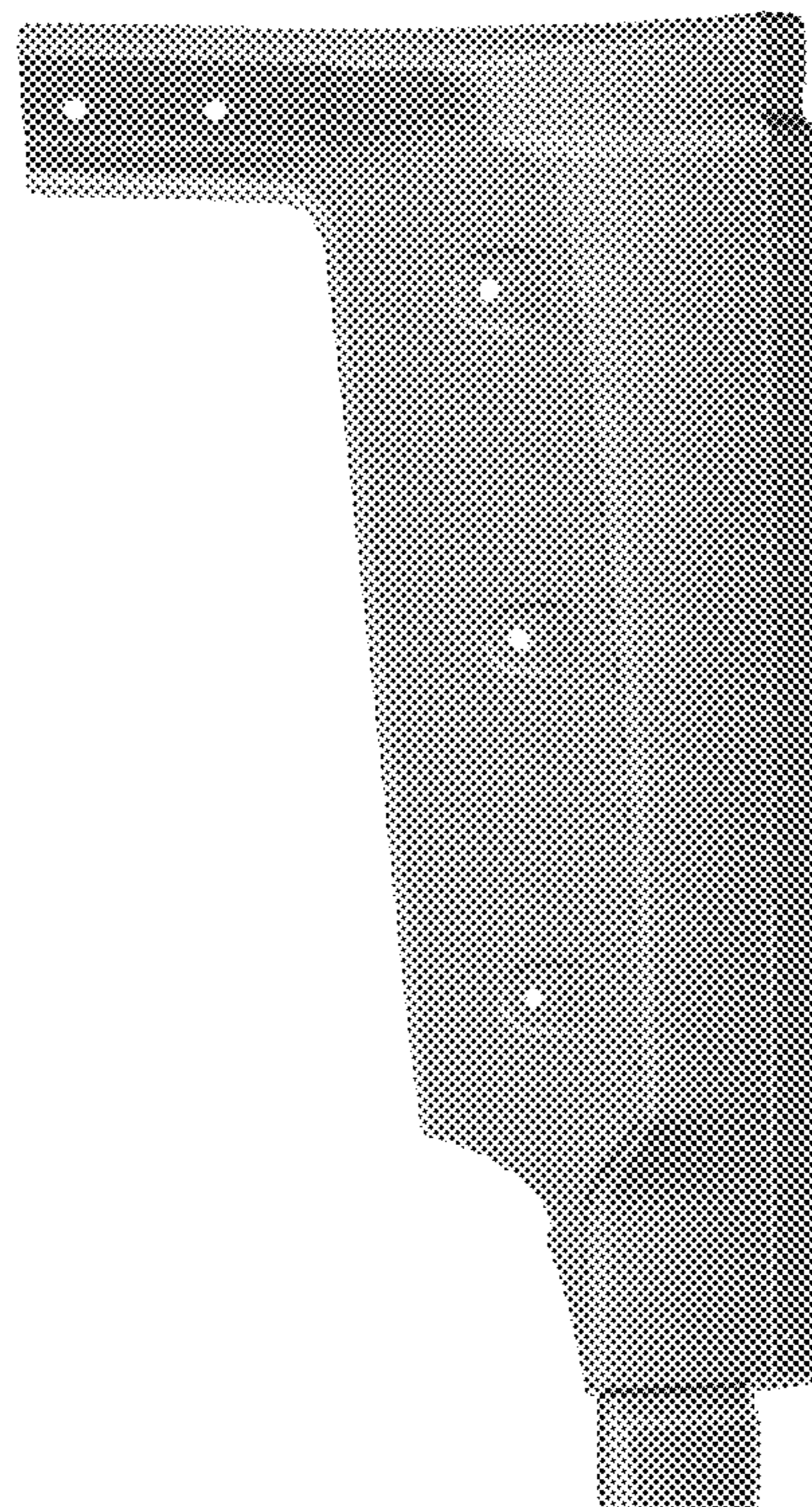

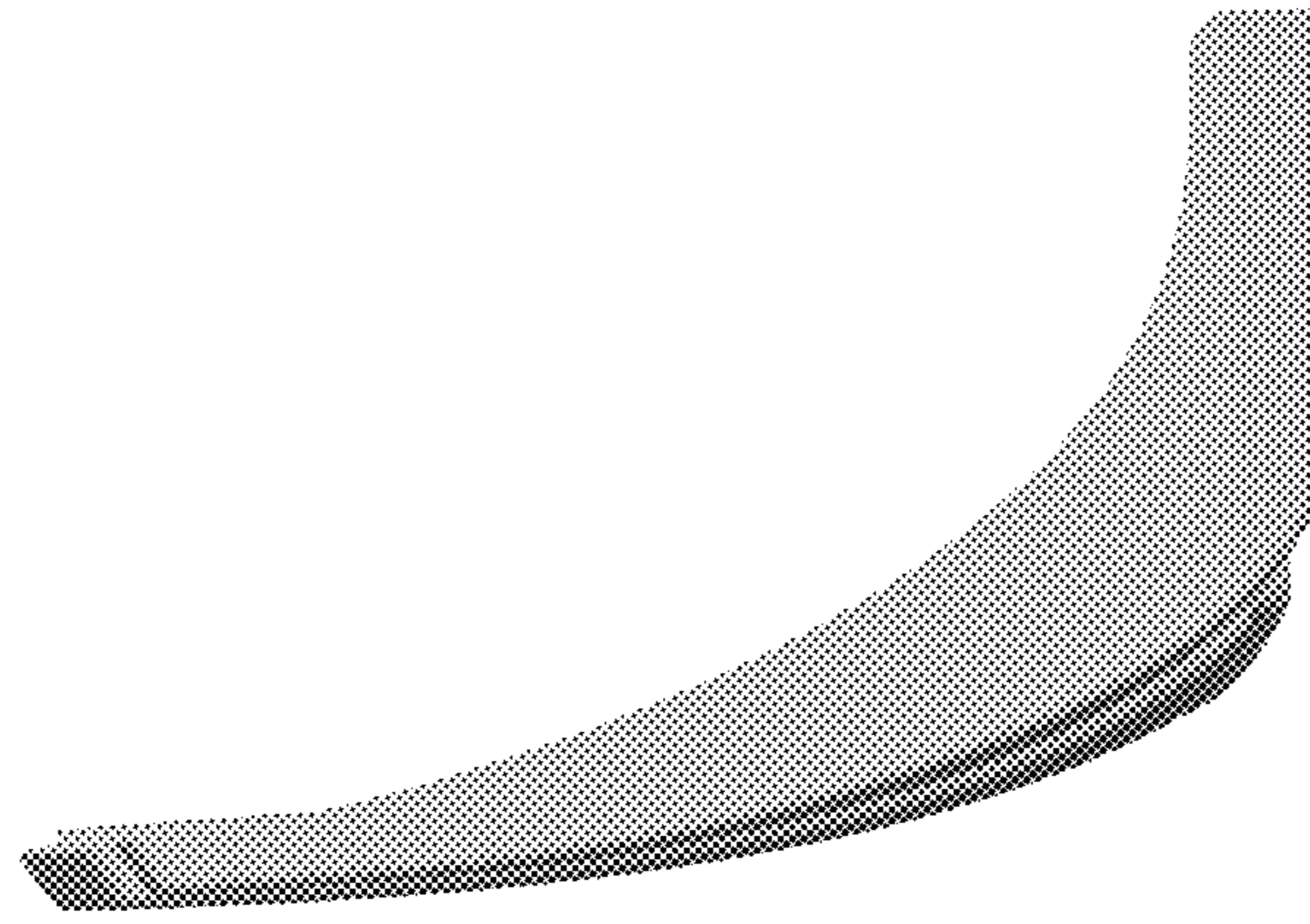

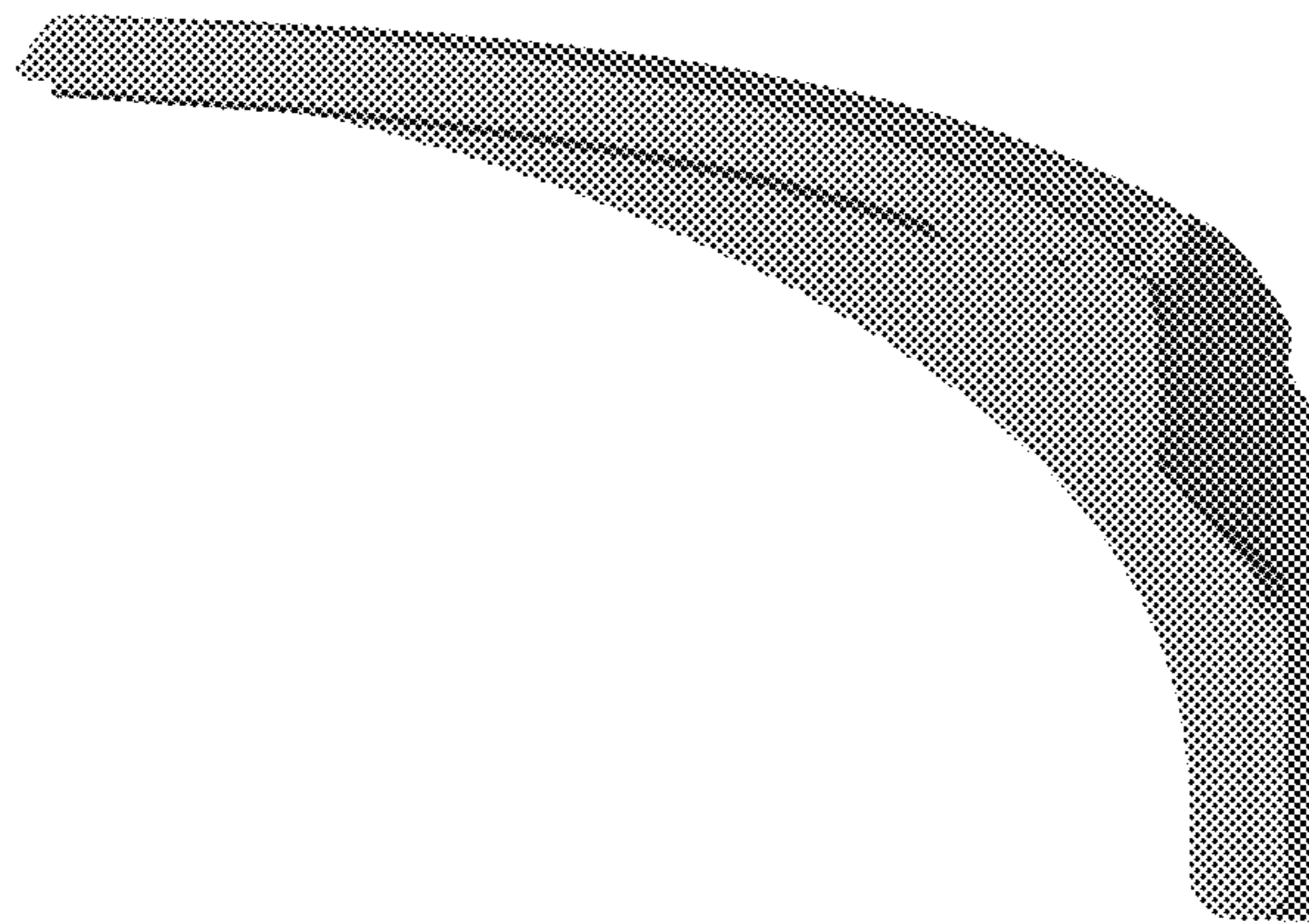
