(57) **CLAIM**

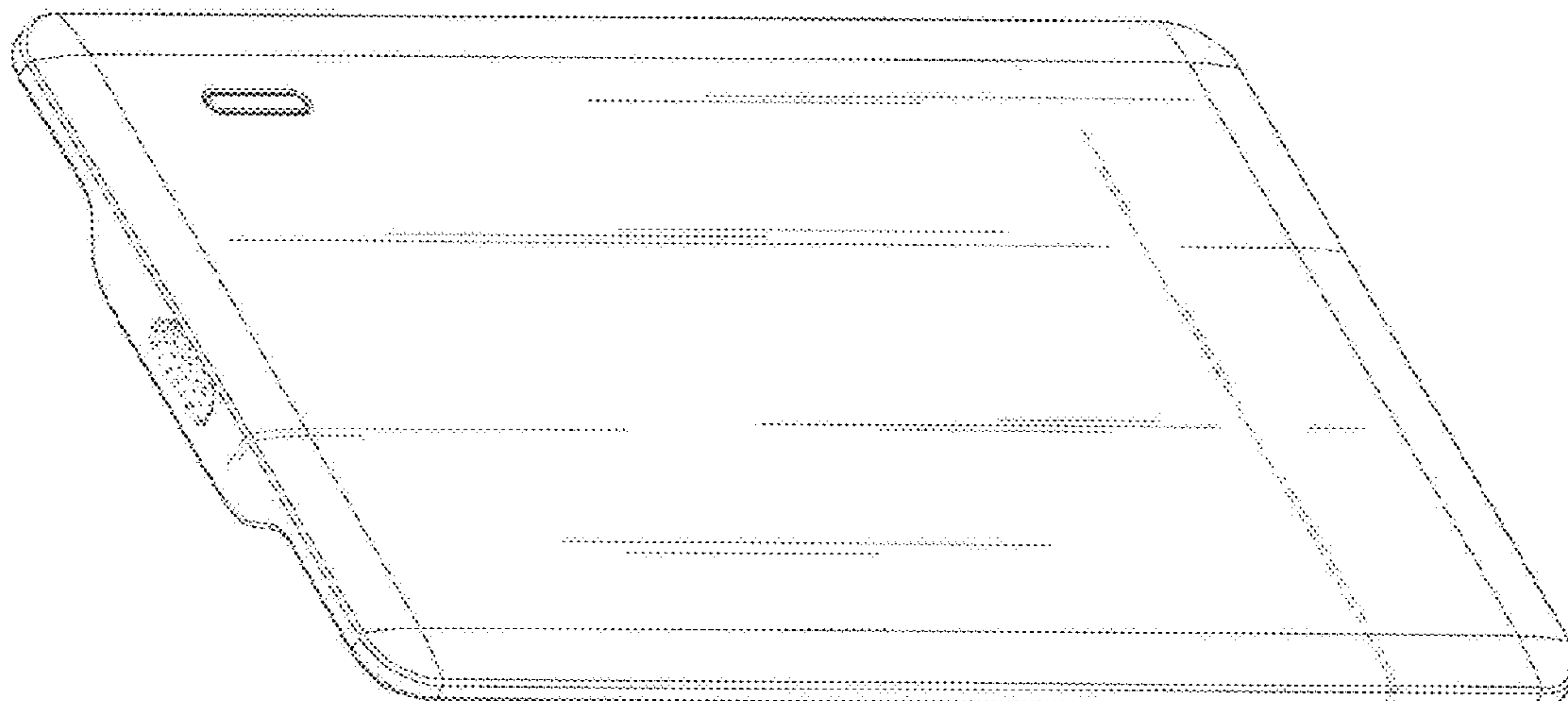
The ornamental design for a wireless charger for cellular phone, as shown and described.

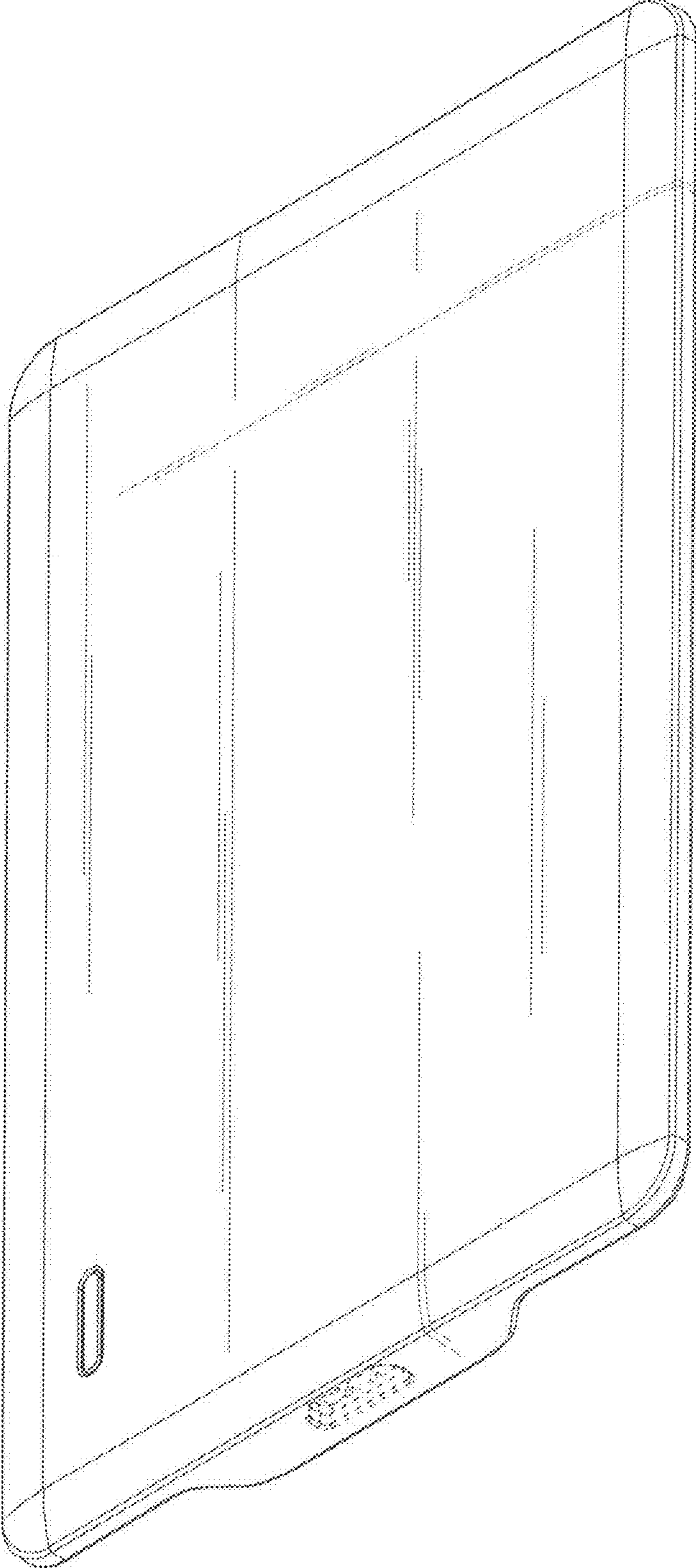

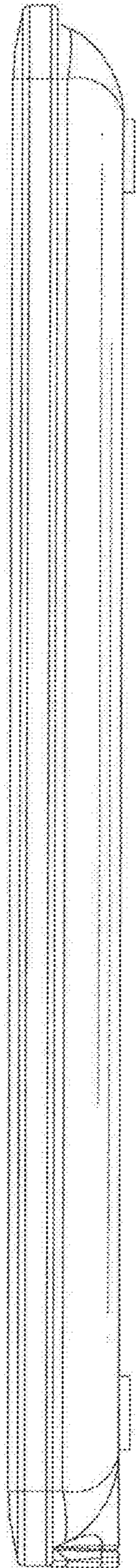

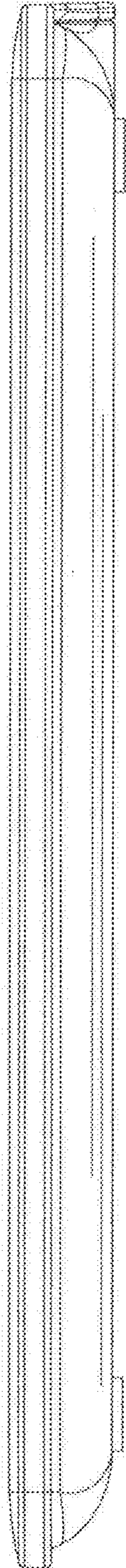

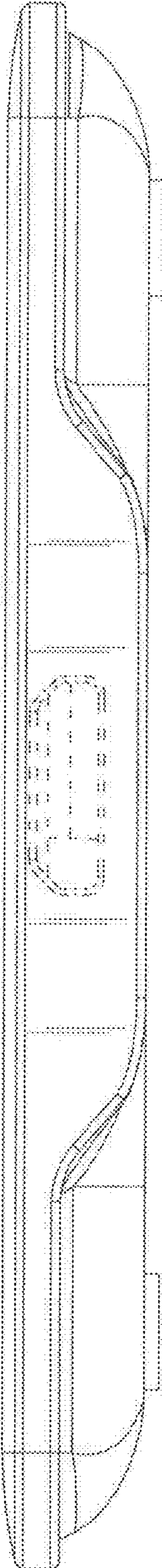

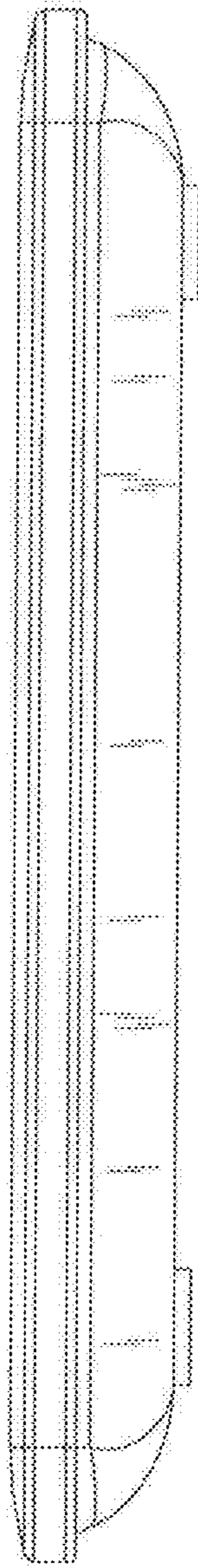

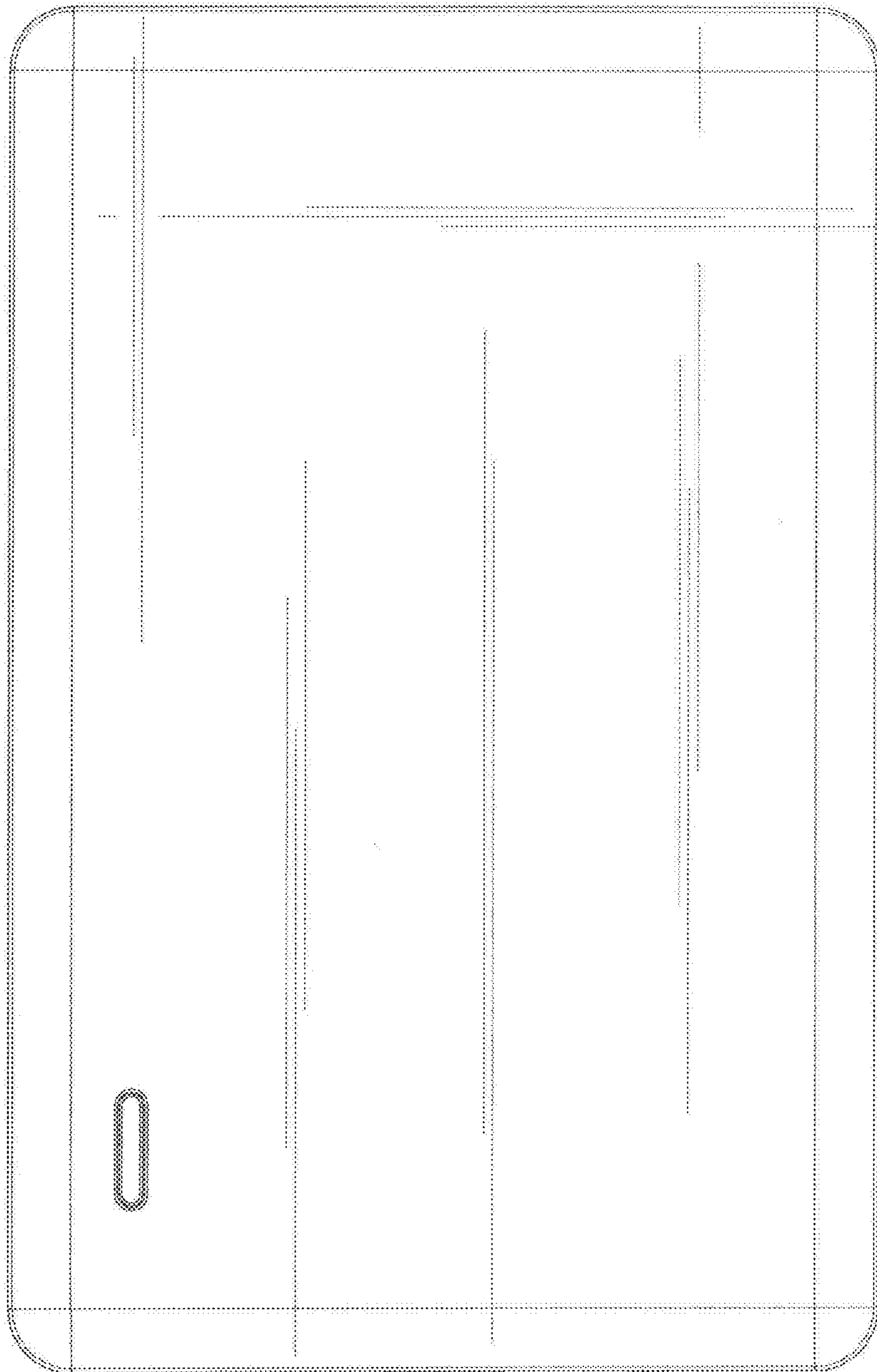
