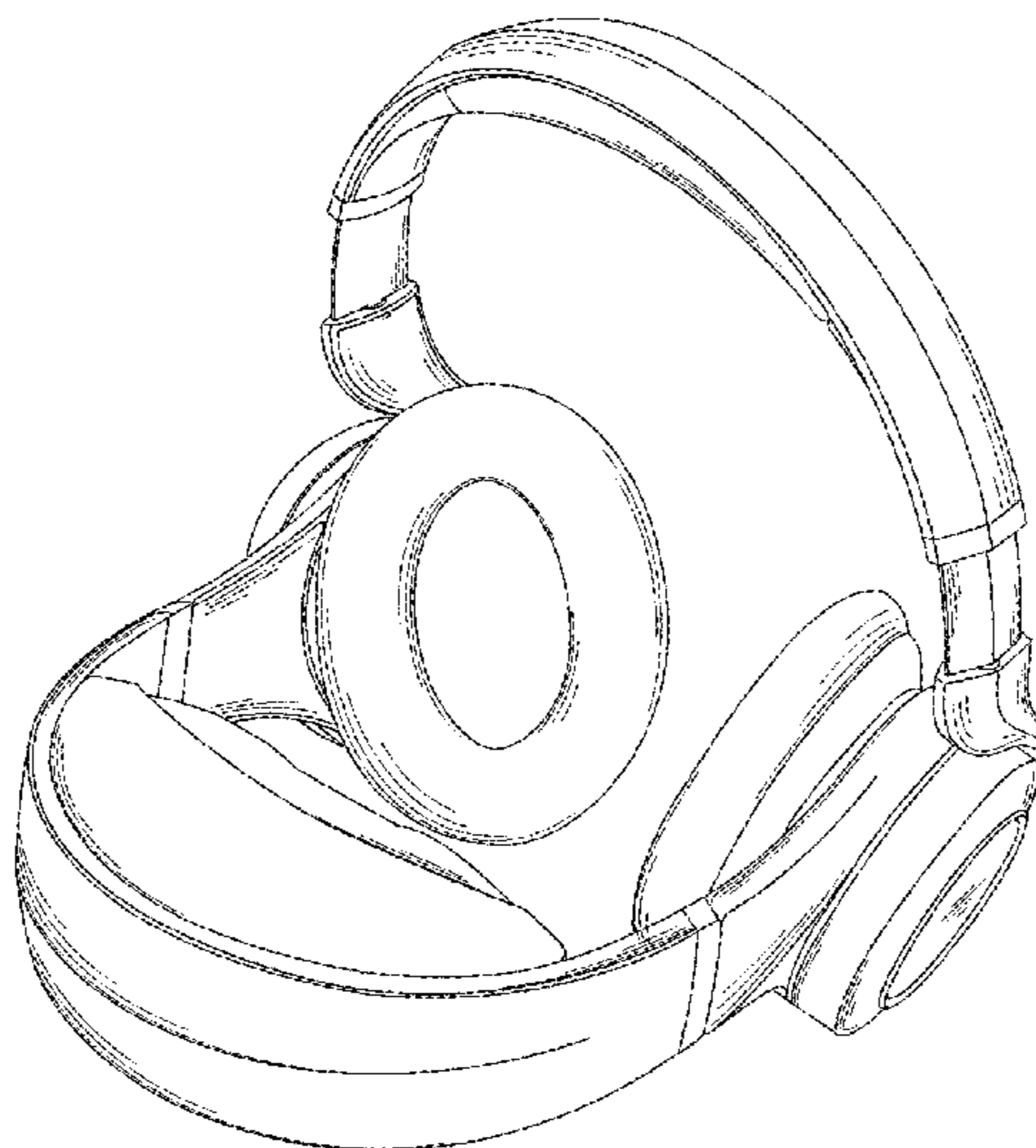
FIG. 8 is a front side perspective view of the head mounted display device in a second state depicted in FIG. 1;

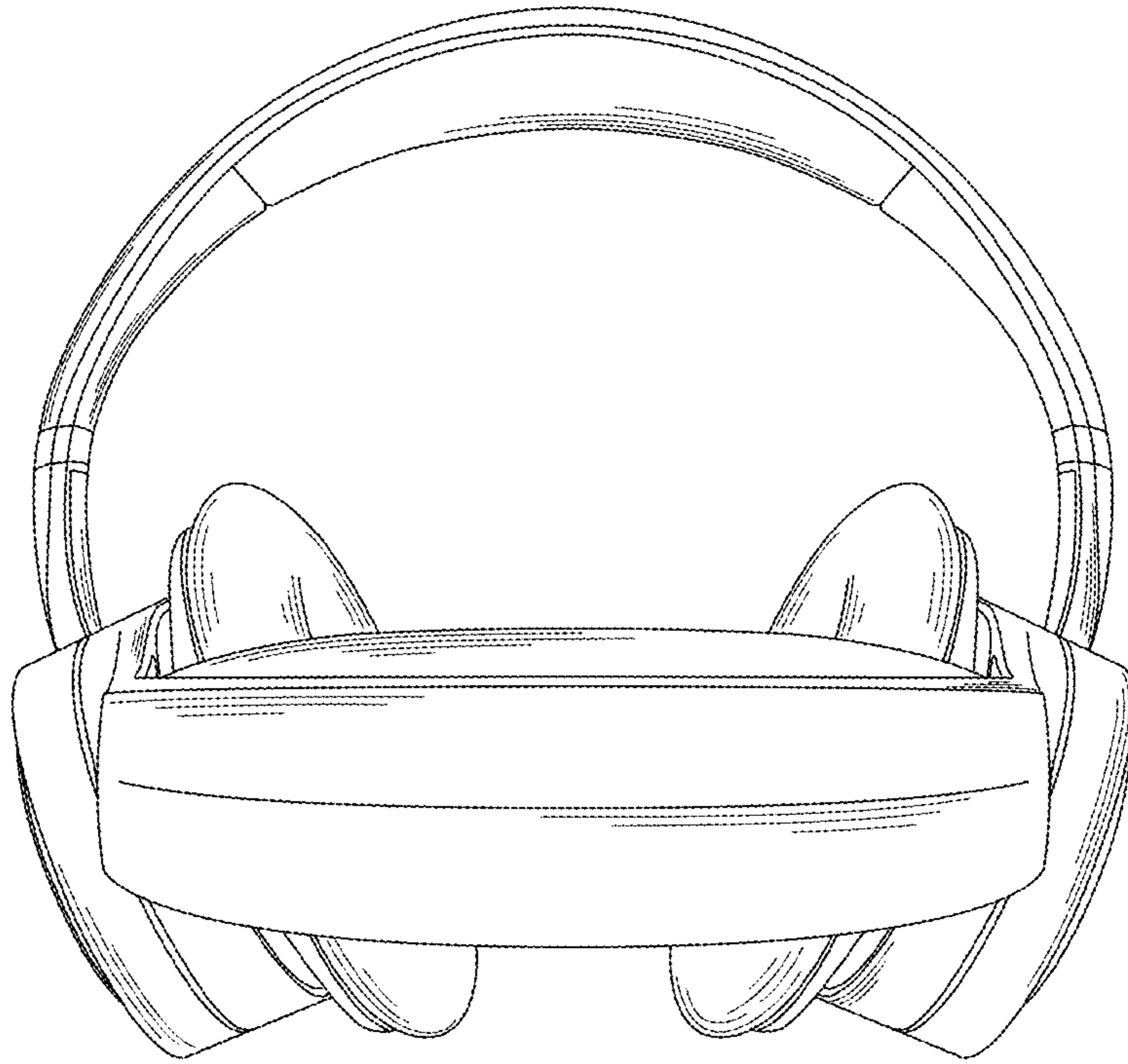

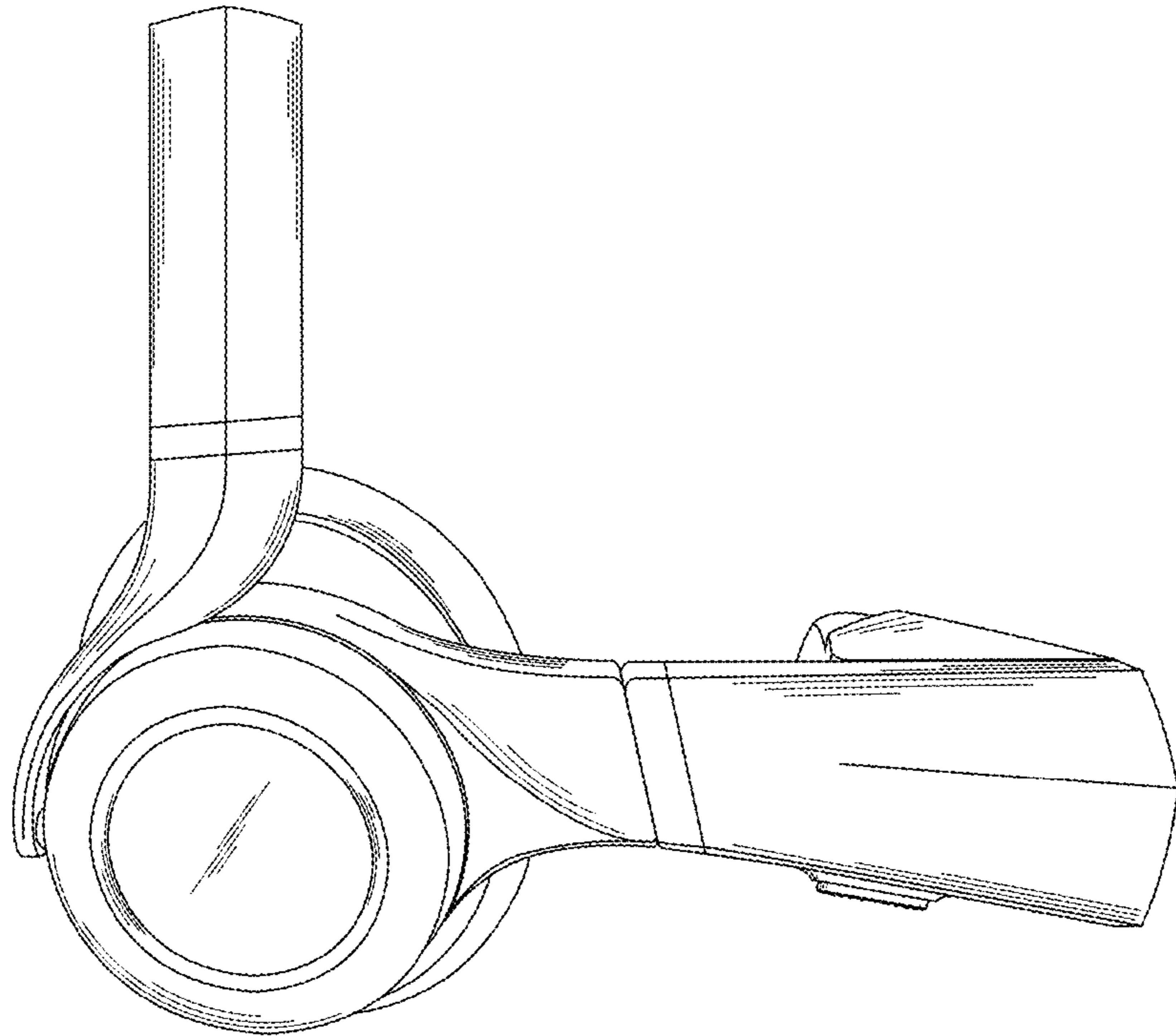

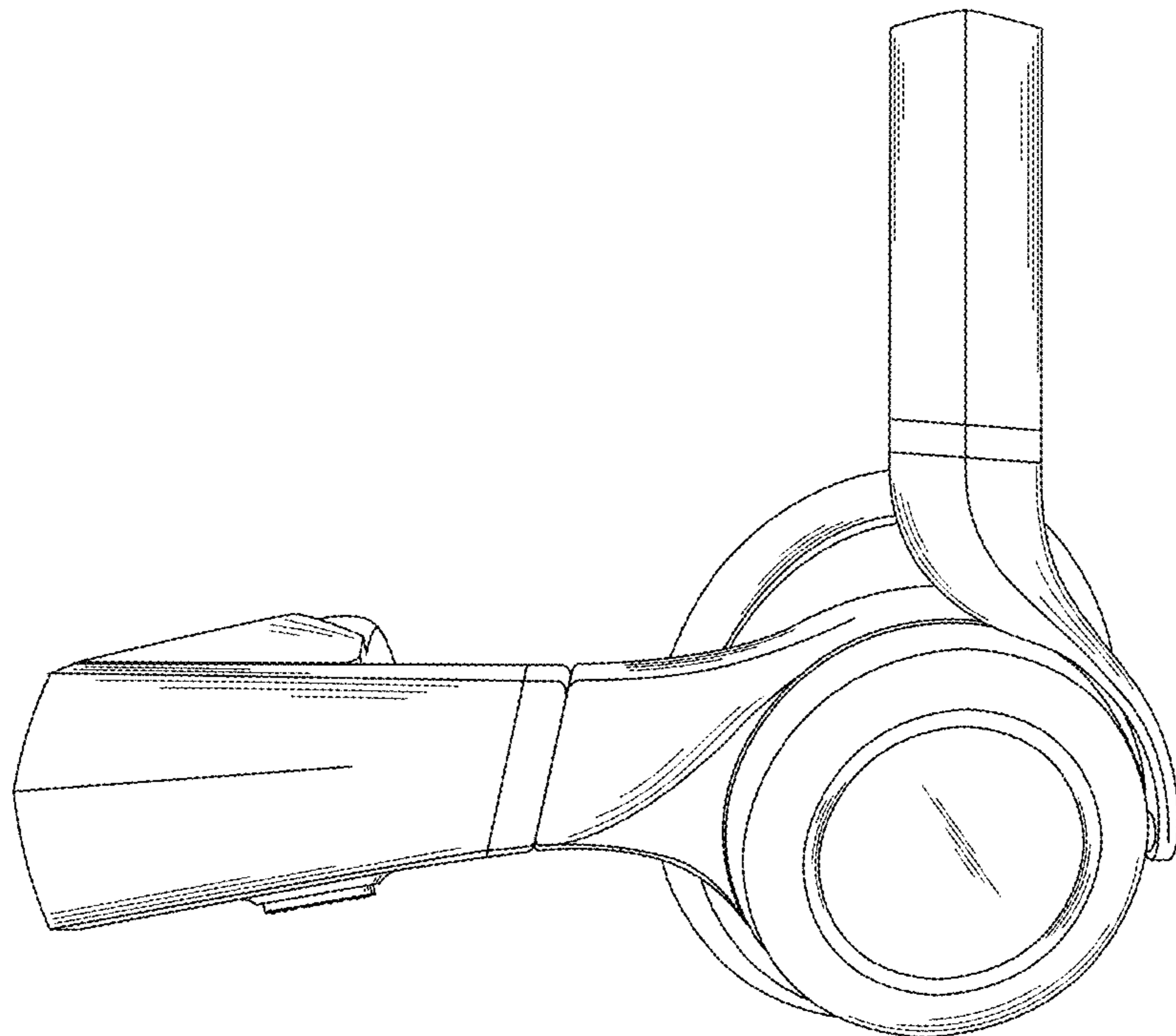

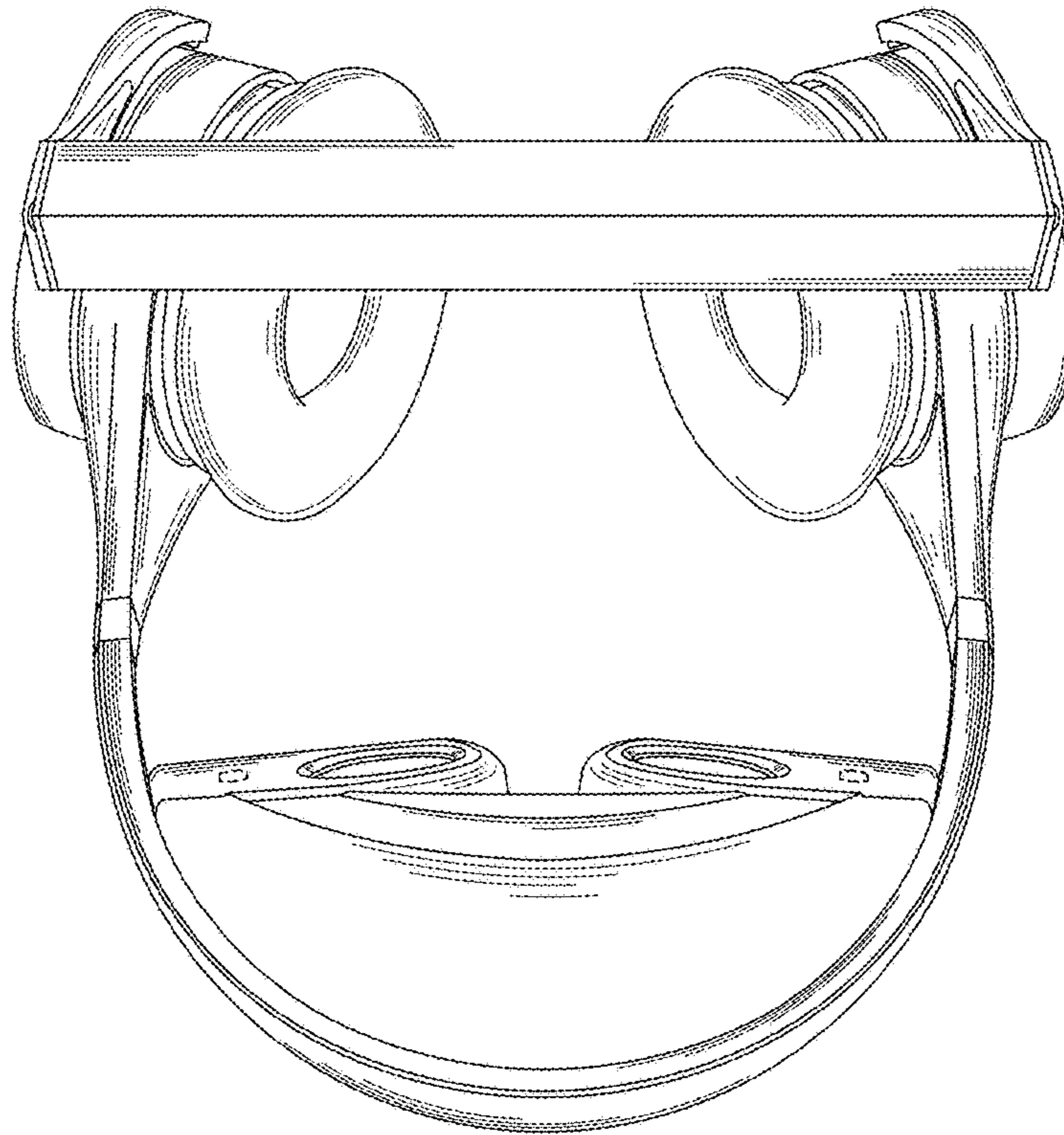

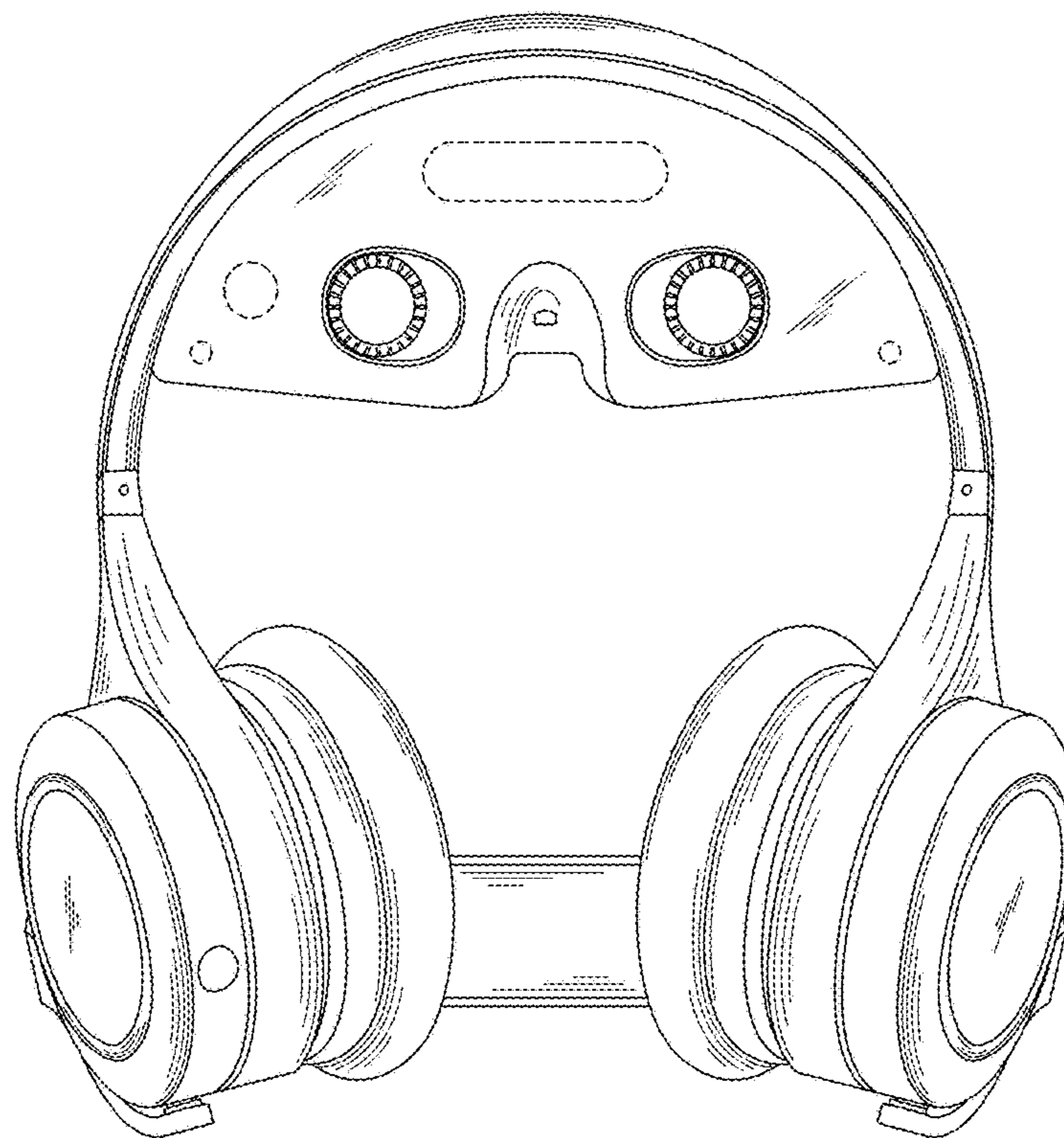

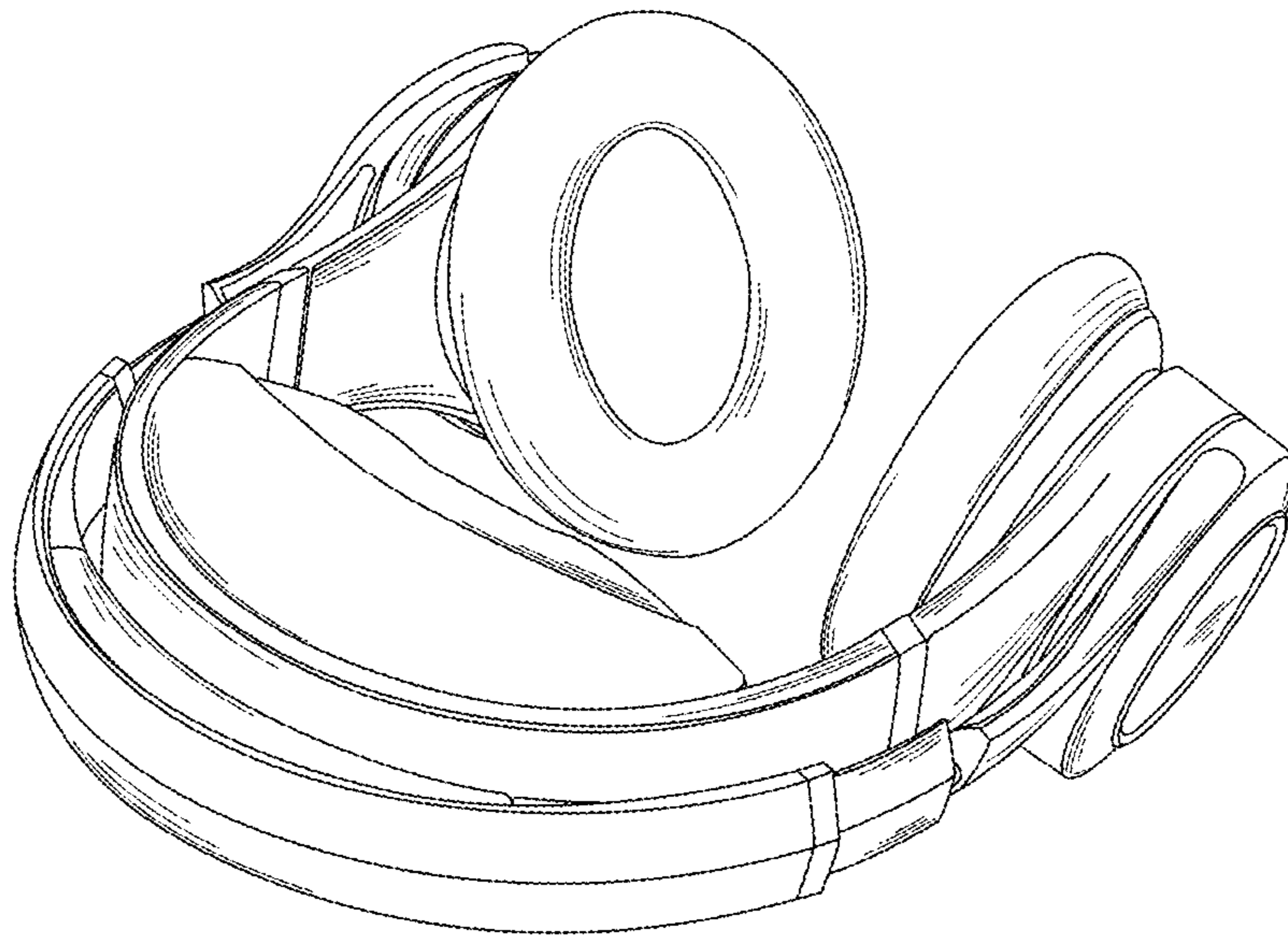

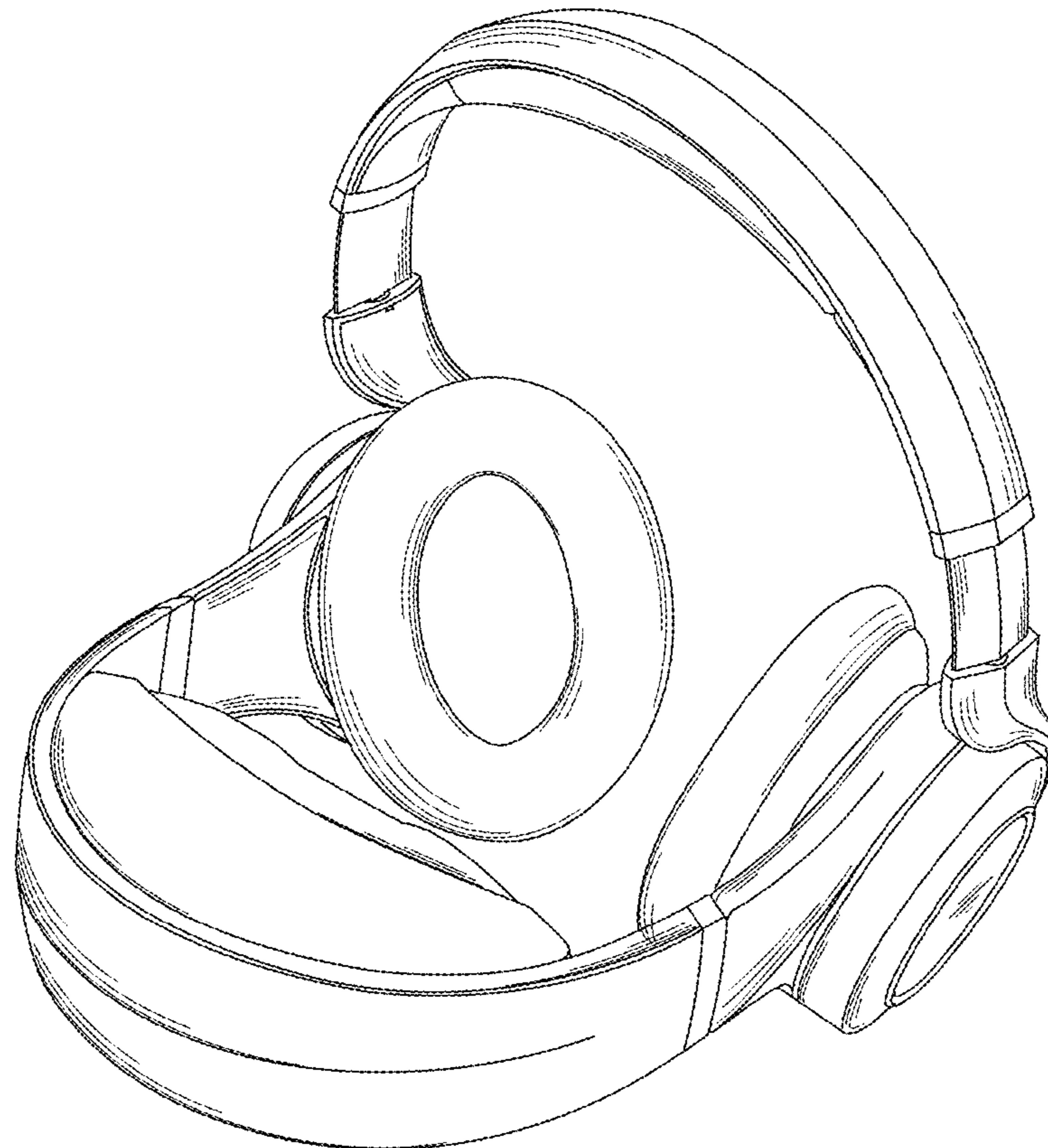

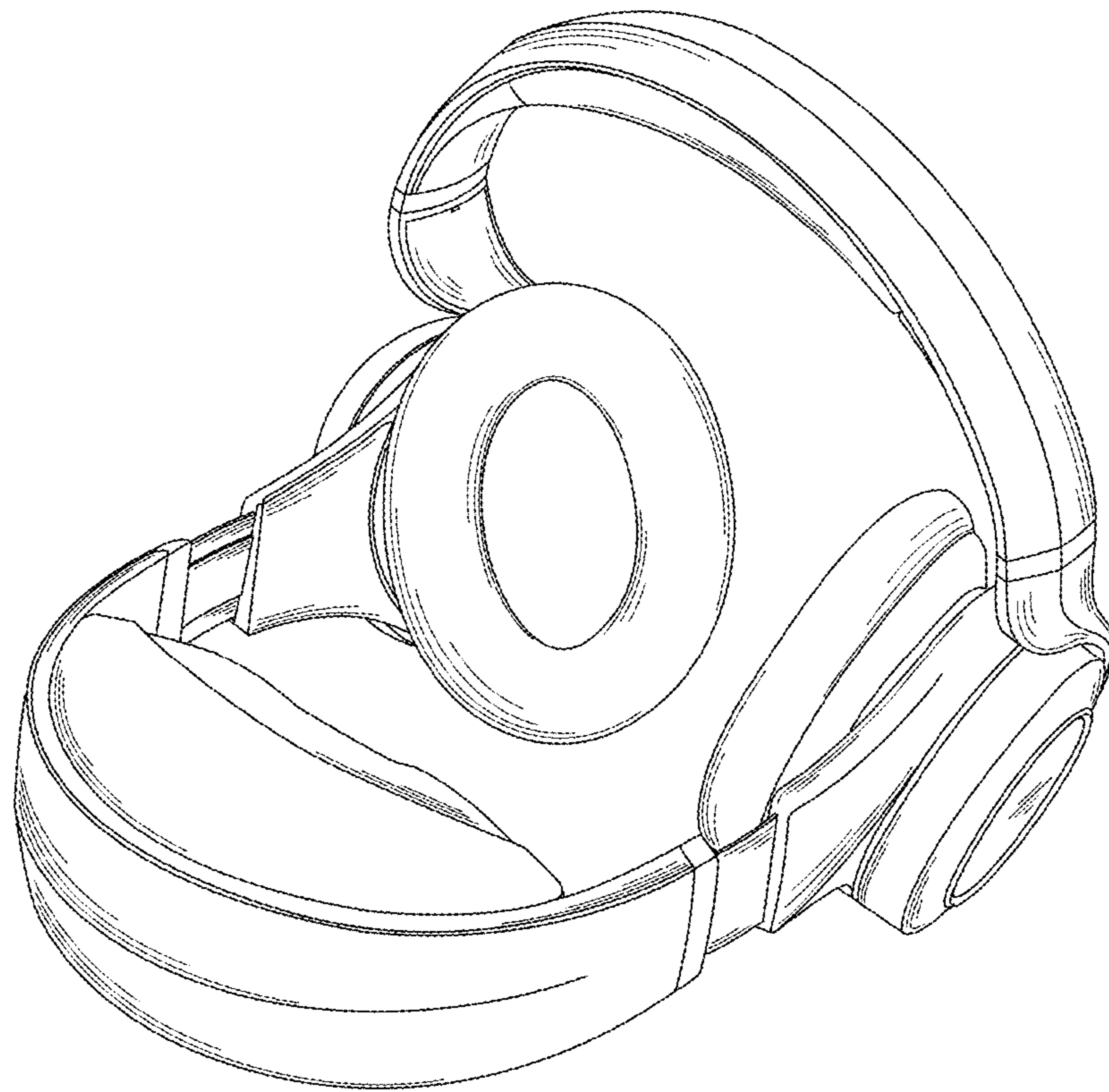
