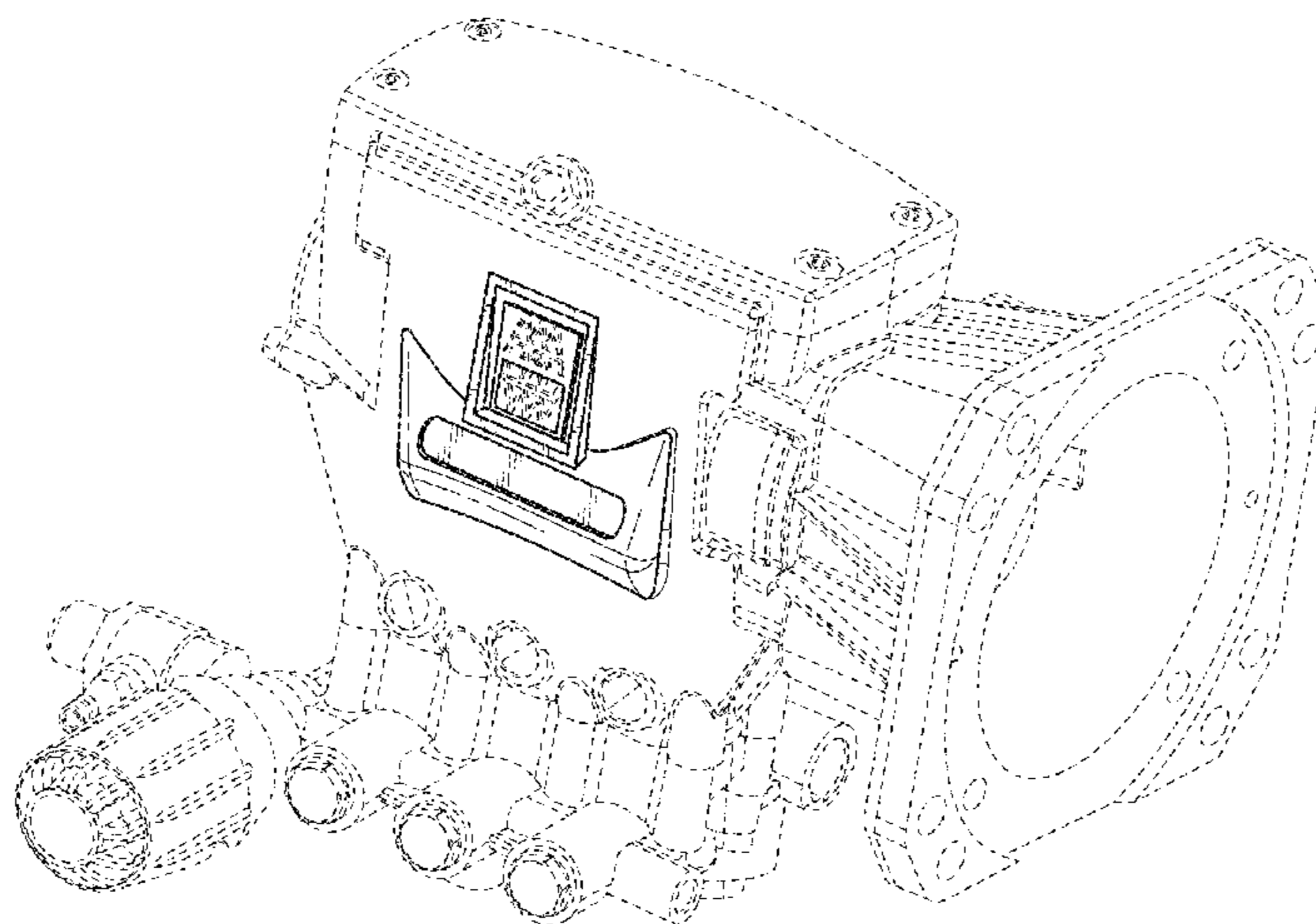
(57) **CLAIM**

The ornamental design for a pressure washer pump case, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-front perspective view of a pressure washer pump case;  
 FIG. 2 is a front elevation view thereof;  
 FIG. 3 is an enlarged top-front perspective view of a portion thereof;  
 FIG. 4 is a bottom plan view thereof; and,  
 FIG. 5 is a left side elevation view thereof.  
 The broken lines are included for the purpose of illustrating portions of the pressure washer pump case that form no part of the claimed design.

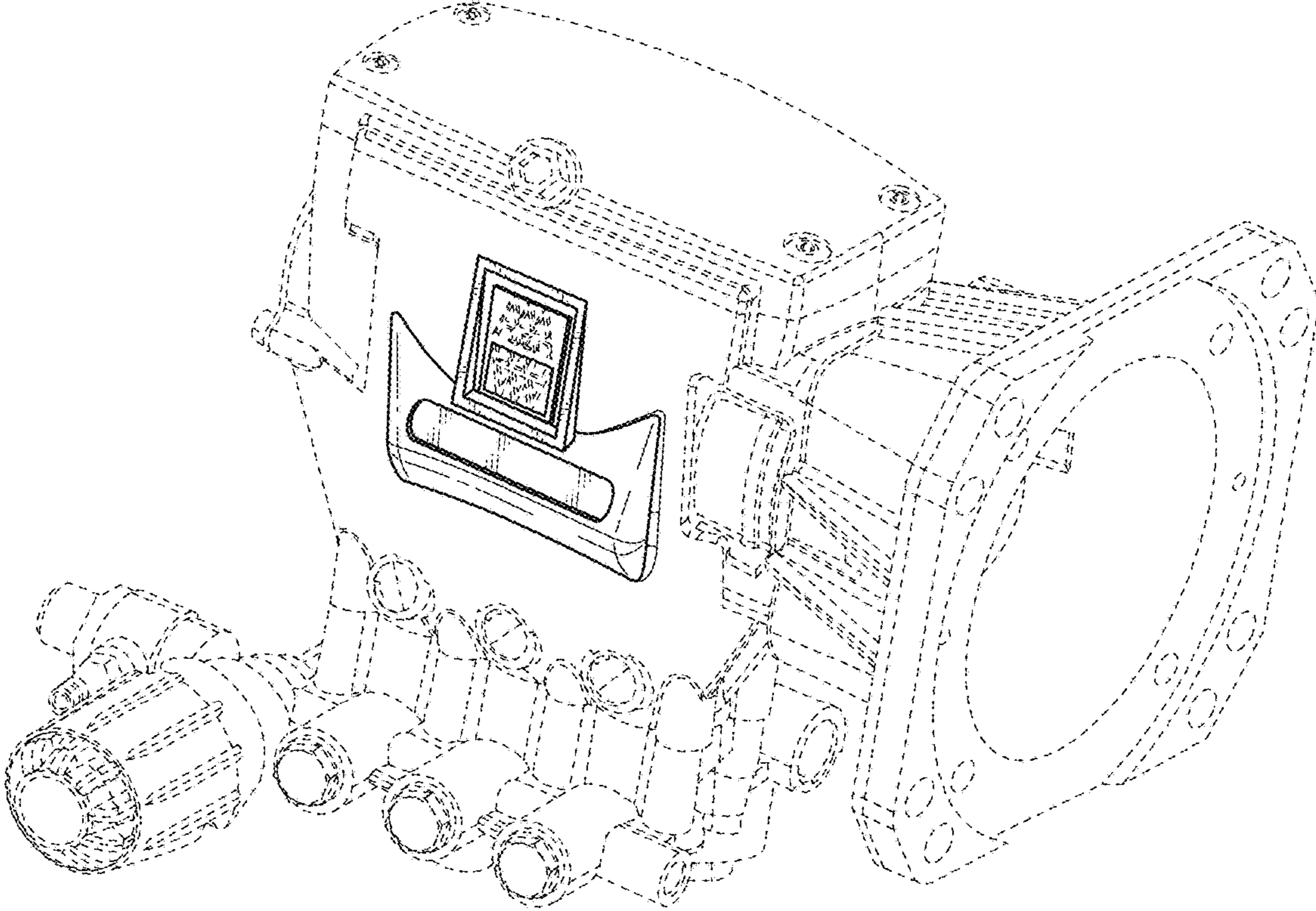

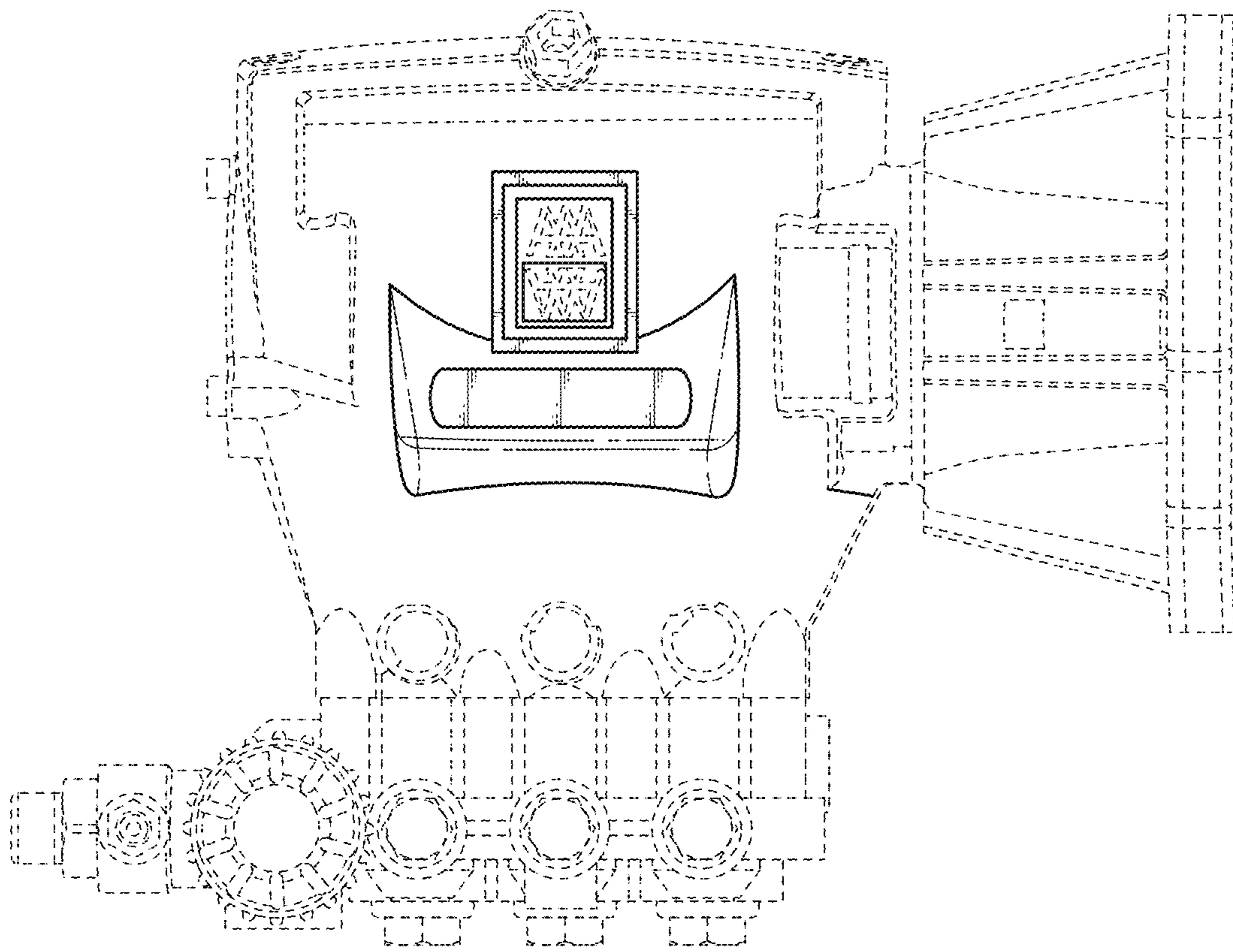

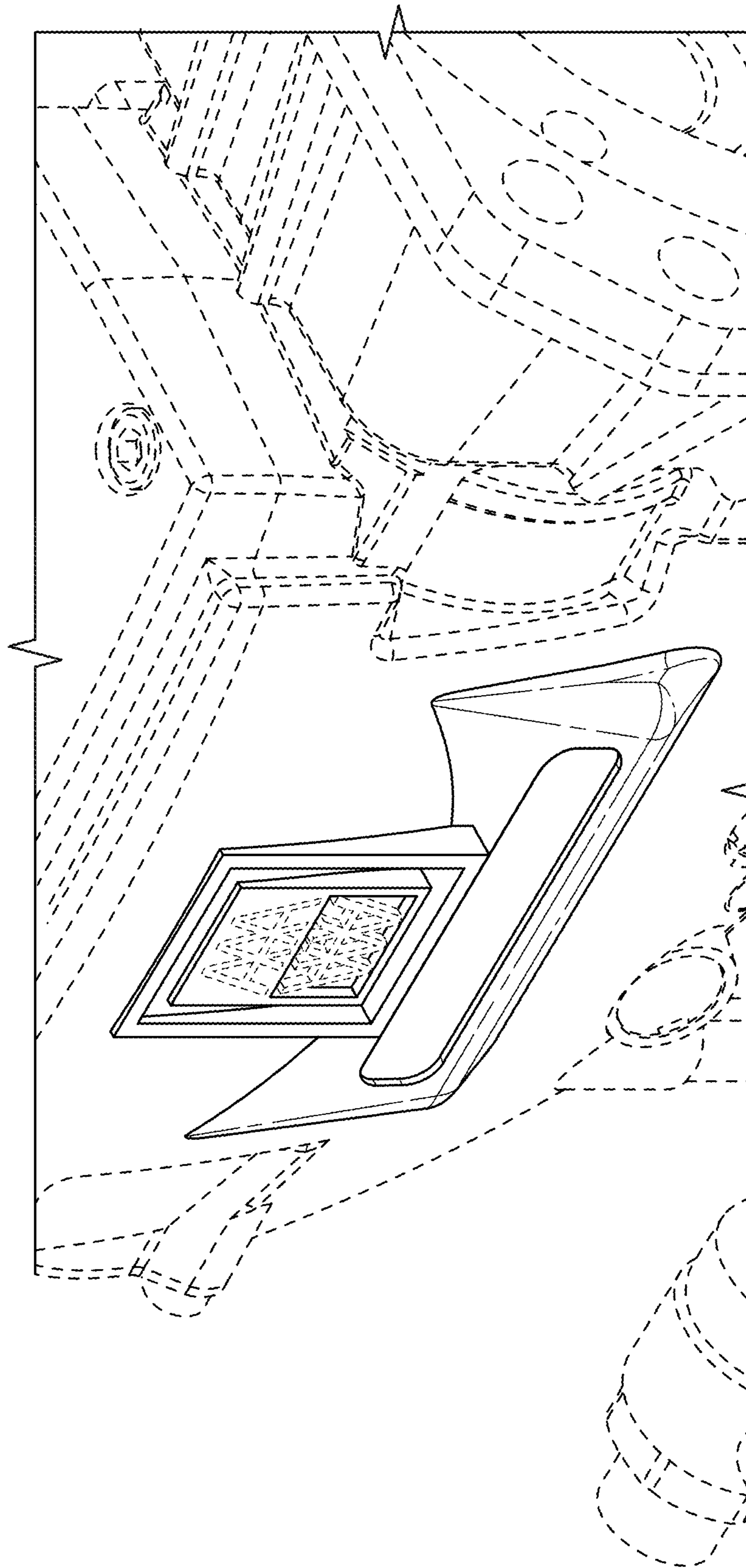

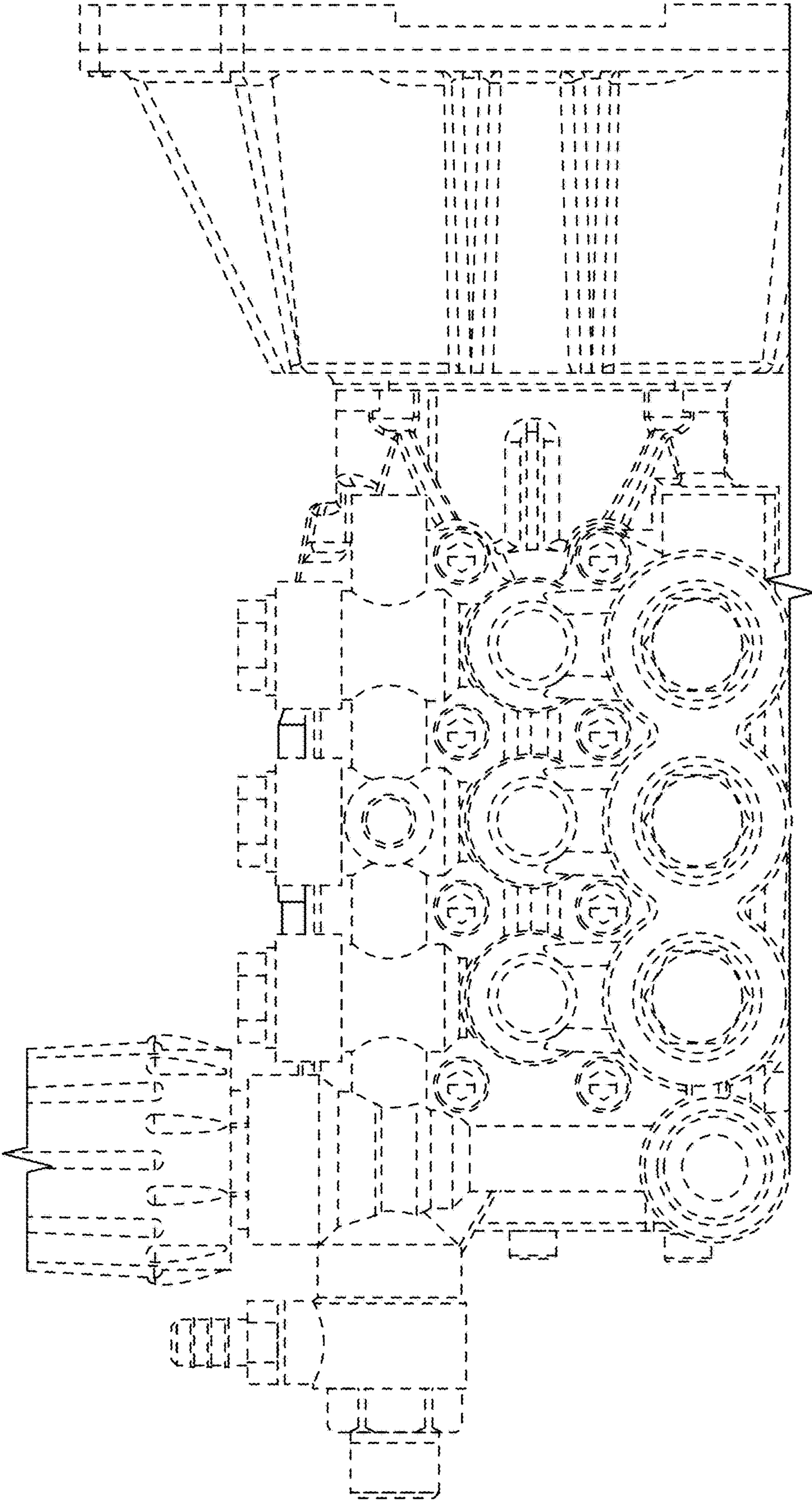

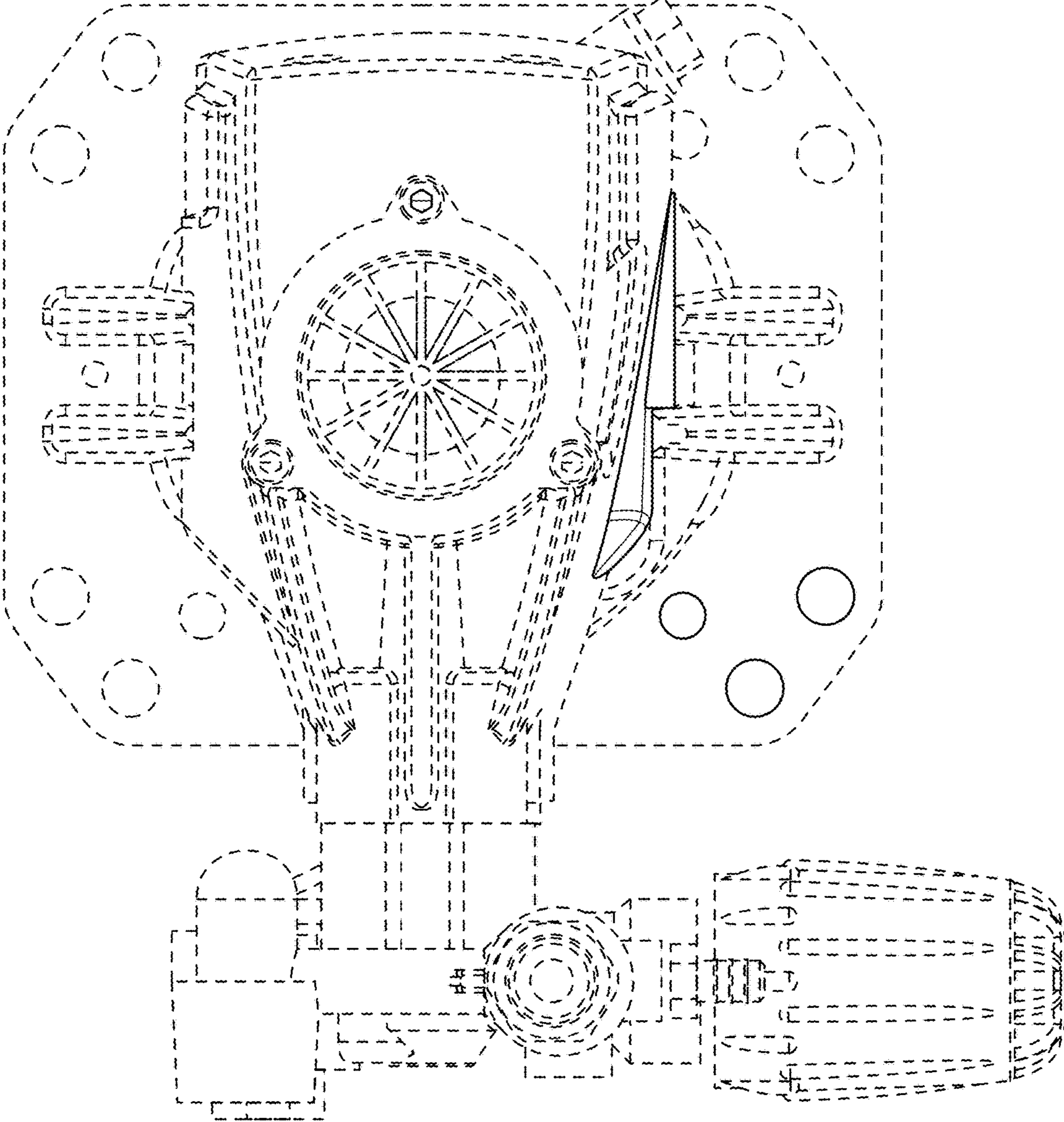
