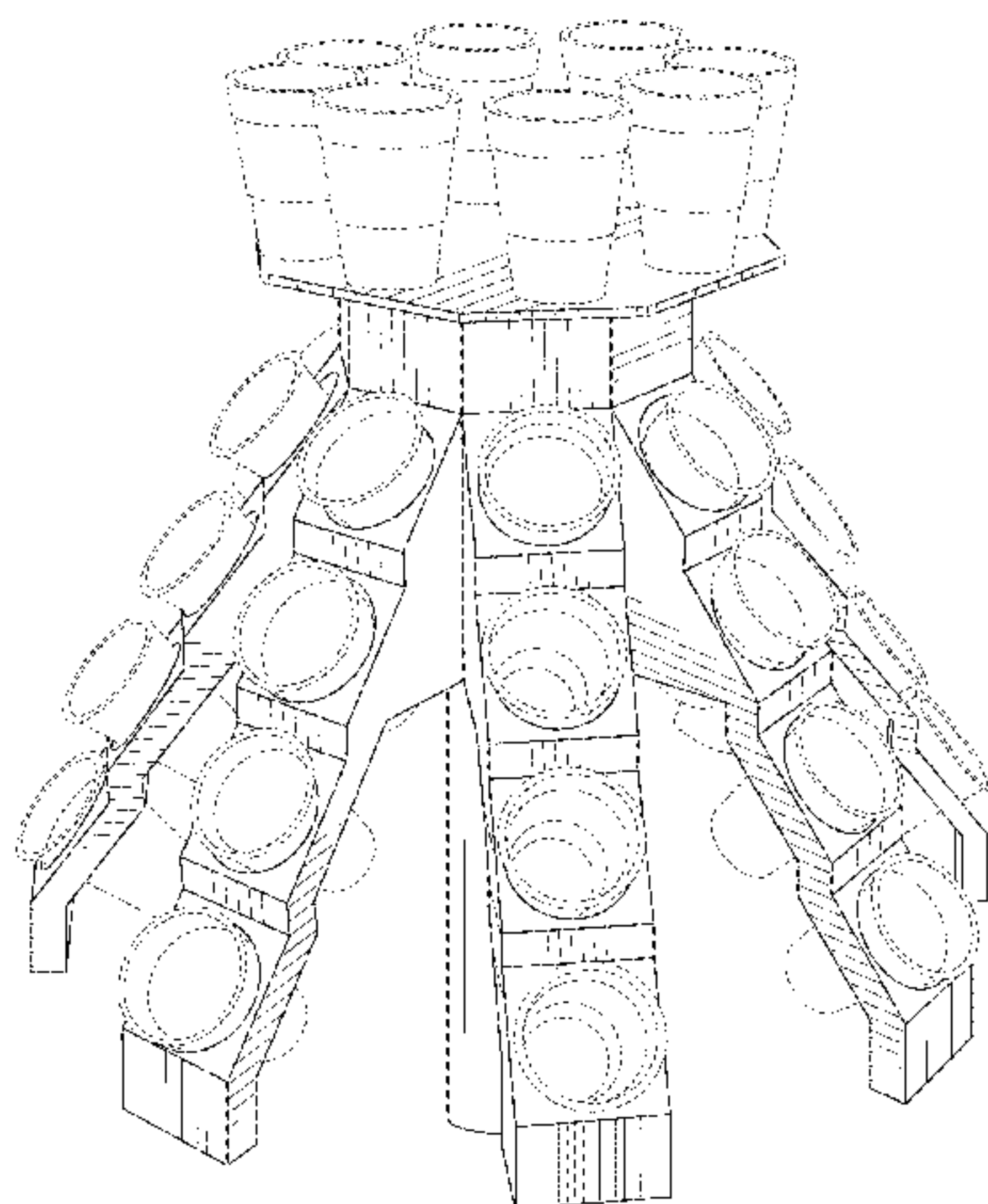

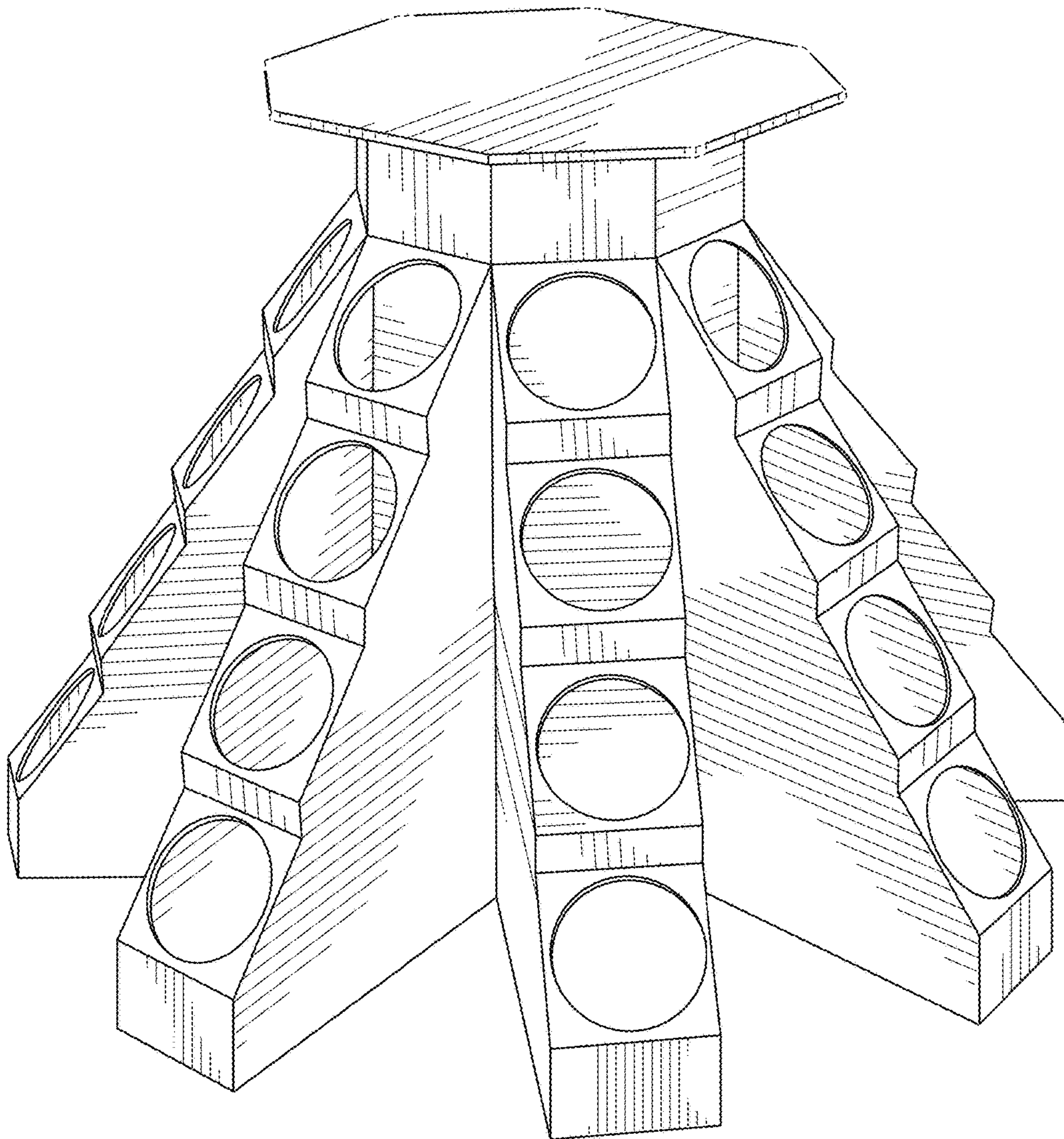

## (57) CLAIM

The ornamental design for a beverage pong game board, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view of a beverage pong game board according to my new design;  
 FIG. 2 is a front elevational view of the beverage pong game board, the back, right, and left elevational views being identical in shape and appearance;  
 FIG. 3 is a top view of the beverage pong game board;  
 FIG. 4 is a bottom view of the beverage pong game board;  
 FIG. 5 is a front perspective view of a second embodiment of the beverage pong game board, shown in use;  
 FIG. 6 is a front perspective view of the beverage pong game board of FIG. 5;  
 FIG. 7 is a front elevational view of the beverage pong game board of FIG. 5, the back, right and left elevational views being identical in shape and appearance;  
 FIG. 8 is a top view thereof; and,  
 FIG. 9 is a bottom view thereof.  
 The broken lines visible in the top surface component of the beverage pong game board in both embodiments depict unclaimed features.  
 The broken line showing of cups in FIG. 5 illustratively depicts exemplary in-use elements, and forms no part of the design claim.

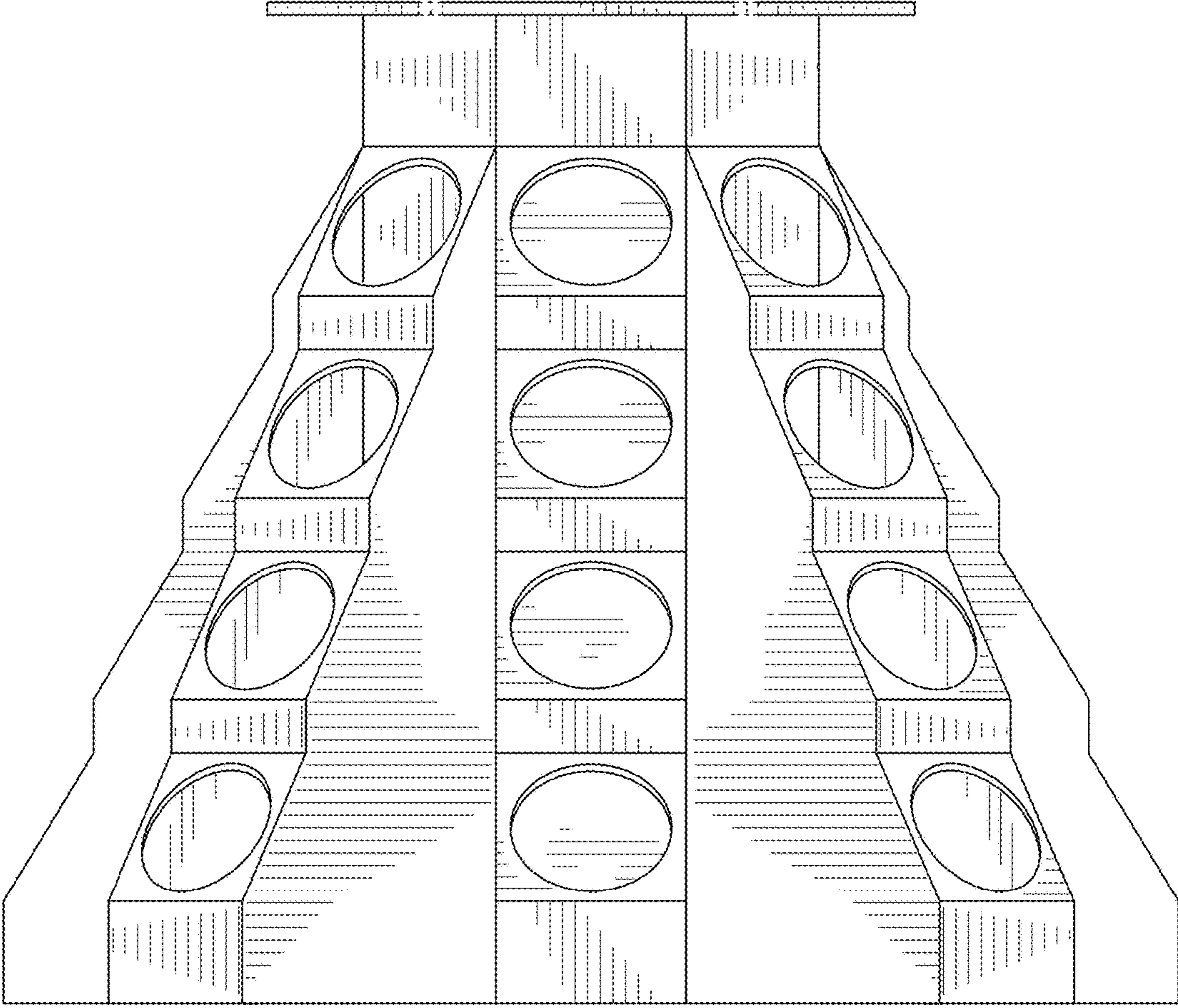

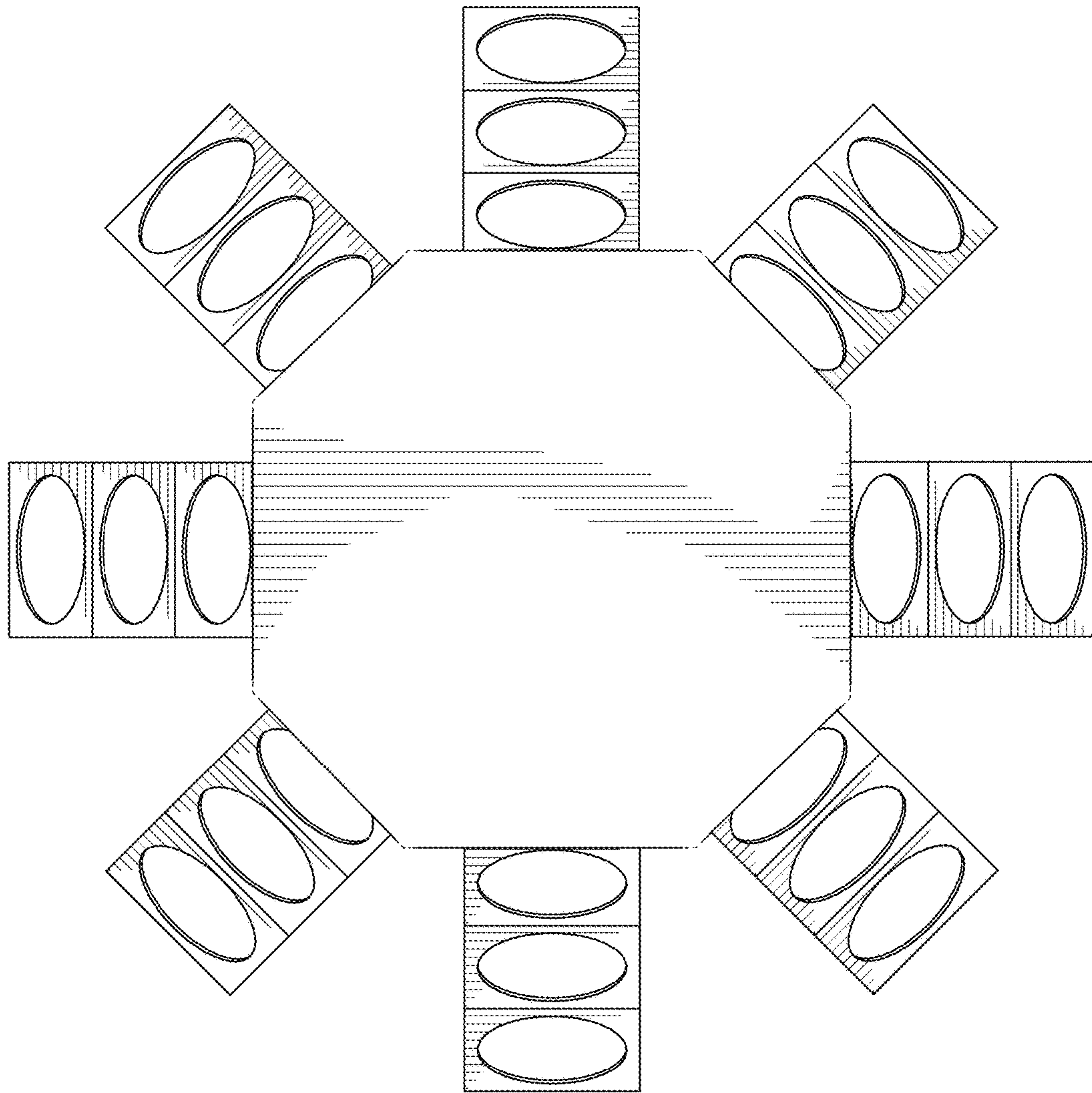

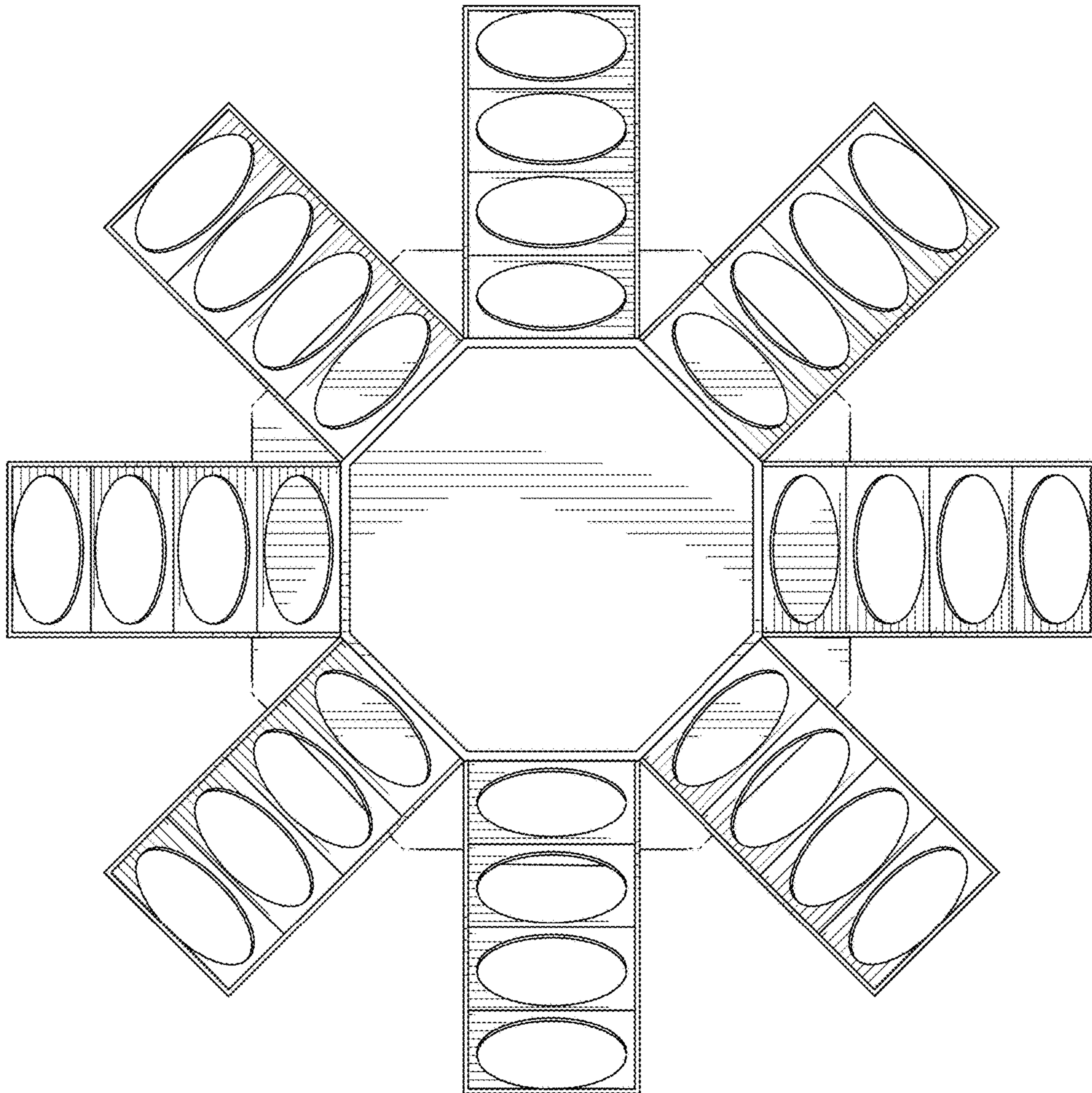

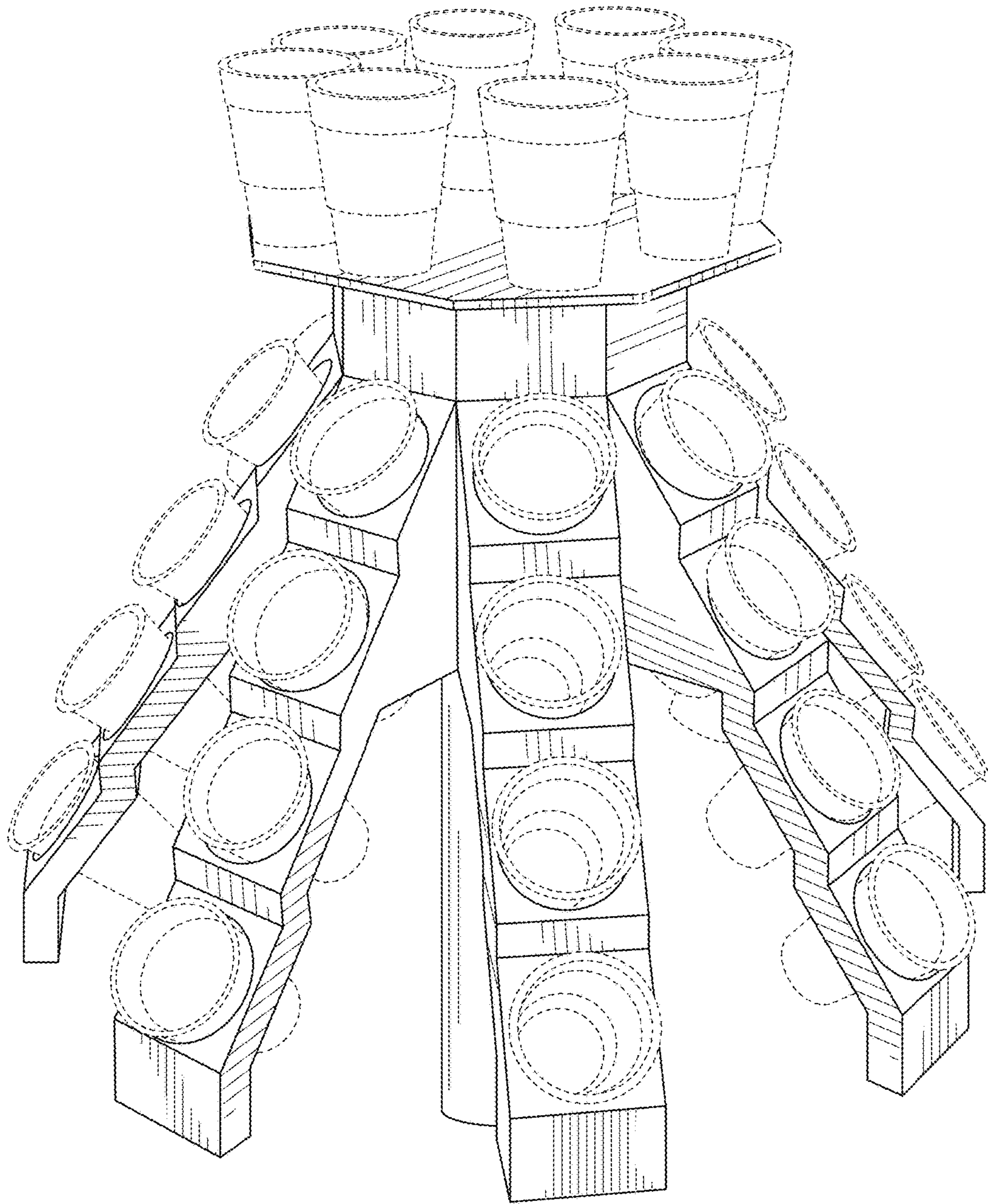

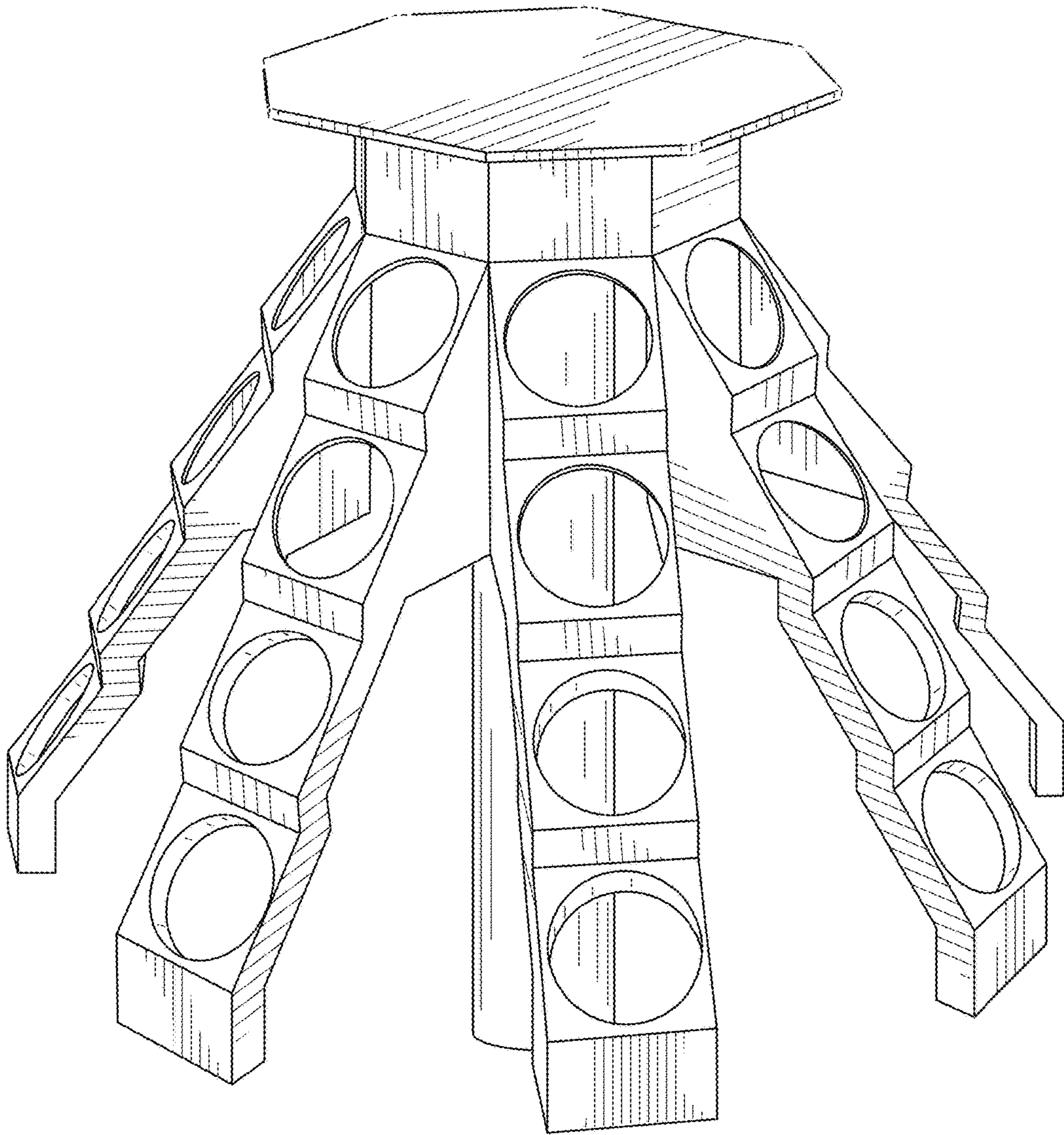

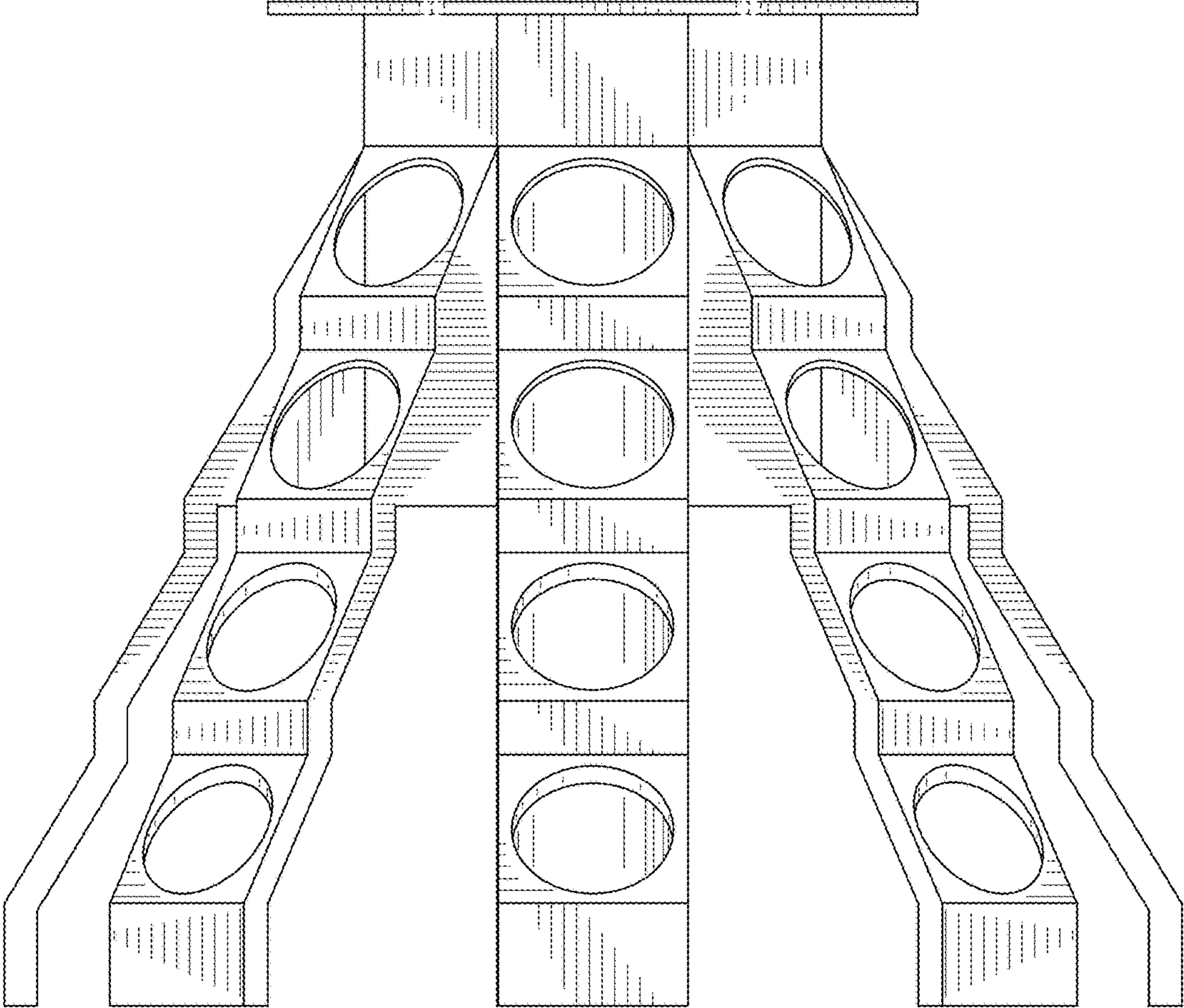

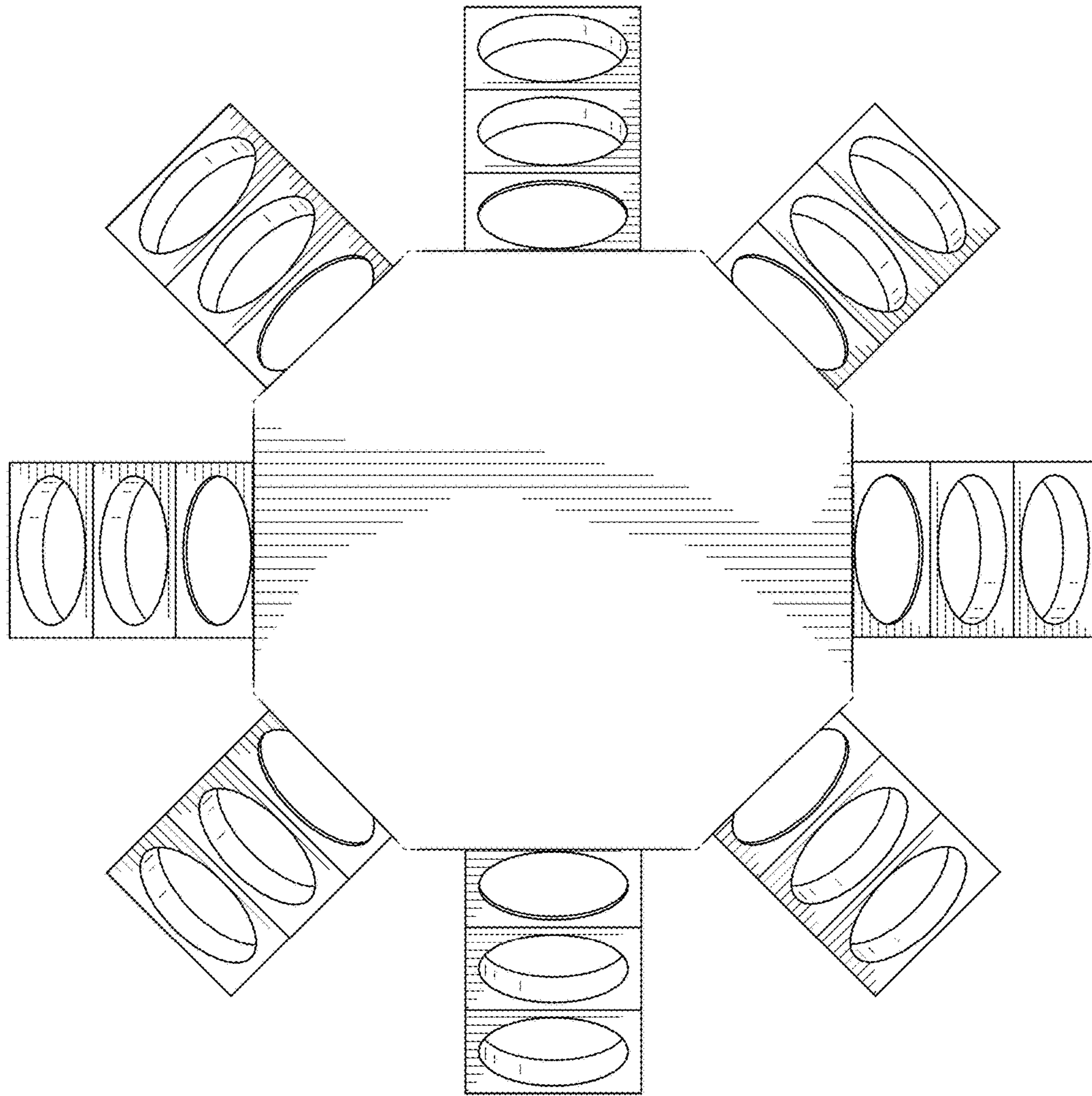

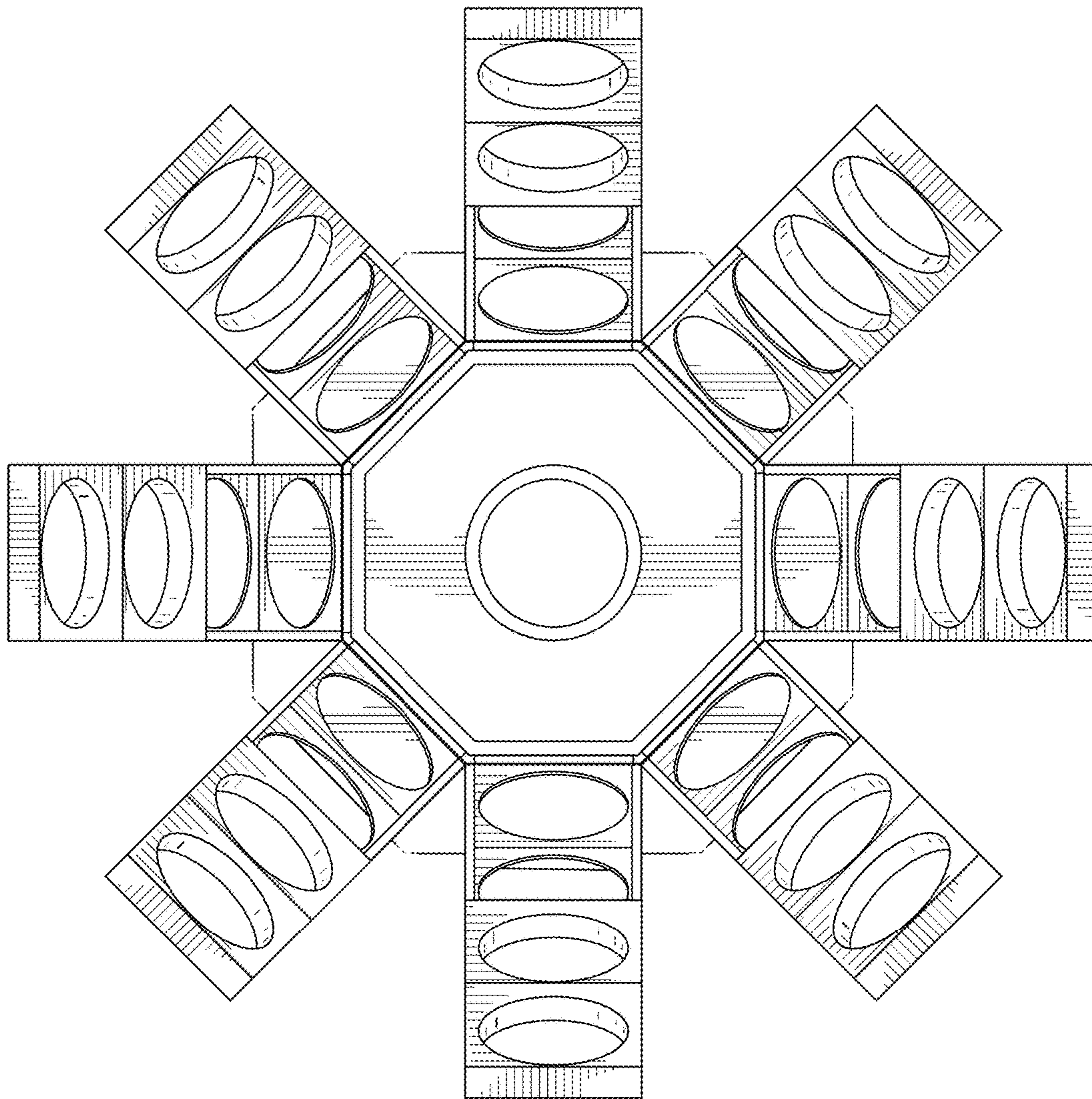
