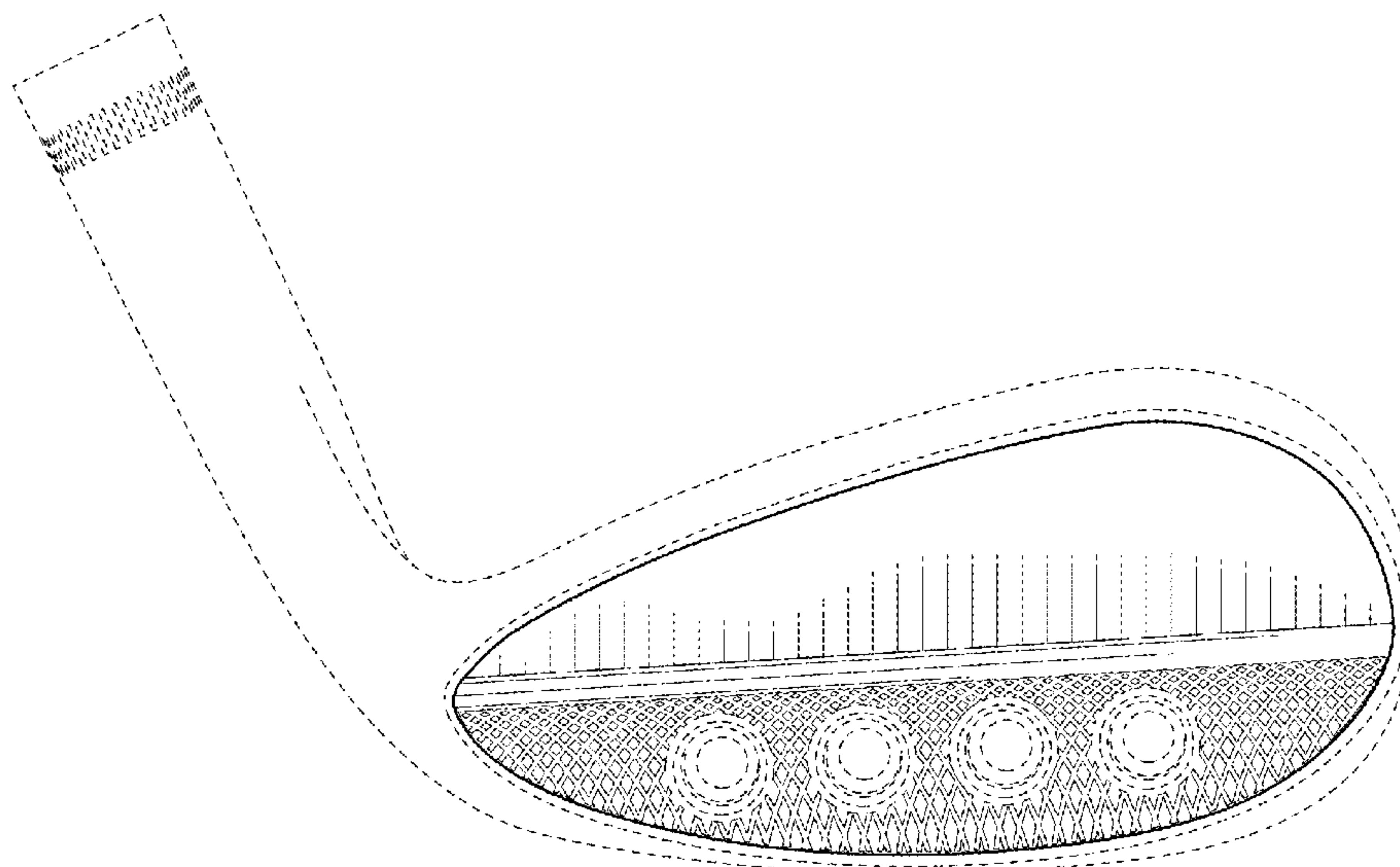
(57) **CLAIM**

The ornamental design for a golf club head, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of a first embodiment of the golf club head claimed herein;
FIG. 2 is a front elevational view thereof;

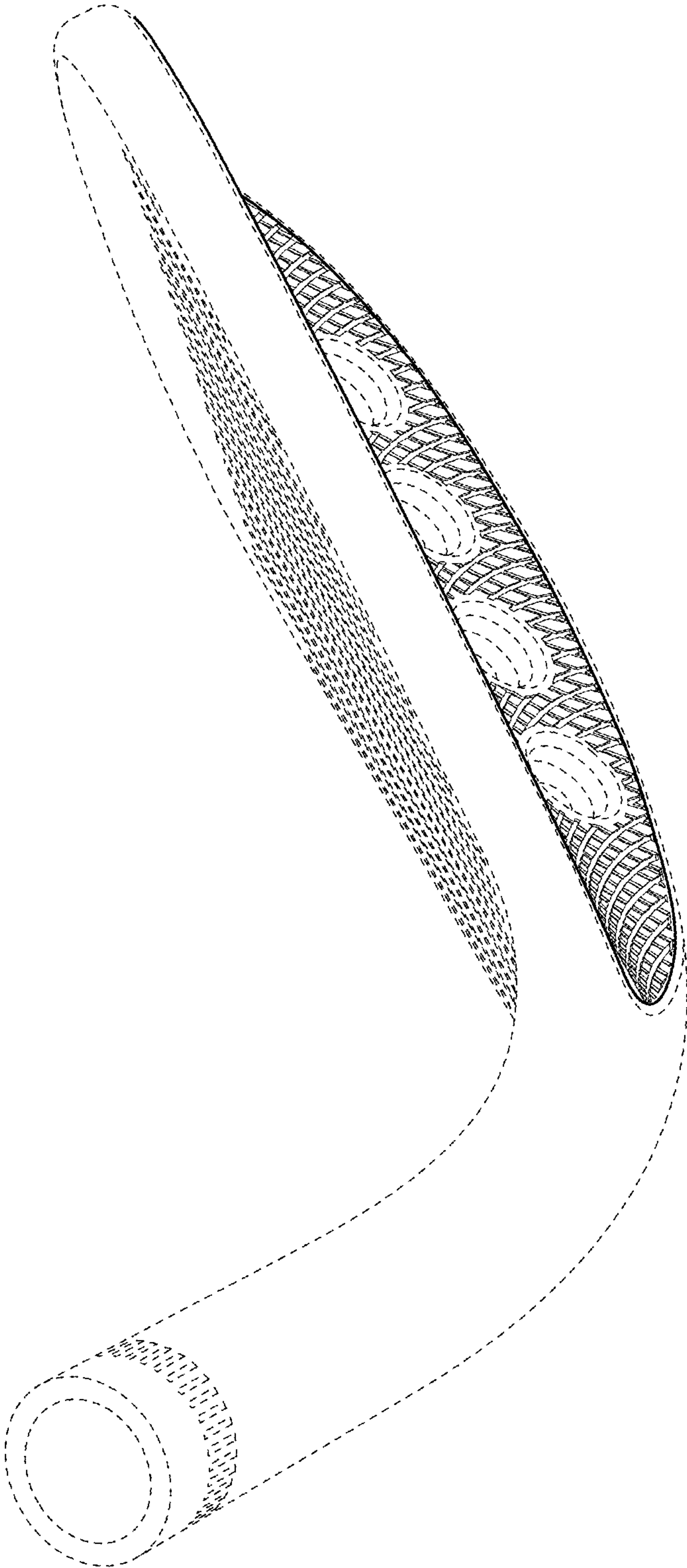

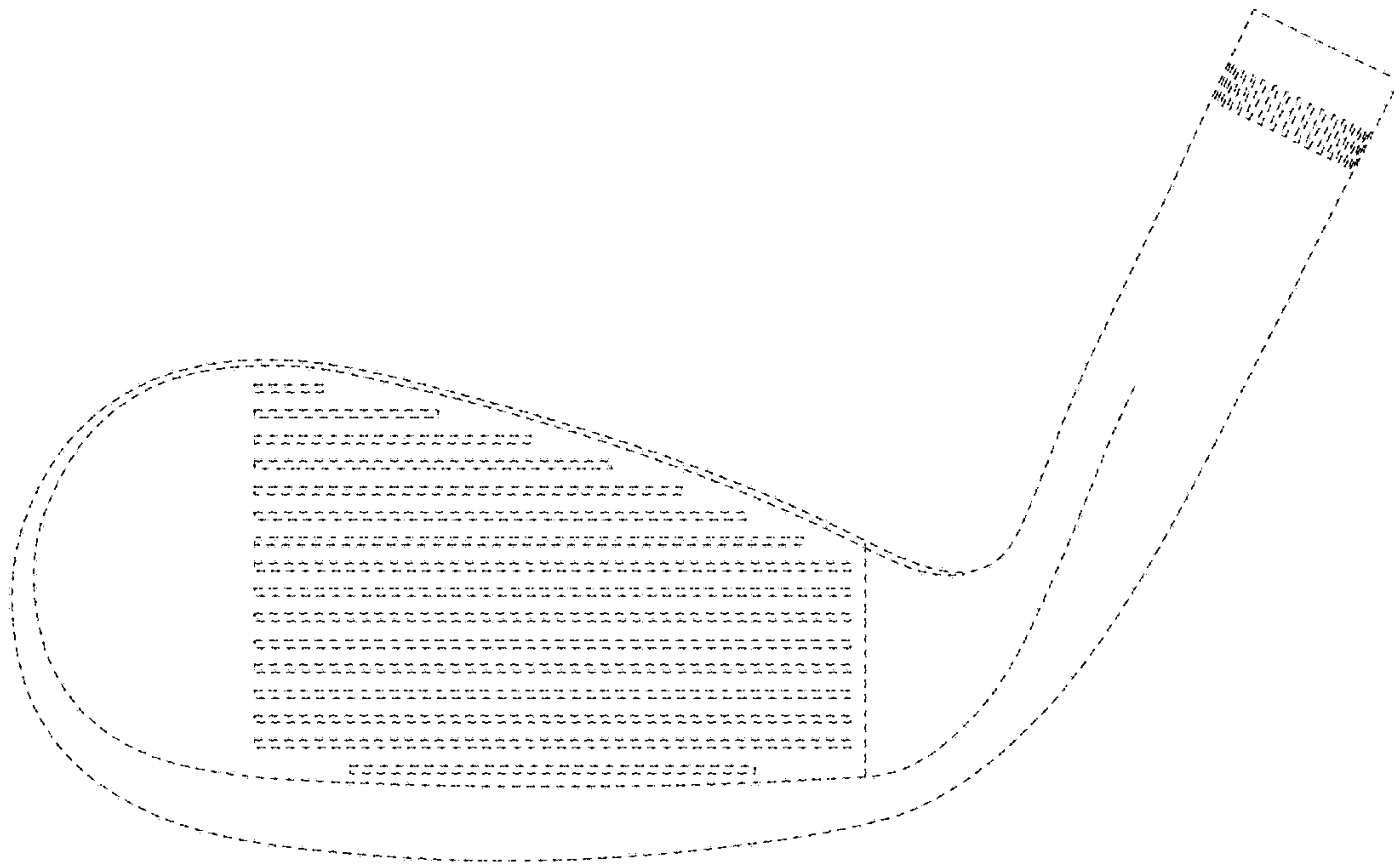

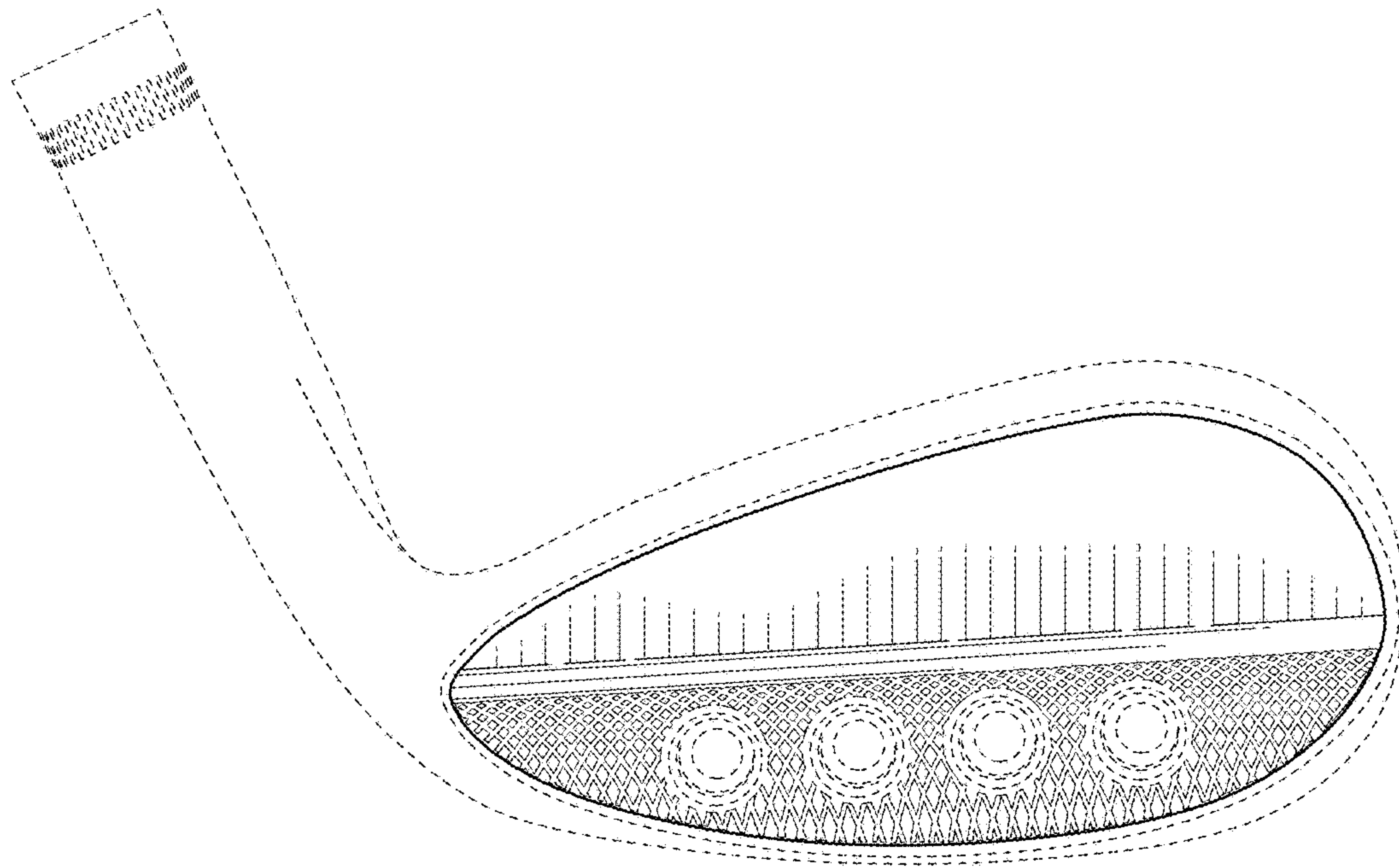

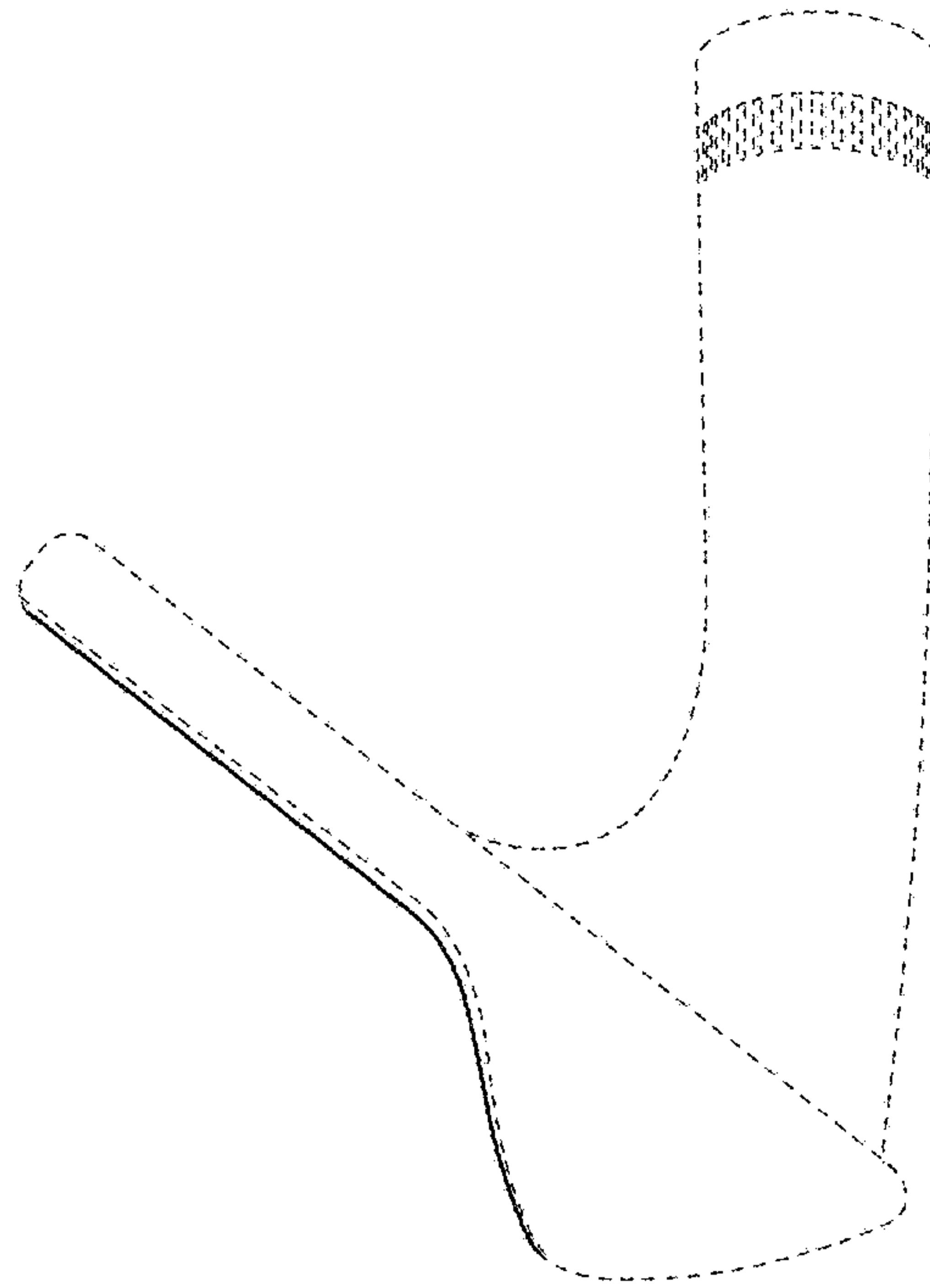

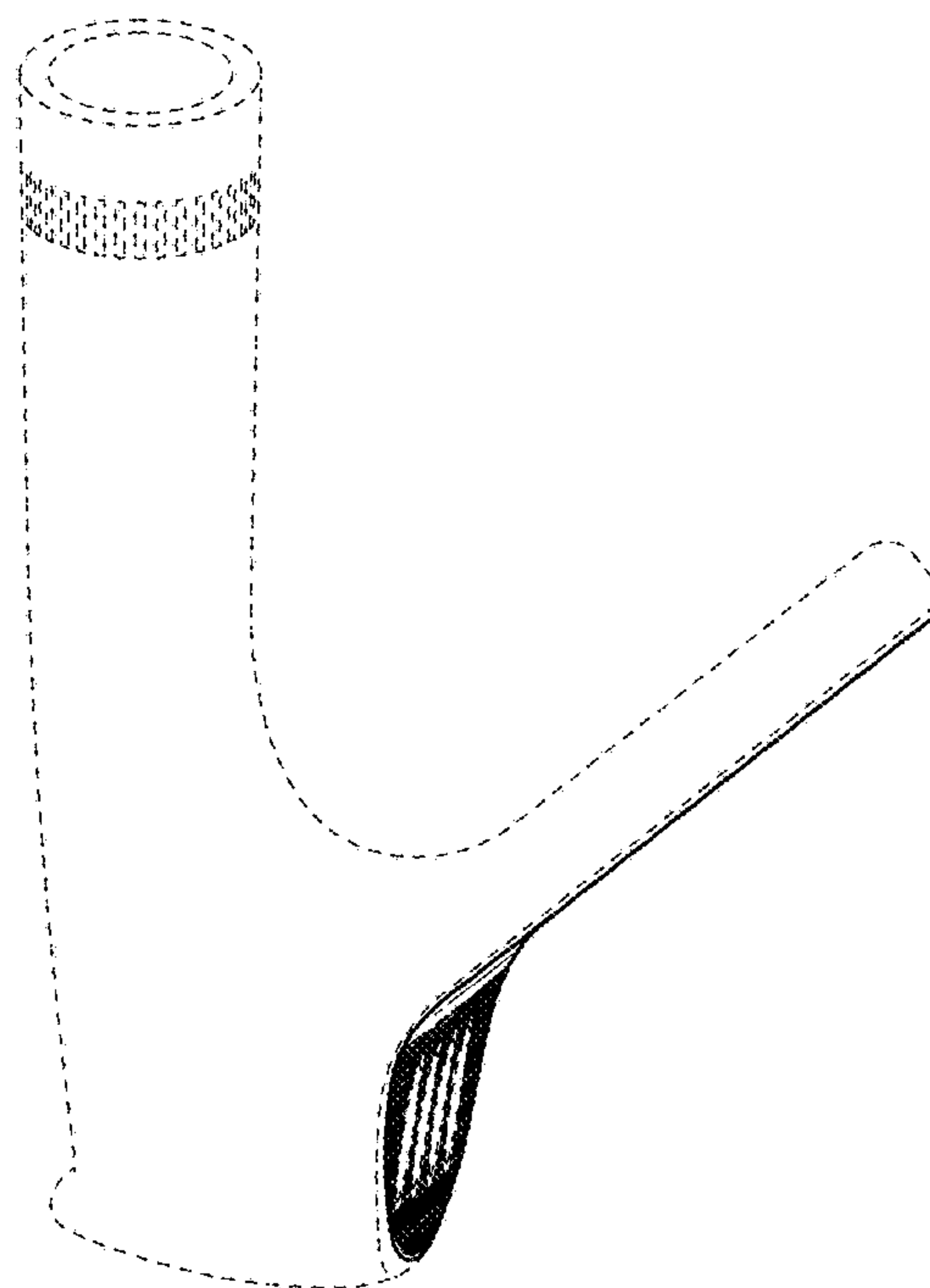

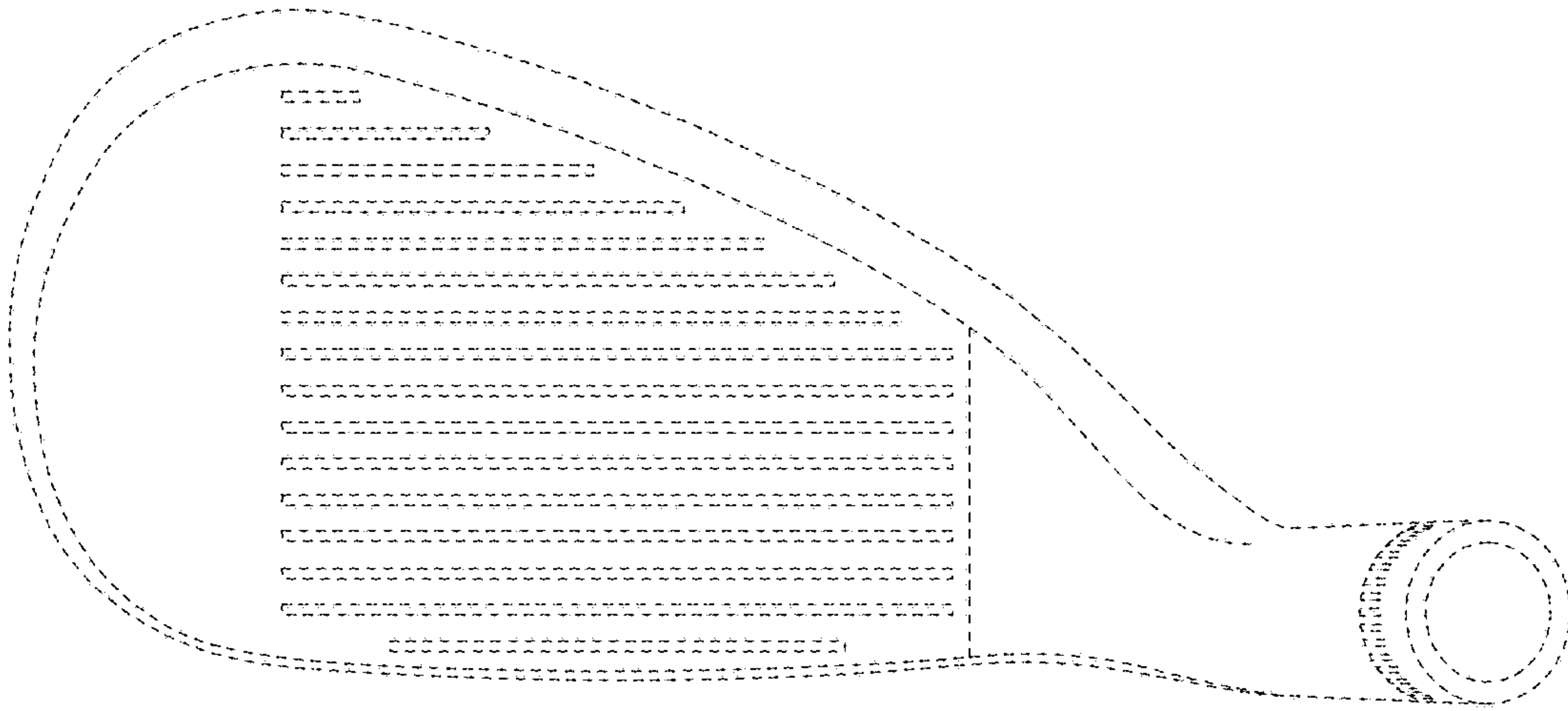

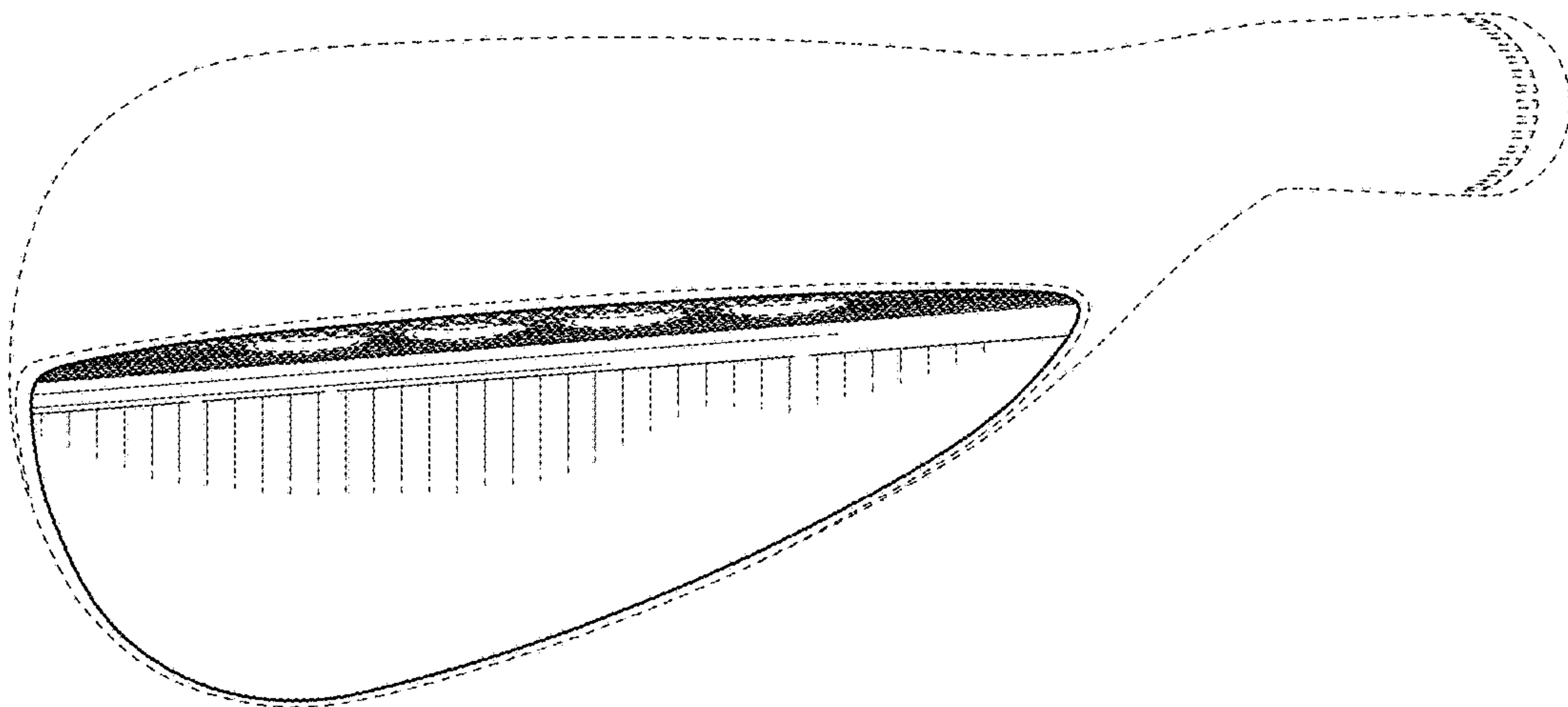

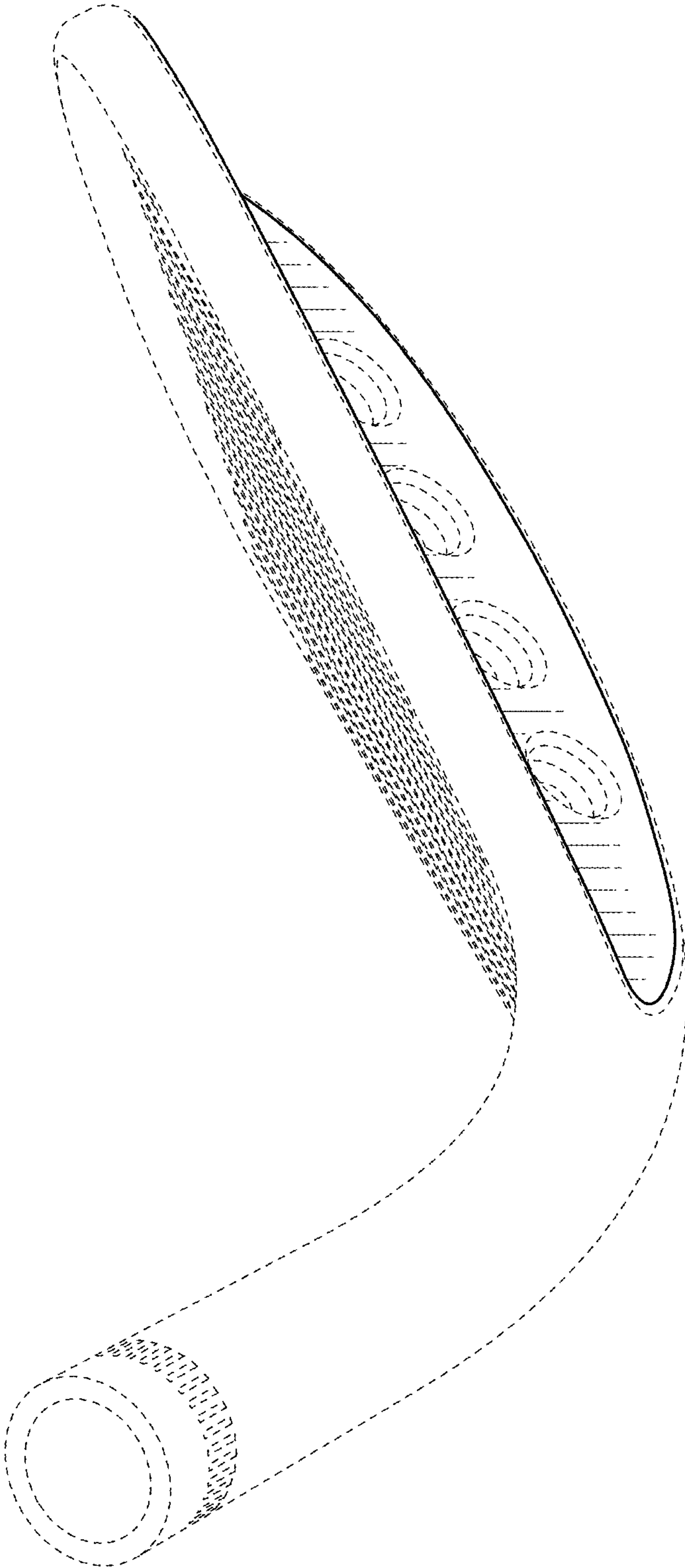

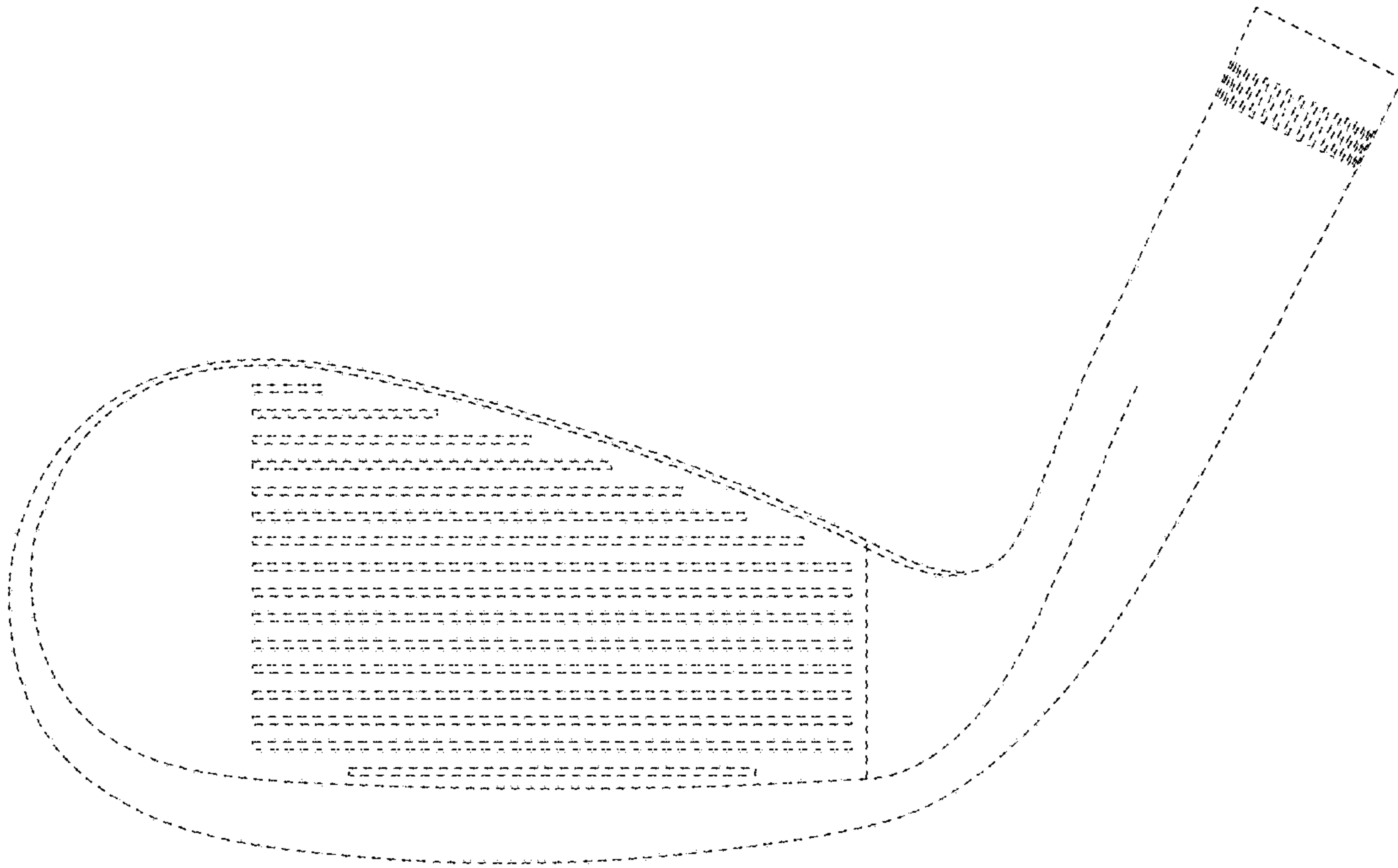

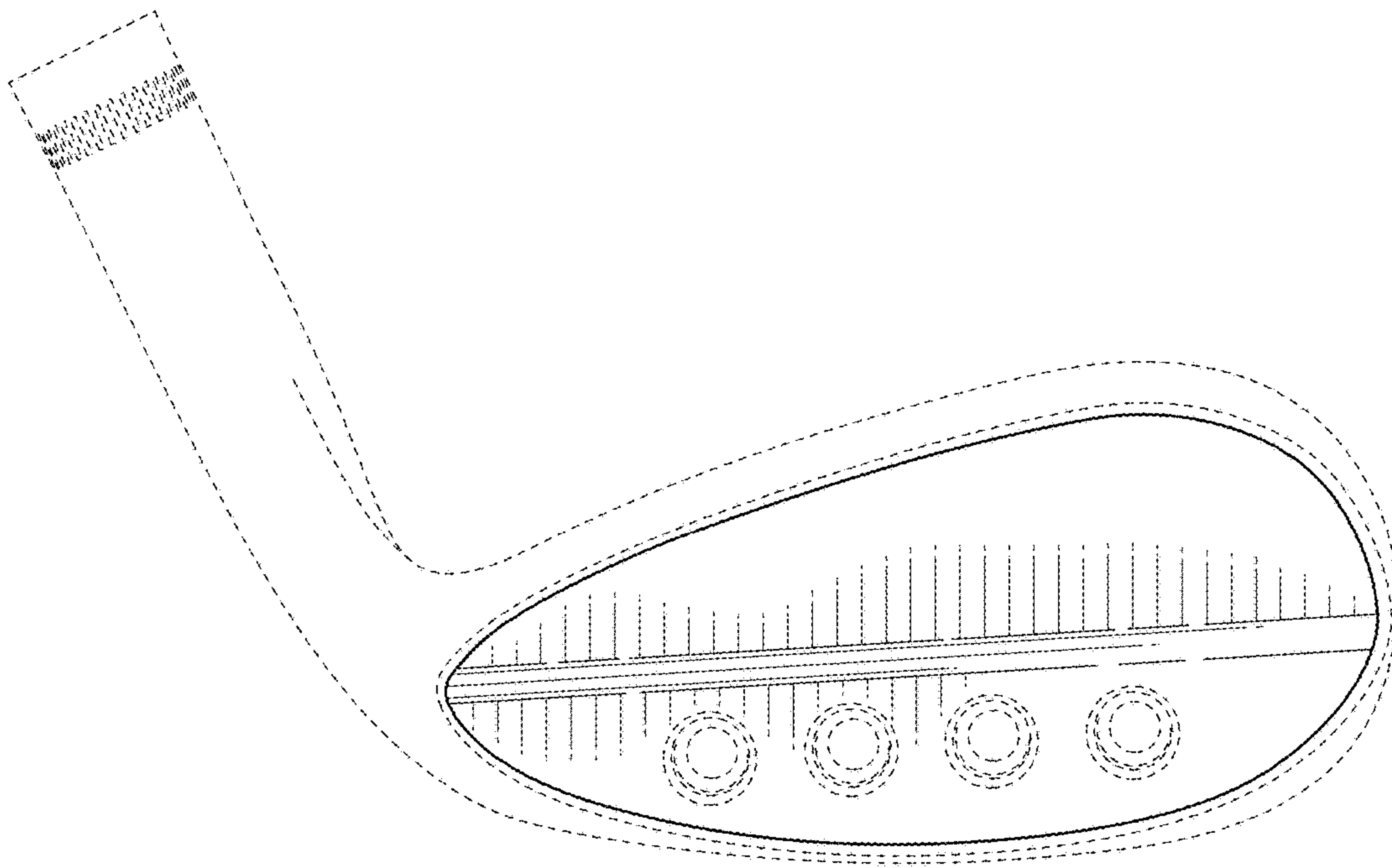

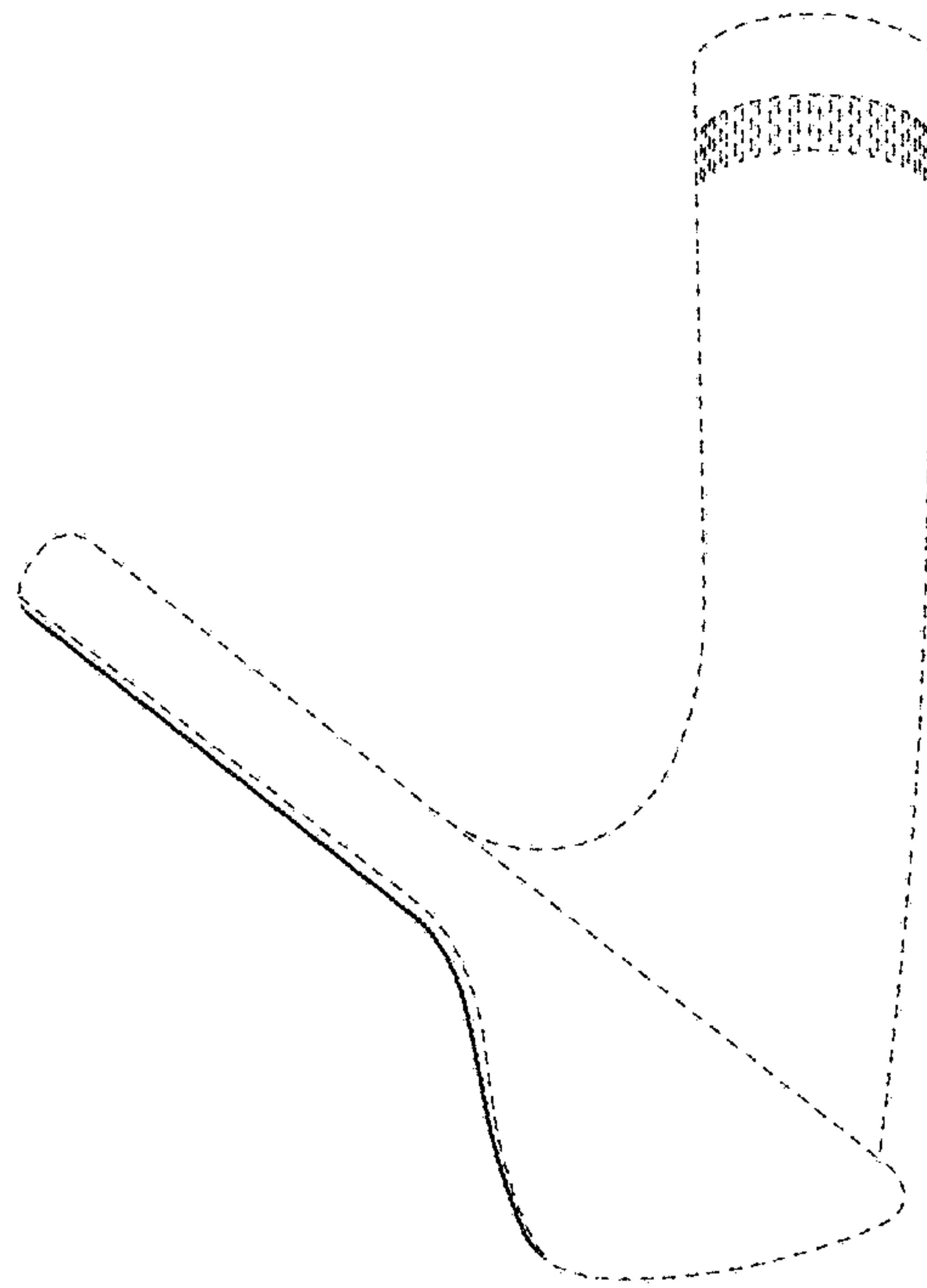

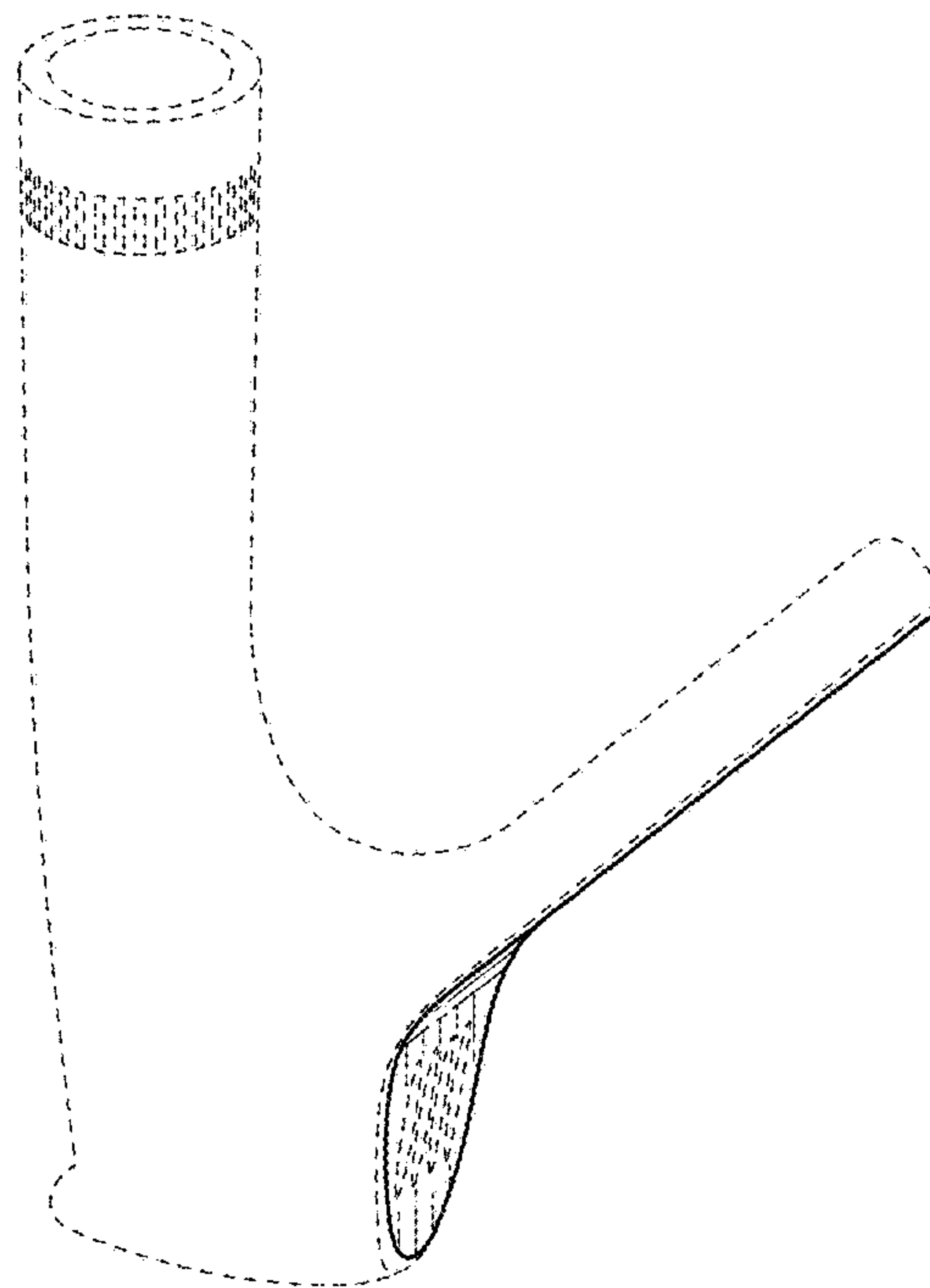

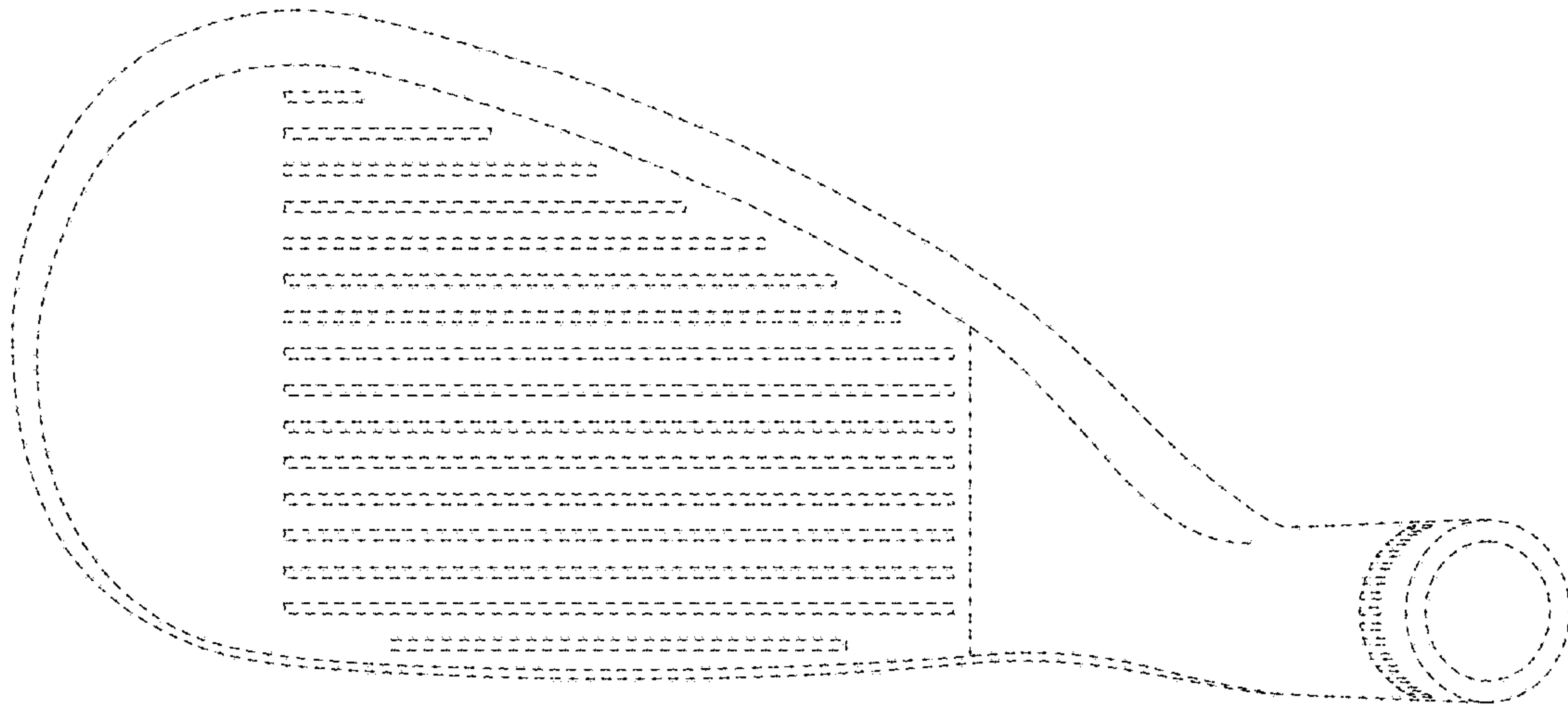

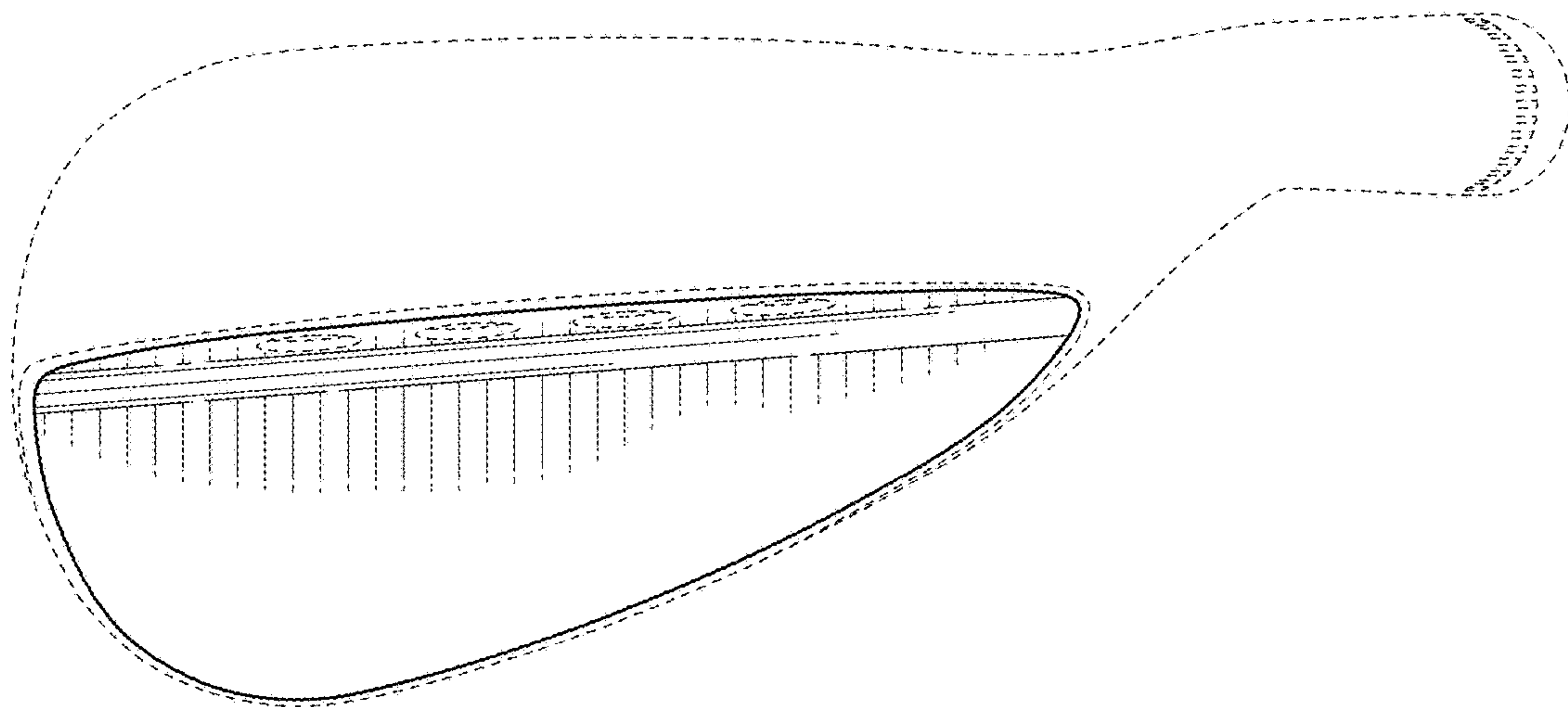
