 Broken lines in the Figures show environmental structure or boundaries of the claim, with the broken lines themselves forming no part of the claimed design.

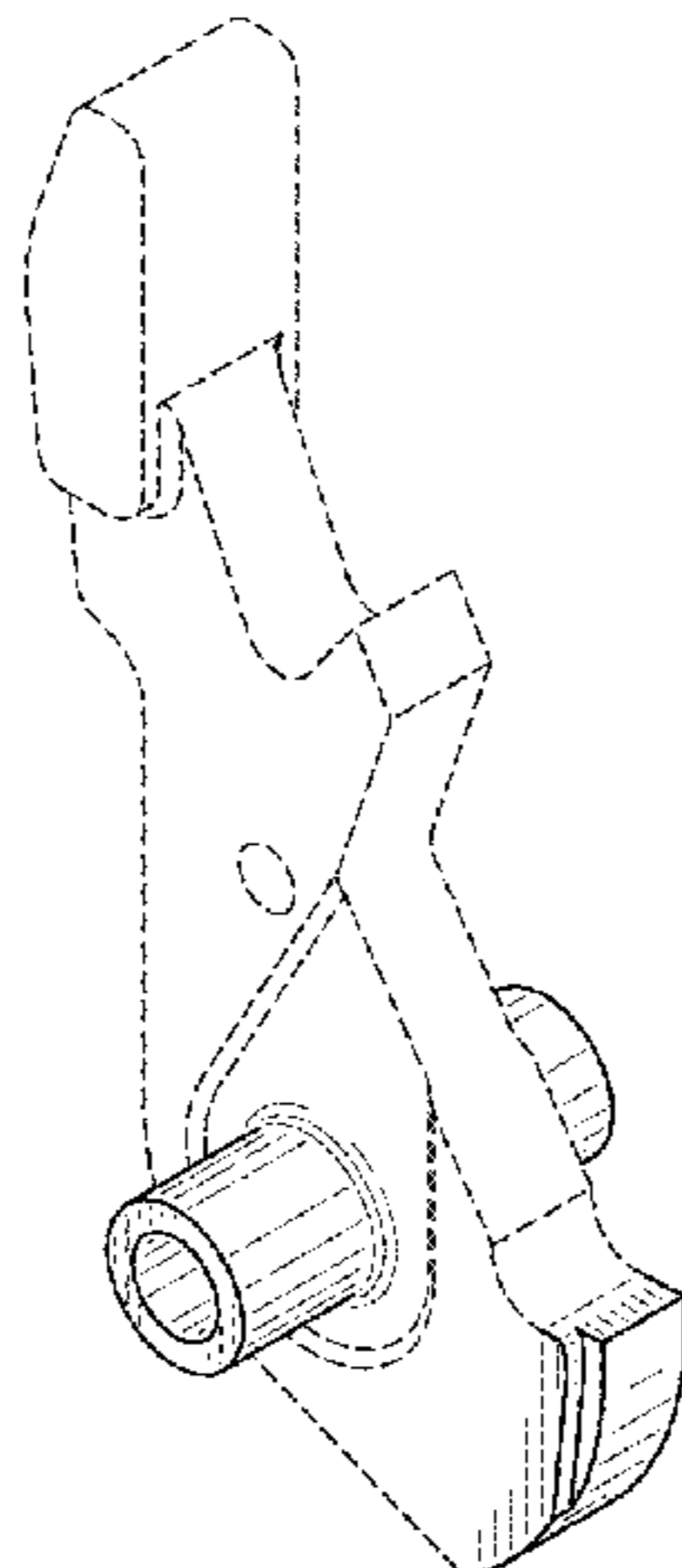

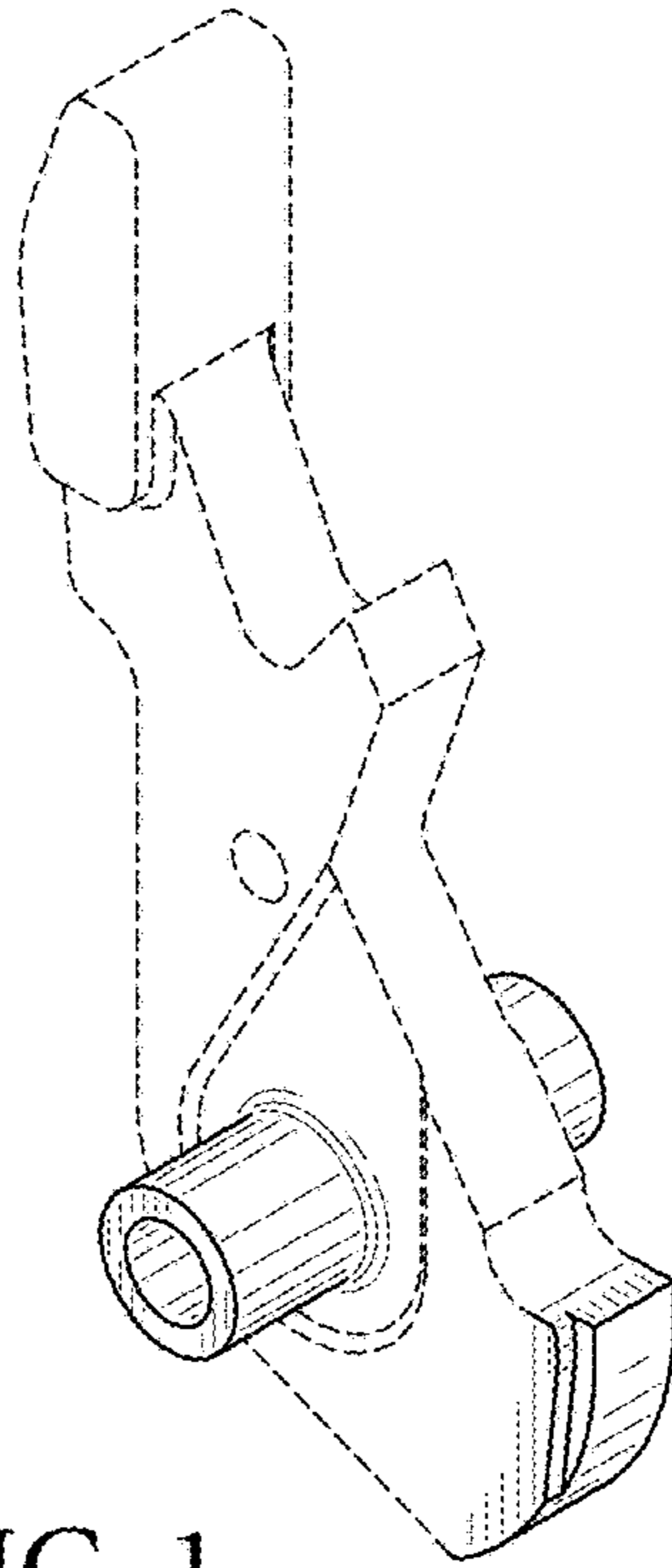

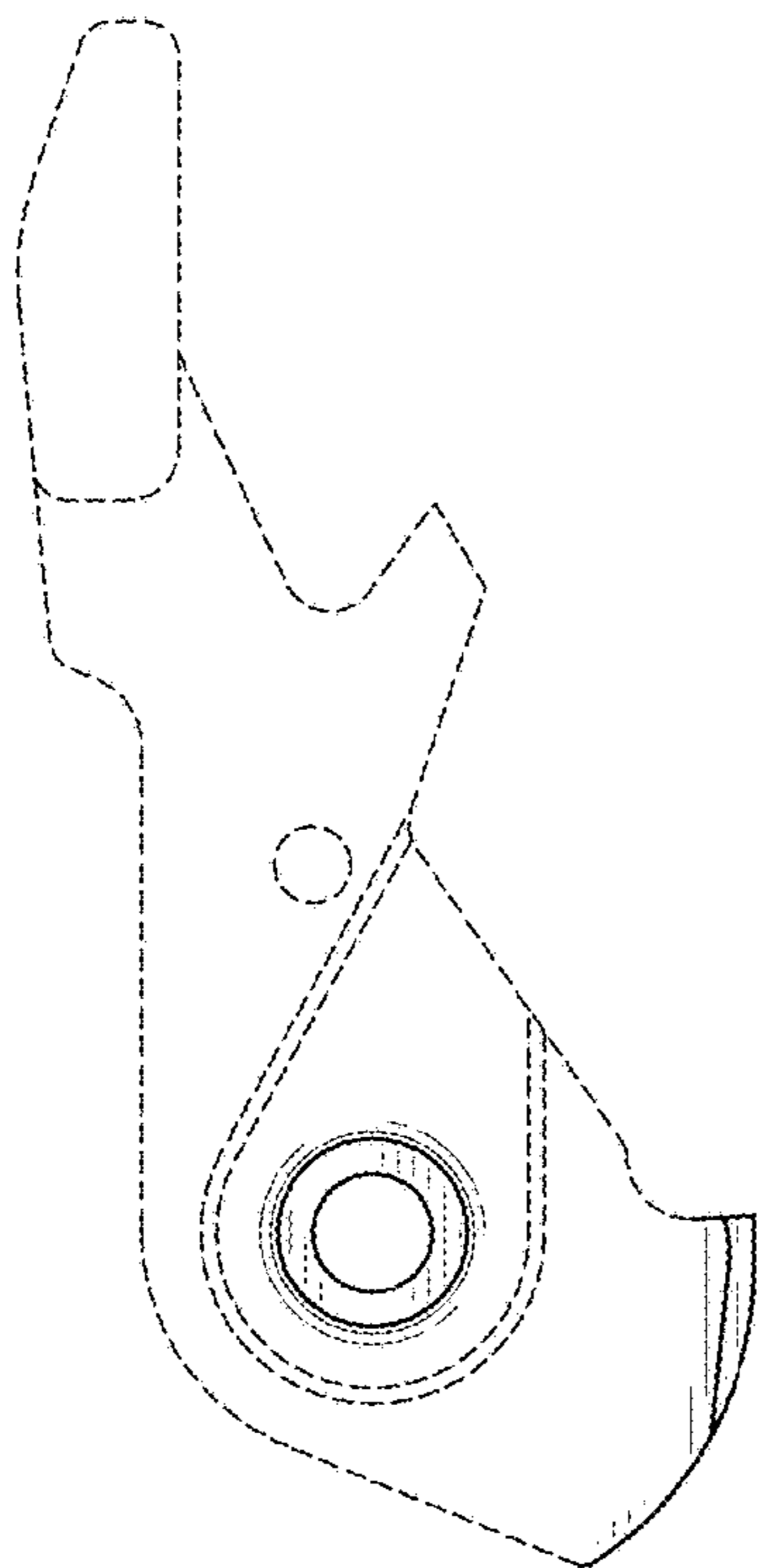

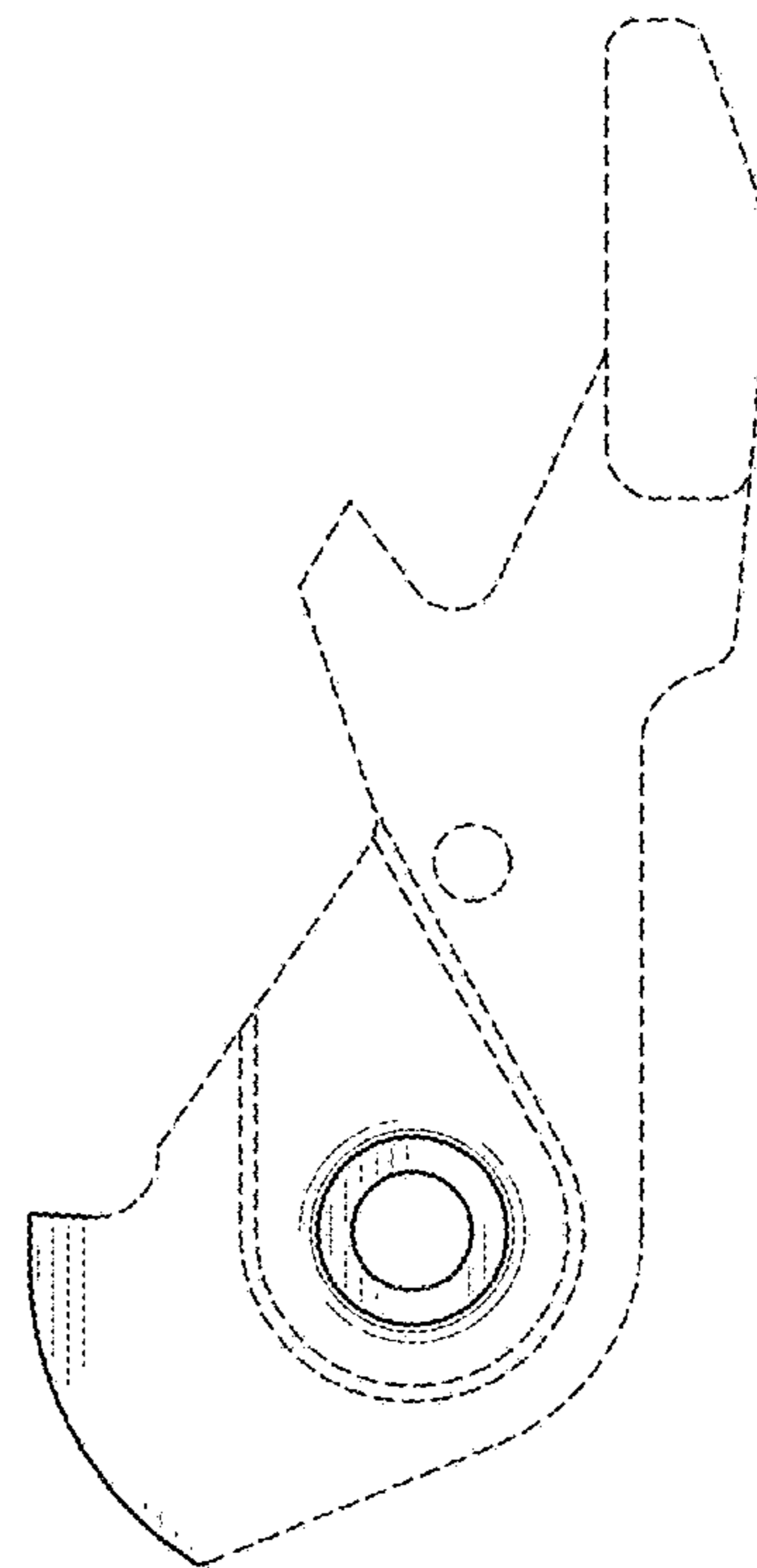

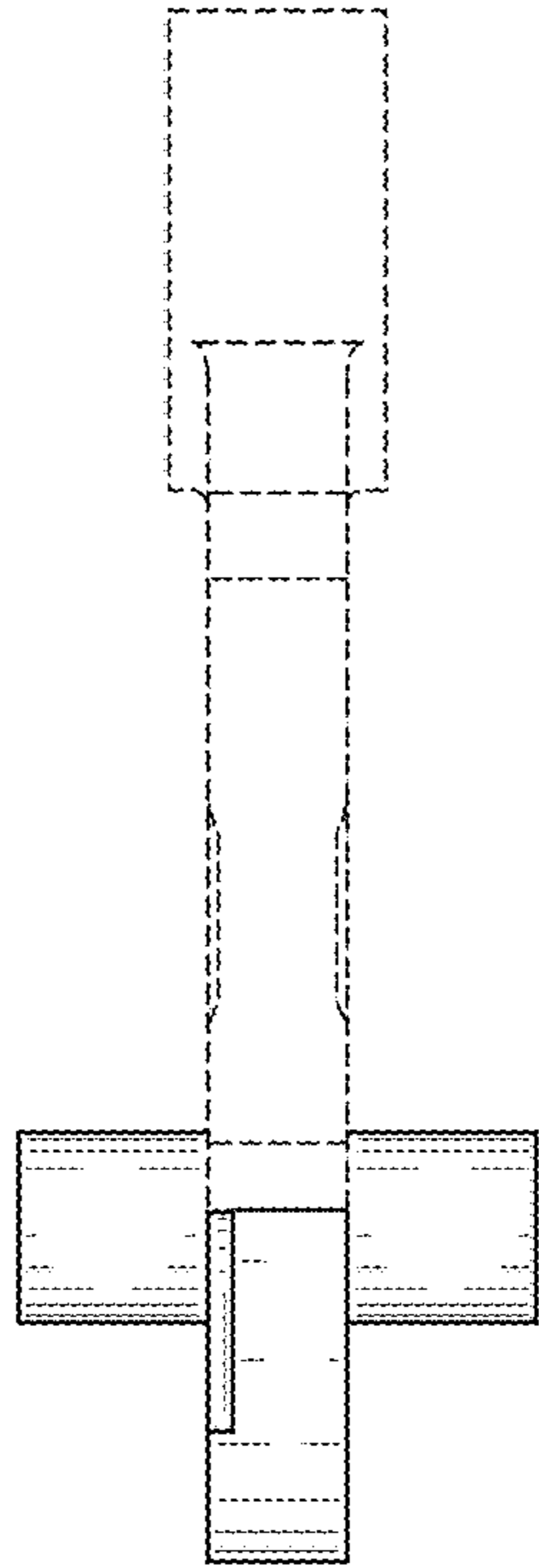

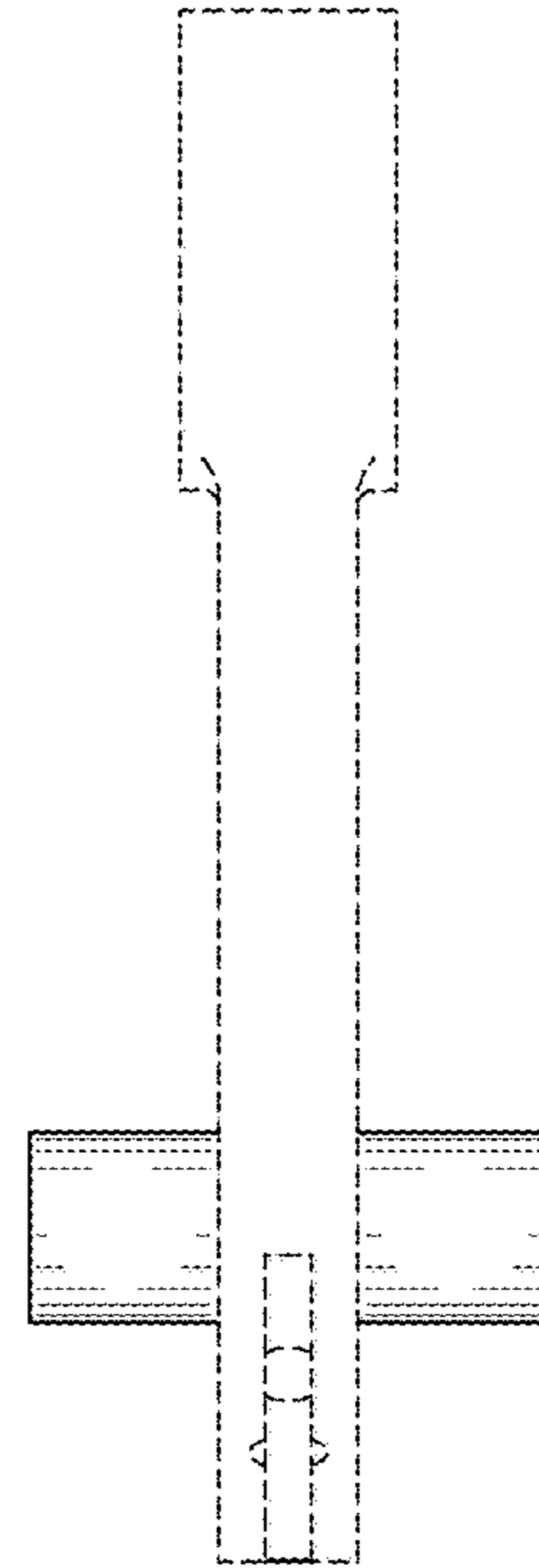

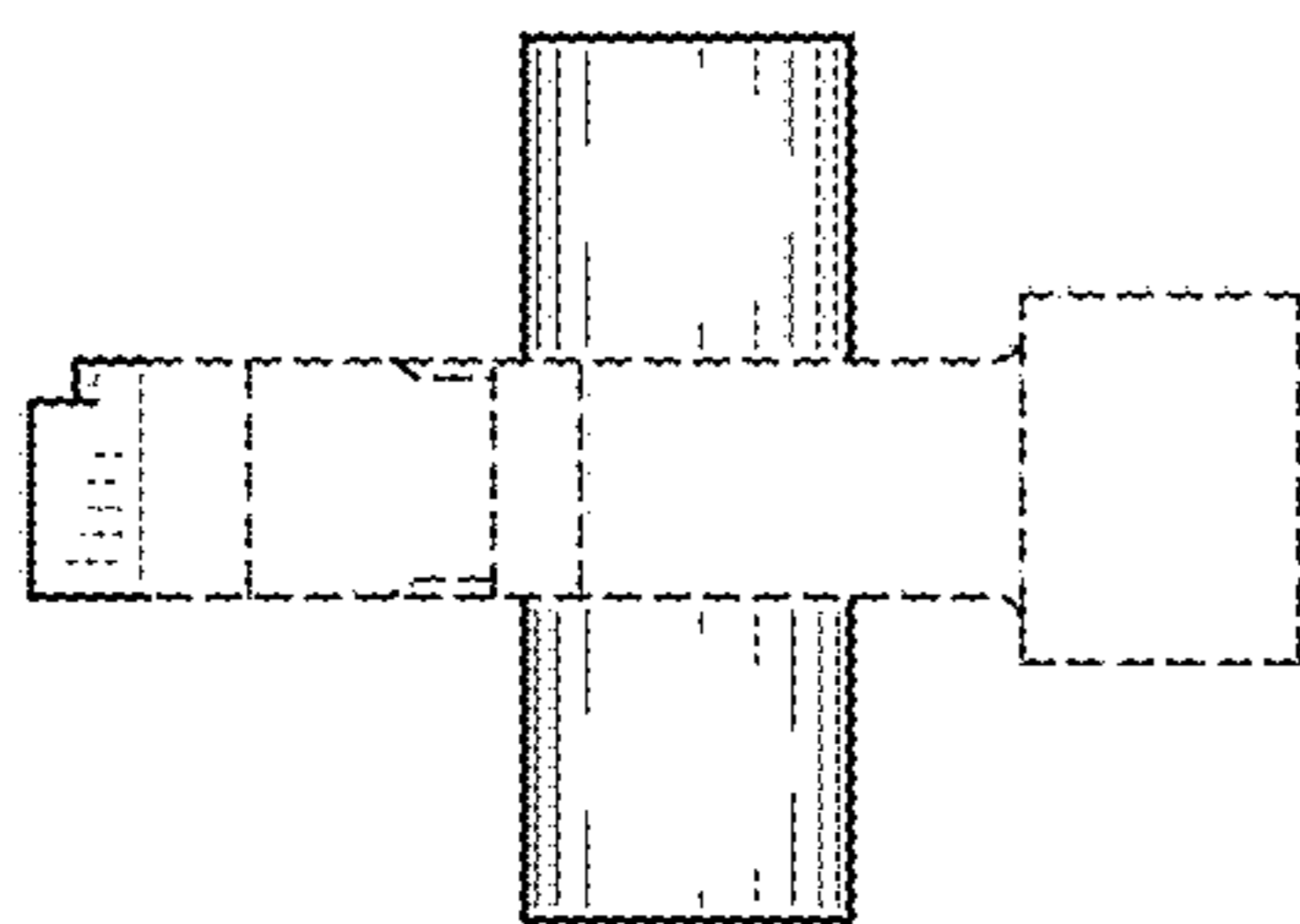

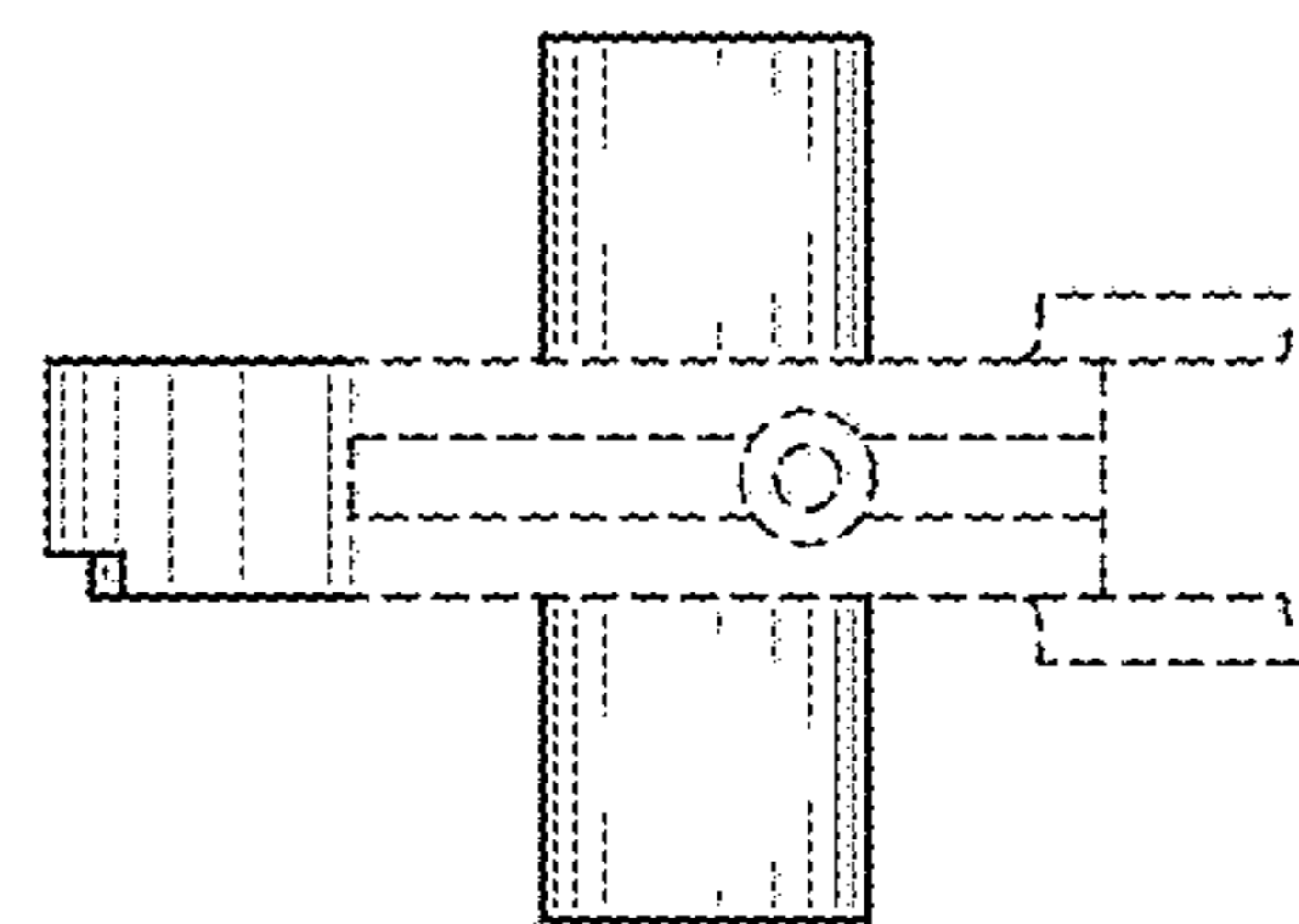

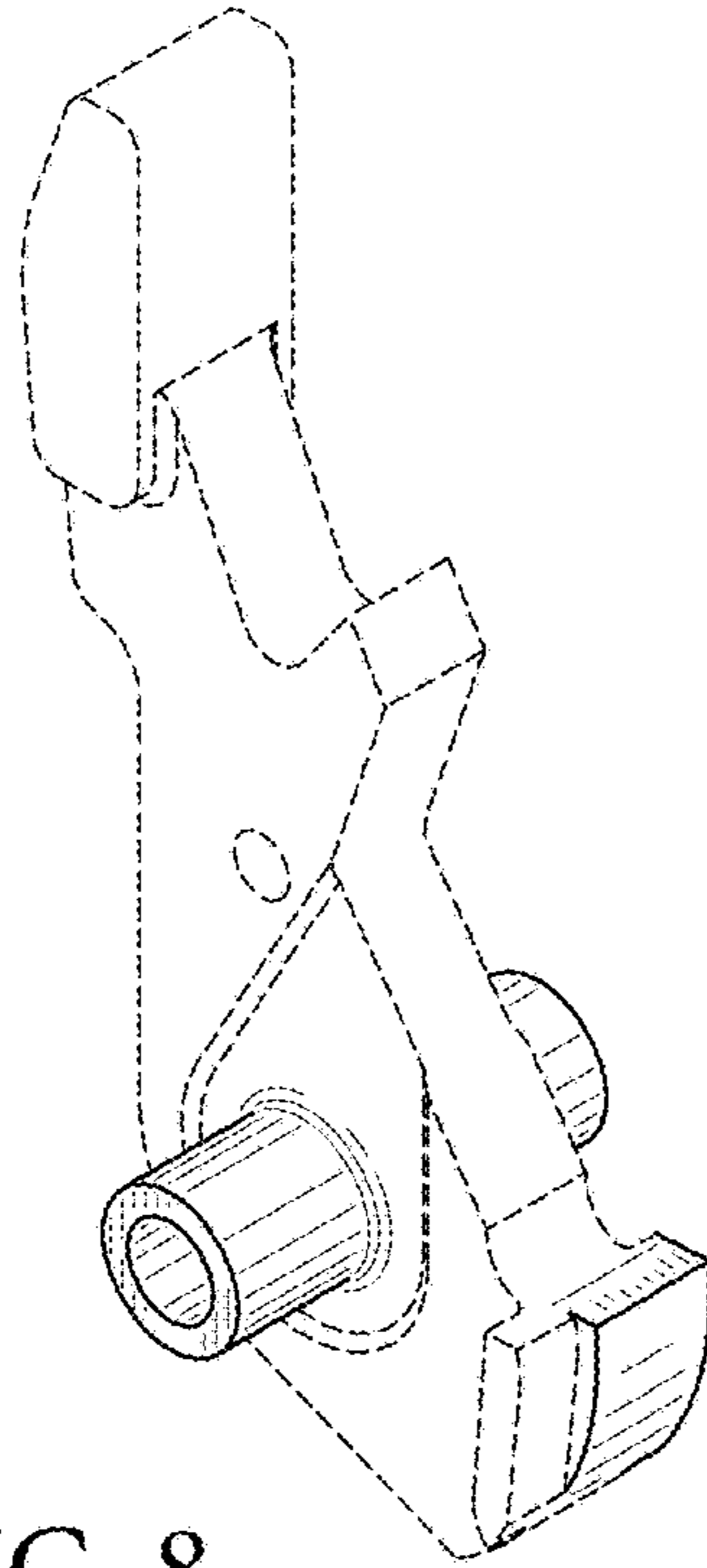

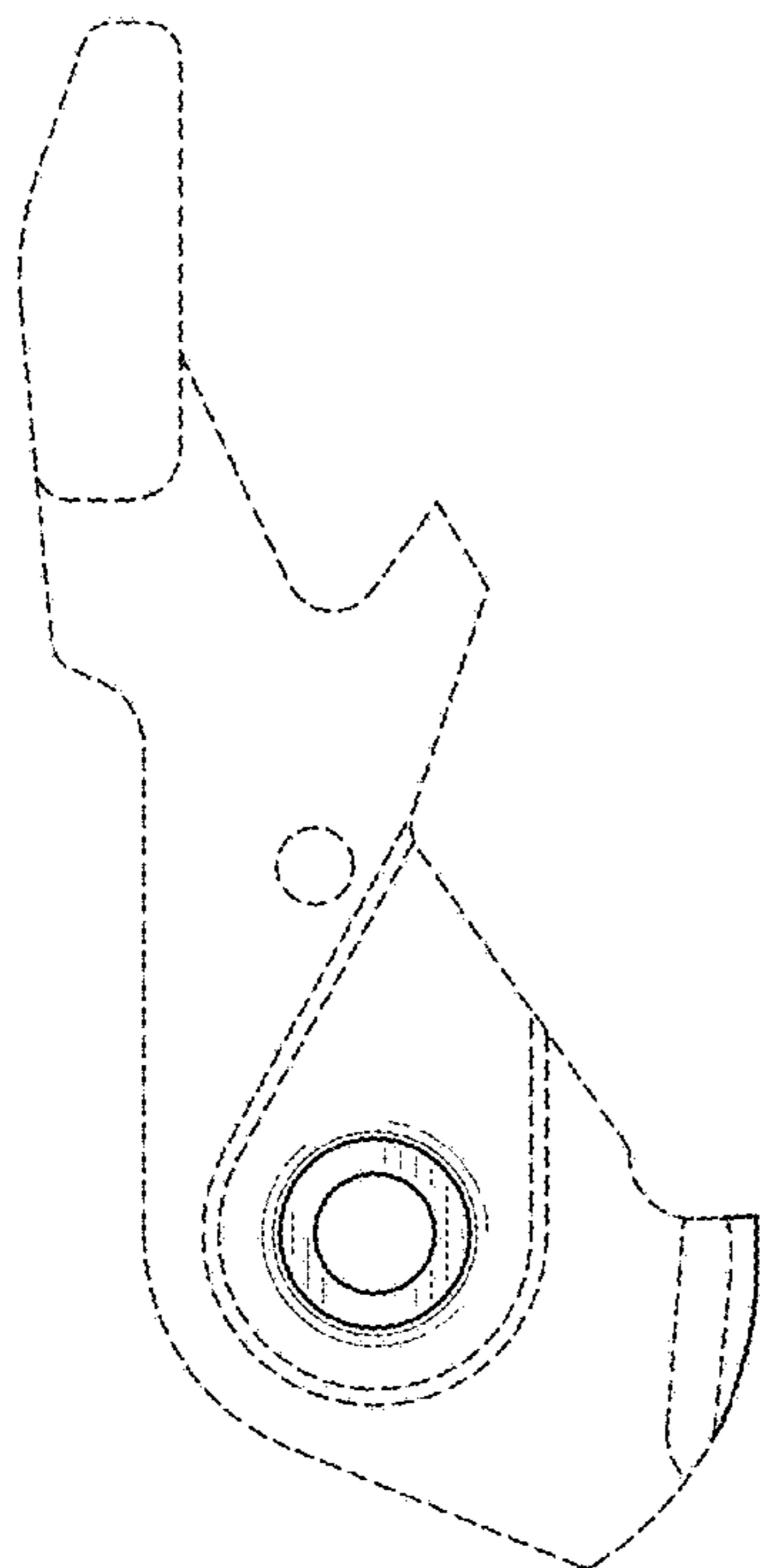

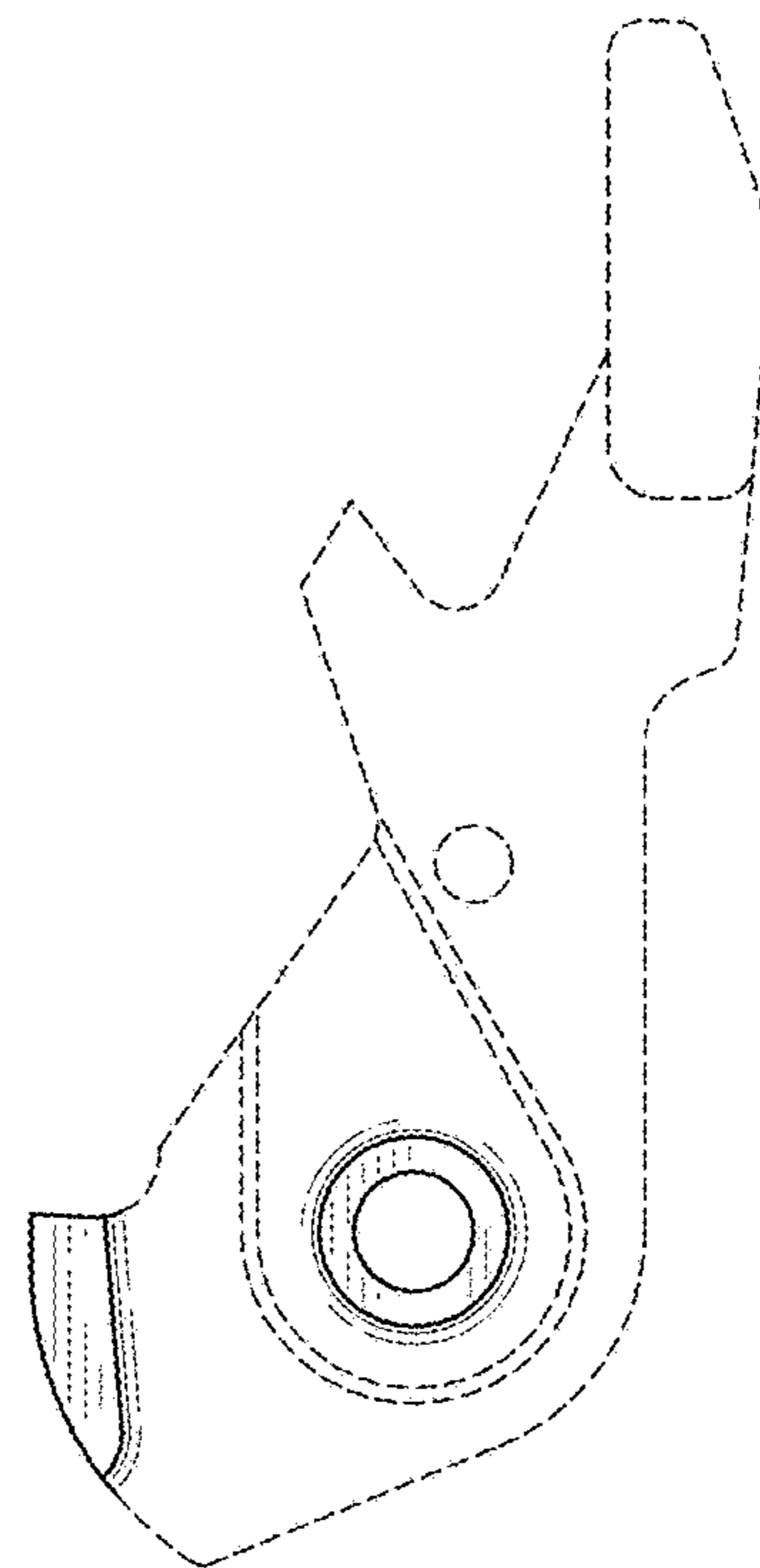

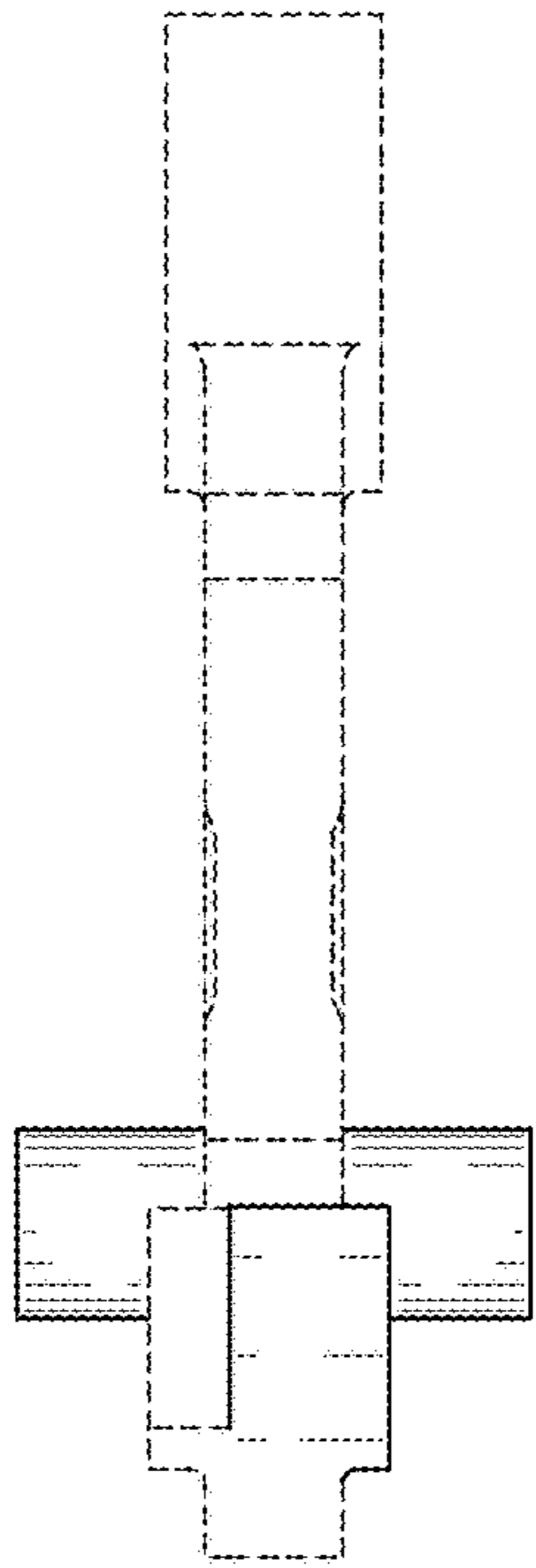

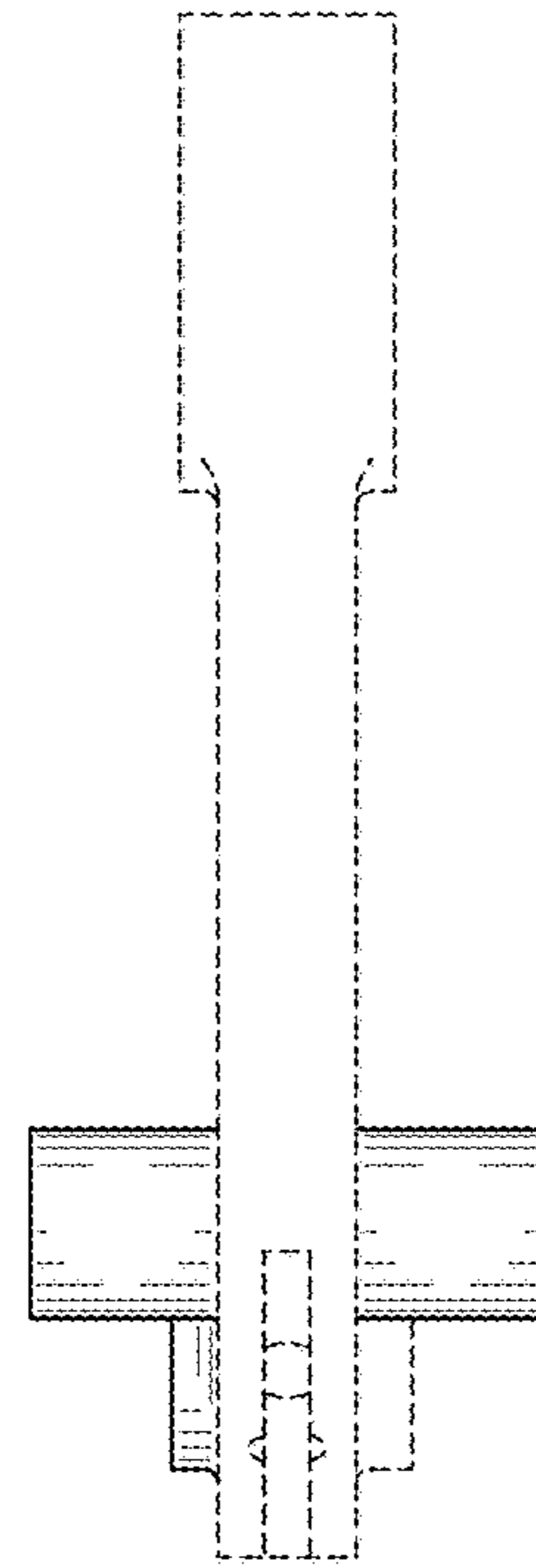

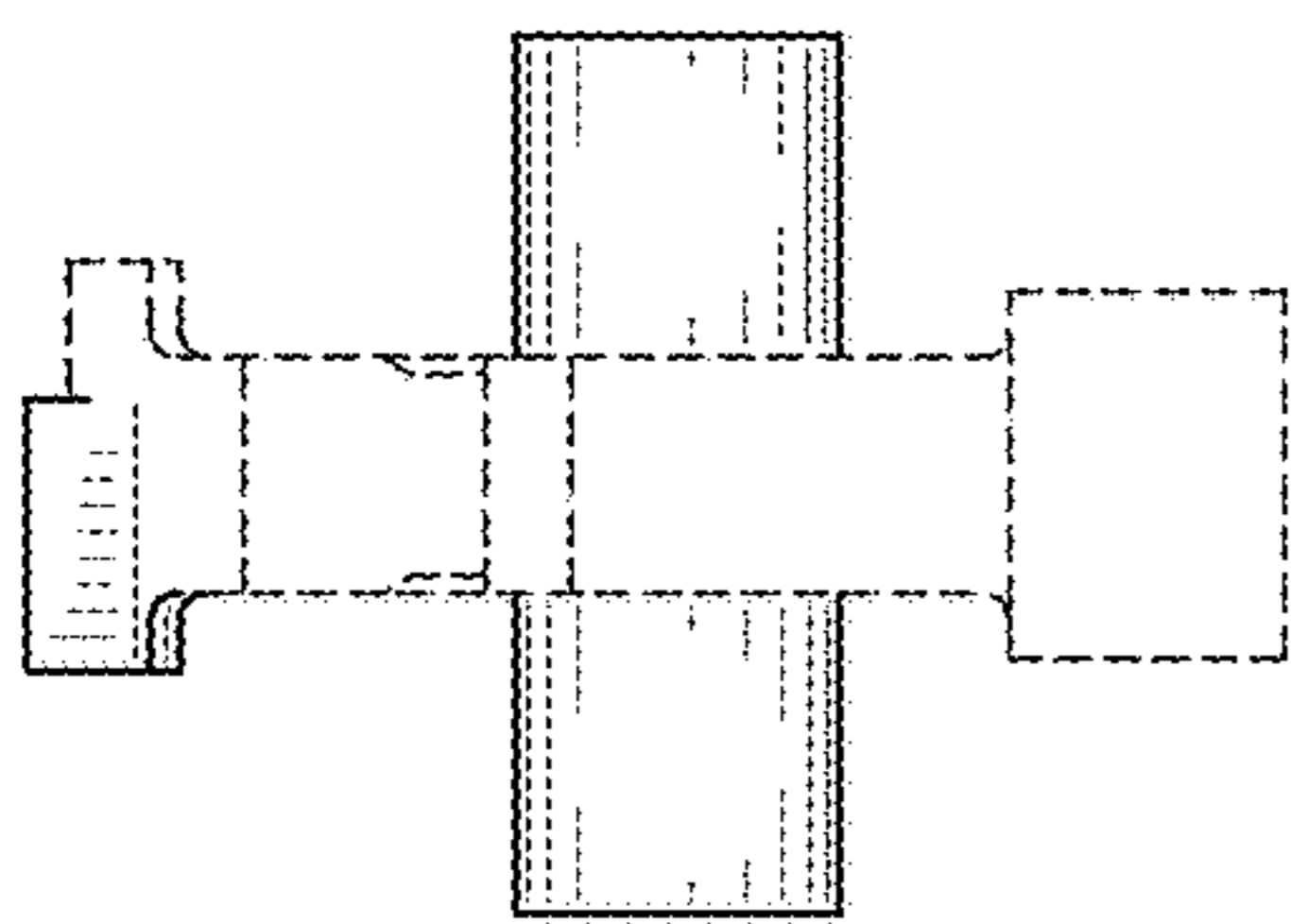

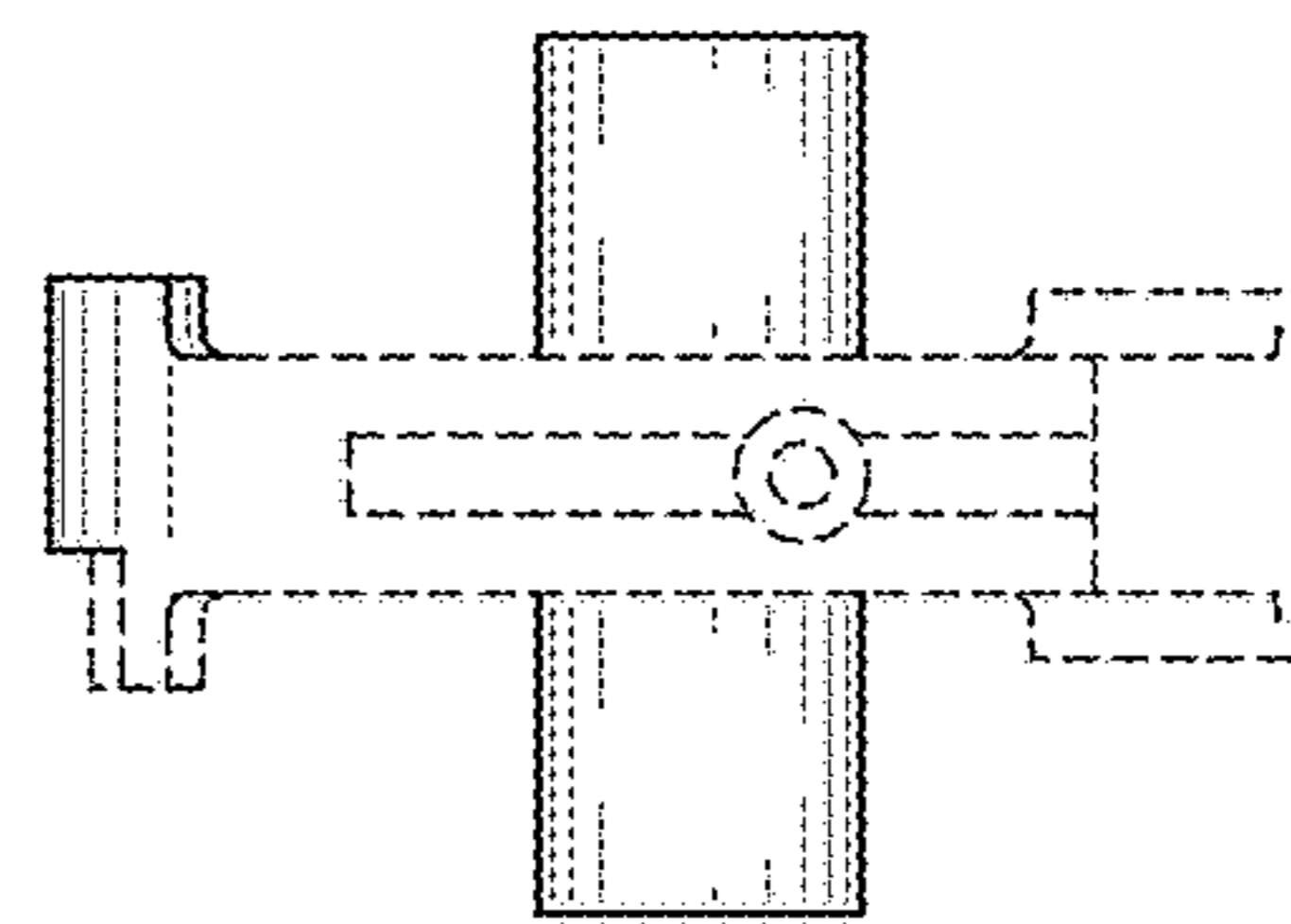

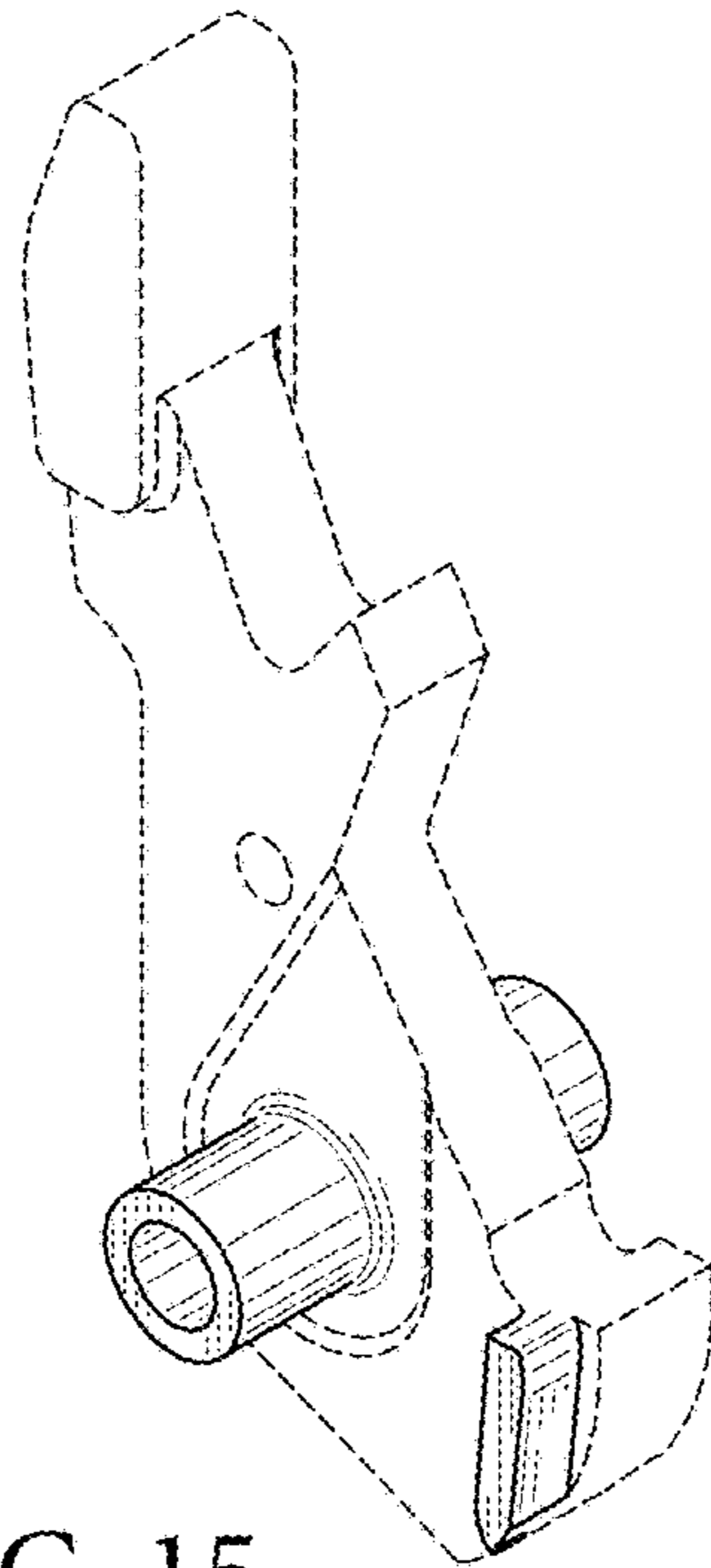

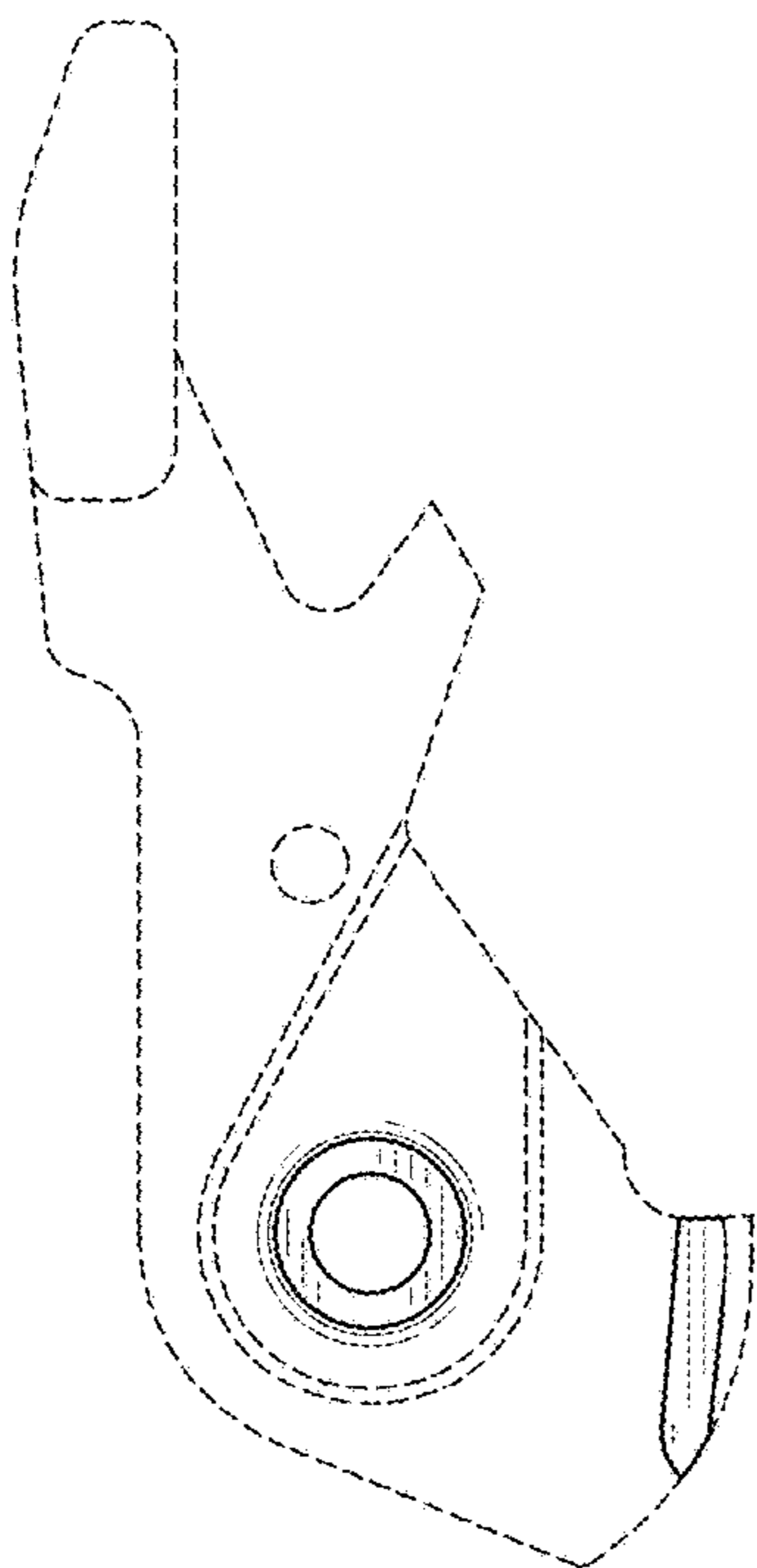

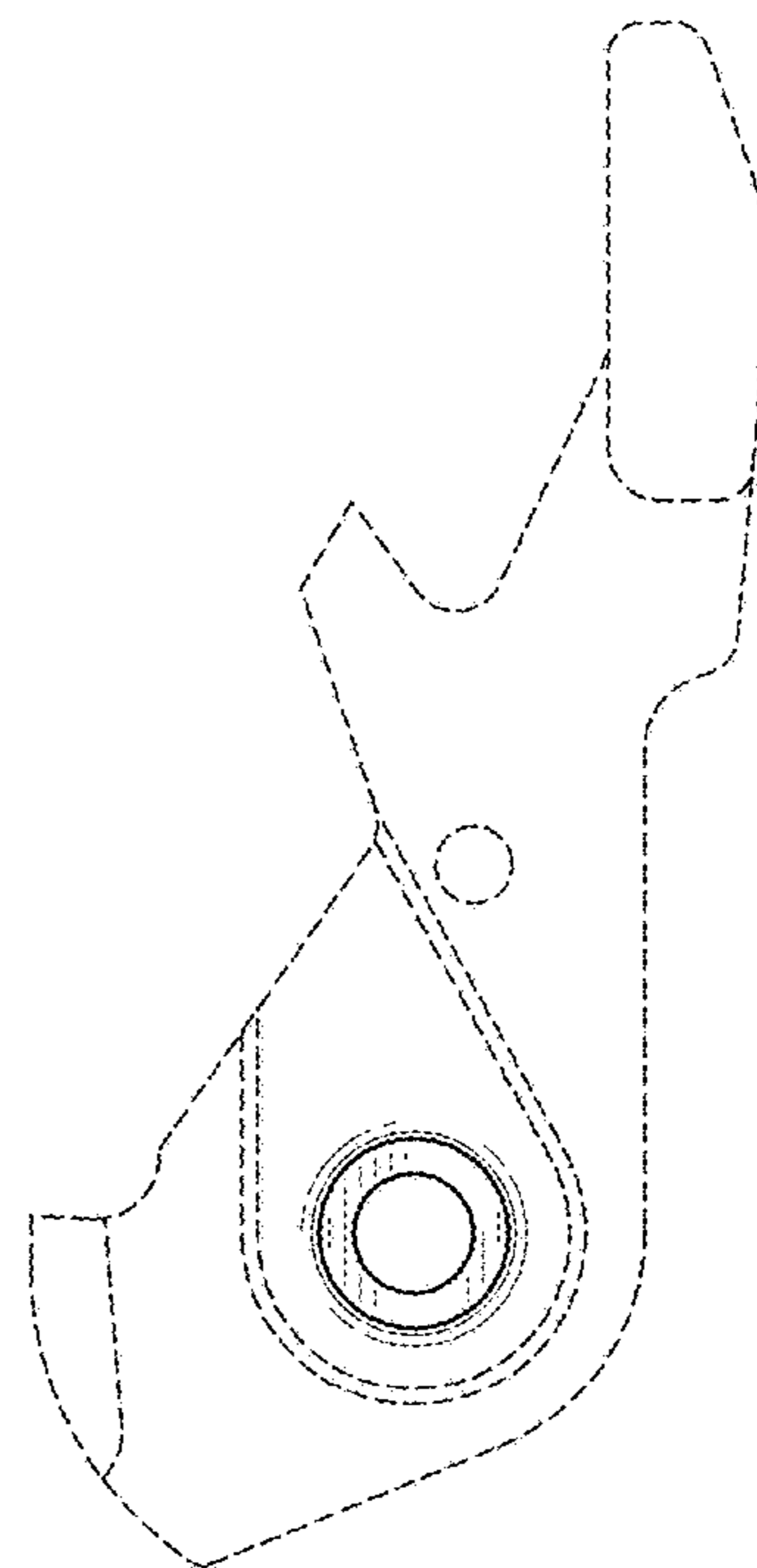

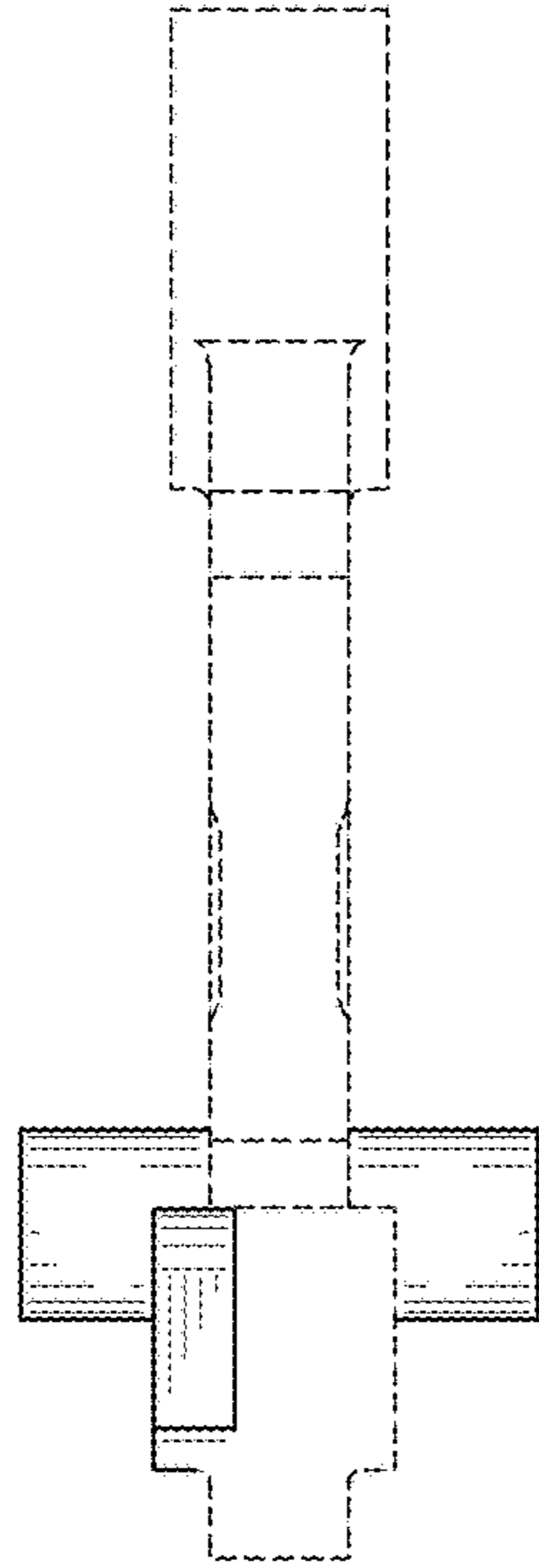

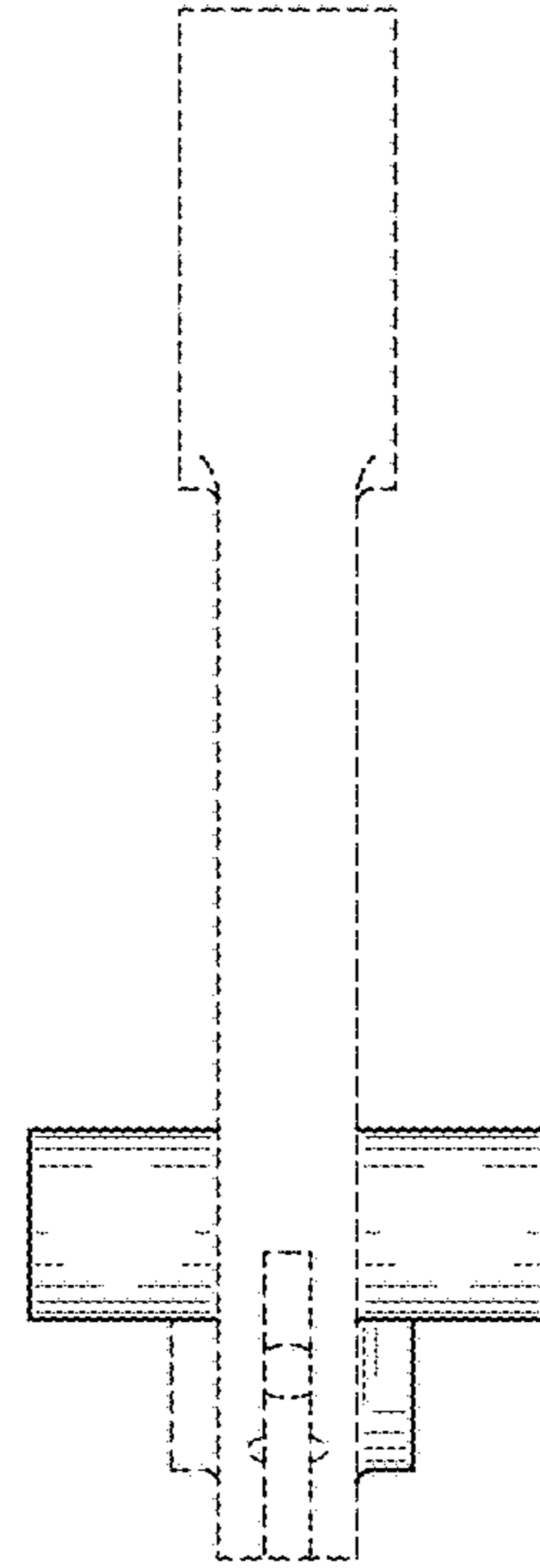

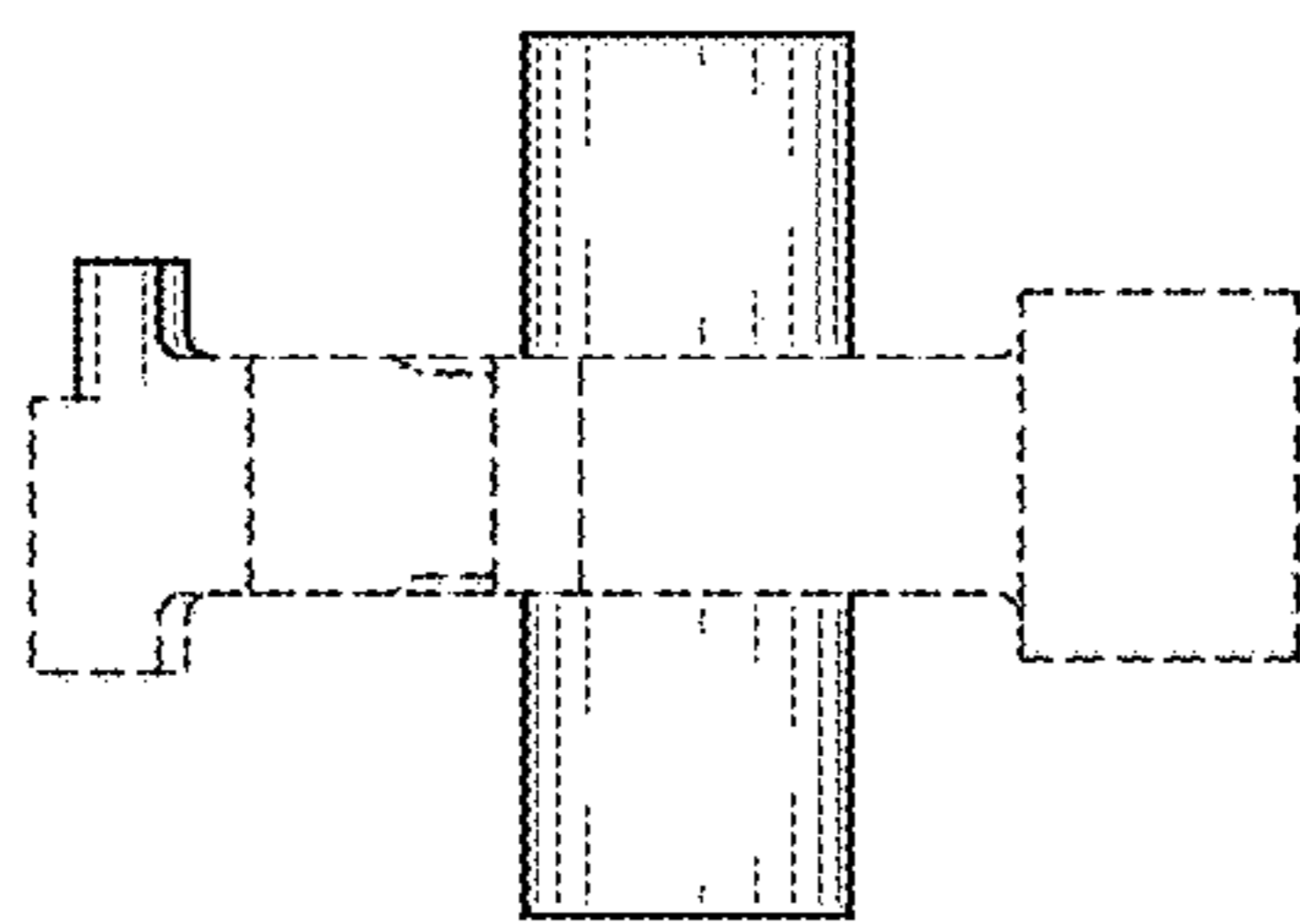

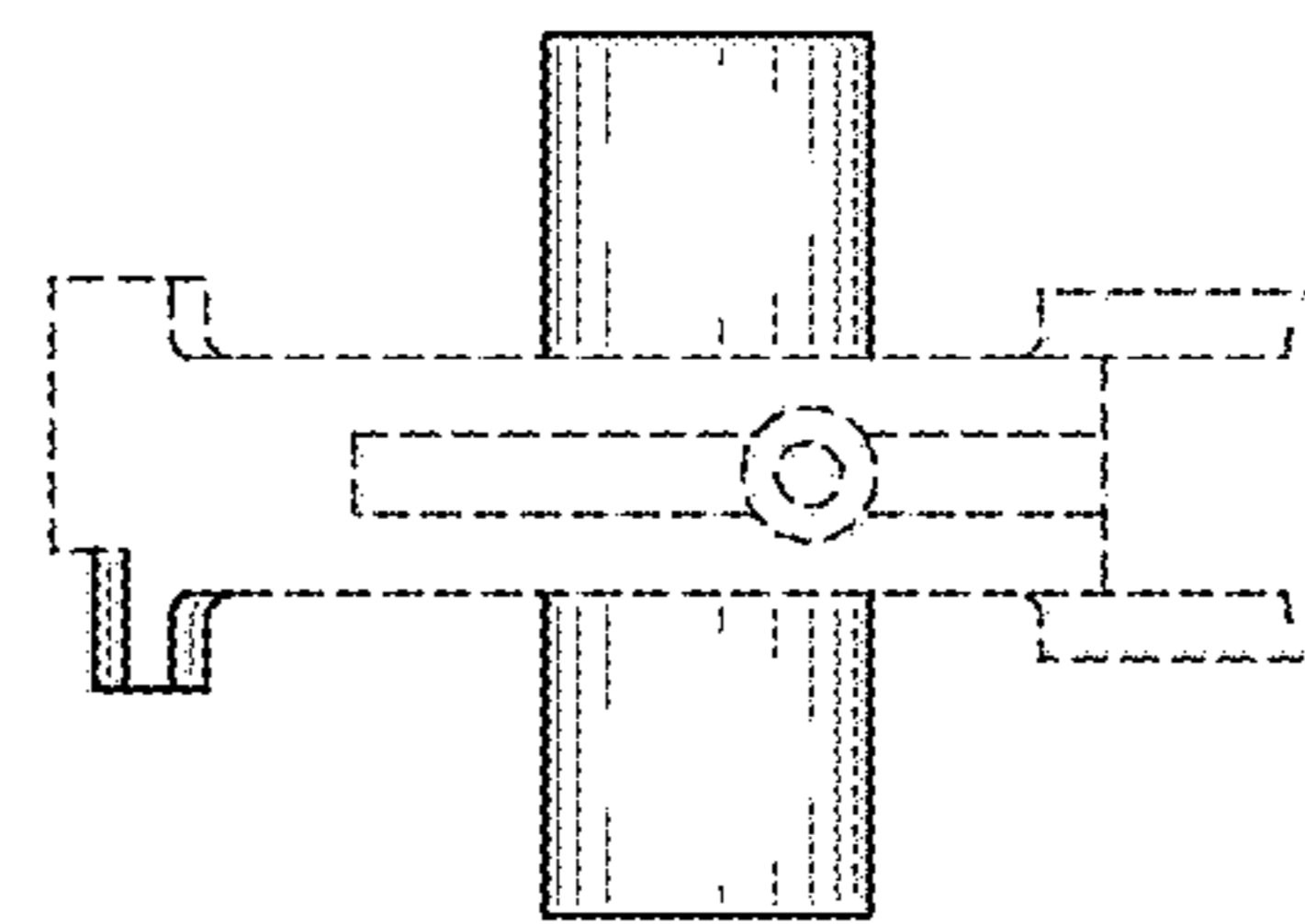
