FIG. 7 is a bottom view thereof.

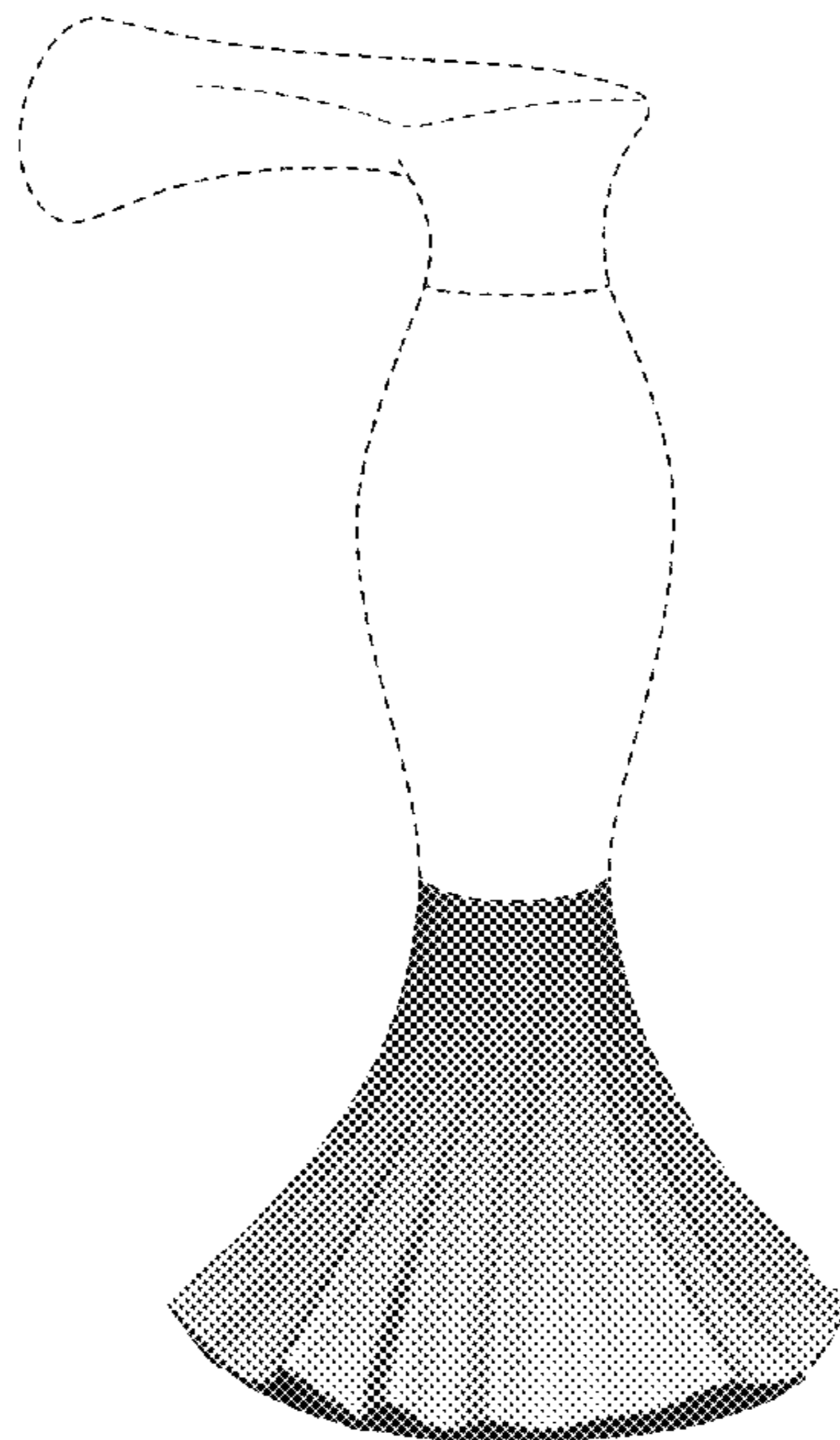
The broken line showing of the various unshaded elements of the faucet hub and lever represents unclaimed subject matter and forms no part of the claimed design.

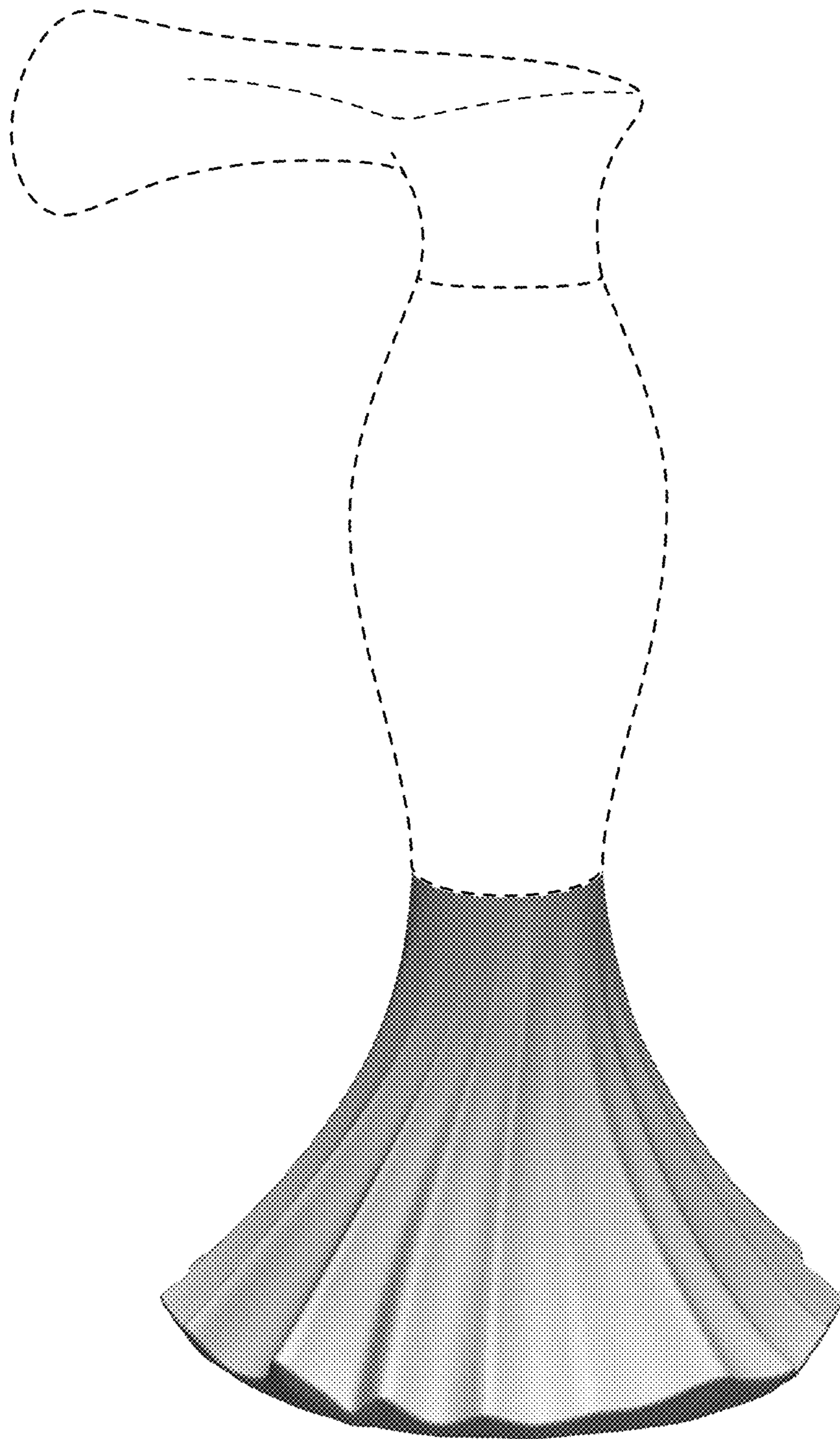

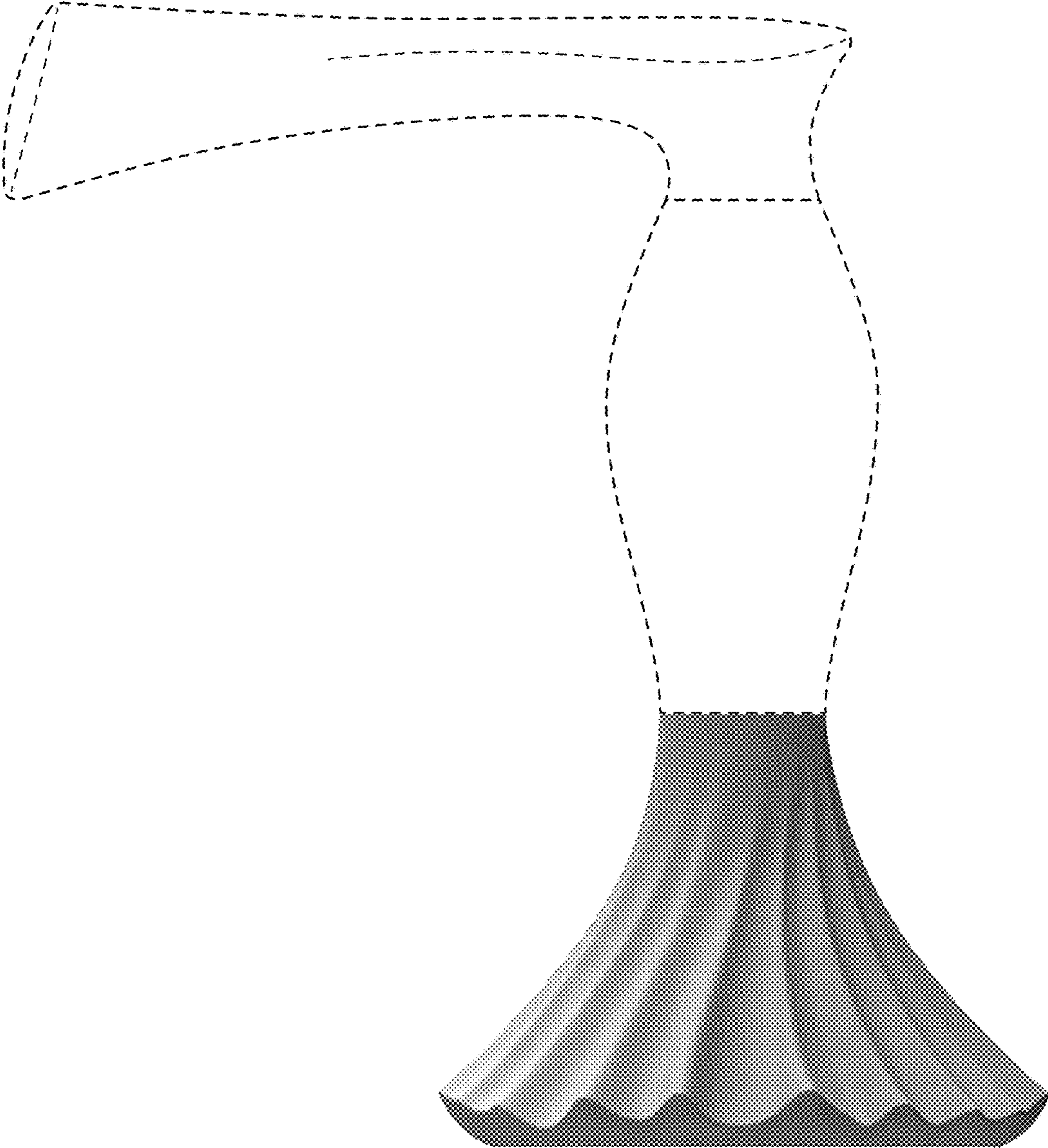

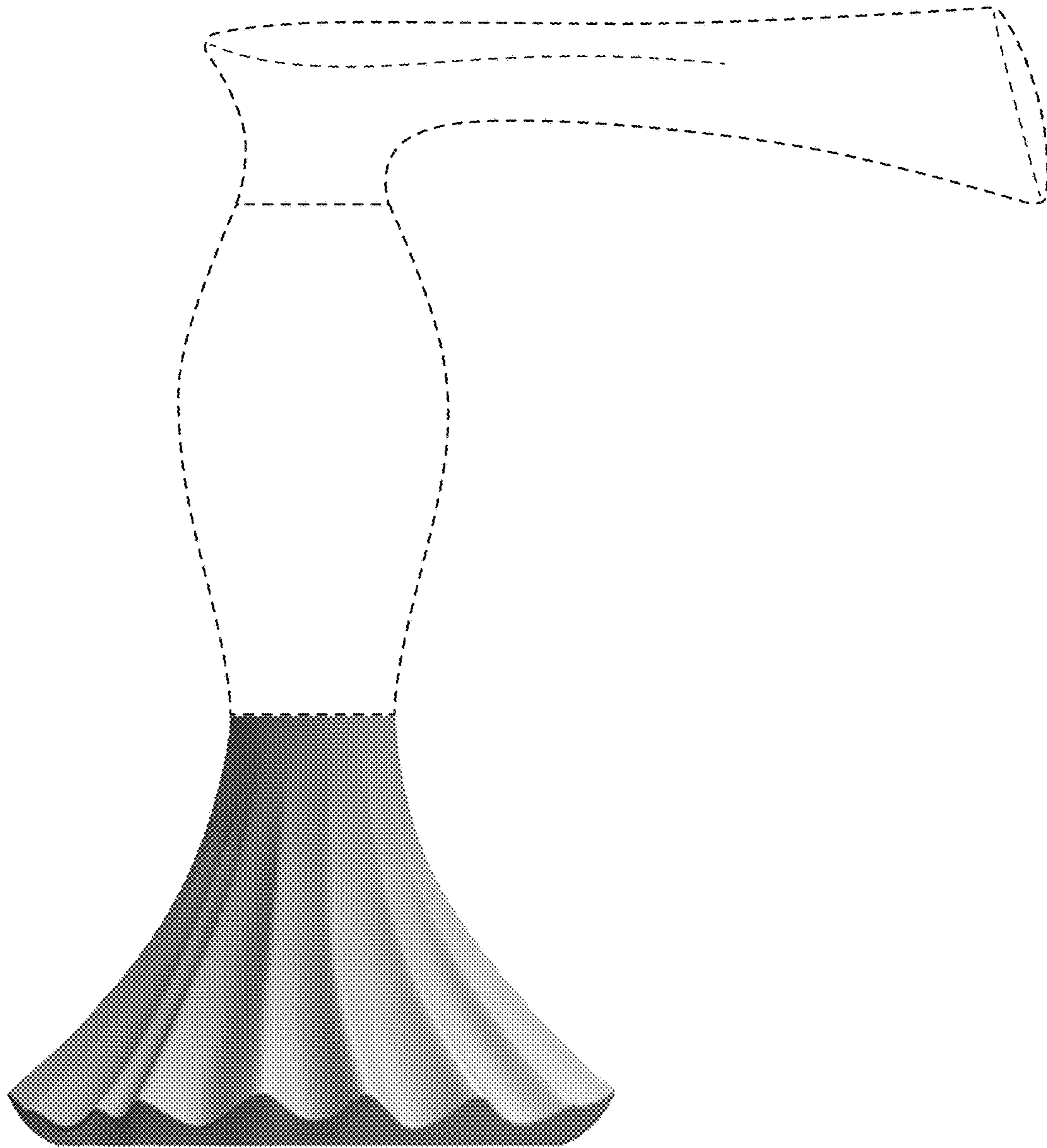

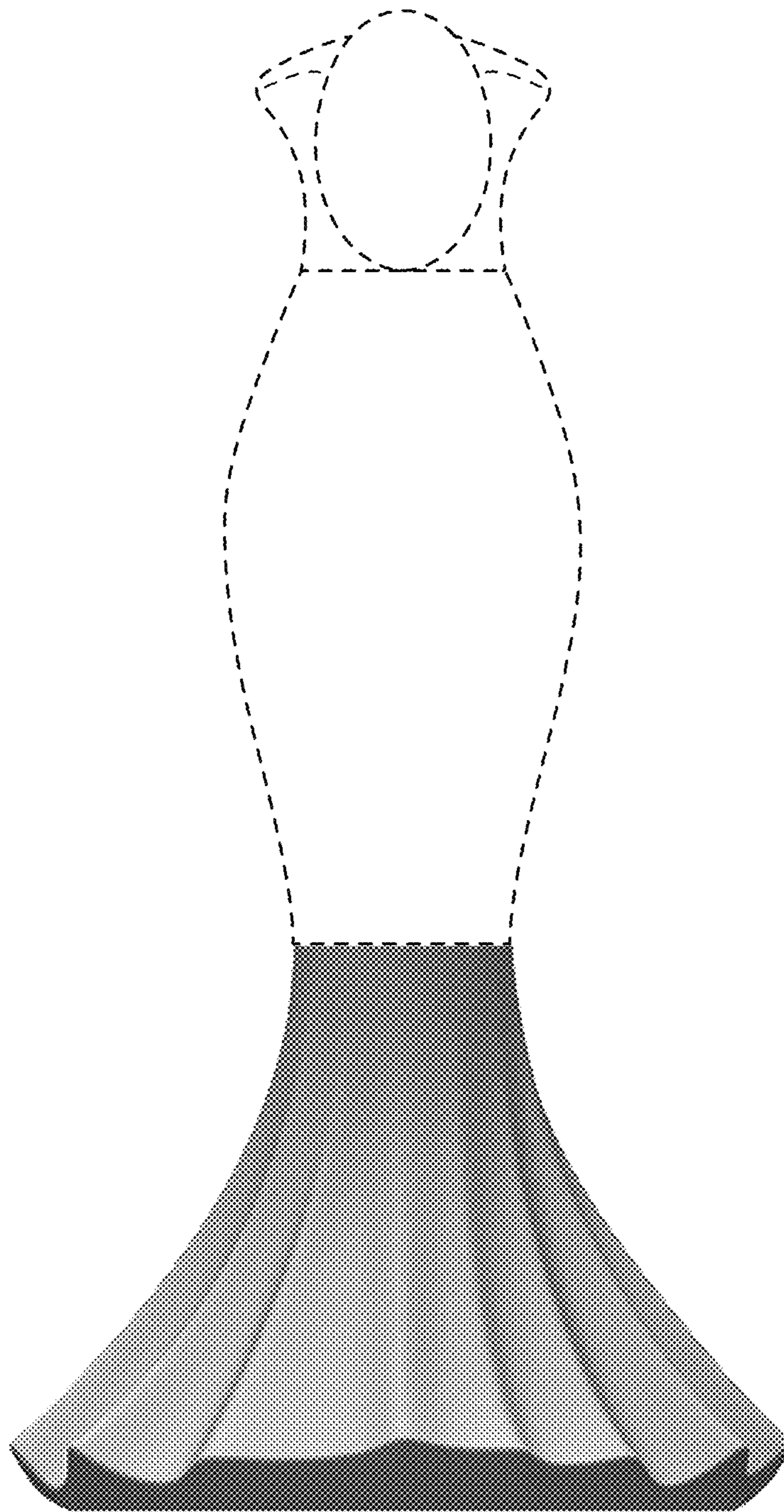

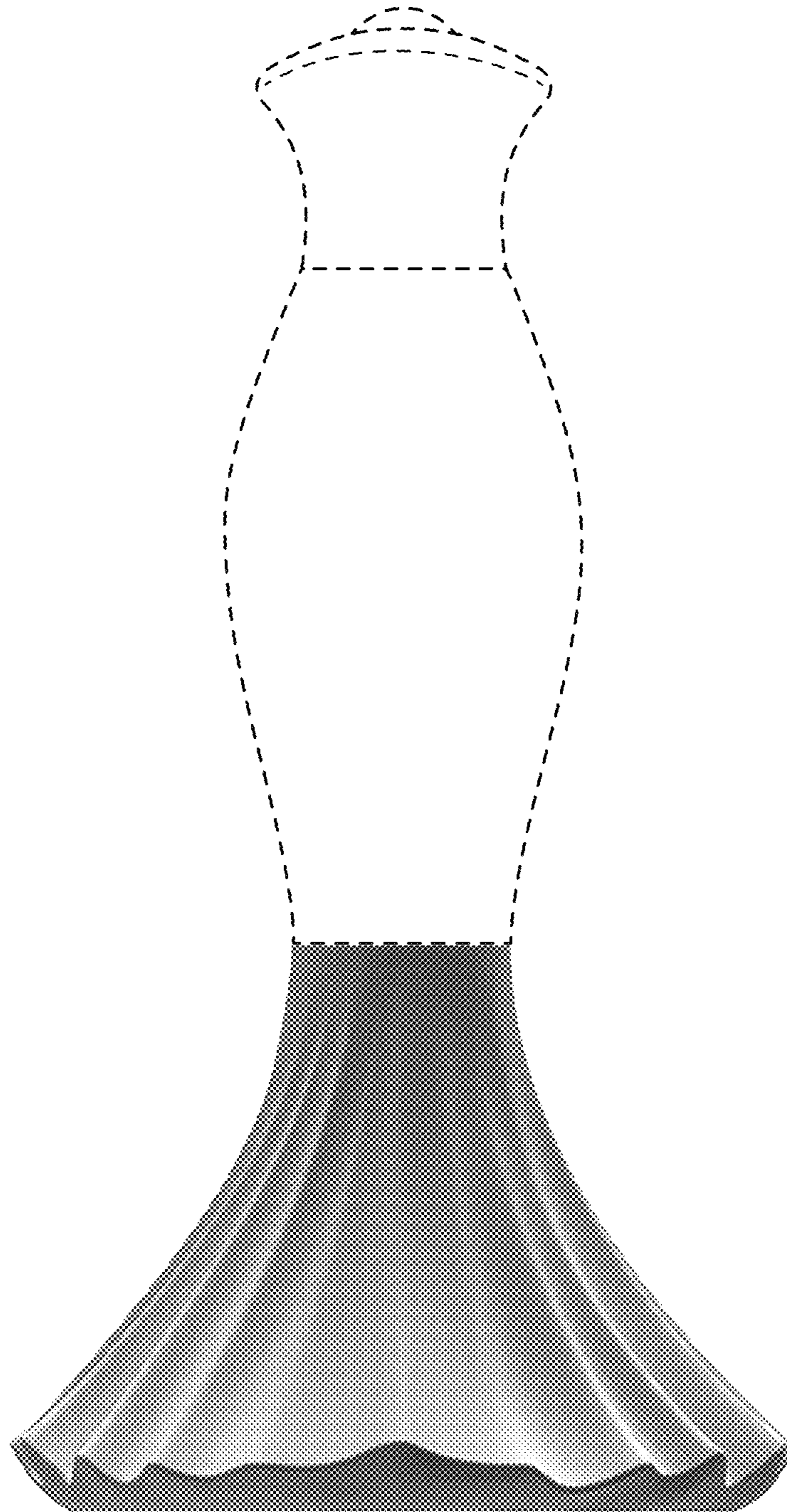

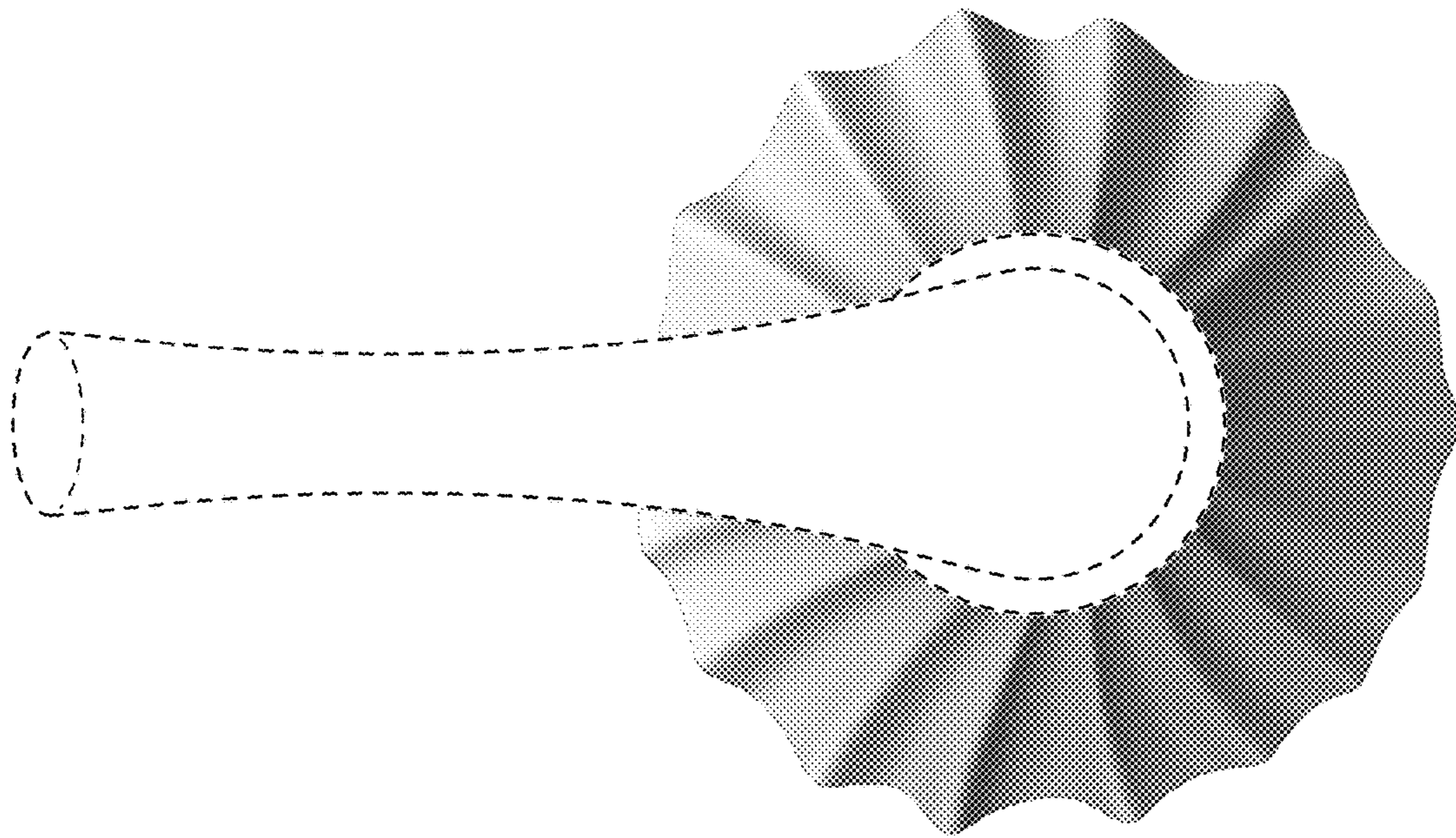

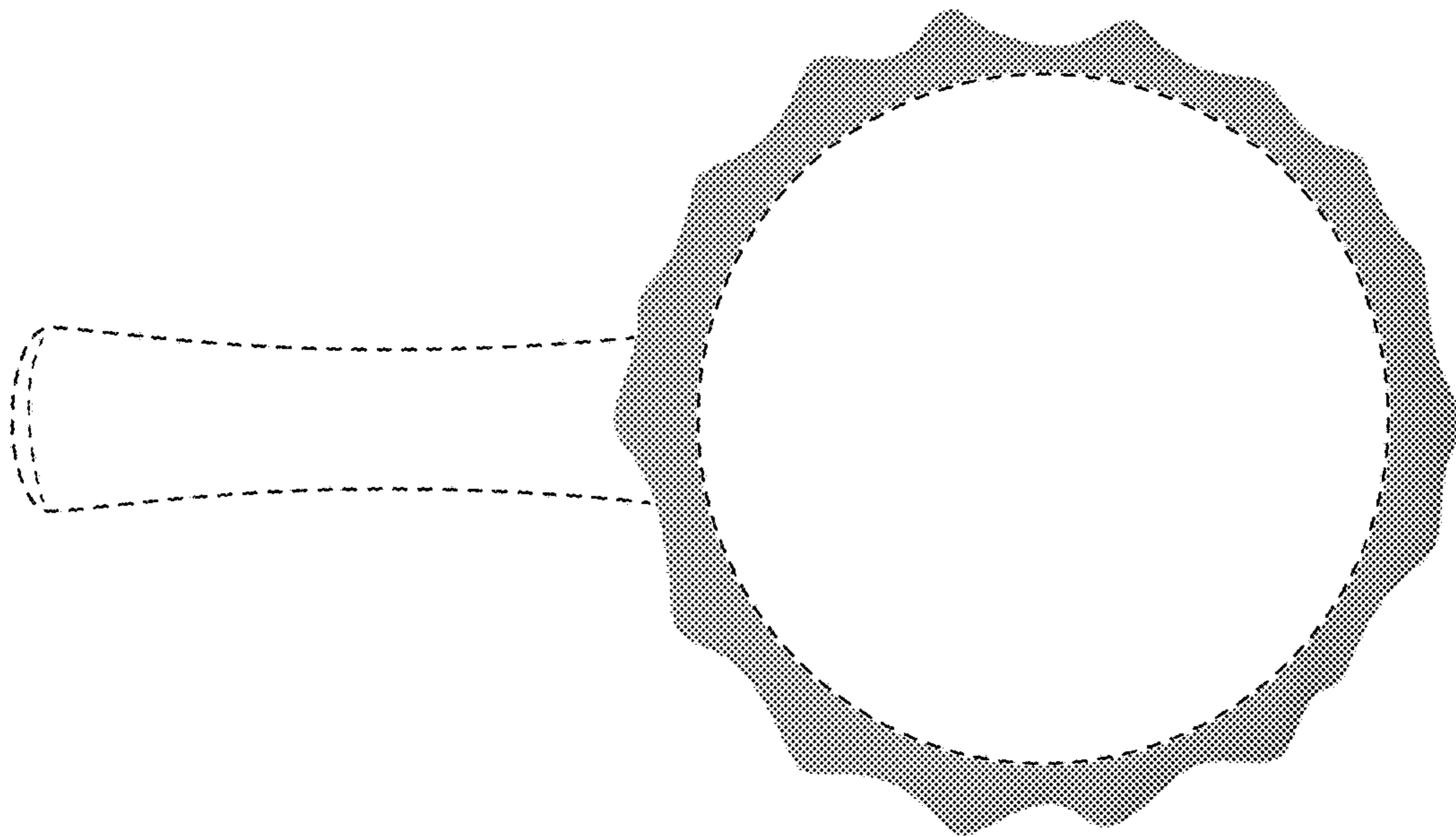
