FIG. 4 is a second side view of the vertical wall reveal of FIG. 1.

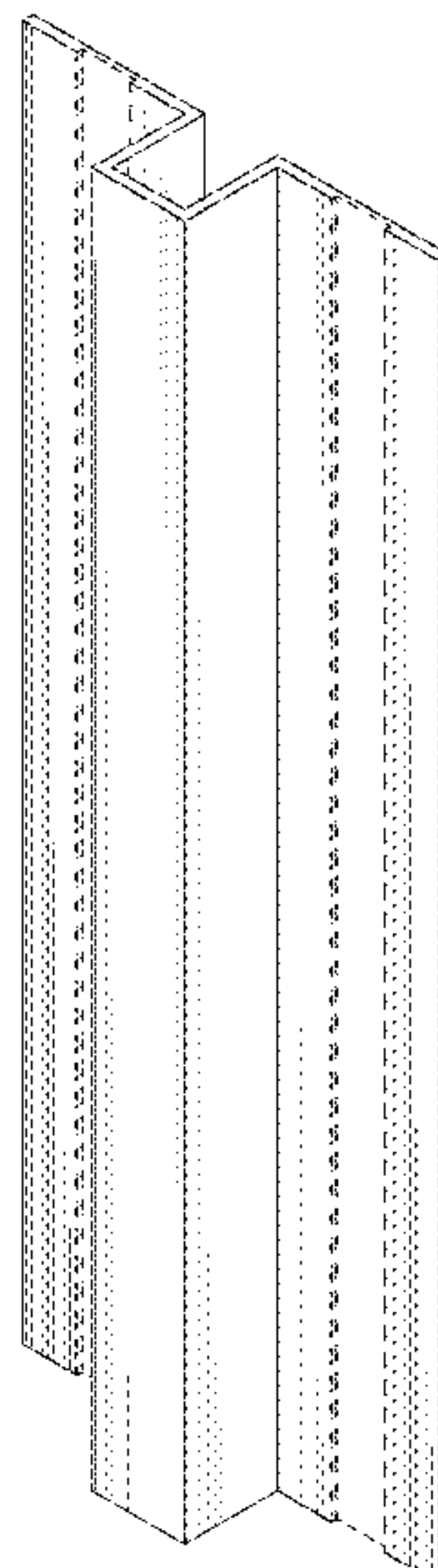
FIG. 5 is a front view of the vertical wall reveal of FIG. 1.

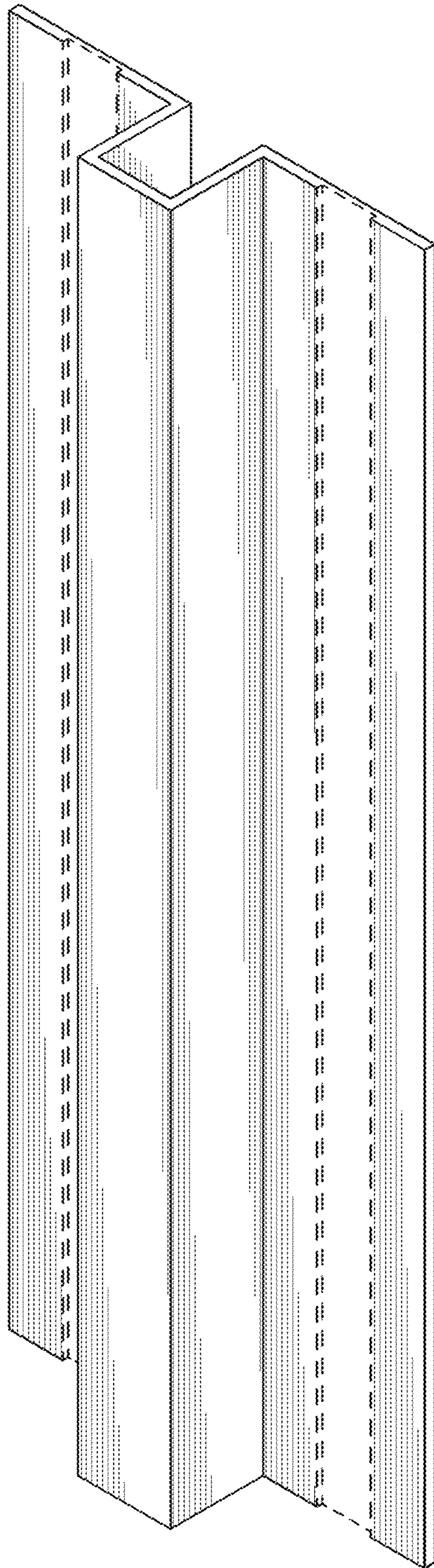

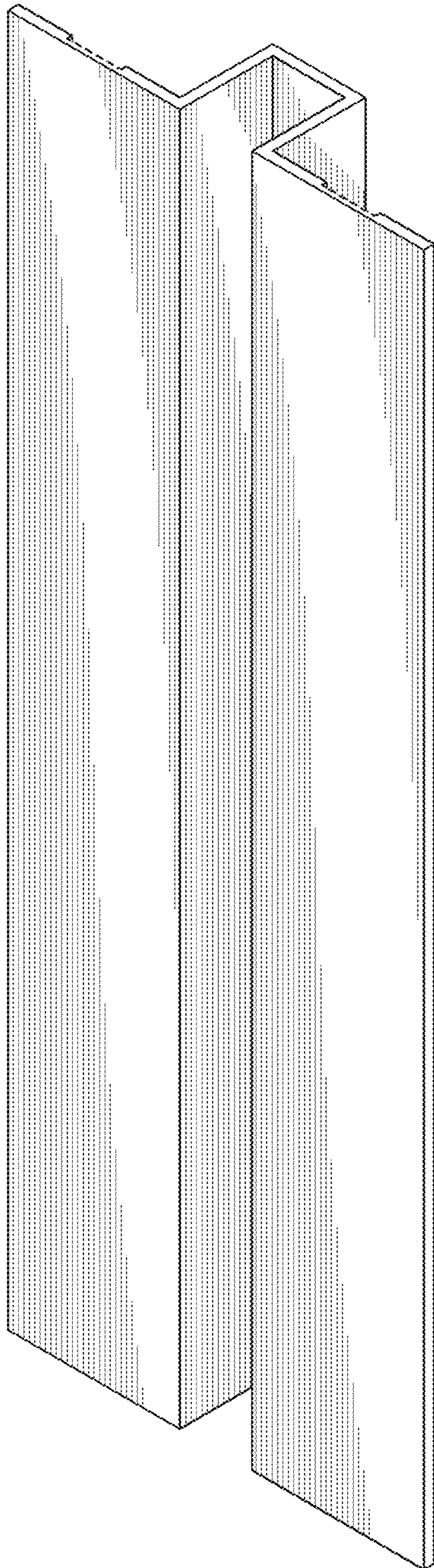

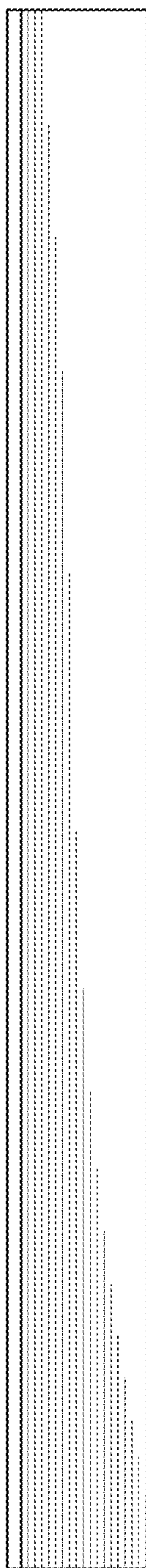

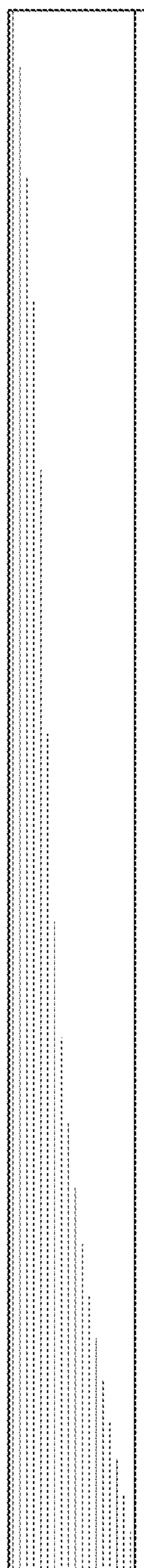

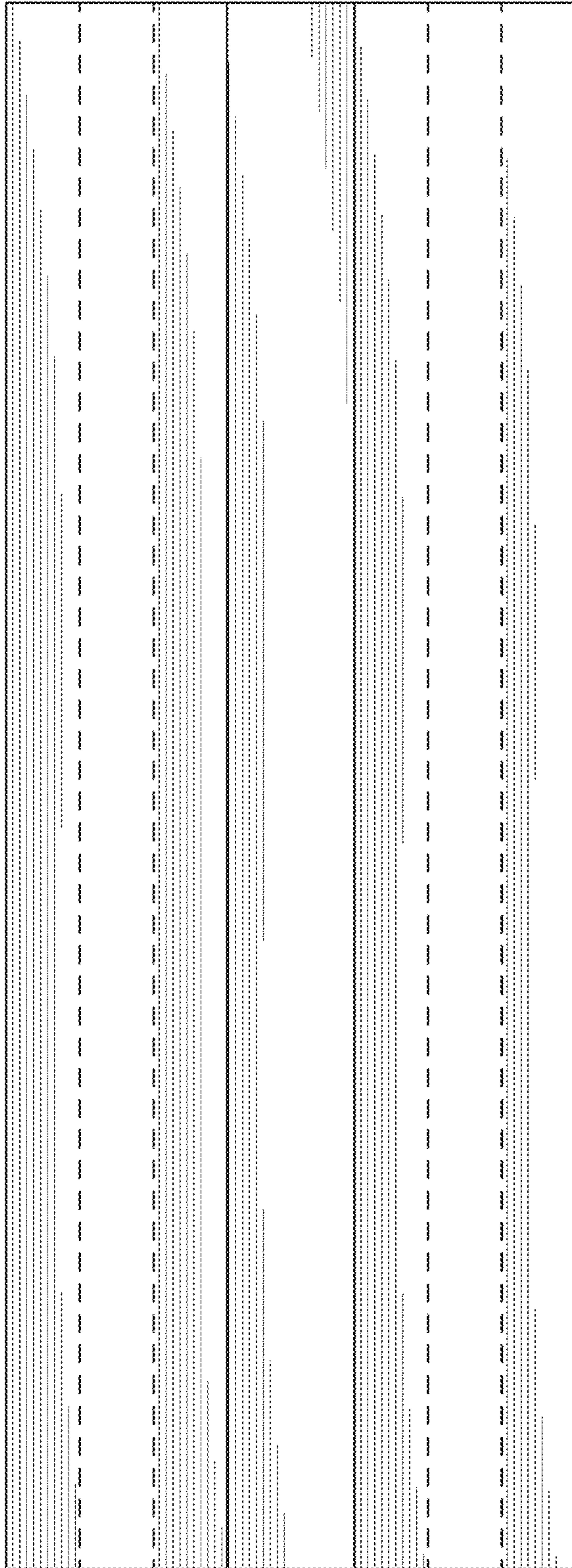

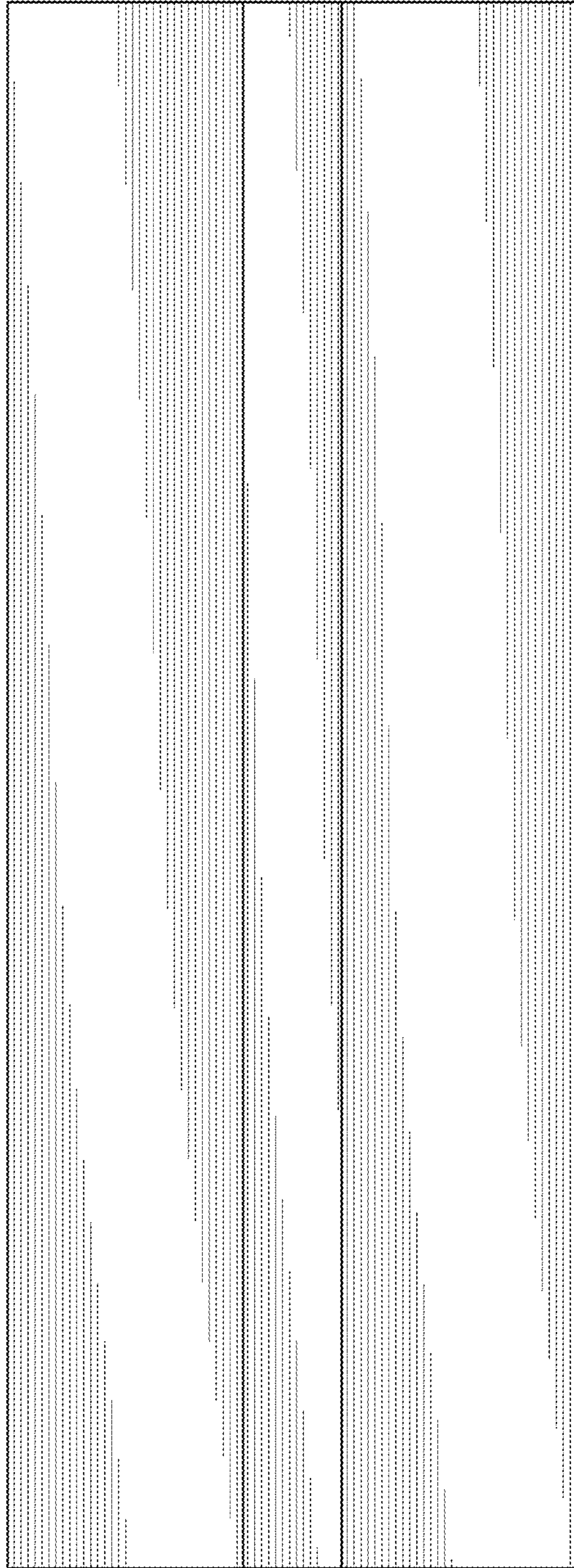

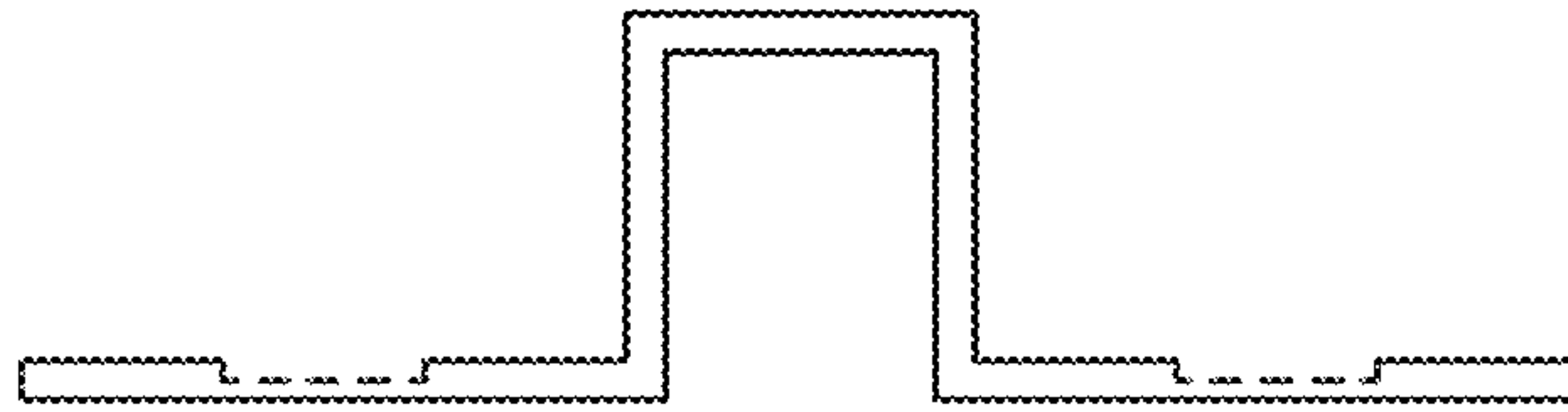

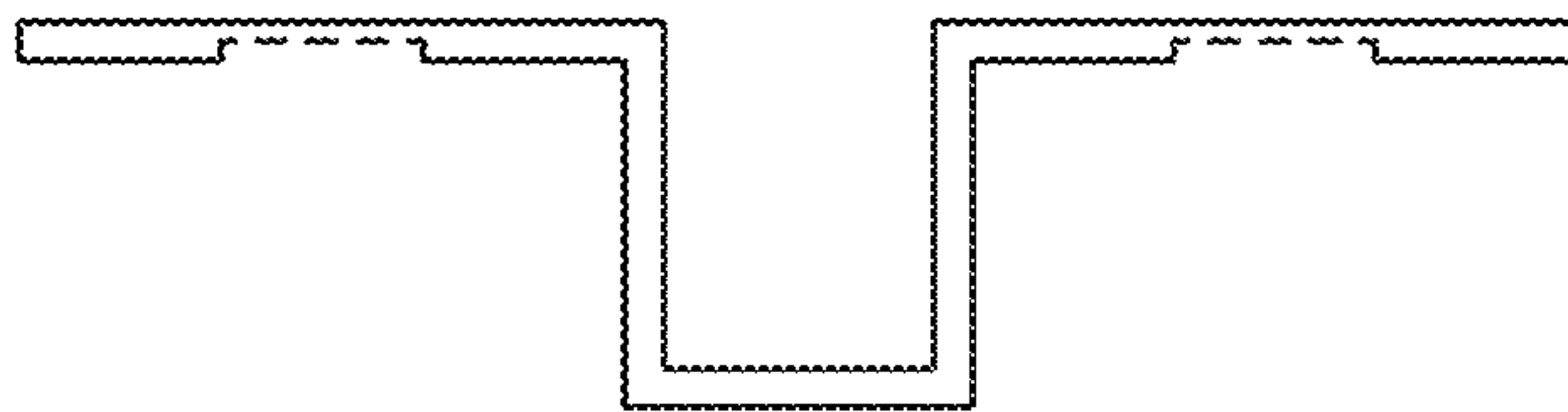
