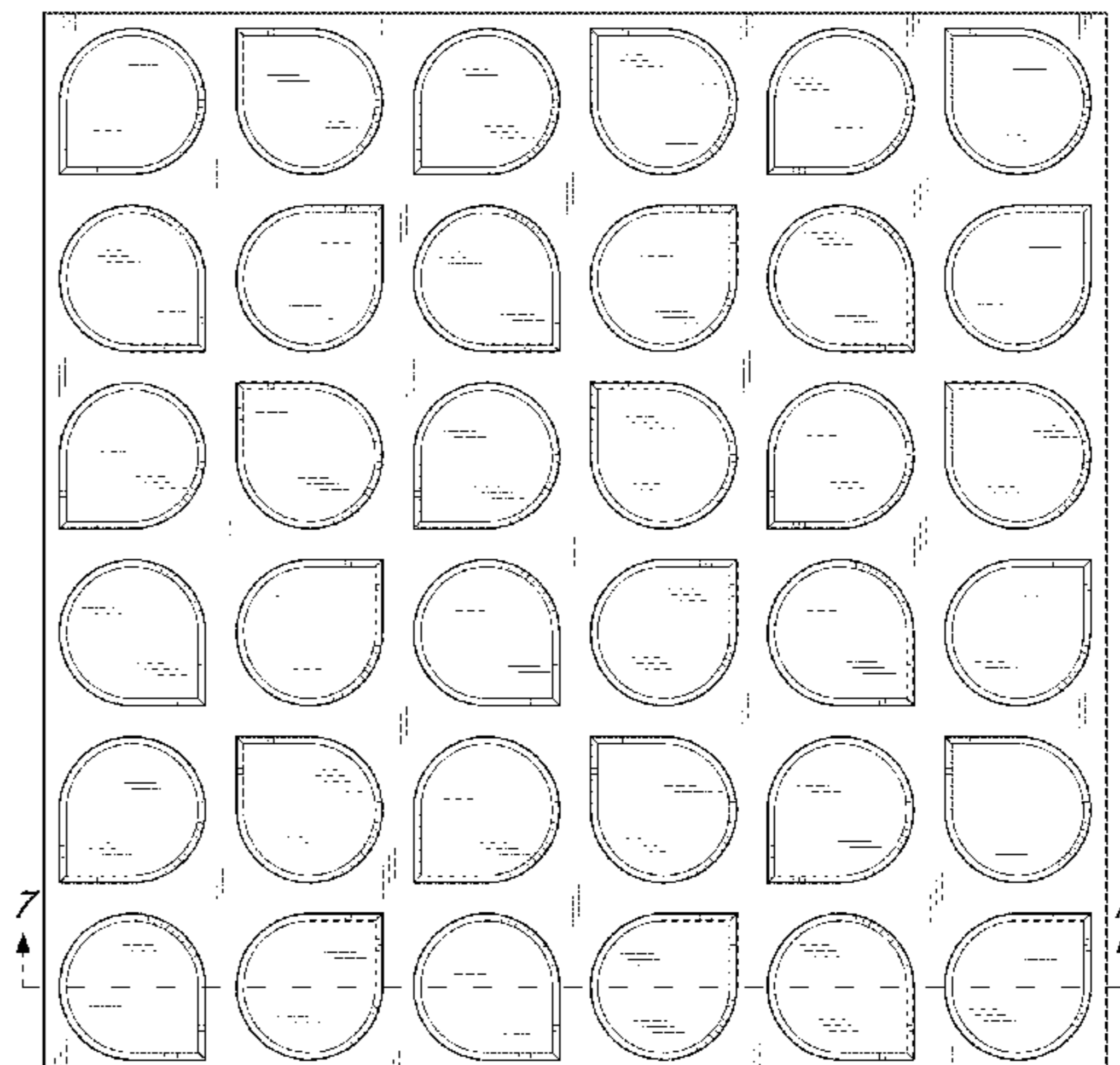
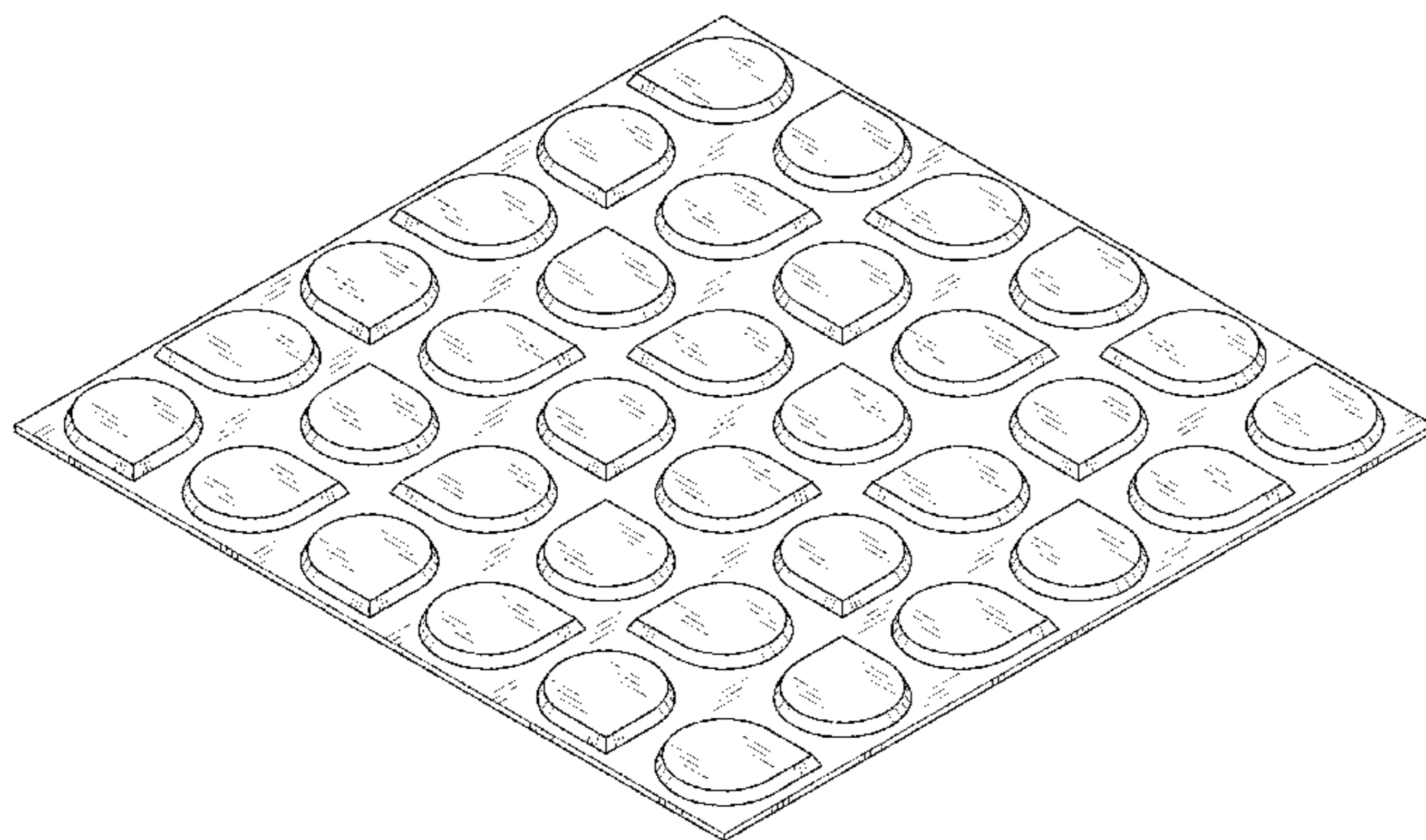
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top perspective view of a floor underlayment showing my new design;
 FIG. 2 is a bottom, perspective view thereof;

 FIG. 4 is a left side elevation view thereof;

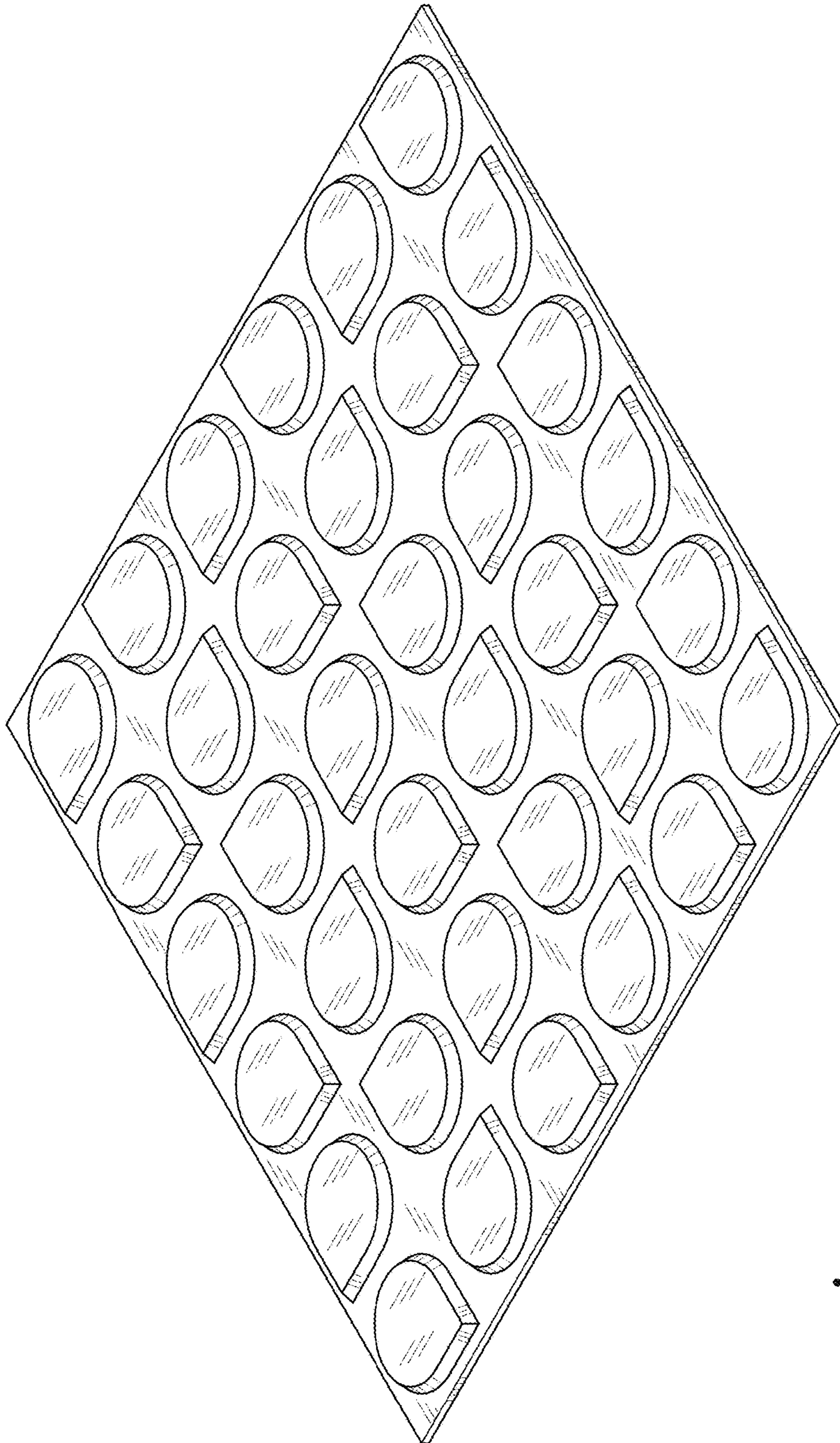

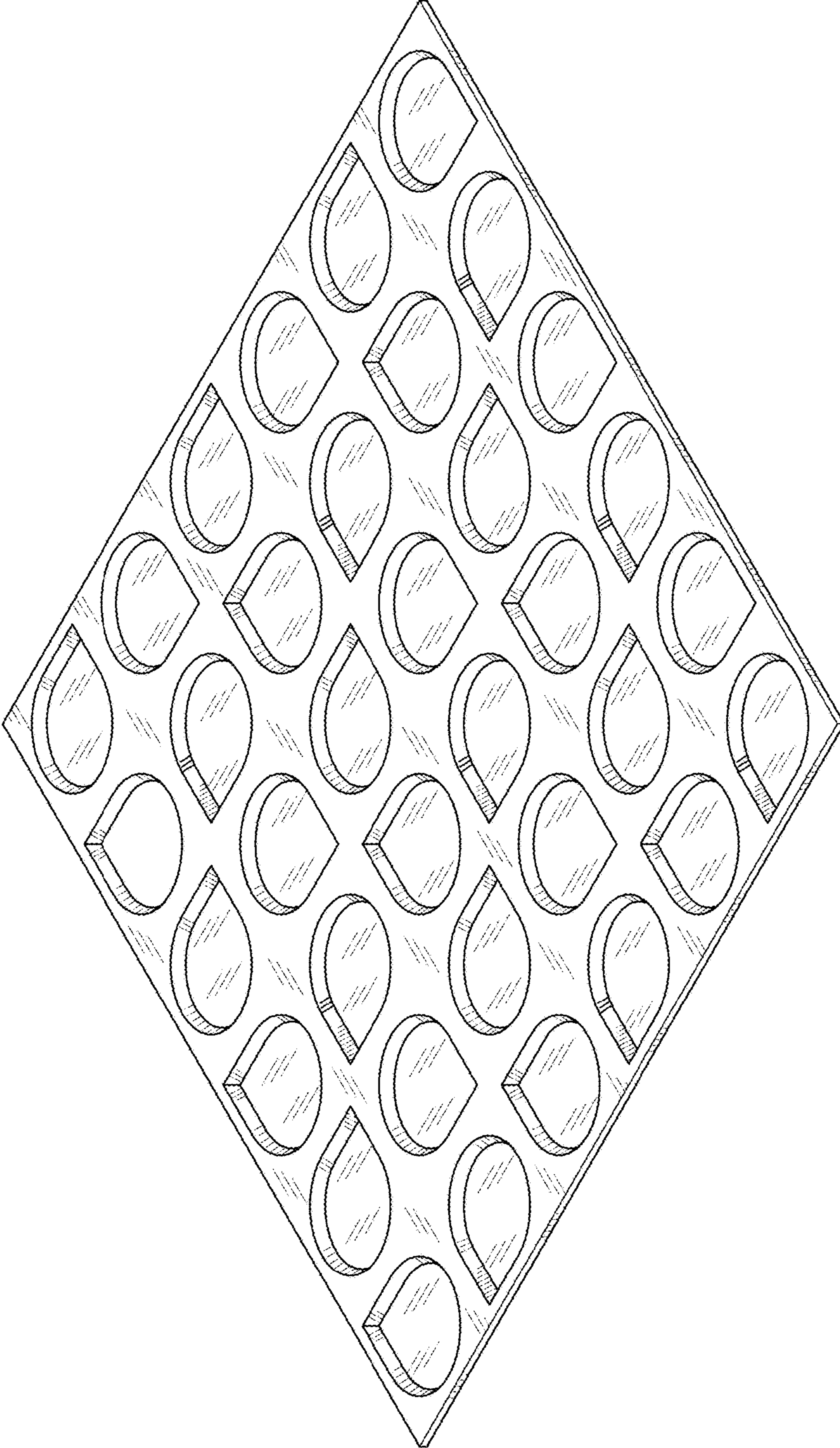

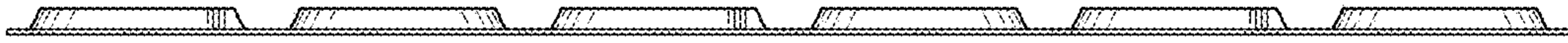

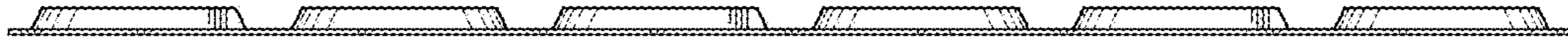

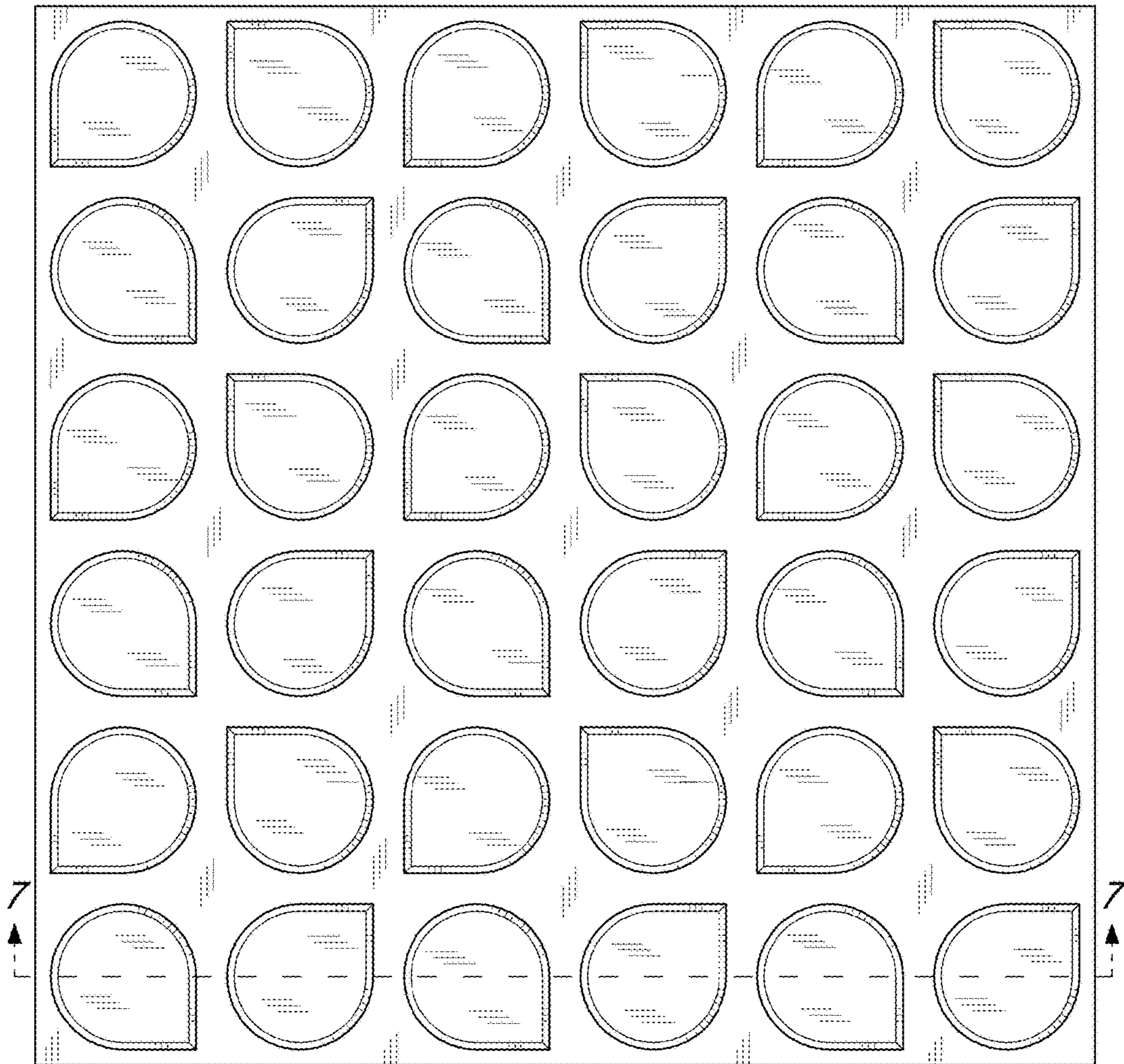

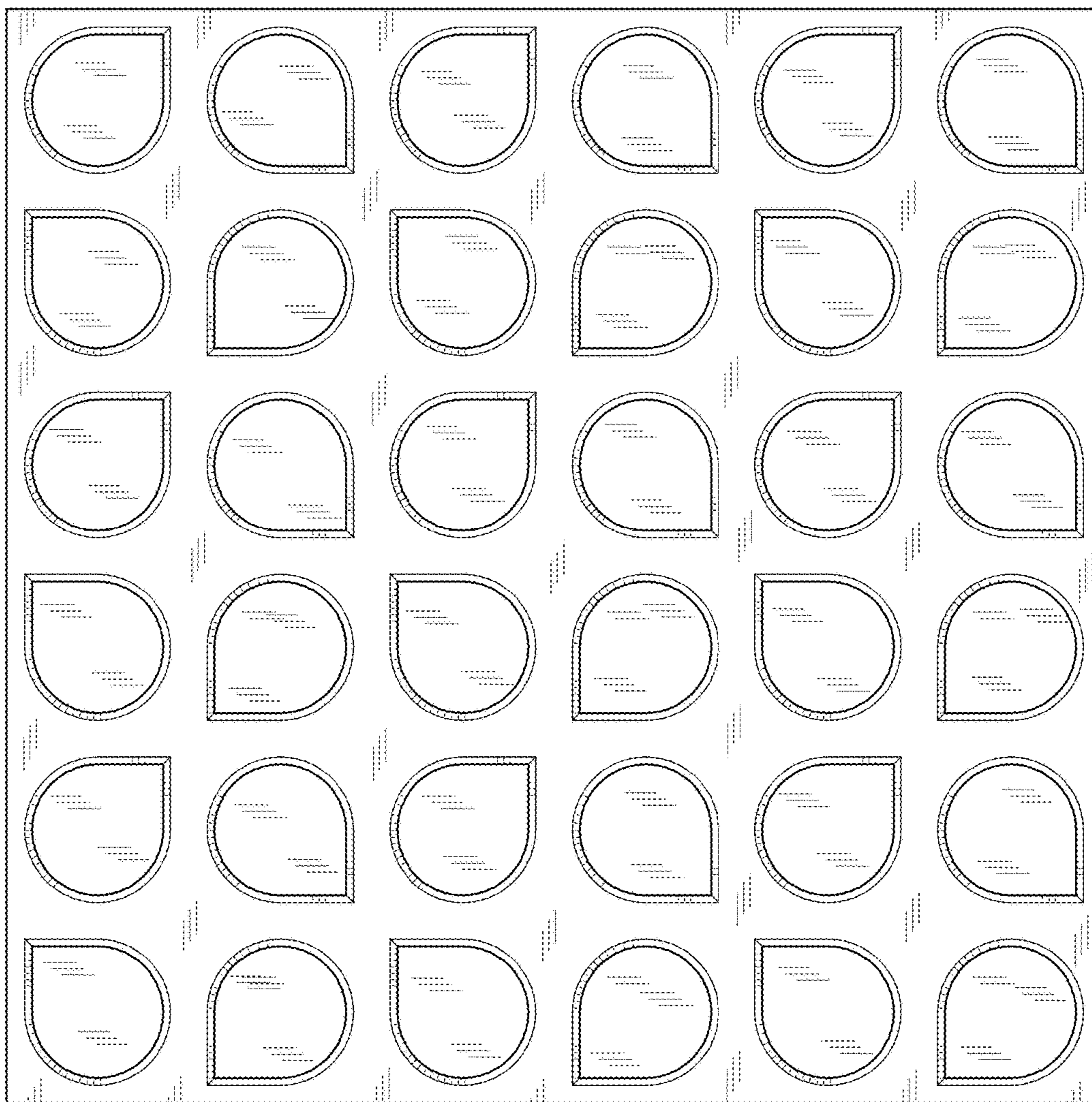

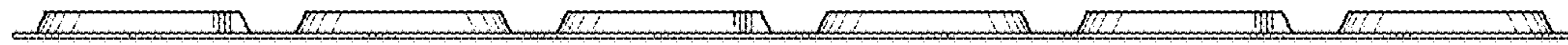
