(57) **CLAIM**

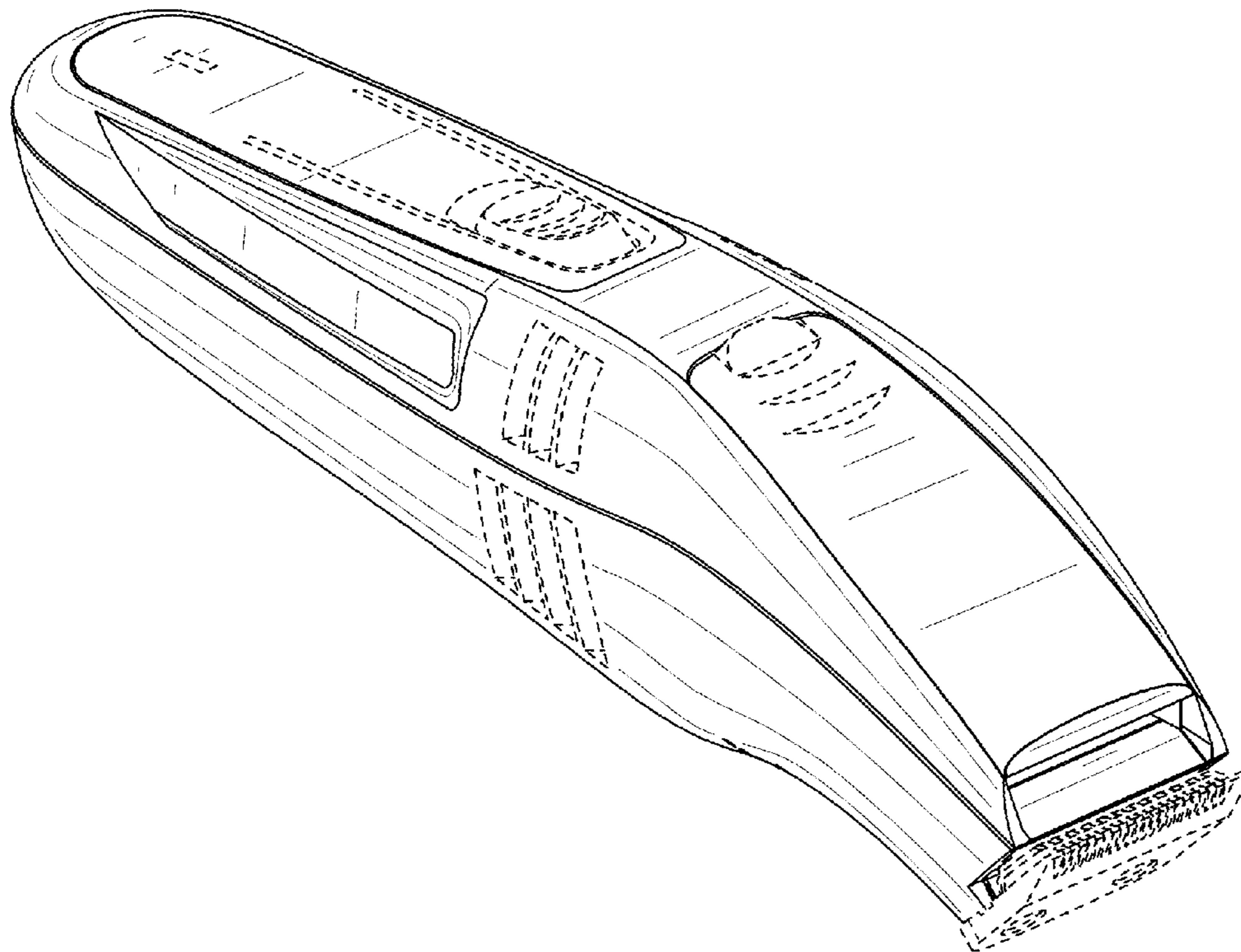
The ornamental design for a hair clipper housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the present hair clipper housing;  
 FIG. 2 is a top plan view of same;  
 FIG. 3 is a bottom view of the hair clipper housing of FIG. 1;  
 FIG. 4 is a right side view of same;  
 FIG. 5 is a left side view of the hair clipper housing of FIG. 1;  
 FIG. 6 is a front view of same; and,  
 FIG. 7 is a rear view of the hair clipper housing of FIG. 1.  
 The broken line disclosure of the clipper blade illustrates the environment. The remaining broken lines illustrate portions of the hair clipper housing. None of the broken lines forms part of the claimed design.

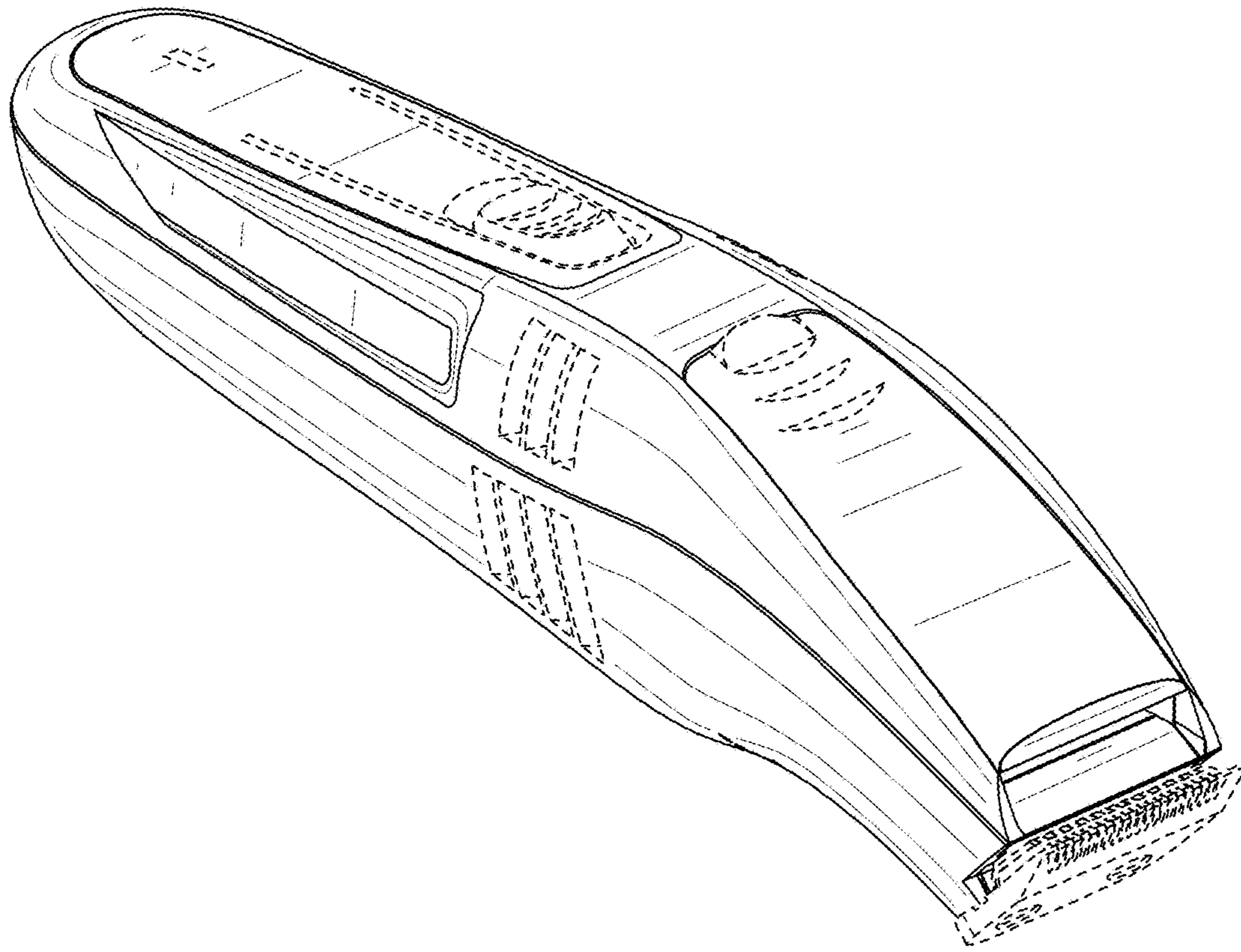

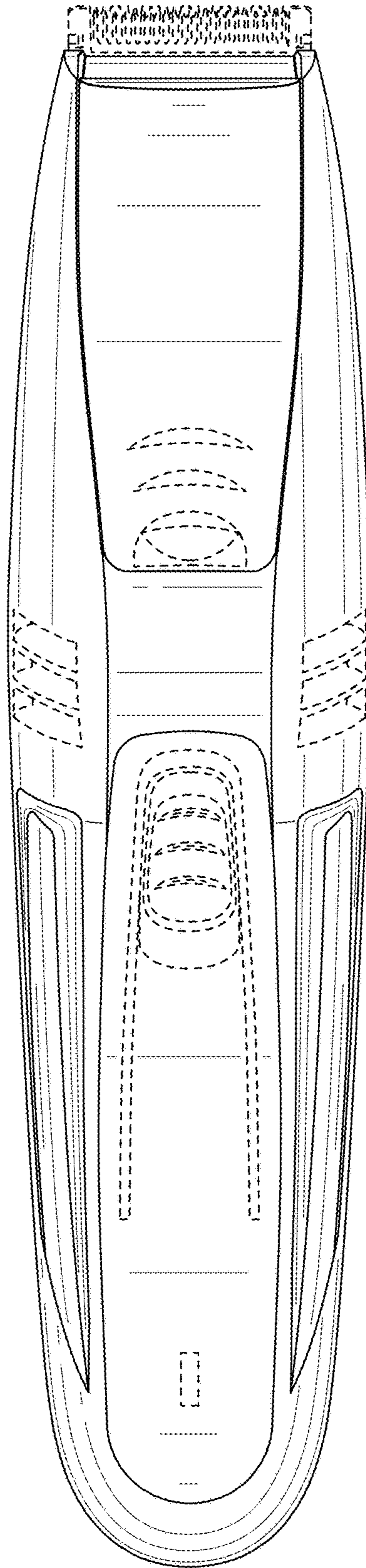

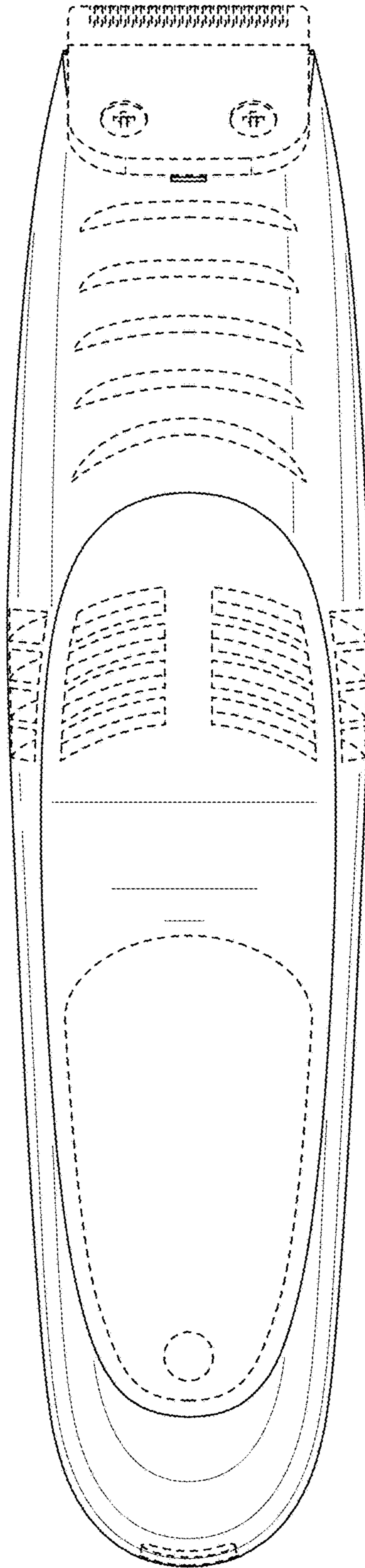

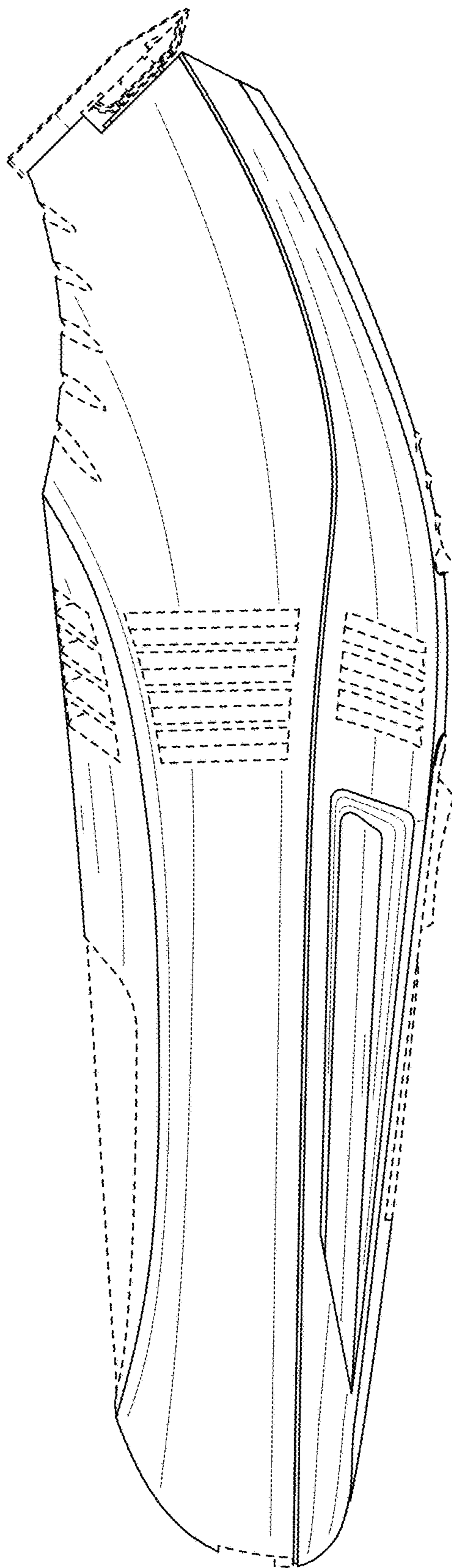

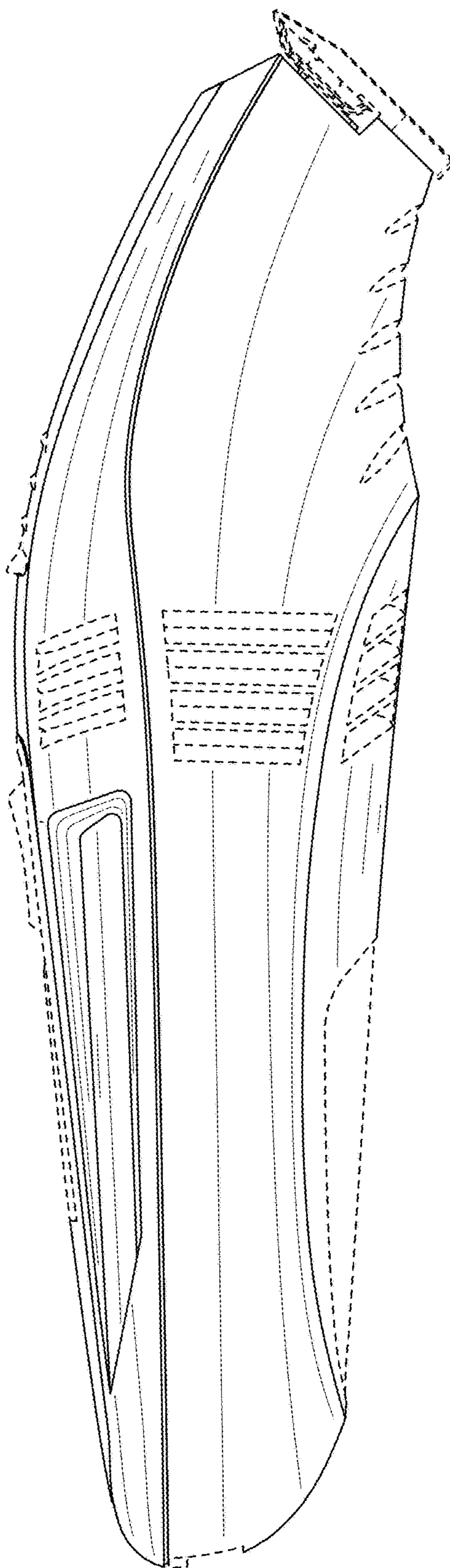

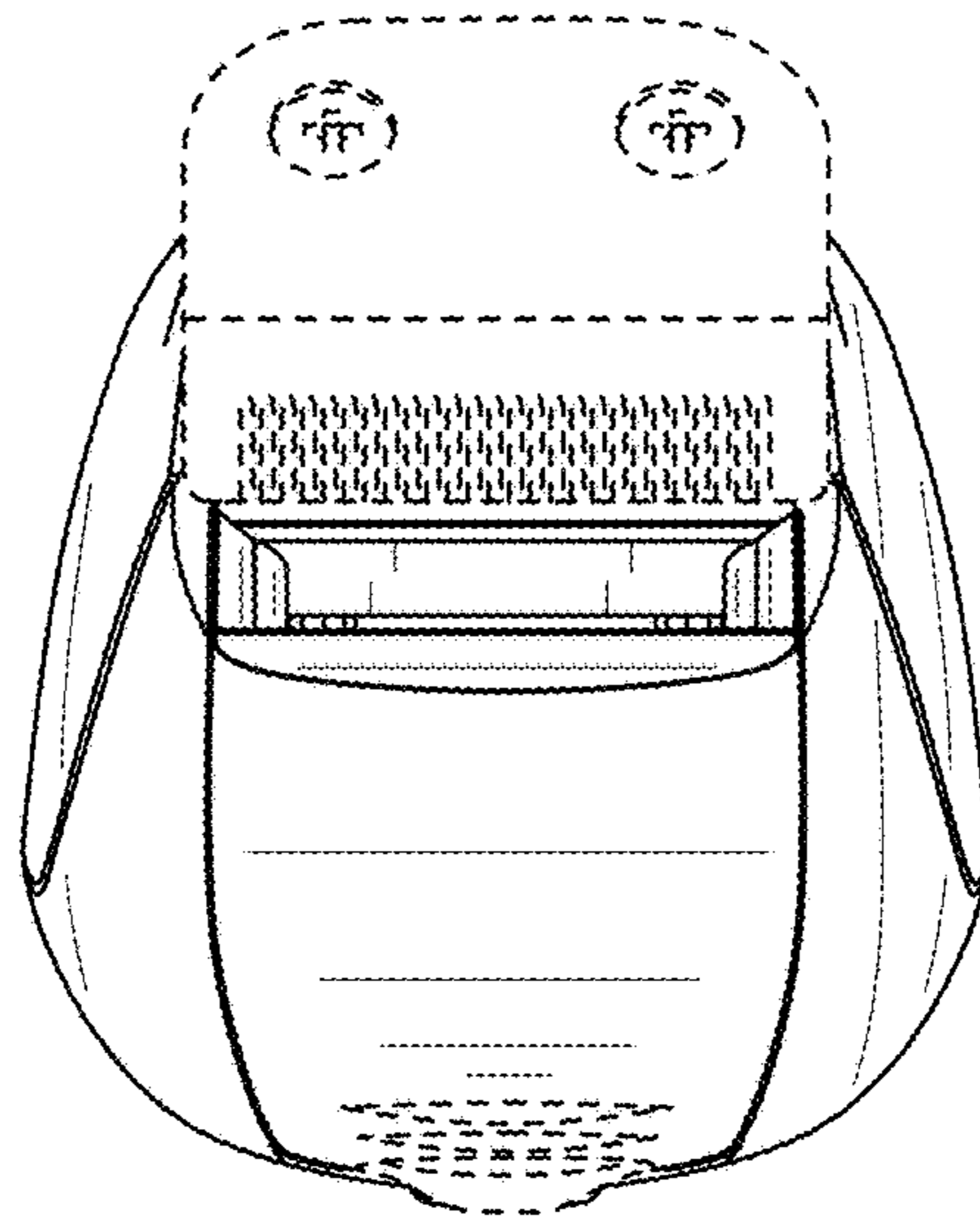

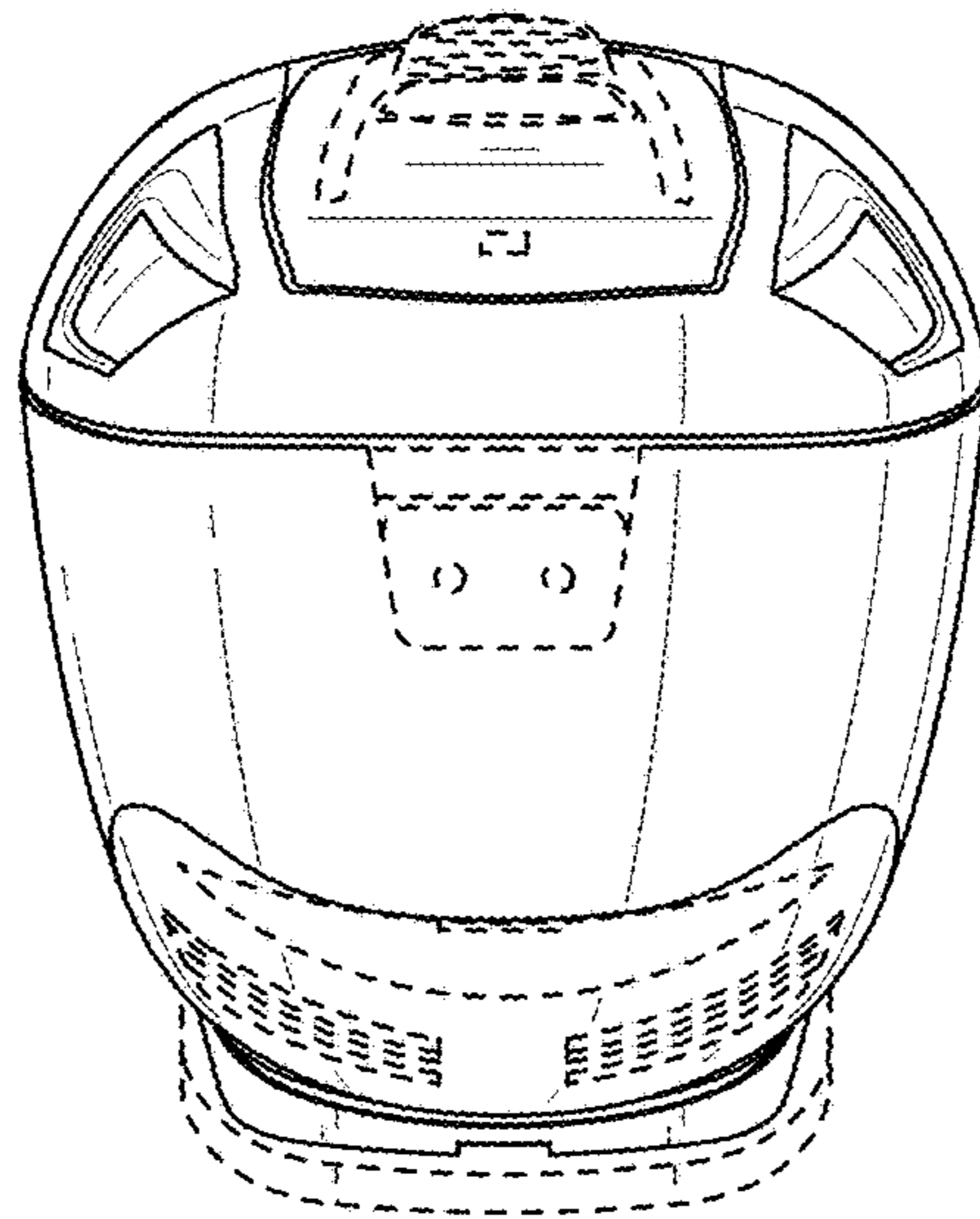
