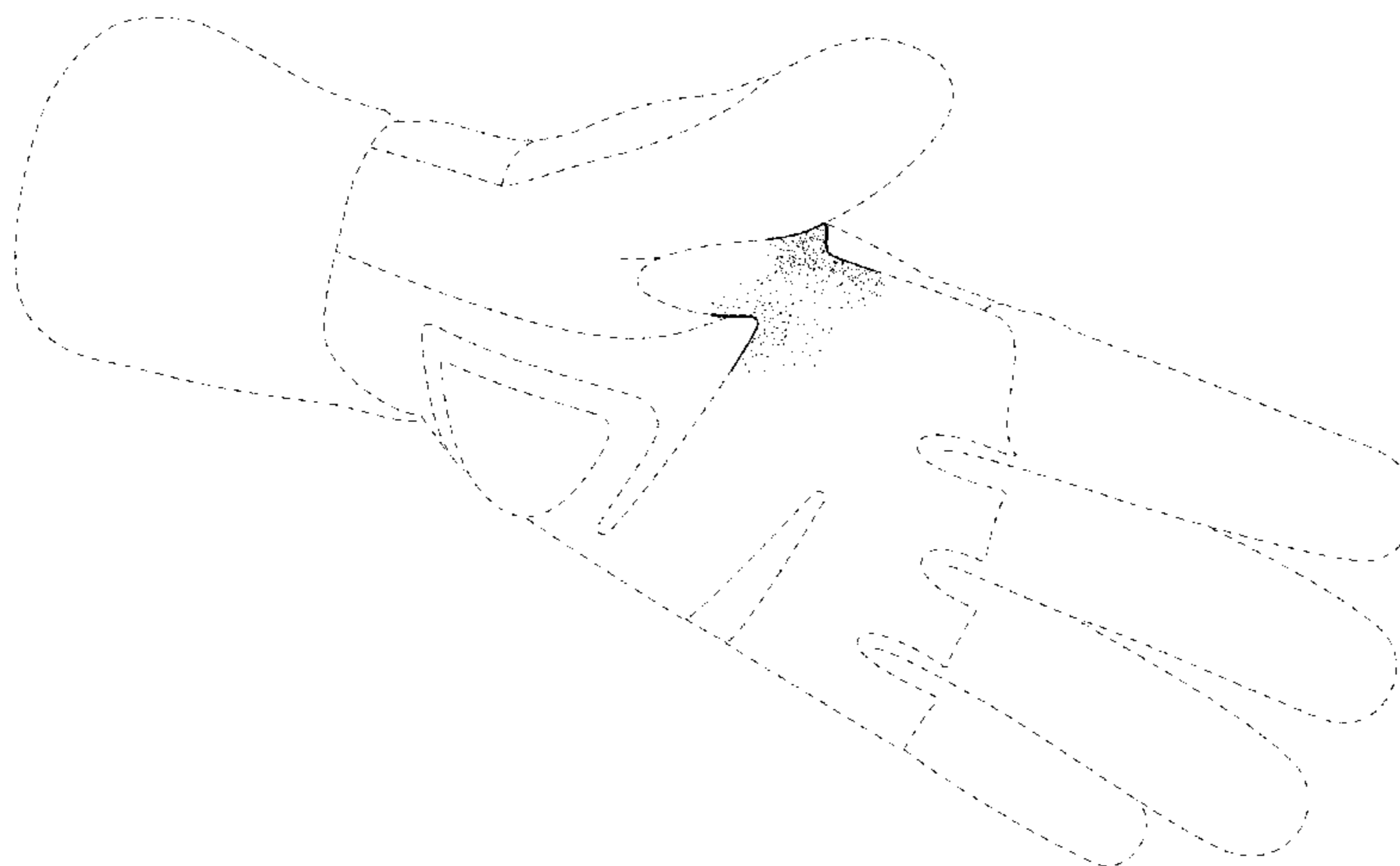
(57) **CLAIM**

The ornamental design for a glove, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a glove showing the design;
FIG. 2 is a top, rear, left side perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof with the left side being a mirror image; and,
FIG. 5 is a front elevation view of a flat pattern overlay.

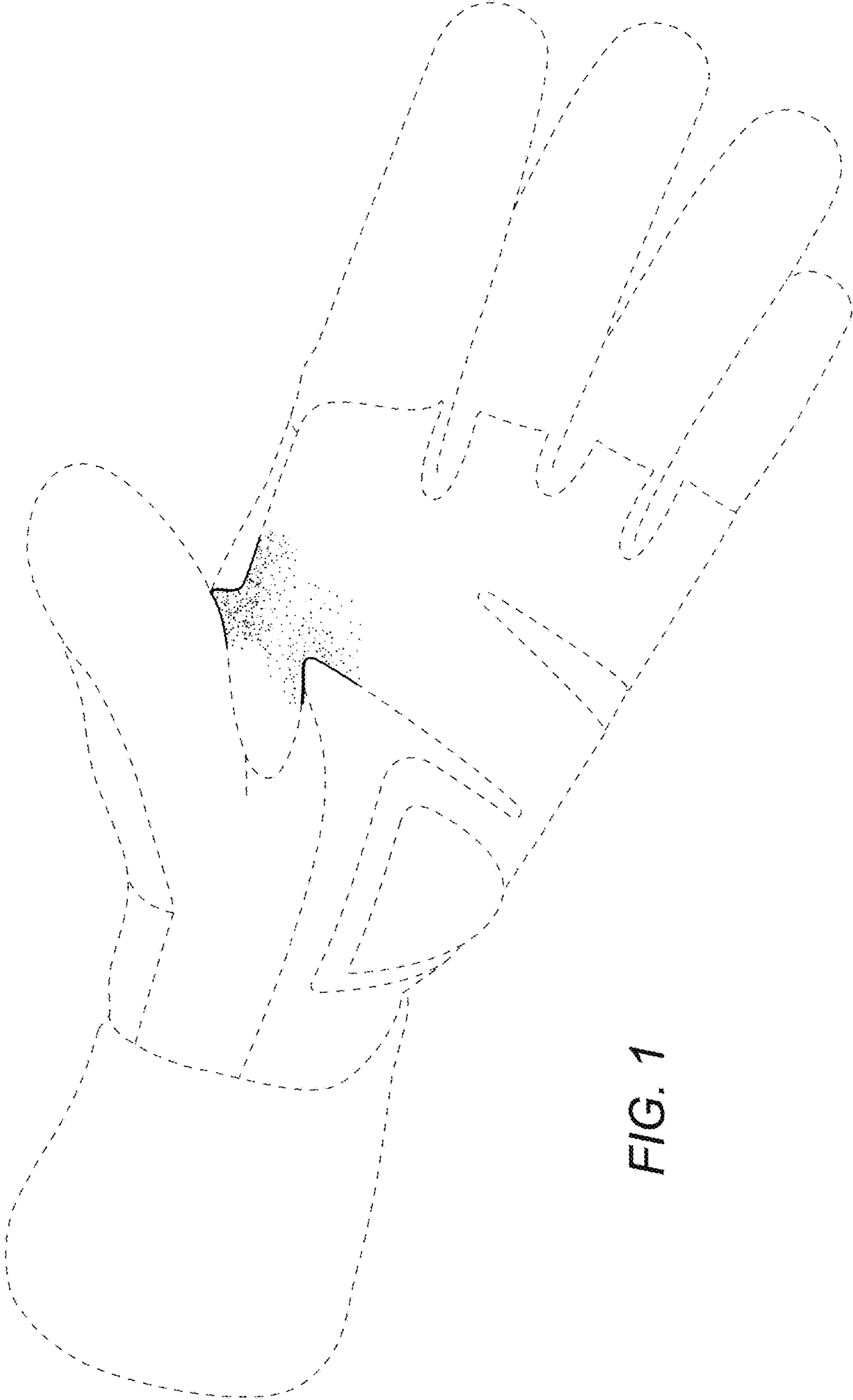

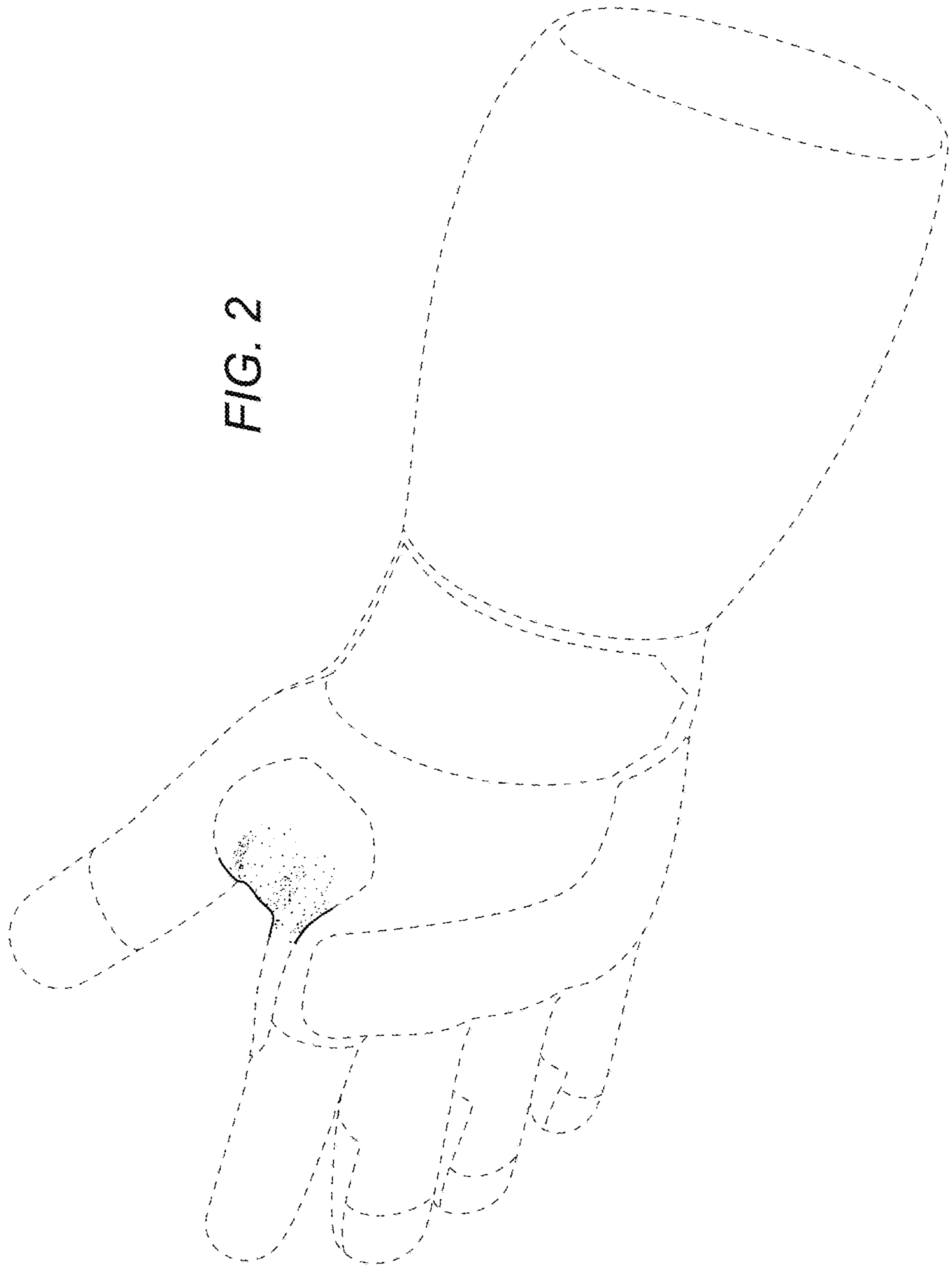

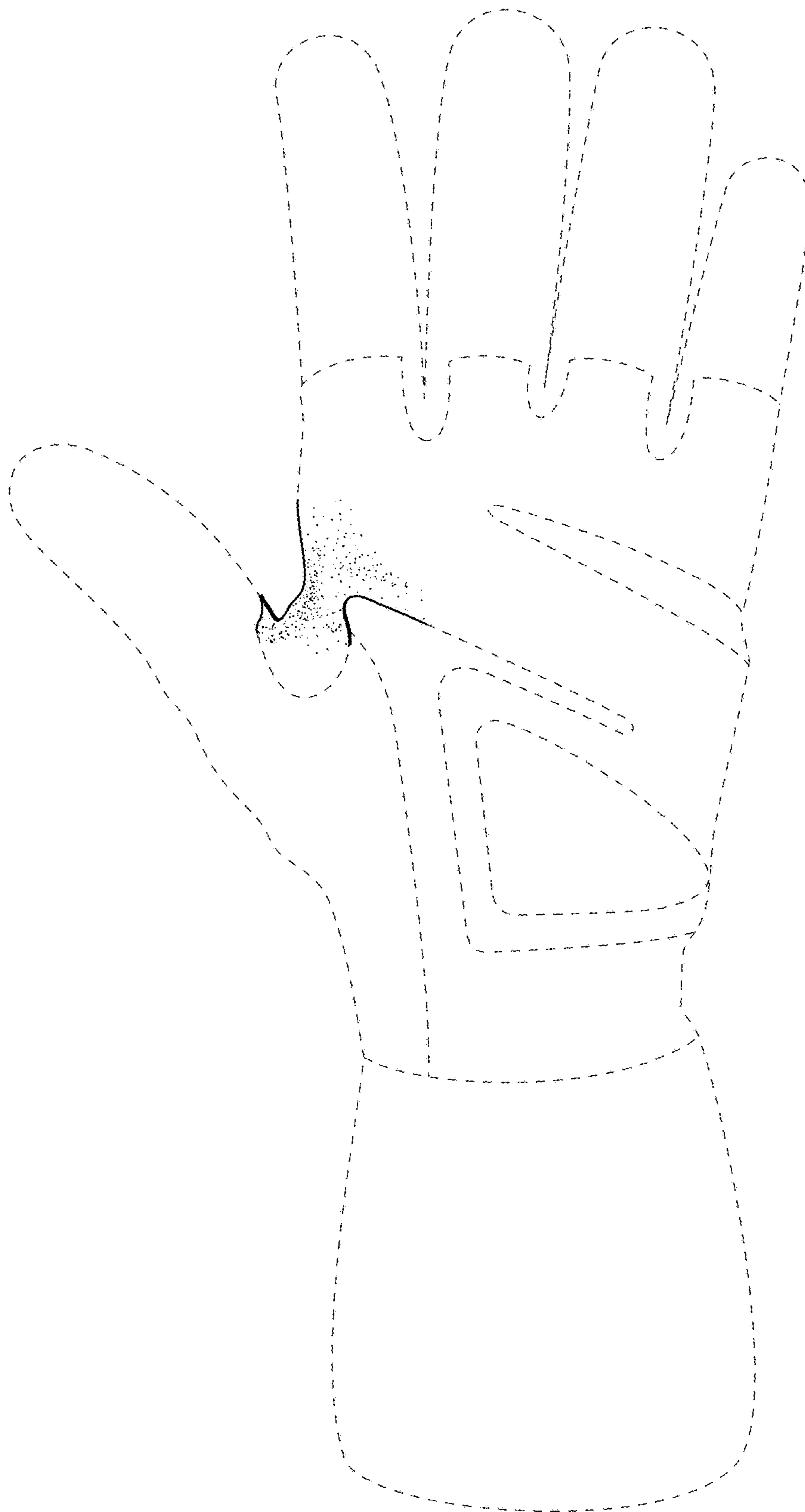

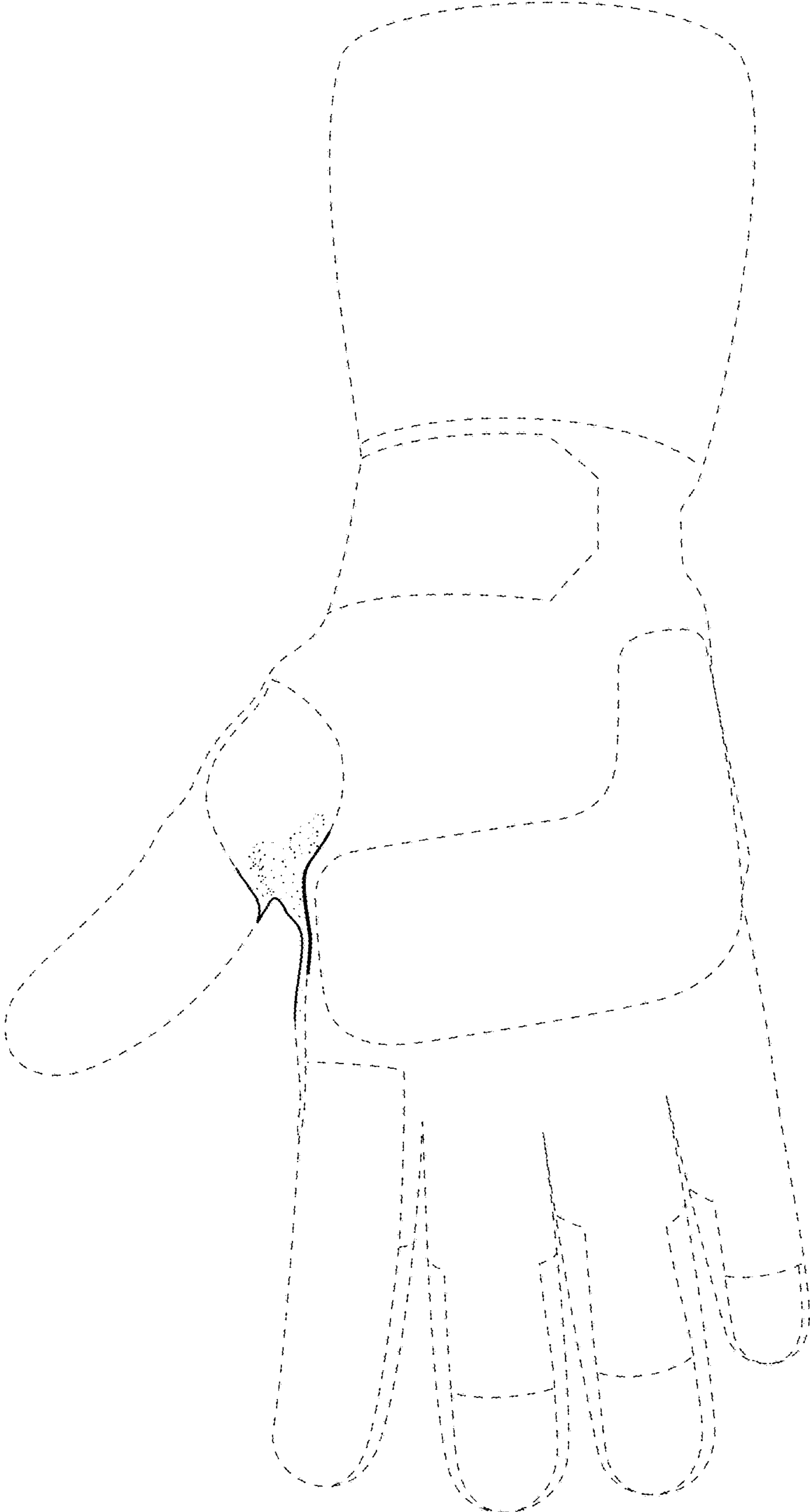

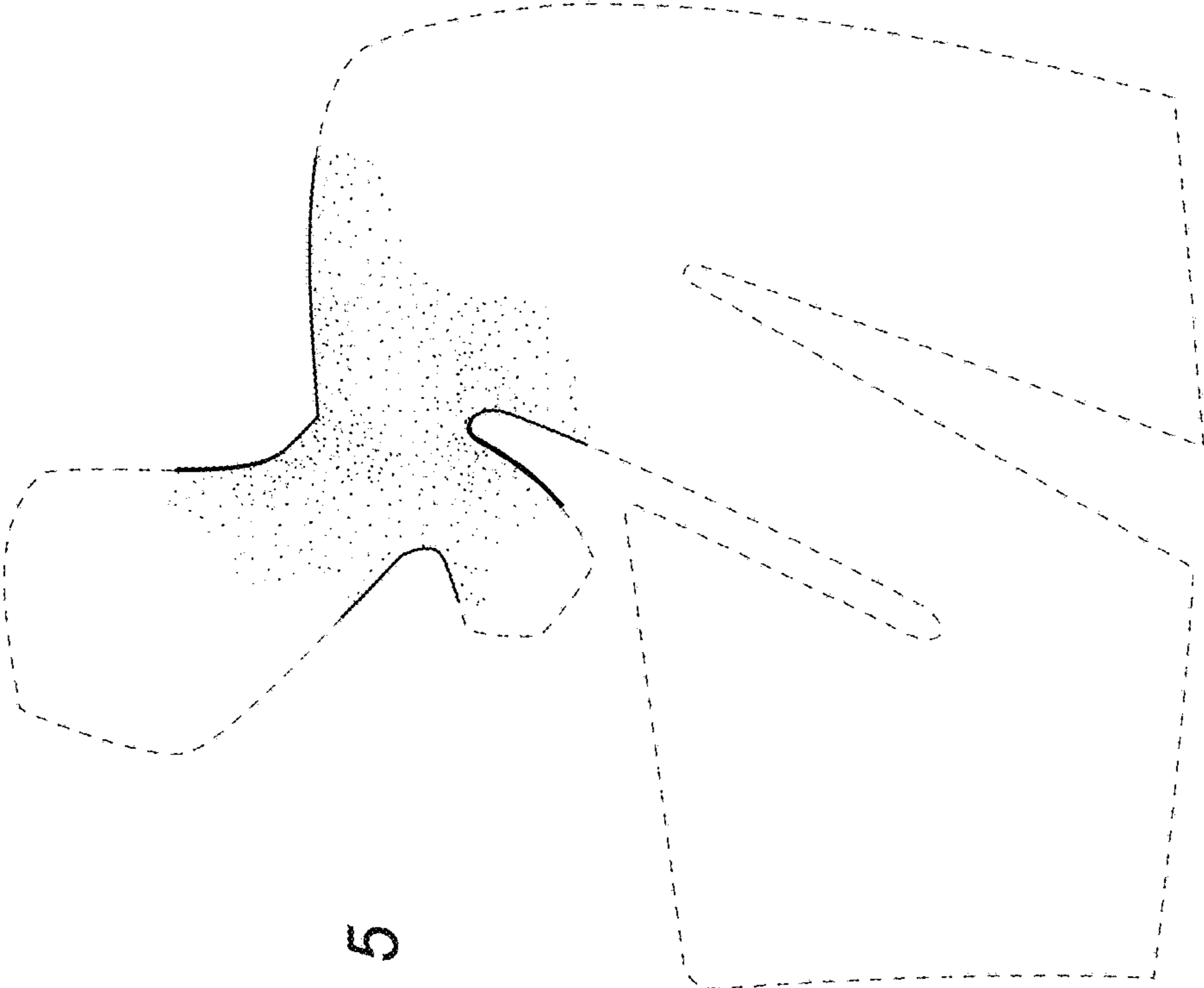
