The ornamental design for an underwear or swimwear enhanced with three dimensional design features and mirrored design waistband, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the underwear or swimwear enhanced with three dimensional design features and mirrored design waistband.

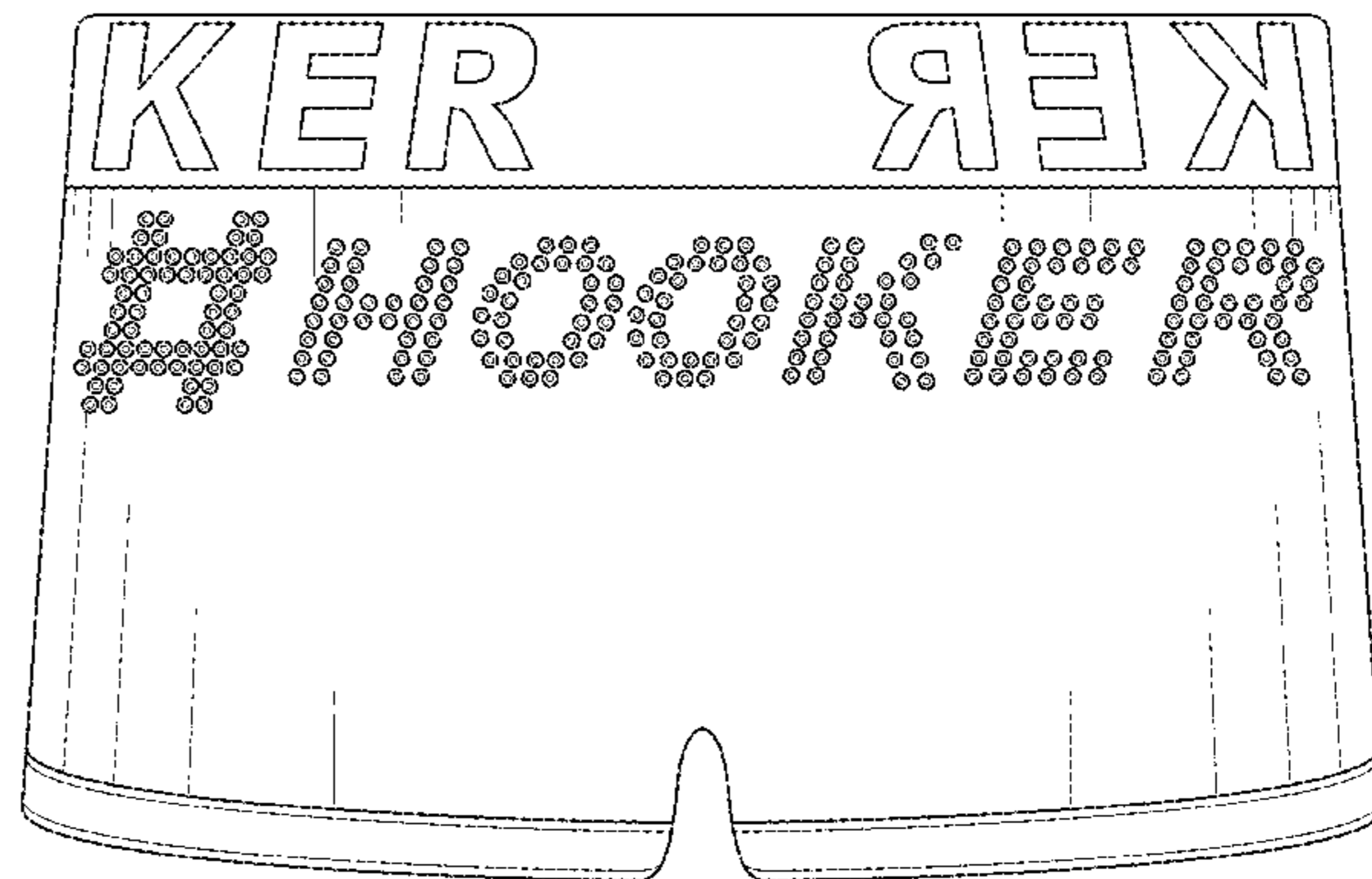
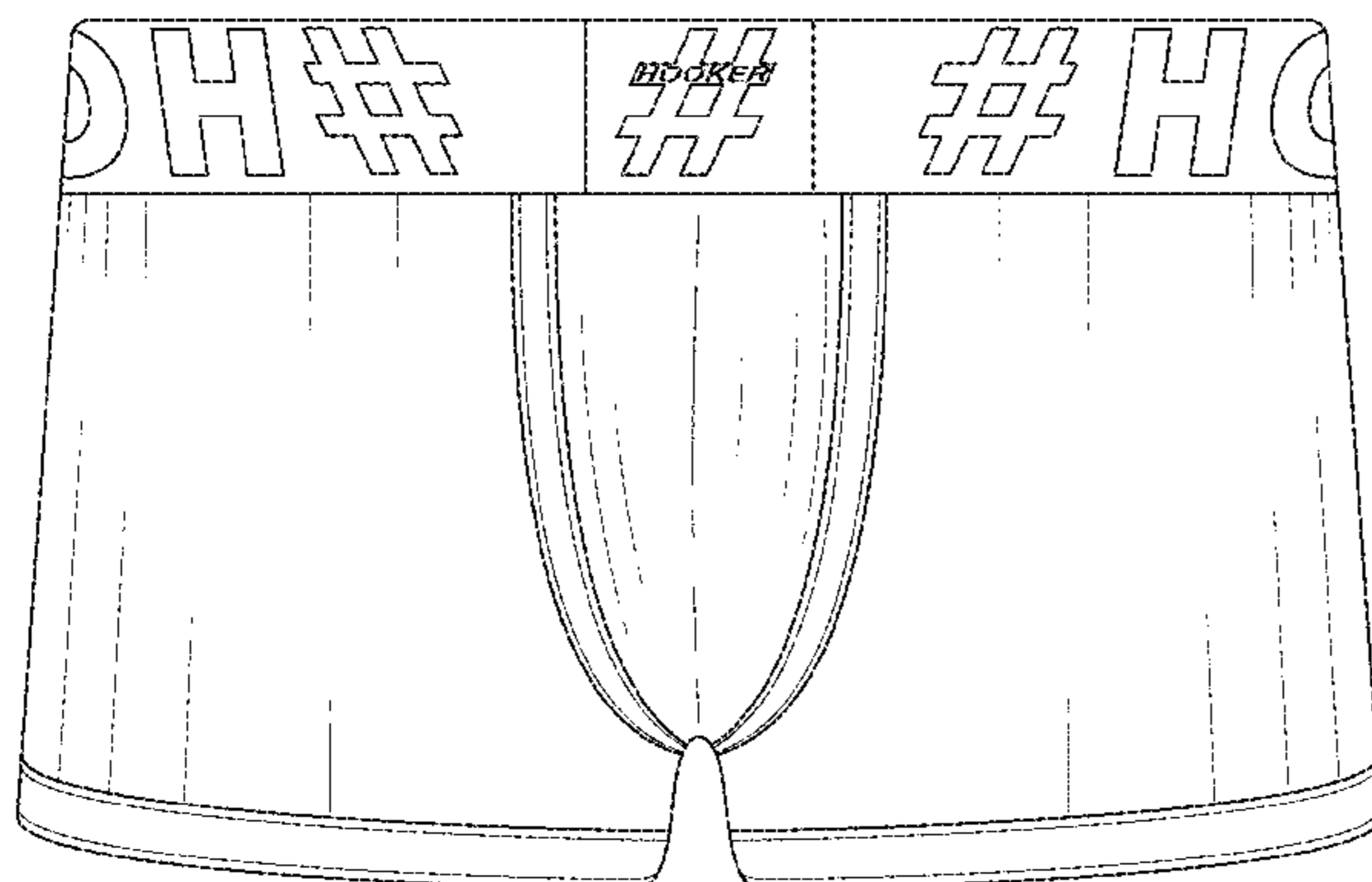

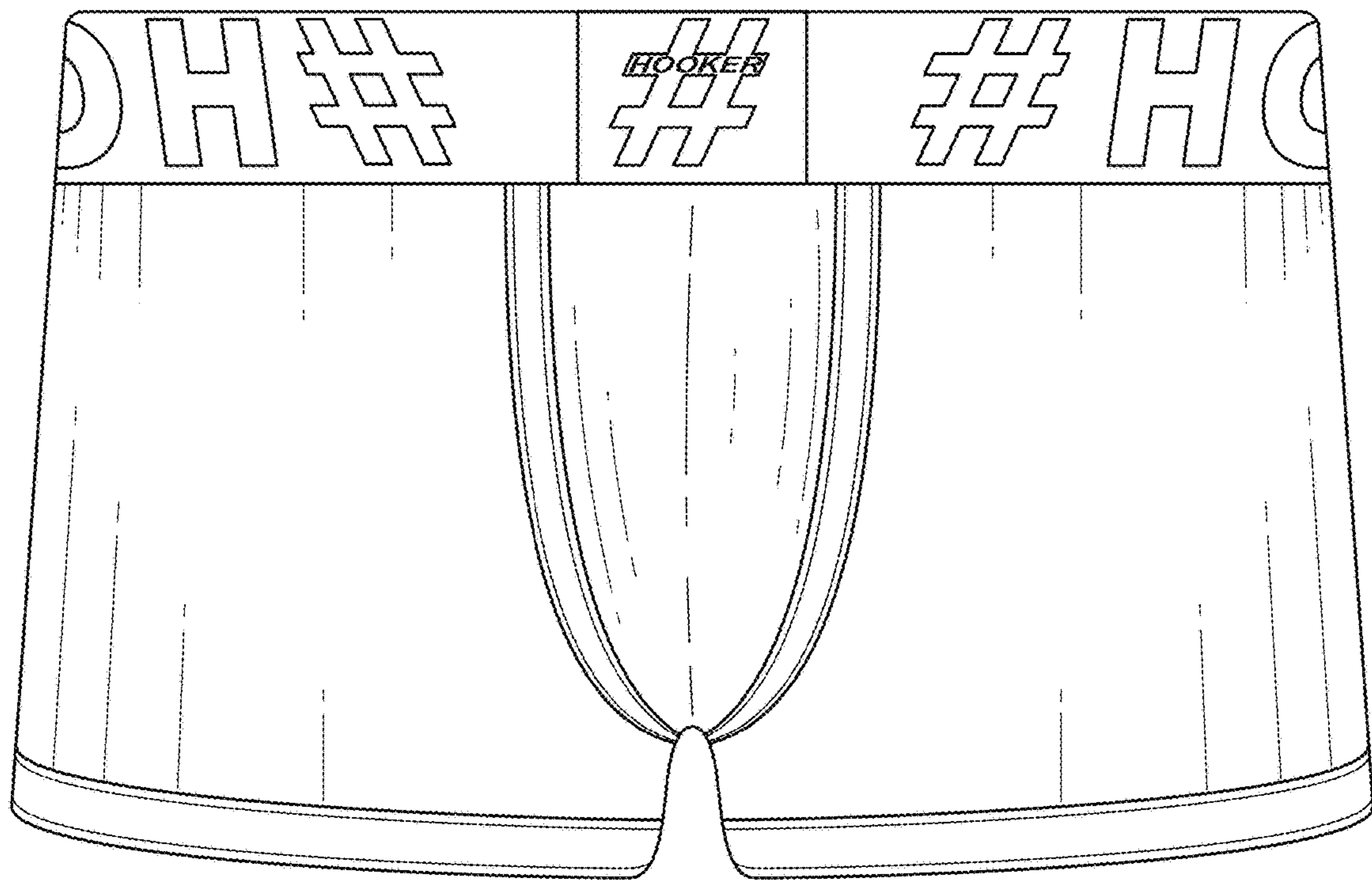

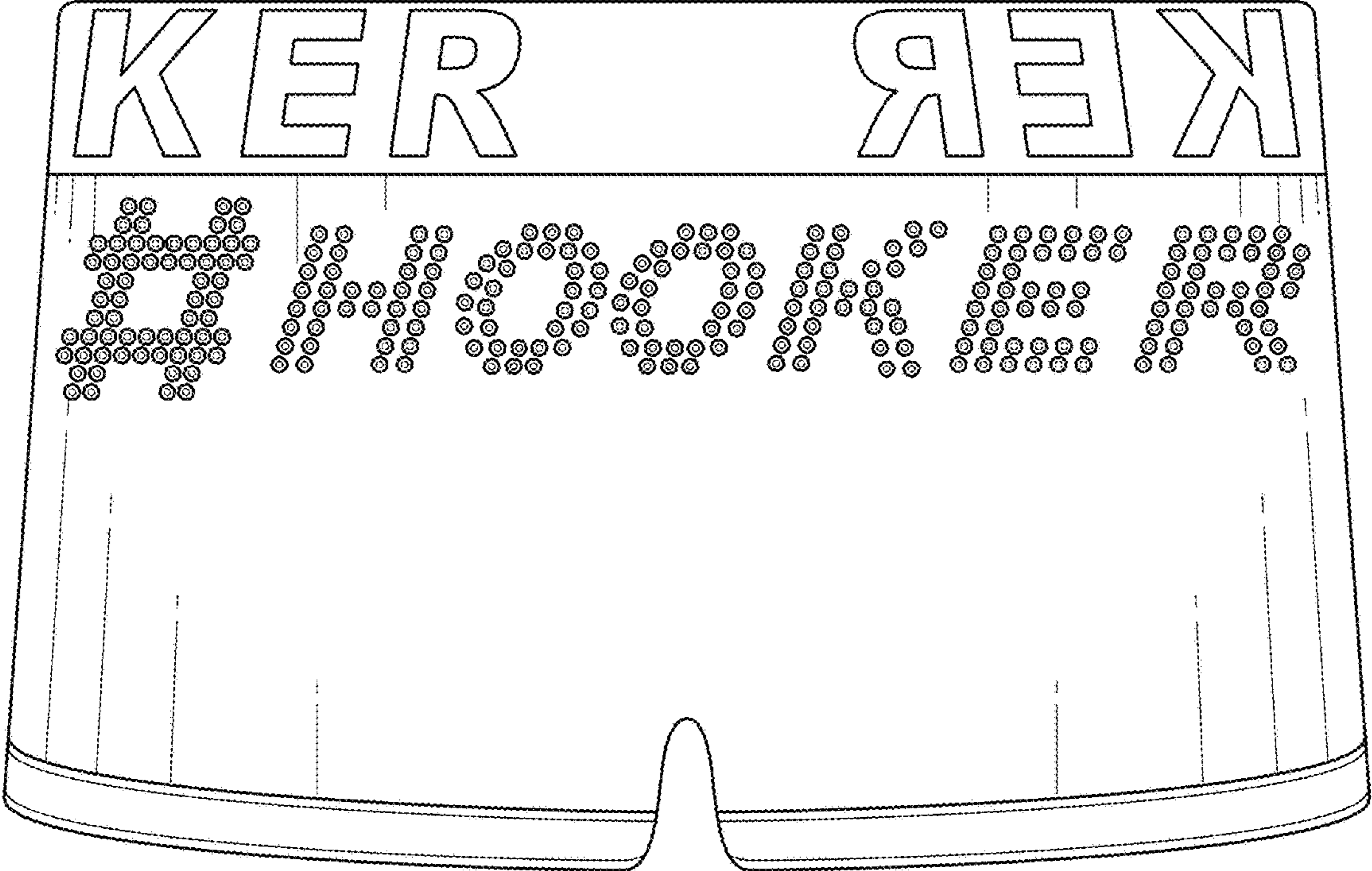

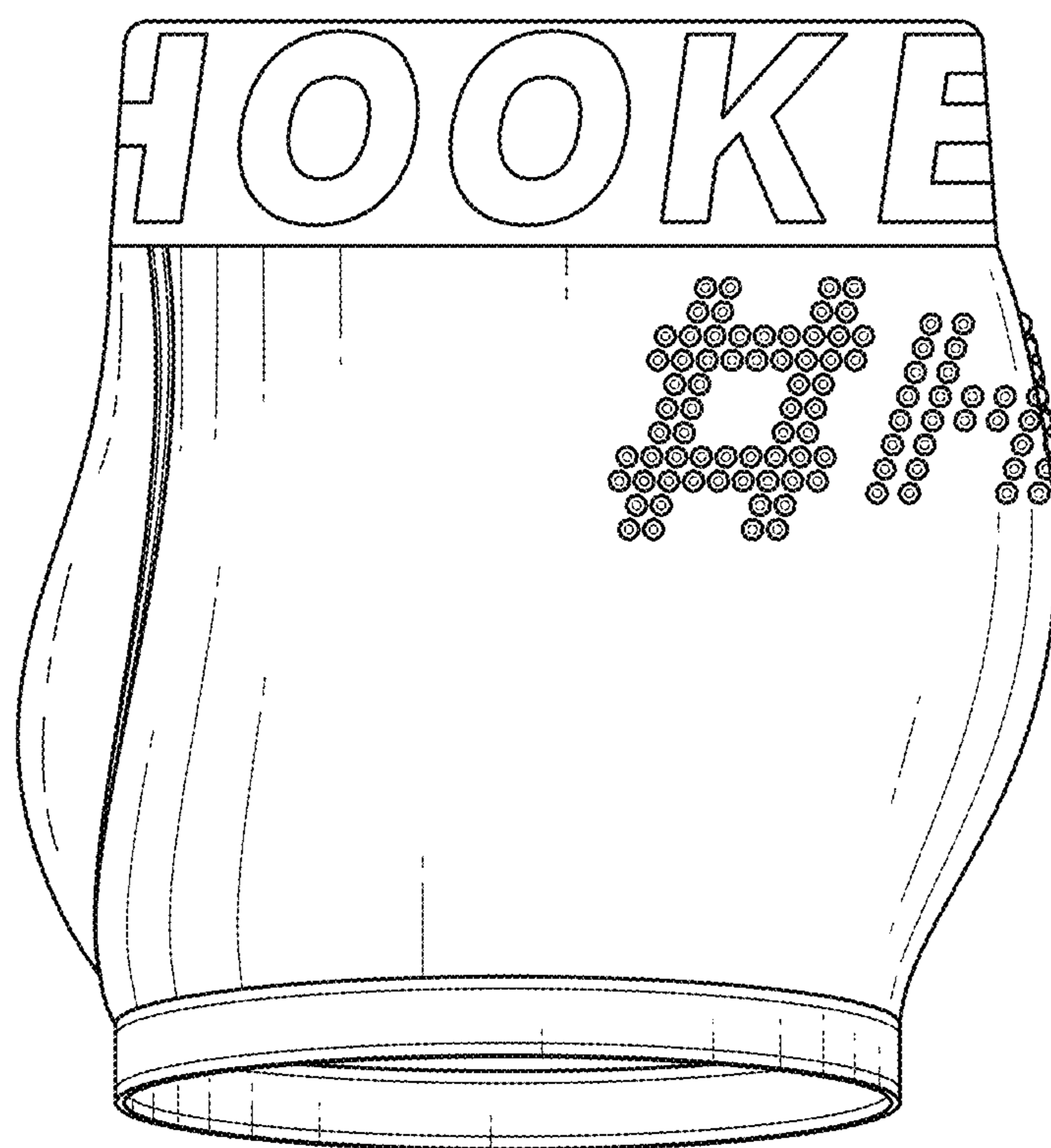

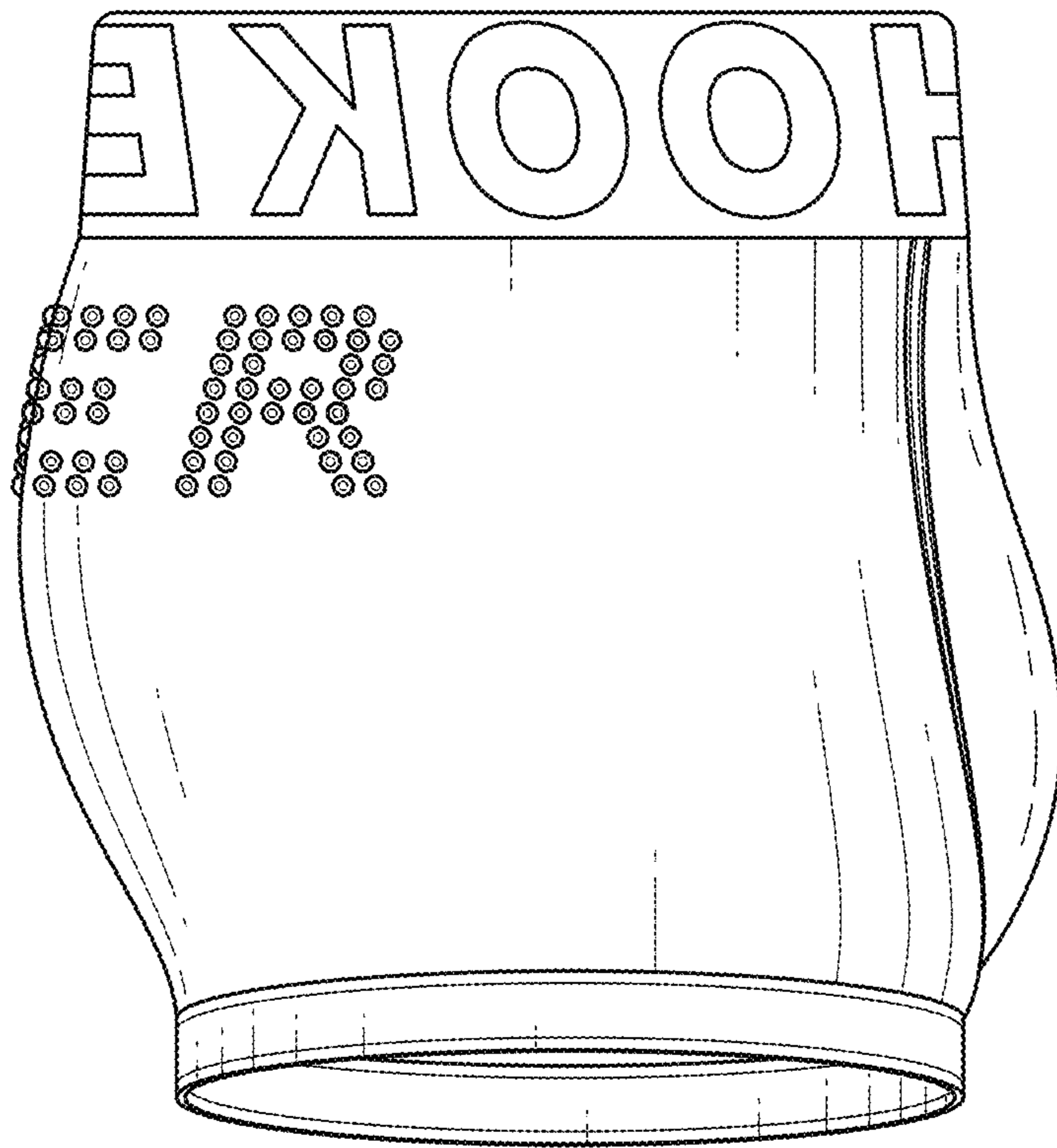
