The ornamental design for an electric styling brush, as shown, and described.

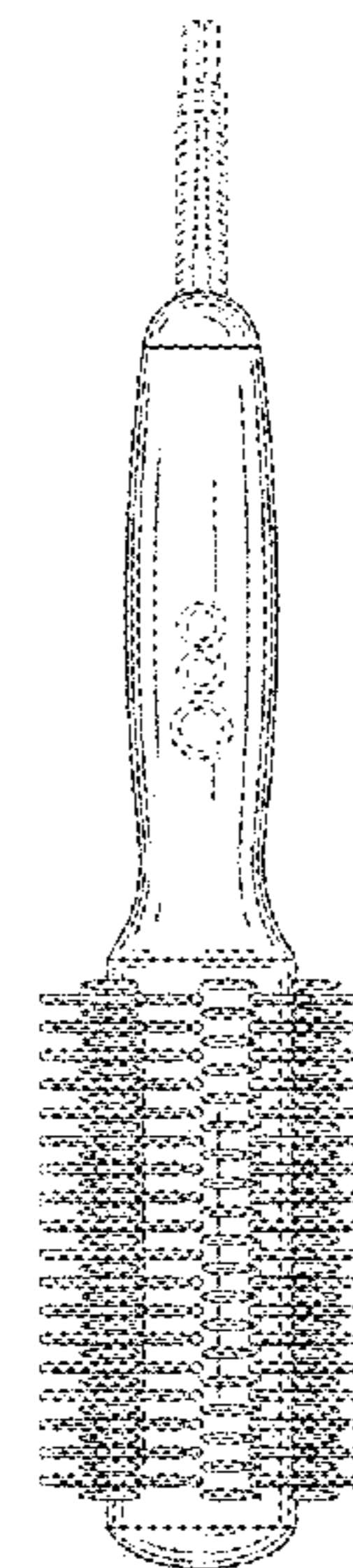
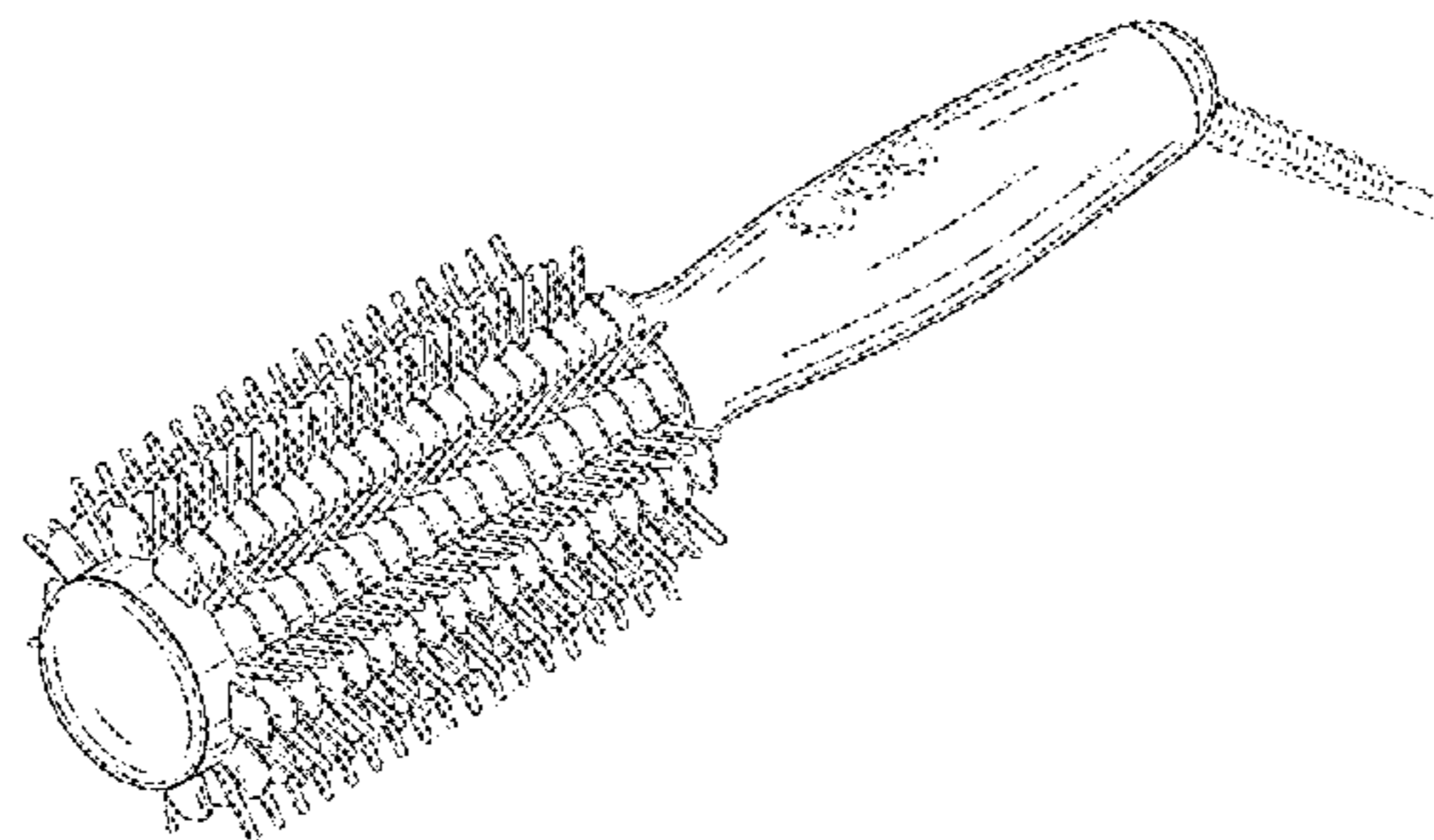

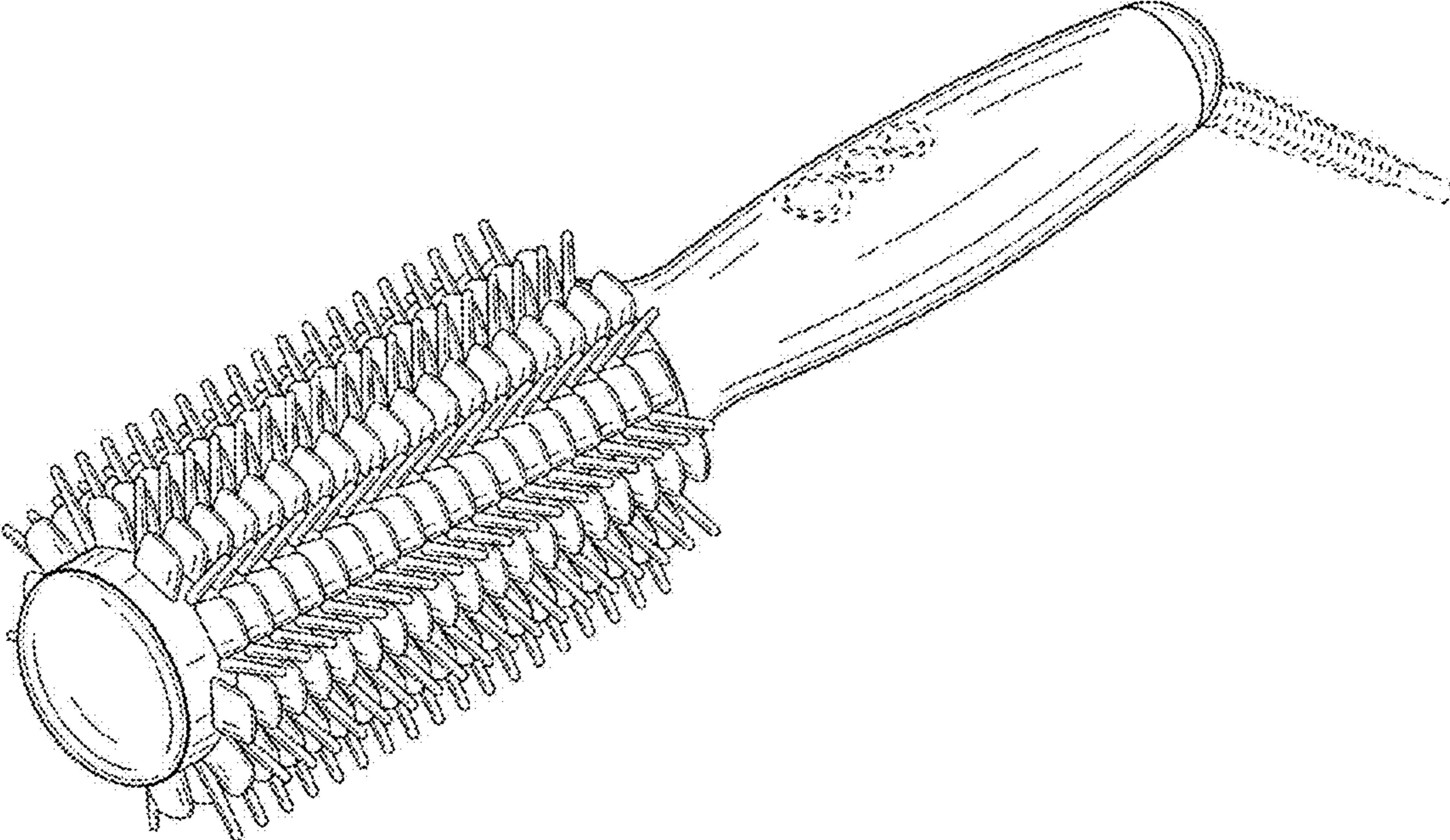

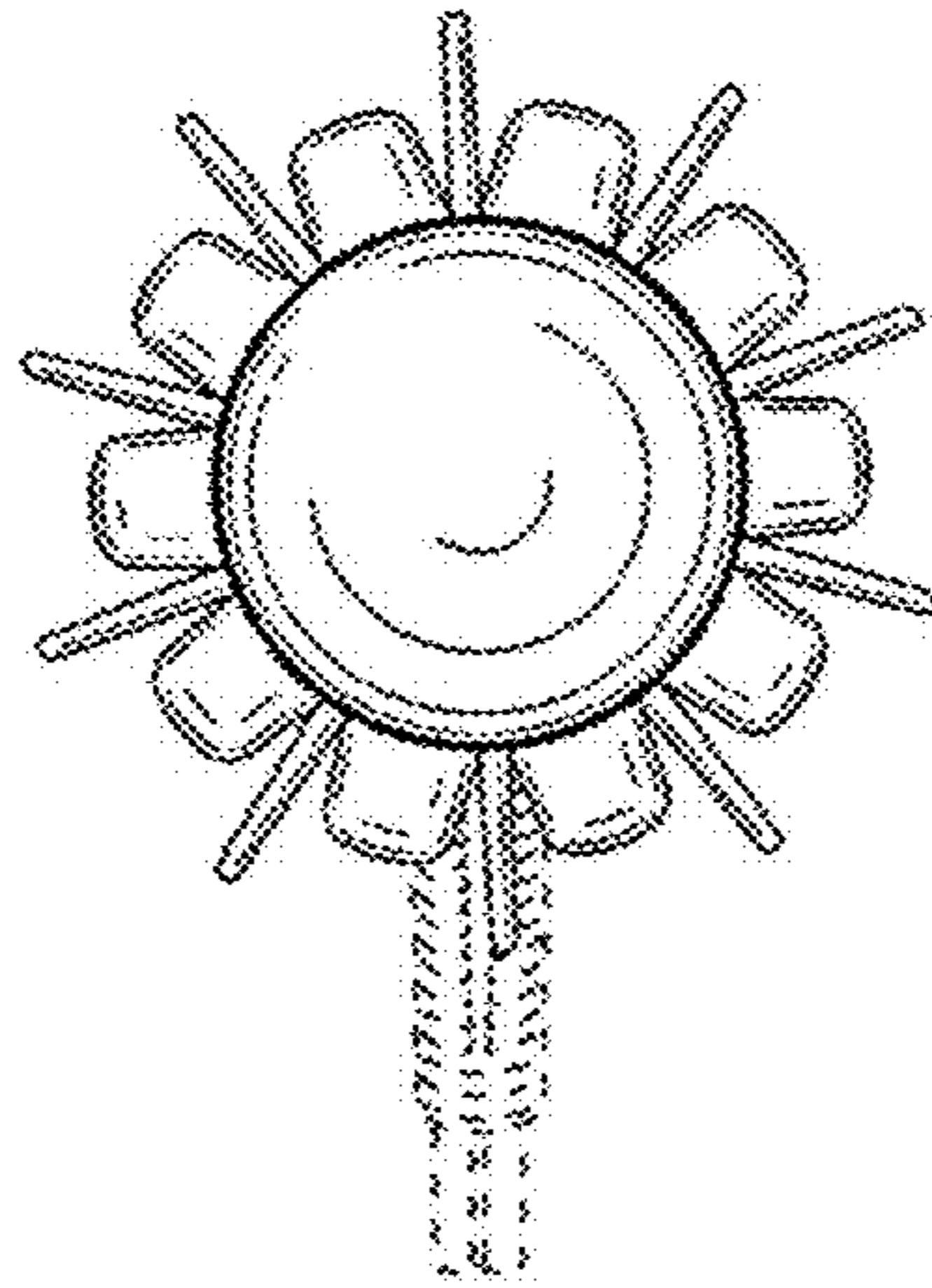

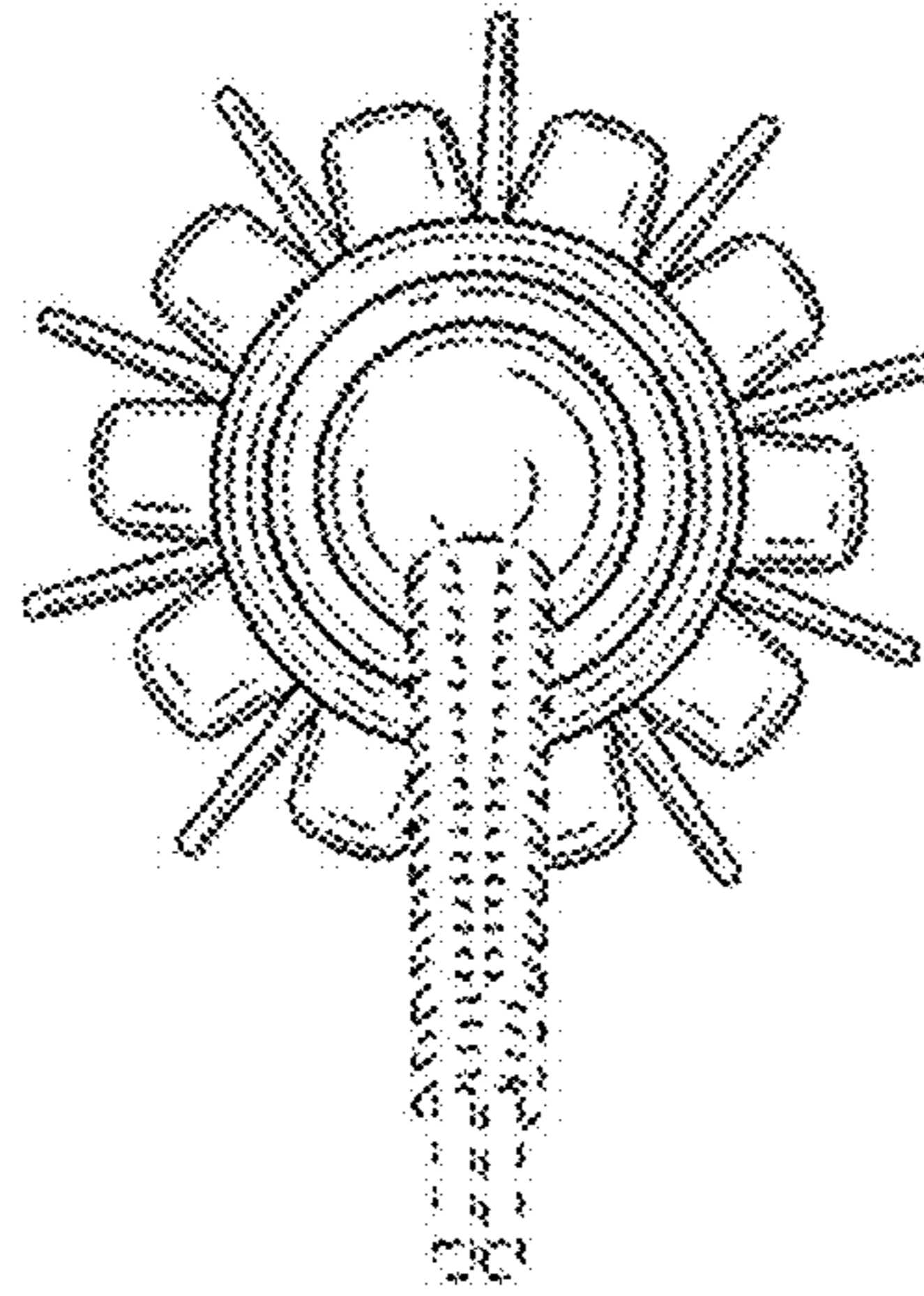

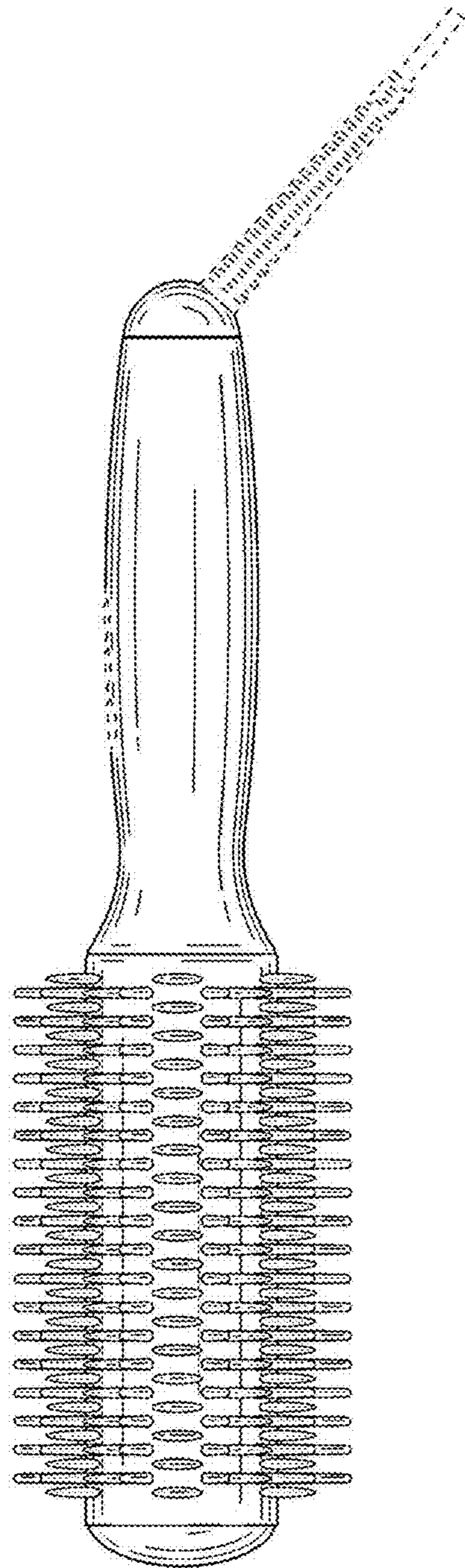

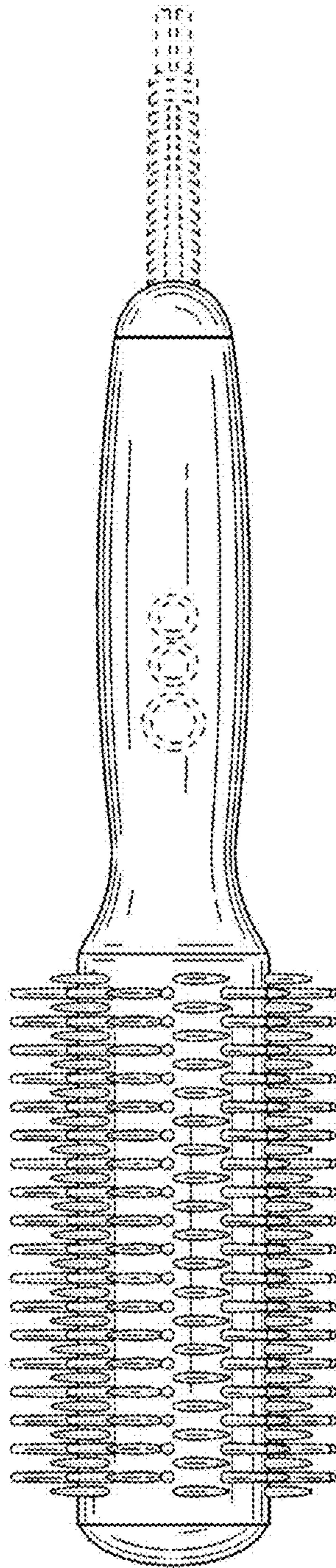

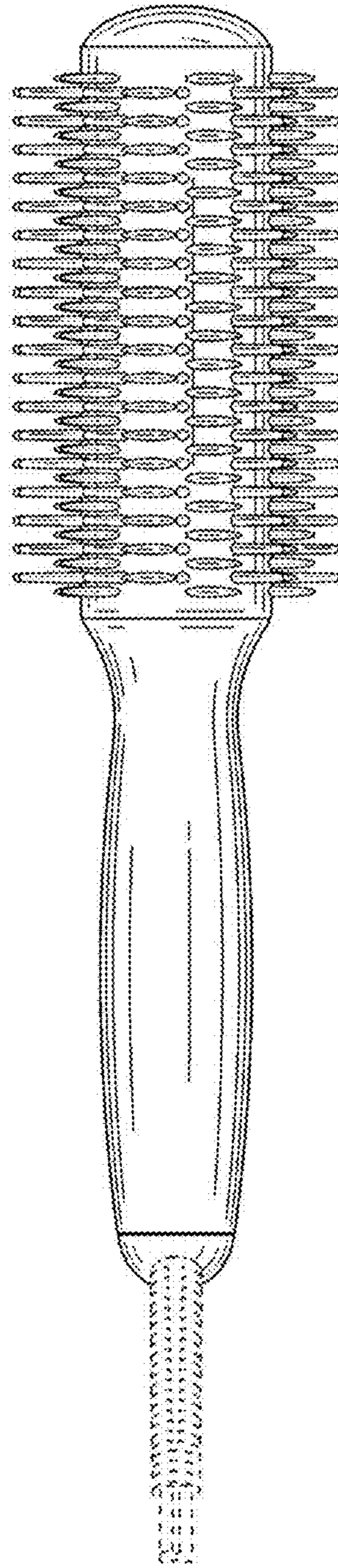
