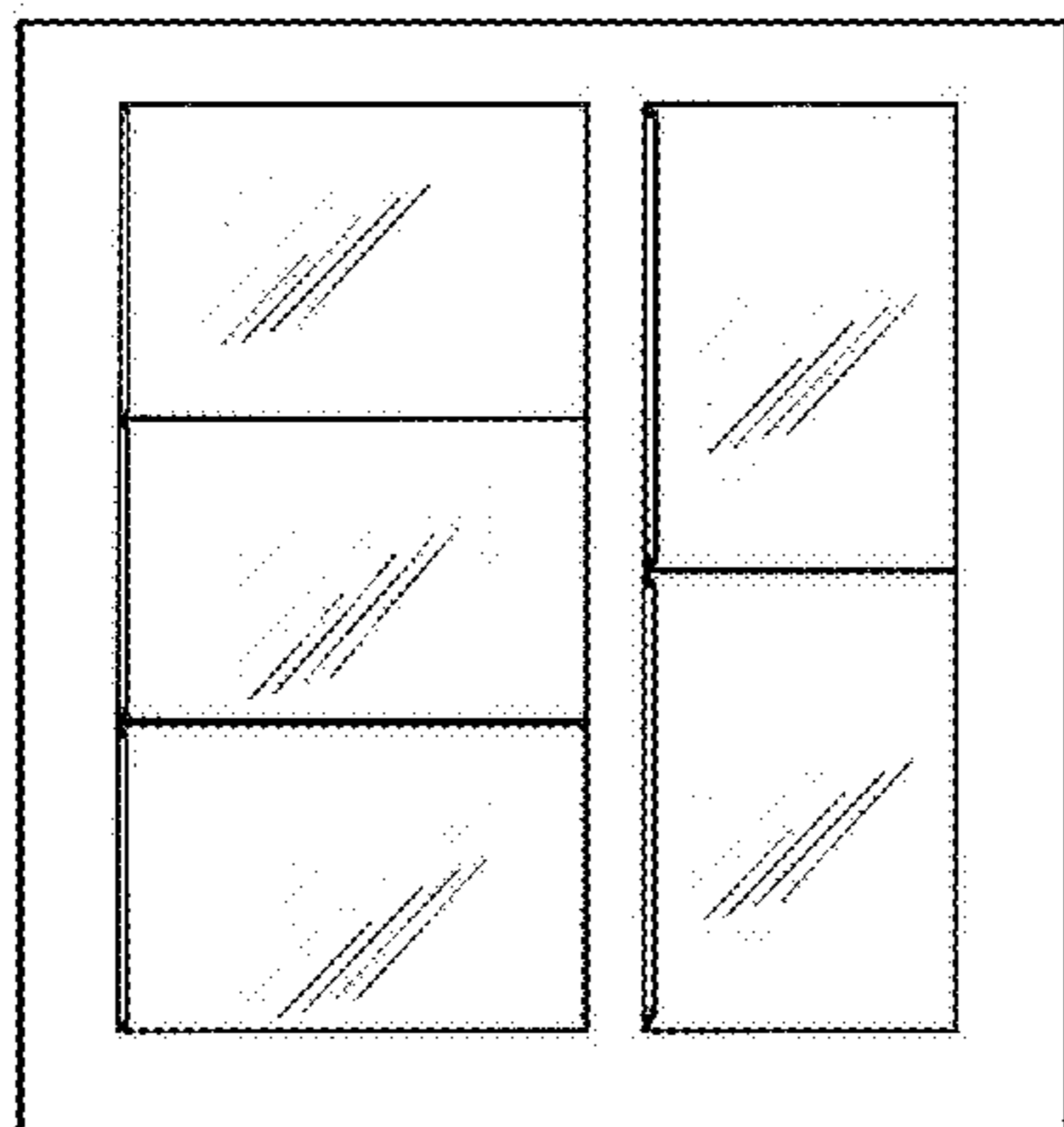
(57) **CLAIM**

The ornamental design for a display board with pockets, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display board with pockets display according to the design;
 FIG. 2 is a rear view of the display board with pockets of FIG. 1;
 FIG. 3 is a first side view of the display board with pockets of FIG. 1;
 FIG. 4 is a second side view of the display board with pockets of FIG. 1, opposite the first side view of FIG. 3;
 FIG. 5 is a first end view of the display board with pockets of FIG. 1; and,
 FIG. 6 is a second end view of the display board with pockets of FIG. 1, opposite the first end view of FIG. 5.

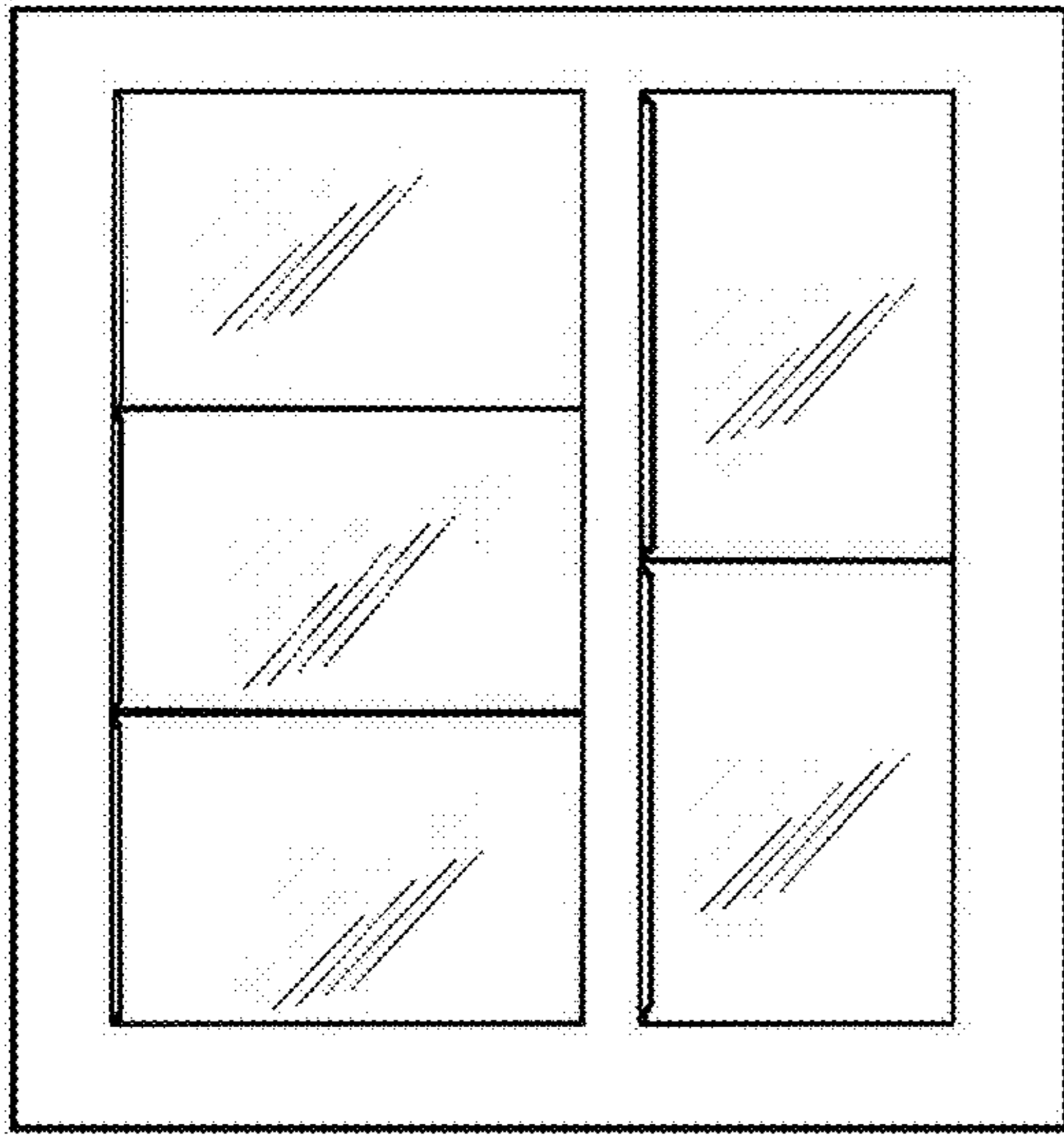

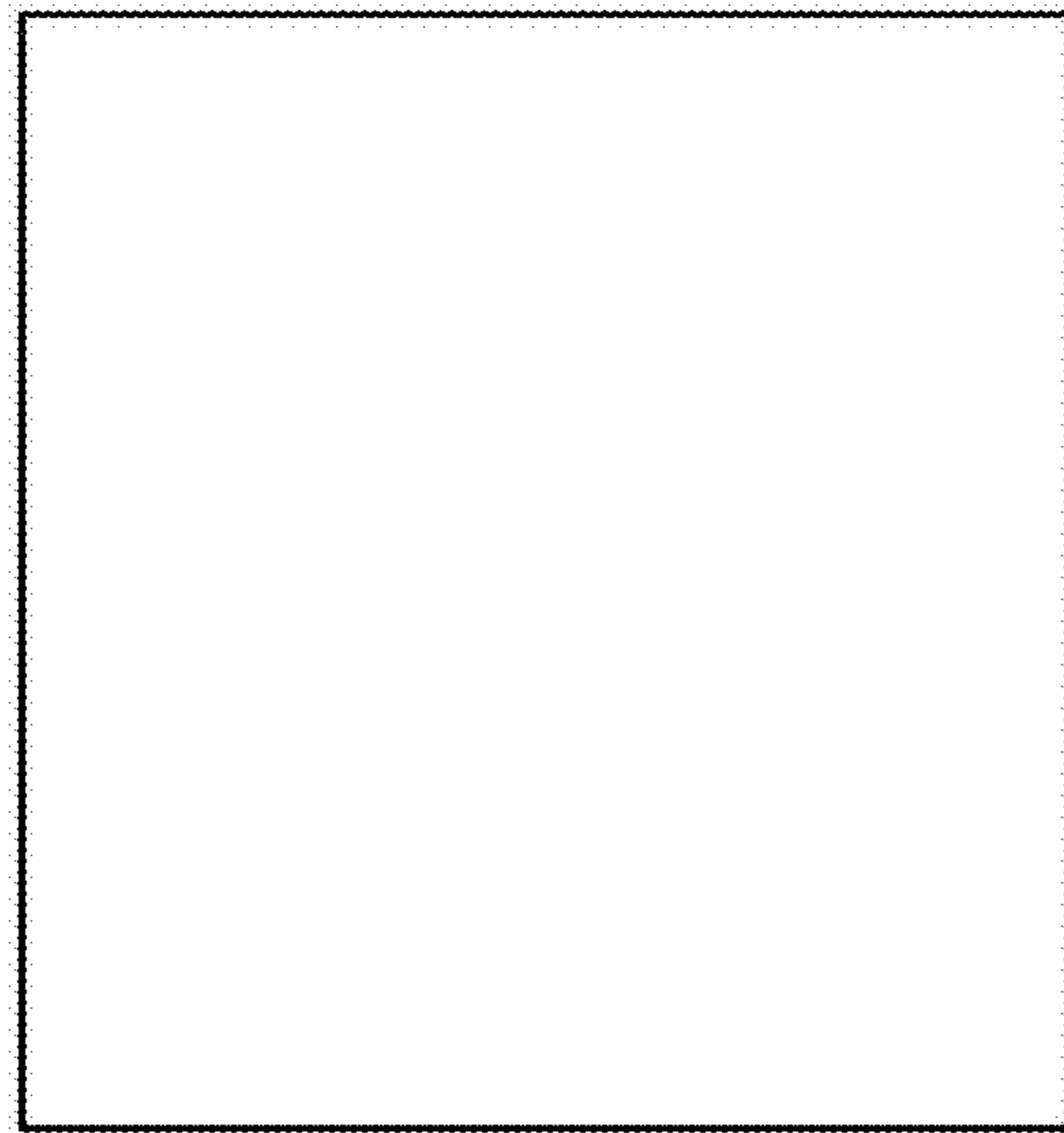

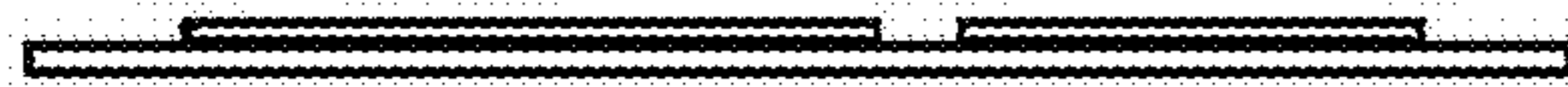

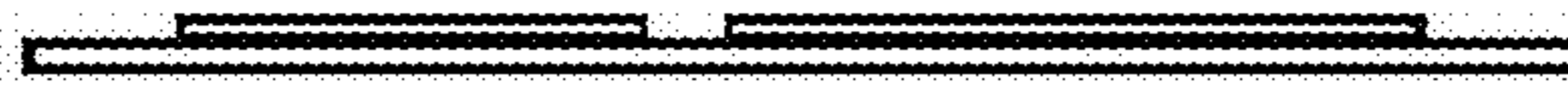

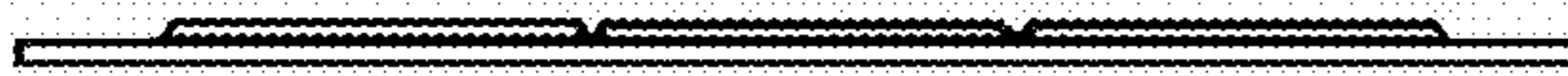
