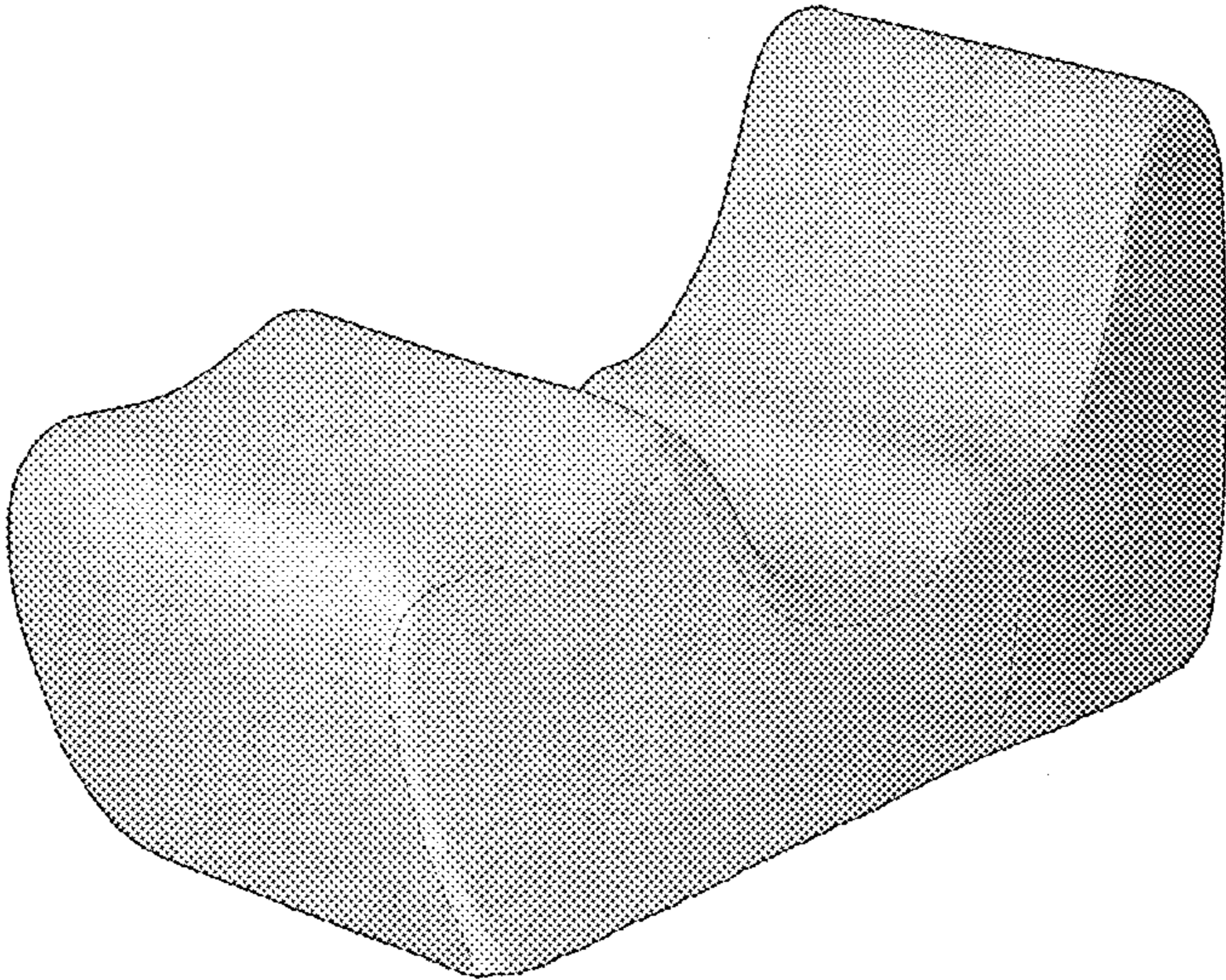
The ornamental design for the reclined foam hacker chair, as shown and described.

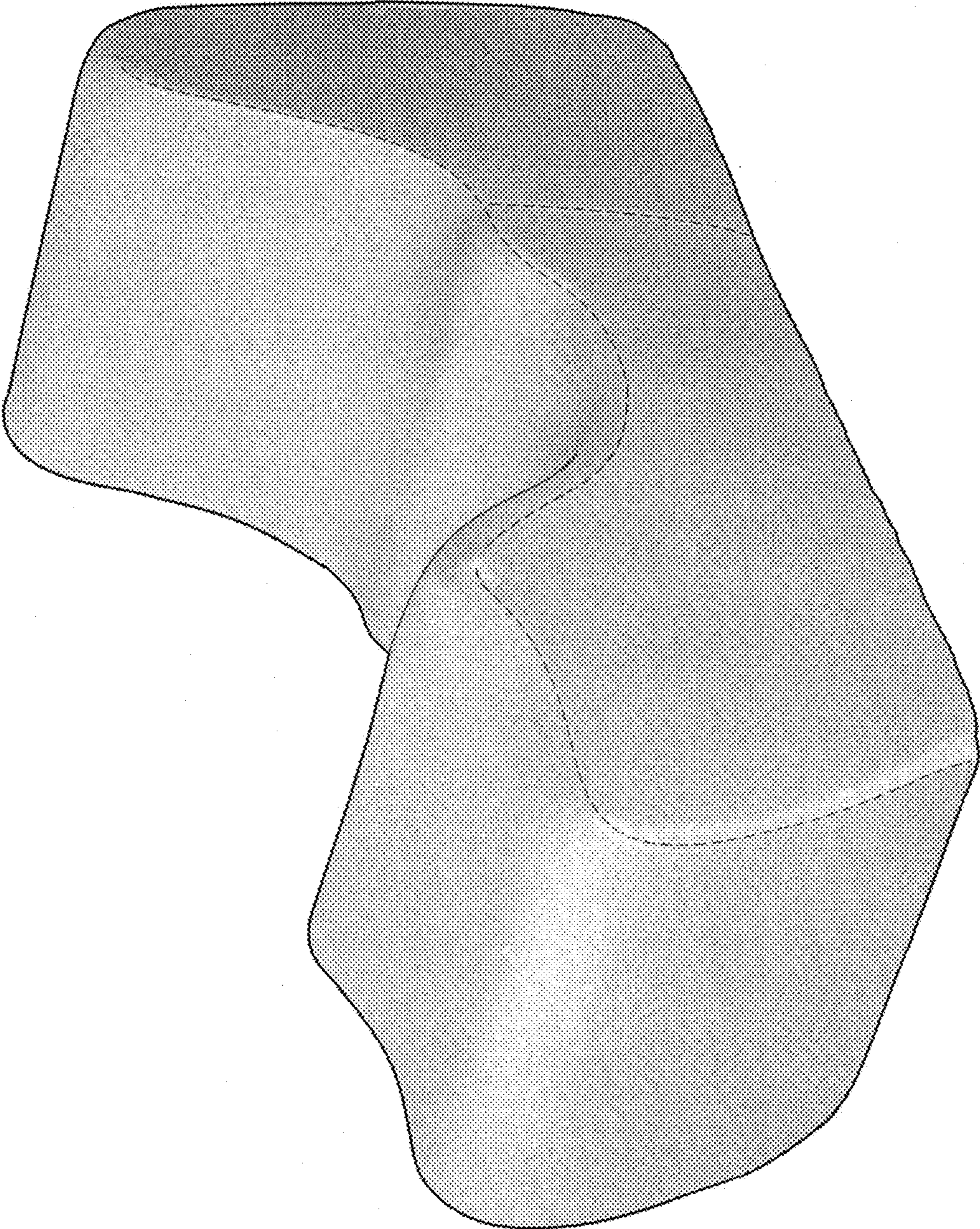

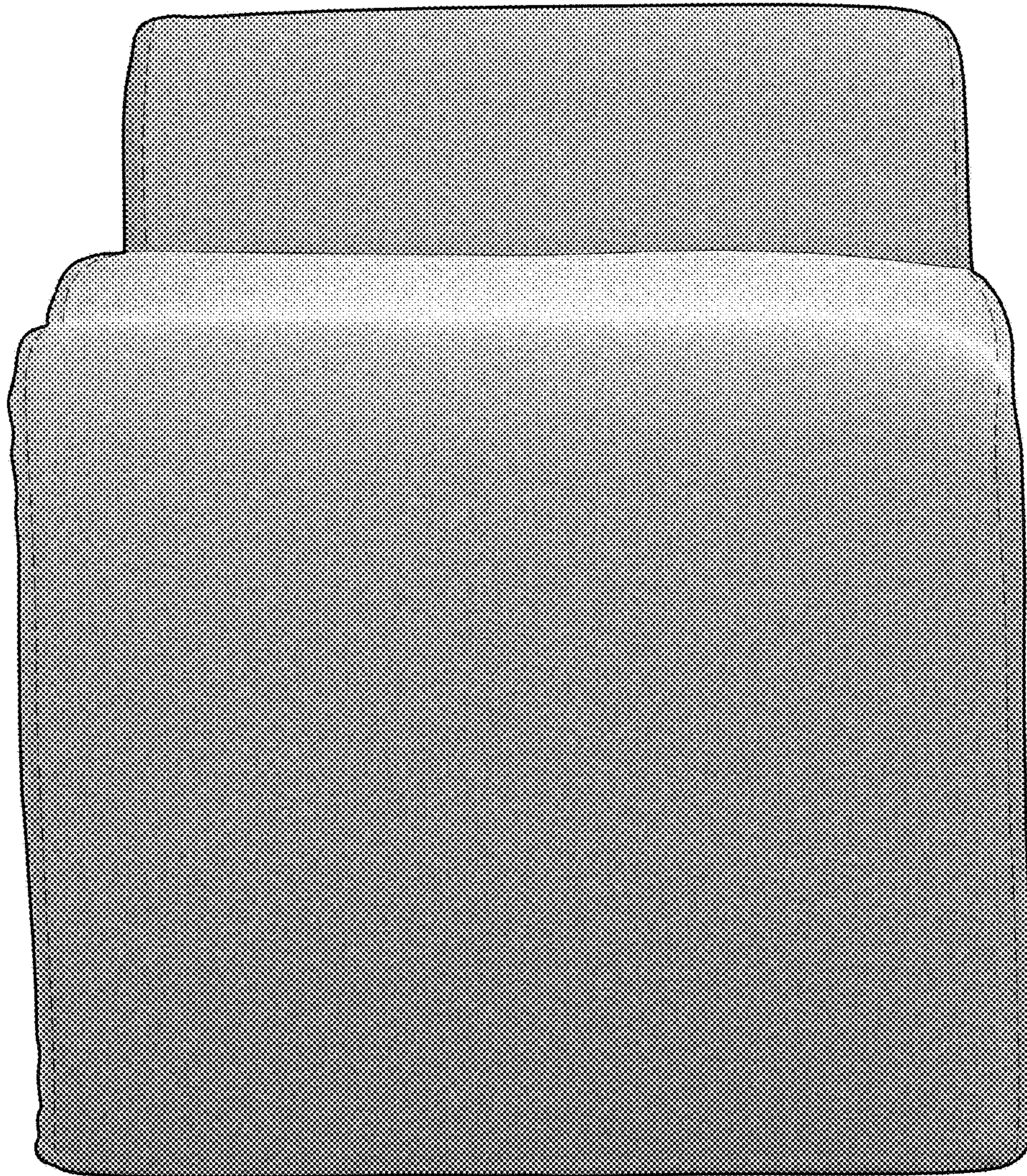

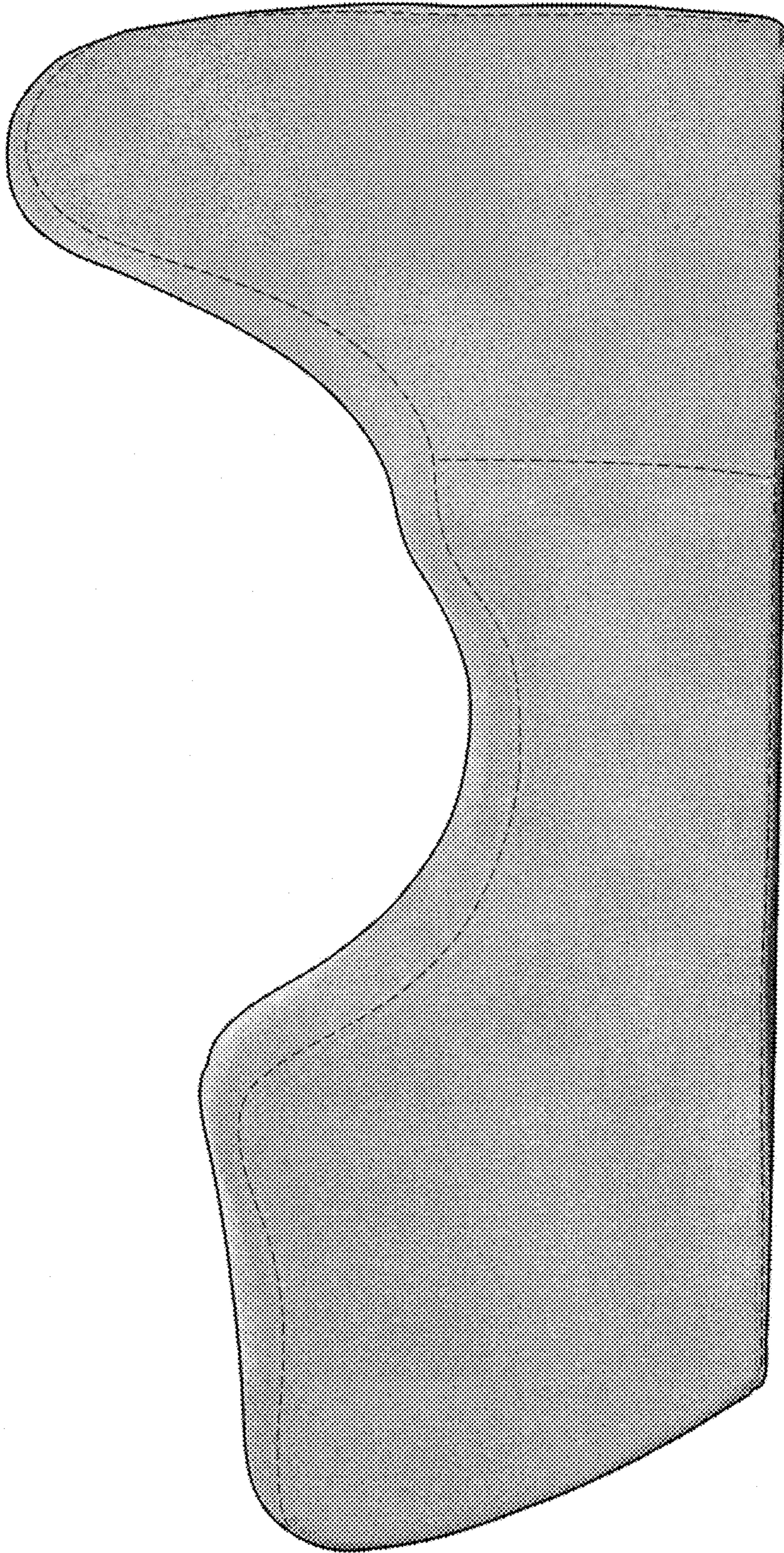

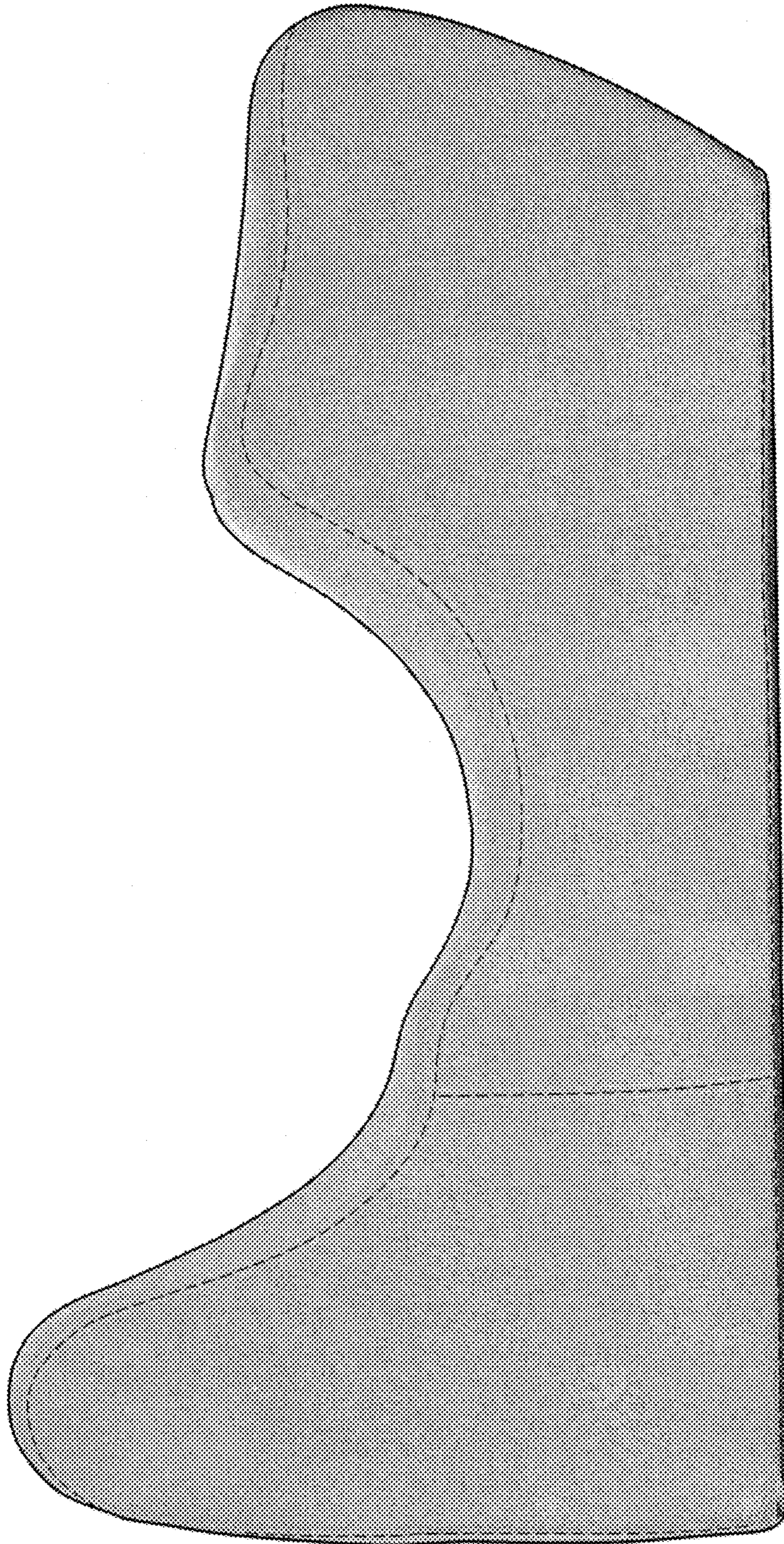

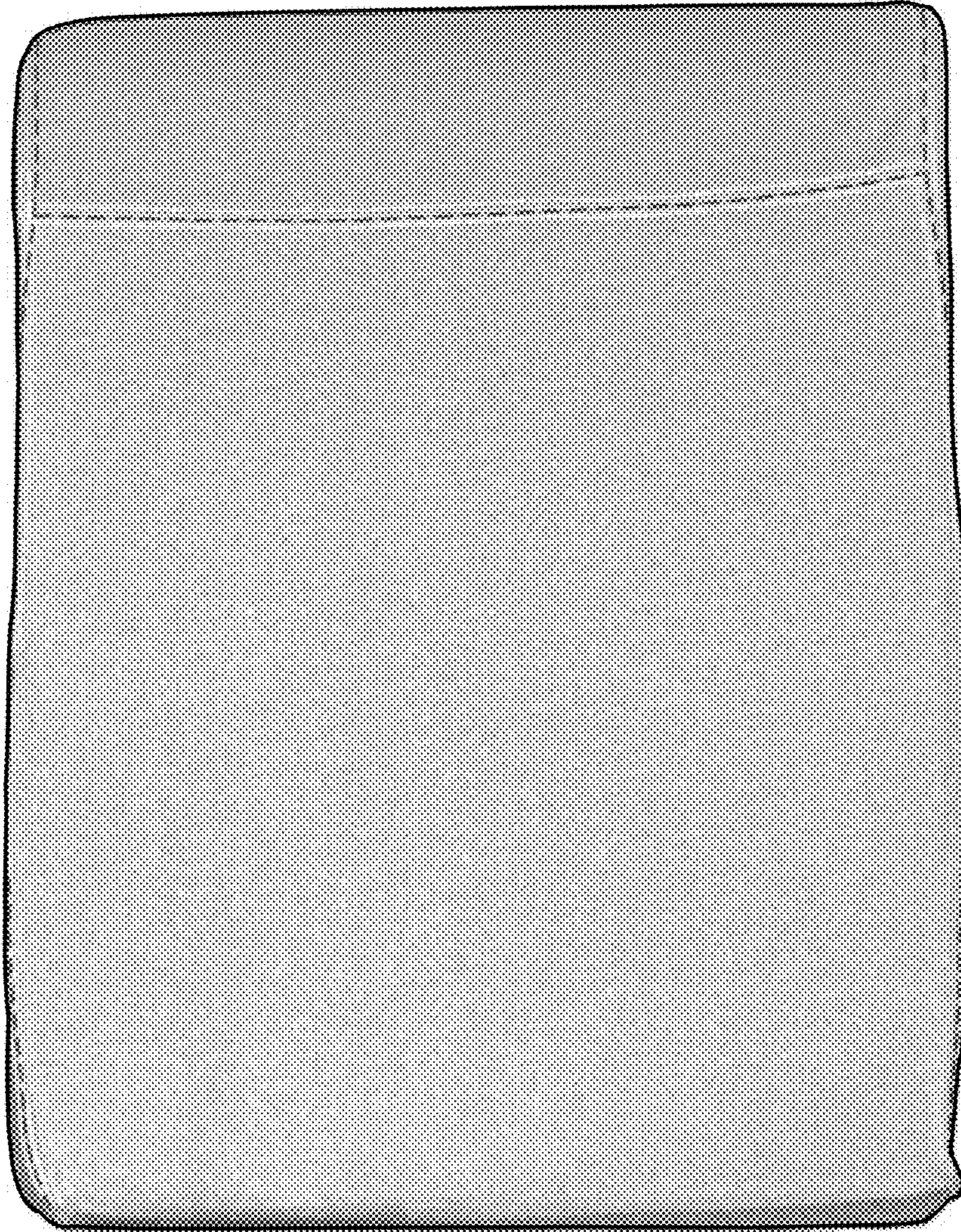

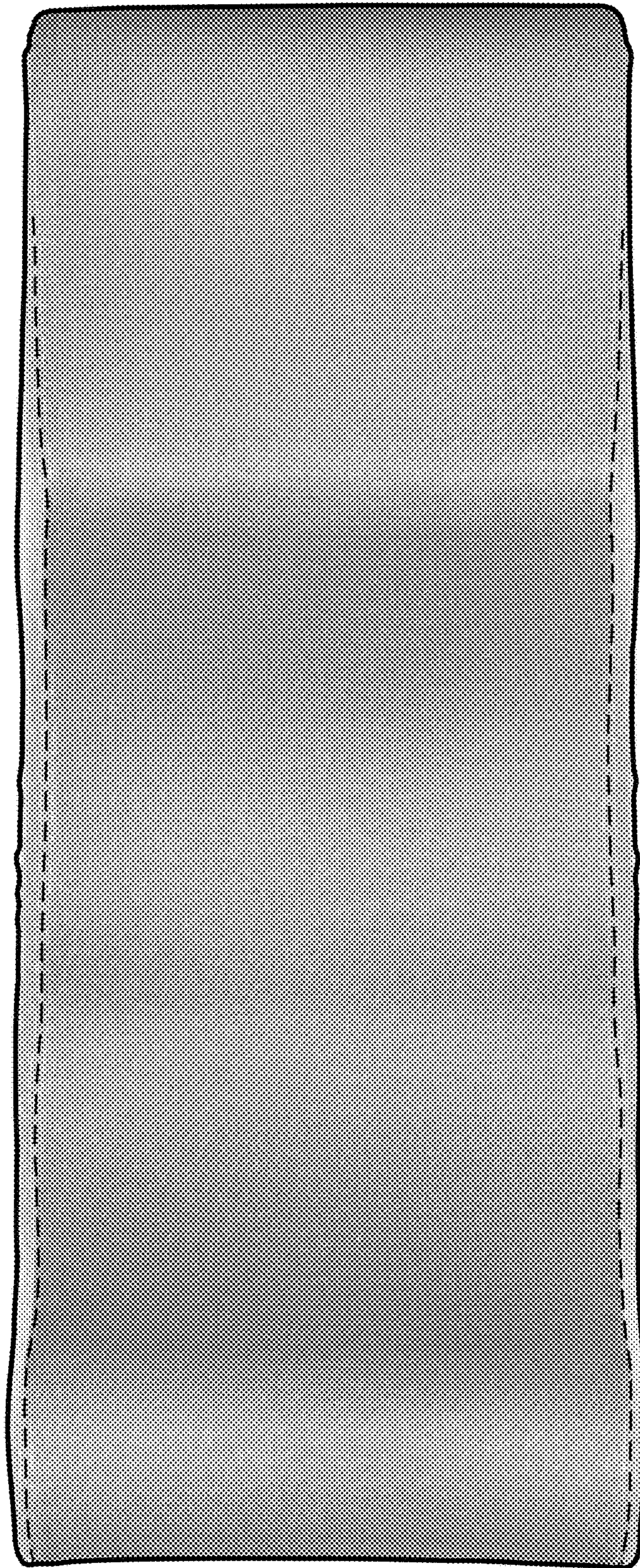
