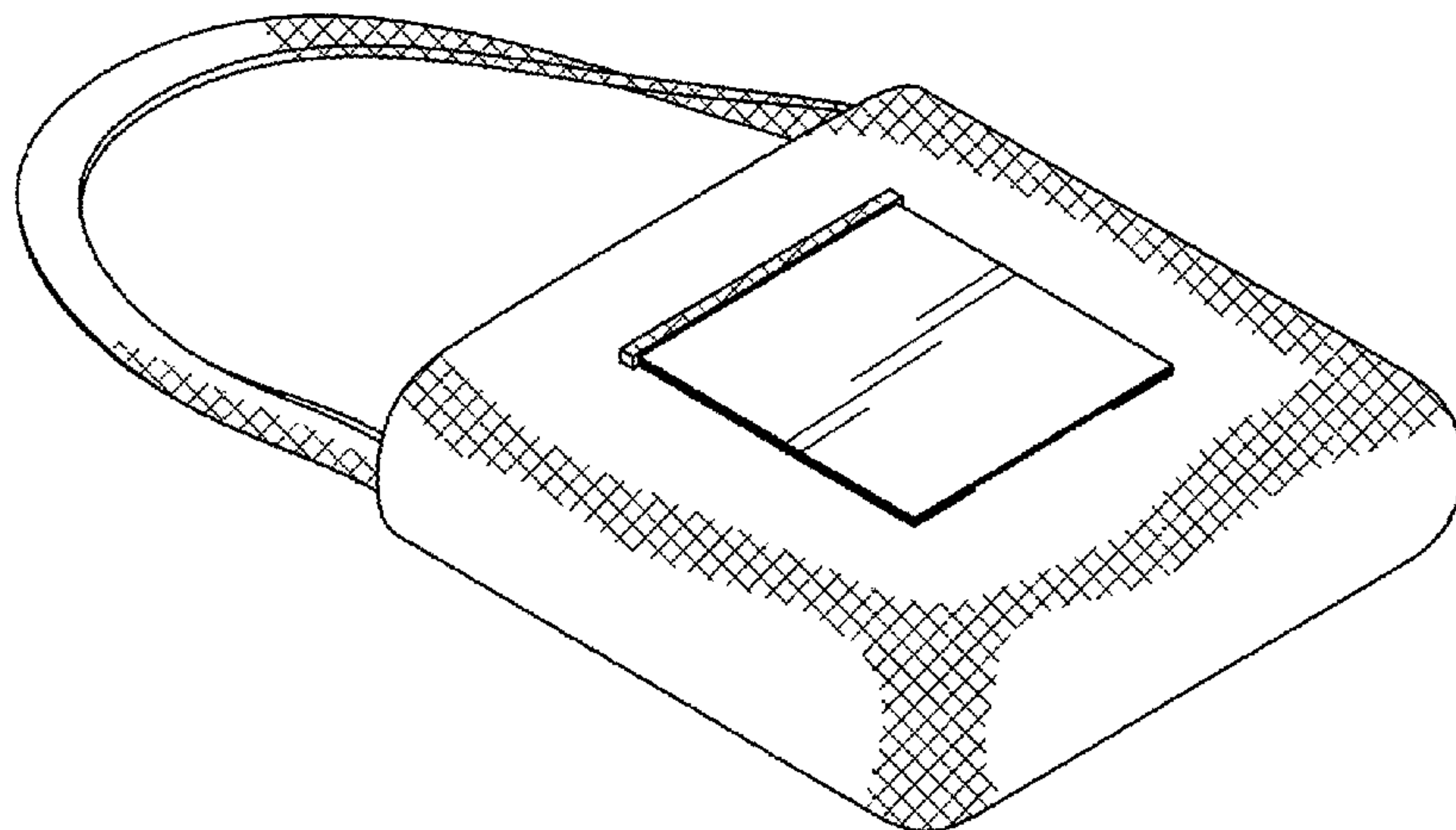
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective top view of a pillow in a closed configuration showing my design;
FIG. 2 is a perspective top view of a pillow in an open configuration;
FIG. 3 is a top side plan view thereof;
FIG. 4 is a bottom side plan view thereof;
FIG. 5 is a left side elevation view with the right side elevation view being a mirror image thereof;
FIG. 6 is a rear side elevation view thereof; and,
FIG. 7 is a front side elevation view thereof.

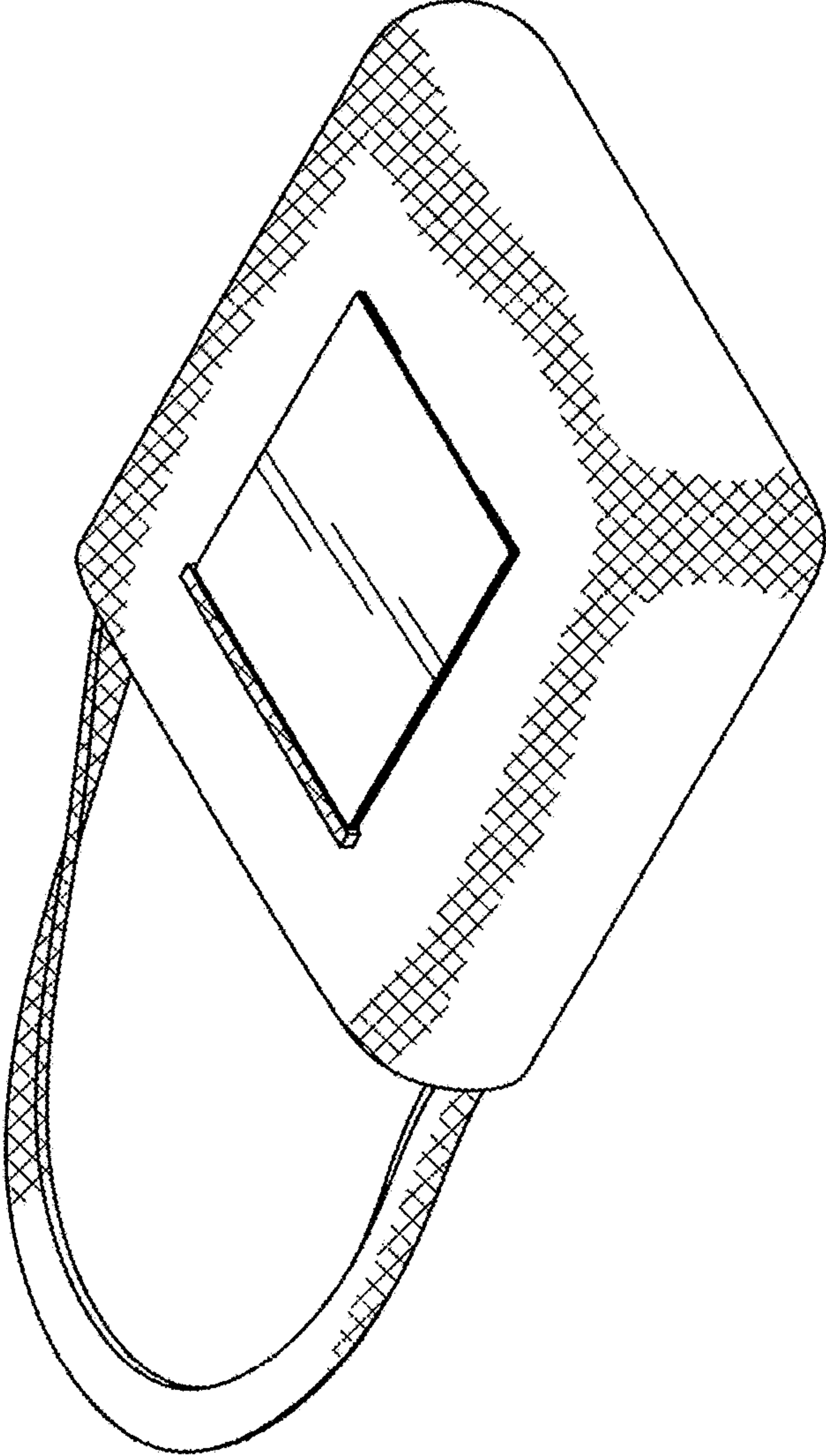

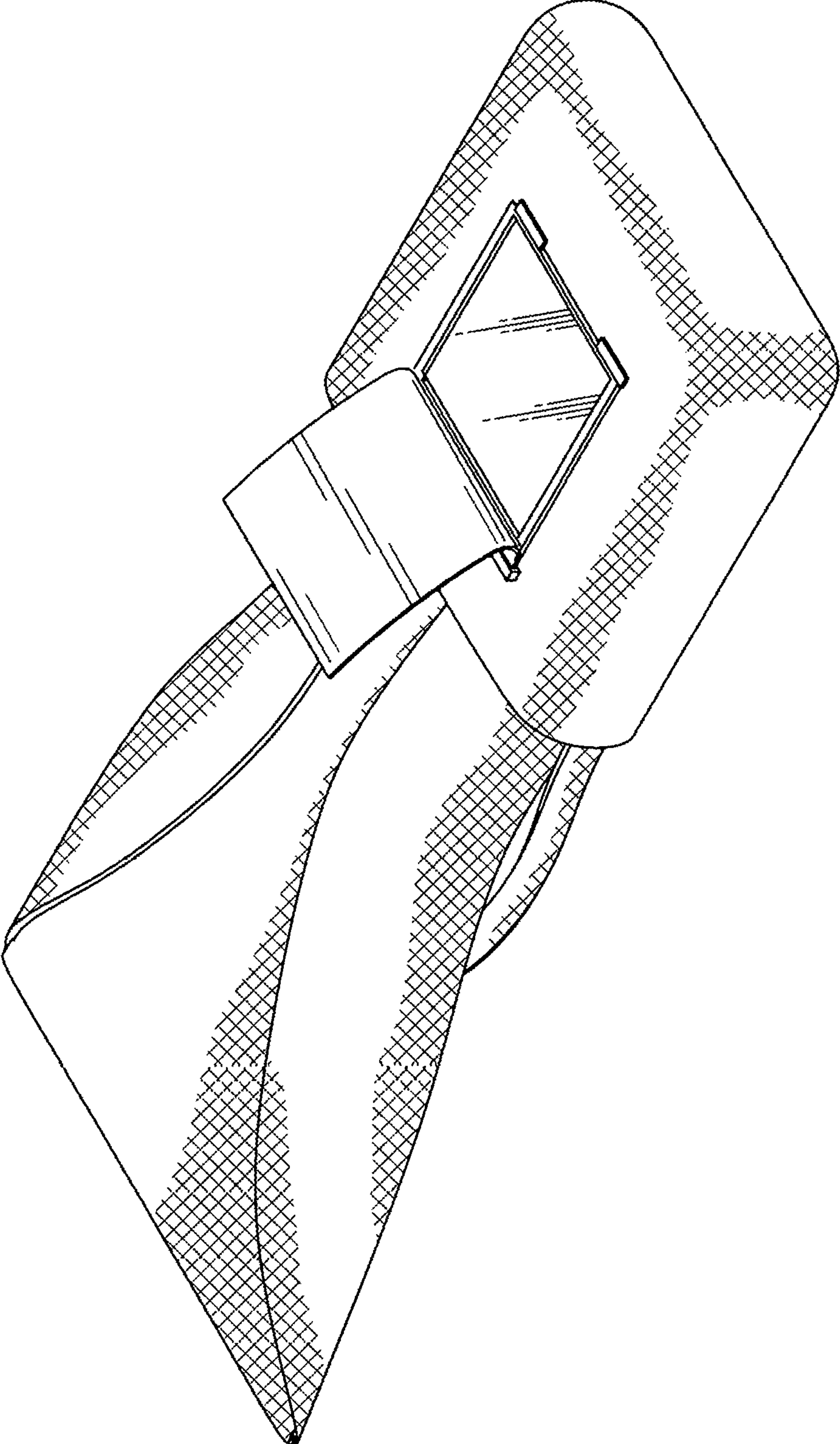

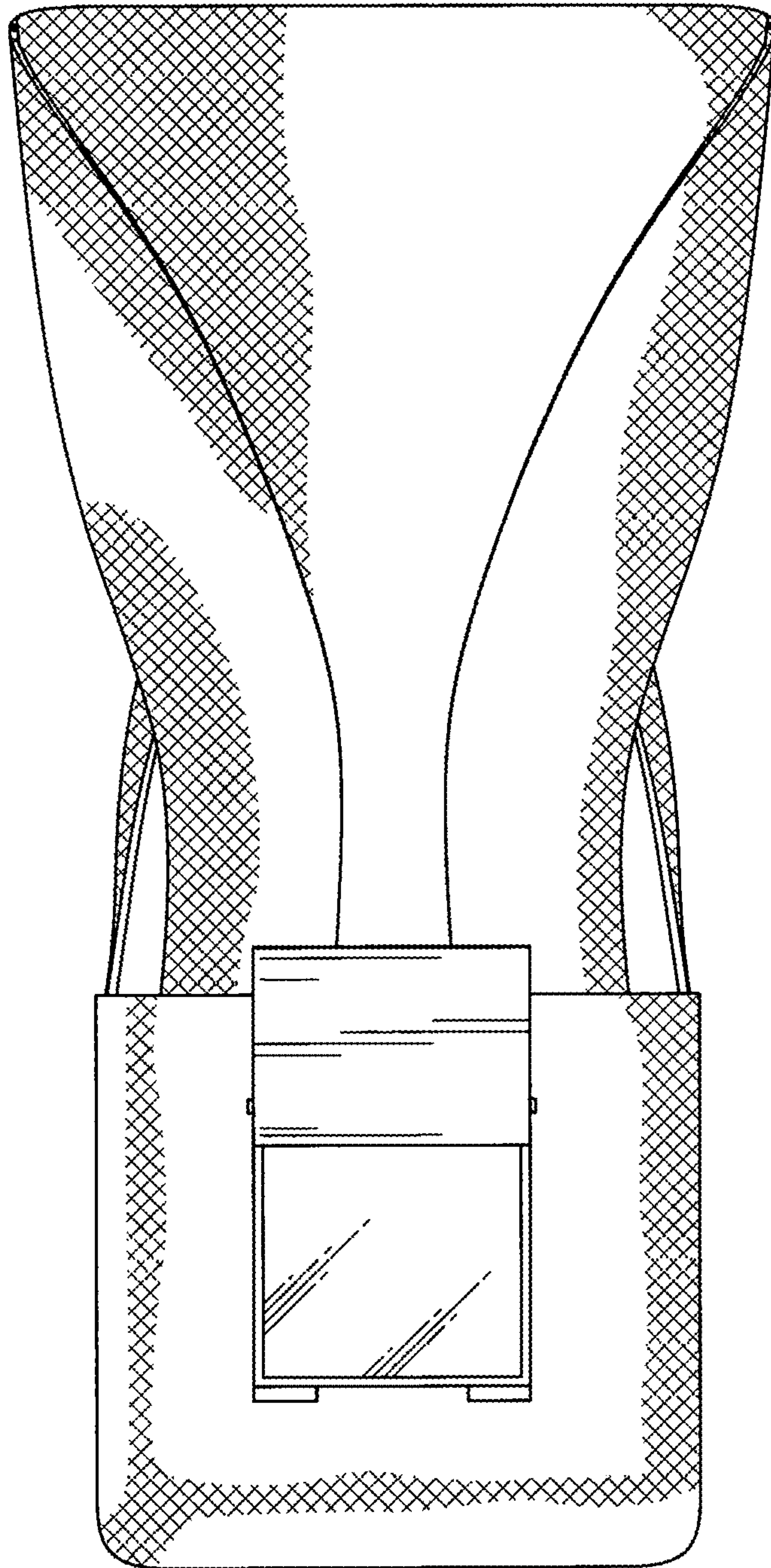

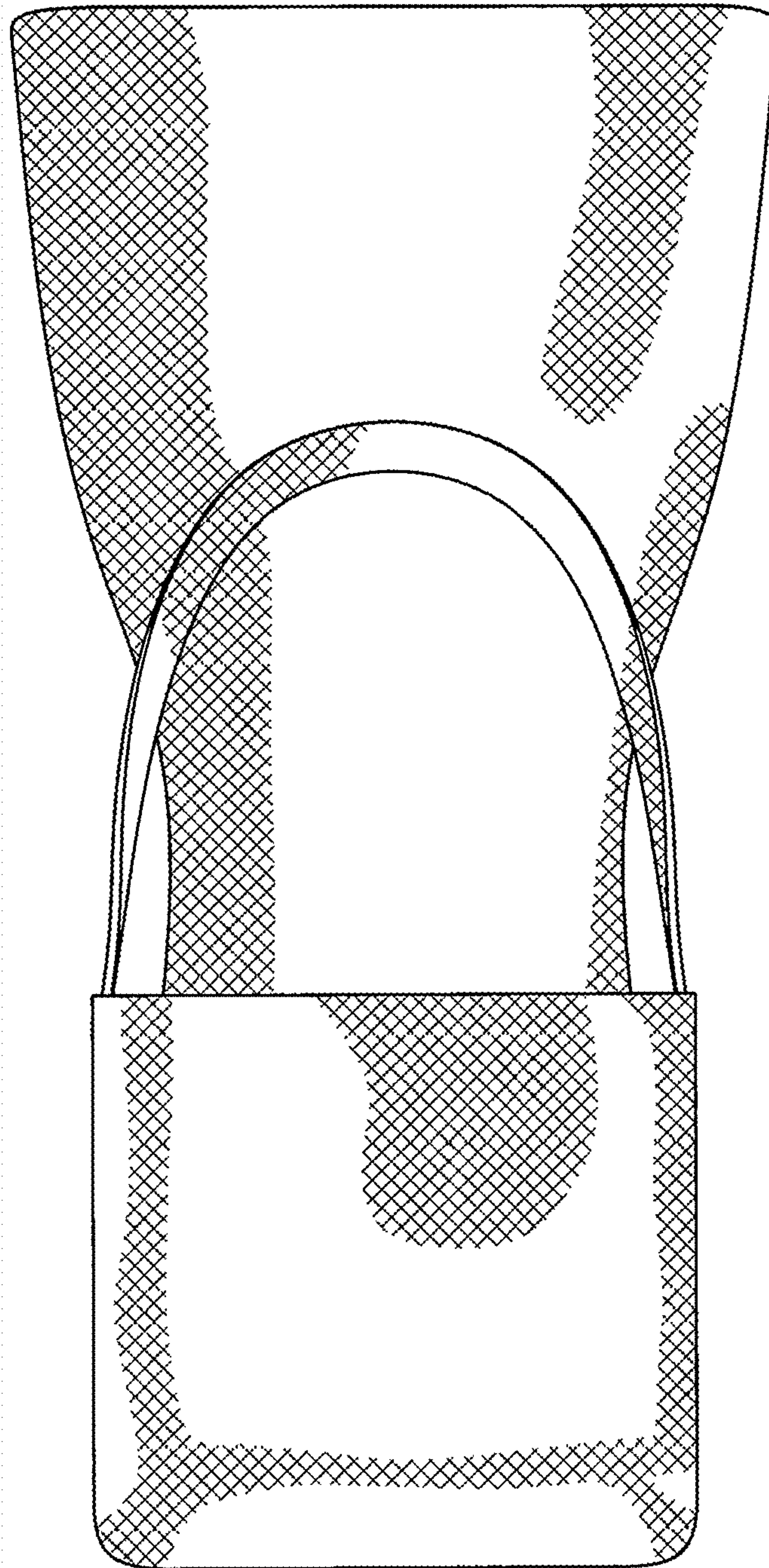

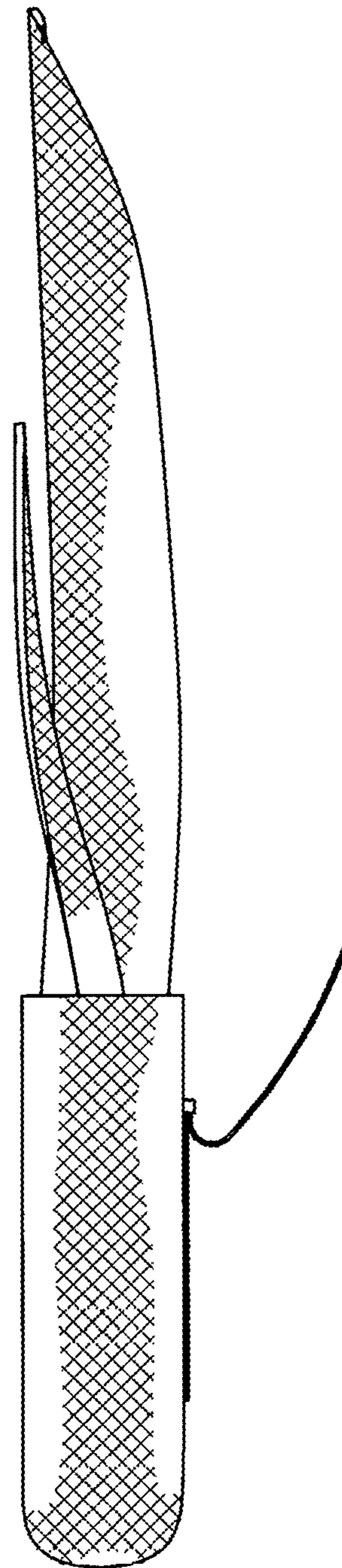

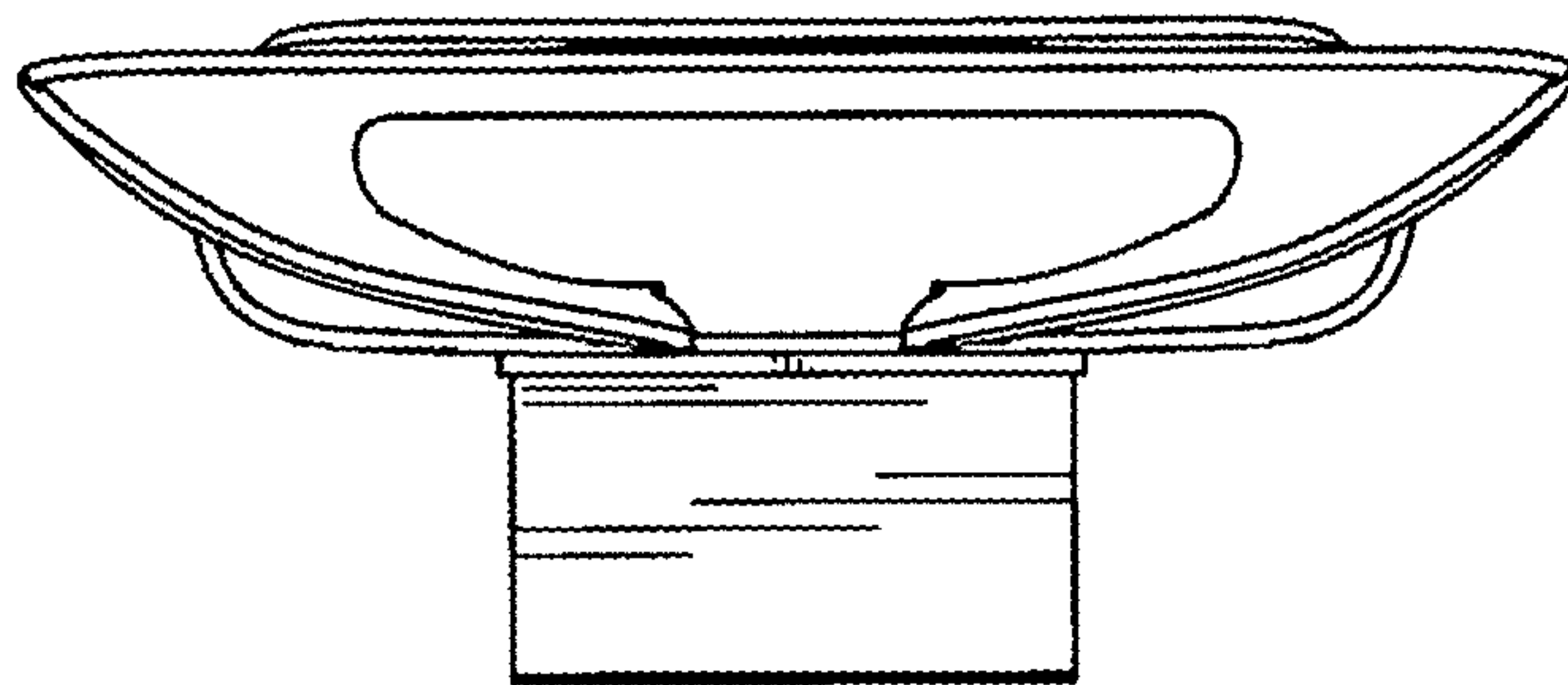

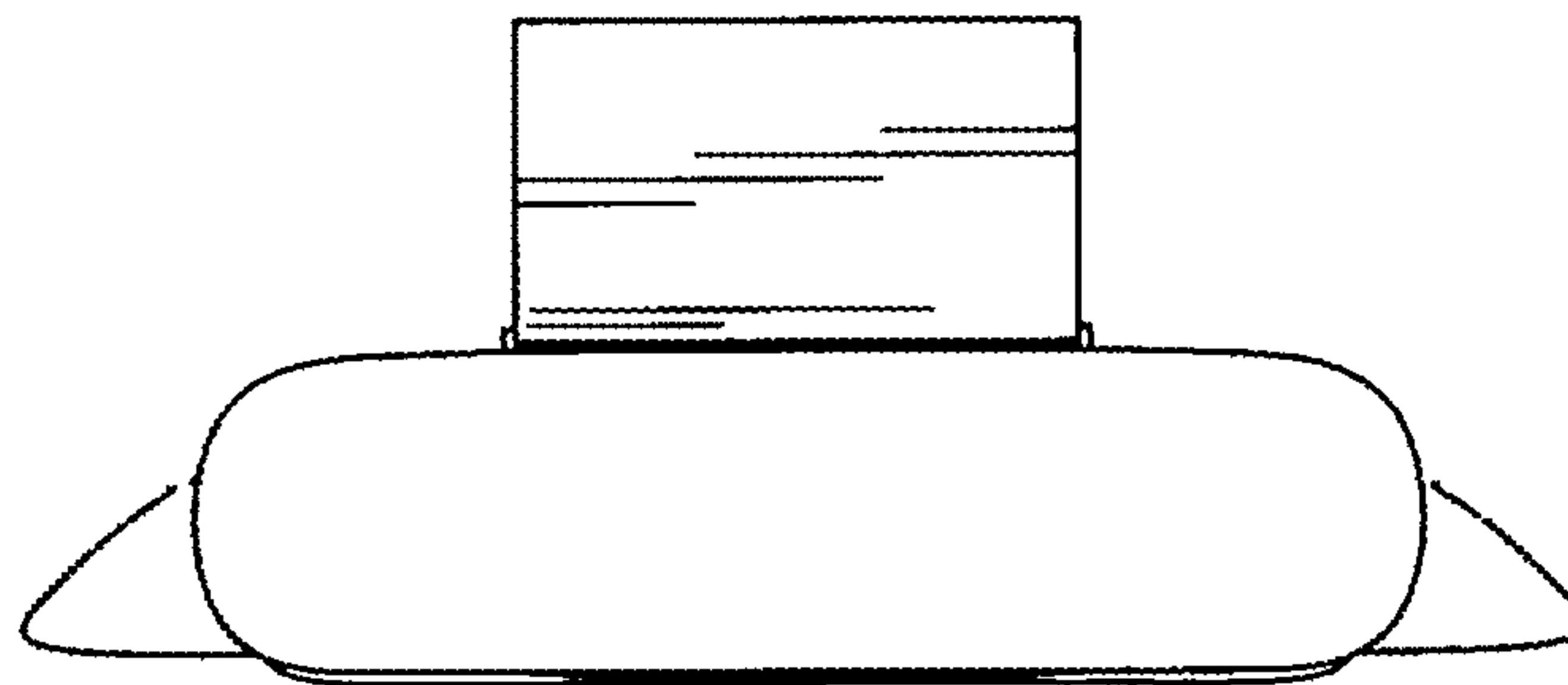
