(57) **CLAIM**

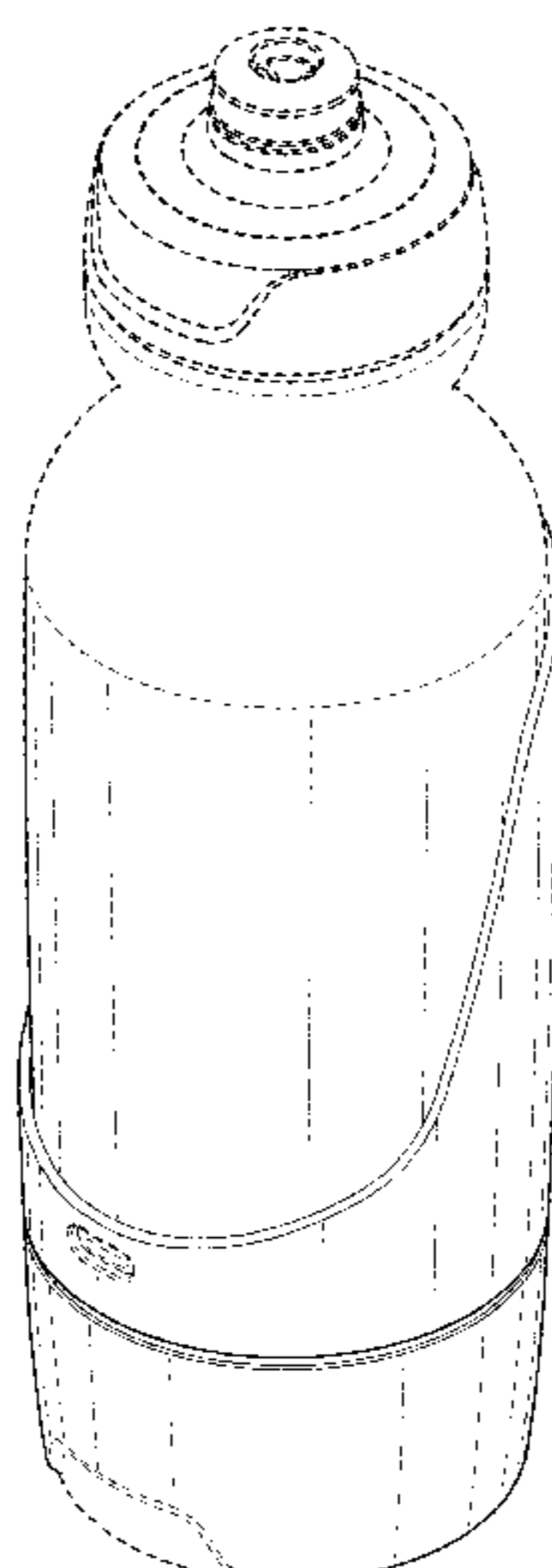
The ornamental design for a bottle with bottom cup, as shown and described.

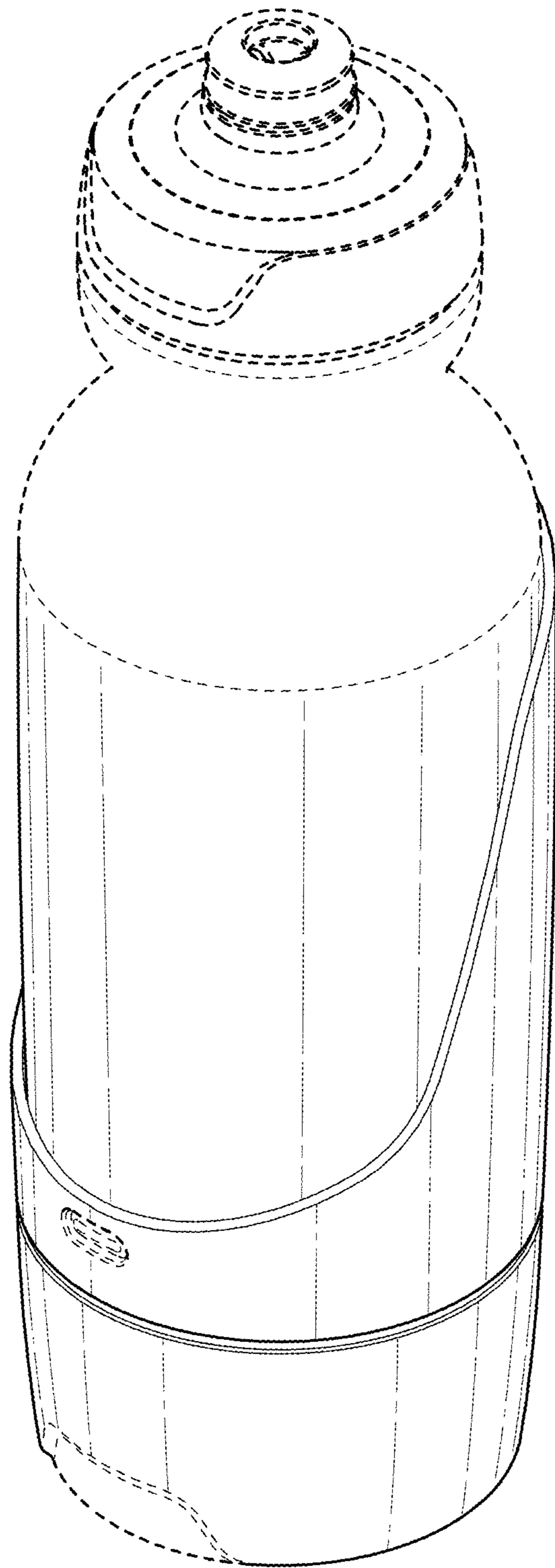

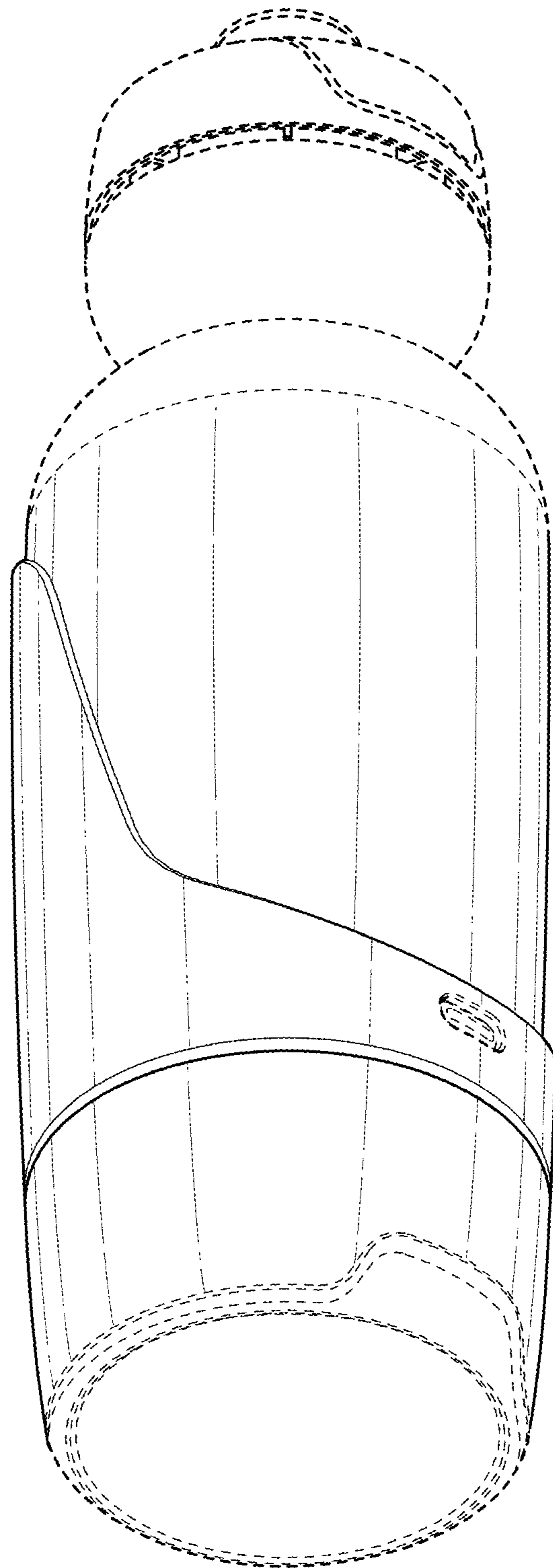

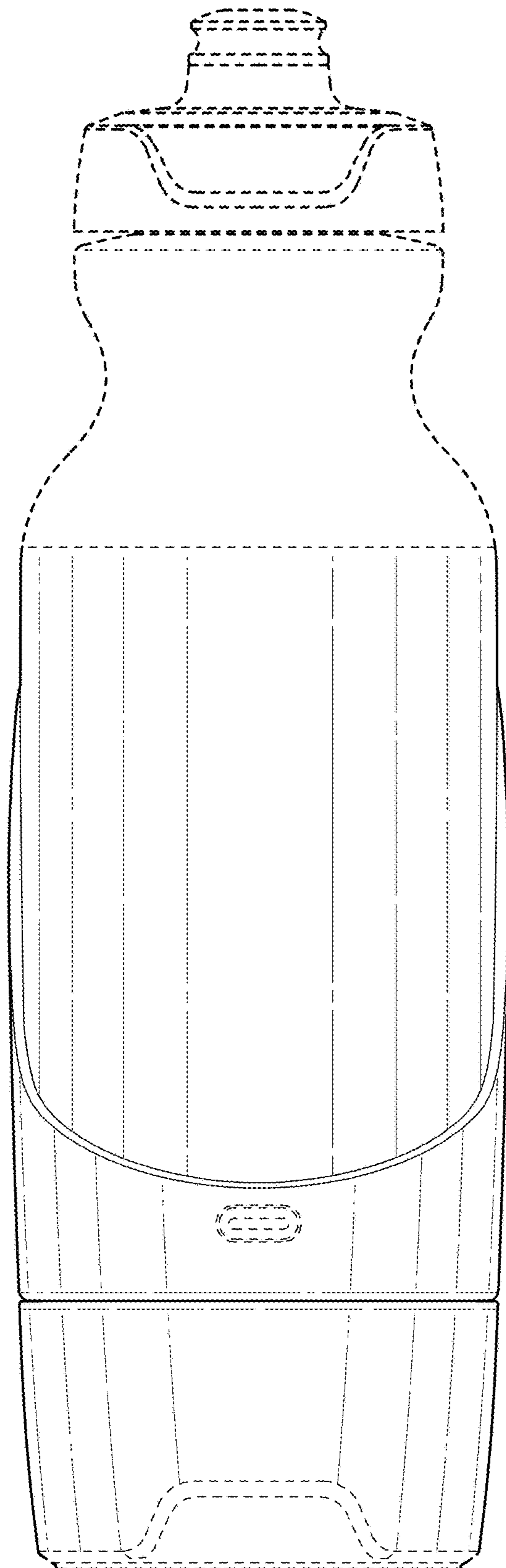

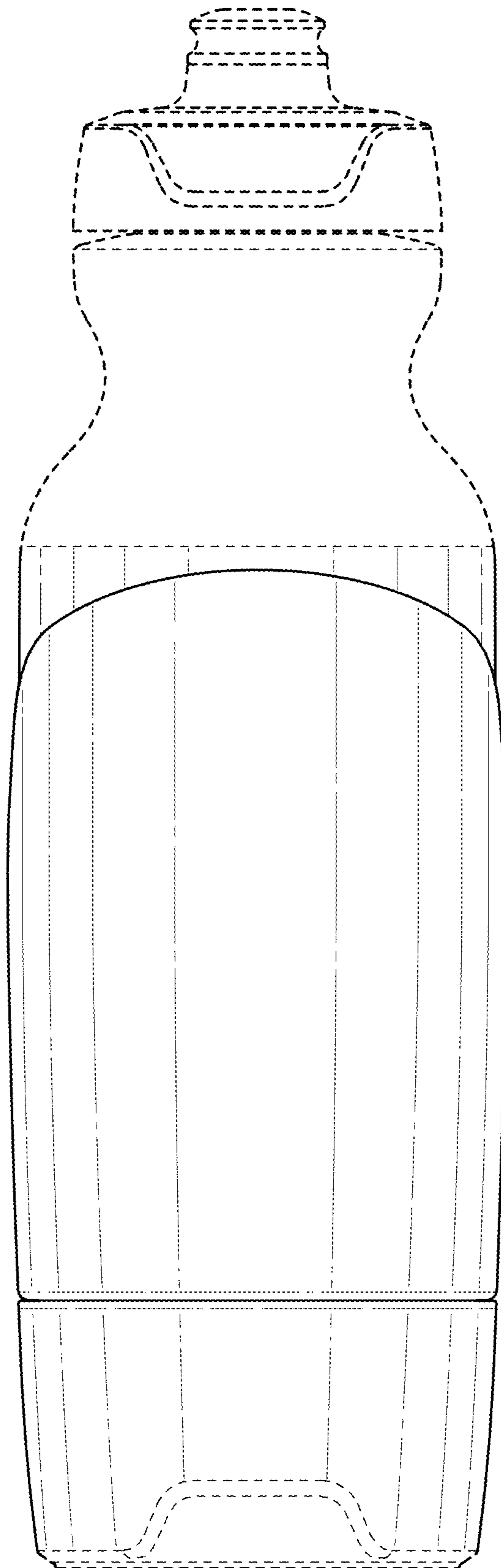

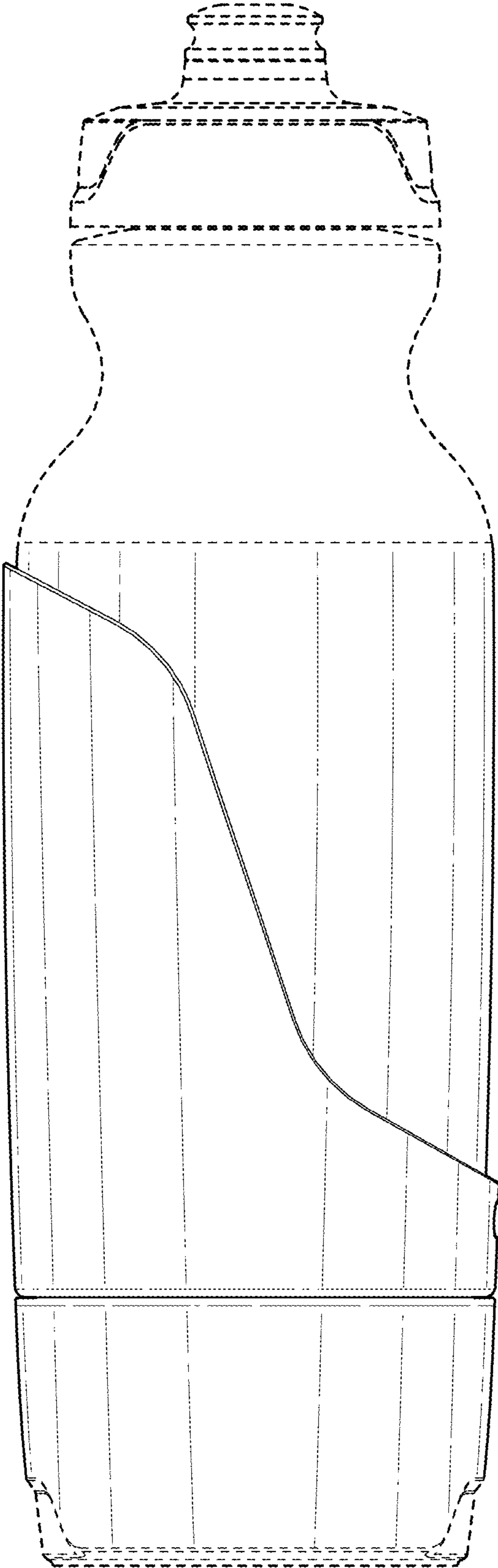

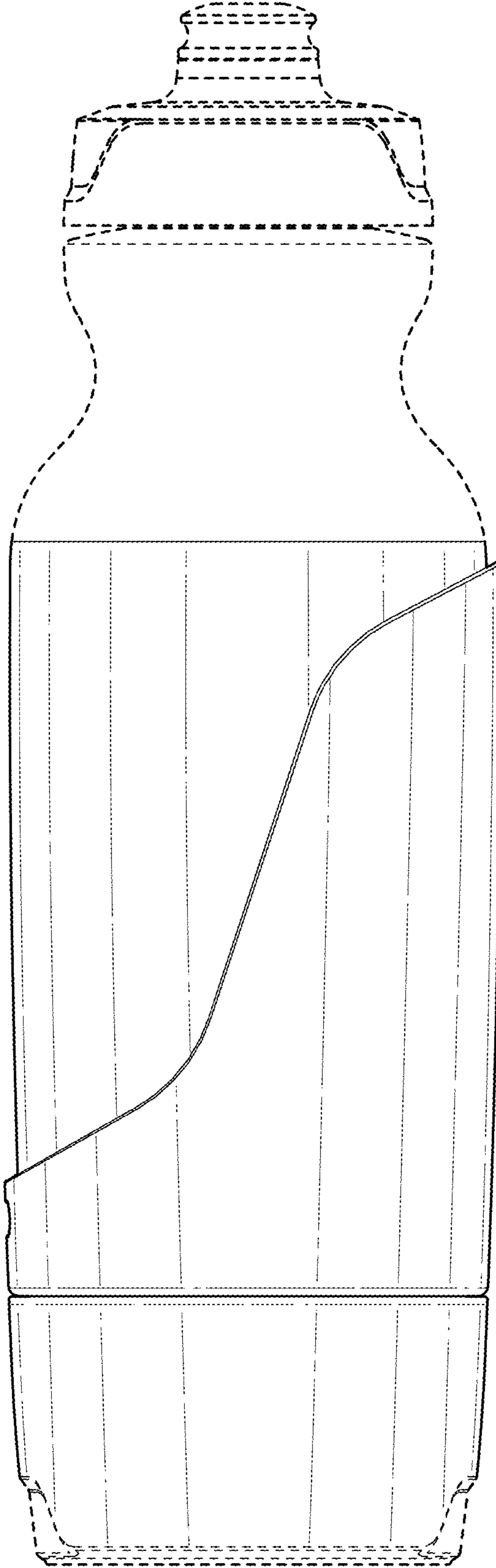
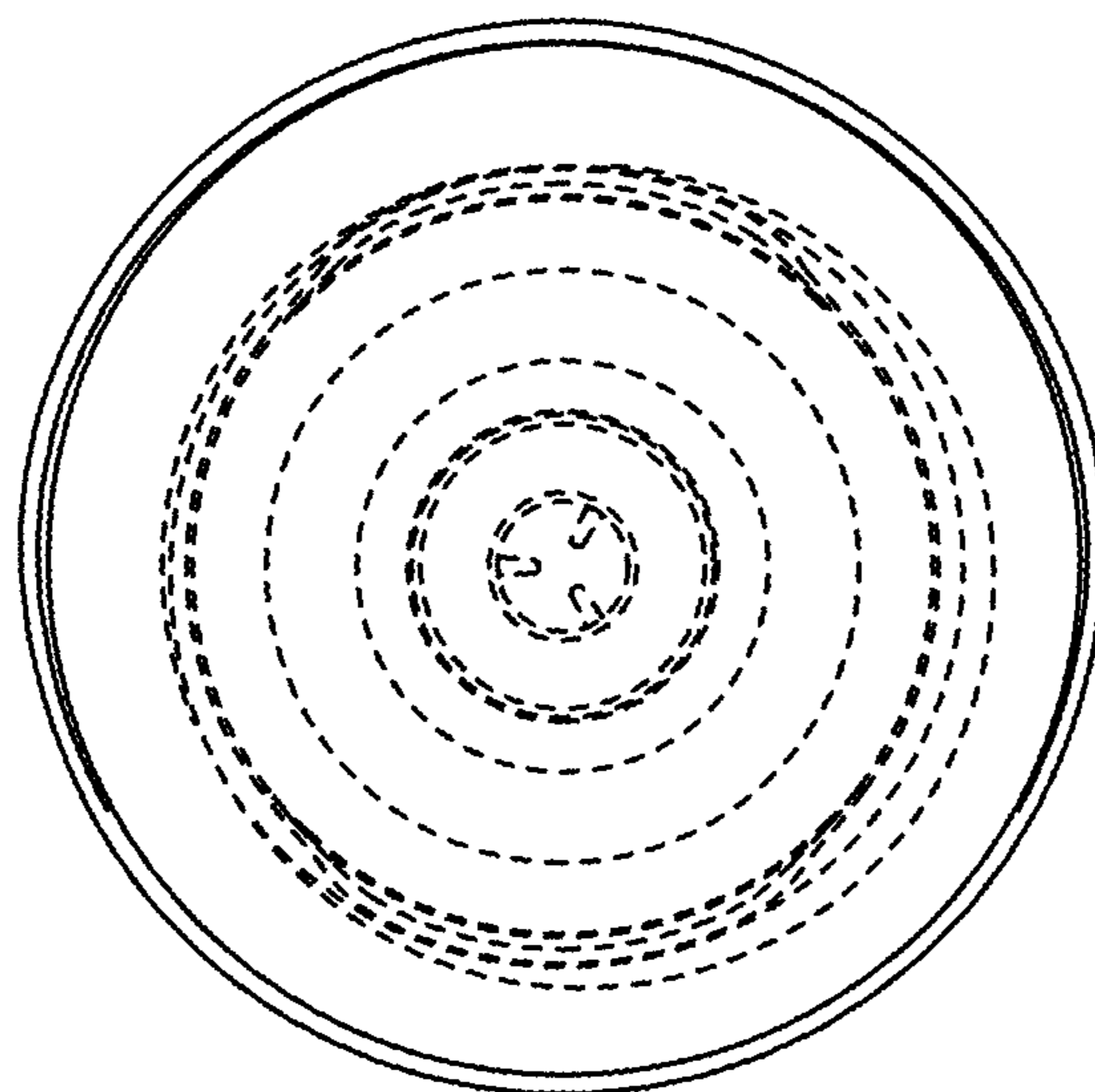
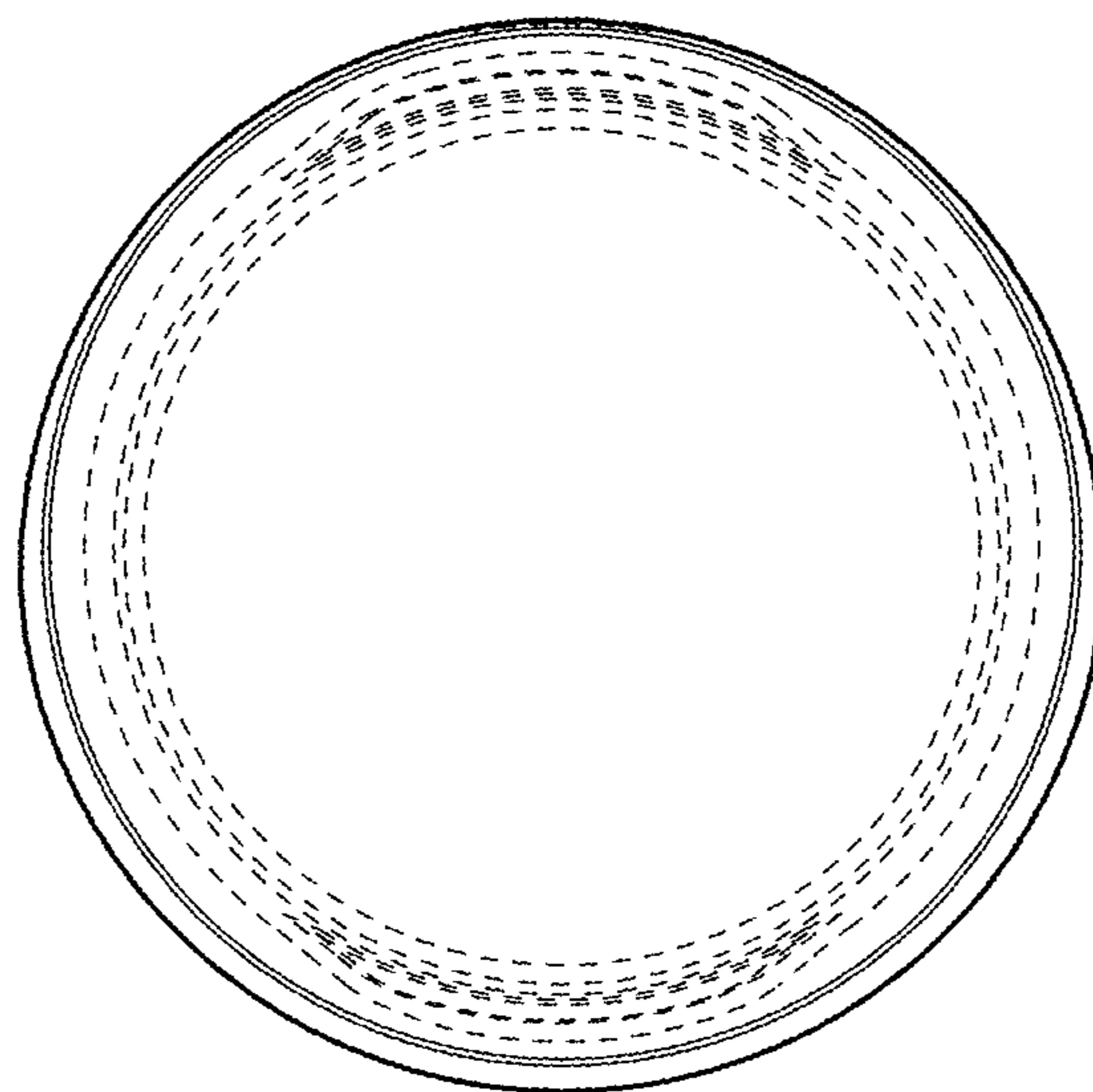
