(57) **CLAIM**

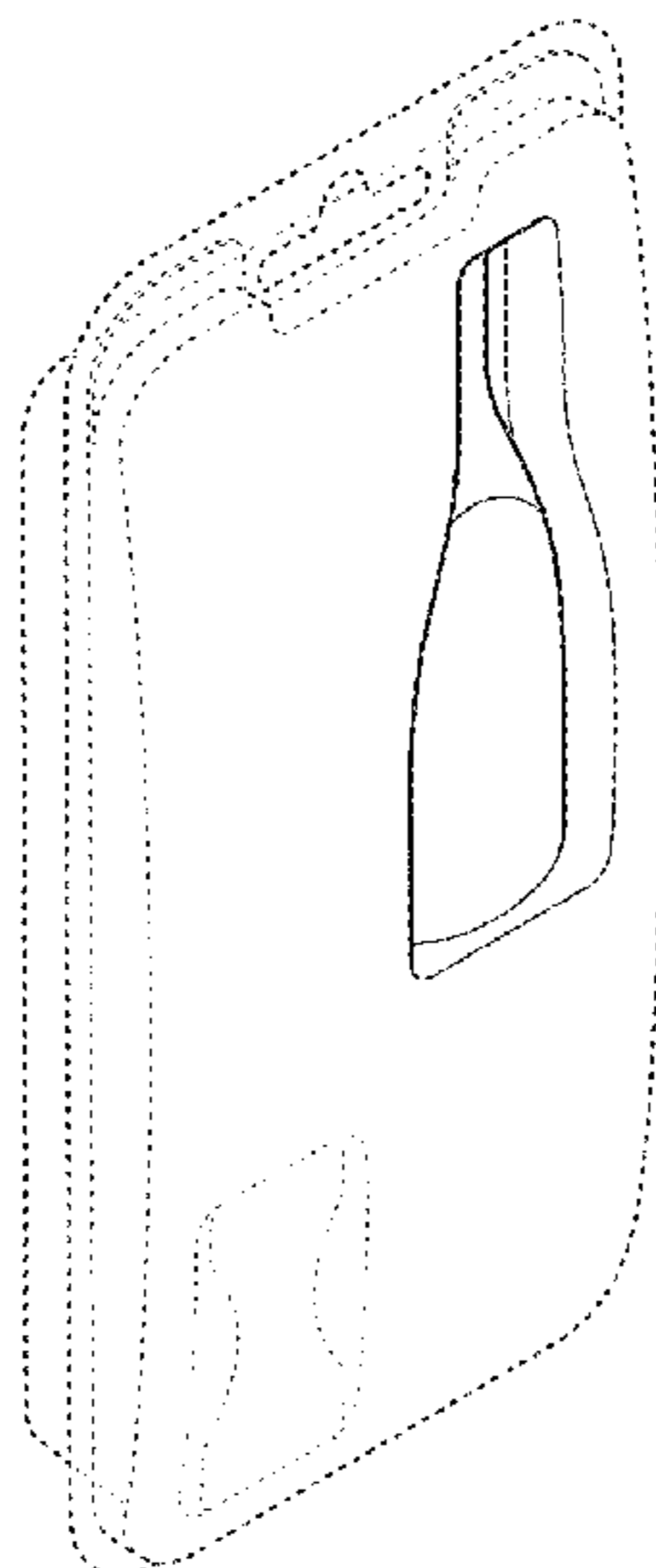
The ornamental design for a blister package, as shown and described.

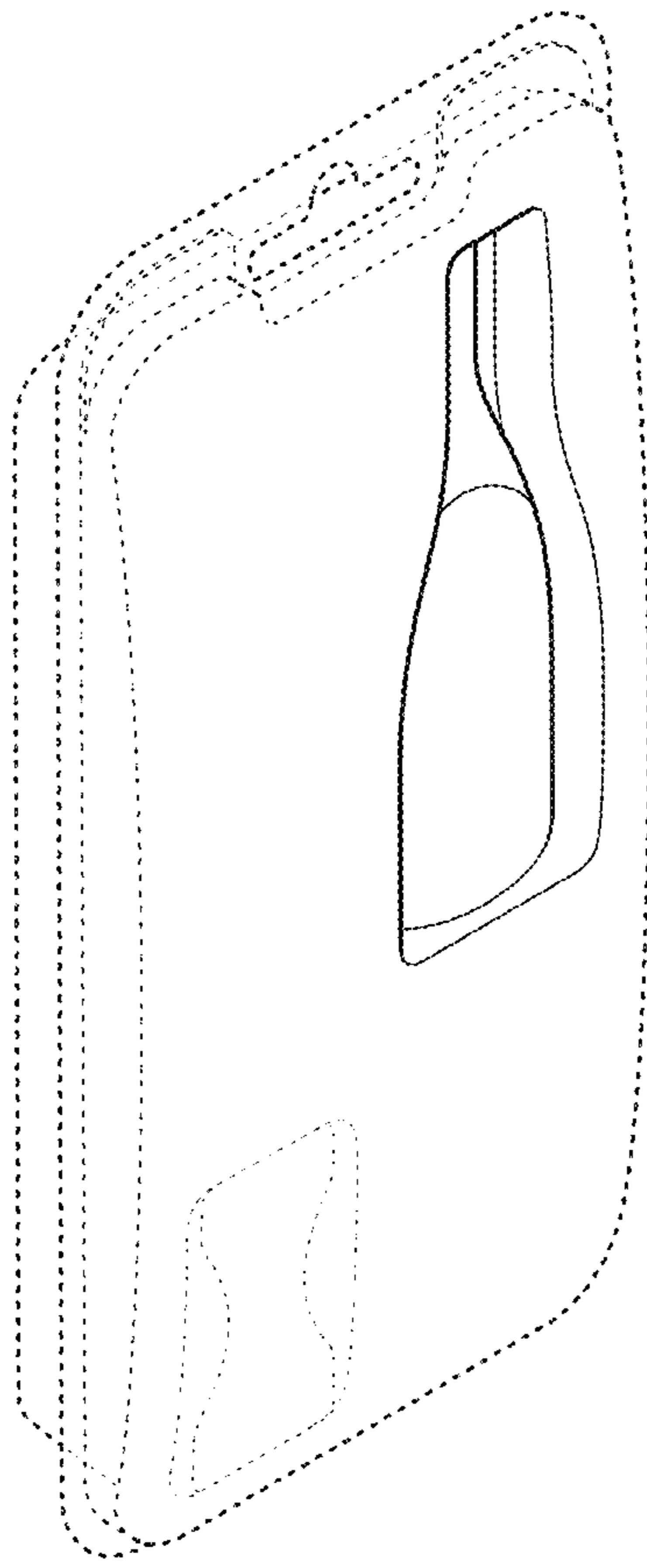

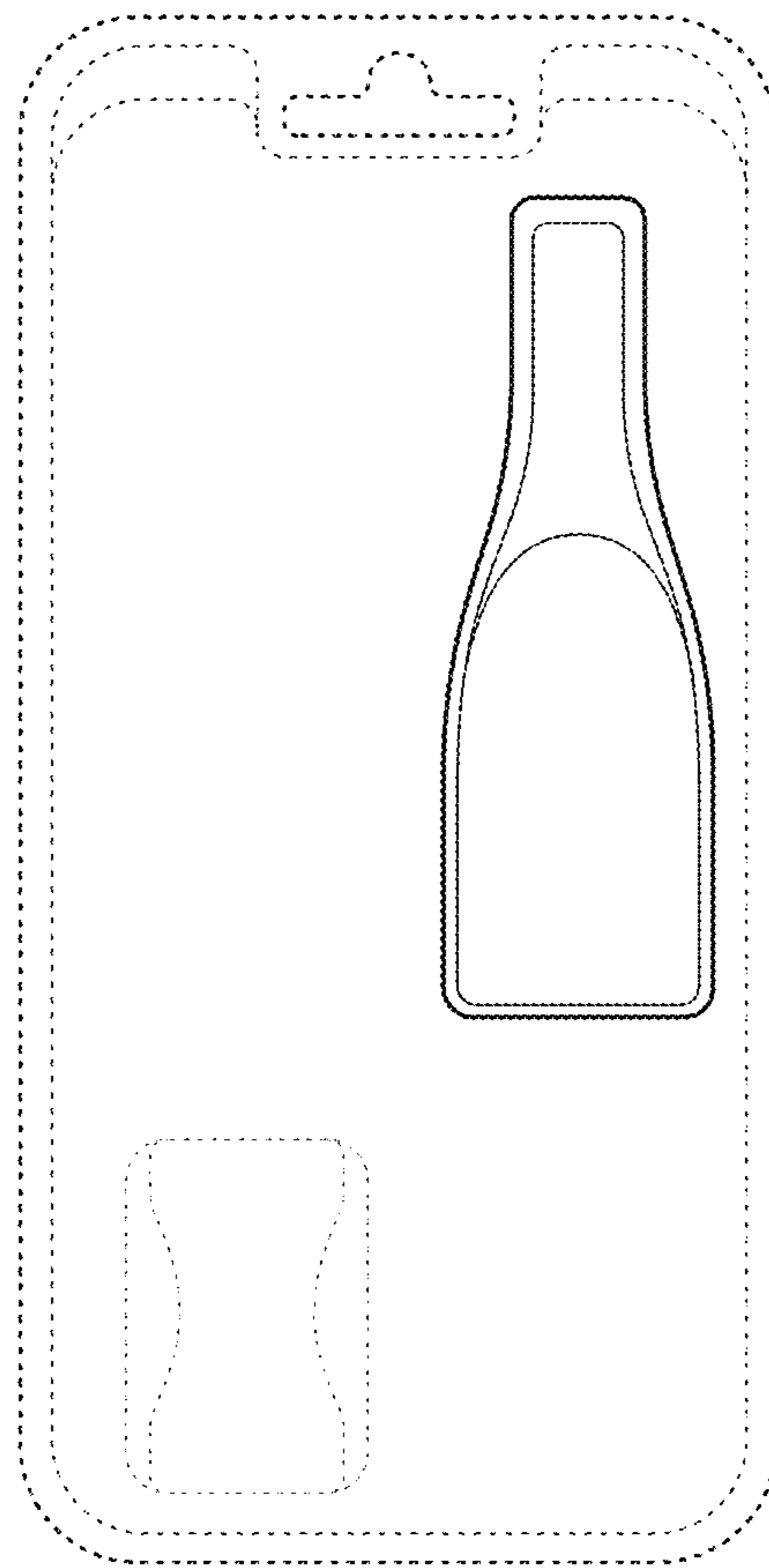

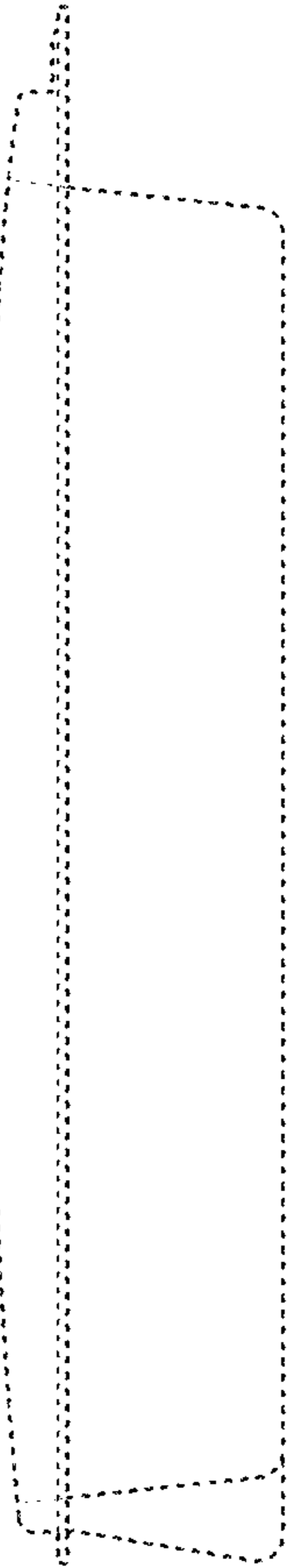

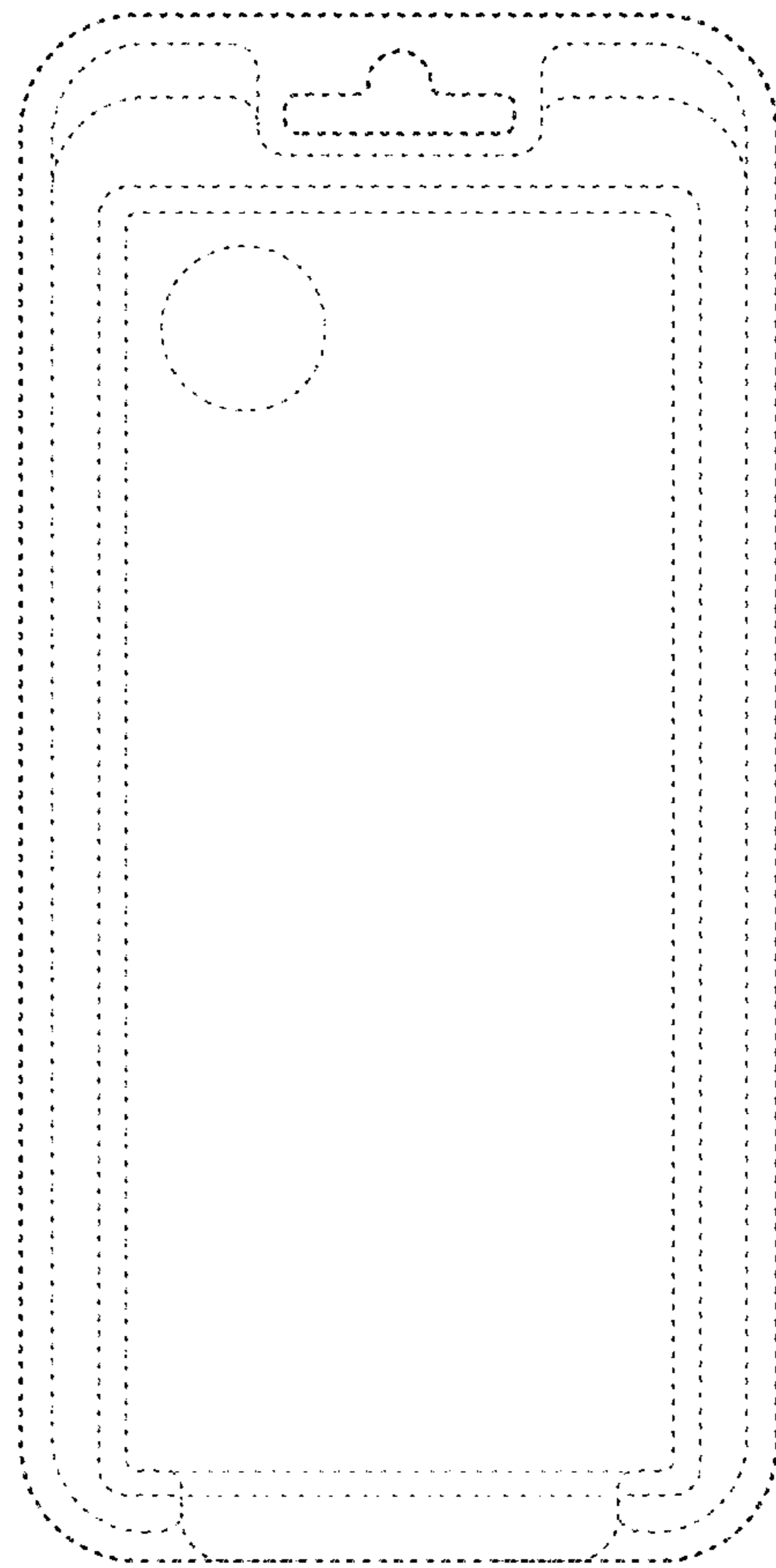

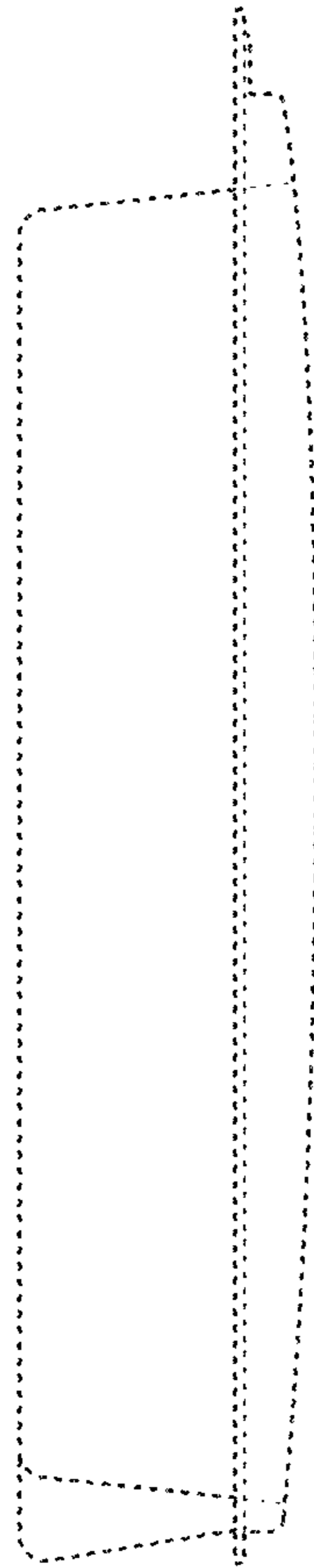

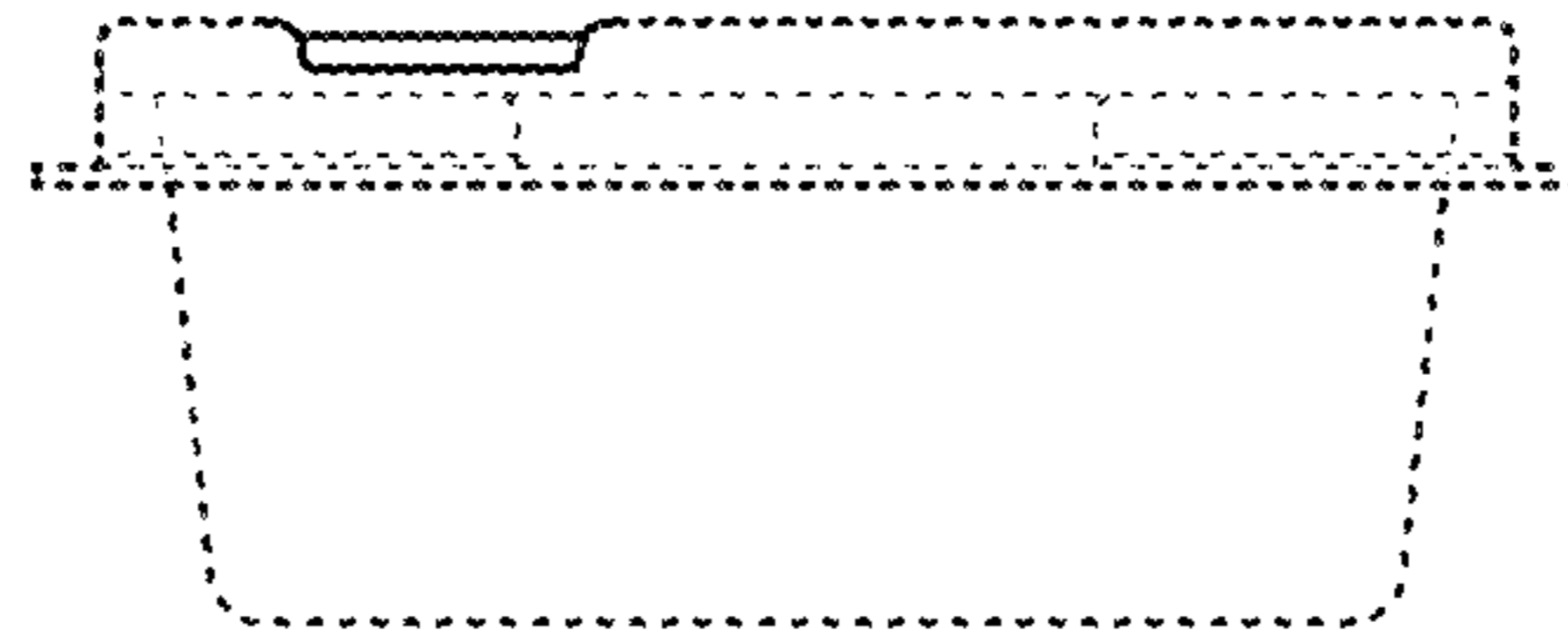

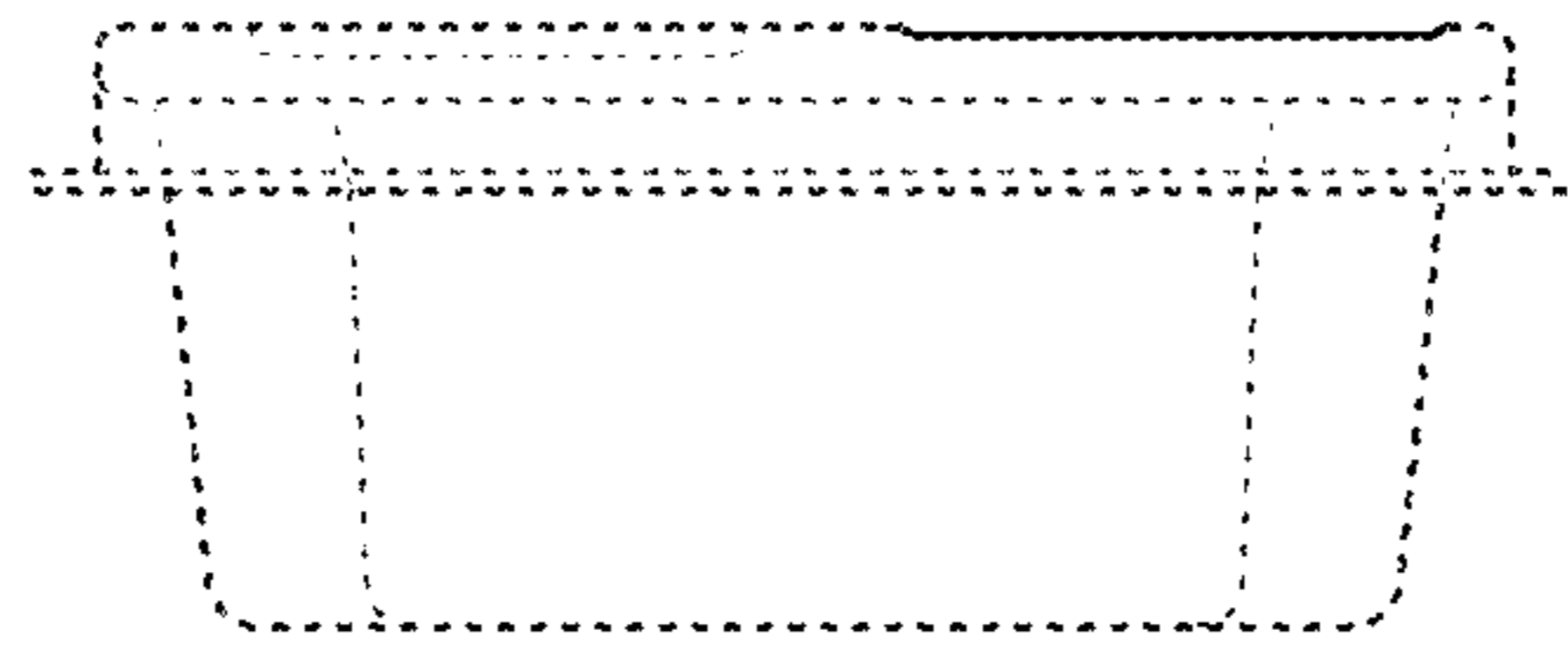
