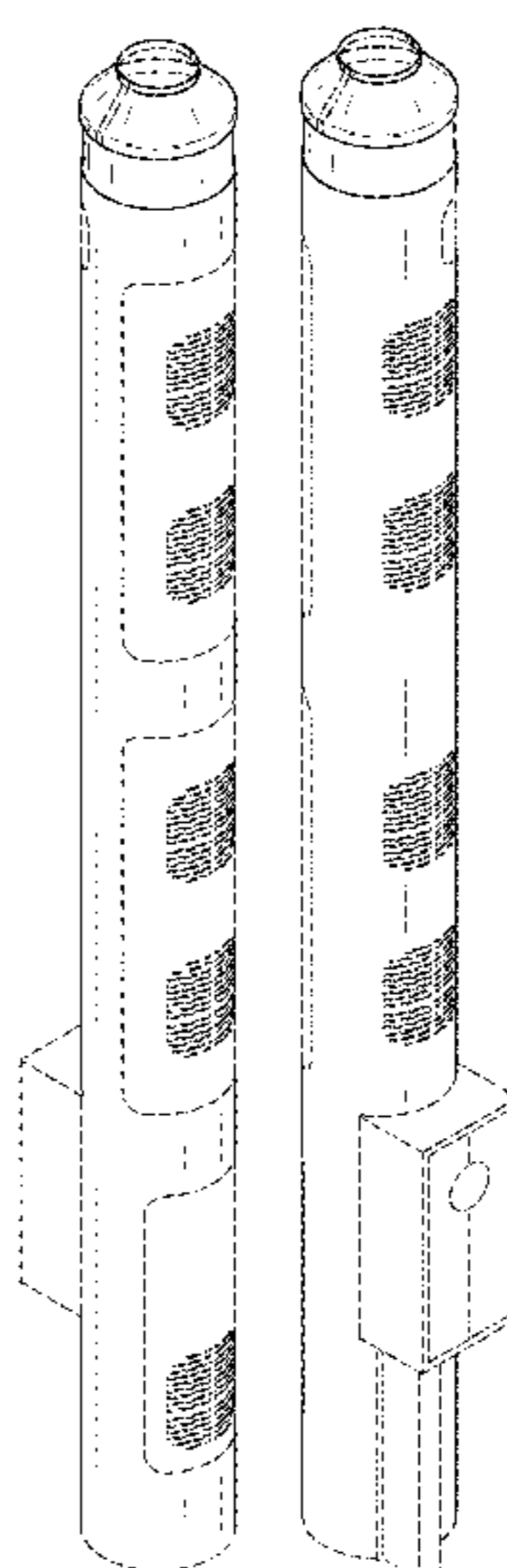
(57) **CLAIM**

The ornamental design for a combined modular radio and power pole, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a combined modular radio and power pole, embodying my new design; FIG. 2 is a rear elevation view thereof; FIG. 3 is a left side elevation view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is an isometric view thereof; and, FIG. 8 is another isometric view thereof. 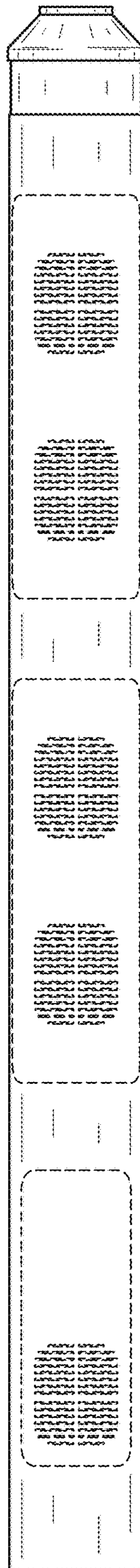

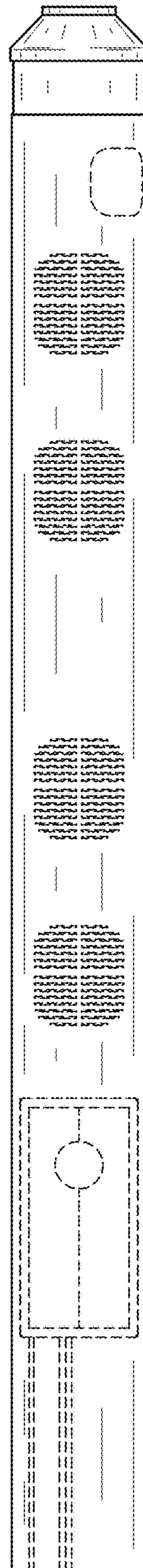

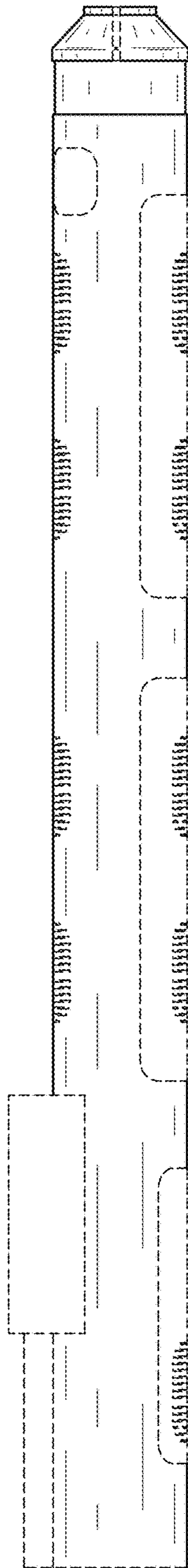

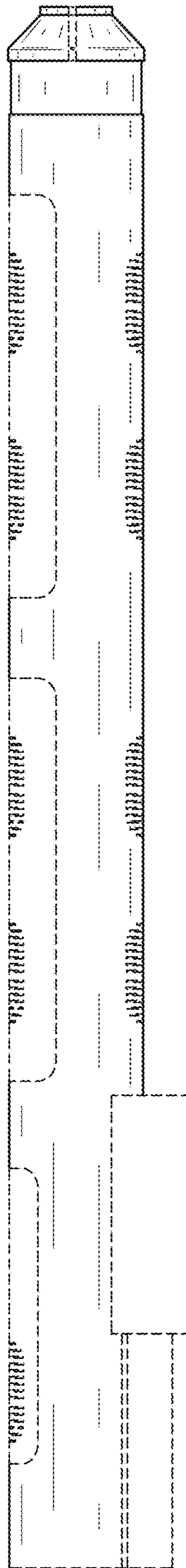

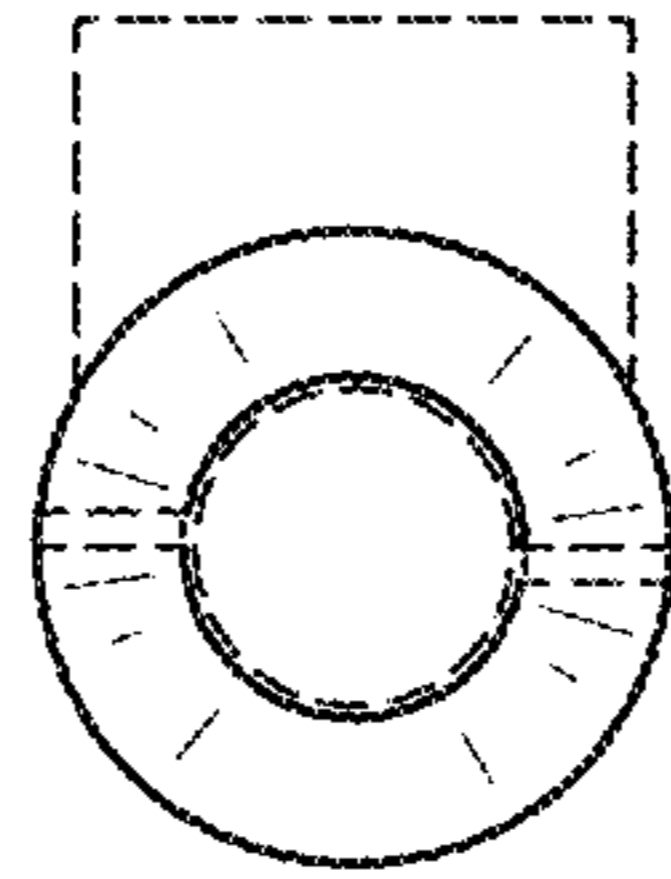

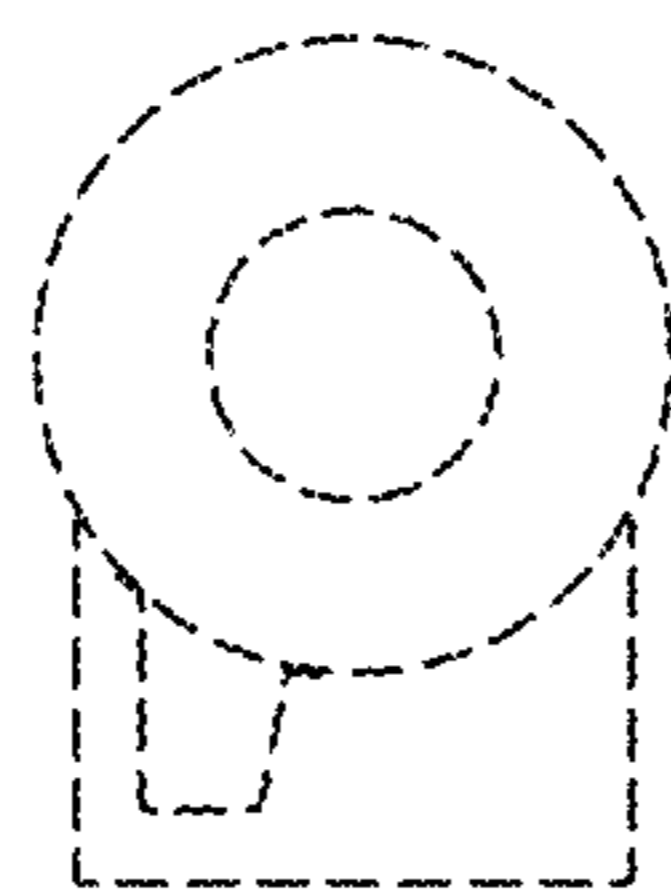

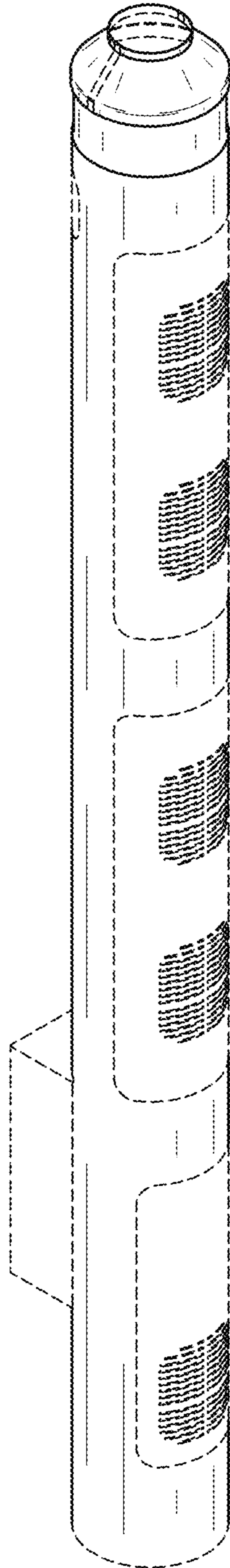

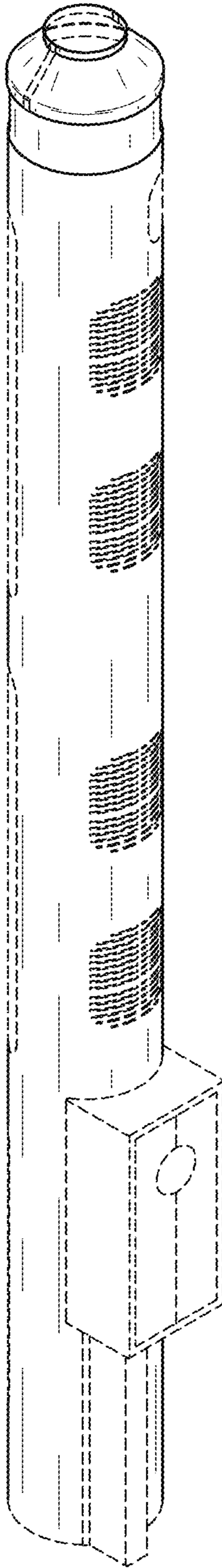
