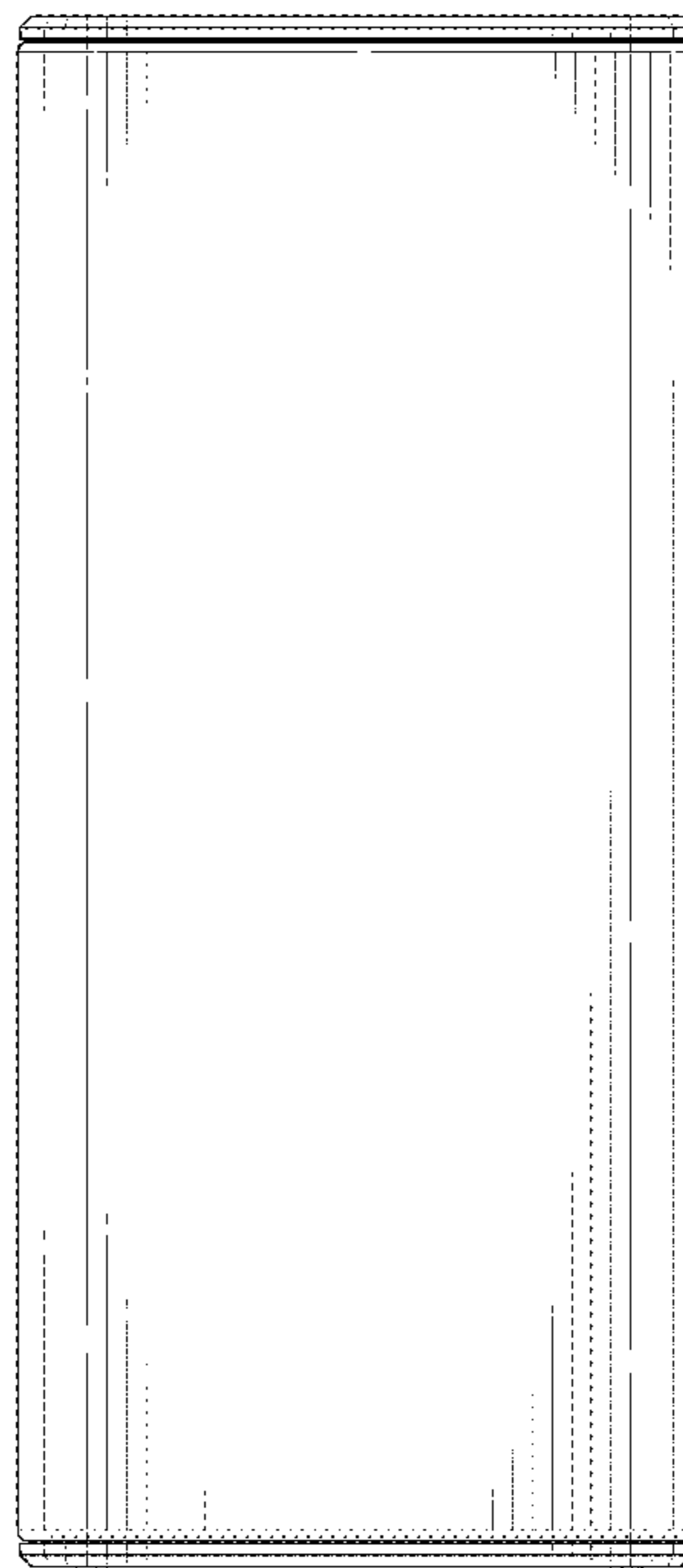
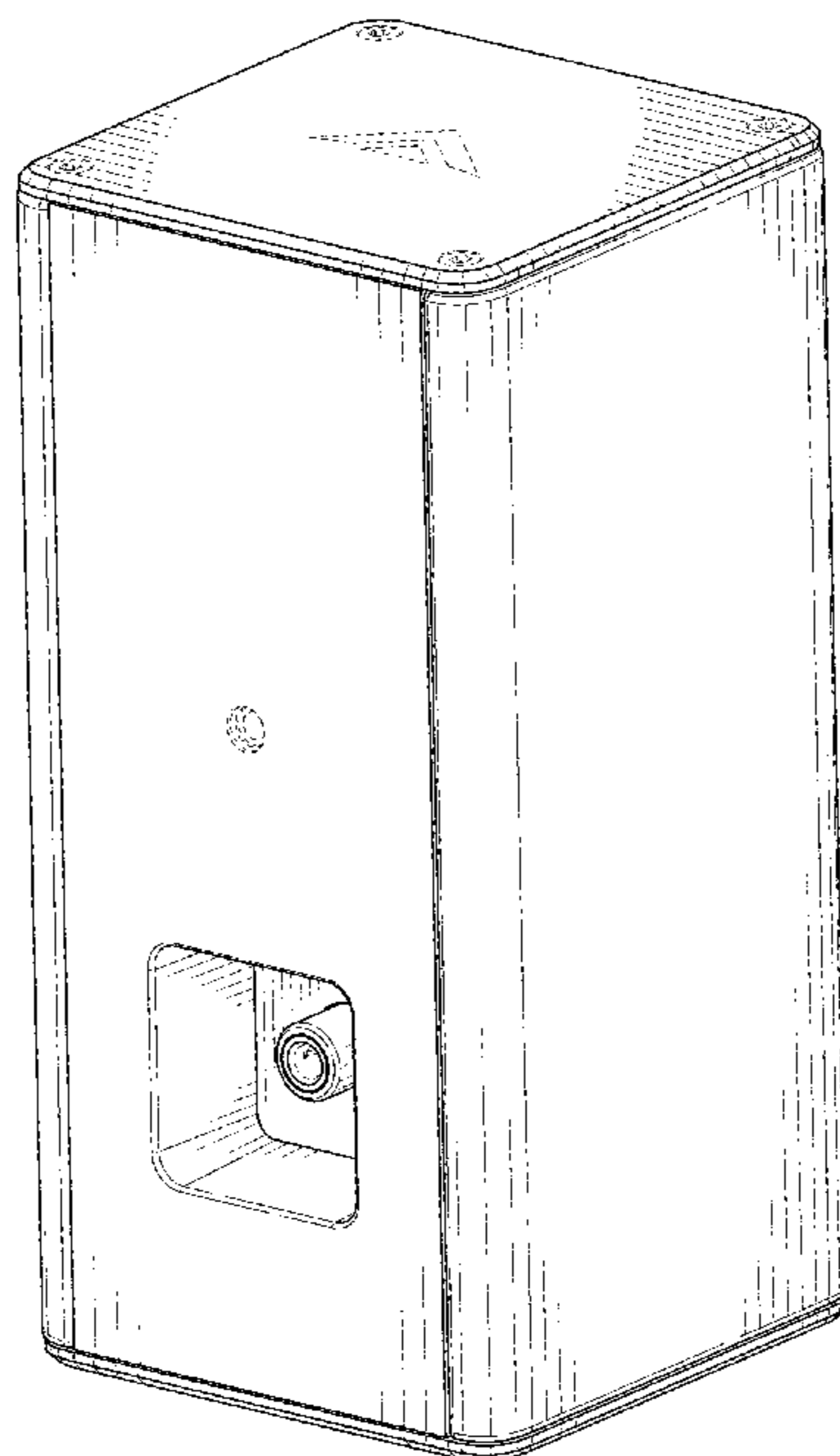
We claim the ornamental design for a satellite speaker, as shown and described.

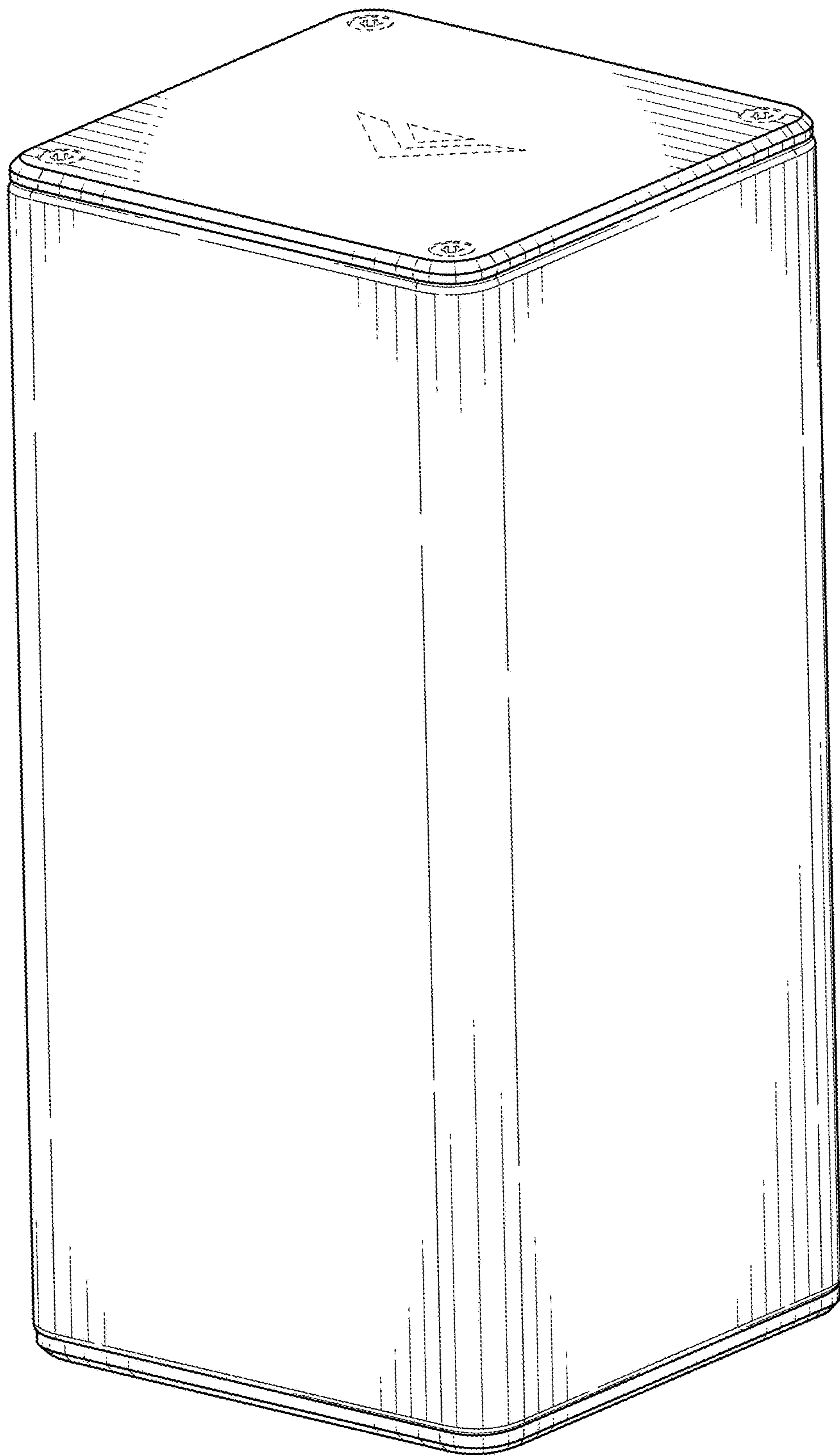

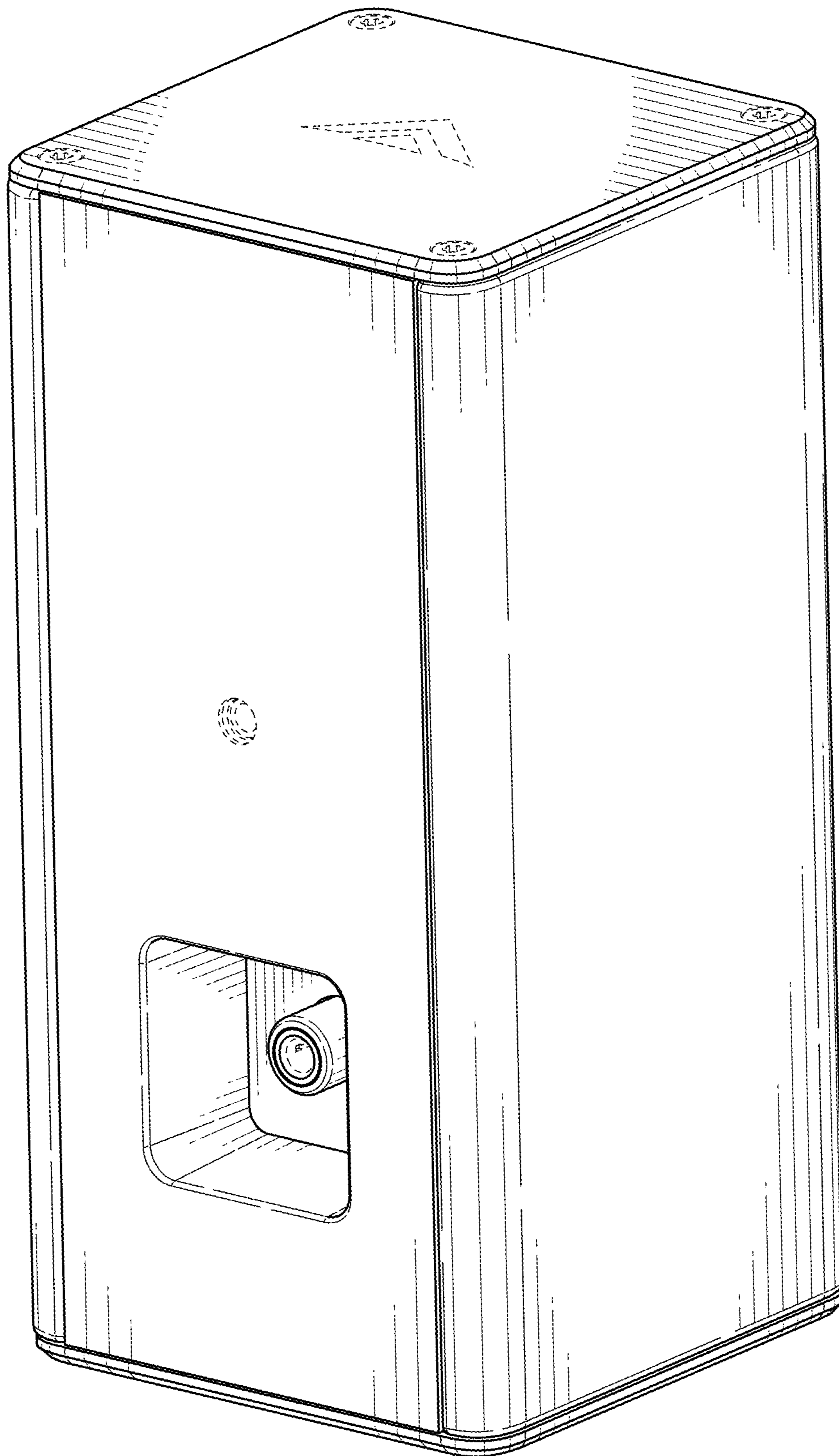

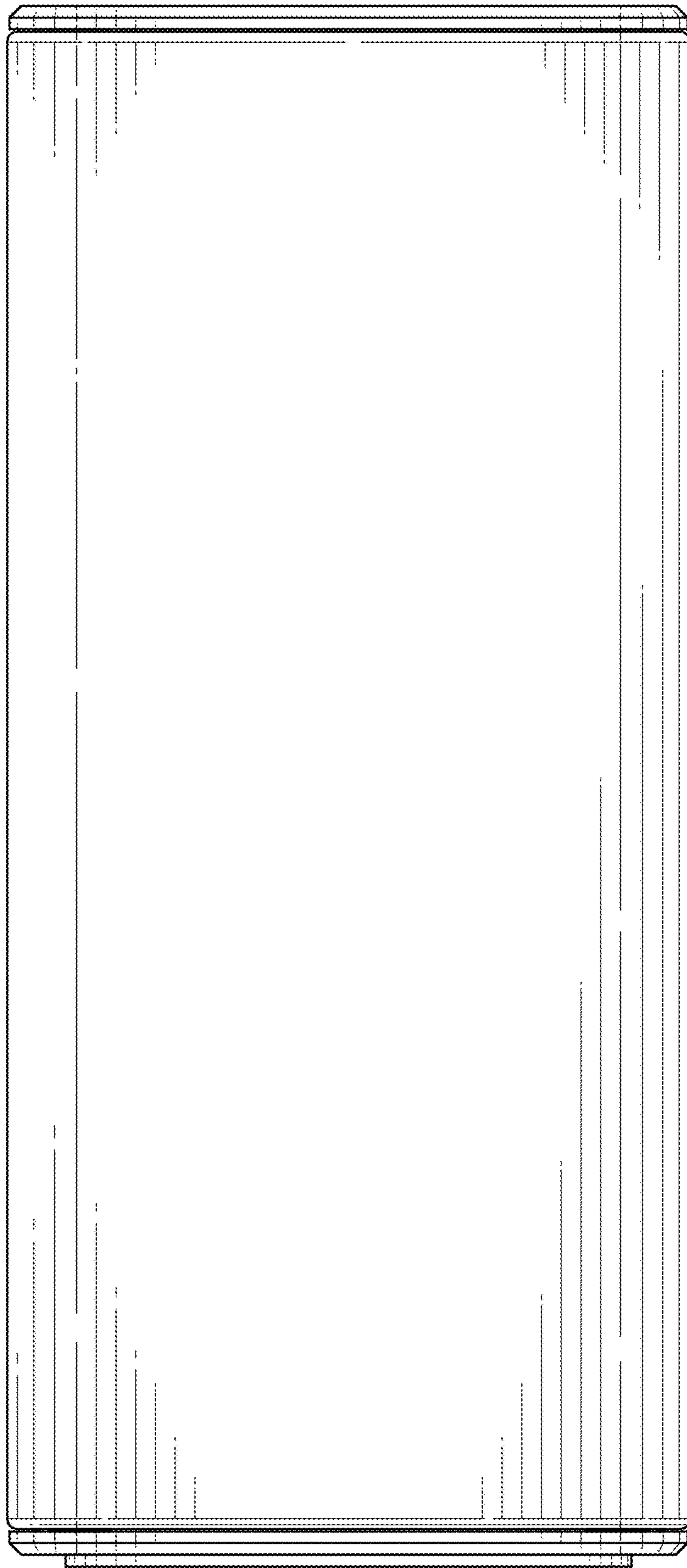

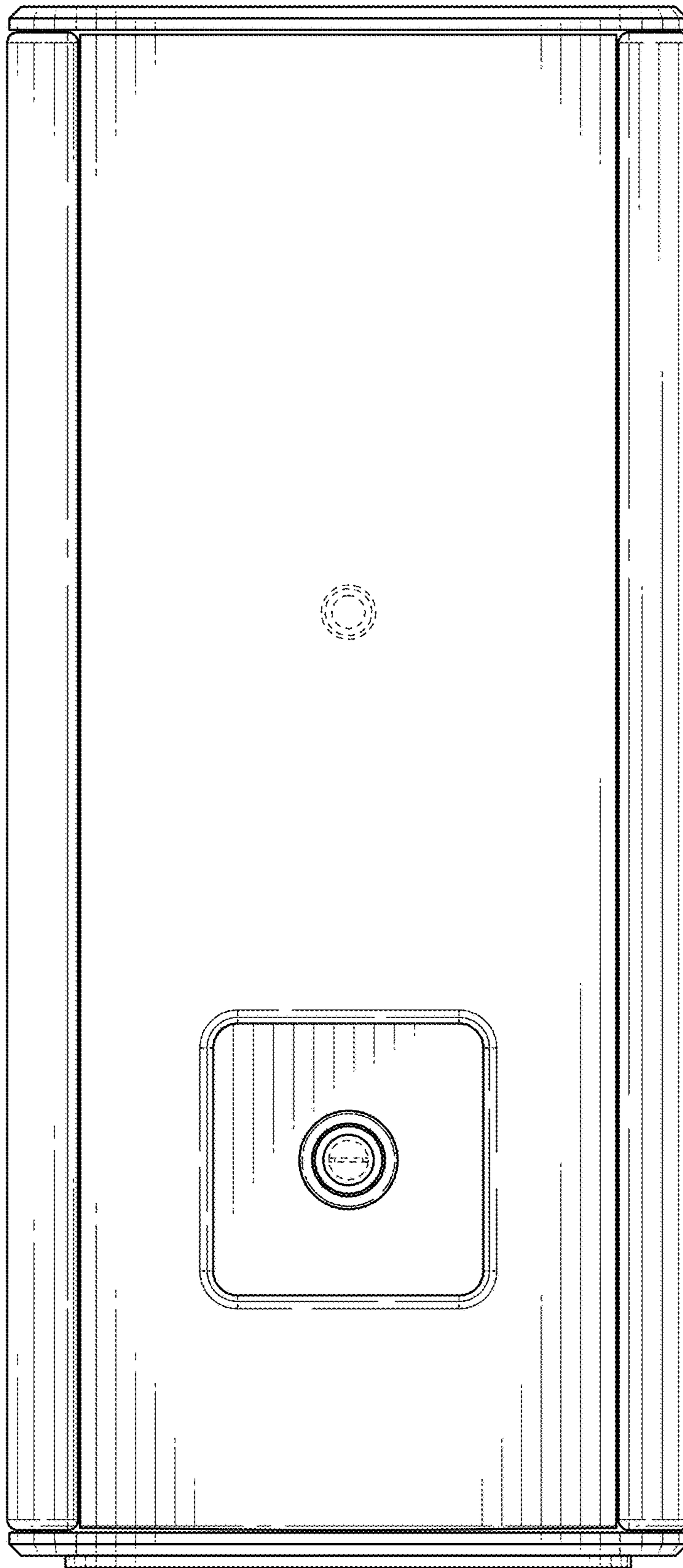

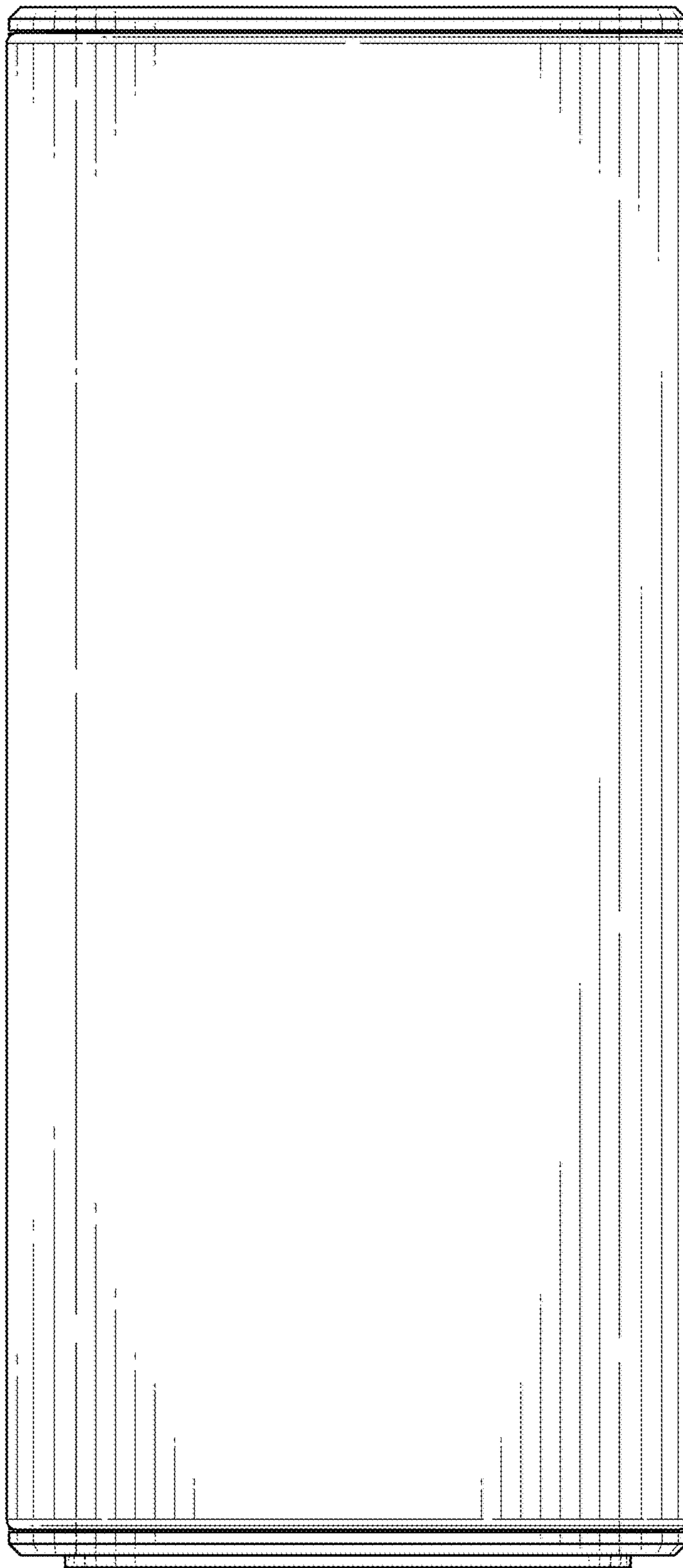

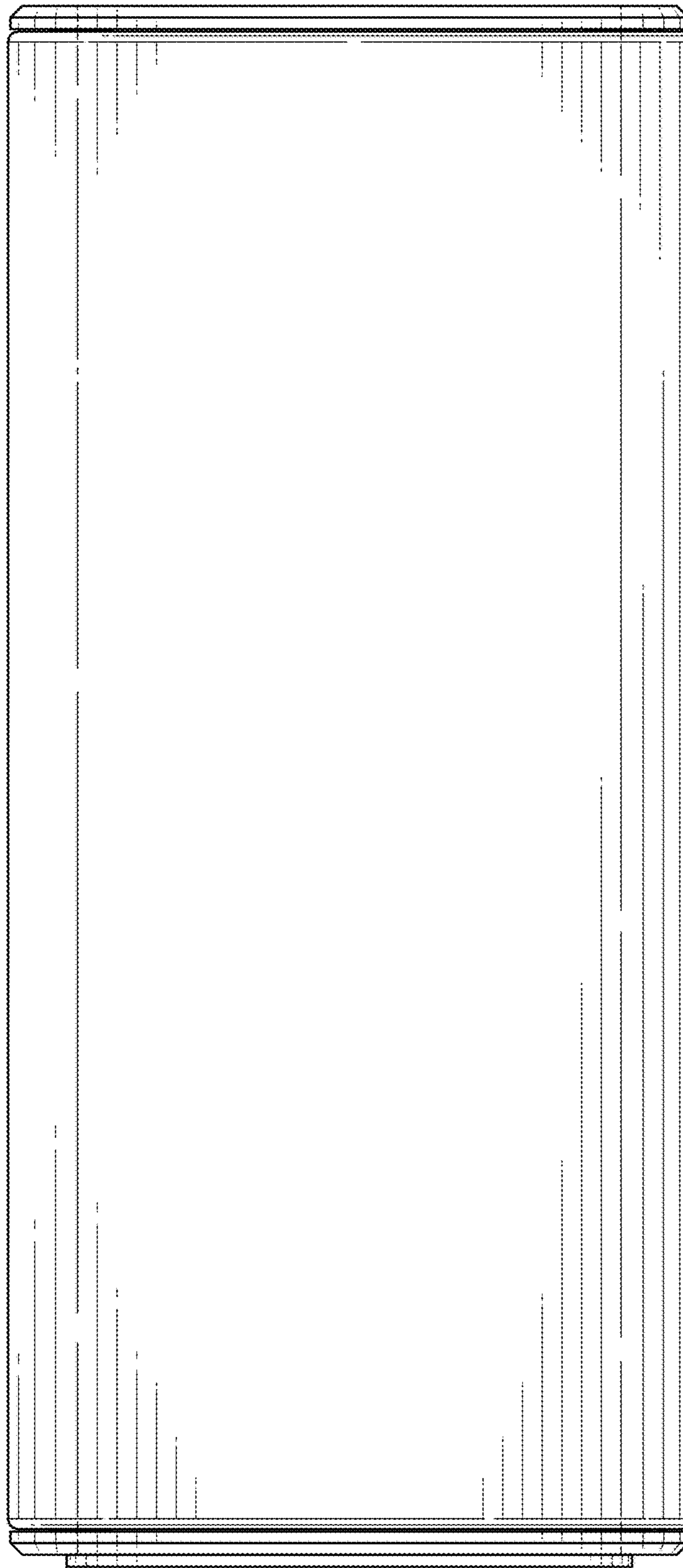

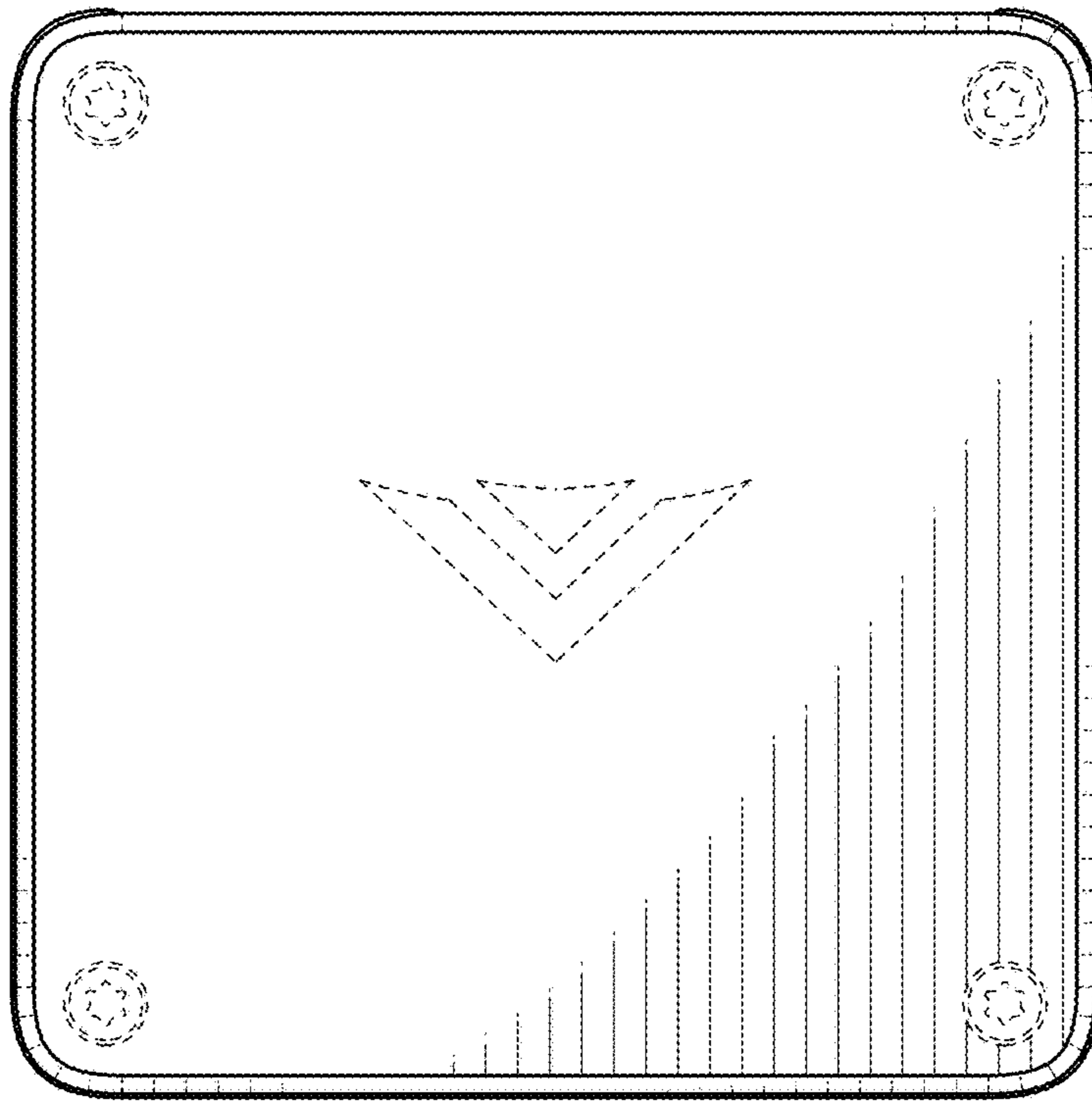

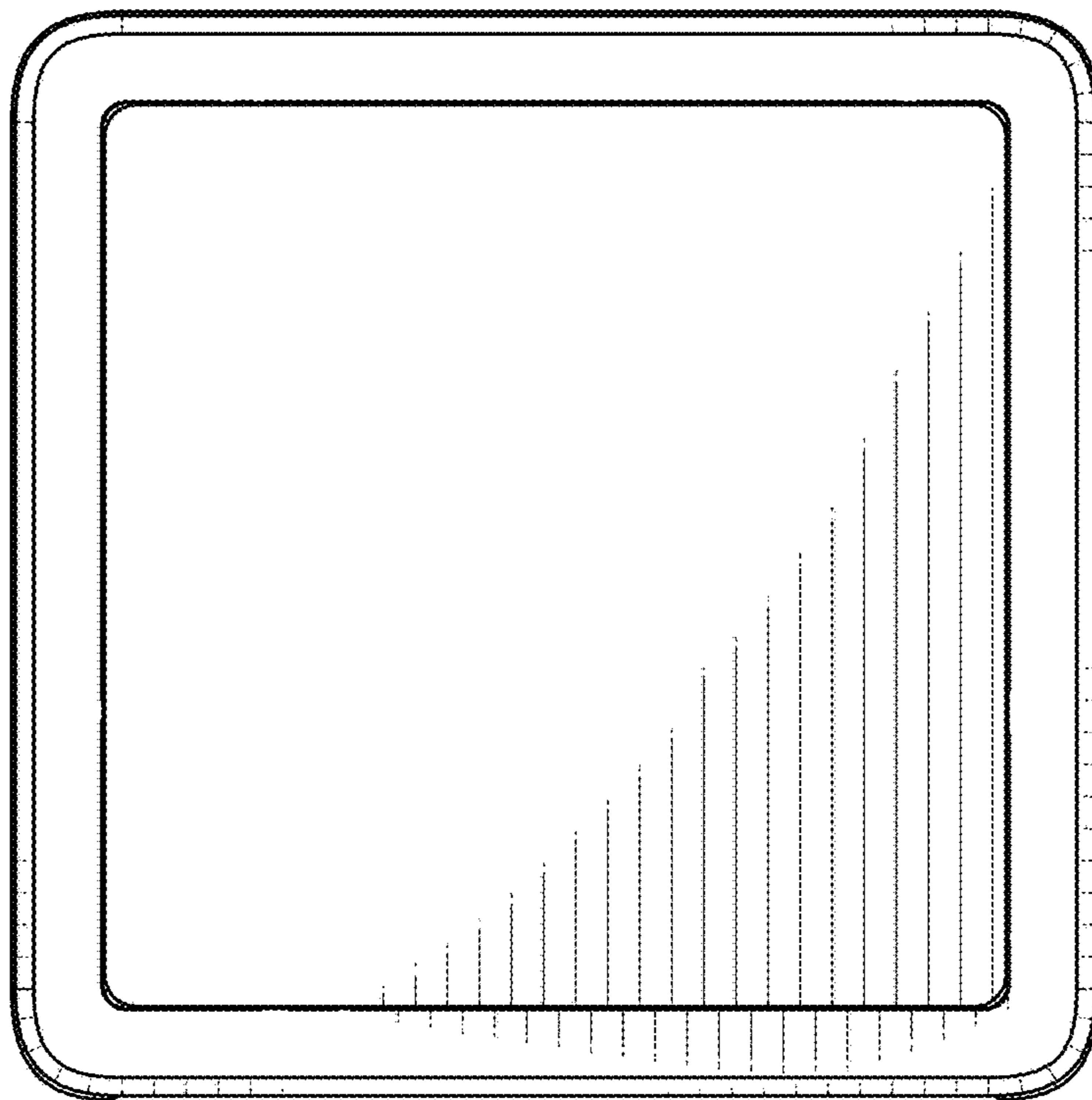
