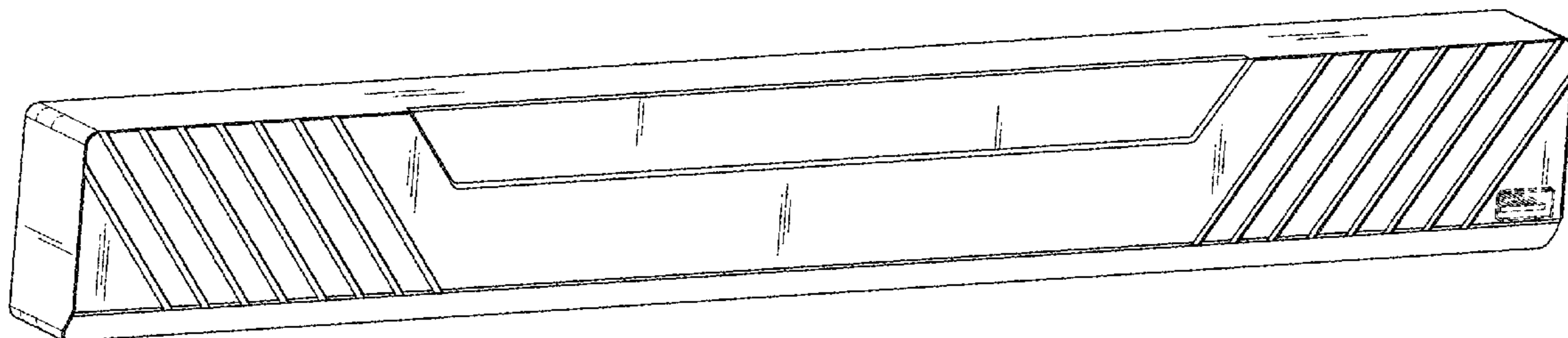

DESCRIPTION

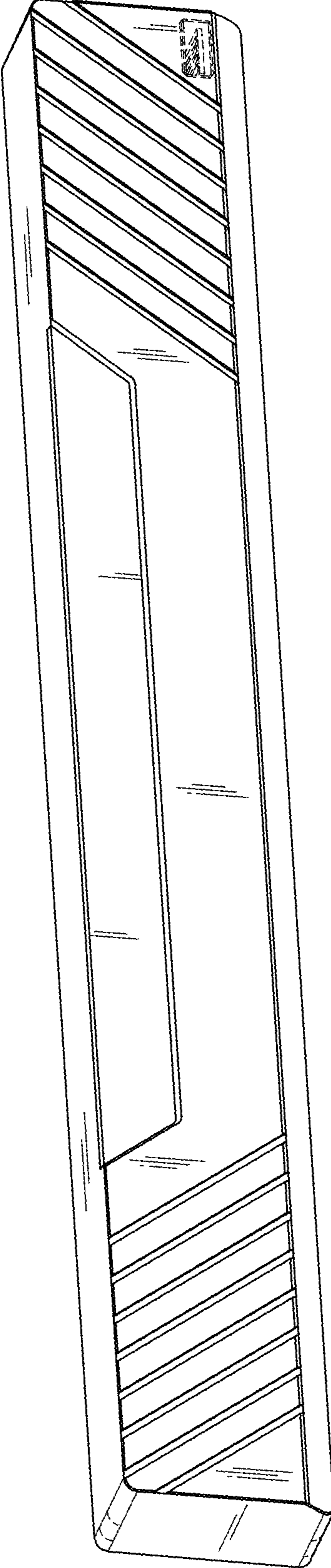

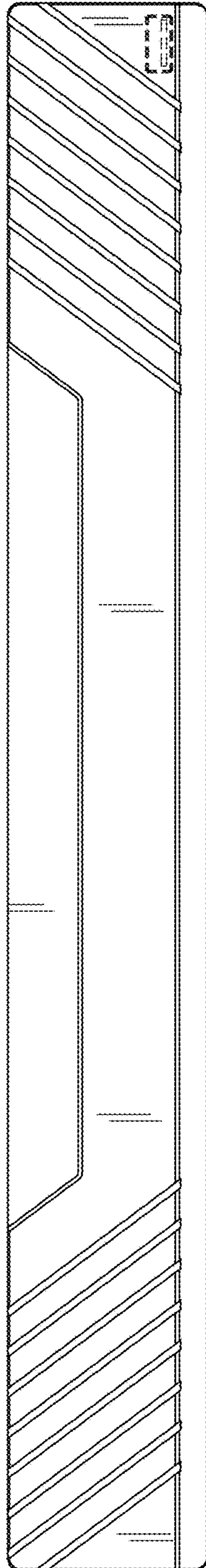

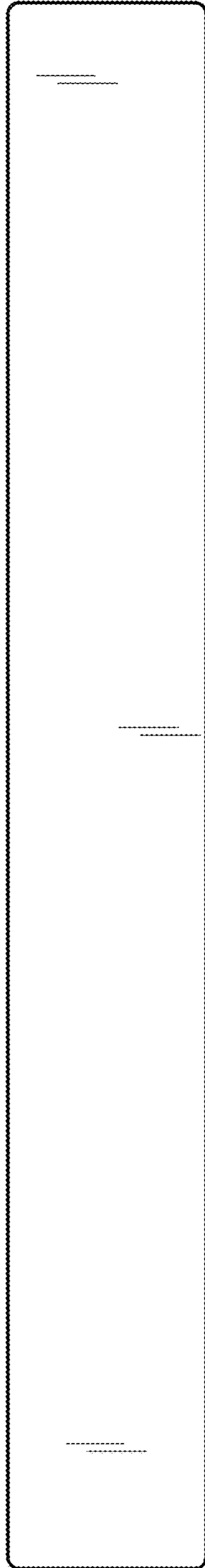

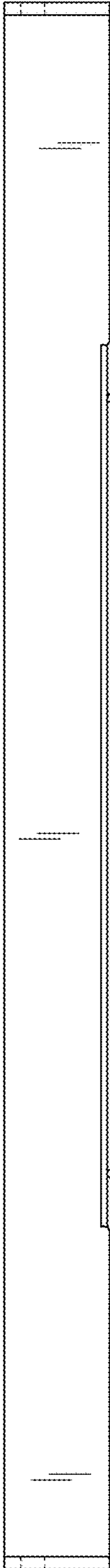

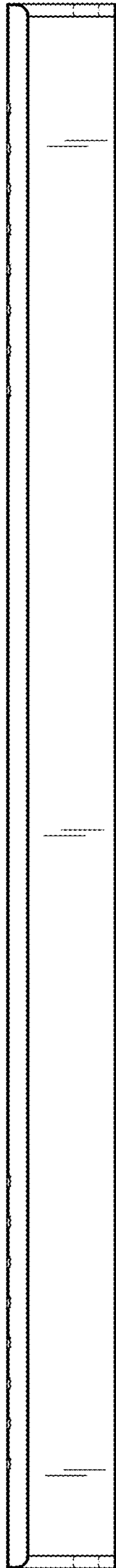

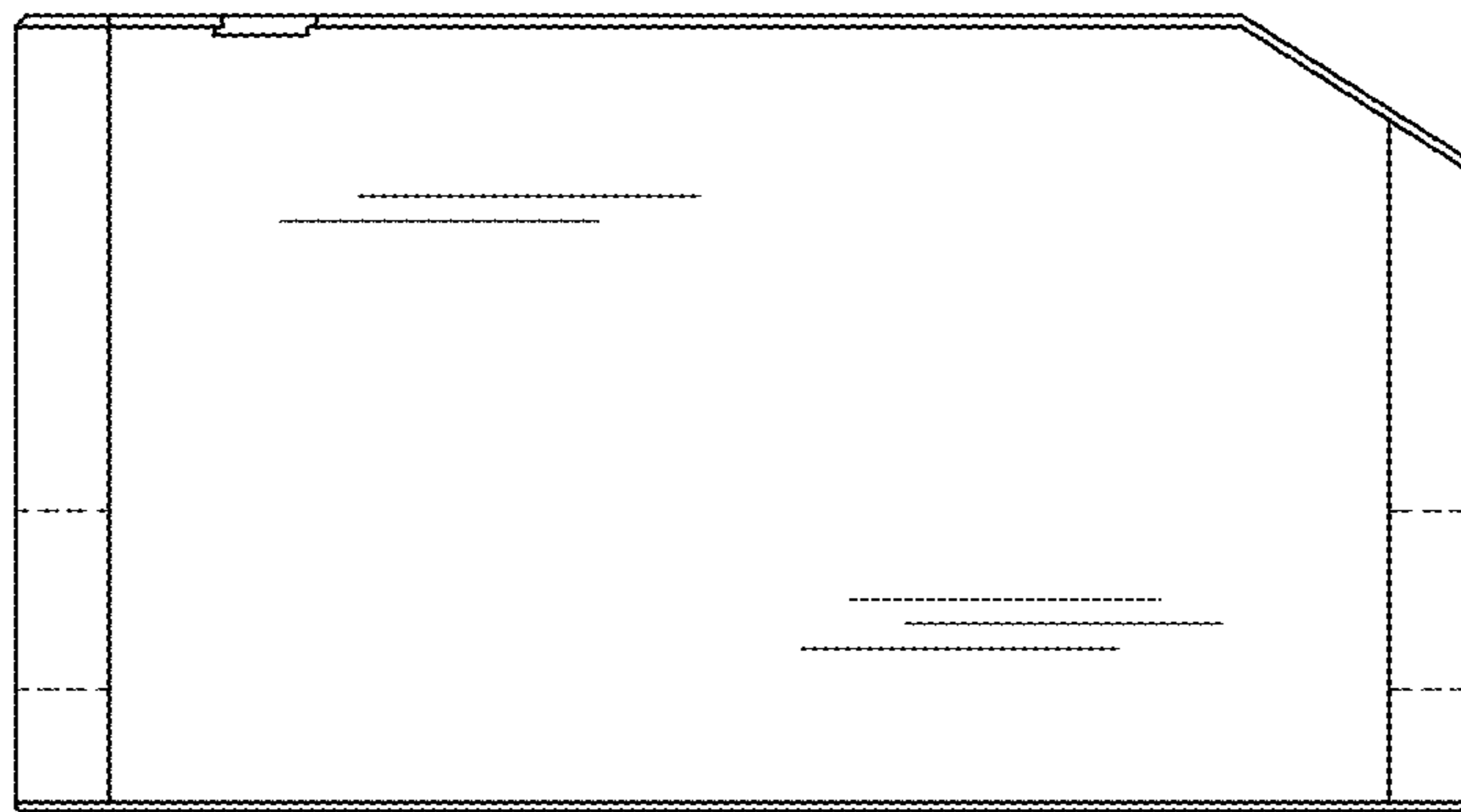

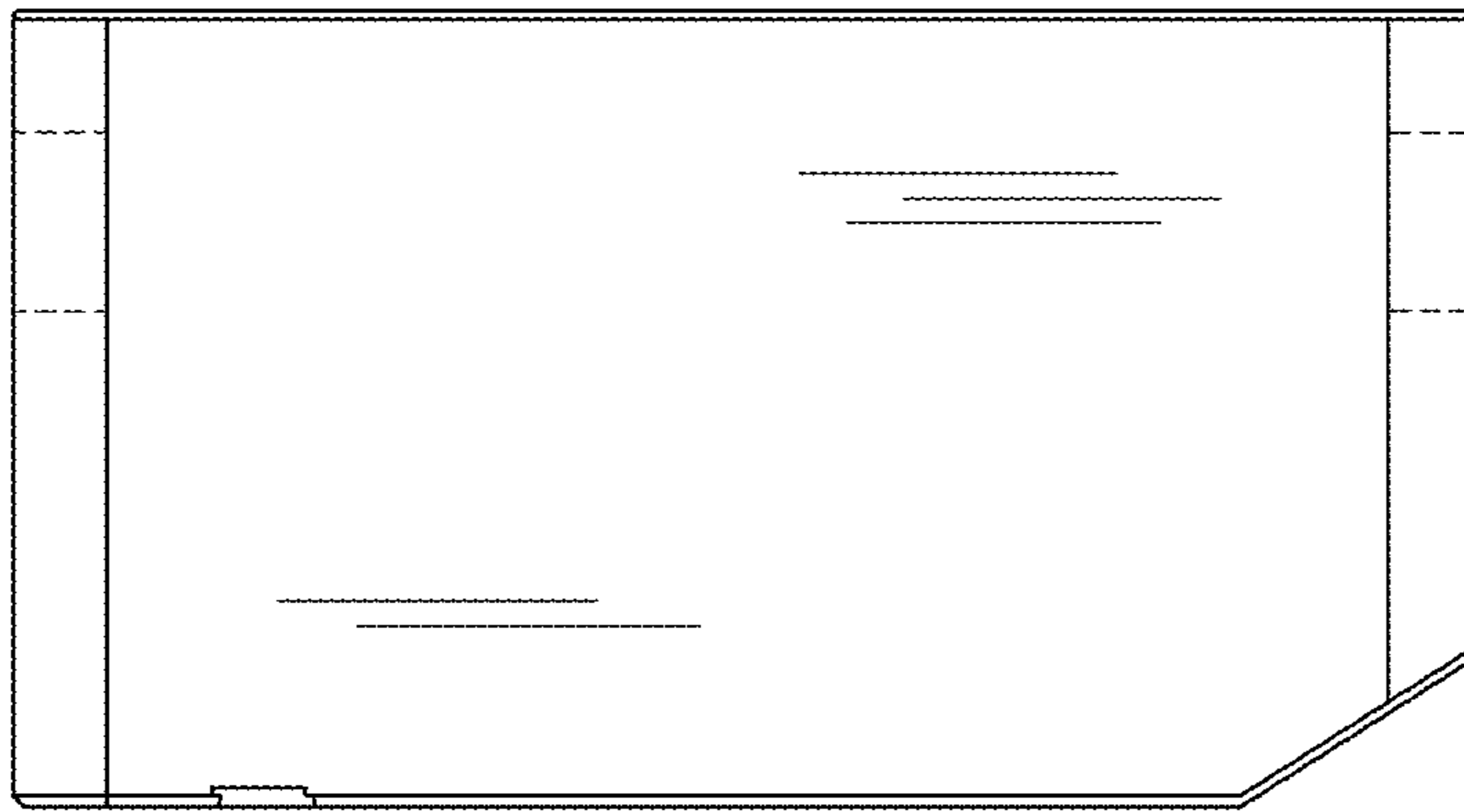
