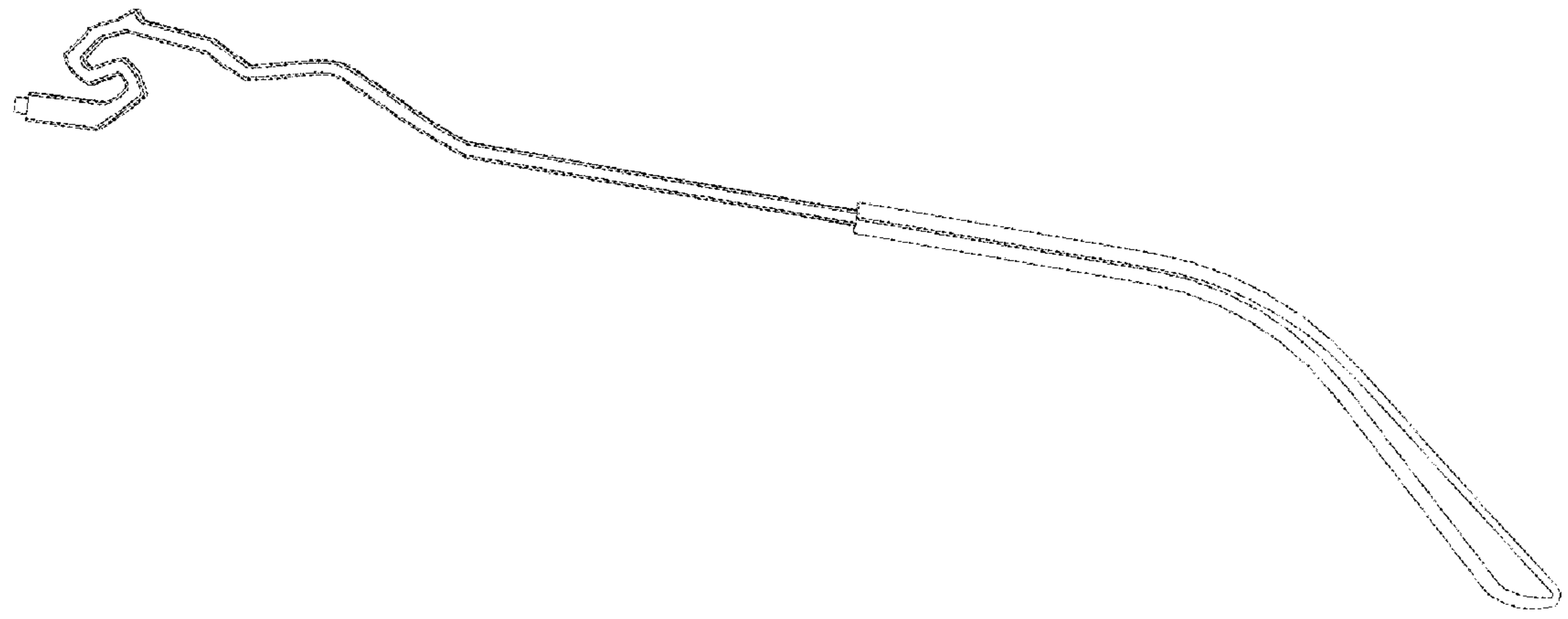
(57) **CLAIM**

FIG. 1 is a front elevational view of a spectacle arm showing my new design;

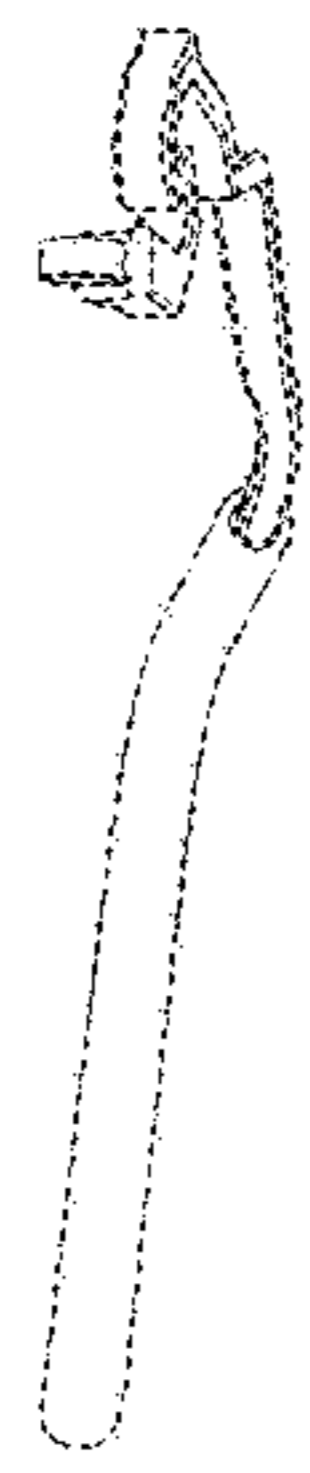

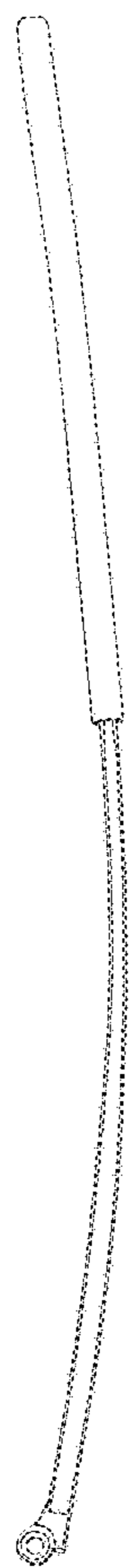

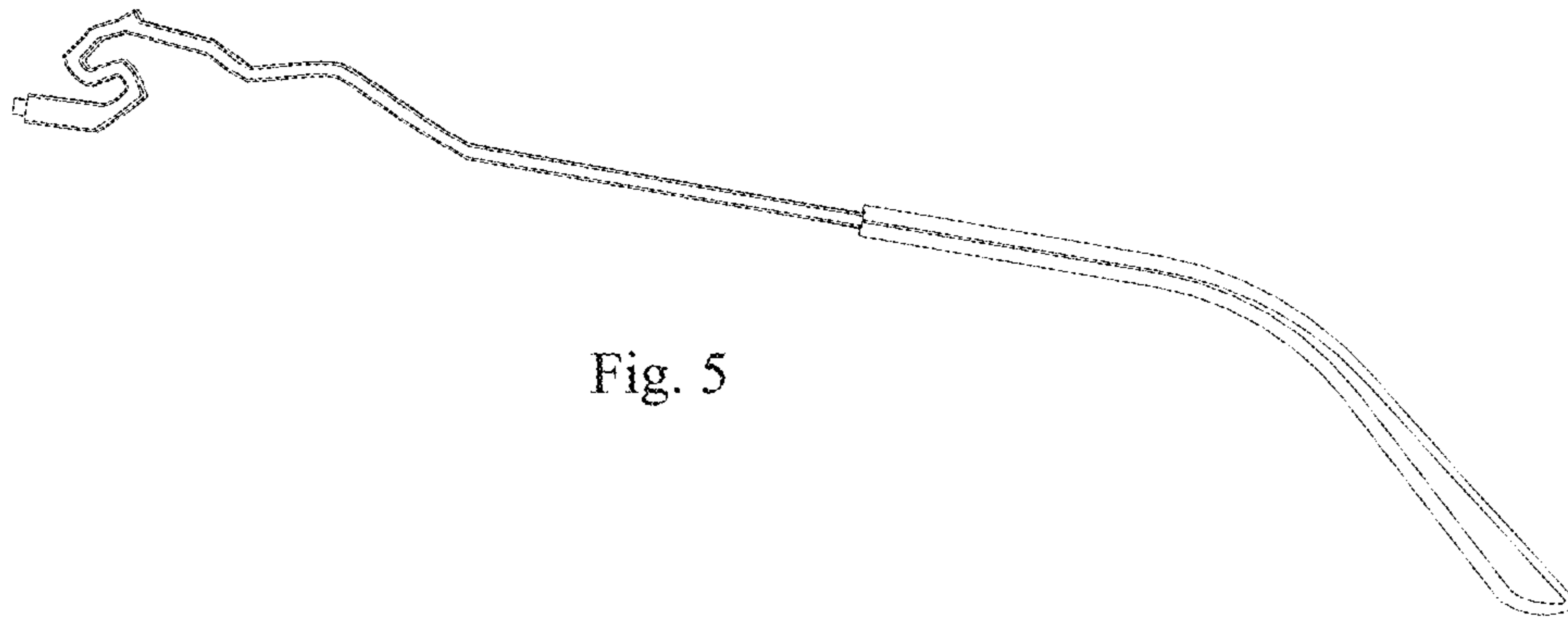

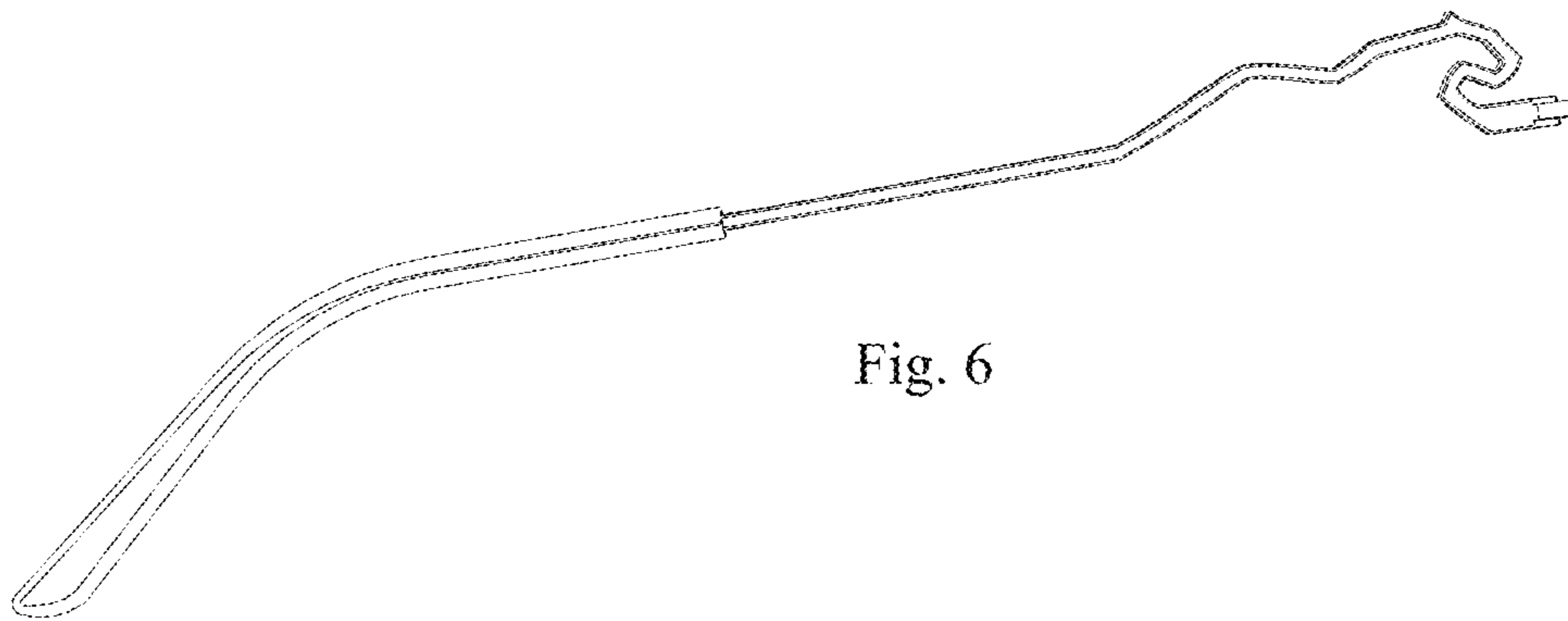

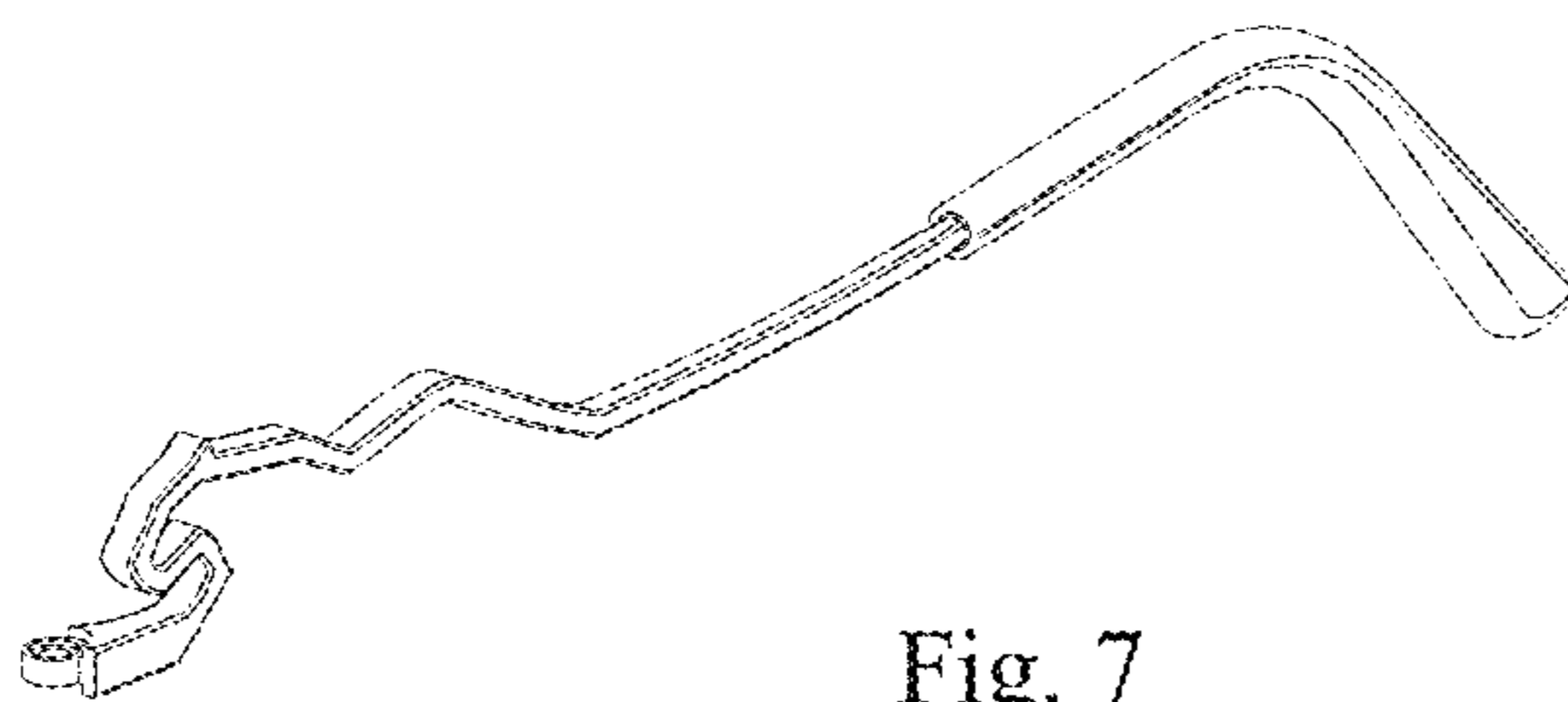
