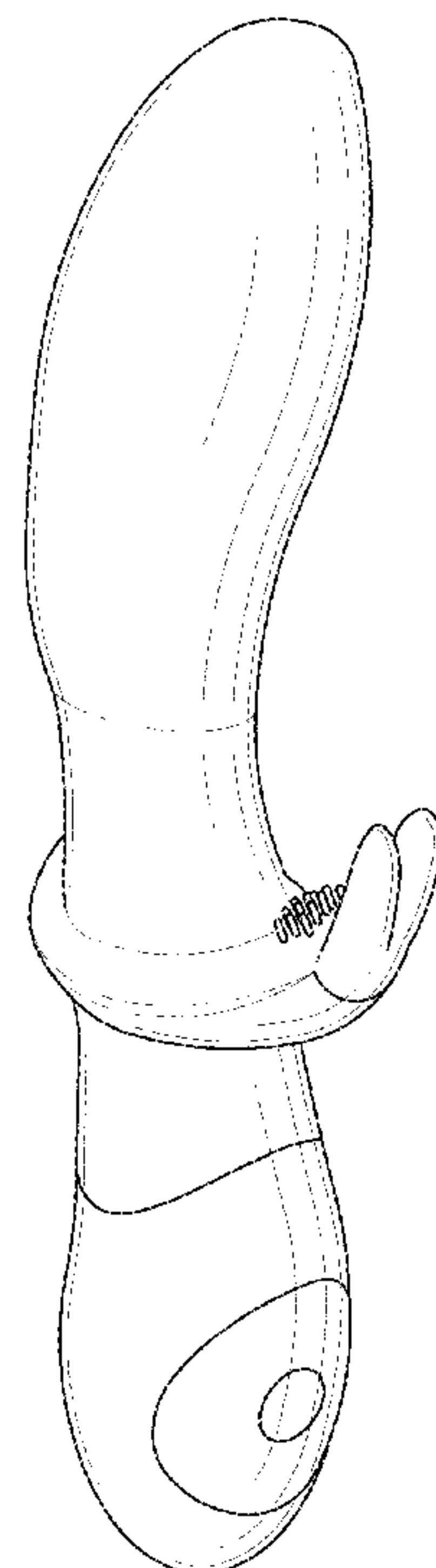

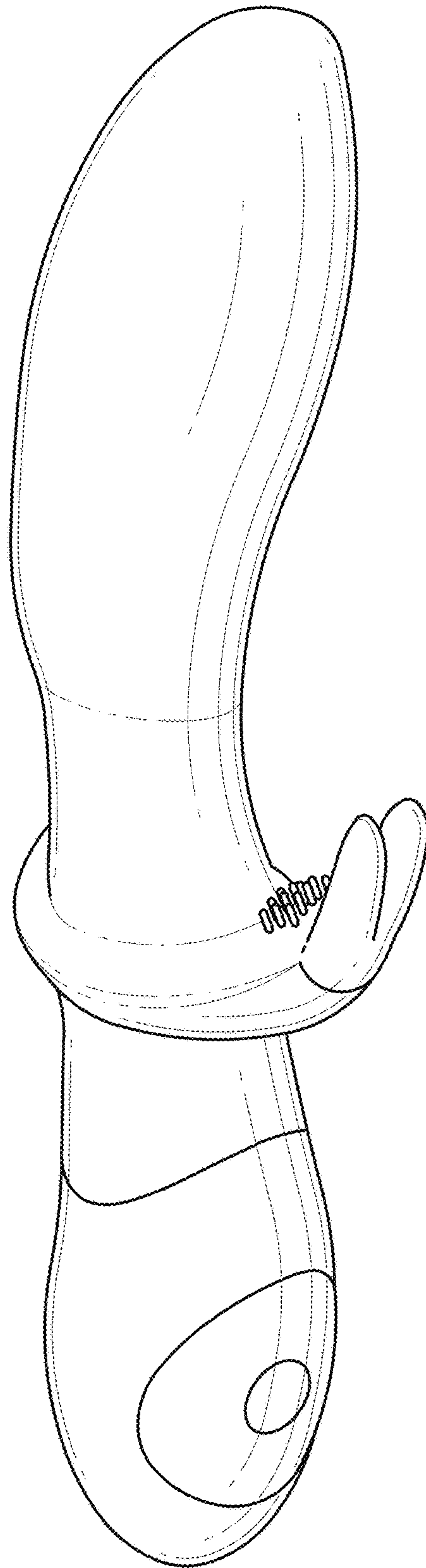
The ornamental design for a vibrator, as shown and described.

**DESCRIPTION**

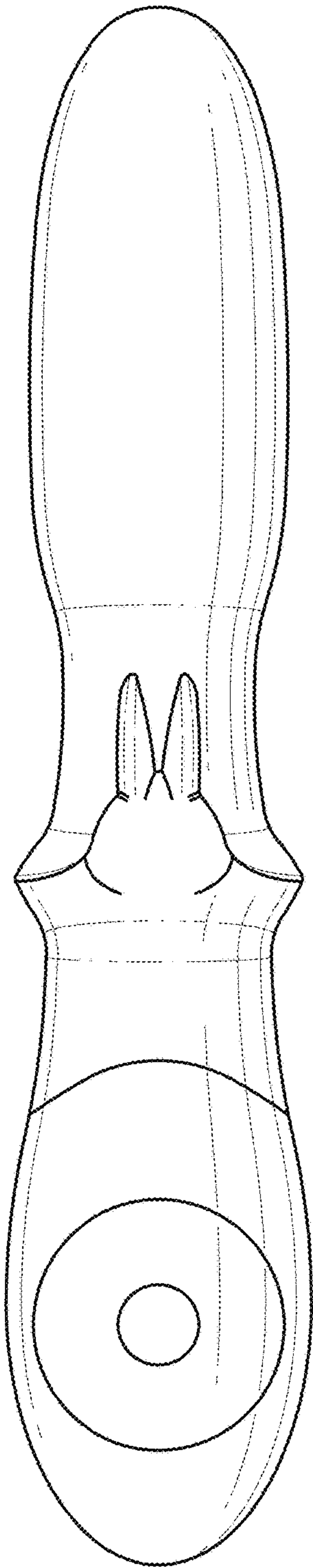
FIG. 1 is a perspective view of a vibrator with the ornamental design;

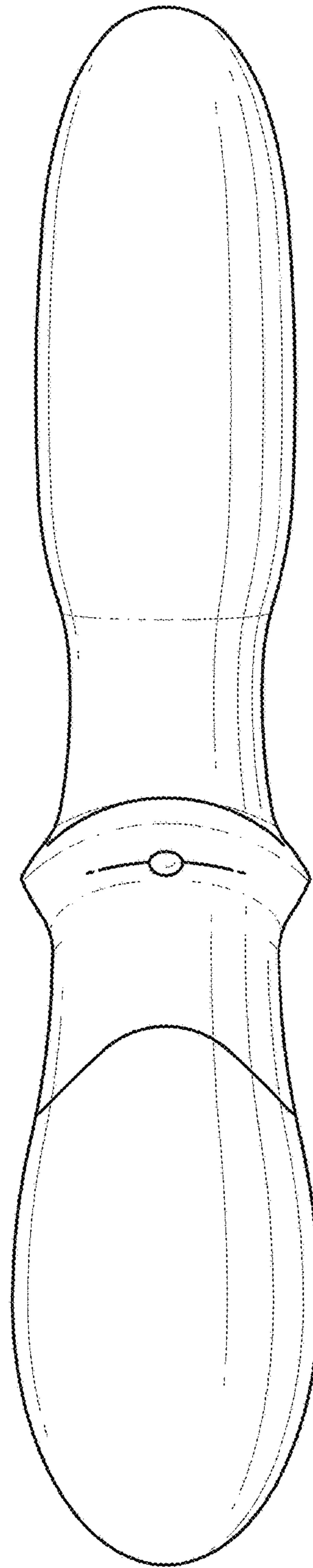




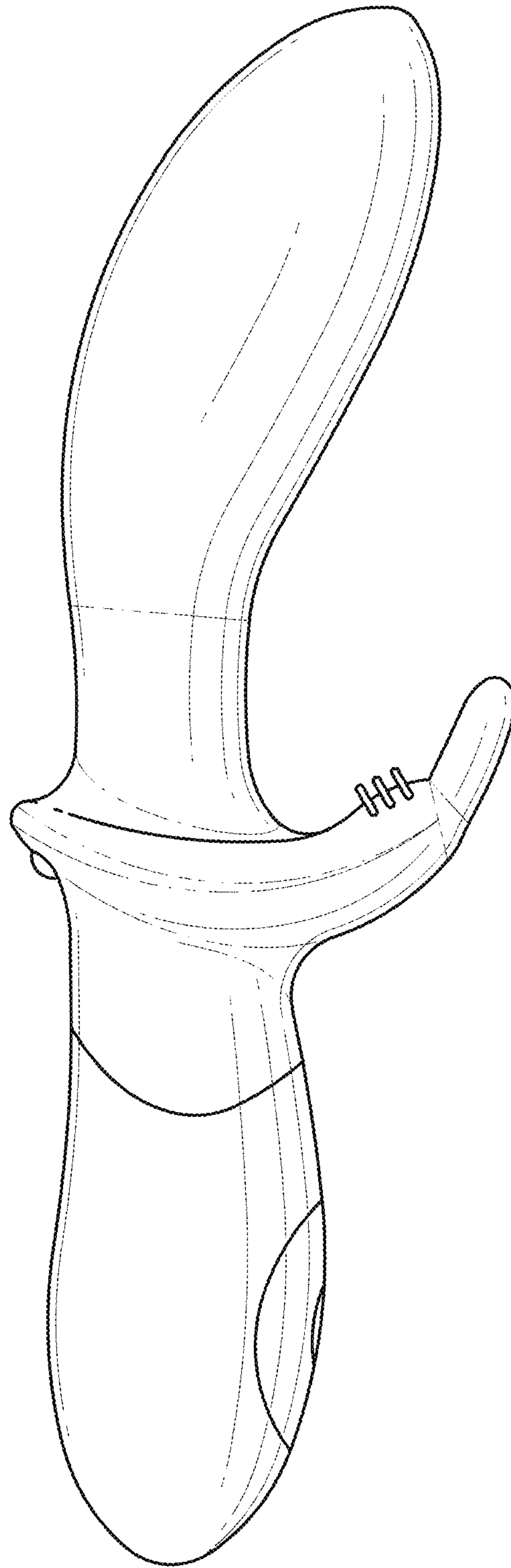

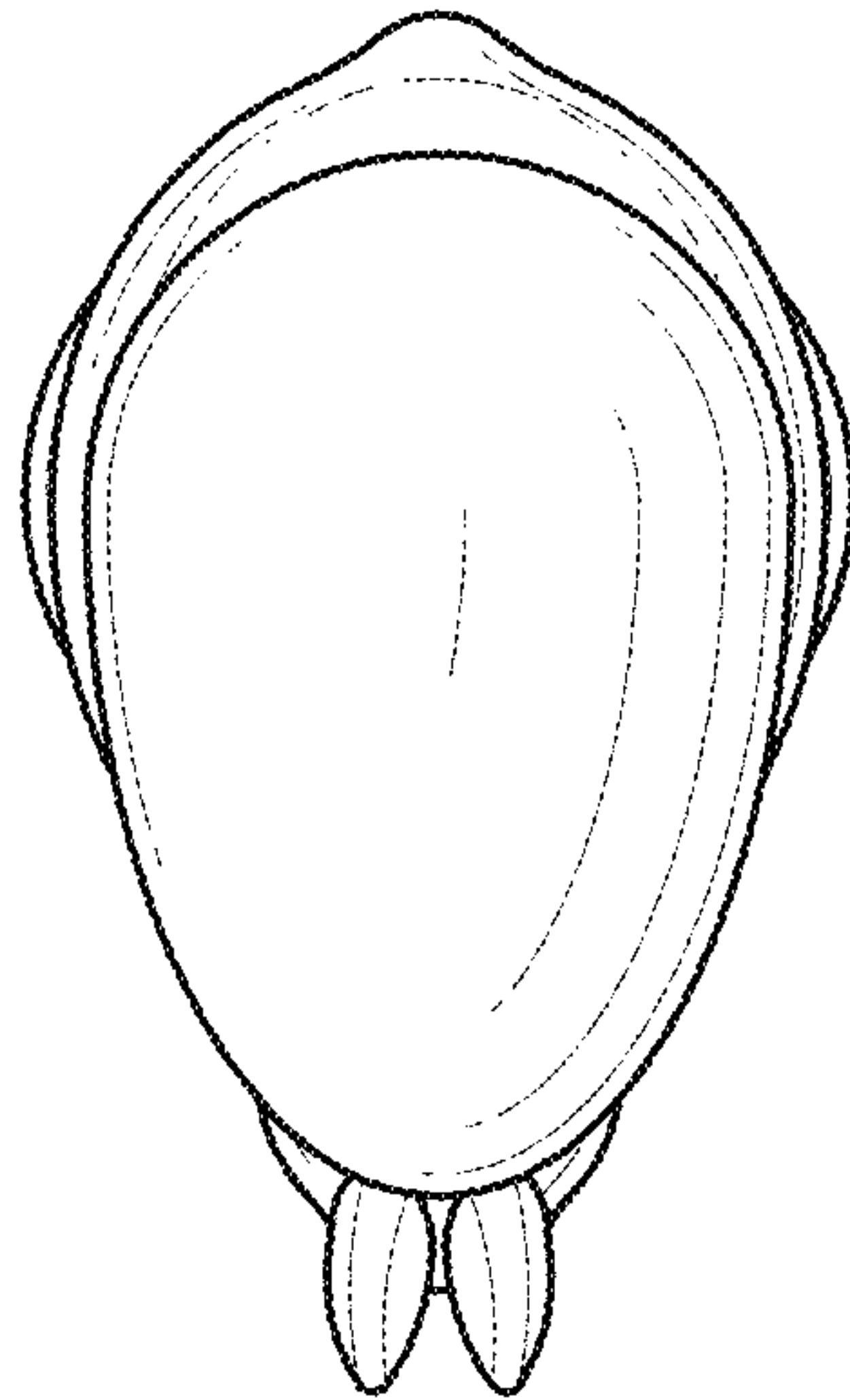

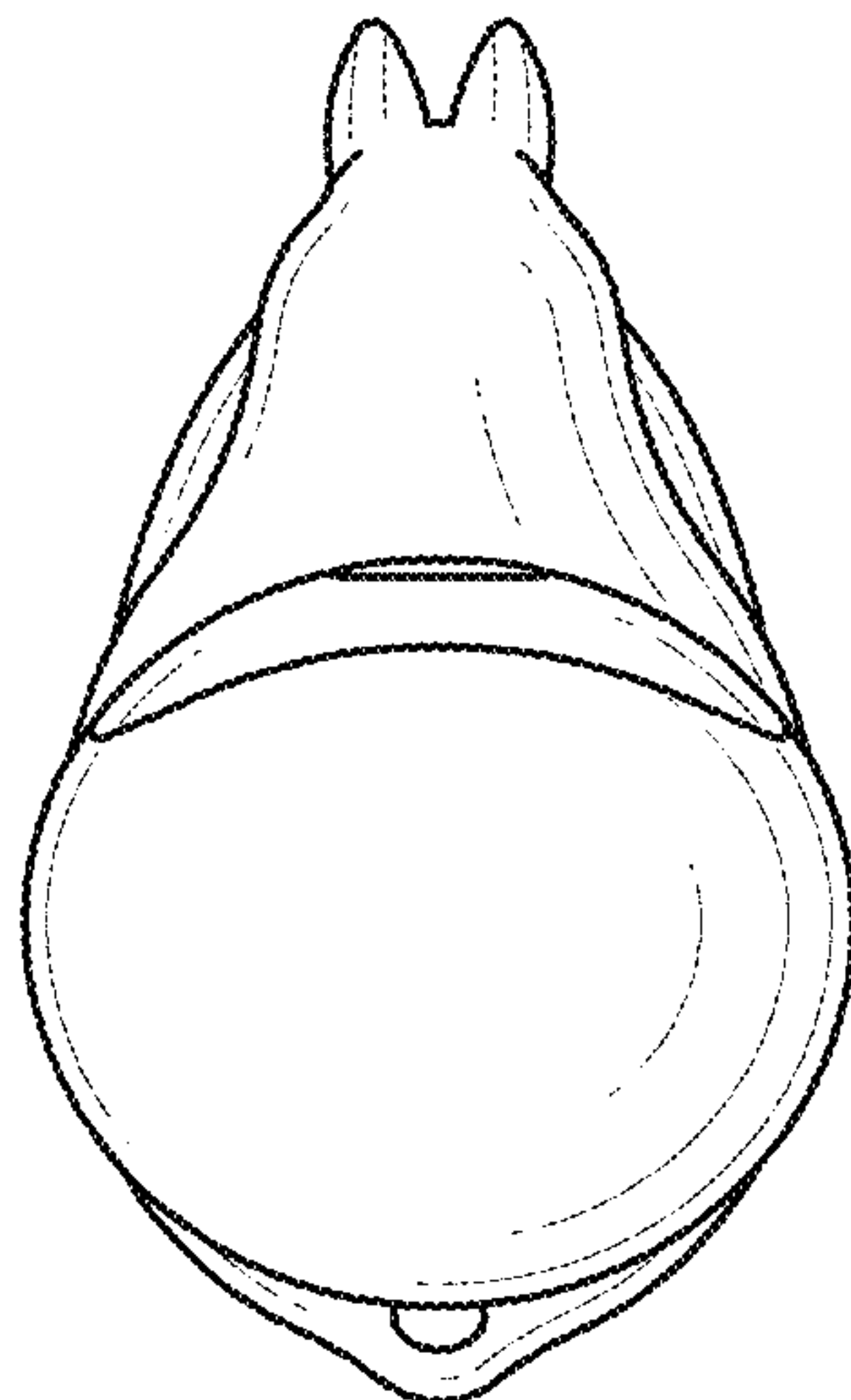
