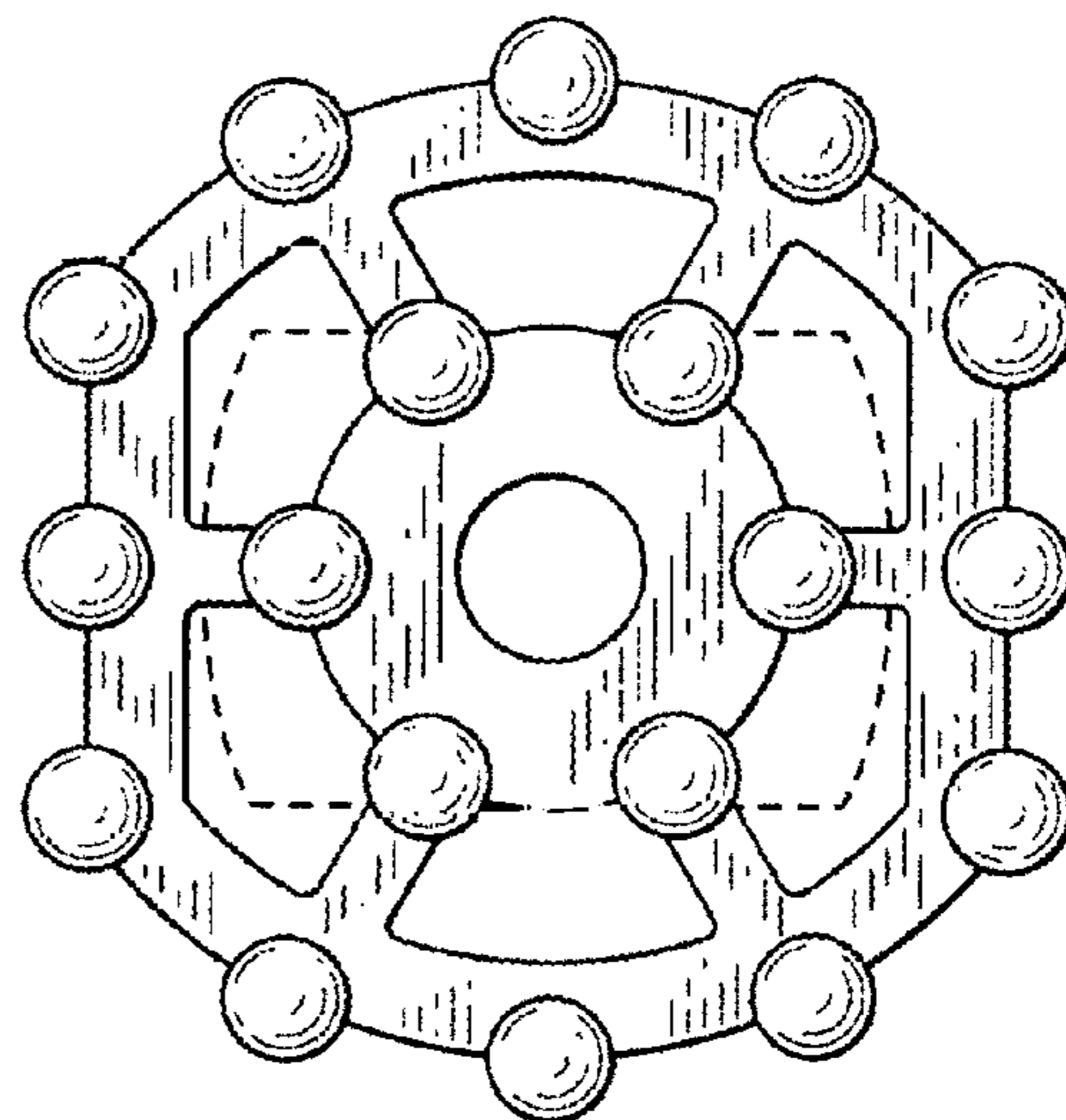
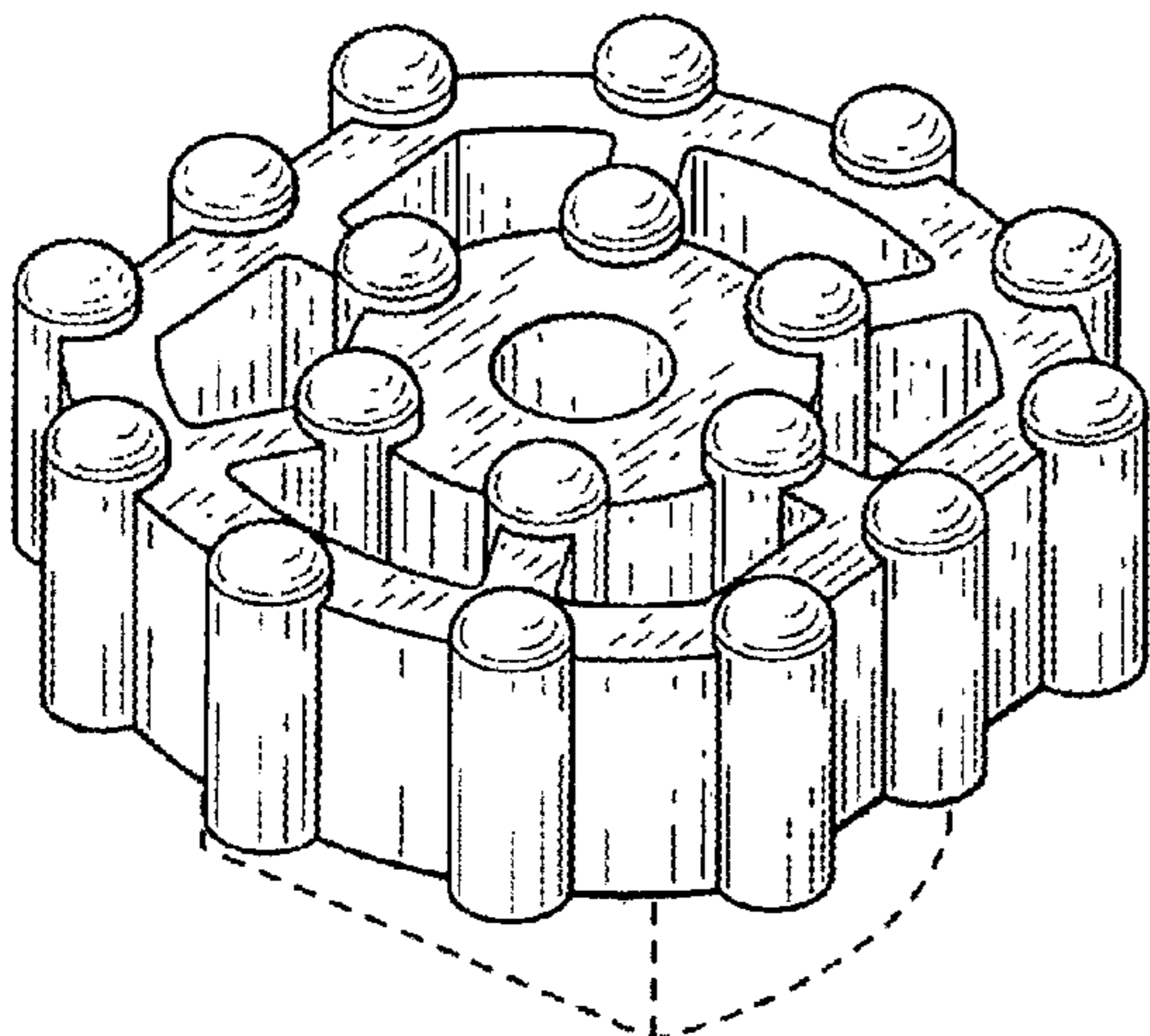
(57) **CLAIM**

We claim the ornamental design for a vibration dampening member for an acoustic mount, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right perspective view of a vibration dampening member embodying our design;  
FIG. 2 is a top plan view of the vibration dampening member of FIG. 1;  
FIG. 3 is a right side elevation view of the vibration dampening member of FIG. 1, the left side elevation view being identical thereof;  
FIG. 4 is a front elevation view of the vibration dampening member of FIG. 1, the rear elevation view being identical thereof; and,  
FIG. 5 is a bottom plan view of the vibration dampening member of FIG. 1.

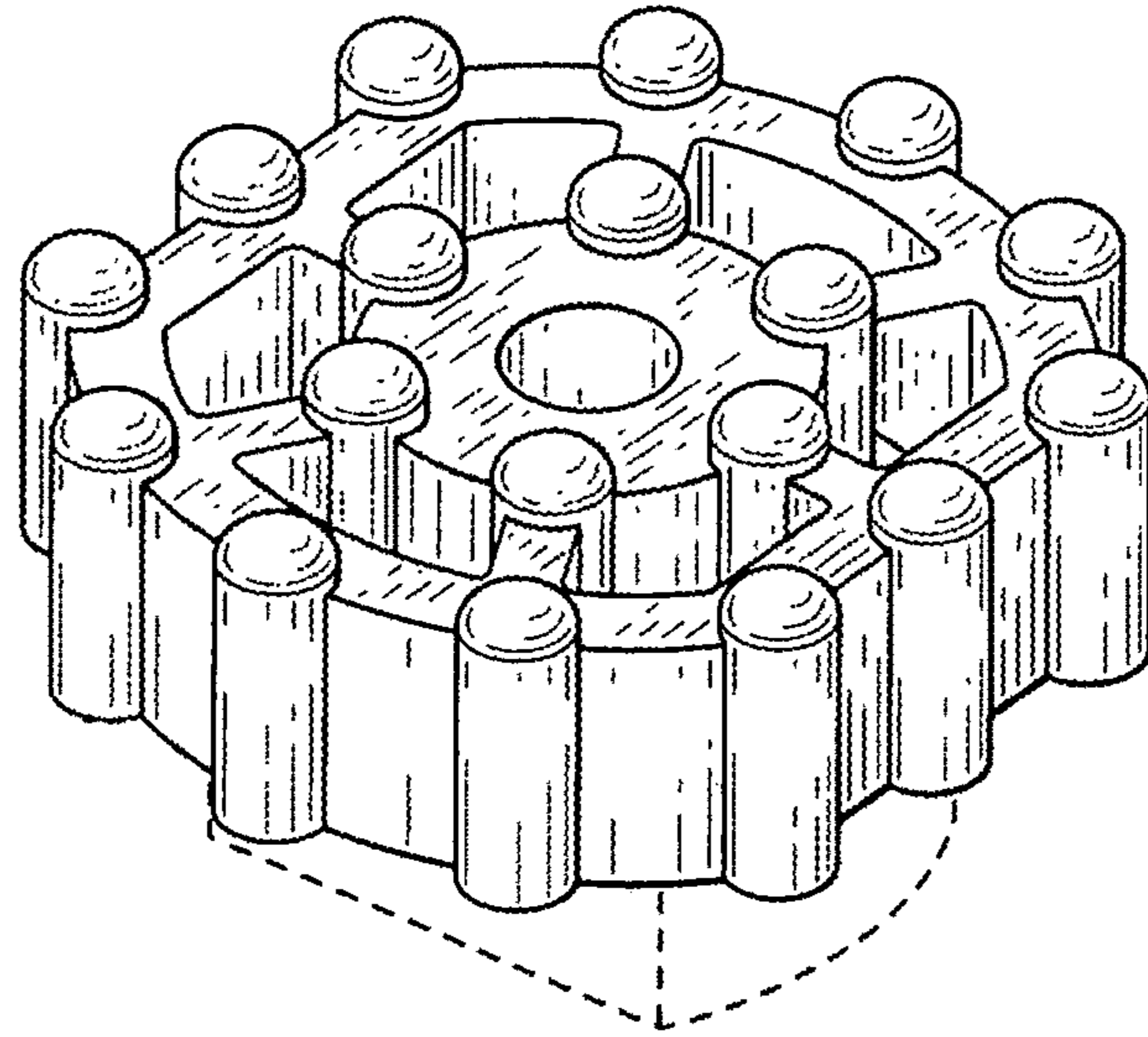

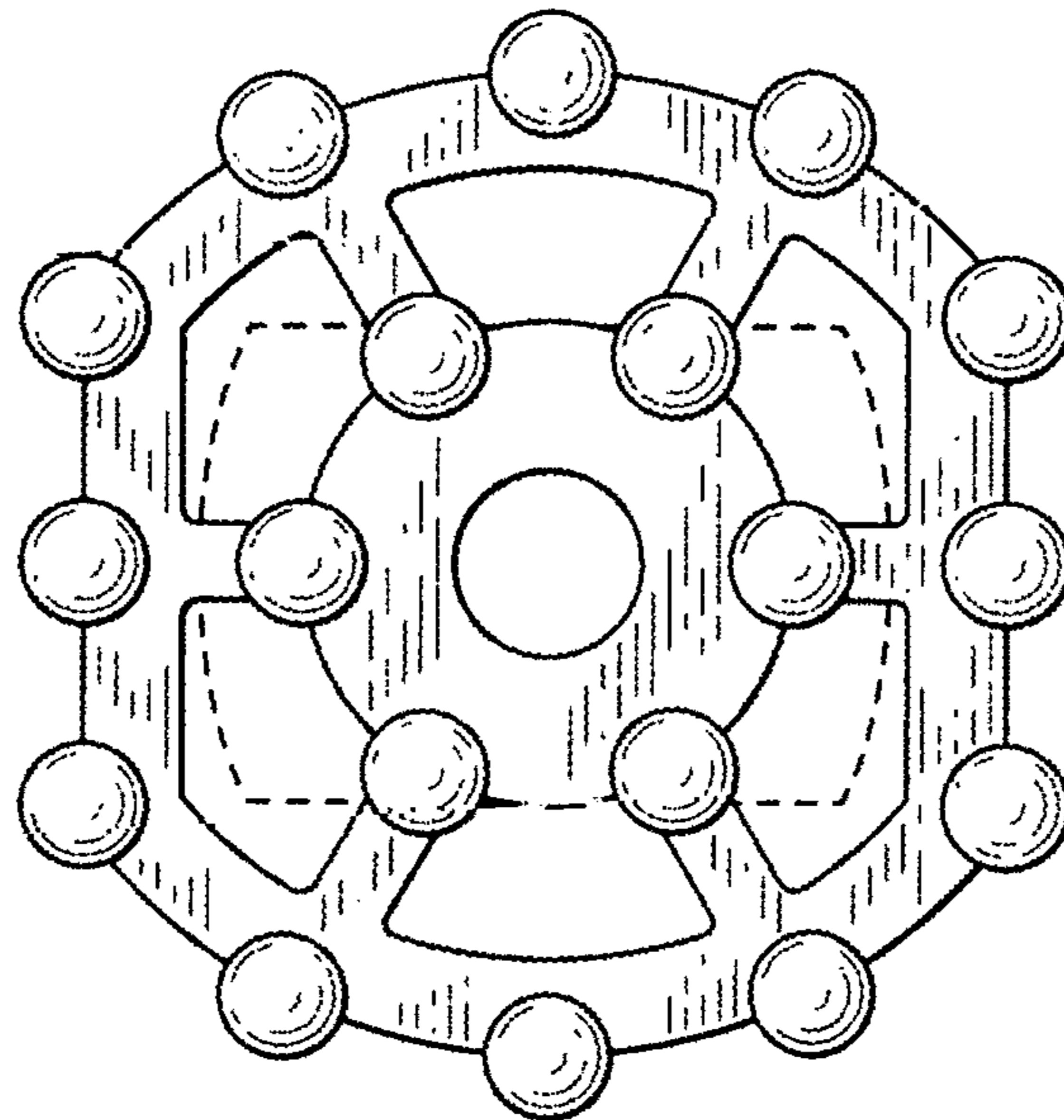

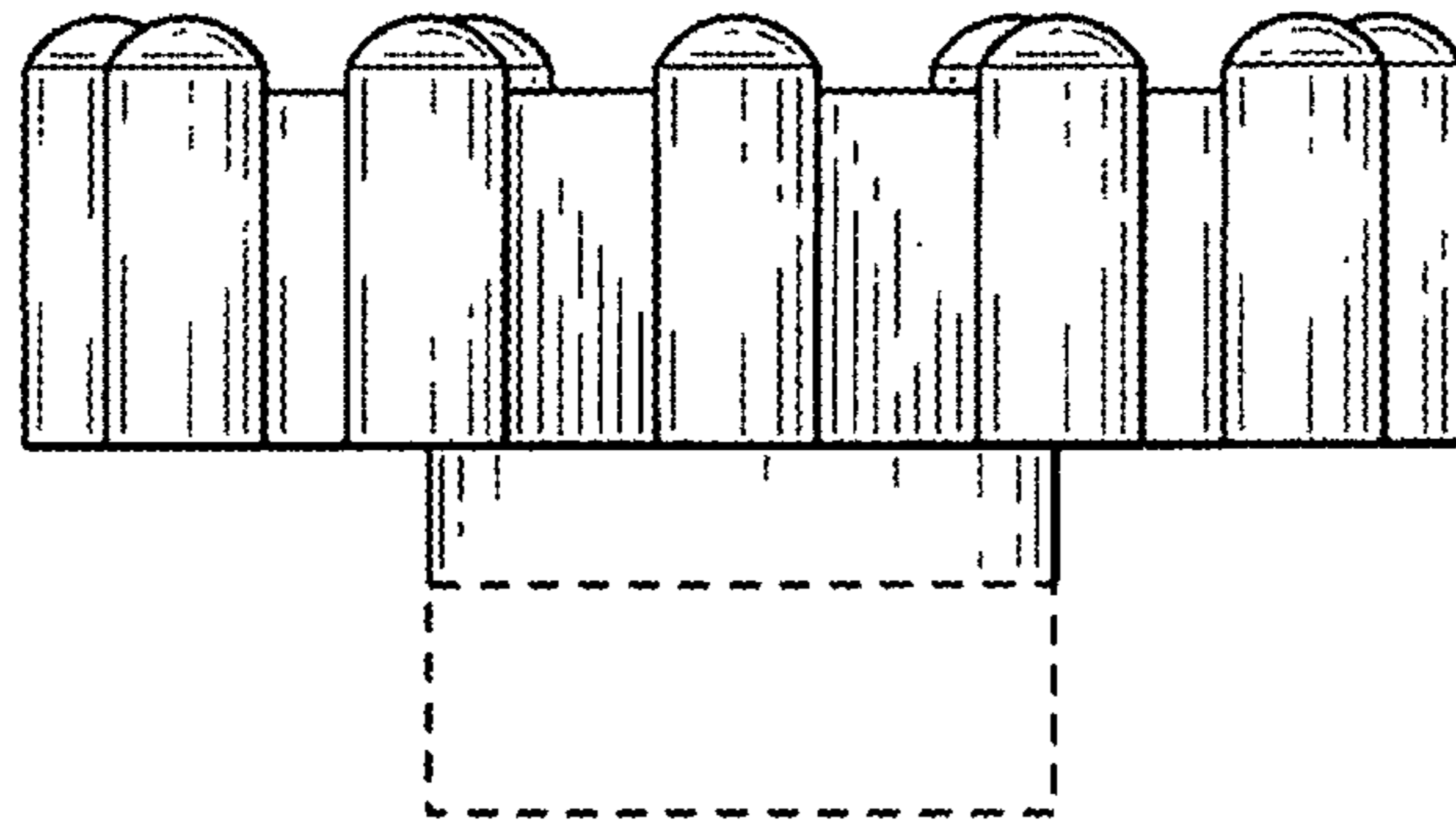

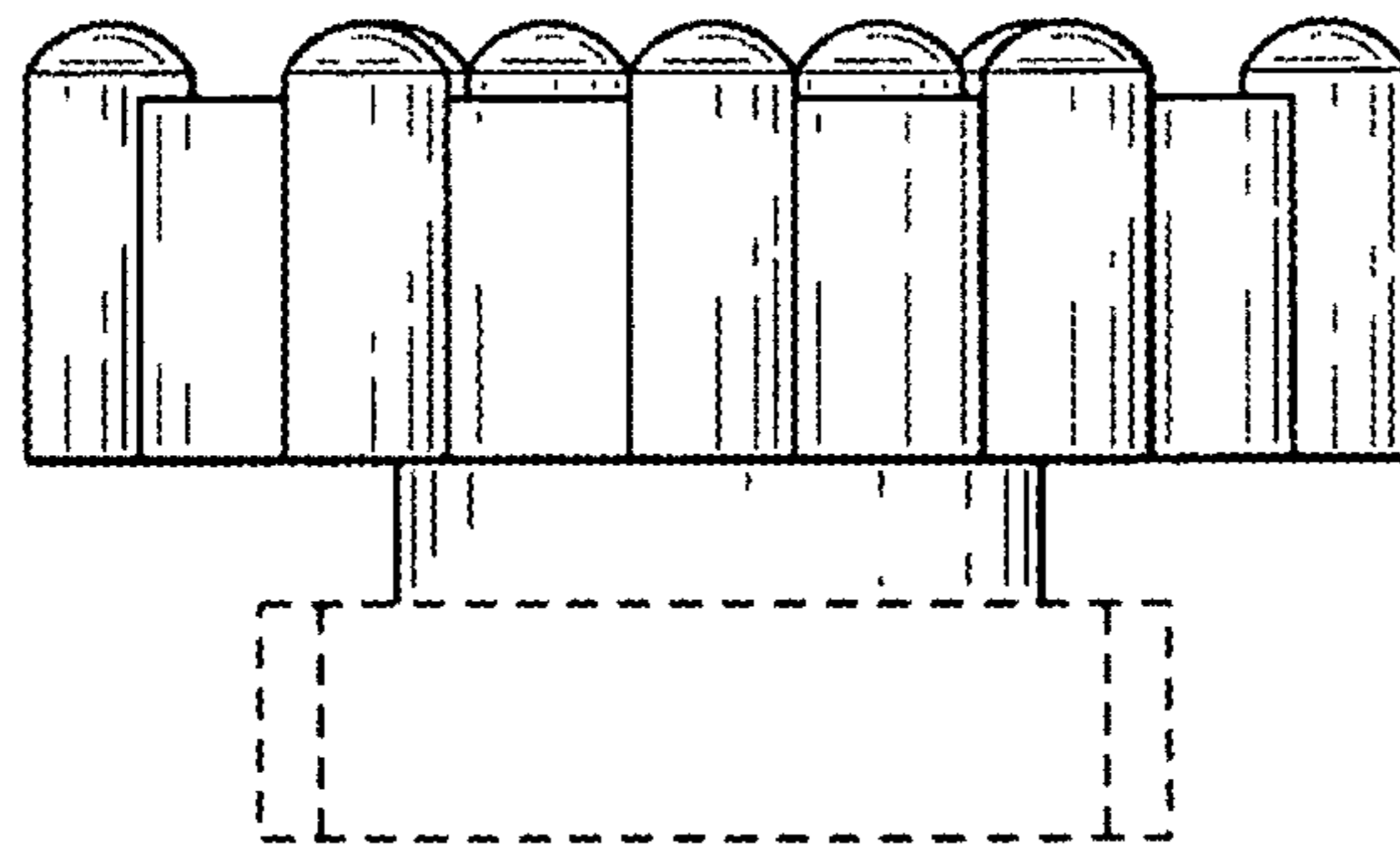

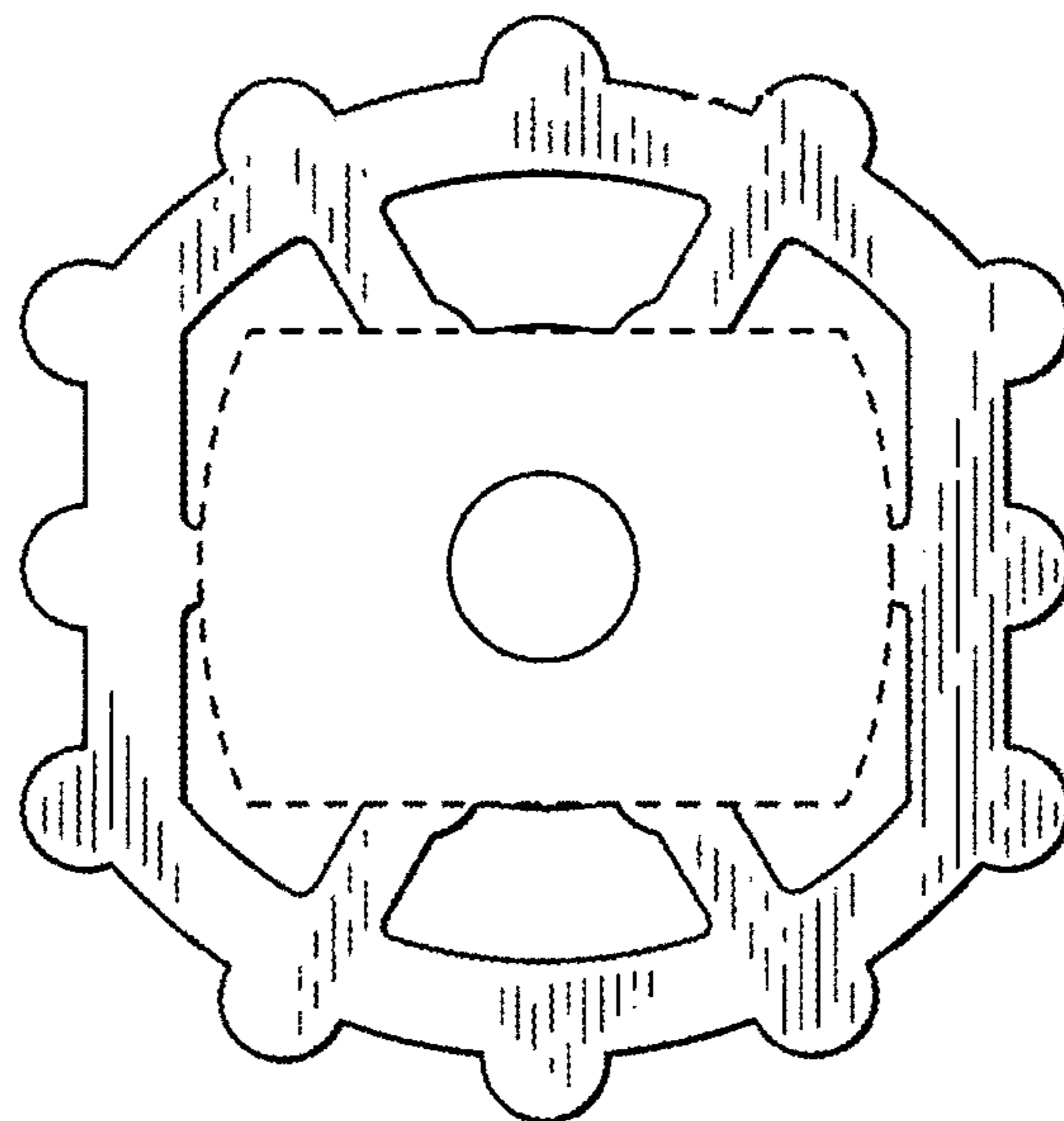
