

DESCRIPTION

1. Rear combination lamp for vehicles
- 1.1 is a top, front, and right side perspective view of a rear combination lamp for vehicles showing our new design;
- 1.2 is a front elevation view thereof;
- 1.3 is a rear elevation view thereof;
- 1.4 is a left side elevation view thereof;










