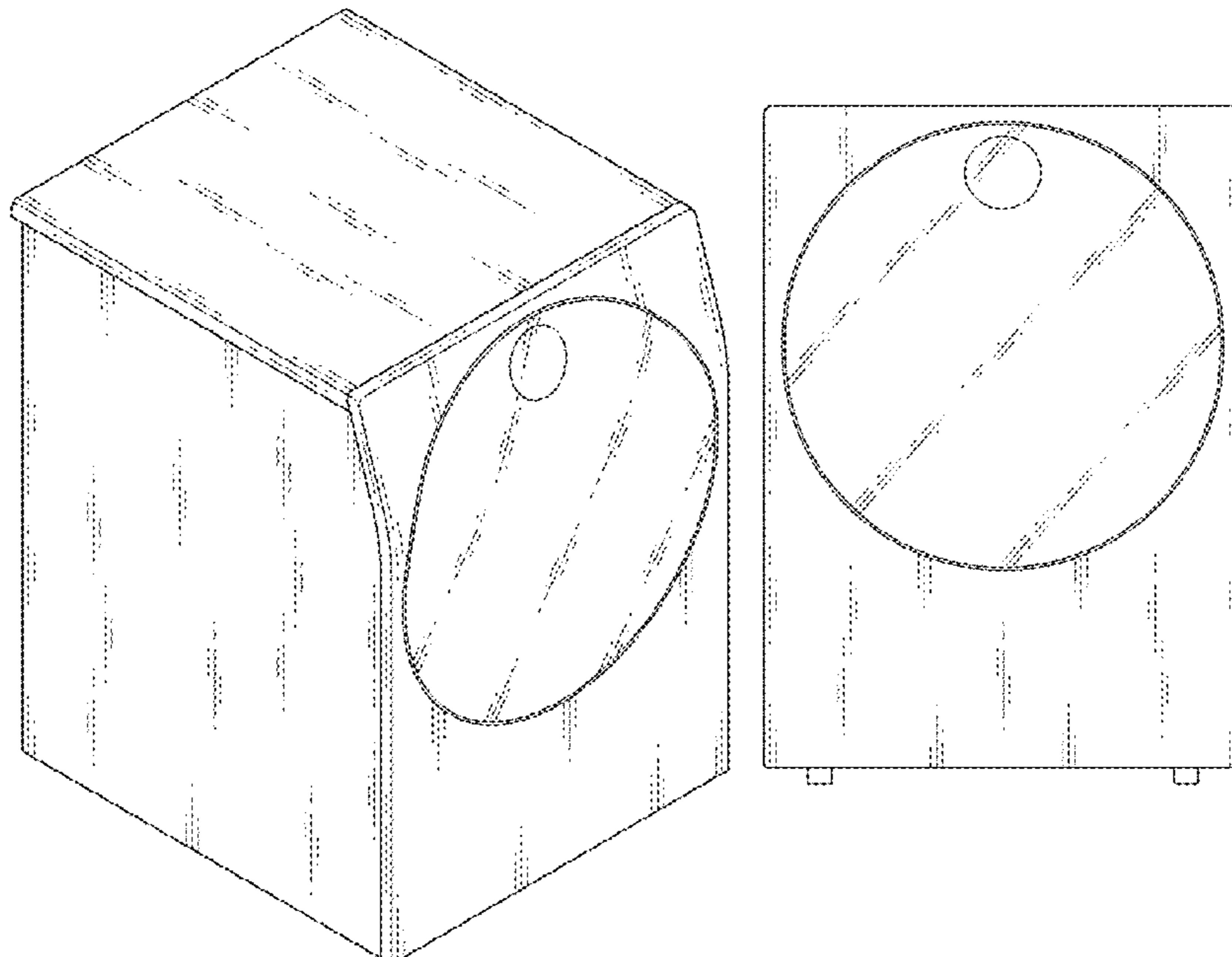

The ornamental design for a washing machine, as shown and described.

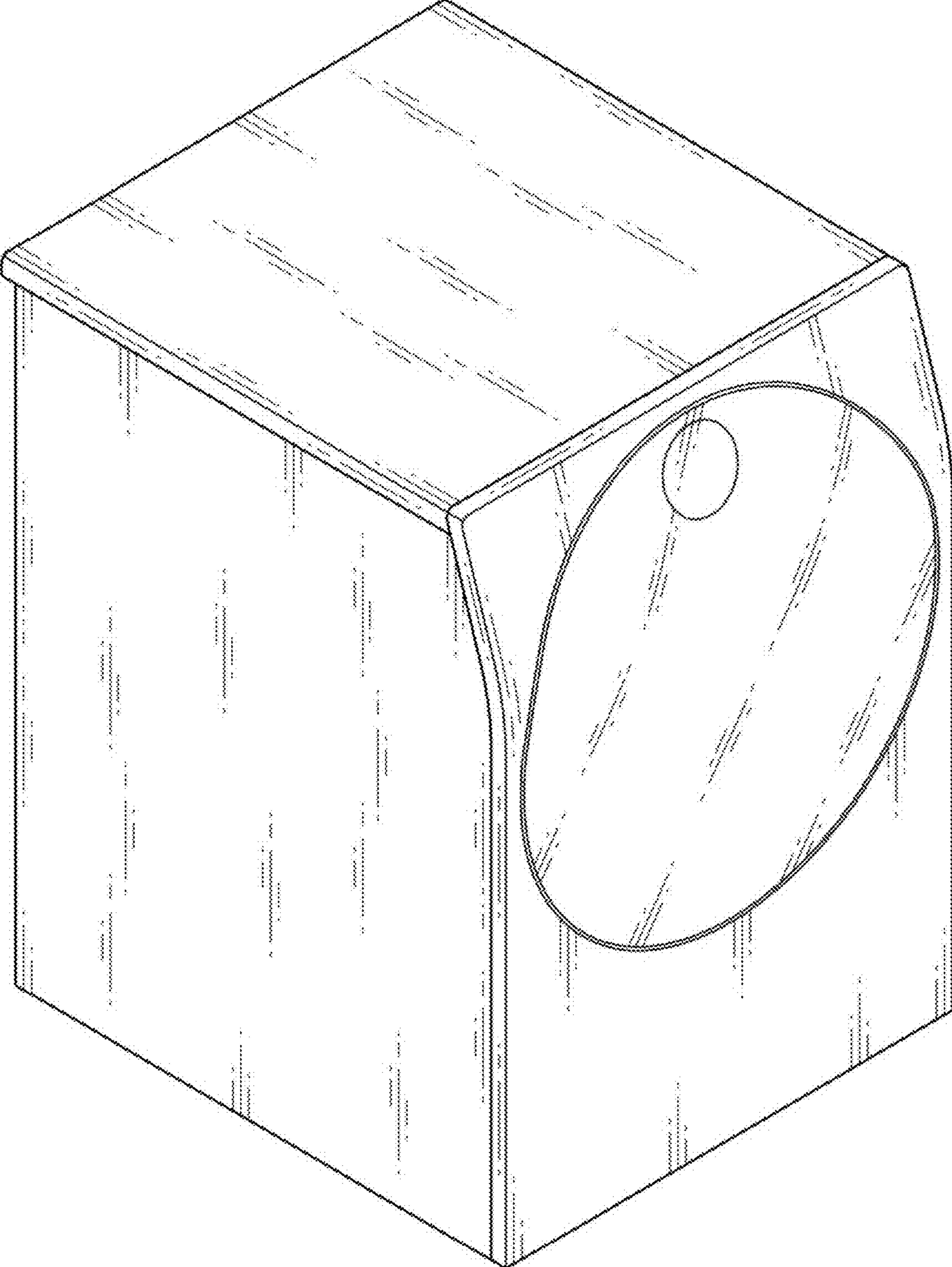
DESCRIPTION

- 1.7 is a Bottom Plan View.

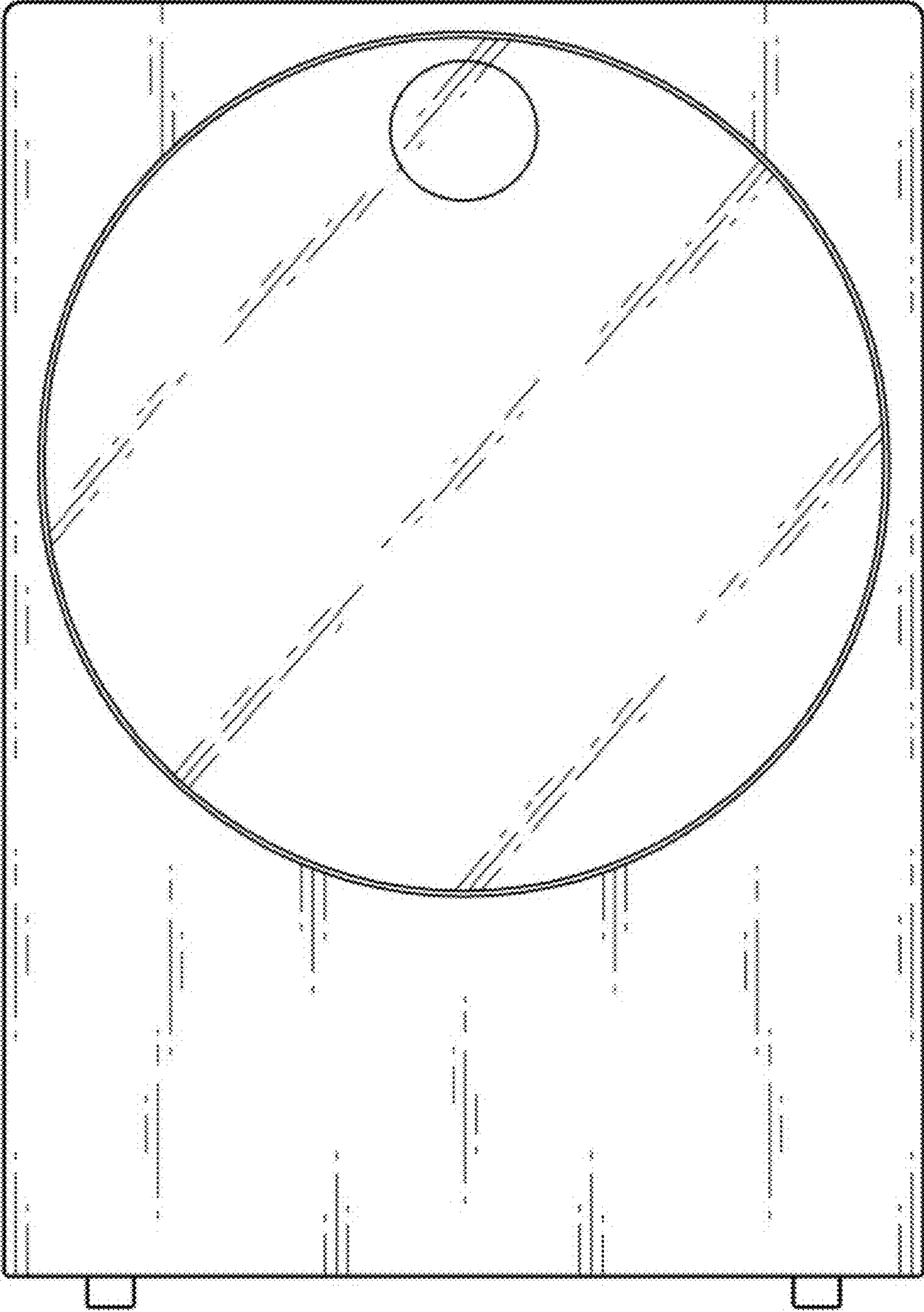

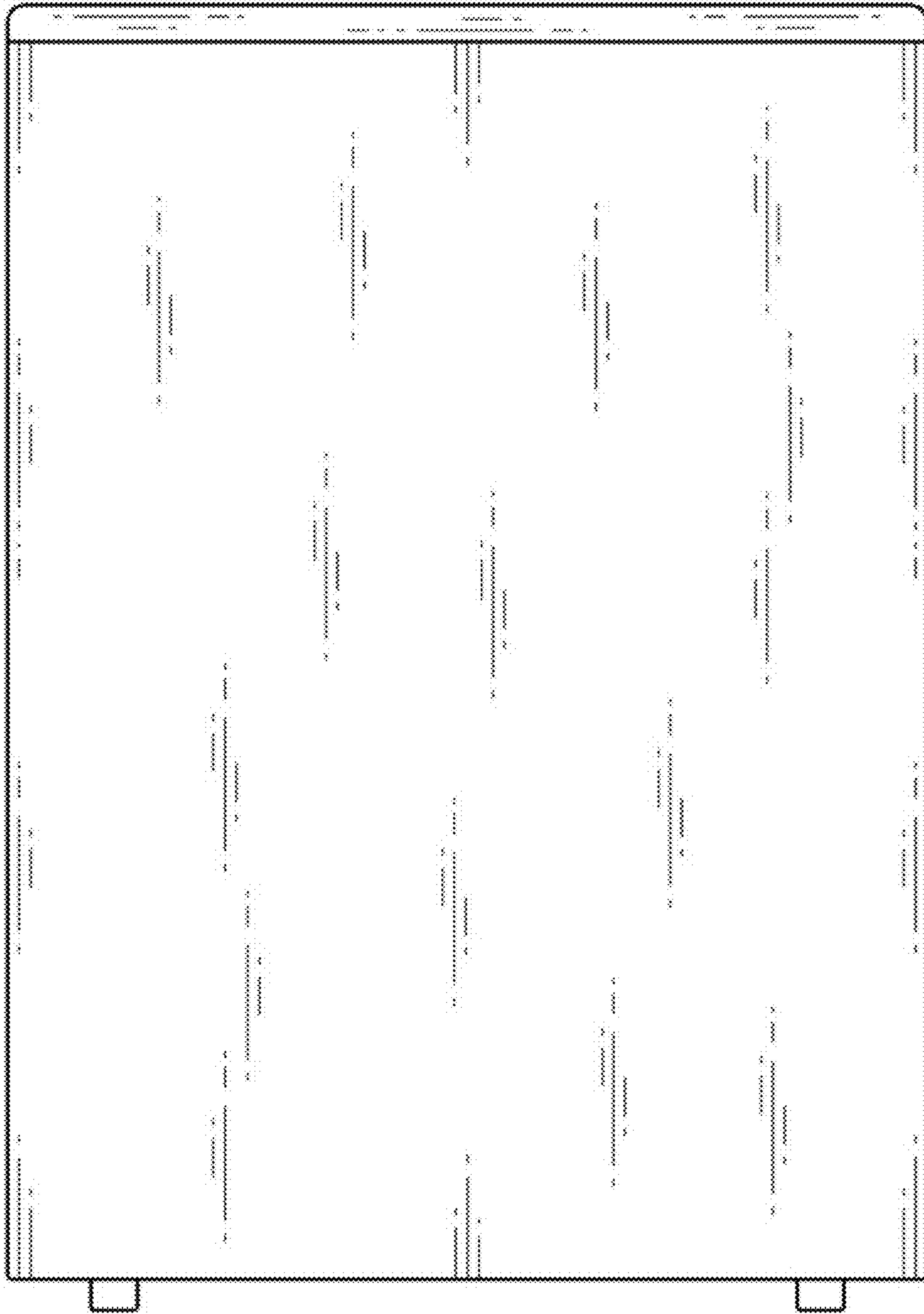

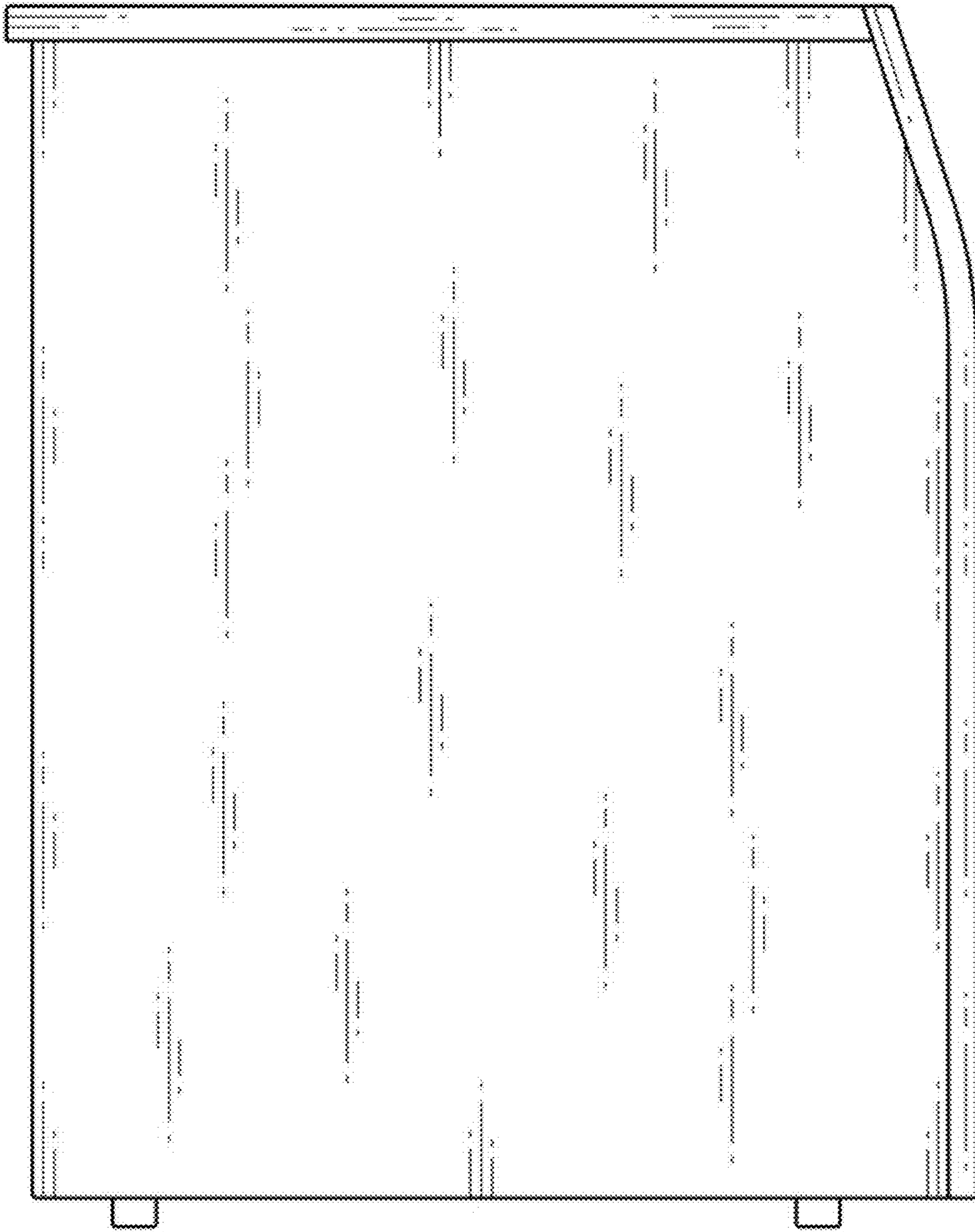

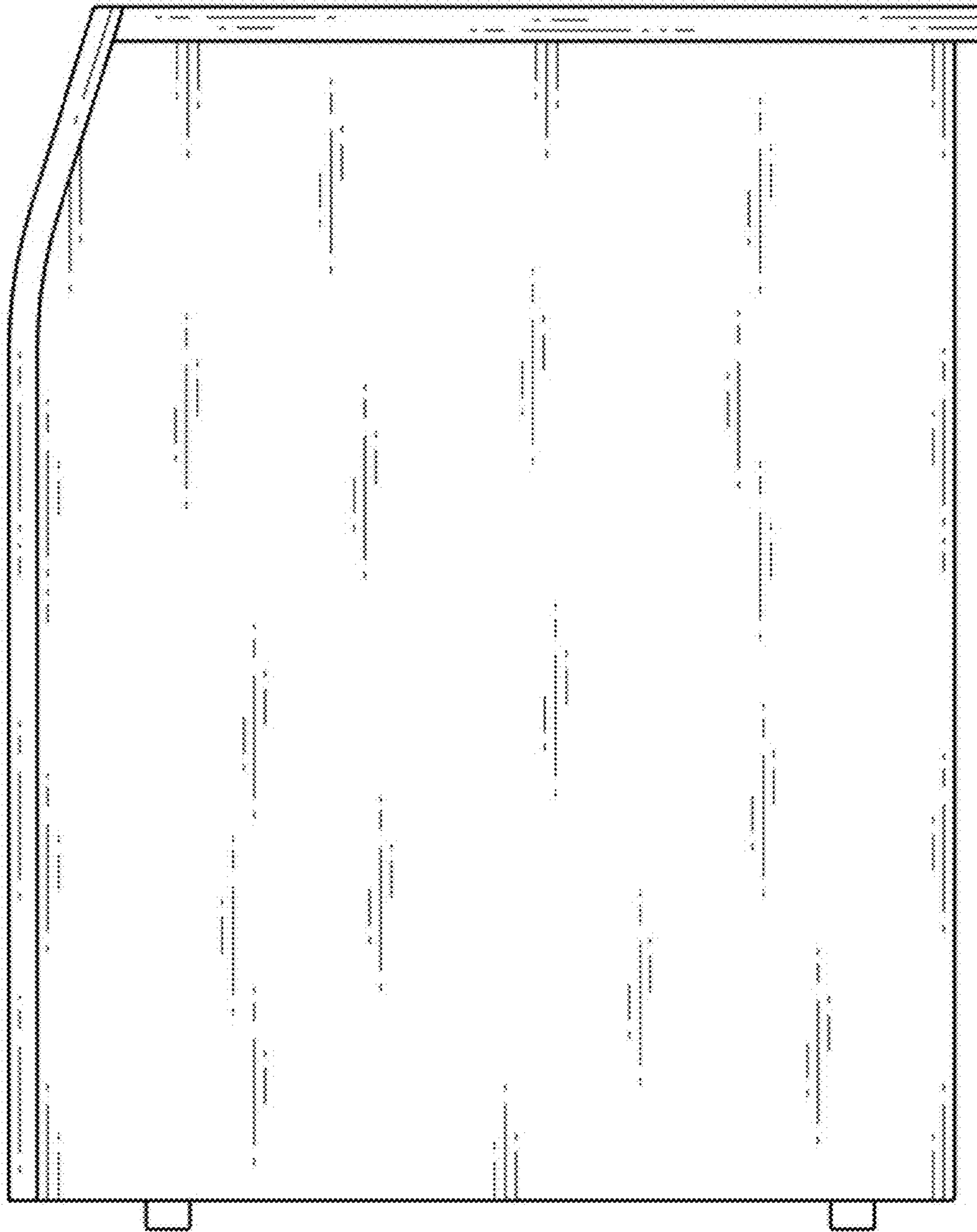

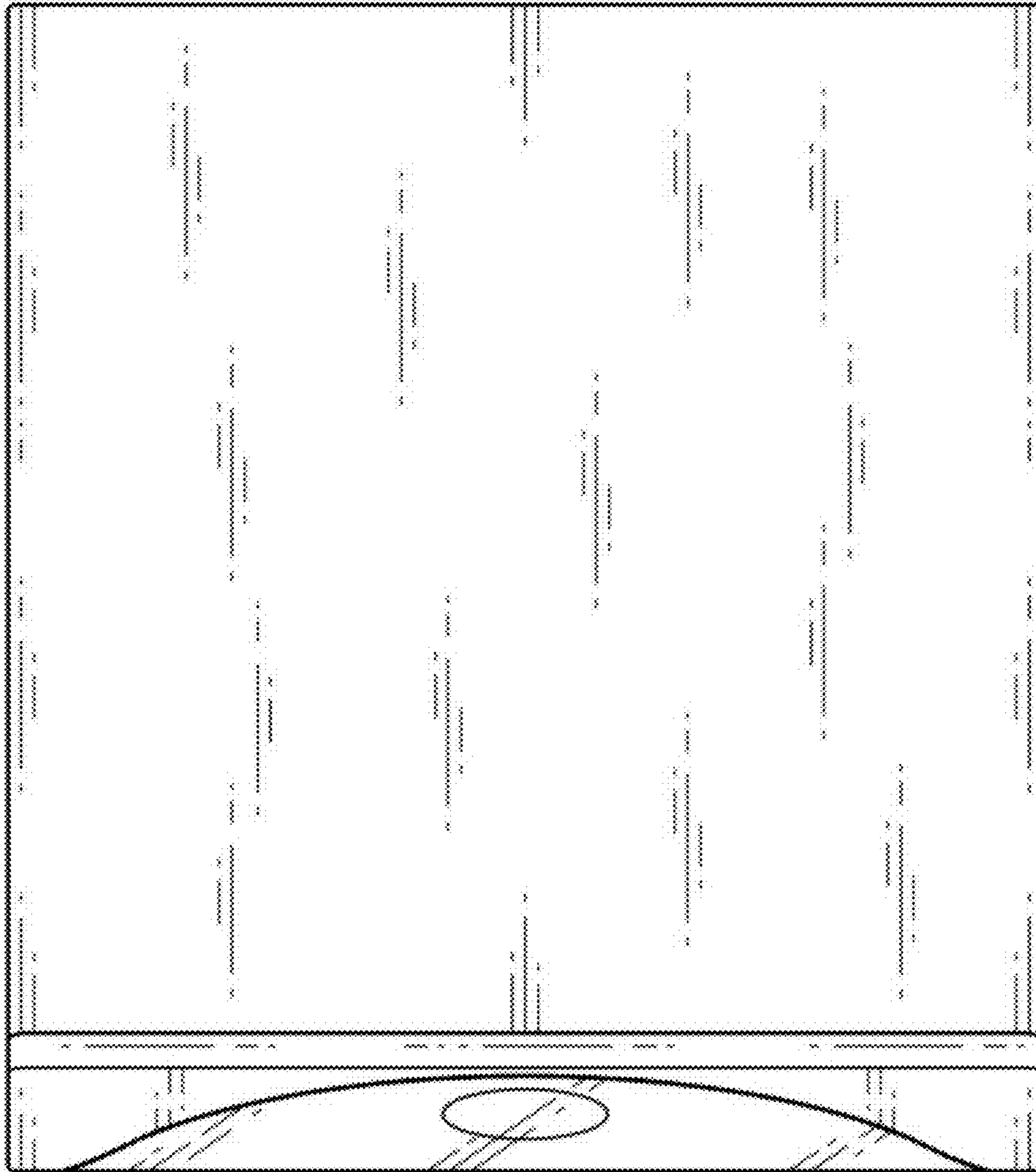
