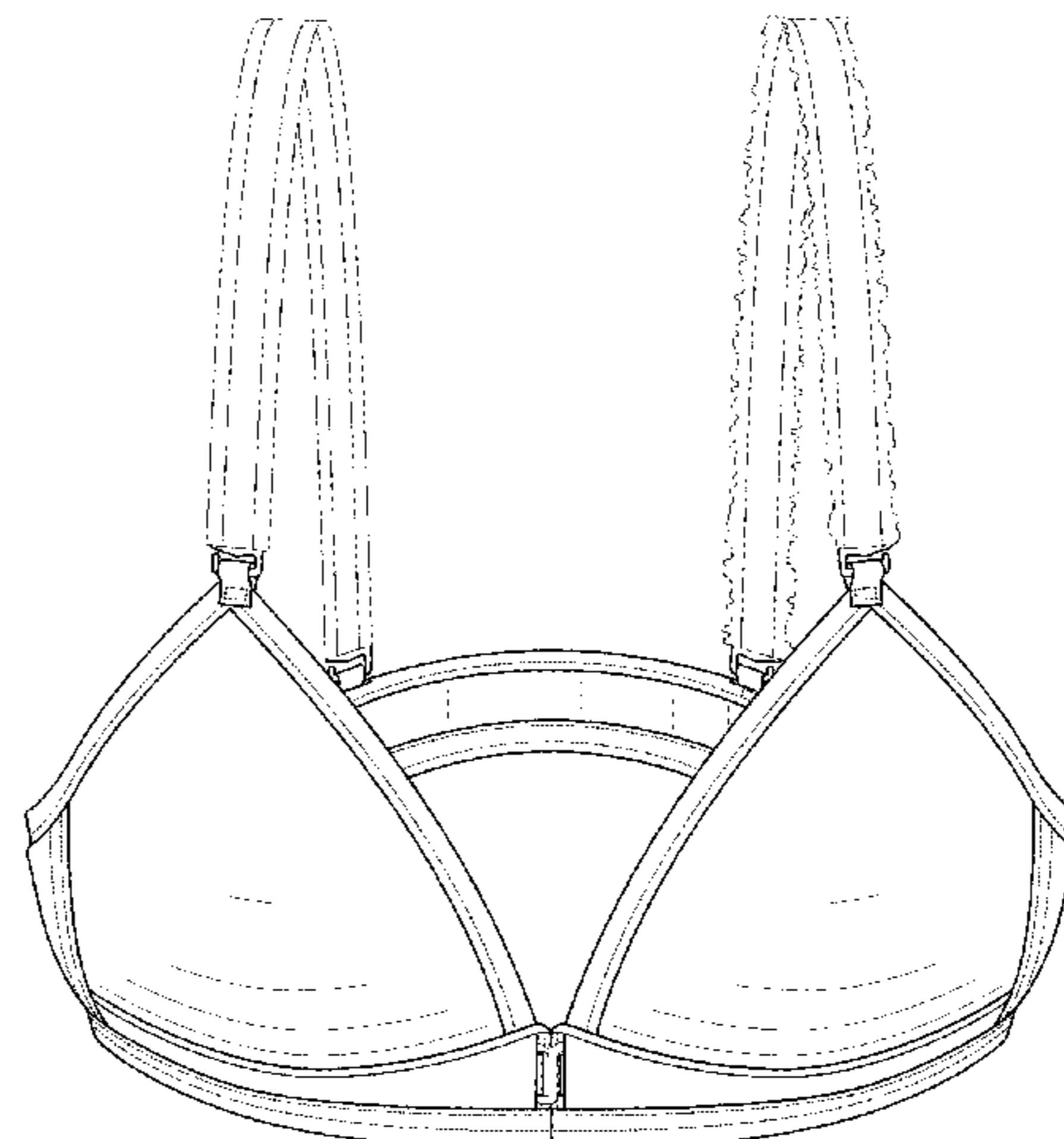
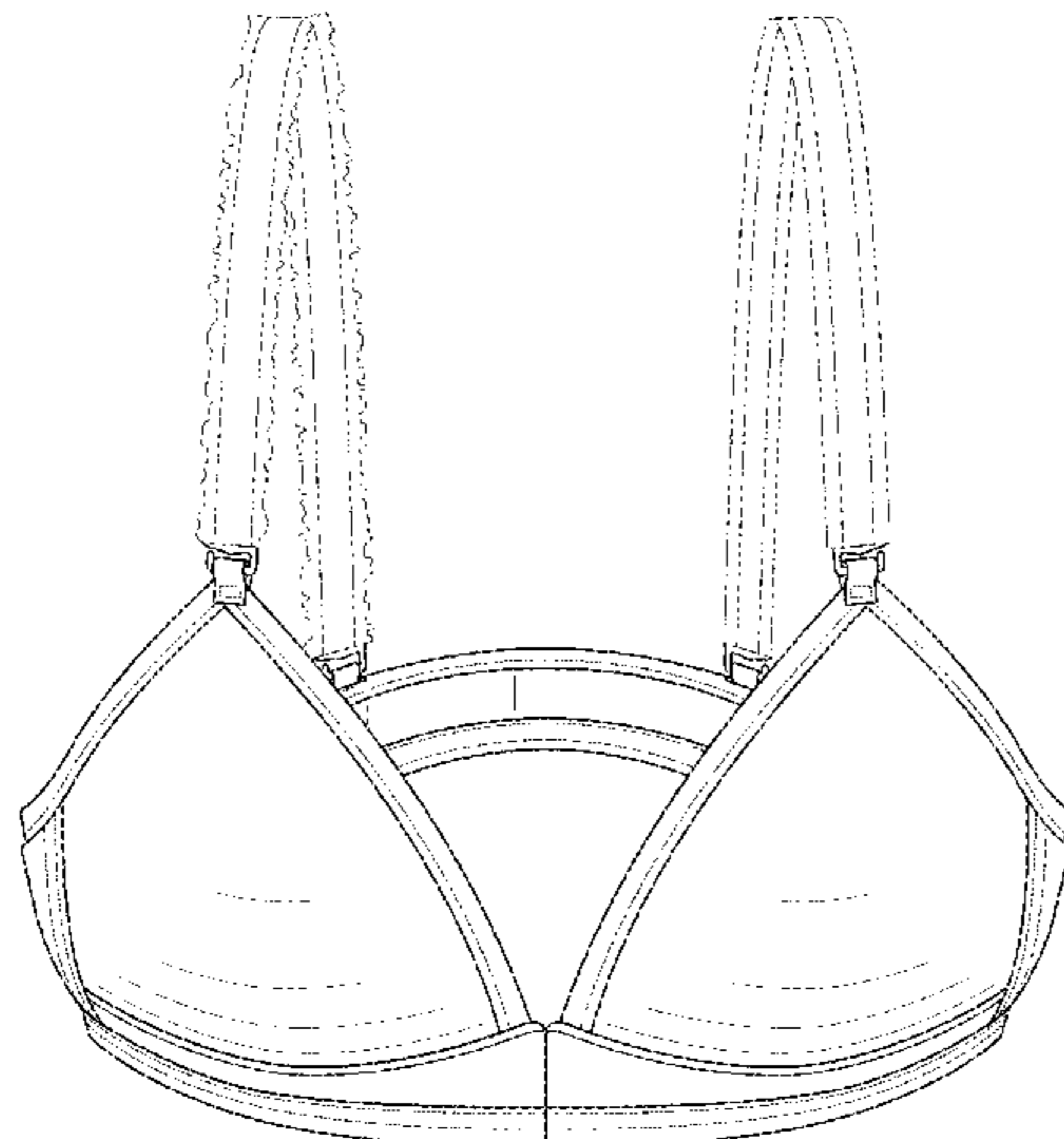
An ornamental design for an undergarment for a girl, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of an undergarment for a girl, shown in a position of use, according to a first embodiment of the present disclosure;  
 FIG. 2 is a front perspective view of the undergarment for a girl of FIG. 1;  
 FIG. 3 is a front elevational view of FIG. 2 shown in an open position;  
 FIG. 4 is a rear elevational view of FIG. 2 shown in an open position;  
 FIG. 5 is a left side elevational view of FIG. 4;  
 FIG. 6 is a right side elevational view of FIG. 4;  
 FIG. 7 is a top plan view of FIG. 3;  
 FIG. 8 is a bottom plan view of FIG. 3;  
 FIG. 9 is a front view of an undergarment for a girl, shown in a position of use, according to a second embodiment of the present disclosure;  
 FIG. 10 is a front perspective view of the undergarment for a girl of FIG. 9;  
 FIG. 11 is a front elevational view of FIG. 10 shown in an open position;  
 FIG. 12 is a rear elevational view of FIG. 10 shown in an open position;  
 FIG. 13 is a left side elevational view of FIG. 12;  
 FIG. 14 is a right side elevational view of FIG. 12;  
 FIG. 15 is a top plan view of FIG. 11; and,  
 FIG. 16 is a bottom plan view of FIG. 11.

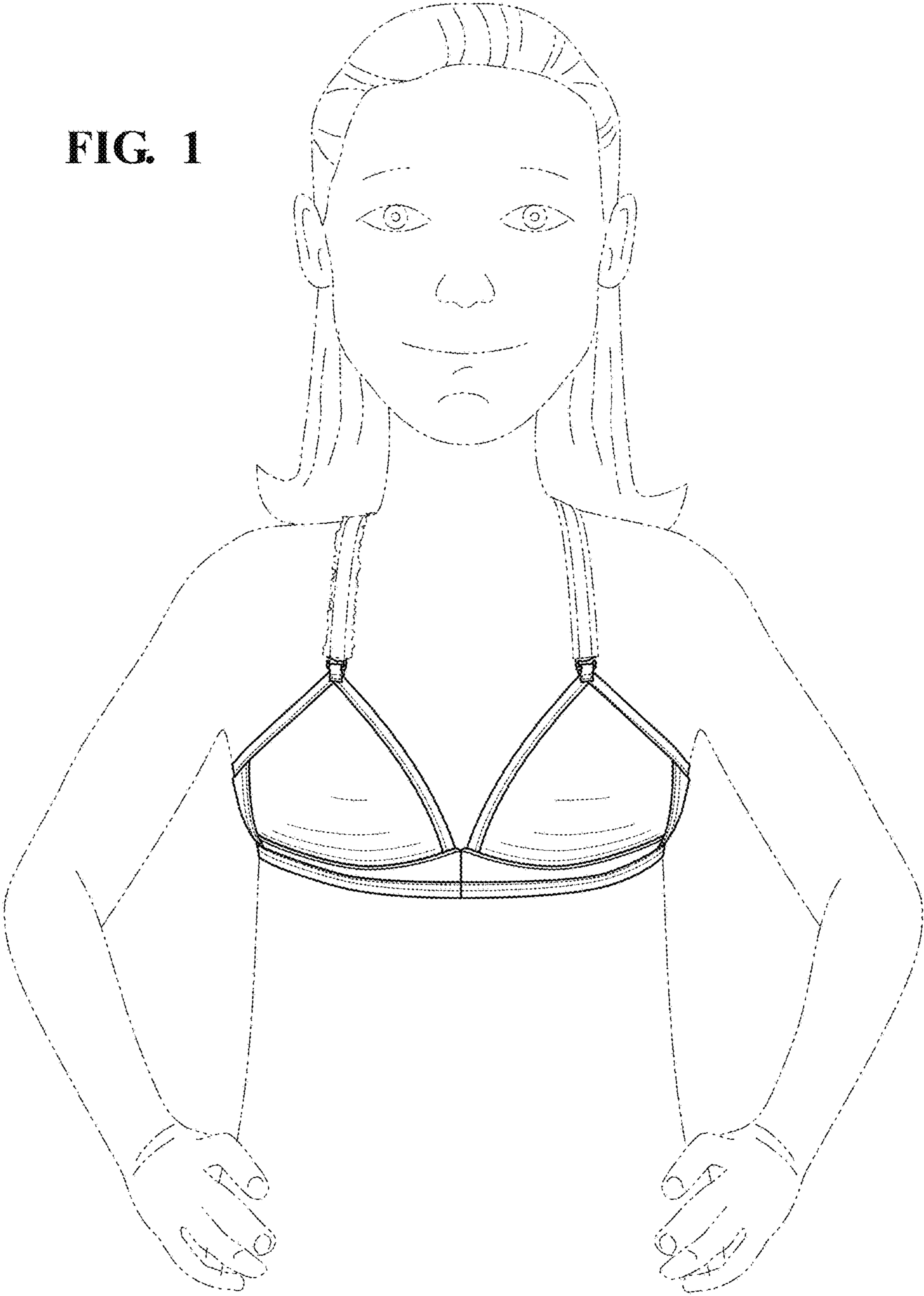

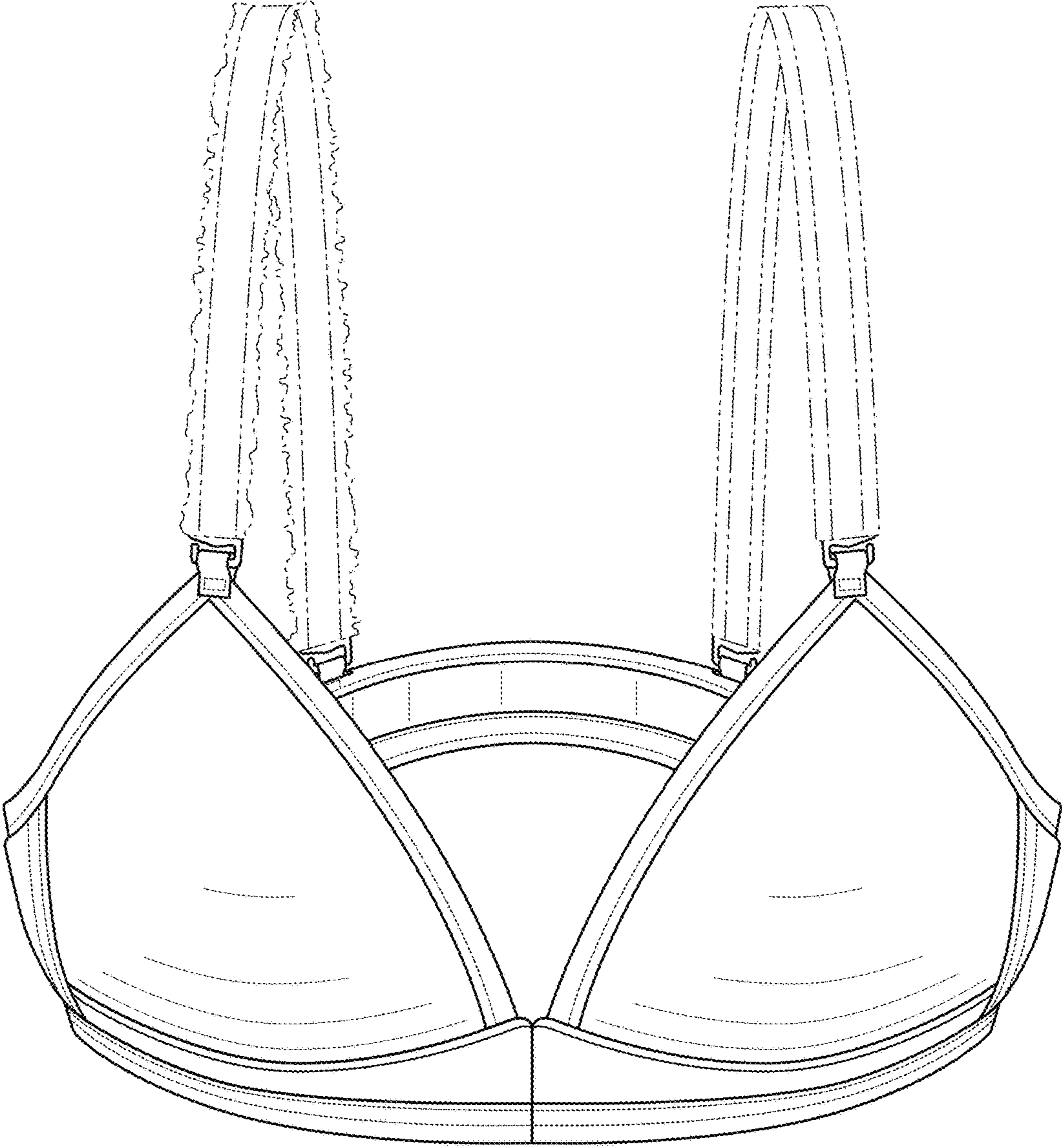

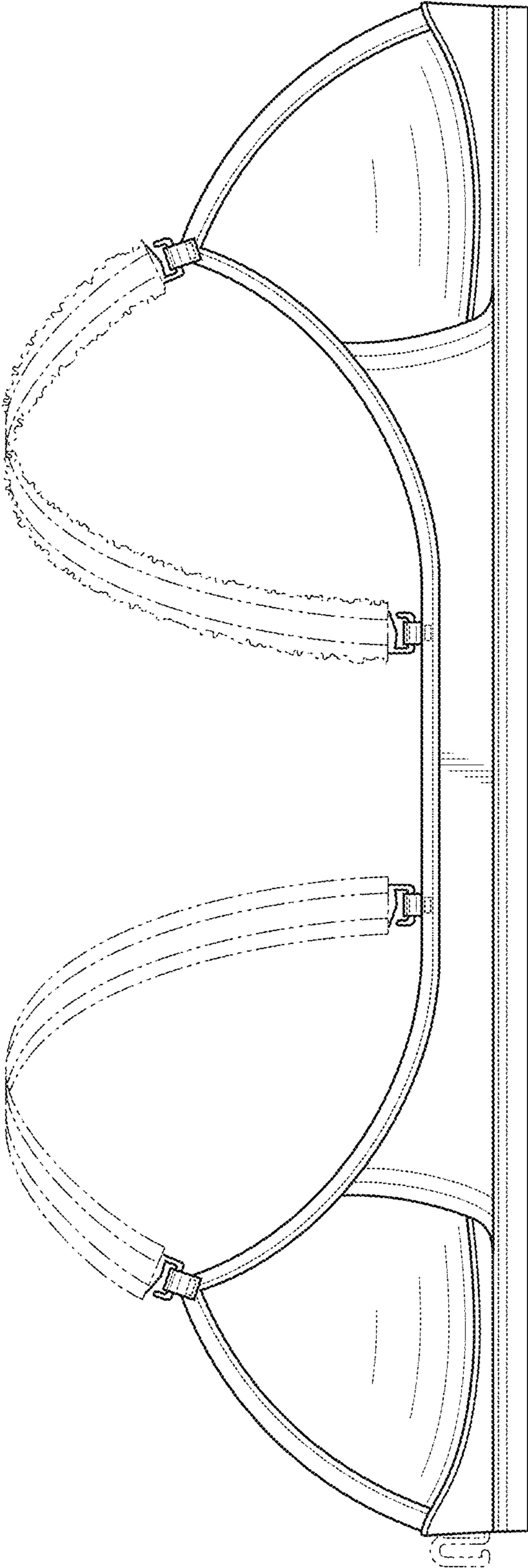

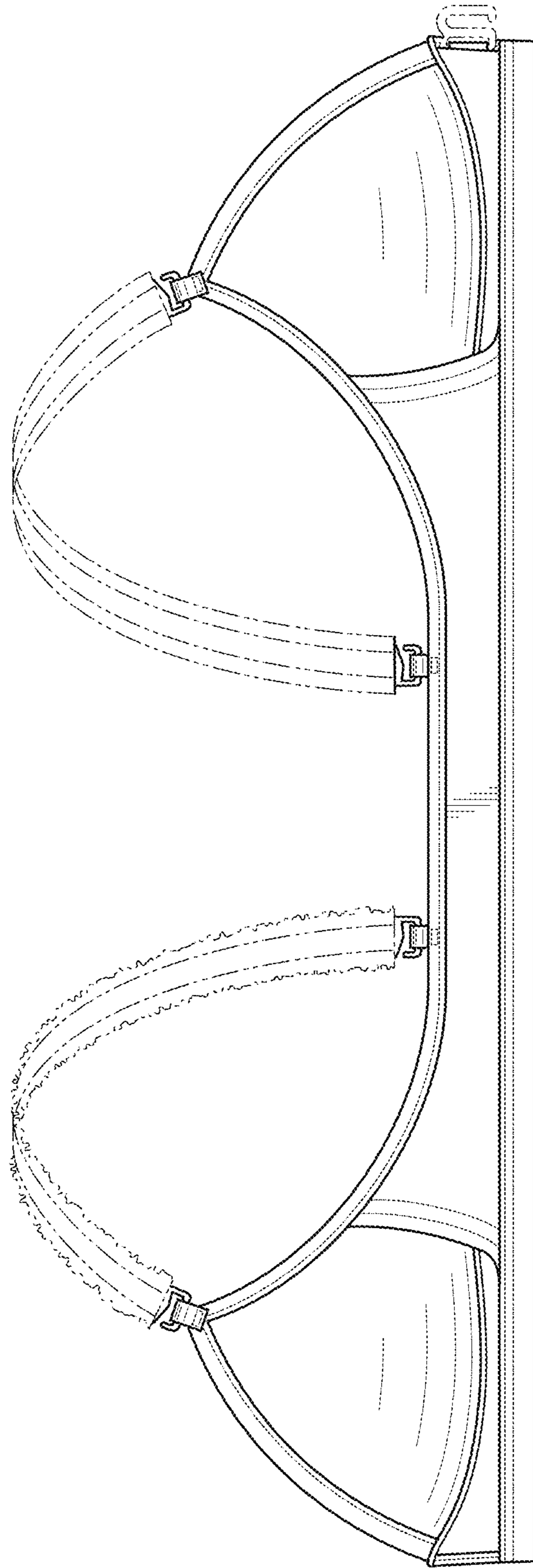

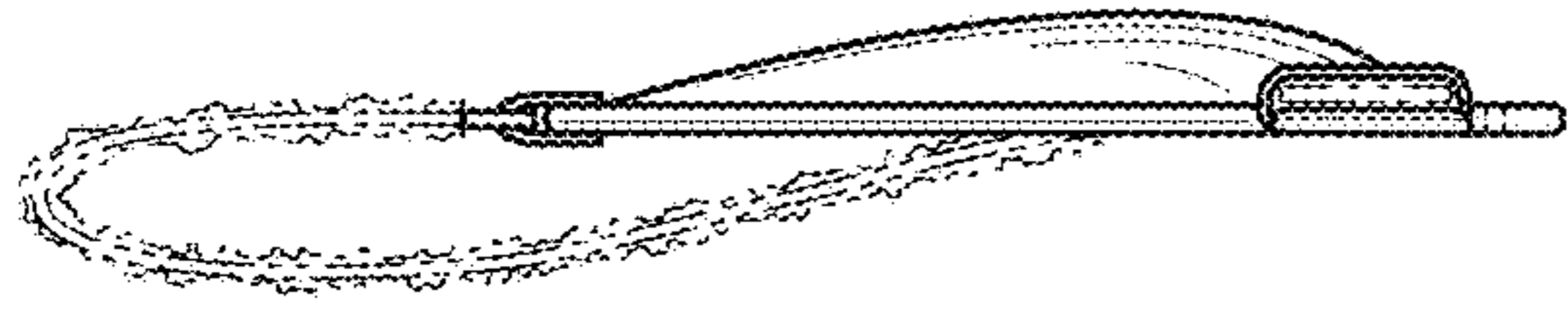

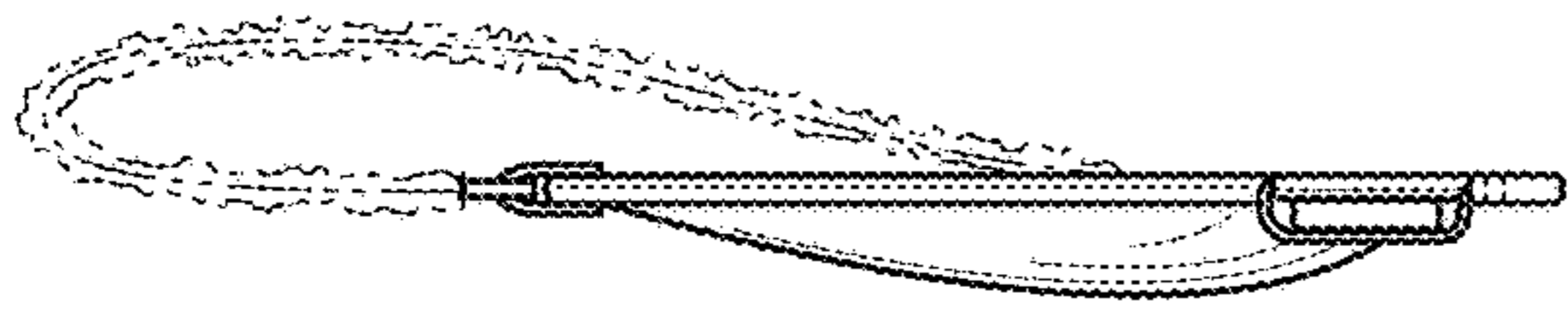

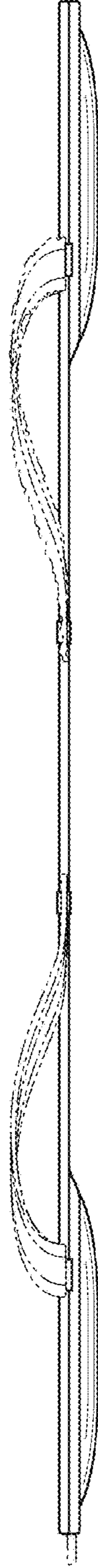

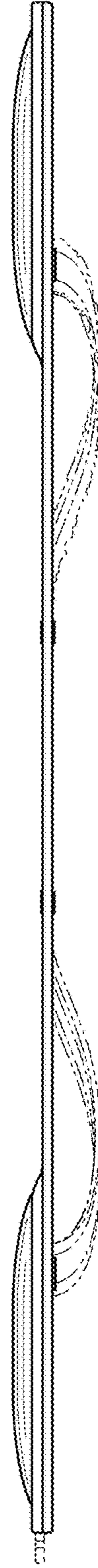
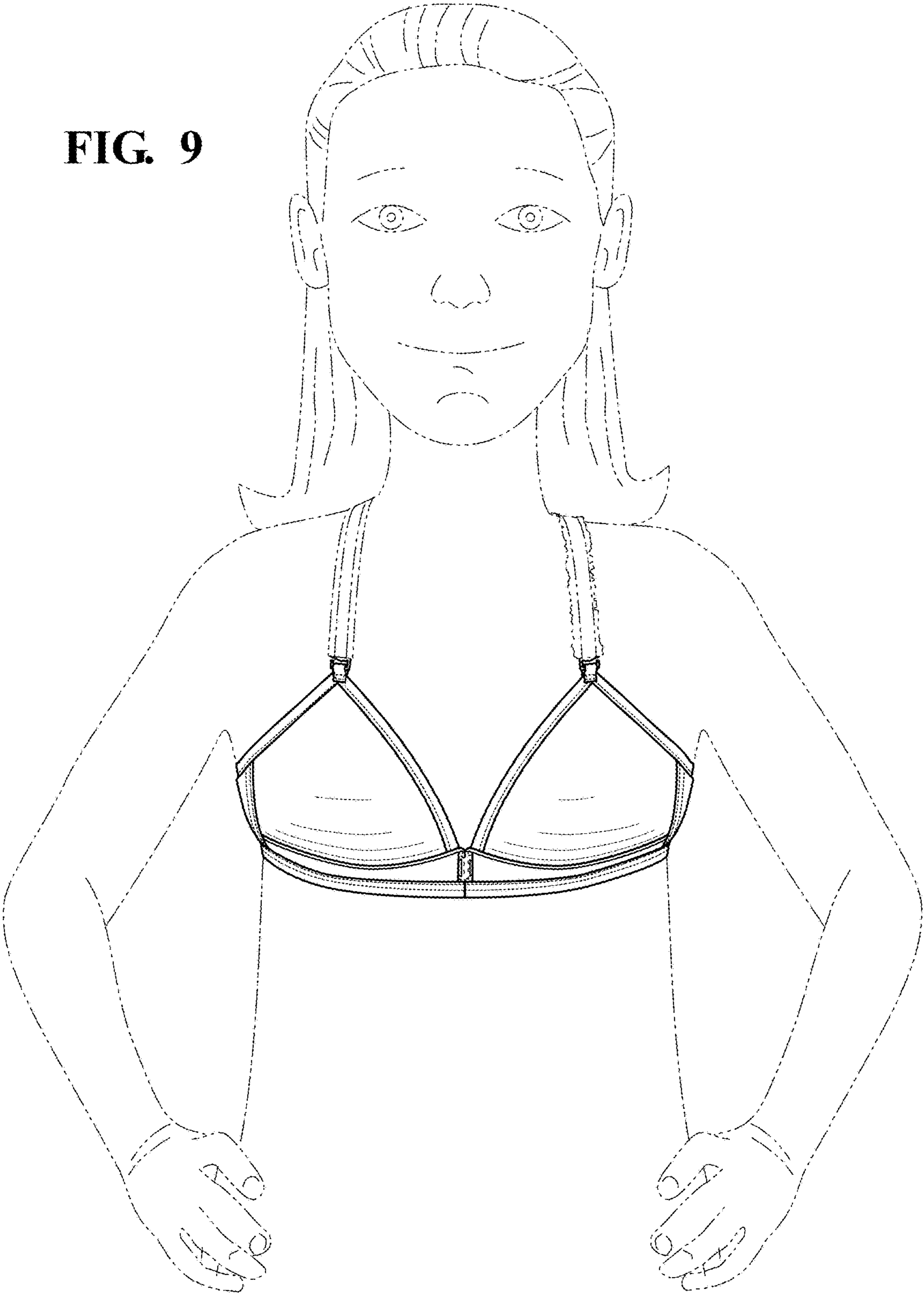
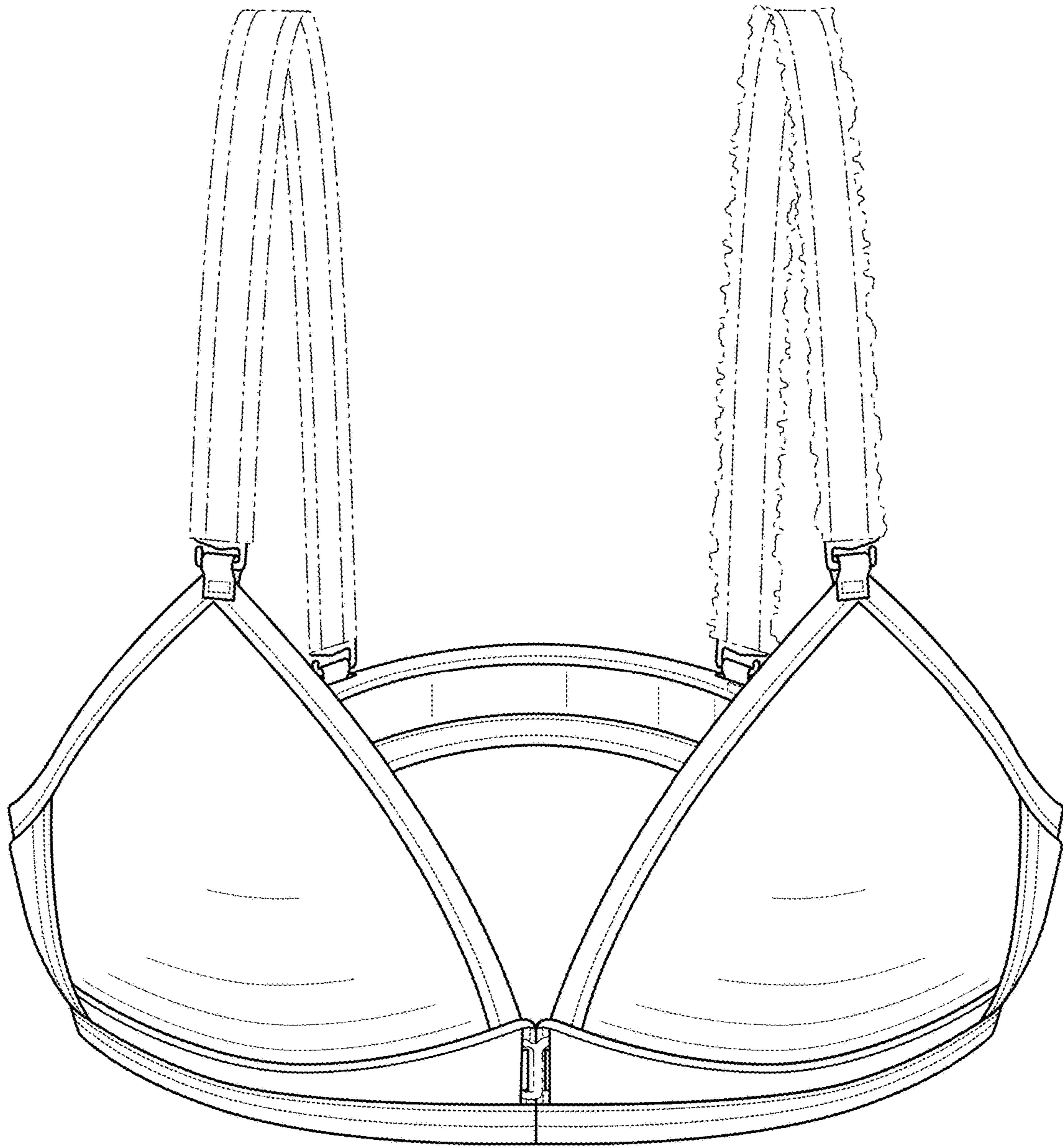

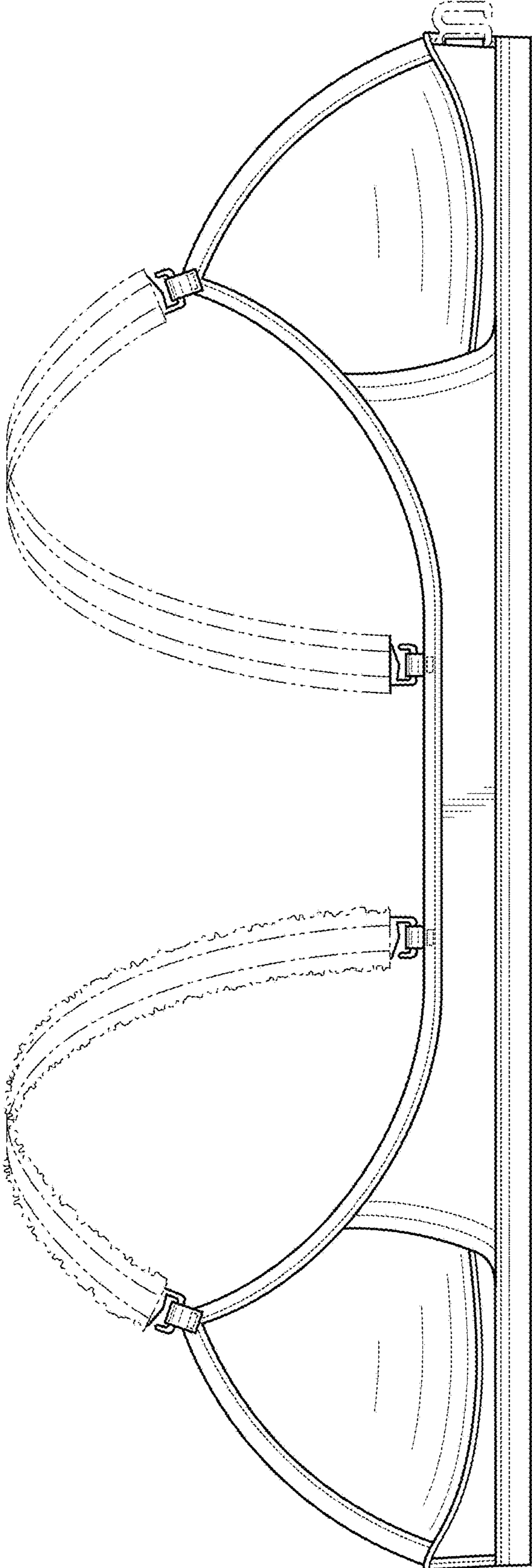

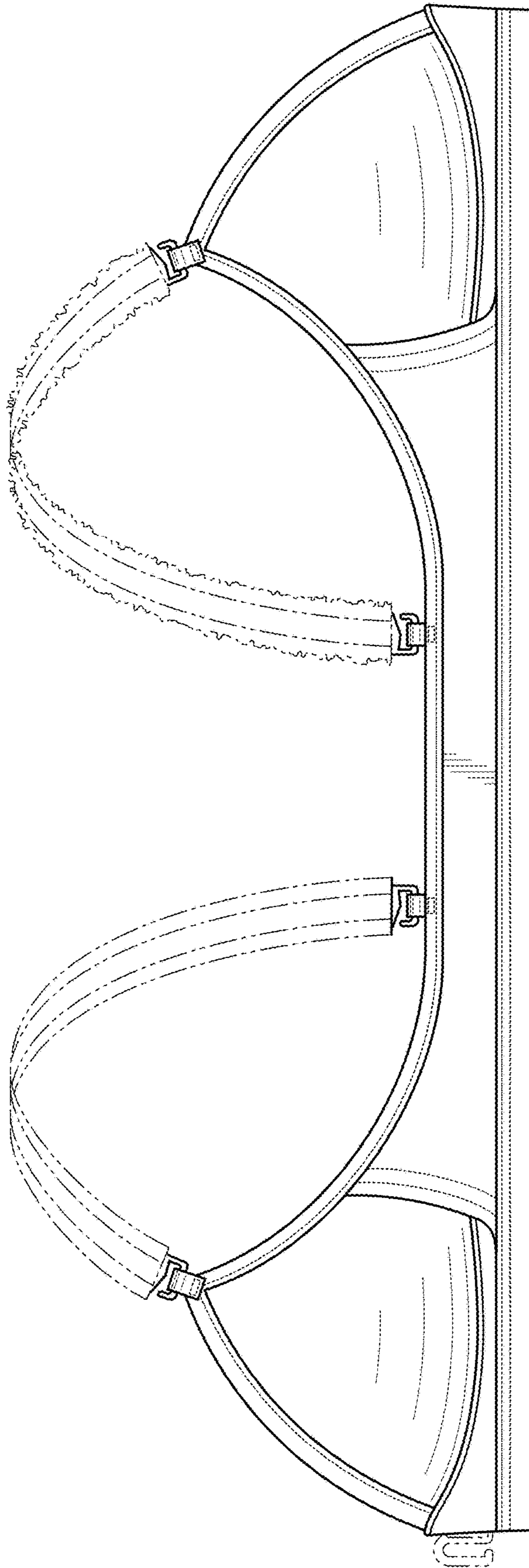

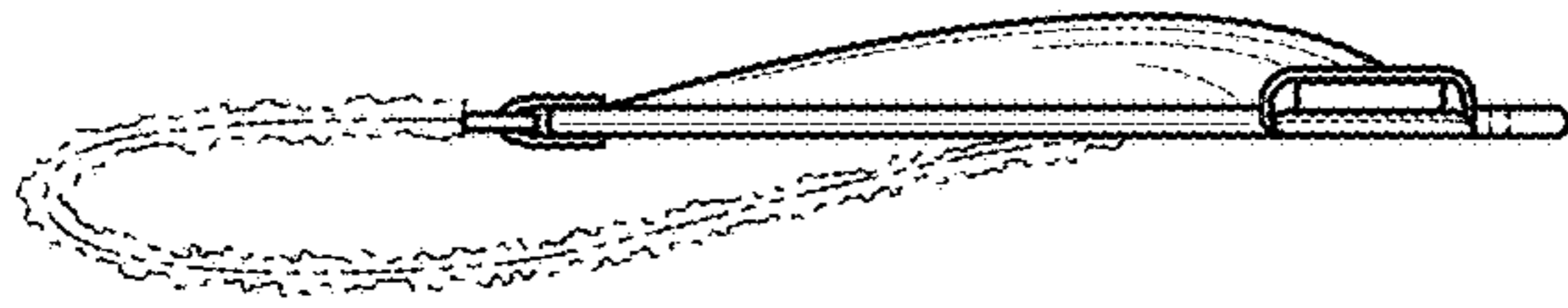

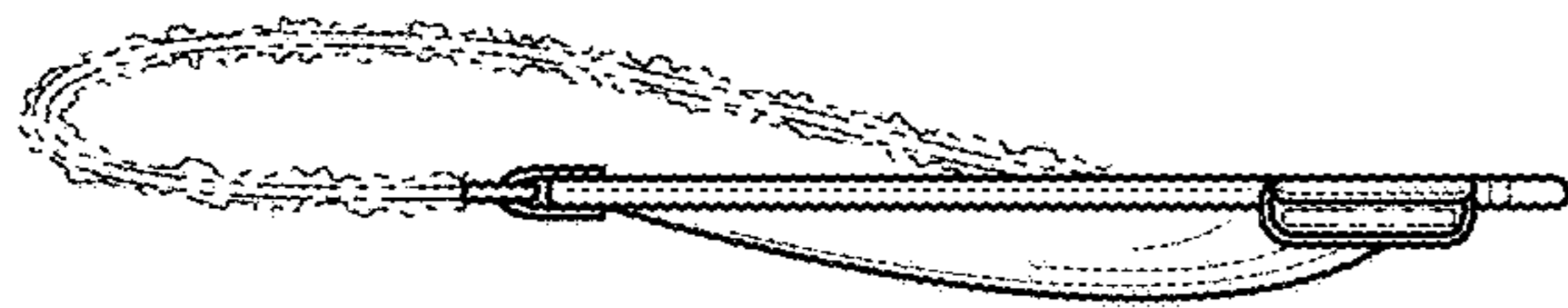

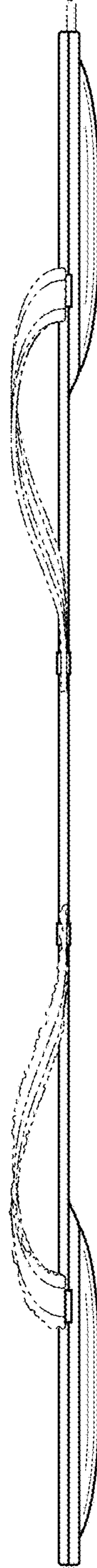

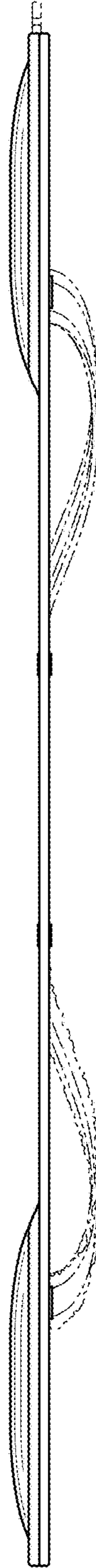
