(57) **CLAIM**

The ornamental design for a reversible detachable apron, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a reversible detachable apron, showing my new design;

FIG. 2 is a rear view thereof;

FIG. 3 is front perspective view thereof, wherein a second side of the detachable lower panel is shown facing the front; FIG. 4 is a front view of one side of the detachable lower panel;

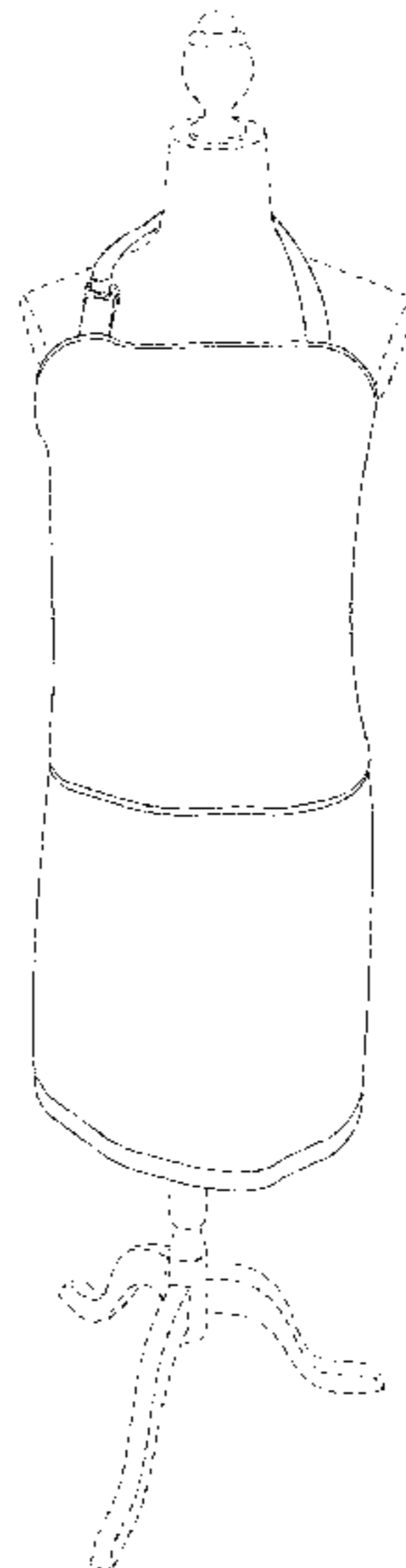
FIG. 5 is a front view of the opposite side of the lower panel of FIG. 4;

FIG. 6 is a front view of one side of the lower panel, showing a second embodiment; and,

FIG. 7 is an opposite view of FIG. 6.

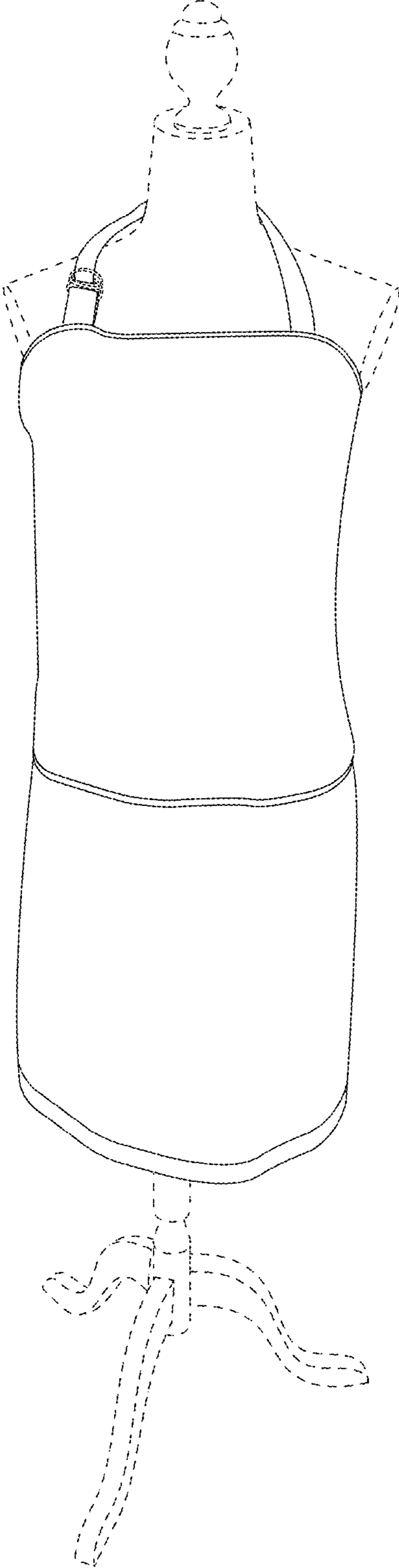

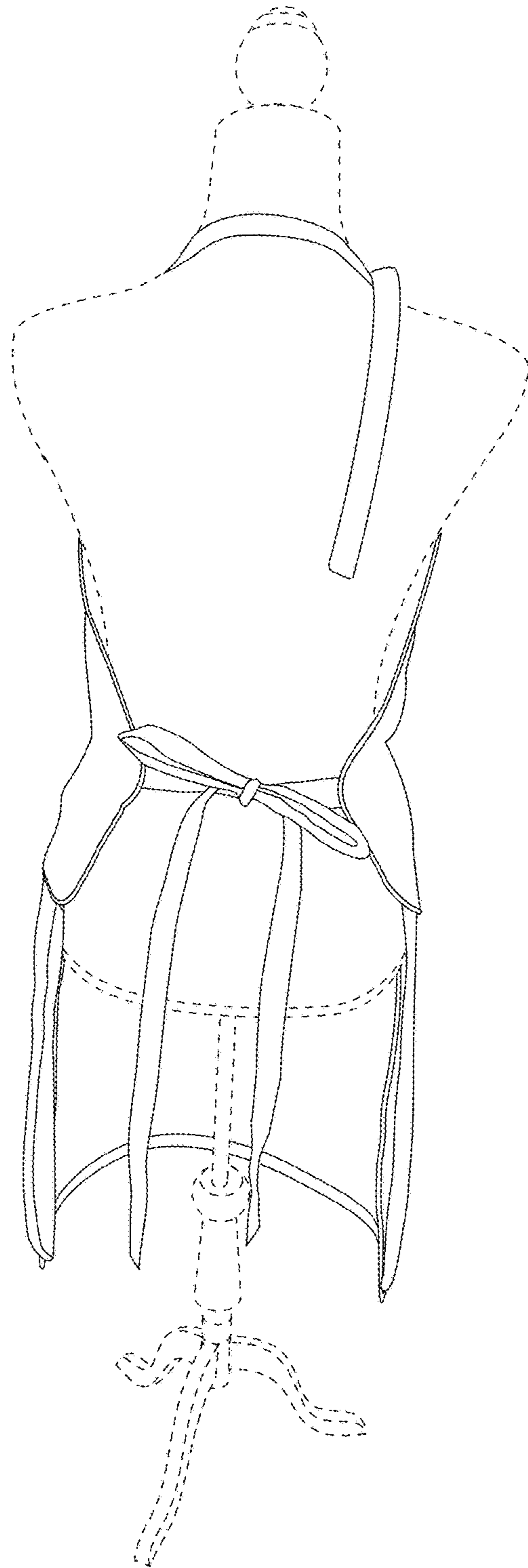

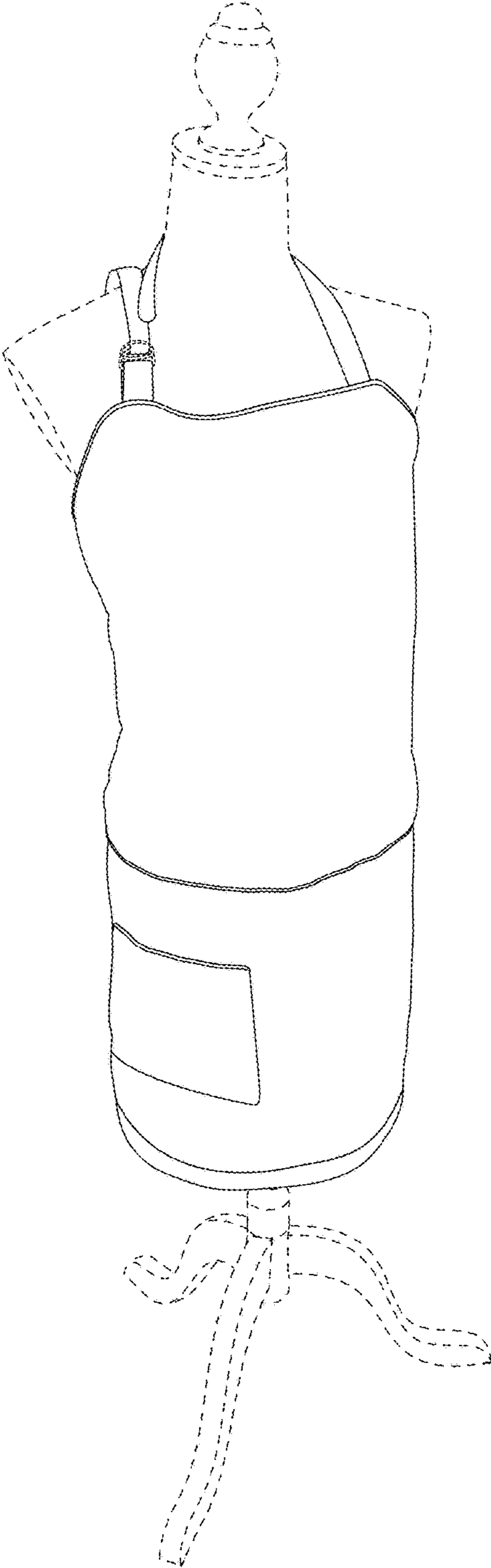

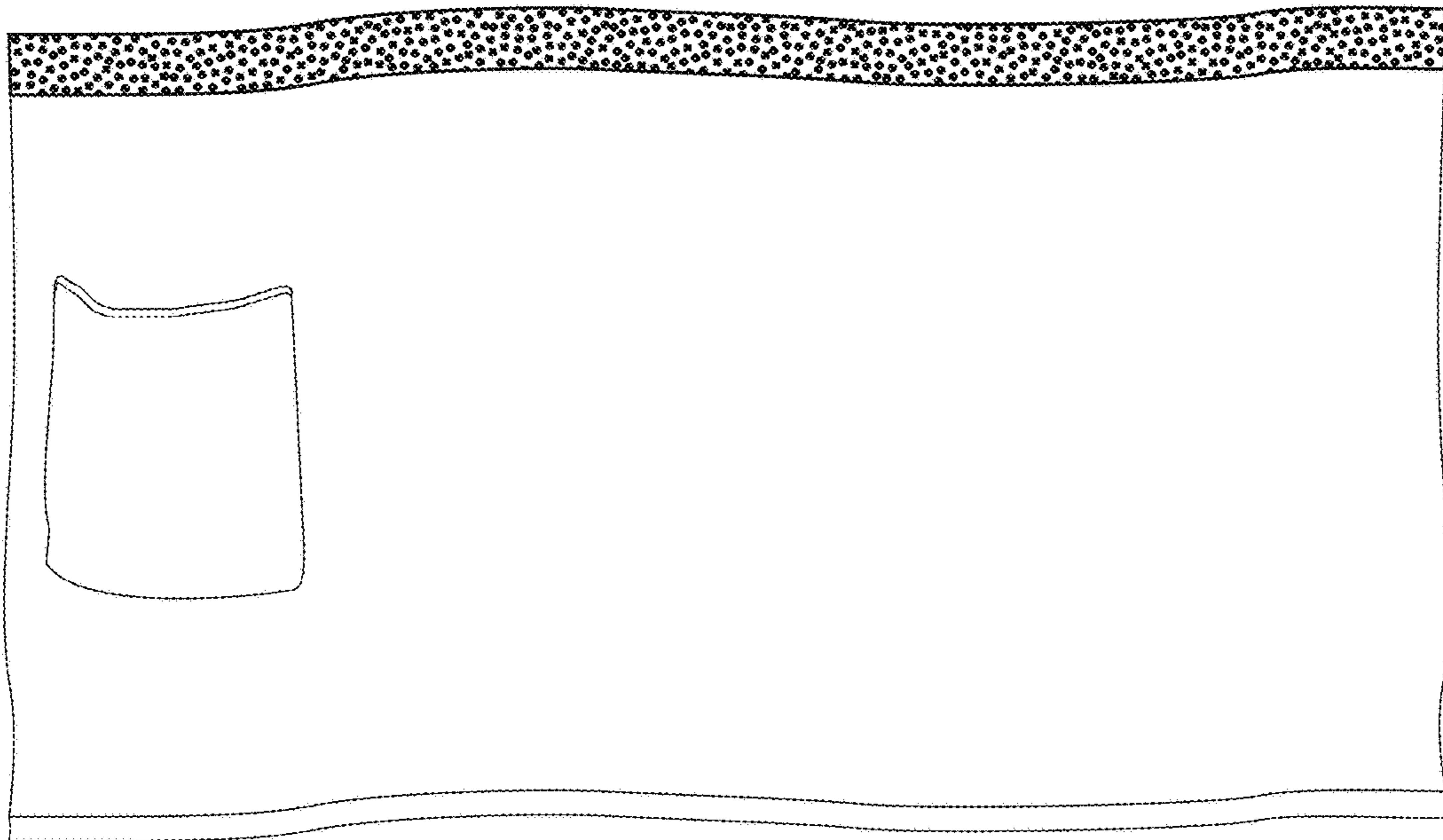

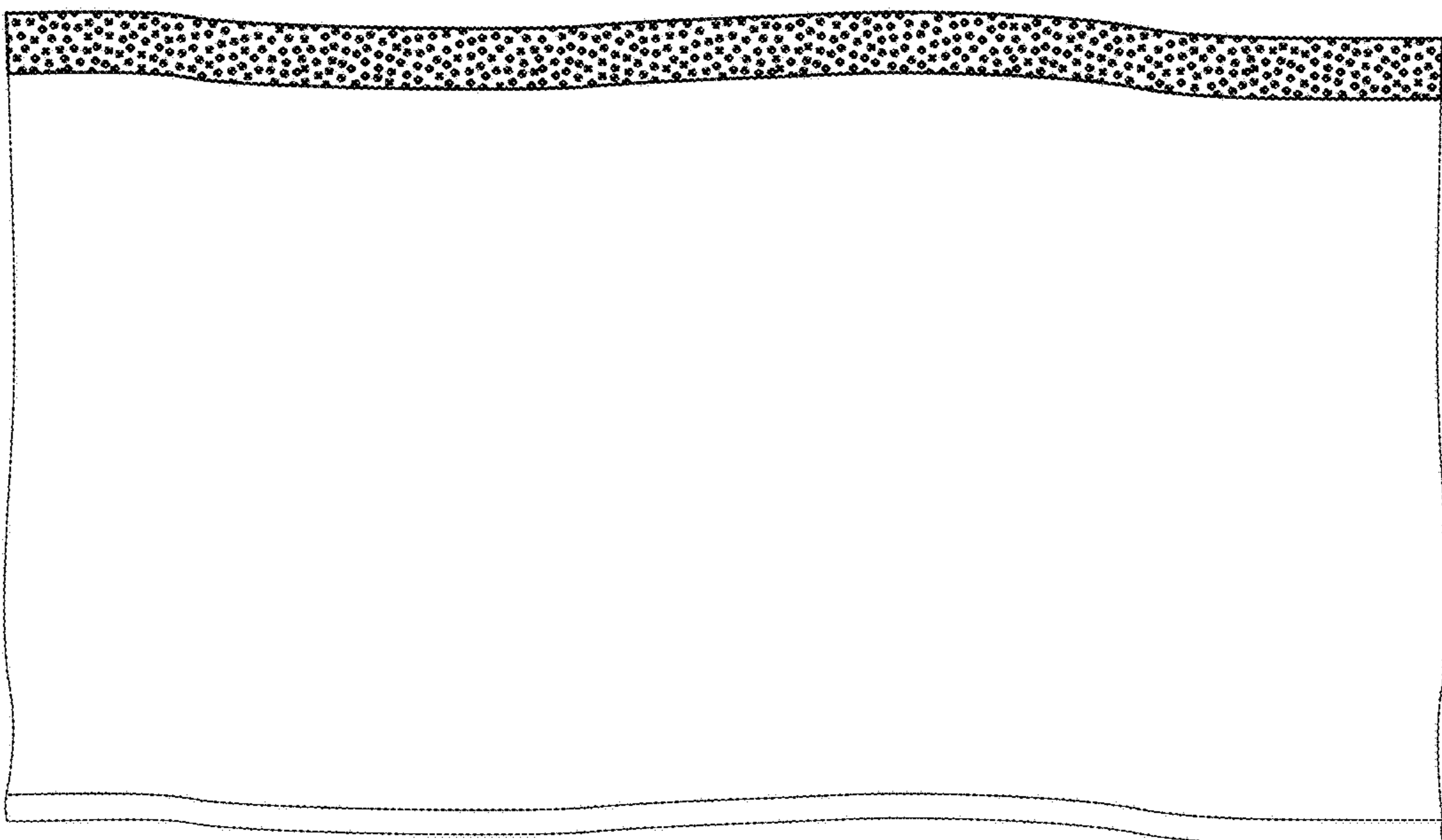

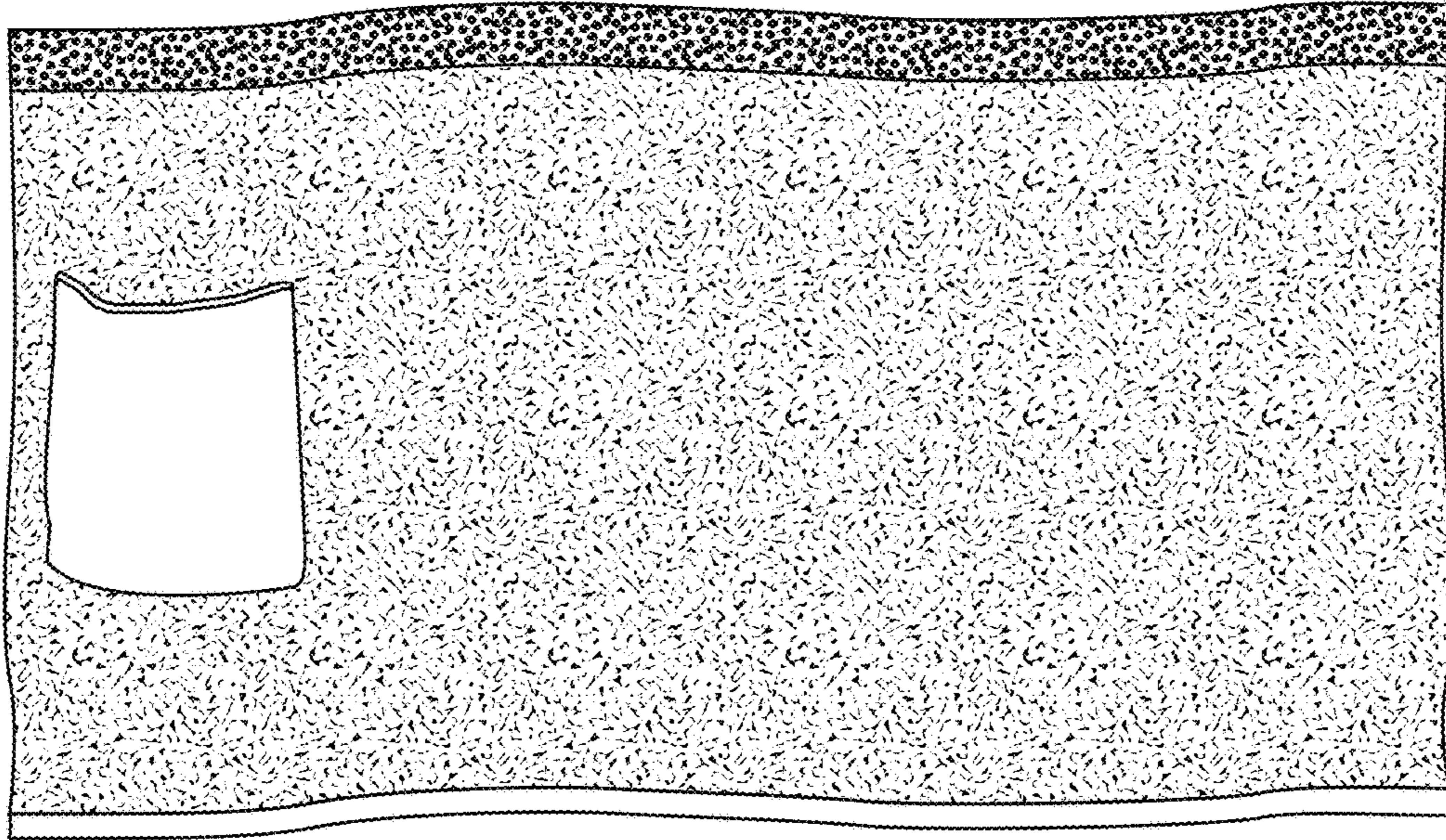

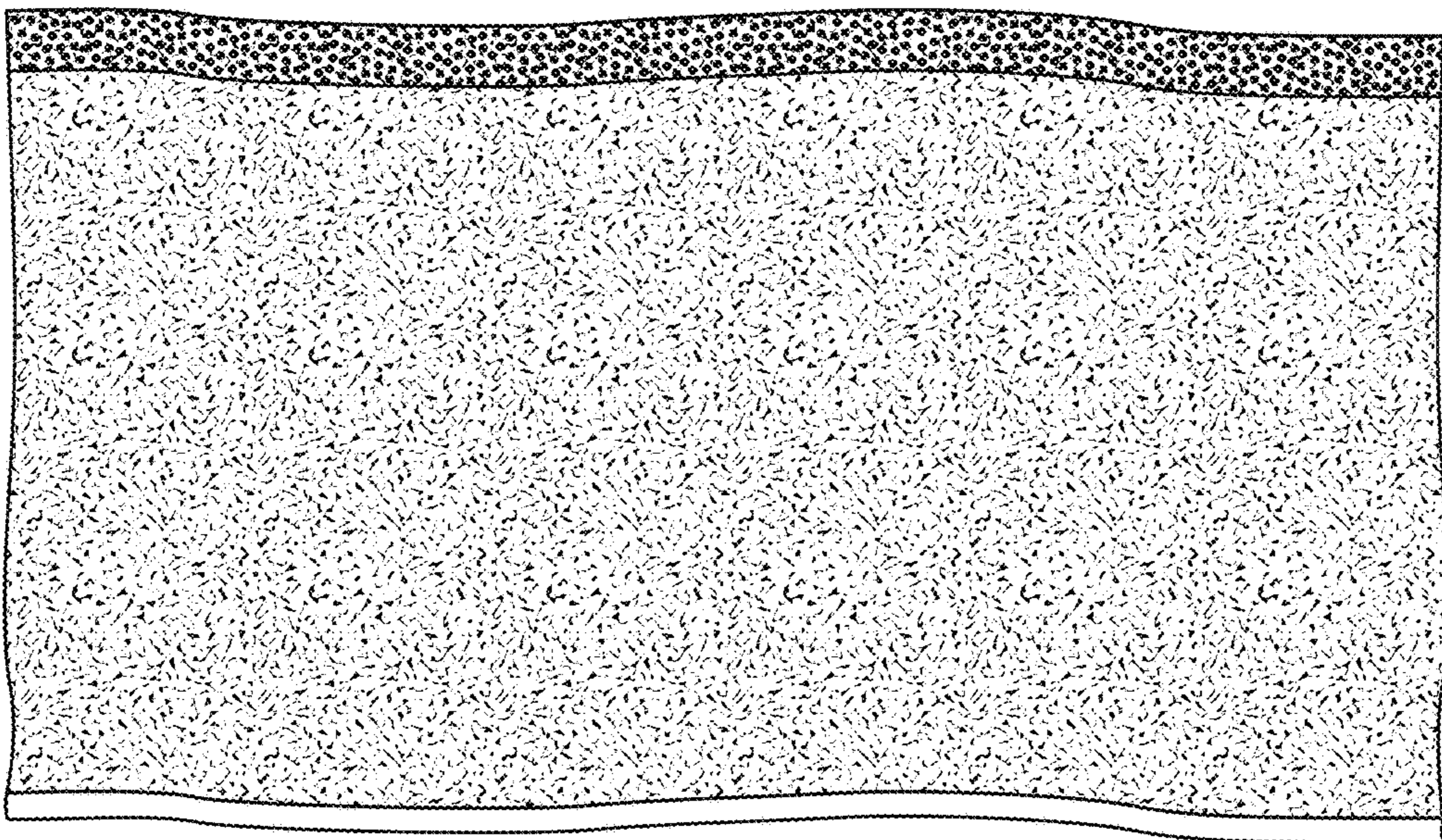
