(57) **CLAIM**

The ornamental design for a molded mascara brush head, substantially as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of our new design for a mascara brush head;
FIG. 2 is a rear perspective view of the mascara brush head shown in FIG. 1;
FIG. 3 is an elevation view of the mascara brush head shown in FIG. 1;
FIG. 4 is an elevation view of the mascara brush head shown in FIG. 1, rotated 60° relative to FIG. 3;
FIG. 5 is a top plan view of the mascara brush head shown in FIG. 1; and,
FIG. 6 is a bottom plan view of the mascara brush head shown in FIG. 1.

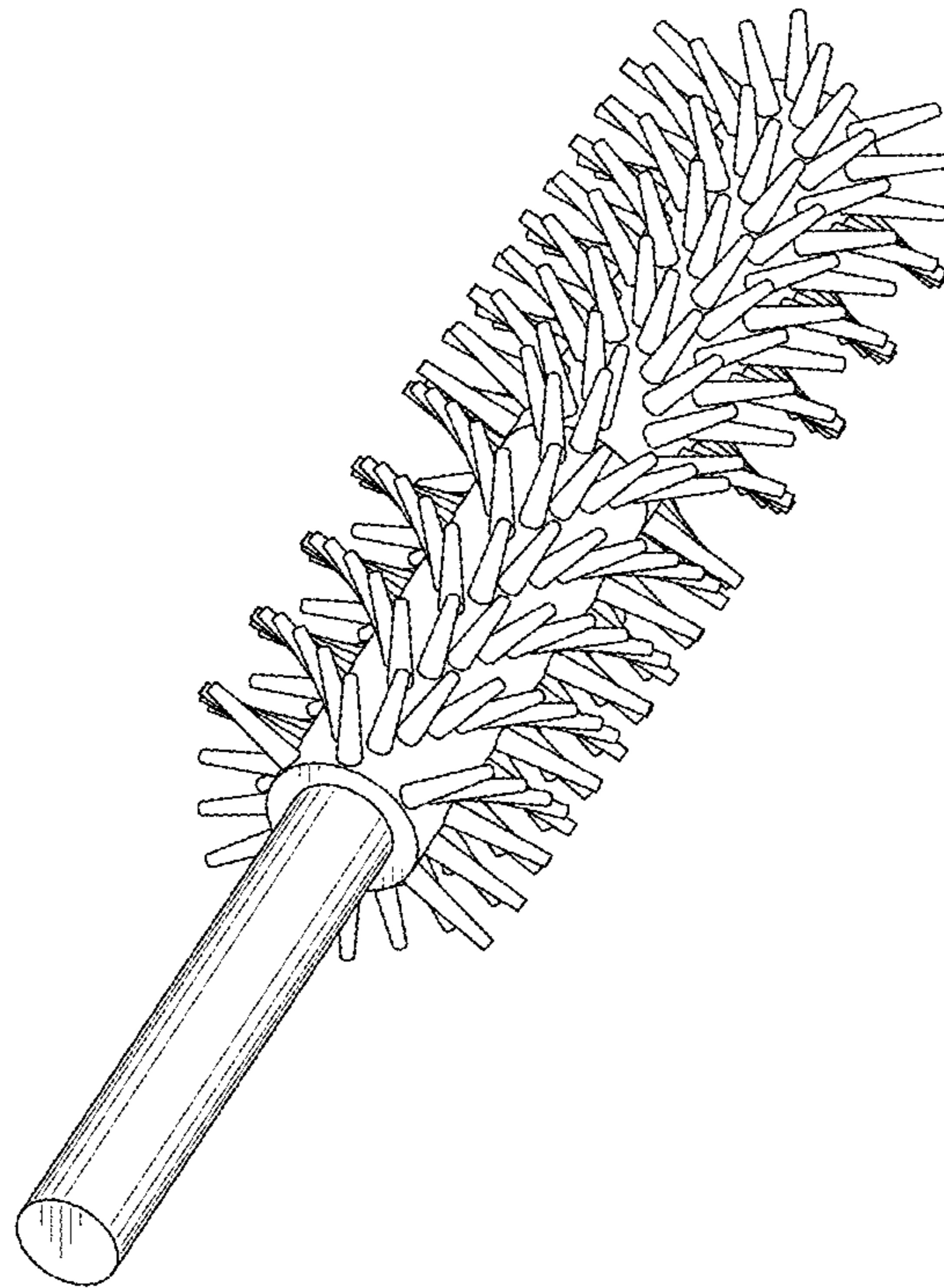

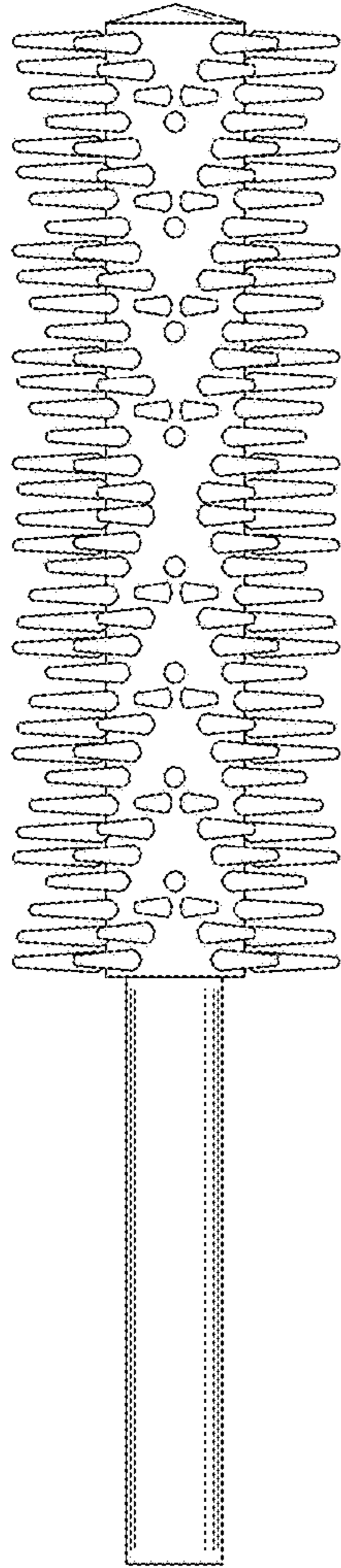

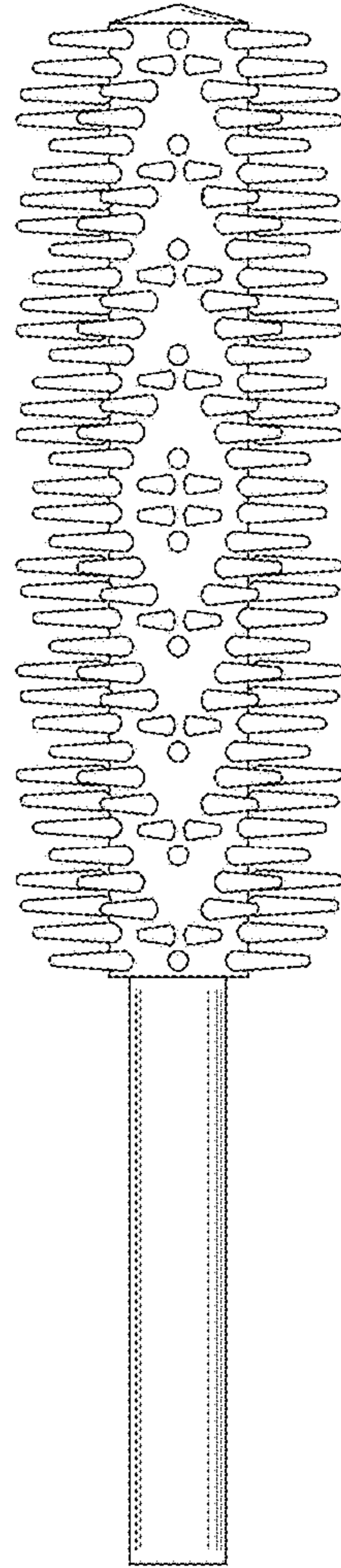

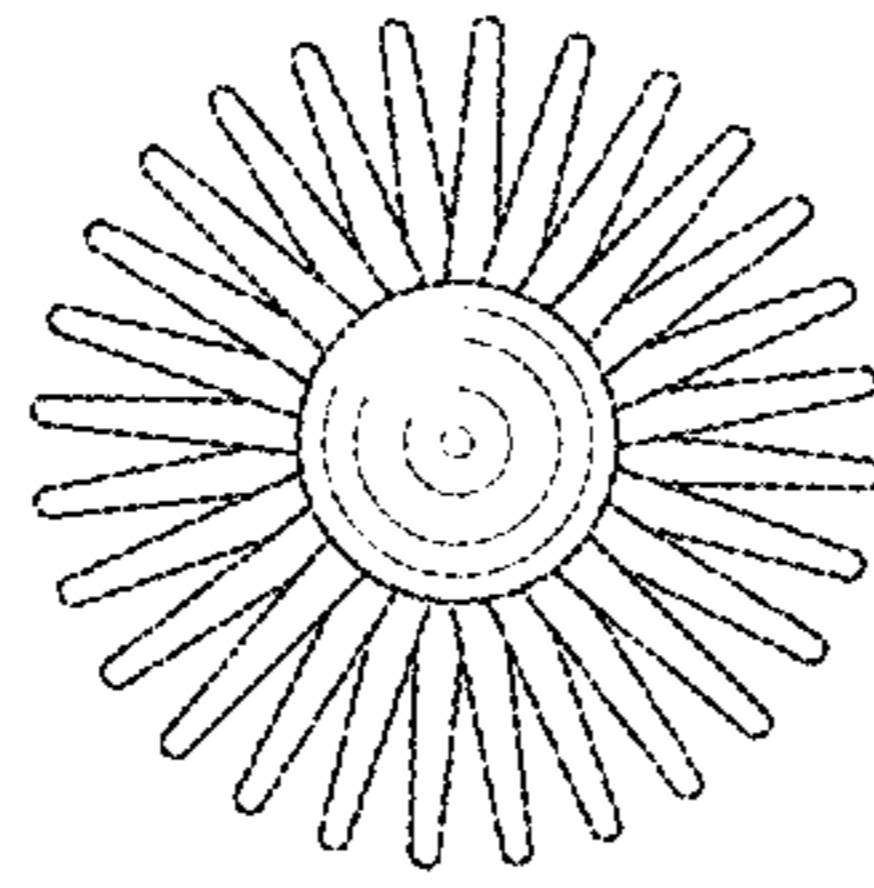

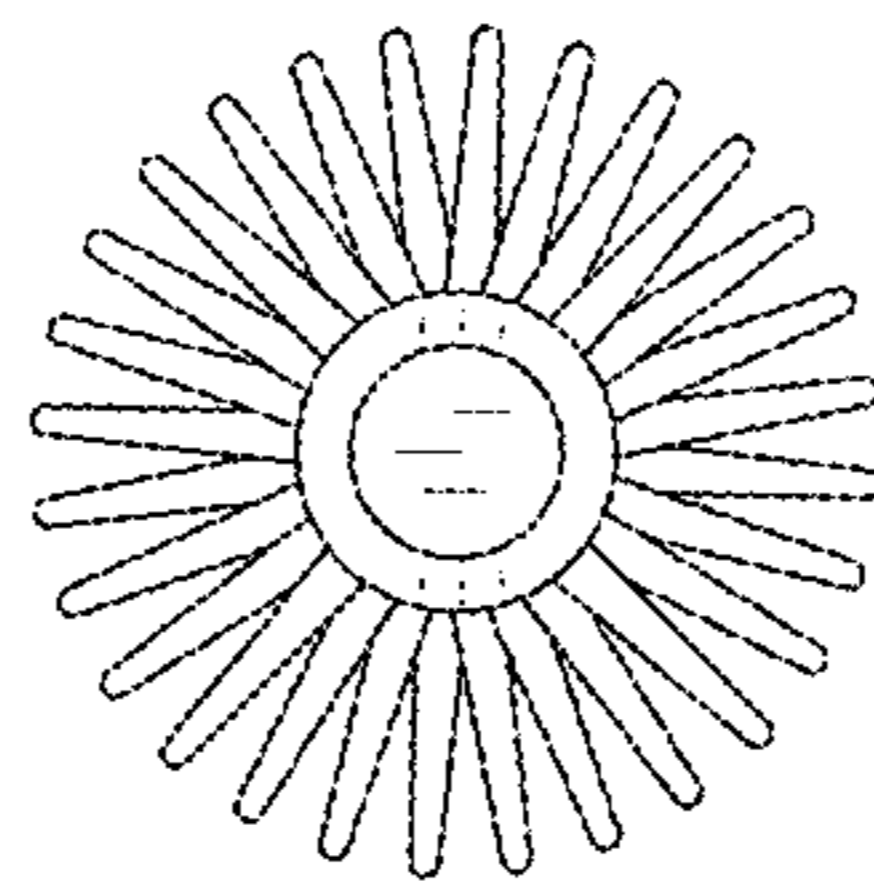
