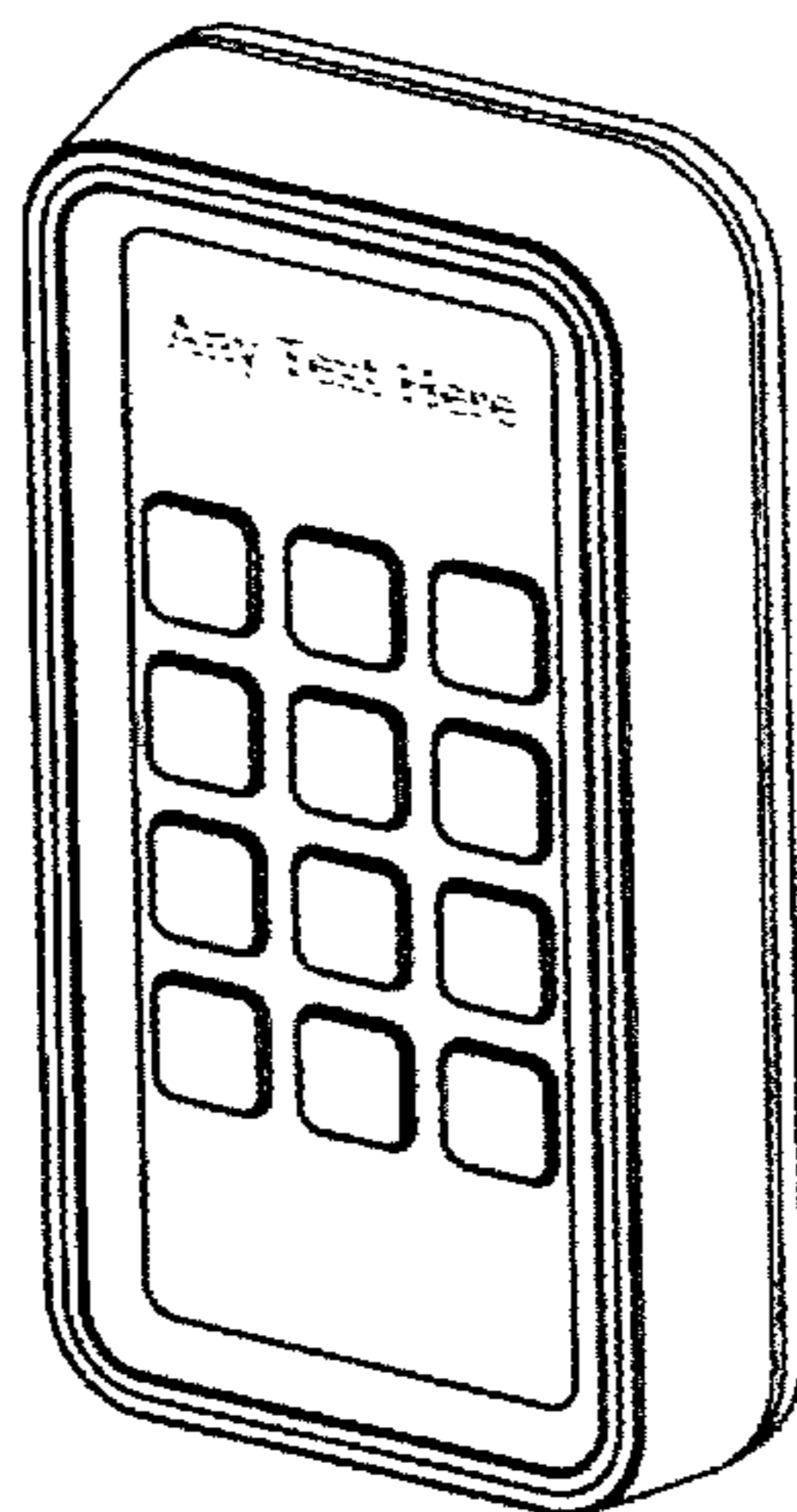
(57) **CLAIM**

The ornamental design for a “trim ring lock,” as shown and described.

DESCRIPTION

FIG. 1 is a right front top perspective view of the “trim ring lock” according to our invention;
FIG. 2 is a front elevational view of the “trim ring lock” shown in FIG. 1;
FIG. 3 is a rear elevational view of the “trim ring lock” shown in FIG. 1;
FIG. 4 is a right side elevational view of the “trim ring lock” shown in FIG. 1;
FIG. 5 is a left side elevational view of the “trim ring lock” shown in FIG. 1;
FIG. 6 is a bottom elevational view of the “trim ring lock” shown in FIG. 1; and,
FIG. 7 is a top elevational view of the “trim ring lock” shown in FIG. 1.
Portions of the trim ring lock are shown in phantom lines and form no part of the design.

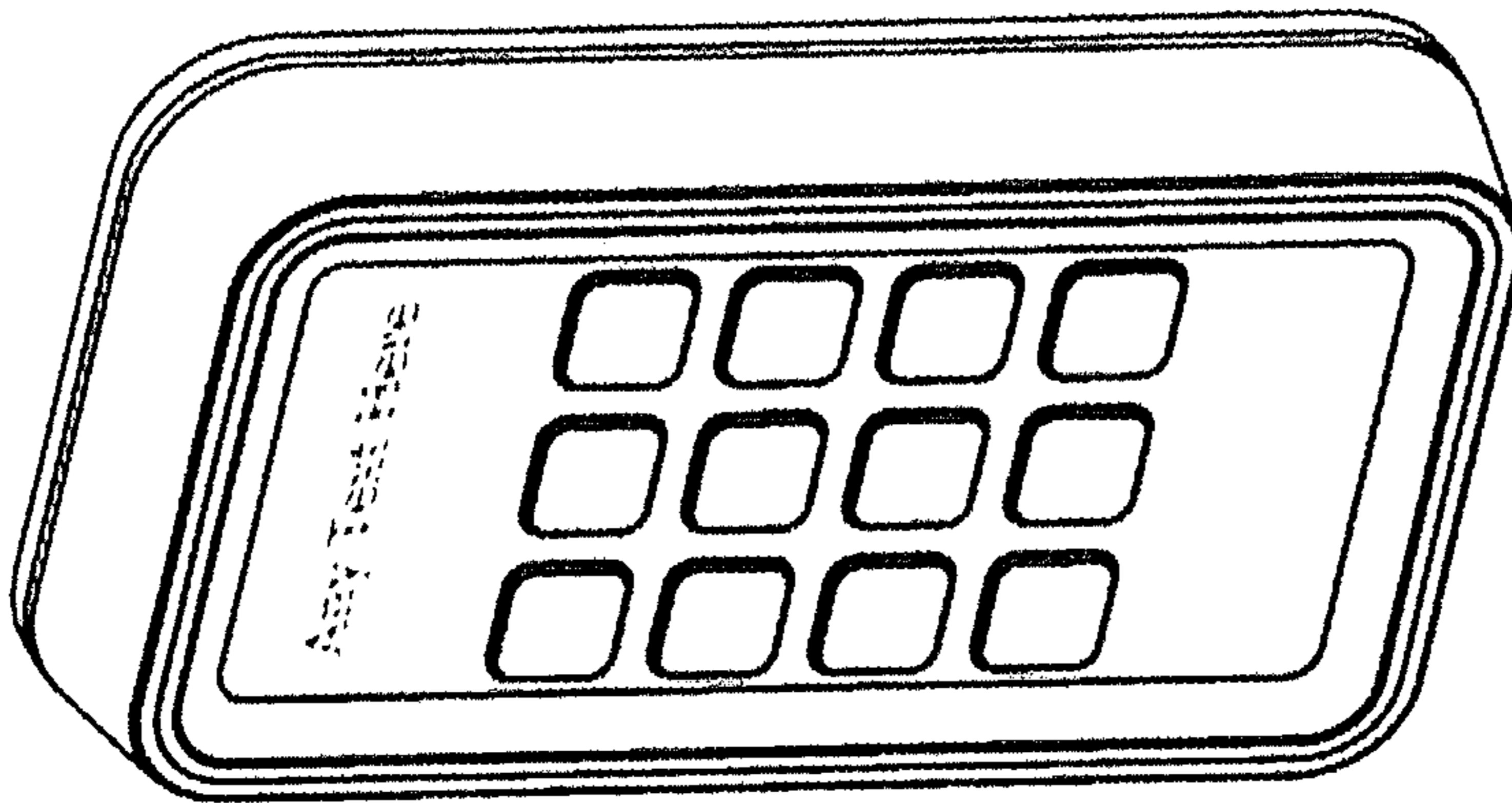

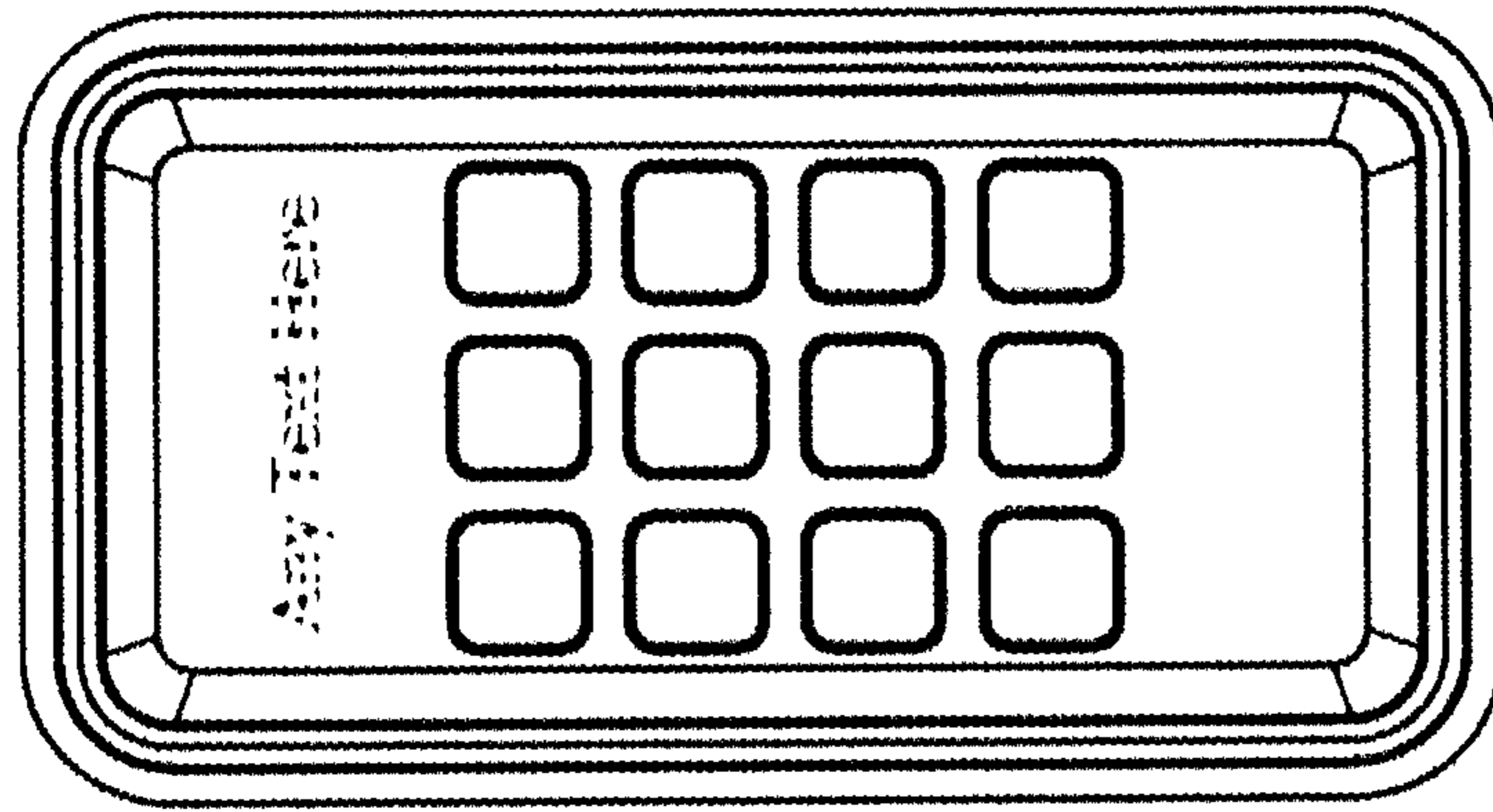

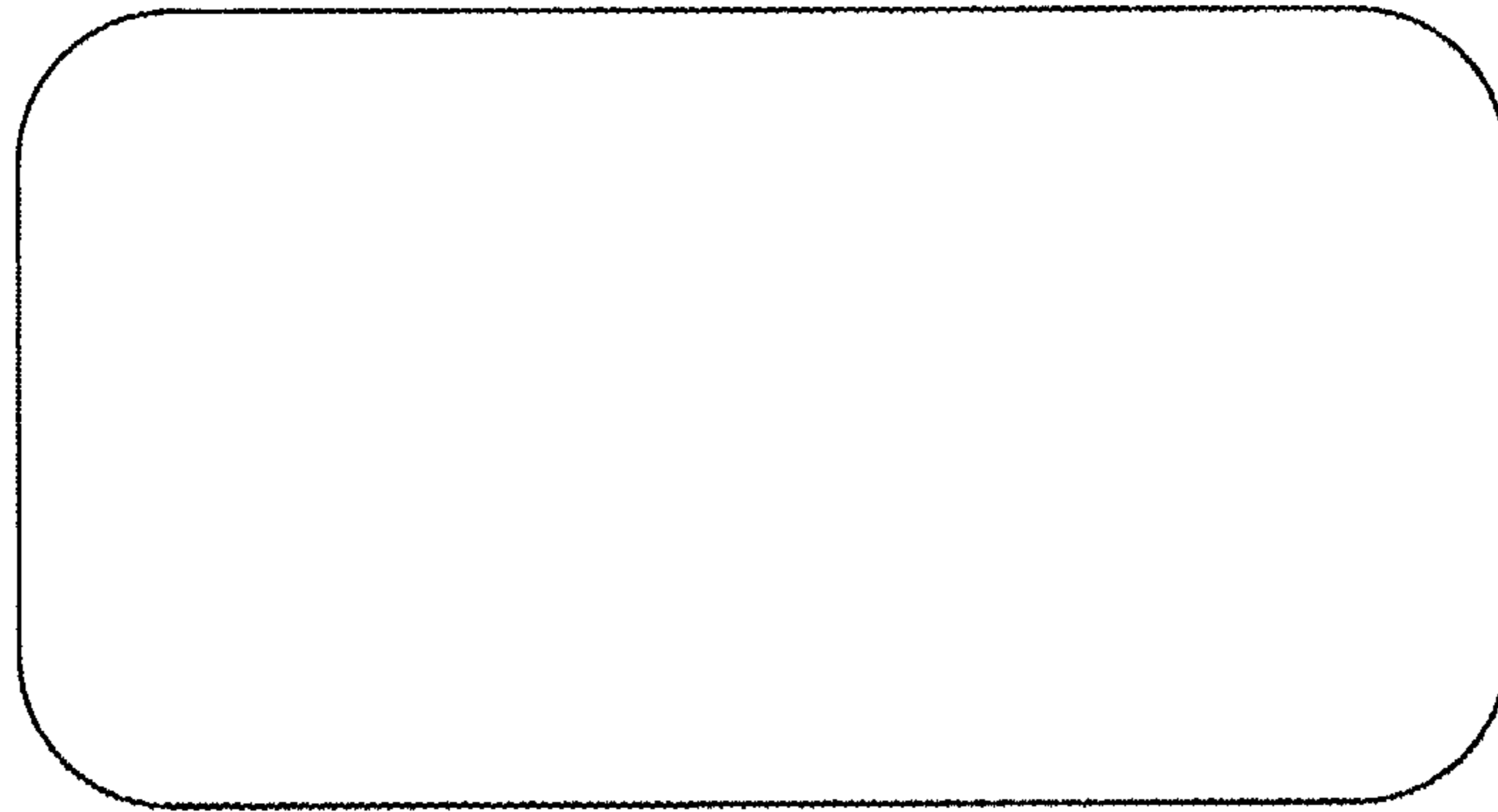

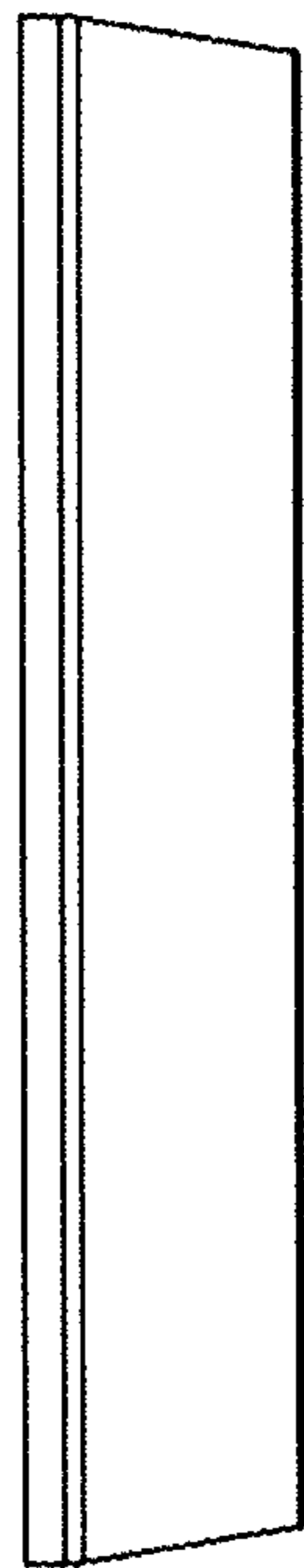

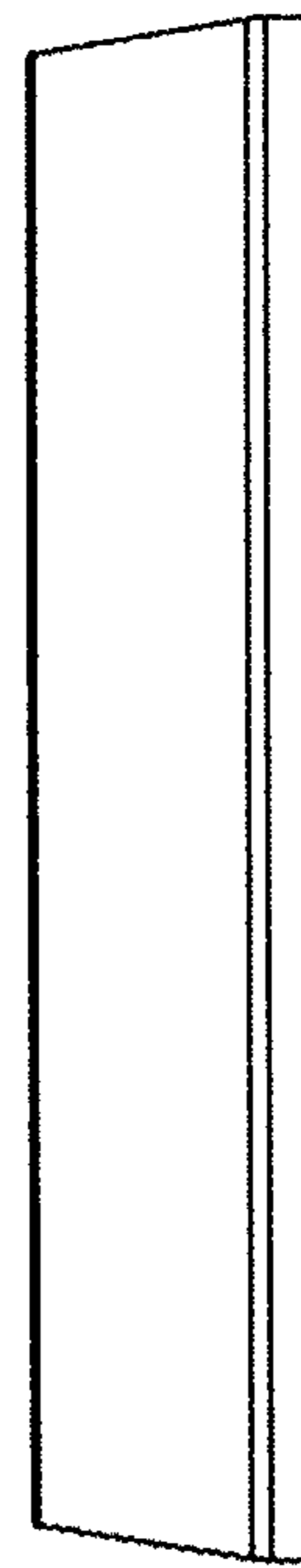
