(57) **CLAIM**

The ornamental design for a wine bottle, as shown and described.

DESCRIPTION

FIG. 1 is an overhead isometric view of the top, front and side of a wine bottle showing my design.

FIG. 2 is a front elevational view of the wine bottle shown in FIG. 1, the back being a mirror image of the front.

FIG. 3 is a right side elevational view of the wine bottle shown in FIG. 1, the left side being a mirror image of the right side

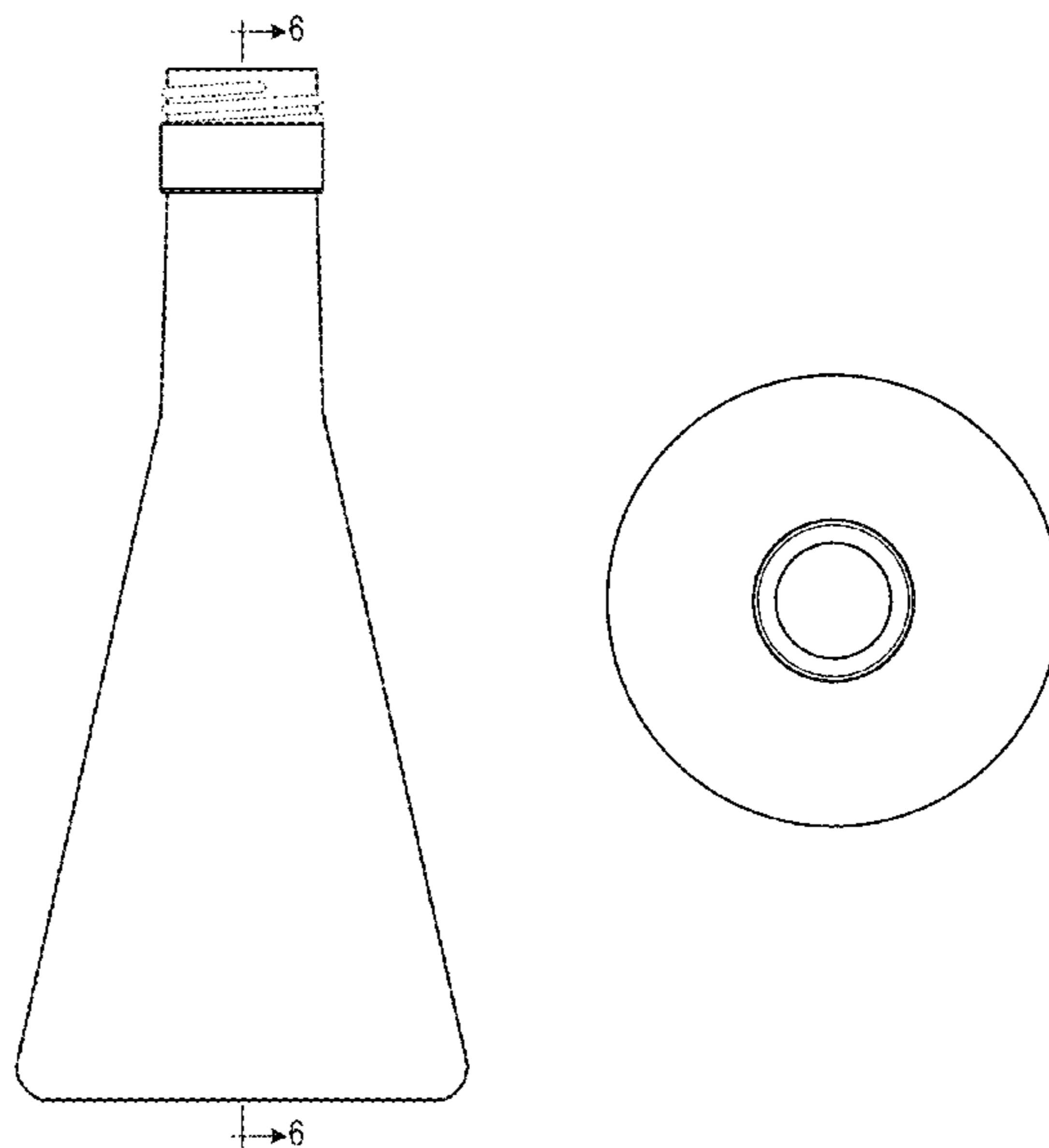
FIG. 4 is a top plan view of the wine bottle shown in FIG. 1.

FIG. 5 is a bottom plan view of the wine bottle shown in FIG. 1; and,

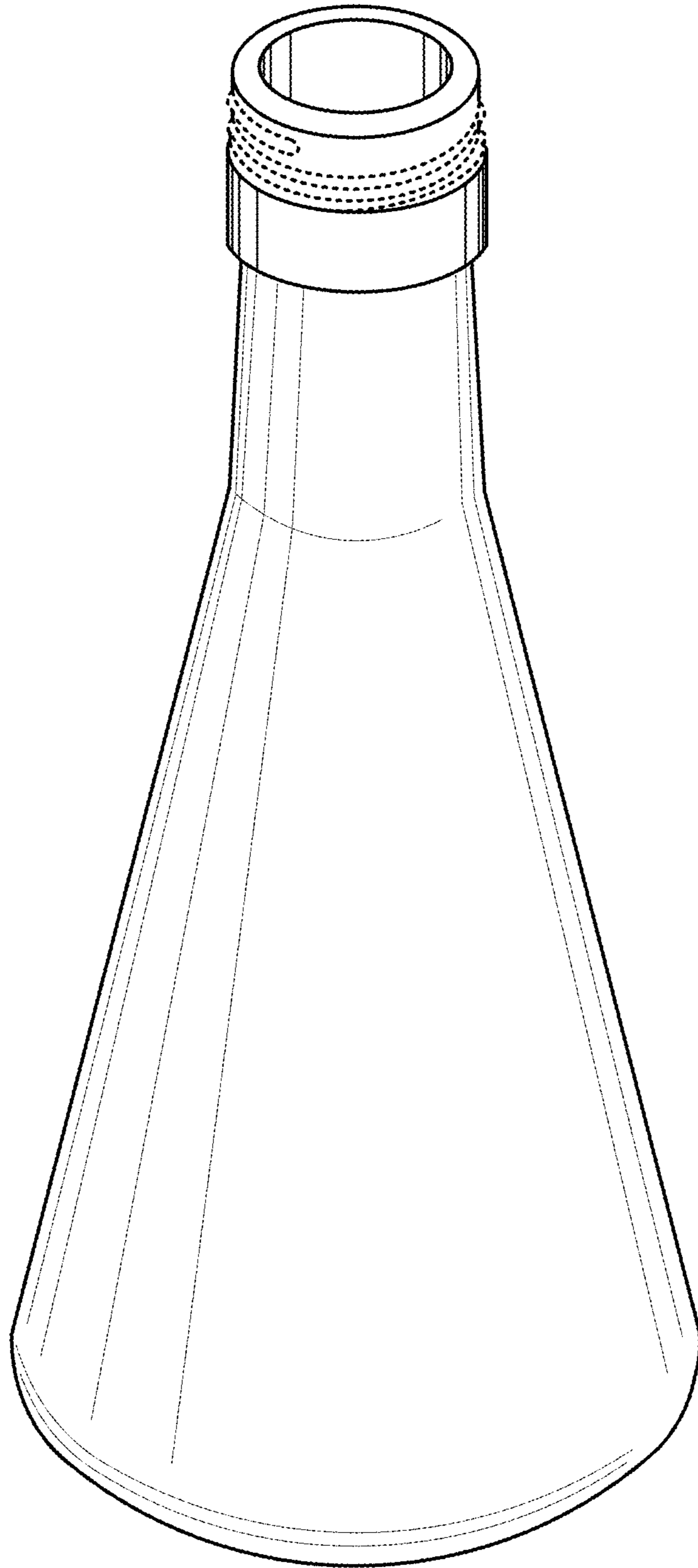

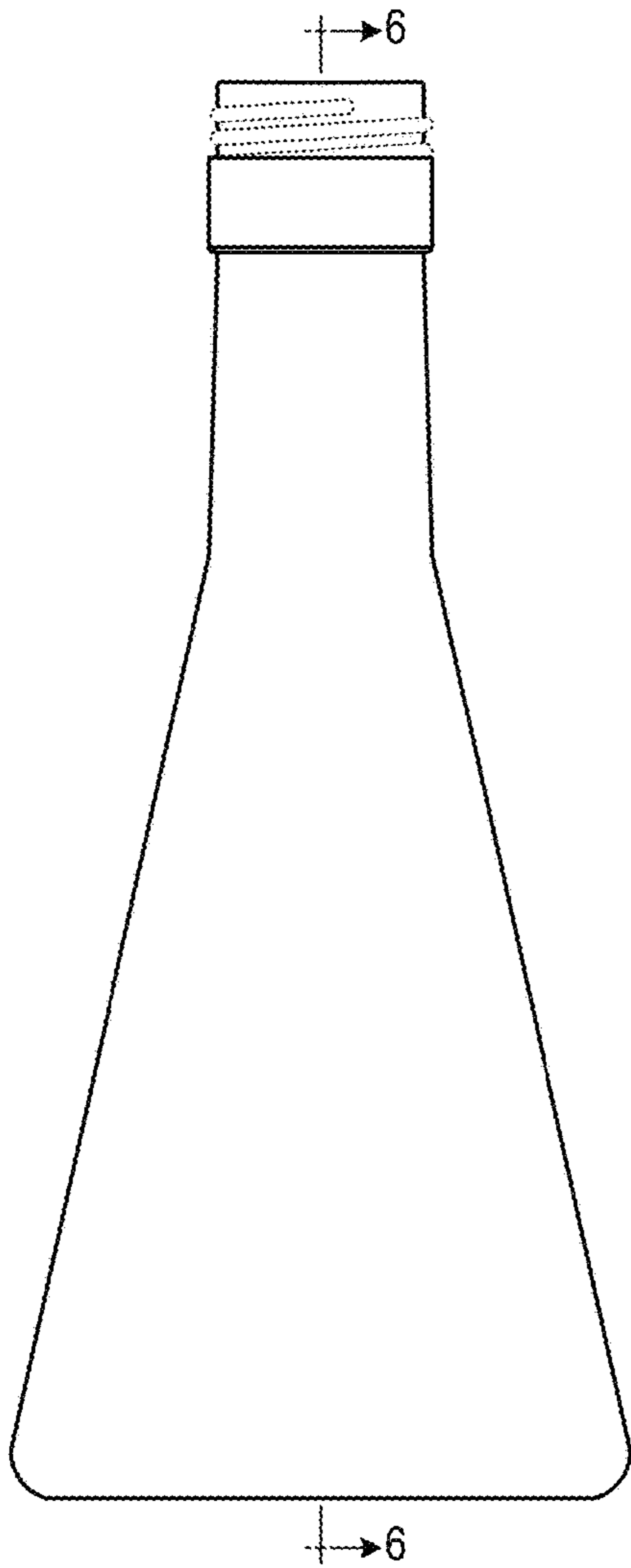

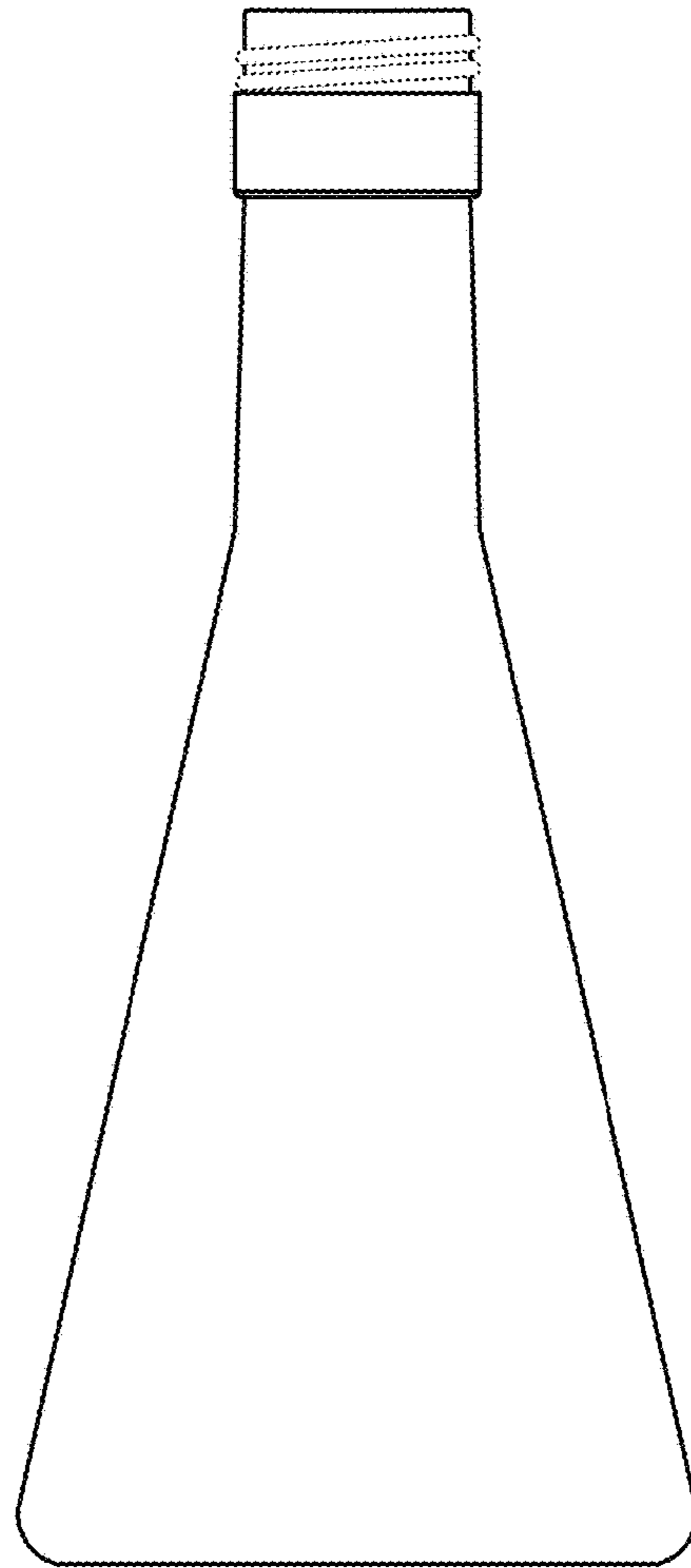

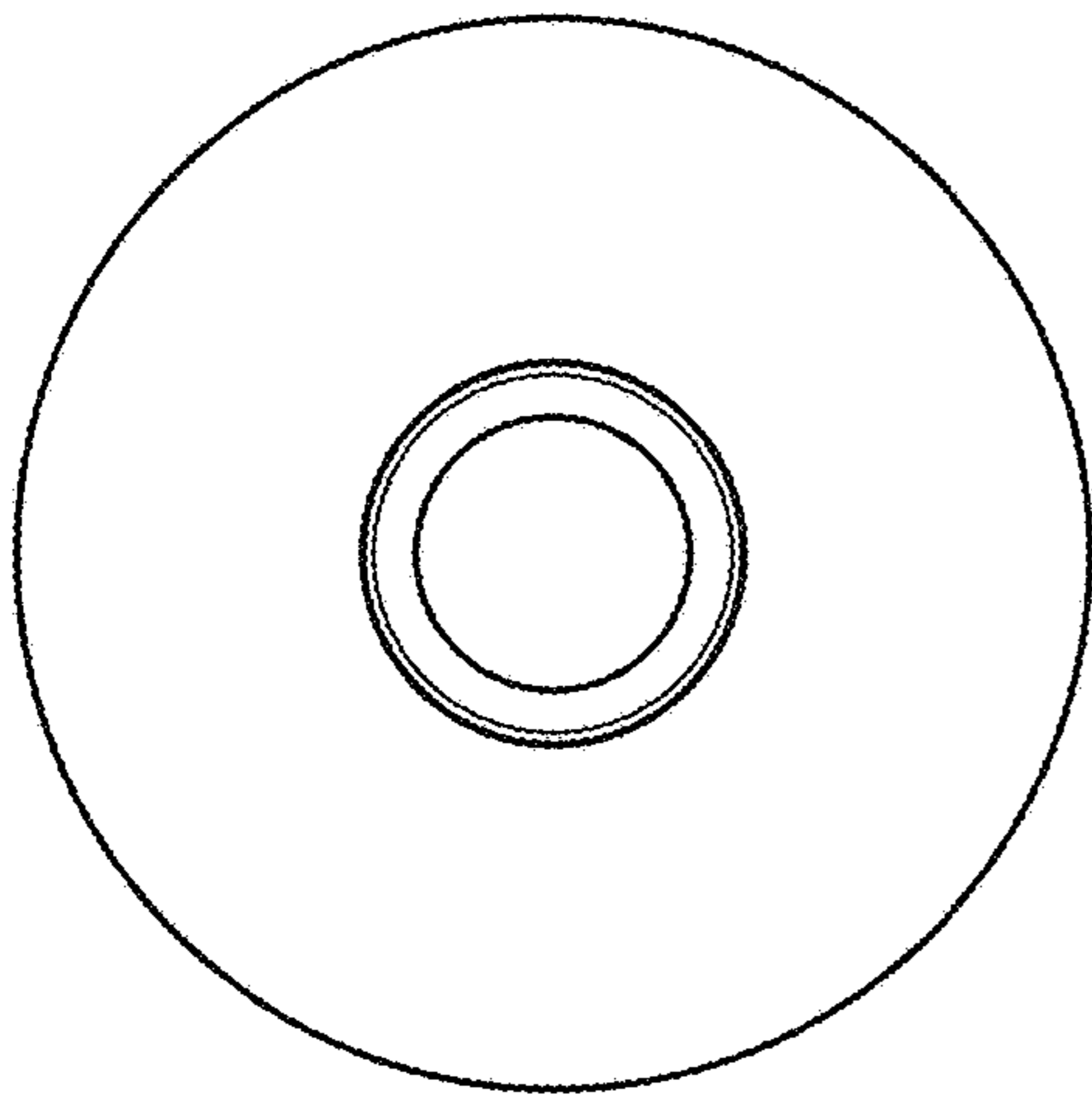

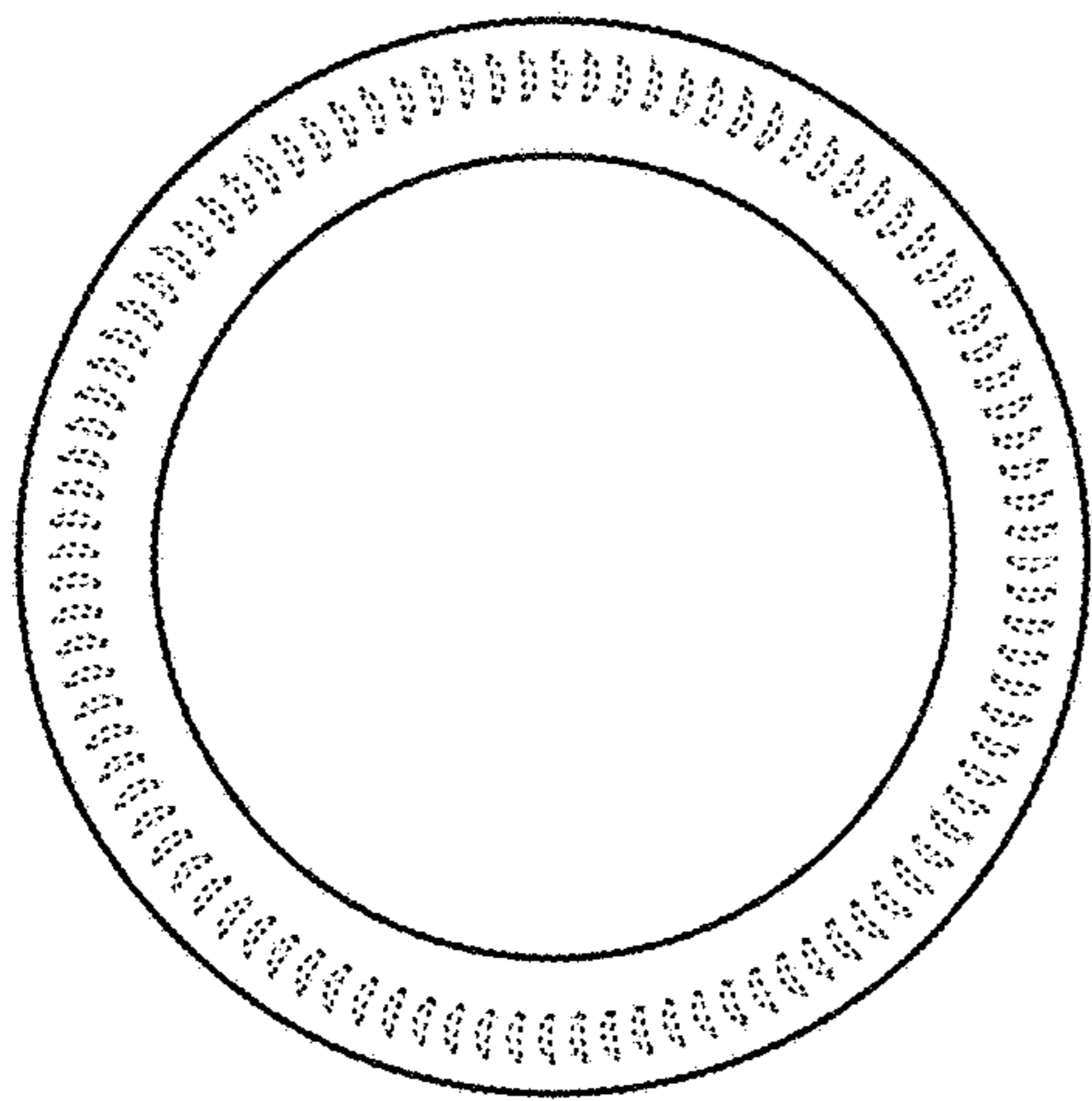

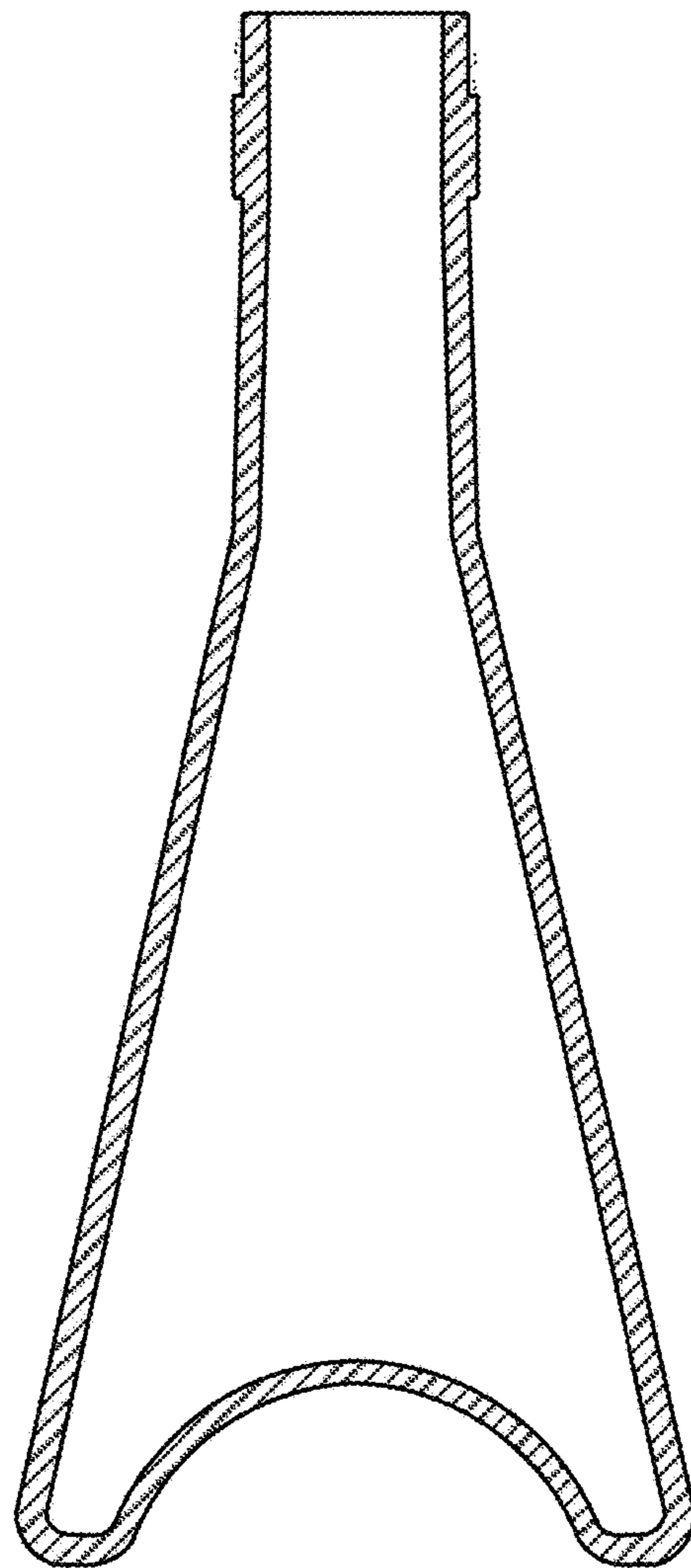
