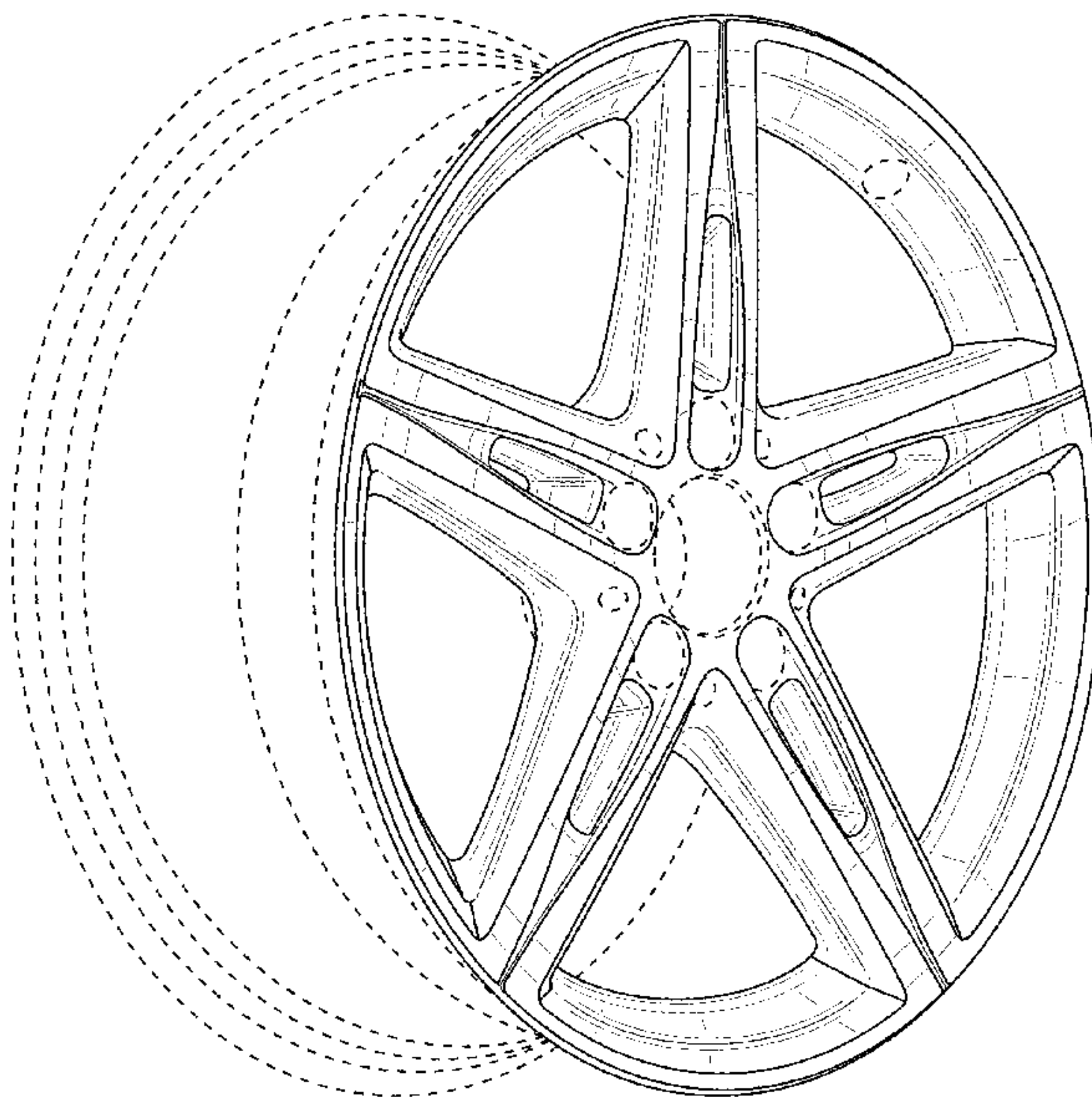
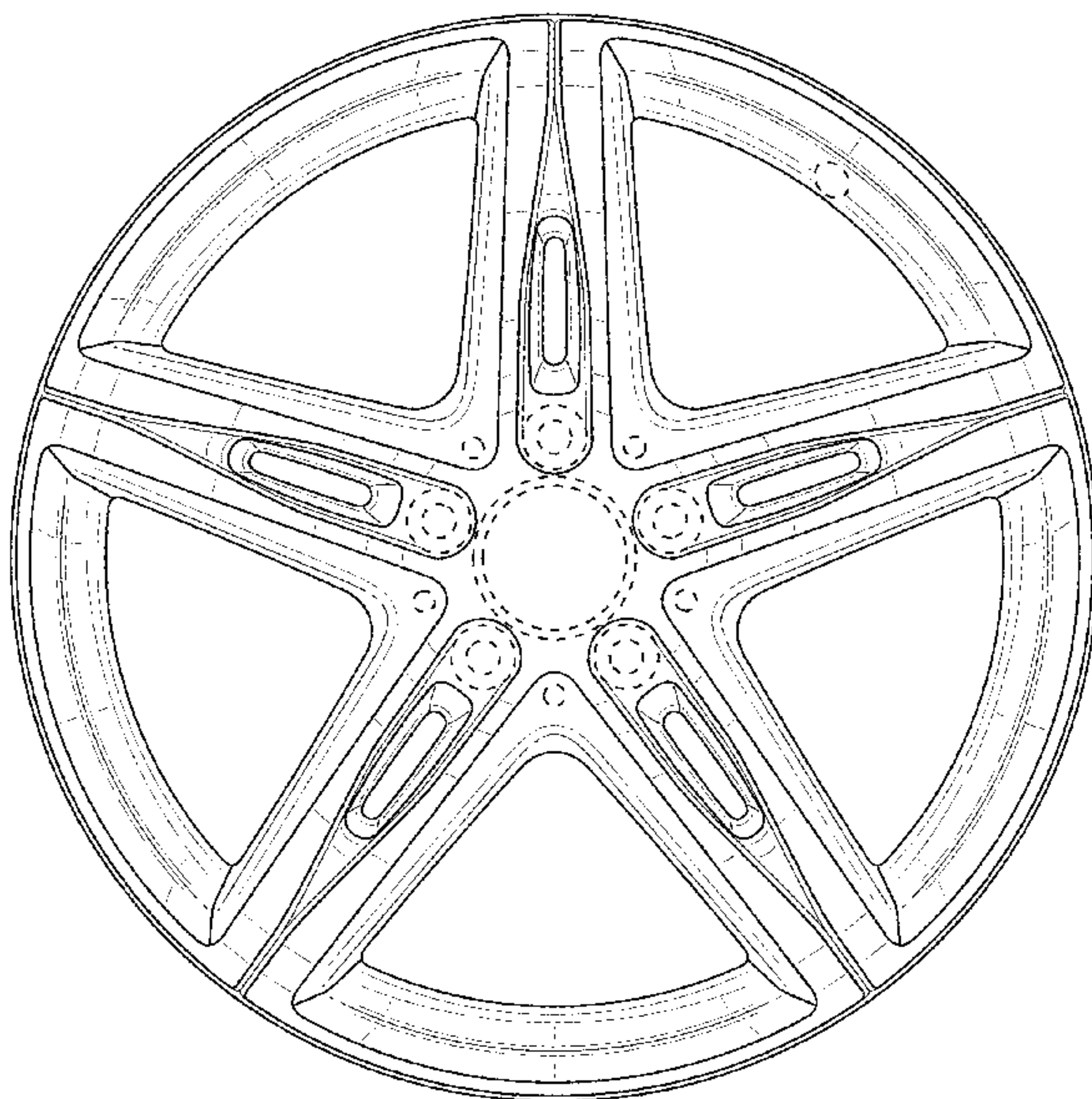

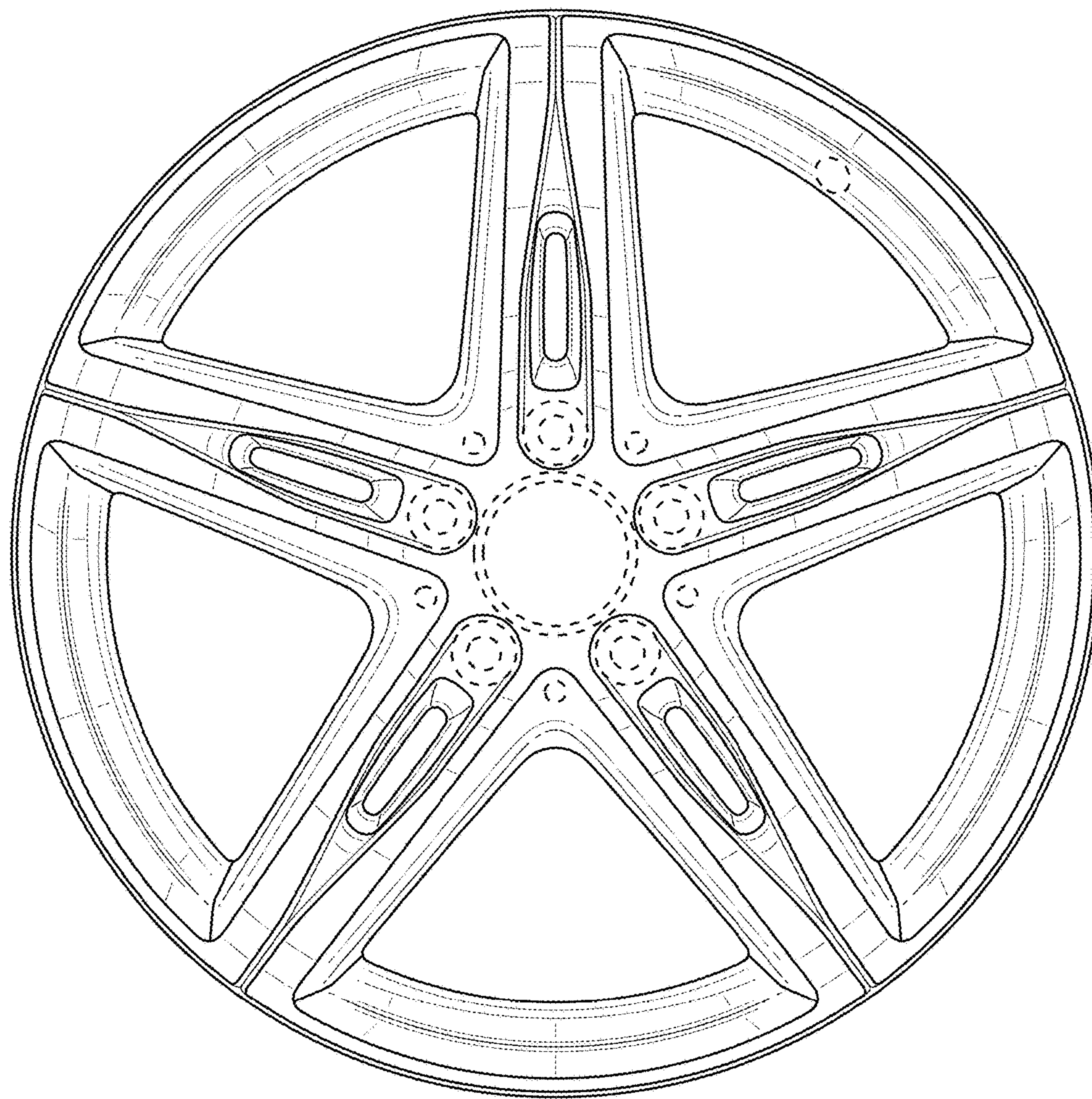
The ornamental design for a wheel or wheel cover, as shown and described.

The broken lines in the drawings illustrate environmental subject matter only and form no part of the claimed design.

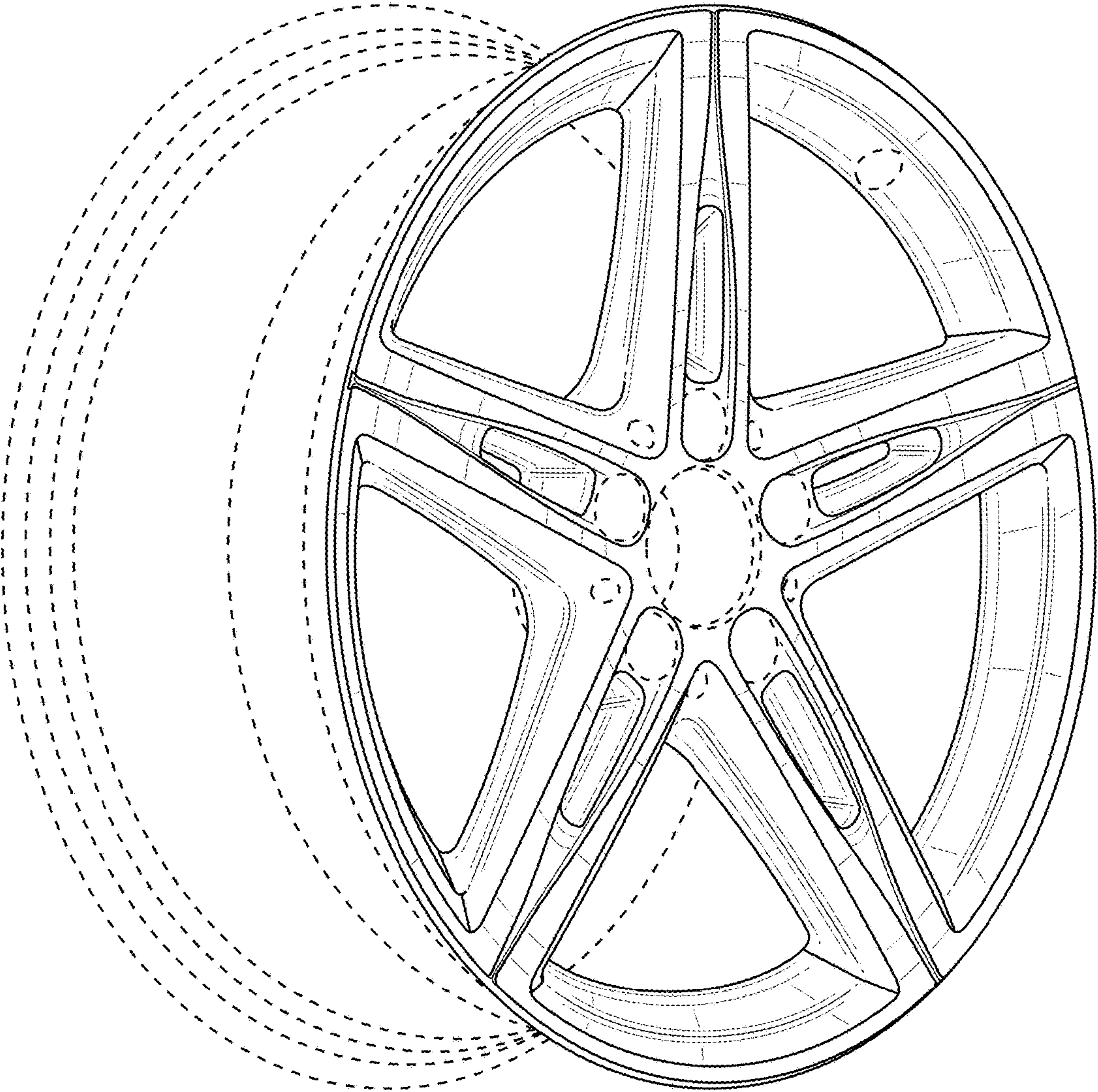
