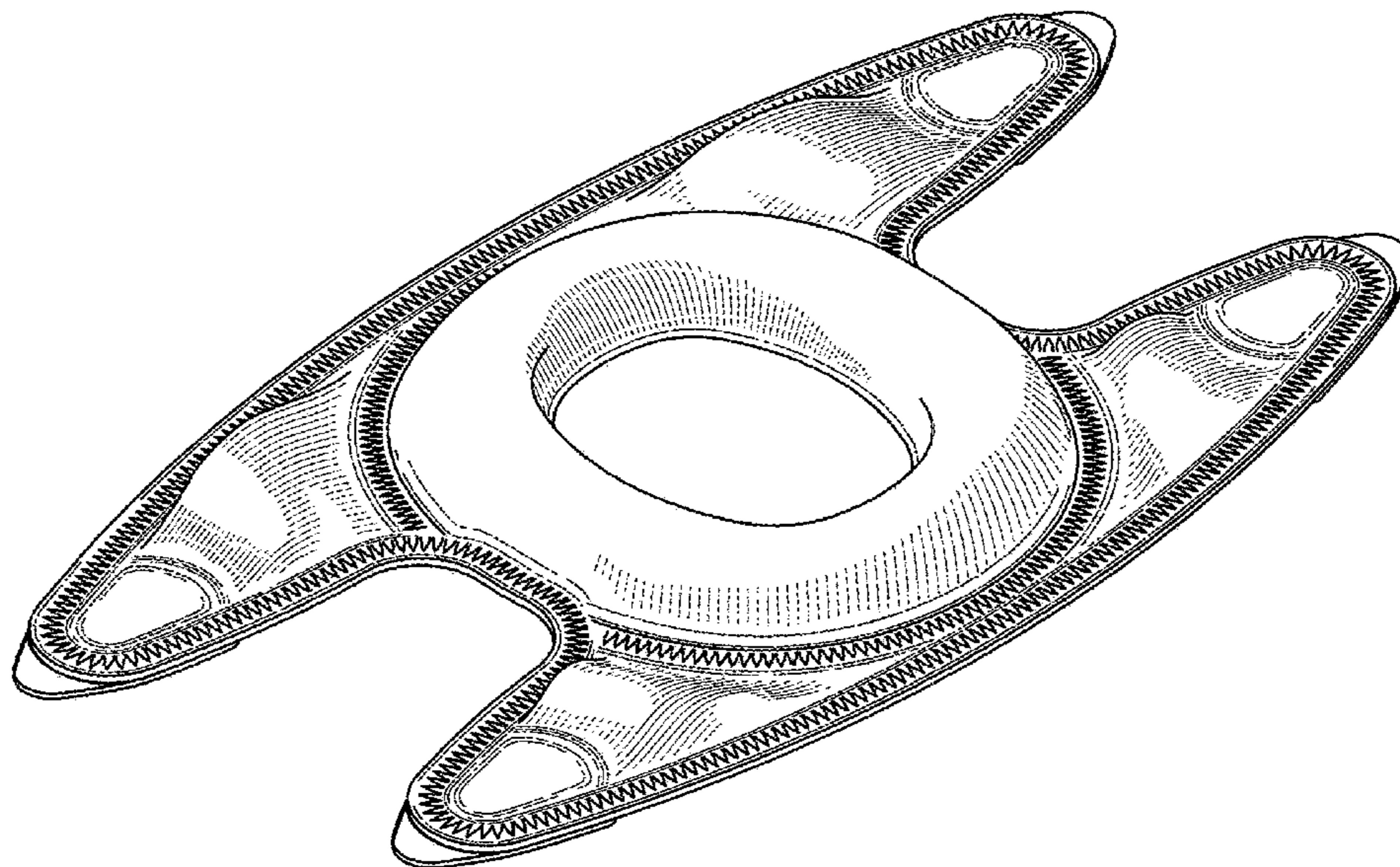
(57) **CLAIM**

The ornamental design for a removable patella buttress assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a removable patella buttress assembly according to the present application. FIG. 2 is a front view of the removable patella buttress assembly of FIG. 1. FIG. 3 is a rear view of the removable patella buttress assembly of FIG. 1. FIG. 4 is a left side view of the removable patella buttress assembly of FIG. 1. FIG. 5 is a right side view of the removable patella buttress assembly of FIG. 1. 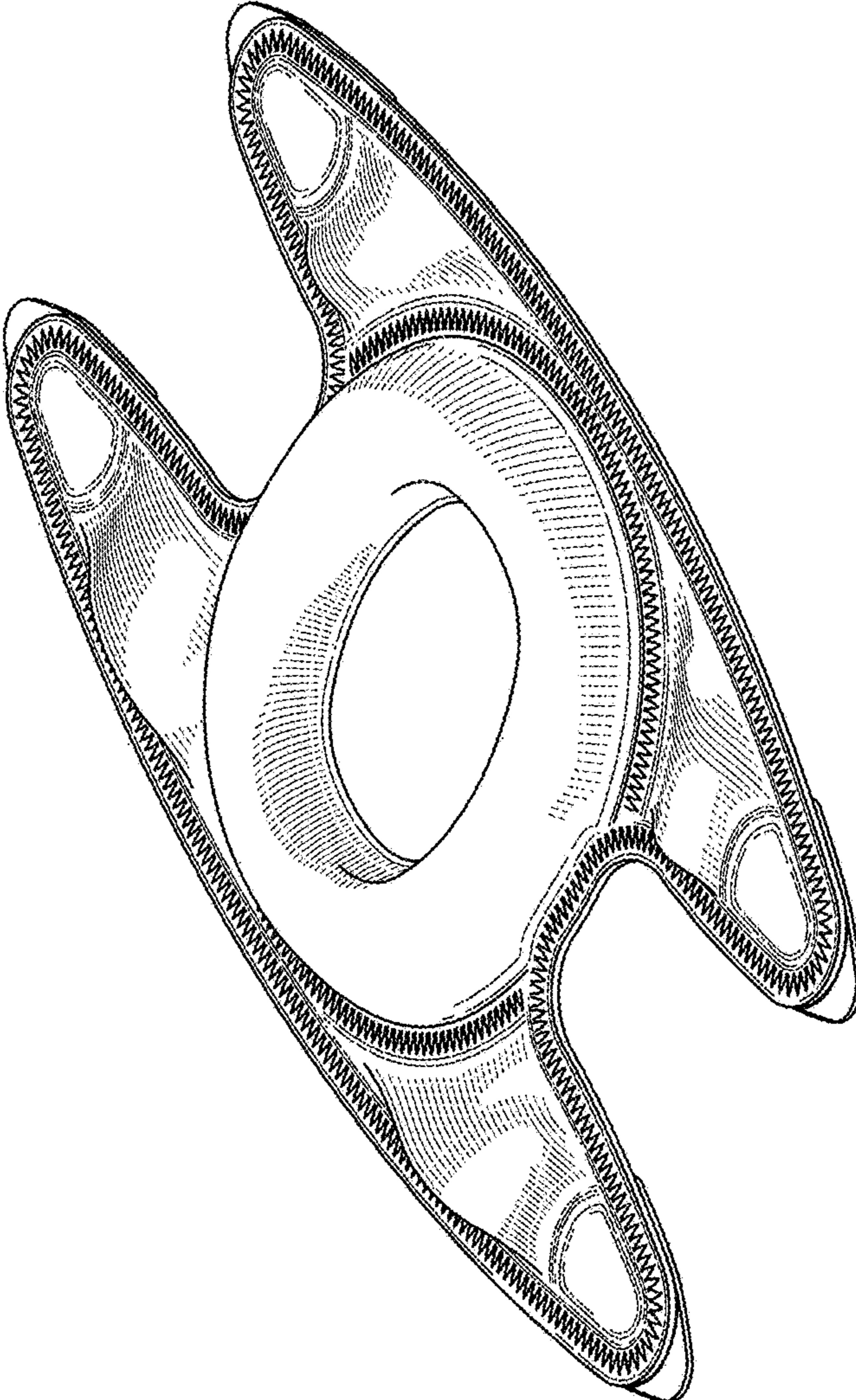

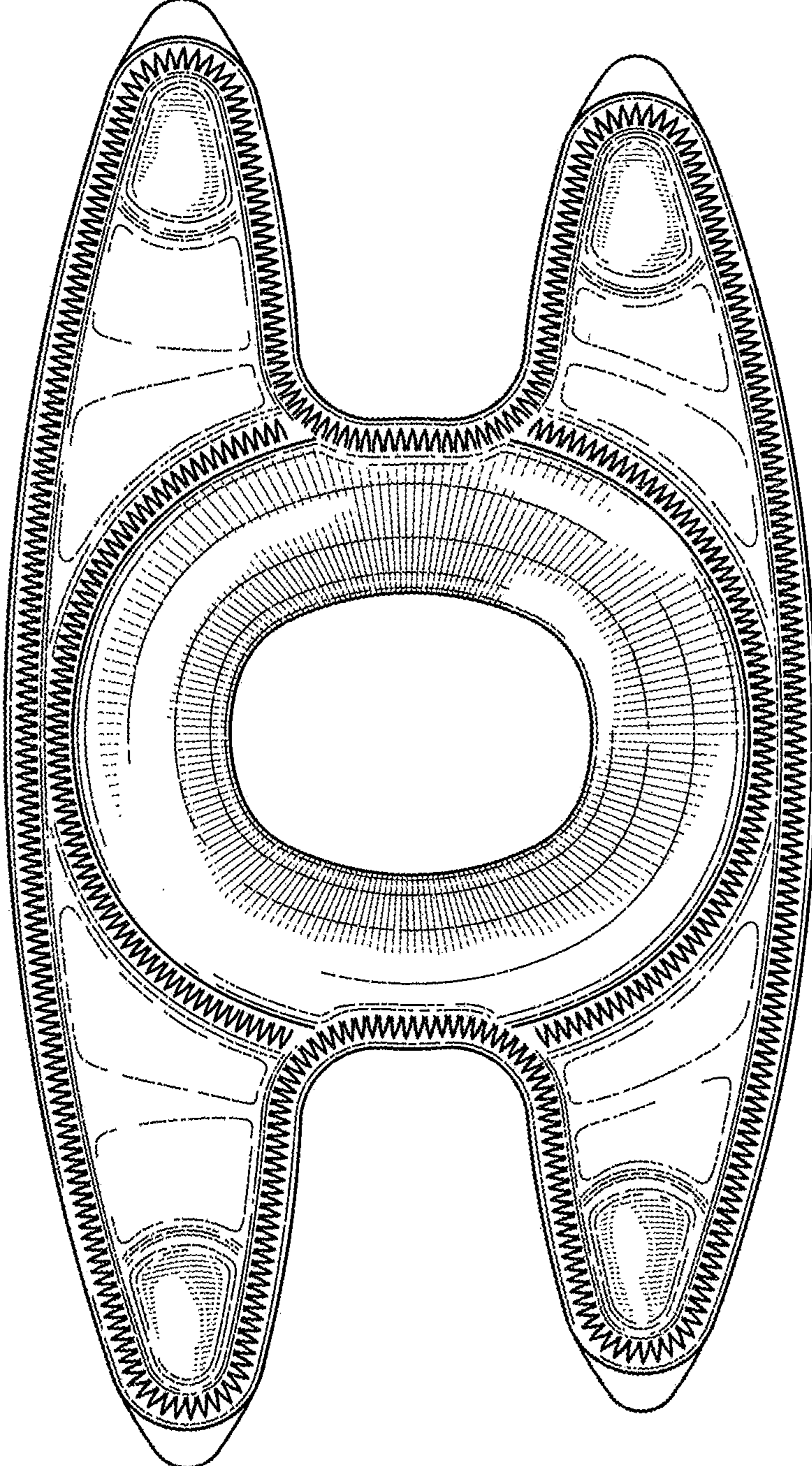

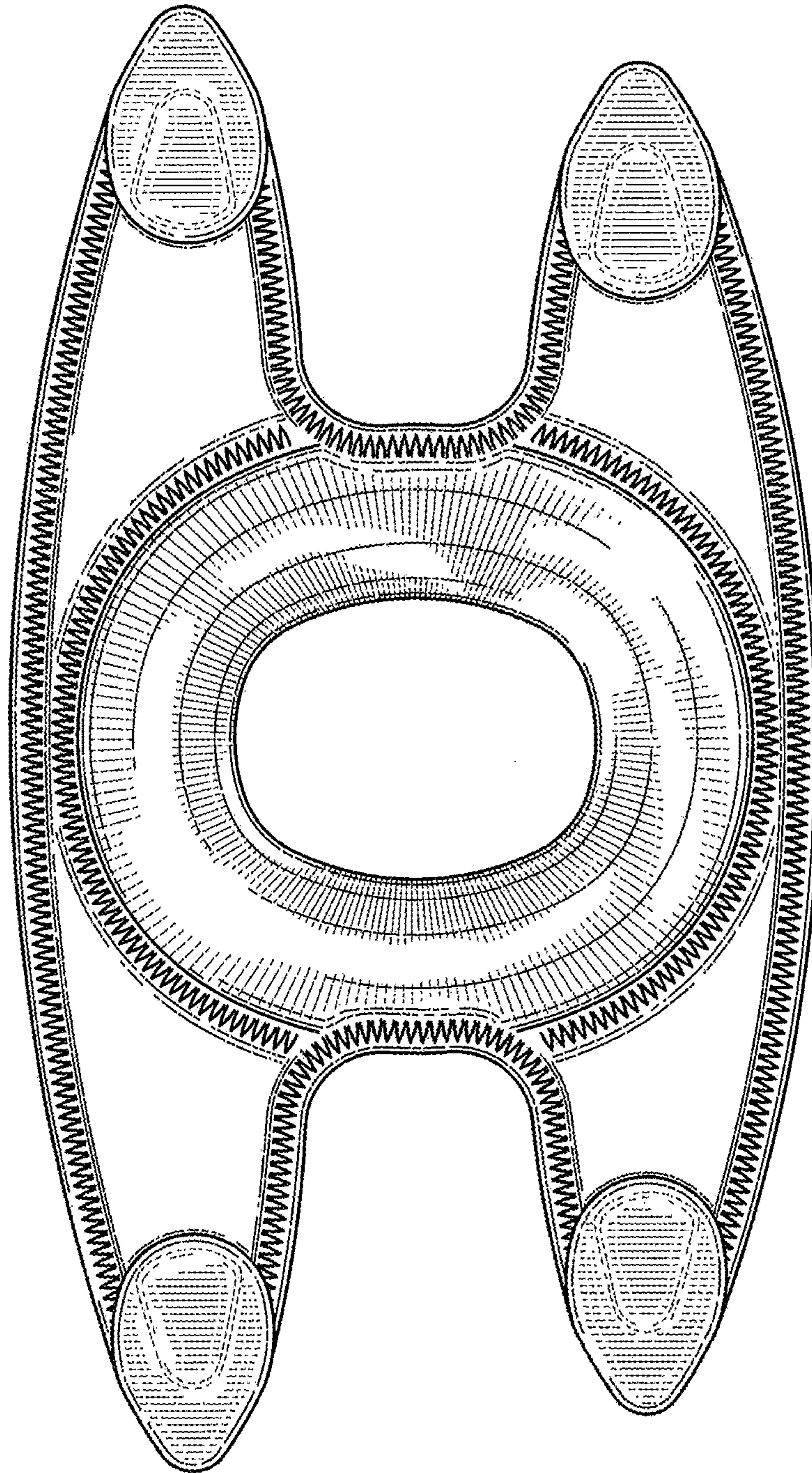

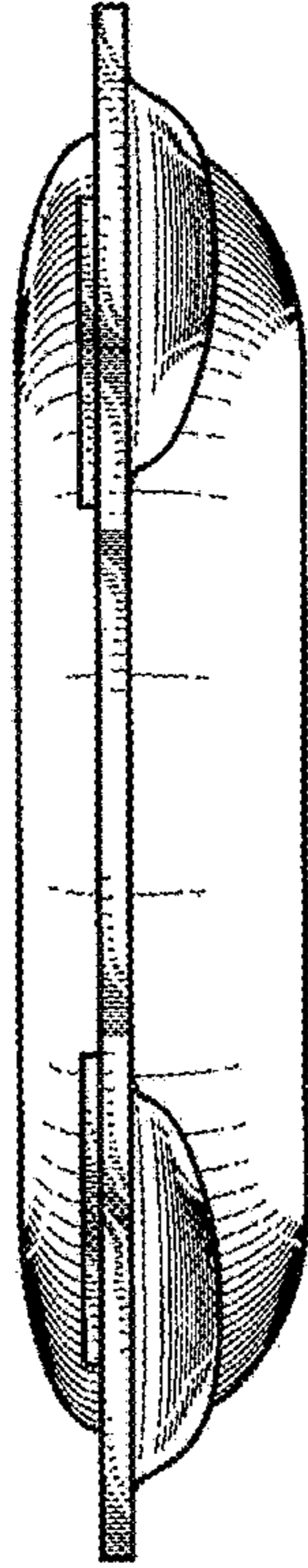

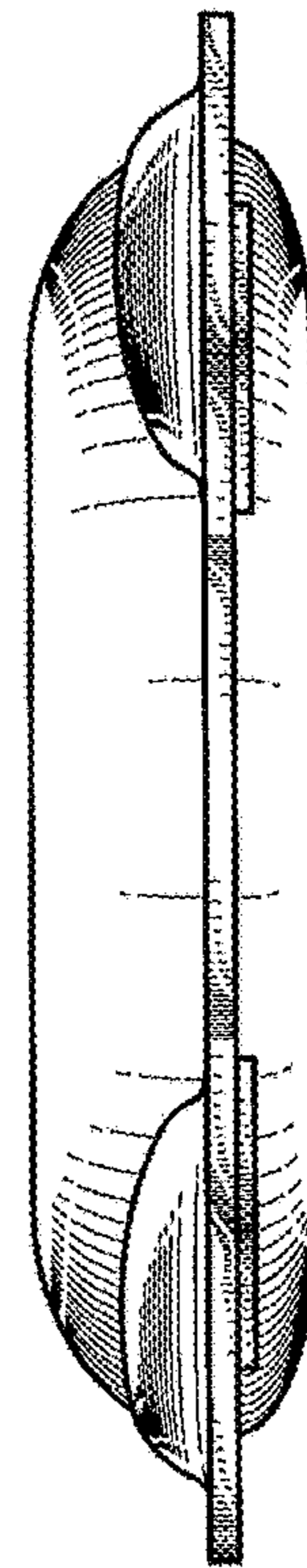

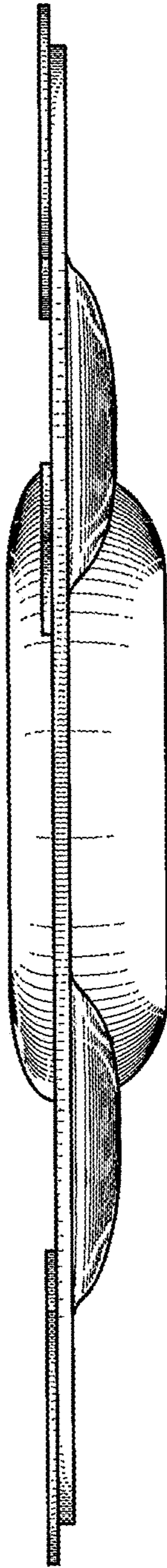

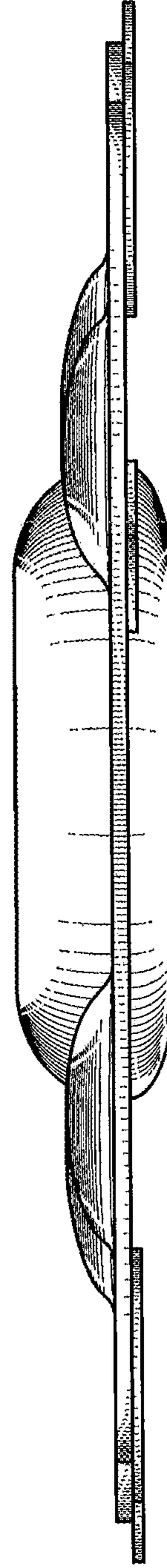
